 - (1) Why does farmland surrounding Armidale not qualify as Strategic Agricultural Land in the draft Strategic Regional Land Use Plan (SRLUP) for New England North West despite the fact that it is renowned for producing some of the best fine wool in Australia?
 - (2) Why have vineyards been recognised as a critical industry cluster in the Hunter SRLUP but not in the New England North West SRLUP, thus excluding the merging cool climate wine growing area around Armidale from recognition as Strategic Agricultural Land?

Answer-

- (1) Two categories of strategic agricultural land are outlined in the draft Upper Hunter and New England North West Strategic Regional Land Use Plans biophysical strategic agricultural land and critical industry clusters. The draft New England North West plan identifies some areas of biophysical strategic agricultural land around Armidale. These have been identified based on soil, water and land capability criteria outlined in the draft plans.
- (2) There are multiple criteria for an area to be classified as a critical industry cluster, including a concentration of significant industries based on an agricultural product that is potentially substantially impacted by coal seam gas or mining development.
 - I am advised that the wine growing area around Armidale does not overlay coal or gas resources in this locality and, hence, the industry is not potentially significantly impacted by mining or coal seam gas development.
