#### **3 AUGUST 2011**

(Paper No. 27)

- \*0477 AMBULANCE BLOCK—WOLLONGONG HOSPITAL—Ms Noreen Hay asked the Minister for Health, and Minister for Medical Research—
  - (1) What are the Minister's intentions in relation to the problem of ambulance block at Wollongong Hospital?
  - (2) Why has the Government not fixed this problem as promised in the lead up to the recent State election?
  - (3) What is the Government's response to the Health Services Union's criticism of the Minister's failure to keep this promise?

Answer-

I am advised:

(1) to (3) Wollongong Hospital is currently experiencing high levels of demand both in the number of presentations and the complexity of those presentations.

During busy periods, Emergency Department staff execute a specialist escalation plan to minimise waiting times for both patients and ambulances. Staff work in close consultation with their Ambulance Service colleagues to ensure that patients are seen and treated as soon as possible. Patients that are most seriously ill are always treated as a priority.

Wollongong Hospital has in place a winter bed strategy and dedicated Patient Flow teams work around the clock to facilitate timely access.

Illawarra Shoalhaven Local Health District is in regular discussion with the Ambulance Service regarding initiatives to improve patient offload times and hospital staff work closely with an Ambulance Liaison Officer to minimise waits and collaboratively work through the issues.

\*0482 COST OF BOTTLED WATER—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—

Given the Minister's statement that \$1 million per year is spent by NSW hospitals on bottled water:

- (1) What was the actual statewide cost of bottled water for the financial year 2009-10?
- (2) How was this figure calculated?
- (3) If no actual figure is known, how was this figure calculated?
- (4) Which area health service (AHS) had the highest cost?
- (5) Which AHS spent the least?
- (6) What measures has the Minister taken to reduce this cost?
- (7) How effective have these measures been?

Answer-

I am advised:

(1) to (7) On average, NSW Health hospitals use 3 million bottles of water per annum. Bottled water is supplied under a statewide contract managed by the State Contracts Control Board, via the Department of Services, Technology and Administration. Under the statewide contract there are a number of bottled water suppliers who can provide hospitals with water that is safe and of a high quality. To be awarded a contract, companies must offer value for money, accommodate the complex needs of a hospital environment, and meet stringent quality standards.

In 2010 the health system spent approximately \$860, 000 on bottled water products.

It is a matter for each Local Health District or hospital to choose whether they wish to have bottled water included in their food service delivery - there is variation across the state. I have asked that Local Health Districts consider reducing use of bottled water, and Local Health Districts, in consultation with Health Support Services, are currently reviewing bottled water utilisation.

\*0483 FIRSTNET COMPUTER SYSTEM—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regard to FirstNet computer system is use in emergency departments and your previous comment "If the system cannot deliver what is required by our hospitals then work would need to begin on looking for an alternative" (press release 7 March 2011):

- (1) Does the minister have any plans to halt the roll-out of the FirstNet system?
- (2) Is there any alternative system being considered?
- (3) Does the "Emergency wait times" website depend on FirstNet being used?

#### Answer—

(1) to (3) Prior to the election I made a commitment to have an independent review undertaken of the FirstNet computer system used in NSW Emergency Departments. Deloitte Consulting has performed the independent review, overseen by a Steering Committee chaired by a clinician, and including two Emergency Department directors and an experienced Emergency Department nurse manager. The terms of reference for the review included scope for determining whether or not the application was fit for purpose and a response to that question is expected in the review report.

The review report is currently under consideration by the Department of Health.

The Emergency Wait Time website extracts real time data from all electronic Emergency Department systems in use across NSW Emergency Departments, of which there are multiple different software applications in use state-wide, including First Net.

\*0485 PAYMENT OF STATE GOVERNMENT ACCOUNTS—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regard to the Government's policy to require State Government accounts "to be paid within 30 days and to allow penalty interest to be automatically charged if this deadline is not met":

- (1) Will this policy be introduced for NSW Health as part of the 2011-12 NSW Budget?
- (2) If not, when will the Minister introduce this policy for NSW Health?
- (3) Has Treasury estimated a possible annual cost to NSW Health if this measure were to be introduced?

#### I am advised that:

- (1) and (2) NSW Health is implementing the Government's policy to pay small businesses in accordance with the requirements of the NSW Treasury Circular issued on 14 July 2011.
- (3) NSW Health intends to comply with the policy and pay small businesses within the terms specified in the NSW Treasury Circular.
- \*0486 SURGICAL WAITING LISTS—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

In regards to hospital surgical waiting lists and your previous statements that "A NSW Liberals and Nationals Government is committed to a health system that is accountable and puts patients first":

- (1) Is the minister prepared to introduce an independent open state-wide inquiry into hospital surgical waiting lists, as she has previously requested?
- (2) Where are the actual numbers for patients on surgical waiting lists publicly available?
- (3) Will the minister ensure that all hospital surgical waiting list numbers, grouped by individual hospital and classification, as she has previously requested, are released publicly within 30 days of the end of the month?
- (4) When will the figures for April/May/June/July and August 2011 be released?

#### Answer-

#### I am advised:

- (1) to (4) A taskforce has been appointed to look at unmet demand for surgery. In addition to this, the independent Bureau of Health Information (BHI) is responsible for publishing performance results for the NSW Health system including surgical performance results. The BHI determines the content and frequency of publication of its reports. All of this information is available at www.bhi.nsw.gov.au
- \*0487 BACKGROUND CHECKS ON DOCTORS—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

In regard to background checks on doctors:

When does the Minister plan to introduce her promised legislation to make it legally mandatory for area health services to conduct background checks on new doctors in public hospitals, meaning that an employer who fails to check a doctor's background will be guilty of a criminal offence, with offenders punished appropriately?

Answer-

I have had a longstanding commitment to ensuring that adequate systems for making sure proper background checks occur on medical practitioners before they are allowed to work in NSW public hospitals.

The circumstances in which Graeme Reeves was allowed to work as an visiting medical officer in obstetrics in Bega Hospital, despite Medical Board conditions restricting him from practising as an obstetrician, must never be allowed to be repeated.

One significant recent change in the governance arrangements of health professionals was the introduction last year of a system of national registration of health professionals throughout Australia.

I therefore intend to raise this matter at a national level, with the intention of seeking to progress a nationally consistent approach to ensuring that health services are obligated to conduct appropriate background checks on new doctors working in public health systems.

\*0488 HOSPITAL PERFORMANCES—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

In regards to your previous commitment to publish "full, honest and regular reports to show how our hospitals are performing" (press release 19 August 2010). This would include publishing "information about health service management including budget allocations, spending, medical errors, infections and other patient outcomes" (press release 15 June 2009) and that "patients have every right to have access to this kind of information so they can make their own informed decisions about where they go for surgery and treatment" (press release 29 June 2008):

- (1) What websites does the minister plan to release these reports on?
- (2) Will these reports be available in both hard copy and on the Internet?
- (3) What data are currently being shown?
- (4) Will the infection rates be published by individual hospital ward level, as previously indicated by the Minister?
- (5) Apart from the emergency waiting times site, what other "new" data (i.e. introduced by your office for public viewing since the election) is going to be shown?
- (6) How will this information differ from the data currently being released by the Bureau of Health Information (BOHI)?
- (7) How soon after the end of each month will these reports be released?

Answer—

(1) to (7) As part of the National Health Reform Agreement recently signed by all Premiers, Chief Ministers and the Prime Minister, transparent comparative performance information on all Australian hospitals both public and private will be developed and reported on the national My Hospitals website, in conjunction with the National Health Performance Authority.

In addition, the NSW Bureau of Health Information will continue its important work on enhancing reporting to both the community and clinicians on the performance of the NSW health system.

The information in both the Bureau's reports and on the My Hospitals website are available on the internet, with the ability to download hard copies of the information.

\*0489 ESTABLISHMENT OF TASKFORCE—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

Given advice that a taskforce to establish a "consistent definition of 'beds' within the NSW health system and determine the number of beds in the NSW health system" (Question 0117):

- (1) Has a taskforce been appointed?
- (2) Who is on this taskforce?
- (3) How often has the taskforce met?
- (4) When will a report be available?
- (5) Is the Minister now able to give a reply as to how many beds there were in the NSW health system as of 1 April 2011?

Answer-

I am advised that:

The Transition Taskforce that I appointed will be completing a final report that will be available by the end of the year. The Taskforce includes Dr Mary Foley, Dr Nigel Lyons, Adjunct Professor Debra Thoms,

Mr Chris Puplick AM, Professor Denis King, and Mr Tom Callachor. The taskforce has met on multiple occasions over the last months.

\*0490 WALKOUT RATES FROM EMERGENCY DEPARTMENTS—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regard to patients "walking out" of emergency departments (EDs) without being seen:

- (1) What was the statewide walkout rate for the month of July 2011?
- (2) How many, and what percentage, of total numbers of those presenting to ED, walked out without being seen in:
  - (a) Bankstown;
  - (b) Concord;
  - (c) Gosford;
  - (d) John Hunter;
  - (e) Liverpool;
  - (f) Nepean;
  - (g) Prince of Wales;
  - (h) Royal North Shore;
  - (i) Royal Prince Alfred;
  - (j) St George;
  - (k) St Vincents;
  - (l) Westmead;
  - (m) Wollongong;
  - (n) The Children's Hospital at Westmead;
  - (o) Sydney Children's;
  - (p) Blacktown:
  - (q) Campbelltown;
  - (r) Mount Druitt;
  - (s) Sutherland;
  - (t) Wyong;
  - (u) Maitland;
  - (v) Port Macquarie;
  - (w) Tamworth;

## Answer-

#### I am advised:

(1) Walk-out rates comprise two groups: those who "did not wait" (i.e. patients who left before treatment was commenced by a clinician) and those who "left at own risk" (i.e. patients who left against advice after treatment had commenced). For the month of July 2011, for all NSW Emergency Departments reporting activity electronically to the Department, the rate of "did not wait" ED attendances was 6.0% and the rate of "left at own risk" ED attendances was 2.2%.

\*0491 HOSPITAL BEDS OPENED—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

- (1) From 27 March 2011 until Monday 1 August 2011, how many hospital beds were opened by the NSW Government (excluding those opened temporarily as part of a winter strategy)?
- (2) In which hospitals were these beds located?
- (3) Were these "new" beds, or relocation of existing beds?
- (4) How were these beds funded (i.e. Federal Government or NSW Government)?

#### Answer-

- (1) 63 hospital beds were opened since the NSW Government election
- (2) Dubbo, Orange, Ballina, Prince of Wales, Royal Hospital for Women, St George, Sutherland, St Josephs, Westmead, Nepean and Children's Hospital at Westmead
- (3) These were all "new" beds, not relocation of existing beds.
- (4) These beds were funded through joint NSW and Federal Government funding.

#### \*0494 WALSH BAY BUSES—Ms Clover Moore asked the Minister for Transport—

With respect to transport services for Walsh Bay (Question No 11671 54th Parliament):

- (1) What assessment has the Government made of the Hassle Free Nights late night buses in The Rocks area, and what does this show about transport needs?
- (2) What assessment has the Government made of the trial extension of the 443 bus service into Walsh Bay, and what does this show about the need for bus services:
  - (a) during day time when residents and workers arrive and leave this precinct;
  - (b) during night time when visitors and patrons of cultural facilities arrive and leave this precinct?
- (3) Noting the strong community support for bus services to Walsh Bay, what action will the Government take to continue and extend 433 bus services?
- (4) Noting complaints about noise and air pollution impacting some residents, what assessment has the Government made about:
  - (a) possible route changes away from quieter residential streets;
  - (b) location of bus layover to prevent noise and air pollution impacts from idling buses?
- (5) What action has been taken on the promised extension of light rail to this precinct, as in the Metropolitan Transport Plan?
- (6) What action has the Government taken to provide ferry services to this precinct?
- (7) What further action will the Government take to address transport needs in Walsh Bay?

#### Answer—

#### I am advised:

- (1) The Department of Transport has monitored patronage on the Hassle Free Nights late night buses in The Rocks area since these services were introduced in April 2010. Patronage of Route 998 which runs from The Rocks to QVB from 9pm to 4.30 am each Friday and Saturday night has been low.
- (2) The Department of Transport is reviewing data on the trial, including patronage, reliability and customer feedback.

The Department of Transport intends to continue collecting operational data throughout the third

quarter of 2011 to ensure the right information is available to make an informed decision.

- (3) This will be considered once the review has been completed.
- (4) This can be considered as part of the review.
- (5) Introducing light rail in Sydney's city centre requires careful and detailed planning. There are a number of complex matters which require further investigation before a preferred corridor can be identified. This includes impacts on customers, bus operators, traffic management and businesses both during operations and construction.

Investigations into the feasibility of extending light rail services through the CBD and to the Universities of Sydney and NSW have been announced.

The Department of Transport is consolidating feasibility analysis of these light rail expansion projects within a Sydney Light Rail Strategic Plan.

The Plan will address issues such as the strategic role of light rail, route options and potential stop locations, patronage demand, economic viability, constructability, integration with other transport modes and cost. This is to ensure that future investments represent value for money and deliver sound transport and urban outcomes with a strong customer focus.

This work is in addition to the Government's commitment to the extension of the existing light rail services to the Inner West from Lilyfield to Dulwich Hill, for which the design for construction is underway.

- (6) As part of the 'Fixing Sydney Ferries' program, the Department of Transport is undertaking a Network Review.
- (7) This can be considered as part of the CBD Access Study being undertaken in conjunction with the City of Sydney.

\*0495 END STAGE KIDNEY DISEASE—Ms Clover Moore asked the Minister for Health, and Minister for Medical Research—

Noting latest data suggesting that there are about 7,000 people in NSW with end stage kidney disease, with higher rates for older people and Indigenous people:

- (1) What is the Government's estimate of the health costs of end stage kidney disease?
- (2) How many of those people with end stage kidney disease receive dialysis treatment in NSW?
- (3) How many of those people with end stage kidney disease are listed for or have received kidney transplants in NSW?
- (4) What does the Government spend on dialysis support for end stage kidney disease?
- (5) What does the Government spend on kidney transplants in response to end stage kidney disease?
- (6) What programs has the Government provided to prevent and intervene early with end stage kidney disease?
- (7) What further action will the Government take to prevent end stage kidney disease?

Answer—

I am advised:

- (1) The annual costs of dialysis and transplantation treatment of end stage kidney disease in NSW is estimated at approximately \$250 million. Costs of end stage kidney disease, not associated with Dialysis or Transplantation, are not known.
- (2) According to the Australia and New Zealand Dialysis and Transplant Registry (ANZDATA) 2010 Report, at the end of 2009 there were 3374 NSW residents undergoing some form of dialysis.
- (3) Also according to the ANZDATA Registry 2010 Report, at the end of 2009 calendar year there were 2232 NSW residents with functioning renal transplants. Approximately 240 kidney transplants are undertaken in NSW each year. The number of procedures is limited by the availability of donated organs, both cadaveric and live donors. There are currently 762 people on the waiting list for renal transplantation in NSW.
- (4) An estimate of the cost is approximately \$214 million per annum.
- (5) An estimate of the cost is approximately \$36 million per annum on transplantation, noting that the number of procedures is limited by the availability of organs.
- (6) and (7) A NSW Health Policy entitled "Kidney Health Check: Promoting the Early Detection & Management of Chronic Kidney Disease" was released in April 2010. This Policy outlines a new approach to the early detection and management of chronic kidney disease to prevent progression to end stage kidney disease. It involves opportunistic screening using the Kidney Health Check in order to identify risk of chronic kidney disease, and will target high-risk individuals in hospital settings.

It aims to optimise existing contacts with at risk patients in hospital settings in order to prevent progression to end stage kidney disease. The screening tool described is the Kidney Health Check. If disease is detected, a primary care referral will be made, highlighting the importance of treating the

condition in order to encourage remission and regression of the disease.

\*0497 BULLYING AT WESTMEAD HOSPITAL—Mr Nathan Rees asked the Minister for Health, and Minister for Medical Research—

In view of the Minister's previous statement (press release 21 July 2010) that bullying is "endemic" at Westmead Hospital:

- (1) What investigation(s) into bullying at Westmead Hospital has the Minister commenced since the 2011 election?
- (2) What actions have been taken?
- (3) Does the Minister still believe that "bullying is endemic at Westmead Hospital"?

Answer-

(1) to (3) I am absolutely committed to abolishing bullying and harassment in the NSW health sector and have established a Taskforce on the Prevention of Bullying and Harassment. The Taskforce will be lead by the Director-General of NSW Health and will identify strategies aimed at eliminating bullying and harassment and bringing about cultural change within NSW Health.

In relation to Westmead Hospital, I am advised that:

- A number of actions have been taken at Westmead Hospital over the past 12 months to positively address the workplace culture and behaviors at the hospital.
- A range of activities have been put in place at Westmead Hospital to educate staff and managers about acceptable workplace behaviours and what constitutes bullying and harassment. This includes training sessions for staff across a wide range of settings.
- The Workplace Behaviour Advisors have been particularly active in providing coaching and mentoring services to supervisors who are managing bullying complaints. This will ensure that complaints of bullying are dealt with appropriately.
- Education for managers has also been a particular focus so that they can intervene to address unacceptable behaviour and deal with formal complaints. All of the Senior Executive of the hospital have attended these training programs, as well as a large number of staff in senior positions.
- Educational material is freely available for staff to access to assist with complaints.

#### **4 AUGUST 2011**

(Paper No. 28)

- \*0498 POLICE STATION CELLS—Mr Richard Amery asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
  - (1) How many police stations in New South Wales do not have a cell to accommodate persons in custody?
  - (2) Of these stations, how many have cells that have been decommissioned?
  - (3) Of the stations referred to above, what is the break-down of this number between metropolitan and country stations?

Answer—

The NSW Police Force has advised me:

- (1) There are 49 police stations in NSW that do not contain cells. However, persons in custody can also be accommodated in docks, which are present in all but eight NSW police stations.
- (2) Records of decommissioned cells are not kept.
- (3) There are 37 "country" stations that do not have cells, however all of these have docks. It follows that 12 metropolitan stations do not have cells, and eight metropolitan stations do not have docks.
- 0499 NO SMOKING POLICY—Ms Sonia Hornery to ask the Minister for Health, and Minister for Medical Research—
- \*0500 INTERNATIONAL STUDENTS TRANSPORT CONCESSIONS—Ms Sonia Hornery asked the Minister for Transport—

- (1) Why are international students not allowed to take advantage of transport concessions available to all domestic students?
- (2) Why is the Government discouraging international students from studying here by such discrimination?

Answer-

I am advised:

(1) and (2) Transport concessions are not available to full-fee paying overseas tertiary students because, when obtaining their visas, they attest that they are fully self sufficient and able to meet their own living expenses. These restrictions are not new. No NSW Government has ever made transport concessions available to full-fee paying overseas students, including the previous government of 16 years.

It should be noted that international students are also ineligible for Commonwealth Government benefits such as Newstart Allowance, Austudy and free and subsidised health services under Medicare.

Even though concessionary travel is not available to international students, they do have access to a range of discounted fare products including off-peak tickets, rail weeklies, TravelTens and MyMulti tickets. Information on these ticketing products is available from the Transport Infoline at www.131500.com.au/ and through the websites of individual transport operators.

\*0503 POLICE STRENGTH NUMBERS—Ms Tania Mihailuk asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

With reference to the police strength numbers posted on the NSW Police Force website:

- (1) (a) Do these figures accurately represent the current allocation of police personnel across New South Wales?
  - (b) If not, why not?
- (2) What is the reason for the discrepancy between authorised numbers of police officers in Bankstown and actual numbers of police officers?
- (3) What action will the Minister take to increase the number of police officers allocated to the Bankstown Local Area Command?

Answer-

- (1) Strength figures currently on the police website represent both authorised and actual strength at each Local Area Command and Region as at 31 July 2011.
- (2) As was the case under the previous Government, the Authorised strength indicates the number of officers currently budgeted for and allocated to each Command. Actual strength figures may vary on a daily basis due to officer movements such as transfers, recruitment, resignations and other terminations. This is true of all Commands, including Bankstown.
- (3) The Government has commissioned an audit of police resources across the State. This audit has examined the issue of staffing allocations to all Commands.
- \*0505 FREE BANKSTOWN SHUTTLE—Ms Tania Mihailuk asked the Minister for Transport—
  - (1) Will the Minister maintain the Free Bankstown Shuttle implemented by the previous Government?
  - (2) Will the Minister expand the Free Bankstown Shuttle's route within the Bankstown CBD?

Answer—

I am advised:

- (1) and (2) Free shuttle buses will be funded while people continue to use them.

I am also aware that the former Government axed the project in November that year, before reannouncing the project in November 2009, with a new completion date of 2016.

In February 2010, the former Government announced that the cost had blown out to \$2.1 billion.

Construction of the South West Rail Link commenced at Glenfield in 2009. Works undertaken prior to March 2011 included:

- The extension of the Seddon Park commuter car park.
- Construction of the Glenfield multi-storey commuter car park

Preliminary works began on the Glenfield Junction northern and southern flyovers in June 2010 and the upgrade of Glenfield Station commenced in August 2010.

(2) Among this Government's election commitments was providing certainty to residents in NSW that key infrastructure projects such as the South West Rail Link would be delivered without unnecessary delay.

Works undertaken on the SWRL project following March 2011 include:

- The laying of the first new track for the SWRL at Glenfield. This track will form part of the connection between the existing East Hills rail line and the new Glenfield to Leppington rail line.
- The installation of columns to support the new overhead concourse for the Glenfield Transport Interchange.
- After ongoing investigation, excavation and earthworks, the first above-ground structures of the southern flyover were installed. These structures will support the flyover which, when complete, will connect the South West Rail Link to the existing network.
- The installation of ramps that will support the rail line on the Northern Flyover.
- The completion of the basement and ground floor slabs for the Glenfield south substation. This substation is one of a number being constructed to assist reliable operation of trains within the Glenfield Junction.
- The majority of survey and investigation works for the Glenfield to Leppington rail line have been undertaken and completed.
- The relocation of utilities along Railway Parade has been completed allowing sewer and water main works to be undertaken throughout August.

Since March 2011, a number of contracts have also been awarded to enable the ongoing design development of the new rail line between Glenfield south and Leppington. Construction of the new rail line continues to progress on time, with services on track to begin in 2016.
