- *0787 MITOCHONDRIAL DISEASE—Mr Richard Amery asked the Minister for Health, and Minister for Medical Research—
 - (1) How many persons in New South Wales have been detected as suffering with a mitochondrial disease?
 - (2) Of these sufferers, how many reside in:
 - (a) the Sydney Metropolitan area?
 - (b) rural and regional New South Wales?

Answer-

I am advised:

(1) and (2) Mitochondrial disease is the name given to a group of over 100 genetic disorders that impair mitochondrial function and produce clinical disability.

Mitochondrial disease affects both children and adults. Mitochondrial disease has a wide variety and severity of symptoms, which may be quite non-specific, and for this reason may be undiagnosed or misdiagnosed. At present there is no cure and treatment is limited to treatment of symptoms.

The prevalence of mitochondrial disease in NSW is not known, but based on various research studies is estimated to be about 1 in 8,500 persons.

- *0789 SYDNEY WATER STAFF—Mr Michael Daley asked the Treasurer representing the Minister for Finance and Services, and Minister for the Illawarra—
 - (1) How many full-time equivalent (FTE) staff did Sydney Water employ in total as of 1 June 2011?
 - (2) How many FTE staff work at Sydney Water's Malabar Treatment Plant?

- *0790 SOUTHERN CLINICAL SUPPORT DIVISION STAFF—Mr Michael Daley asked the Minister for Health, and Minister for Medical Research—
 - (1) How many full-time equivalent (FTE) staff were employed by NSW in the Southern Clinical Support Division (Cluster) on 1 August 2011?
 - (2) Where were they based?
 - (3) Where was the chief executive based?
 - (4) What was the annual remuneration package of the Chief executive of the Southern Clinical Support Division?
 - (5) (a) How many staff members of the Southern Clinical Support Division were paid a total remuneration package of over \$100,000 per year?
 - (b) Of these staff paid over \$100,000 per year, how many will be devolved back into Local Health Districts?

Answer-

(1) to (5) This Government is continuing to deliver on its promise to devolve responsibility and accountability within the health system. In line with this commitment, on 24 August 2011, I announced the outcomes of the Governance Review of NSW Health.

One of the key reforms announced is that the Northern, Southern and Western bureaucratic "Clusters" introduced by Labor will be abolished, saving money and devolving most of these resources to Local Health Districts to be subject to local decision making.

The new structure will provide greater transparency and accountability; duplication of tasks will be stopped; and there will be greater clarity of roles and responsibilities.

The "Future Governance Arrangements for NSW Health - Report of the Director-General" is available on the Department of Health website: www.health.nsw.gov.au. This Report outlines the new governance arrangements aimed at ensuring NSW Health is a strong and resilient health system able to deliver the excellent health outcomes we expect for our patients and the broader community.

*0791 LONG BAY GAOL STAFF—Mr Michael Daley asked the Attorney General, and Minister for Justice—

- (1) How many full-time equivalent (FTE) staff worked at Long Bay gaol, the Long Bay hospital and Forensic Hospital as of 1 June 2011?
- (2) What is the breakdown of staff numbers at each facility?

Answer—

I am advised:

(1) There is no facility known as "Long Bay Gaol". Long Bay Correctional Complex contains Long Bay Hospital, the Metropolitan Special Programs Centre, and the Special Purpose Centre, each of which is separately proclaimed as a correctional centre; and the Corrective Services Inner Metropolitan Regional Administration Office. The Forensic Hospital is administered by Justice Health, and that portion of the question should be directed to the Minister for Health.

As of 26 September 2011, 750.76 full-time equivalent (FTE) staff worked at facilities and offices within Long Bay Correctional Complex.

- (2) It is inappropriate to provide a breakdown of the roles of staff for security reasons.
- *0792 SOUTHERN CLINICAL SUPPORT DIVISION—STAFF DEVOLVED—Mr Michael Daley asked the Minister for Health, and Minister for Medical Research—
 - (1) How many staff, as a result of the Government's health restructure, will be devolved from the Southern Clinical Support Division to the South Eastern Sydney LHD?
 - (2) What role will they now be acting in at the South Eastern Sydney LHD?

Answer-

(1) and (2) On 24 August 2011 I announced the outcome of the Governance Review of NSW Health. The proposed changes are outlined in detail in the report titled "Future Arrangements for Governance of NSW Health - Report of the Director-General". A copy of this report is available on the Department of Health's website: www.health.nsw.gov.au

Services currently managed by the Health Reform Transition Organisations will be devolved to other health entities, principally to Local Health Districts. Full details will be confirmed when the final transition plan is completed, which is scheduled to occur by the end of October 2011.

- *0793 MOST ACCIDENT-PRONE INTERSECTIONS—Mr Michael Daley asked the Minister for Transport representing the Minister for Roads and Ports—
 - (1) Does the Roads and Traffic Authority keep records of the most accident-prone intersections in the State?
 - (2) What are the ten intersections with the most recorded accidents in the Maroubra electorate?

Answer-

I am advised:

(1) The RTA's crash data system 'Crashlink' records all fatal, injury and towaways crashes. Crashlink is able to provide a list of the intersections with the greatest number of road crashes (vehicle or pedestrian).

However the RTA does not analyse locations on the basis of the greatest number of crashes, it analyses crashes based on type of crash and severity so that resources are focused on addressing locations experiencing more severe (fatality and injury) crashes.

Therefore, crash data relating to particular intersections, such as the following for the Maroubra electorate, does not automatically warrant blackspot road safety measures being implemented.

- (2) The intersections with the greatest number of crashes in the Maroubra electorate are:
 - Bunnerong Road and Anzac Parade (Nineways);
 - · Bunnerong Road and Wentworth Avenue;
 - Anzac Parade and Maroubra Road;
 - Fitzgerald Avenue and Malabar Road;
 - Bunnerong Road and Botany Road;
 - · Anzac Parade and Fitzgerald Avenue;
 - Avoca Street and Rainbow Street;
 - Anzac Parade and Boyce Road;
 - · Bunnerong Road and Flint Street;
 - Denison Street and Wentworth Avenue.

- *0794 SYDNEY CHILDREN'S HOSPITAL NETWORK—Mr Michael Daley asked the Minister for Health, and Minister for Medical Research—
 - (1) Where is the Sydney Children's Hospital Network (Randwick and Westmead) based?
 - (2) How many full-time equivalent (FTE) staff work for the specialty health network?
 - (3) How will the Sydney Children's Hospital at Randwick be affected by the establishment of the new Sydney Children's Hospital Network in terms of services provided and collaboration between other services such as the Children's Hospital at Westmead, NETS, PSN and others?

Answer-

I am advised:

- (1) The Sydney Children's Hospitals Network consists of The Children's Hospital at Westmead, Sydney Children's Hospital, Randwick, Newborn and Paediatric Emergency Transport Service, NSW Pregnancy and Newborn Service Network, the Children's Court Clinic and Bear Cottage.
- (2) 3,916 FTE staff work for the Network (as at 31 August 2011).
- (3) The Sydney Children's Hospitals Network (SCHN) is a key feature of the NSW Kids Strategy as recommended in the Garling Inquiry. It is designed to harness the strengths of Sydney Children's Hospital, Randwick and The Children's Hospital at Westmead and in the future bring together other key paediatric services.

By sharing resources and harnessing the strengths of both hospitals, we will see the development of new clinical networks, new models of coordinated care, new partnerships and a boost to the research, training and development capacity of both hospitals.

*0795 RECURRENT FUNDING FOR COMMUNITY CENTRES—Mr Michael Daley asked the Minister for Family and Community Services, and Minister for Women—

What is the total amount of recurrent funding that all of the community centres in the Maroubra electorate received from Community Services or through any other grants program in 2010-2011 and specifically:

- (a) Kooloora Community Centre;
- (b) The Junction Neighbourhood Centre:
- (c) Botany Family and Children's Centre?

Answer-

In 2010-11, the Department of Family and Community Services, Community Services budget provides information on funding to non-government providers. Botany Family and Children's Centre is neither located in the Maroubra electorate nor a community centre.

*0796 EASTERN BEACHES LOCAL AREA COMMAND—PROBATIONARY CONSTABLES—Mr Michael Daley asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

How many probationary constables did Eastern Beaches Local Area Command (LAC) receive in the May 2011 and August 2011 attestations?

Answer-

The NSW Police Force has advised me that the Eastern Beaches Local Area Command was allocated two Probationary Constables from the May 2011 attestation and a further four Probationary Constables from the August 2011 attestation.

- *0797 PUBLIC AND HIGH SCHOOL FTE STAFF—Mr Michael Daley asked the Minister for Education—
 - (1) What is the total current full-time equivalent (FTE) staff employed in 2011 at public and high schools in the Maroubra electorate in Department of Education and Communities Schools?
 - (2) What is the breakdown of FTE staff numbers per school?
 - (3) What is the breakdown of FTE staff numbers per school broken down by the following position:
 - (a) teachers;
 - (b) support staff;
 - (c) administration?

Answer-

(1) At census day 2011 government schools in the Maroubra electorate had a total of 321.752 full-time equivalent positions.

(2) and (3) The total full-time equivalent positions at each school and a breakdown by teachers and by school administrative and support staff (SASS) including school administrative manager, school administrative officer, school learning support officer, SASS supplementation, Aboriginal education officer and general assistant positions is as follows:

- *0798 REVIEW OF IMPLEMENTATION OF NSW KIDS—Mr Michael Daley asked the Minister for Health, and Minister for Medical Research—
 - (1) At what stage is the current review of the implementation of NSW Kids as recommended by Commissioner Garling?
 - (2) When is the review expected to be released?

Answer—

I am advised:

- (1) and (2) The Expert Group convened to advance the implementation of Recommendations 9, 10 and 11 of the Garling Report (concerning the establishment of a Children and Young People's Health Authority, to be known as NSW Kids) held its inaugural meeting on 15 September 2011. The Chair of the Expert Group is expected to report by the end of the year.
- *0799 SCHOOLS AS COMMUNITY CENTRES—Mr Michael Daley asked the Minister for Education—
 - (1) What schools in the Maroubra electorate operated in the Schools as Community Centres program in June 2010?
 - (2) What schools operated as Schools as Community Centres in August 2011.

Answer-

- (1) In June 2010 there was one Schools as Community Centres project in the Maroubra electorate located at Maroubra Bay Public School, outreaching to the South Coogee community.
- (2) No schools operated as Schools as Community Centres in August 2011.
 - As a result of increased enrolments at Maroubra Bay Public School in 2011, the school was no longer able to accommodate the project which closed on 30 June 2011.

The Department of Education and Communities has been advised that the South Randwick Community Hub project has been funded through the Families NSW strategy for a three-year period in 2011-12 to 2013-14, to continue the provision of support to families with young children in the Maroubra area.

*0800 SOUTHERN CLINICAL SUPPORT DIVISION SERVICES—Mr Michael Daley asked the Minister for Health, and Minister for Medical Research—

- (1) Could the Minister advise and provide a list of exactly what services were provided by the Southern Clinical Support Division (Cluster)?
- (2) Can the Minister confirm that each and every one of these services will continue to be provided by each of the Local Health Districts in the Southern Cluster (i.e. South Eastern Sydney LHD, Illawarra Shoalhaven LHD, Murrumbidgee LHD, Southern NSW LHD)?

Answer-

(1) and (2) On 24 August 2011 I announced the outcome of the Governance Review of NSW Health. The proposed changes are outlined in detail in the report titled "Future Arrangements for Governance of NSW Health - Report of the Director-General". A copy of this report is available on the Department of Health's website: www.health.nsw.gov.au

Services currently managed by the Health Reform Transition Organisations will be devolved to other health entities, principally to Local Health Districts. Full details will be confirmed when the final transition plan is completed, which is scheduled to occur by the end of October 2011.

- *0801 CHICHESTER PIPELINE—LEAD POISONING—Ms Sonia Hornery asked the Minister for the Environment, and Minister for Heritage—
 - (1) Are farmers along the Chichester pipeline concerned about the pipeline shedding lead and the potential lead poisoning of livestock?
 - (2) Has the Government ordered Hunter Water to test the areas along the pipeline from Chichester to residential Shortland, following the death of a calf from lead poisoning?

Answer—

I am advised as follows:

- (1) Some farmers and their livestock have been affected by the contamination legacy caused by the shedding of the lead collars used to seal the joints along the Chichester pipeline.
- (2) Hunter Water Corporation has been undertaking testing in its management of the contamination issue.
- *0802 LONGWORTH AVENUE PAVEMENT REHABILITATION—Ms Sonia Hornery asked the Treasurer representing the Minister for Finance and Services, and Minister for the Illawarra—
 - (1) When will Hunter Water Corporation begin the design process for the replacement of the two trunk mains in Longworth Avenue, Wallsend, namely Valve house and Newcastle Road pumping station, constructed in 1884 and 1902 respectively, to allow Newcastle City Council to undertake the necessary major road rehabilitation works in the street?
 - (2) What will be the cost of the replacement of the two trunk mains?
 - (3) How long will the project to replace the two trunk mains take?

Answer-

- (1) Hunter Water is yet to be contacted by Newcastle City Council regarding road works in Longworth Avenue. Hunter Water is currently upgrading the Wallsend Pump Station.
- (2) Project costs would depend on the scope and complexity of the works required.
- (3) Project timeframes would depend on the necessary planning approvals, as well as the scope and complexity of the works required.
- *0803 TRAIN SECURITY ON HUNTER LINE—Ms Sonia Hornery asked the Minister for Transport—
 - (1) In the light of the tragic and needless death of a defenceless, homeless man travelling on a train in the early hours between Newcastle and Cardiff, can the Minister assure commuters that there are security guards on each and every train to ensure their safety?
 - (2) Why was the Minister initially unable to confirm if there were security guards on the train the elderly man was travelling on?

Answer-

I am advised:

(1) and (2) Transit Officers are deployed to the areas and at the times they are most needed based on gathered intelligence.

In May 2011, RailCorp increased the presence of Transit Officers in the Central Coast and Hunter areas from 7 on night shift on Thursdays, Fridays, Saturdays and Sundays to 24 patrolling trains and stations 24 hours per day, 7 days per week.

- *0804 HUNTER WATER—PAYMENT OF DIVIDENDS—Ms Sonia Hornery asked the Treasurer representing the Minister for Finance and Services, and Minister for the Illawarra—
 - (1) Has the Government reneged on its promise to freeze dividend payments from Hunter Water which are vital for water infrastructure and other water programs?
 - (2) Is this increase likely to cause an increase in water charges to consumers in the Hunter?

Answer—

- (1) Hunter Water's State of Corporate Intent for 2011-12 can be found on the NSW Parliamentary website.
- (2) Hunter Water's pricing is set by the Independent Pricing and Regulatory Tribunal.
- *0805 ROLL OUT OF JUSTICE LINK—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
 - (1) Has the roll out of Justice Link for Civil matters been completed for the:
 - (a) Local Court:
 - (b) District Court;
 - (c) Supreme Court?
 - (2) If the answer to any of the categories above is no, when is it anticipated it will be completed?

Answer—

I am advised:

- (1) (a) to (c) Yes.
- (2) Not applicable.
- *0806 SUPPORTED ACCOMMODATION—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

What programs and initiatives and at what cost are run by Corrective Services to provide supported accommodation to people leaving custody who are at risk of homelessness?

Answer—

I am advised:

Corrective Services NSW is lead agency for 3 projects under the NSW Homelessness Action Plan:

- Targeted Housing Support for ex-prisoners: a 3-year project 2010-2013 with a budget of \$980.000 per annum;
- People refused bail on the basis of homelessness: a 3-year project 2009-2012 with a budget of \$220,000 per annum; and
- Sustaining tenancies for ex-prisoners in Far West NSW: a 3-year project 2010-2013 with a budget of \$180,000 per annum.

In addition, Community Offender Support Program Centres (COSPs) provide accommodation to people leaving custody or subject to community based sentences who are at risk of homelessness.

Corrective Services NSW also provides funding to three non-government organisations for supported or transitional accommodation to recently released prisoners. These include Guthrie House, Glebe House and Rainbow Lodge. Details are provided in the Department of Attorney General and Justice Annual Report.

- *0807 COMPLIANCE AND MONITORING OFFICERS—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
 - (1) How many Compliance and Monitoring Officers are employed by Correctional Services?
 - (2) How many Home visits to offenders have been carried out by Compliance and Monitoring Officers in the period:
 - (a) 1 January 2010 to 30 June 2010;
 - (b) 1 July 2010 to 31 December 2010;
 - (c) 1 January 2011 to 30 June 2011?

Answer-

I am advised:

- (1) As of 26 September 2011, Corrective Services NSW employed 71 Compliance and Monitoring Officers and 17 Senior Compliance and Monitoring Officers.
- (2) In the periods in question, Compliance and Monitoring Officers have carried out the following numbers of visits to offenders (including home visits, field visits and workplace visits):
 - (a) 19,340.
 - (b) 16,161.
 - (c) 18,040.
- *0808 COMMUNITY OFFENDER SUPPORT PROGRAM CENTRES—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

How many offenders have been dealt with by Community Offender Support Program Centres in the following periods:

- *0809 CASUAL CORRECTIONAL OFFICERS—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

How many casual correctional officers were employed in NSW in these periods:

- (a) 1 January 2010 to 30 June 2010;
- (b) 1 July 2010 to 31 December 2010;
- (c) 1 January 2011 to 30 June 2011?

- (a) 273 new casual correctional officers were employed between 1 January 2010 and 30 June 2010.
- (b) 66 new casual correctional officers were employed between 1 July 2010 and 31 December 2010.
- (c) 71 new casual correctional officers were employed between 1 January 2011 and 30 June 2011.
- *0810 COURT REFERRAL OF ELIGIBLE DEFENDANTS INTO TREATMENT—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

What was the outcome of the Court Referral of Eligible Defendants Into Treatment (CREDIT) Program commenced in Tamworth and Burwood Courts in August 2009?

Answer-

The Bureau of Crime Statistics and Research will be completing its evaluation of the CREDIT program by the end of 2012.

*0811 YOUTH CONDUCT ORDER PROGRAM—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

What has been the result of the 2-year trial of the new Youth Conduct Order Program commenced in 1 July 2009 in the New England, Camperdown and Mt Druitt local area commands?

Answer-

I am advised:

Following an interim evaluation, the pilot project has been extended to February 2012 and the number of participating Local Area Commands (LACs) has been increased to include Liverpool, Macquarie Fields, Blacktown and St Marys LACs.

*0812 INCIDENTS OF SELF HARM—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

How many incidents of self harm occurred in Juvenile Justice Centres in NSW in the following periods:

- (a) 1 January 2010 to 30 June 2010;
- (b) 1 July 2010 to 31 December 2010;
- (c) 1 January 2011 to 30 June 2011?

Answer-

- (a) 1 January 2010 to 30 June 2010—96
- (b) 1 July 2010 to 31 December 2010—69

- *0813 COBHAM JUVENILE JUSTICE CENTRE—CUSTODIAL ACCOMMODATION UNITS—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
 - (1) Has the construction of three custodial accommodation units at Cobham Juvenile Justice Centre commenced?
 - (2) If so, what progress has been made in construction?

Answer-

Stage 1 of the Cobham Juvenile Justice Centre redevelopment project, which is the construction of the three accommodation units, new car parking and infrastructure work, is 30 per cent complete.

*0814 BAIL ASSISTANCE LINE—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

What progress has been made in piloting a Bail Assistance line for young people in Sydney, Newcastle and Dubbo?

Answer-

The Bail Assistance Line has been operational since June 2010. The service commenced in Dubbo in June 2010 and expanded to include the south-western Sydney metropolitan region in August 2010 and the Newcastle/Hunter region in November 2010.

Since its launch, the Bail Assistance Line has received approximately 165 calls for assistance, providing transport, advice, case support and assessment services, as well as providing safe accommodation for 46 young people. The Bail Assistance Line has successfully diverted young people who, without access to such a service, could have ended up in detention.

Following an analysis of demand for services, resources providing supported accommodation for the Dubbo pilot were diverted to enhance bed availability in the Sydney metropolitan area effective September 2011. Police within the Dubbo area are still able to access telephone services from the Bail Assistance Line.

The Intensive Supervision Program (ISP) in Juvenile Justice has been in operation since May 2008. The program has been established in two locations, Newcastle and Western Sydney.

Over the last 12 months, 50 families commenced and 64 per cent completed the program.

Aboriginal families comprised 34 per cent of those that commenced the program. Of the Aboriginal families that commenced the ISP, 71 per cent completed the program.

The Bureau of Crime Statistics and Research (BOCSAR) will complete an evaluation of the ISP in 2012.

Answer-

The NSW Police Force has advised me that the new Oak Flats police station has been constructed in accordance with the Council approved development application.

*0818 ROAD TRANSPORT AUTHORITY—MAXIMUM WIDTH REQUIREMENTS—Mr Guy Zangari asked the Minister for Transport representing the Minister for Roads and Ports—

What policies and/or procedures does the Government have in place to allow businesses to transport inventory on NSW roads that are over the Road Transport Authority's maximum width requirements?

Answer—

I am advised:

The width dimension limit for vehicles in NSW and nationally is 2.5 metres. This width dimension limit is based on the national model law, which is adopted in NSW in the Road Transport (Vehicle Registration) Regulation 2007.

The Road Transport (Mass, Loading and Access) Regulation 2005 authorises the Roads and Traffic Authority (RTA) to issue exemptions to dimension limits via permits and notices.

The RTA issues oversize permits to operators for the transportation of indivisible loads which exceed 2.5 metres in width. The vehicles may only operate on specified routes, and are subject to access conditions to ensure the safety and protection of other road users and road infrastructure.

The RTA also allows vehicles transporting baled wool, hay and straw to exceed the 2.5 metre width limit up to a maximum of 2.7 metres wide via the Class 3 Baled Wool Exemption Notice 2011 and Class 3 Baled or Rolled Hay and Straw Exemption Notice 2011. These exemptions were introduced in recognition of the unique challenges of baling, loading and transportation of baled loads.

It is a condition that the baled load must be loaded within the 2.5 metre constructed width limit of the vehicle. An additional 100 millimetres either side of the load is allowed to accommodate the "bulge" that occurs during the loading and transportation of the particular baled products.

Loads of baled wool, hay and straw up to 2.6 metres wide have general access to the NSW network. Loads between 2.6 metres and 2.7 metres are subject to clearway, transit lane and critical location restrictions, and are subject to road safety conditions, including warning devices.
