- \*7500 FREE SHUTTLE BUS FOR ROADS AND MARITIME SERVICES EMPLOYEES—Mr Paul Scully asked the Minister for Roads, Maritime and Freight—
  - (1) Has the free shuttle bus to transport Roads and Maritime Services employees from Sydney CBD to Rozelle three times daily been cancelled?
    - (a) If so, on what date was the service cancelled?
    - (b) If not, why not?

Answer-

I am advised:

The shuttle bus which transports Roads and Maritime Services employees from the Sydney CBD to Rozelle has not been cancelled. Roads and Maritime has a commercial contract in place with the shuttle service provider.

This service was an enterprise bargaining condition agreed to in recognition of the limited public transport options available.

Roads and Maritime's office located within the industrial precinct at Rozelle is similar to other large employers in the business precinct providing a shuttle bus service for staff.

Non-discretionary payments from the Public Purpose Fund can only made for the purposes of regulating the legal profession in New South Wales, pursuant to section 53 of the Legal Profession Uniform Law Application Act 2014.

### Answer-

I am advised:

On Demand transport allows people to book a vehicle to pick them up from home or a convenient local location like a bus stop using an app, website or phone.

On Demand pilots are currently underway at various locations across greater Sydney.

Initially, the pilots will run alongside existing services and help inform Transport for NSW's thinking for future service contracts and create potential opportunities for new models and entrants in the transport network of the future.

Incremental patronage growth has been strong for the Premier On Demand Service since the service started on 2 January 2018, with results showing consistent week-on-week growth and continued positive community and customer feedback.

The operational zones were determined by the proponent, and chosen based on a range of operational factors including the number of vehicles allocated per zone and an ability to meet estimated maximum journey times.

\*7504 FULL-TIME EQUIVALENT PARAMEDICS IN THE ILLAWARRA—Mr Paul Scully asked the Minister for Health, and Minister for Medical Research—

What is the number of full-time equivalent Paramedics in the Illawarra in each year from 2012 to 2018 (as at 13 February 2018)?

#### Answer-

I am advised that the number of Paramedic positions across the Illawarra Zone Stations has increased by over 20.0 full-time equivalent during this period.

Sydney Trains performance is measured by punctuality. This information is available on the Sydney Trains website. Services that are cancelled are not considered on time for the purposes of punctuality reporting.

\*7507 WOLLONGONG HOSPITAL CONCESSION PARKING—Mr Paul Scully asked the Minister for Health, and Minister for Medical Research—

- (1) How many people applied for concessions for parking at Wollongong Hospital (to 13 February 2018)?
  - (a) How many concessions have been issued (as at 13 February 2018)?
- (2) What were the top five reasons for refusing applications for concession?

Answer-

I am advised that Wollongong Hospital does not record the number of concession parking applications received.

Applicants who meet the criteria are issued concessions for parking.

- \*7508 PASSENGER DATA ON NEWCASTLE BUSES—Ms Sonia Hornery asked the Minister for Transport and Infrastructure—
  - (1) What methods are used for the collection of passenger data on Newcastle Buses?
    - (a) What guidelines exist to set out methodologies for the collection and reporting of this data?
    - (b) What guidelines exist for the publication of this data?

Passenger travel data is collected from Opal readers. Guidelines are in place and are available on the Opal website.

\*7510 SCHOOLS IN FLETCHER—Ms Sonia Hornery asked the Minister for Education—

What plans exist to ensure that schools in the Fletcher area are capable of incorporating expected demand for rising populations of young families?

Answer-

I'm advised that the Fletcher area is currently serviced by the Glendore and Minmi Public Schools, Callaghan College Wallsend and Jesmond secondary schools.

I'm further advised that these schools are adequate to meet the enrolment demand.

Planning to meet future school needs is well advanced. This includes identifying long-term educational requirements of the area and assessing options to meet future enrolment demand.

\*7511 OLD WALLSEND FIRE STATION SITE—Ms Sonia Hornery asked the Minister for Police, and Minister for Emergency Services—

What are the current plans for the use of the old Wallsend Fire Station site?

\*7512 2018 LEGAL TOPICS FOR OLDER PEOPLE DIARY—Mr Paul Lynch asked the Attorney General—

How much was spent preparing, publishing, printing and distributing the NSW Legal Aid Legal Topics for Older People Diary 2018?

Answer-

I am advised:

The NSW Legal Aid Legal Topics for Older People Diary 2018 (the diary) is available free of charge and provides older people across NSW with essential information about their legal rights, legal services and resources in an accessible and useful format.

There were 55,000 diaries produced in 2018, with more than 38,000 pre-orders for the diary from sponsor organisations, libraries offices and community organisations.

The cost of preparing, publishing, printing and distributing the diary was contributed to by a mixture of government and non-government organisations including Legal Aid NSW, the Department of Family and Community Services, Law Society of NSW, NSW Trustee & Guardian, Seniors Rights Service, NSW

Elder Abuse Helpline and Resource Unit, Financial Ombudsman Service Australia, Credit & Investments Ombudsman and the Energy & Water Ombudsman NSW.

\*7513 JUST REINVEST NSW PRE-BUDGET SUBMISSION—Mr Paul Lynch asked the Attorney General—

What is your response to the Just Reinvest NSW Pre-Budget submission?

Answer-

I am advised:

The Just Reinvest NSW pre-budget submission is being considered in the context of wider work being done to address the overrepresentation of Aboriginal and Torres Strait Islander people in the criminal justice system and to increase community safety.

\*7514 DOMESTIC VIOLENCE CLAIMS—Mr Paul Lynch asked the Attorney General—

In light of comments on page 121 of the Department of Justice's Annual Report 2016-17, in what ways have the number of domestic violence claims changed in the last three years?

Answer-

I am advised:

The number of applications from victims of domestic violence have changed over the last couple of years as more victims are accessing the Victims Support Scheme (VSS). The increase is mainly driven by Government initiatives aimed at helping domestic violence victims gain direct access to the Victims Services section of the Department, such as the state wide rollout of Safer Pathway, and an increased media focus on family violence which may increase awareness and usage of assistance from the VSS.

- \*7516 LEGAL EXPENDITURES REPORTED TO NSW PROCUREMENT—Mr Paul Lynch asked the Minister for Transport and Infrastructure—
  - (1) Considering the responses to LA Q7192 and LA Q7193, what was the amount of legal expenditures reported to NSW Procurement by each cluster of NSW Government agencies for the 2016-17 financial year?
  - (2) What was the total legal expenditures reported to NSW Procurement by General Government agencies for the 2015-16 and 2016-17 financial years?

Answer—

Transport for NSW reports NSW Government Legal Services Panel billings to the NSW Procurement Board.

These billings are available in the NSW Government Legal Services Panel annual report for the 2016-17 financial year, which is publicly available on the website of the Department of Justice.

As the NSW Government Legal Services Panel commenced on 1 July 2016, this information is not available for the 2015-2016 financial year.

\*7517 CAMDEN COURT HOUSE—Mr Paul Lynch asked the Attorney General—

What are the plans for the development of Camden Court House?

- \*7518 LIFELINK PROGRAM—Mr Paul Lynch asked the Attorney General—
  - (1) Why has the LifeLink Program used by marriage celebrants not yet been upgraded to take account of changes to Marriage Legislation in December 2017?
  - (2) When will the LifeLink Program be updated?
  - (3) What is the estimated cost of the upgrade of the LifeLink Program?

Answer-

- (1) Marriage celebrants do not have access to the Lifelink program and do not use it to register marriages.
- (2) The Lifelink program, and other electronic programs used by the NSW Registry of Births Deaths &

Marriages, are currently being updated.

### \*7519 PRIVACY MANAGEMENT PRACTICES—Mr Paul Lynch asked the Attorney General—

What steps have you or your Department taken to monitor or improve the privacy management practices and capacity of non-government organisations that have received Government funding to deliver services?

Answer-

I am advised:

Non-government organisations engaged to deliver services on behalf of the Government are required to comply with privacy obligations outlined in their contracts of engagement.

Standard clauses in funding deeds also require non-government organisations to comply with the Information Privacy Principles of the Privacy and Persona/Information Protection Act 1998 when handling the personal information of individuals they engage with in the course of delivering funded services.

Non-government organisations in New South Wales which have an annual turnover of more than \$3 million are also required to comply with the Commonwealth Government's Privacy Act 1988.

- \*7520 FREE BUS TRAVEL FOR YEARS 3 TO 6 STUDENTS—Mr Ryan Park asked the Minister for Transport and Infrastructure—
  - (1) Are students in Years 3 to 6 eligible for free bus travel to and from school if they live:
    - (a) 2.2 kilometres from their school?
    - (b) 2.3 kilometres from their school?
  - (2) Is terrain between a child's house and school taken into account when determining elibility for a bus pass?
  - (3) Is there any consideration of risks associated with a child walking to school if they are ineligible for a bus pass on the basis of their walking distance, for example crossing busy roads/major highways?

This information is available on the School Student Transport Scheme website.

\*7521 DOMESTIC VIOLENCE IN ORANGE—Mr Philip Donato asked the Minister for Police, and Minister for Emergency Services—

What steps are you, as Minister for Police, and the Government undertaking to reduce the incidence of domestic violence in Orange, which is reportedly twice that of the State average?

Answer—

Through the investment of more than \$350 million over four years, the Government has taken concrete steps to improve the safety of domestic and family violence victims and hold perpetrators accountable.

The Safer Pathway program, which is an important component of the Government's domestic and family violence reforms, was successfully launched in two sites, one of which was Orange, in September 2014. The Government will continue to roll out Safer Pathway investing \$13 million in the 2017-18 budget.

Additionally, in the 2017-18 budget the Government committed:

- \$25 million for Start Safely, to help people escaping violence move into stable housing in the private rental market;
- More than \$10 million for behaviour change interventions for high-risk offenders;
- \$10 million for Women's Domestic Violence Court Advocacy service to support victims through the criminal justice system;
- \$6.2 million for Staying Home Leaving Violence to support women and their children to remain safely at home;
- \$5.1 million for the NSW Police Force High Risk Offender Teams, which includes the continued rollout of new teams in 2017-18:
- \$4 million to support a trial of the core and cluster accommodation model to increase capacity of women's refuges;
- \$4.9 million for non-government organisation led community based perpetrator interventions;
- \$3.7 million in support of the multi-agency Integrated Domestic and Family Violence Service

Program;

• \$1.7 million for the NSW Domestic Violence Line.

Additionally, under reforms by this Government the NSW Police Force has the power to issue provisional Apprehended Domestic Violence Orders (ADVOs) to help provide immediate protection to domestic violence victims. Domestic Violence Suspect Target Management Plans targeting repeat domestic violence offenders were rolled out state-wide in February 2016.

In addition, I am advised:

The Central Western Police District was one of the first to use the Domestic Violence Safety Assessment Tool and to participate in Safety Action Meetings to proactively reduce the risk of harm to domestic violence victims.

The new District has a Domestic Violence Officer and a Domestic Liaison Officer at both Orange and Parkes, specialising in enforcement and victim support respectively, who also work with the Districts Proactive and Property Investigation Team when conducting Apprehended Violence Order compliance operations.

- \*7522 CORRESPONDENCE CONCERNING NOISE MITIGATION AT TREWILGA—Mr Philip Donato asked the Minister for Roads, Maritime and Freight—
  - (1) When can I expect a response to the letter sent to your office dated 27 October 2017, in which I detailed concerns raised by my constituent regarding Roads and Maritime Services proposals that relate to noise mitigation at Trewilga and reported subsequent significant adverse effects suffered by my constituent and his family?

      - (iii) How many Transport for NSW representatives travelled on each of those trips?
      - (iv) What is the total cost of overseas trips since the sign-off on the contract for the New Intercity Fleet?

What regulation is in place to protect people from the targeted advertising of instant cash loans?

Regulation of instant cash loans is the responsibility of the Australian Securities and Investments Commission (ASIC).

\*7526 NSW STOLEN GENERATIONS REPARATIONS SCHEME AND FUNERAL ASSISTANCE FUND—Ms Jodie Harrison asked the Minister for Education representing the Minister for Early Childhood Education, Minister for Aboriginal Affairs, Assistant Minister for Education—

What is the Government doing to promote the NSW Stolen Generations Reparations Scheme and Funeral Assistance Fund?

Answer\_

In response to the General Purpose Standing Committee No. 3 report into reparations for the Stolen Generations Unfinished Business the Government has invested \$75 million in reparations initiatives. This included the establishment of the Stolen Generations Reparations Scheme and Funeral Assistance Fund that commenced on 1 July 2017. The Reparations Scheme will run until 31 December 2022, and the Funeral Assistance Fund will run as long as needed. As at 19 March 2018 a total of \$21.7 million has been paid in reparation and funeral assistance payments to Stolen Generation survivors.

The remainder of the funding is allocated to the establishment of a Stolen Generations healing fund and financial support to Stolen Generations organisations.

An extensive media campaign was rolled out in late June 2017 to publicise the opening of the Stolen Generations Reparations Scheme (SGRS). This included public notices in all key state wide, regional and indigenous press along with online digital public notices in the Koori Mail Online and the National Indigenous Times Online.

In addition, specific briefings were held for key stakeholders and information about the eligibility requirements of the Scheme along with application forms and various Fact Sheets relating to a variety of SGRS issues were posted on the Aboriginal Affairs Website - https://www.aboriginalaffairs.nsw.gov.au/healing-and-reparations/stolen-generations.

Ongoing, targeted and trauma informed promotion of the Scheme is being undertaken on a regular basis through conversations with key stakeholder organisations including Legal Aid NSW, Aboriginal Health and Medical Research Council NSW and LinkUP NSW.

Aboriginal Affairs considers the advice of Stolen Generations survivors in formulating all communication strategies as it is critical in understanding and minimising the trauma that can be experienced by survivors when confronted by media and other publicity relating to Stolen Generation issues.

In 2017 the Stolen Generations Advisory Committee was established to support the implementation of the New South Wales Government Response to 'Unfinished Business' including the Scheme and Funeral Assistance Fund. The Stolen Generations Advisory Committee reports to the Minister for Aboriginal Affairs and the Premier on issues impacting on Stolen Generations survivors.

Through the Advisory Committee representatives from the four New South Wales Stolen Generations Organisations – Kinchela Boys' Home Aboriginal Corporation, Coota Girls Aboriginal Corporation, Children of the Bomaderry Aboriginal Children's Home Incorporated and the New South Wales/Australian Capital Territory Stolen Generations Council – work with government officials from the Departments responsible for delivering services or supports for Stolen Generations survivors.

The Advisory Committee meets quarterly and regular updates are discussed regarding the Scheme and Funeral Assistance Fund.

Why did the 48 bus service, due at Charlestown at 3:55 pm, arrive at 4:20 pm on 6 February 2018?

The bus used to run the 48 bus service was delayed due to heavy traffic on its previous run. As a result, the 48 bus service ran late and reached Charlestown at 4.19pm.

- \*7531 RETURN AND EARN SCHEME—Ms Jo Haylen asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
  - (1) What are the impacts on the Return and Earn scheme of China's decision to stop importing recyclable materials from Australia?

- \*7532 DEPARTMENT OF PLANNING'S CHARACTER STATEMENTS—Ms Jo Haylen asked the Minister for Planning, Minister for Housing, and Special Minister for State—
  - (1) What legal impact will the Department of Planning's character statements have on the determination of the Sydenham to Bankstown Urban Renewal strategy?
  - (2) Will the proposed statements incorporate recommendations that councils will be required to integrate into amended Local Environment Plans?
    - (a) Will the Sydney Planning Panel or Greater Sydney Commission have to refer to or incorporate these character statements?
      - (i) If so, how?
  - (3) How will these character statements impact development approvals along the corridor?

Answer-

I am advised:

The Department is currently in the process of finalising the submissions report for the public exhibition of the Sydenham to Bankstown Urban Renewal Strategy that occurred in 2017. The planning response to the issues and challenges raised by over 2,800 submissions will be informed by the Local Character Statement.

The Local Character Statements will define the elements of the precinct that the community values. It will ensure that the existing and desired future local character is acknowledged in all future planning for the precinct.

The recent changes to the Environmental Planning and Assessment Act 1979 recognise the critical role of councils in strategic planning for their local area. Under the changes each council will prepare a local strategic planning statement which will set out the 20-year vision for land-use in the local area, the special character and values that are to be preserved and how change will be managed into the future. The statements will need to align with the regional and district plans, and the council's own priorities in the community strategic plan it prepares under local government legislation.

The statements will shape how the development controls in the local environmental plan (LEP) evolve over time, with the LEP the main tool to deliver the council and community's plan.

I'm advised that as at 13 February 2018, there were 81 mathematics related vacancies across New South Wales, two of which were in the Macquarie Fields electorate.

As part of the Government's commitment to Science, Technology, Engineering and Mathematics (STEM), 320 public school teachers are being provided scholarship opportunities to train as specialists in mathematics and science over a four year period commencing in 2015, increasing the supply of highly trained teachers in key foundation learning areas.

If a teaching position in a school does not have a permanent occupant, the Principal will engage a qualified casual or temporary employee, endorsed by the NSW Department of Education, to support in the delivery of the school's educational and curriculum priorities.

Principals are responsible for the teaching allocation, resourcing and monitoring of all subjects offered within the school. Schools monitor student achievement of learning outcomes in all subjects through a variety of school-based and external assessments.

A total of 139 teachers applied for the scholarship in 2017.

In 2018, 90 scholarships will be made available for the 2019 STEM scholarships for science and maths program.

In addition, the department offers cadetships, internships and teach. Rural scholarships to students seeking to qualify as teachers in subject areas and locations of workforce need, including mathematics; physics; technological and applied studies, particularly engineering studies and industrial technology including design and technology; and special education.

The station will remain in operation 24 hours a day, seven days a week with no change to the availability of police crews. What are you doing, as the Minister for Western Sydney, to ensure schools in Western Sydney are adequately air conditioned?

#### Answer—

I'm advised public schools that are eligible for air cooling under the Department of Education's Air Cooling Policy are identified by the department and prioritised in a program of necessary works.

The department cools all habitable spaces in New South Wales public schools located in areas that have a mean maximum January temperature of 33 degrees celsius or higher. In addition to this, air cooling is provided in schools with students that have special needs, in all demountable teaching spaces, and in those areas where temperature combined with humidity is likely to cause heat stress.

Any public school below the policy threshold may make a local decision to install air-conditioning at their cost.

The department has a set of design standards that recommend sustainable and cost effective approaches to improving thermal comfort in schools via passive measures such as insulation, sunscreens, improved ventilation and appropriately designed landscaping. These measures have been included in the design for the upgrade of this school.

- \*7550 DEVELOPMENT HEIGHT LIMITS—Mr Anoulack Chanthivong asked the Minister for Planning, Minister for Housing, and Special Minister for State—

Why do parts of the Ingleburn CBD, that is a 47-minute train ride to the Sydney CBD, have an uncapped development height limit when other areas closer to the CBD by train such as Wollstonecraft, Oatley, Revesby and Roseville have development height limits less than 14 metres?

### Answer-

### I am advised:

The Precinct Plan for Ingleburn is a strategic plan that provides guidance about the future character of the precinct. It does not remove current height limits. It identifies where medium and high-rise development could potentially occur subject to future rezoning. Until Campbelltown City Council puts forward planning proposals, the current planning controls will continue to apply.

The precinct plans for the Glenfield to Macarthur corridor supports the growth of local jobs by reinforcing Campbelltown and Macarthur as a Metropolitan City cluster with a health and education precinct. This is complemented by employment growth in each precinct. Ingleburn is less than 20 minutes by train to Campbelltown.

\*7551 FUELCHECK NSW—Mr Clayton Barr asked the Minister for Finance, Services and Property—

- (1) Since its launch, how many downloads of the FuelCheck NSW app have there been (as at 15 February 2018)?
- (2) Did the Government partner up with any start-ups to launch the FuelCheck NSW app?
- (3) How much did the FuelCheck NSW app cost to develop?
- (4) What is the projected annual cost to maintain the FuelCheck NSW app?
- (5) Has the FuelCheck NSW app had any technical difficulties that have arisen since the launch?

### Answer-

Five Service Centres have opened and are located at Maclean, Murwillumbah, Gunnedah, Wentworth and Muswellbrook. On 8 March 2018, Glen Innes and Wellington were undergoing fit out and preparation works. On 8 March 2018, 17 motor registries were in operation and are located at Walgett, Lightning Ridge, Leeton, Narrandera, Yass, Moree, Finley, Hay, Cootamundra, Tumut, Tenterfield, Nambucca Heads, Wauchope, Springwood, Nyngan, West Wyalong and Forbes.

I am advised that five Roads and Maritime Services Employees were successful in gaining roles with Service NSW at Maclean, Murwillumbah, Gunnedah, Wentworth and Muswellbrook Service Centres.

The redundancy process is managed by Roads and Maritime Services. All Roads and Maritime Services registry employees are invited to apply for roles at Service NSW via a priority recruitment process ensuring they have the first opportunity to secure roles. Staff members that choose not to apply are offered voluntary redundancy or redeployment where opportunities existed.

As at 8 March 2018, the overall program timeline remained on track.

## \*7553 PRIVATE OPERATORS AND SERVICE NSW CONTACT CENTRES—Mr Clayton Barr asked the Minister for Finance, Services and Property—

- (1) How many calls to Service NSW Contact Centres have been handled by the eight private operators as identified in the Service NSW (One-stop Access to Government Services) Amendment (Approved Persons) Regulation 2017?
- (2) What is the definition of "overflow" as referred to in the Regulation?
- (3) What is the definition of "after-hours" as referred to in the Regulation?
- (4) Where are the headquarters of these private operators located?
- (5) What training or advice is provided to these private operators prior to them taking calls on behalf of Service NSW?
- (6) Have there been any formal complaints about the conduct or response of these private operators by customers (as at 15 February 2018)?

- (a) If so, how are these complaints handled?
- (b) Who is responsible for providing feedback and advice to the private companies on improving customer service?

#### Answer—

As at 28 February 2018, 11 per cent of the total amount of calls made to Service NSW contact centres were answered by the singular outsourced contact centre provider DataCom. On 15 February 2018, there was no reference to 'overflow' or 'after-hours' in the Service NSW (one-stop Access to Government Services) Regulation 2013. Contact details for the approved persons listed in the Service NSW (one-stop Access to Government Services) Regulation 2013 are publicly available.

An outsourced provider will receive appropriately designed training and instruction relevant to the call types being answered prior to commencing work. Outsourced provider training is delivered by Service NSW to the same high standard that is delivered to Service NSW employees.

I am advised that Service NSW conducts weekly quality reviews of outsourced calls and monthly calibrations of all work types to ensure rigorous standards of quality, compliance and customer experience are maintained. Far less than 0.01 per cent of calls handled by an outsourced provider have resulted in a complaint. These complaints are handled by Service NSW in accordance with its Complaints Management Policy.

This blended Contact Centre model was established in 2013 and allows Service NSW to quickly scale up and down to meet customer demand.

- \*7554 DIVERSITY AT SERVICE NSW—Mr Clayton Barr asked the Minister for Finance, Services and Property—
  - (1) What programs or initiatives has Service NSW implemented to attract graduate and non-graduate Indigenous employees to assist in meeting the 3.3% benchmark?

  - (5) Are ESL employees strategically placed in locations that require their language skills and expertise (i.e. a Mandarin speaking individual is relocated to a Service NSW Centre that is close to a large Chinese community)?

#### Answer-

- (1) The Service NSW Aboriginal and Torres Strait Islander Employment and Community Engagement Plan 2018-2019 is being developed. Its main purpose is to increase representation of Aboriginal and Torres Strait Islander peoples throughout the Service NSW workforce.
- (2) and (3) The Service NSW network has grown. The overall number of Aboriginal and Torres Strait Islander employees has increased from 15 in January 2015 to 38 employees in December 2017.
- (4) Service NSW values the diversity of its workforce. For example, at least 20 language groups have been identified at the Parramatta Contact Centre and these are Punjabi, Hindi, Gujarati, Cantonese,

Arabic, Spanish, Bengali, Croatian, Macedonian, Bosnian, Serbian, Thai, Mandarin, Tagalog, Vietnamese, German, Syrian, Tongan, Samoan, and Marathi.

- (5) Yes.
- (6) No.
- (7) All Service Centres and Contact Centres offer customers free access to translating and interpreting Services.
- (8) Around 14 per cent of staff members at the Service NSW Contact Centres have advised that they speak a language other than English. The provision of this information is voluntary.
- (9) and (10) Employees are trained on the availability of translating and interpreting Services that are available for customers.
- (11) In addition to the language groups listed at the answer to no. 4, Greek, Italian, Portuguese, Persian, Dari, Korean, Nepalese, Indonesian, Laotian, Assyrian, Chaldean and Tamil are also represented in the Service NSW network.
- (a) Language support is offered at all Service Centres and Contact Centres for free through current workforce capability or through translating and interpreting services.
- (b) I am advised that Service NSW does not hold this information.
- \*7555 TEACHER HOUSING PROPERTIES—Mr Clayton Barr asked the Minister for Finance, Services and Property—
  - (1) How many properties are currently owned by Teacher Housing (as at 15 February 2018)?
    - (a) Of these properties, how many are currently occupied by teachers?
    - (b) Of these properties, how many currently do not have occupancy?
  - (2) Are applicants placed on a waiting list prior to being offered accommodation?
  - (3) Is maintenance undertaken by local tradespeople or Government contractors?
  - (4) What amount has Teacher Housing paid in maintenance costs in each year from 2011 to 2017?
  - (5) How many Teaching Housing properties were sold in each year between 2011 and 2017?
    - (a) What has been the total revenue for these sales?
  - (6) How many new Teacher Housing properties were purchased or constructed in each year between 2011 and 2017?
    - (a) What has been the total expense for the purchases and constructions?

#### Answer—

- (1) As at 15 February 2018, Teachers Housing Authority (THA) owns 1,180 properties and has 26 pieces of vacant land. THA also manages a further 106 properties owned by the Department of Education (DoE).

- (3) Yes, responsive repairs and maintenance are performed by local tradesmen sourced through an established network of managing agents. Refurbishment work of a larger scale is subject to a tender process in which local sub-contractors are engaged to undertake the work by the awarded contractor.
- (4) Teacher Housing paid in maintenance costs (including responsive repairs and refurbishments) the amount of \$11 million in financial year ended 30 June 2011, \$10.3 million in 2012, \$6.8 million in 2013, \$8.4 million in 2014, \$7.6 million in 2015, \$6.6 million in 2016 and \$7.2 million in 2017.

- (5) Teacher Housing sold 11 properties (including land) in financial year ended 30 June 2011, 35 properties in 2012, 25 properties in 2013, 44 properties in 2014, 26 properties in 2015, 10 properties in 2016 and 44 properties in 2017.

(1) The Government is delivering on its commitments in the Renewable Energy Action Plan, which was released in 2013 to increase renewable energy projects in New South Wales including wind and solar farms. This includes providing \$64.9 million in funding support for the development of the state's first major solar farms at Nyngan and Broken Hill.

Appointed under the Plan, the Renewable Energy Advocate has provided tailored support to 51 major renewable energy projects in New South Wales worth almost \$10 billion in potential investment. This includes facilitating the process of network connection and leveraging funding support from the Australian Renewable Energy Agency and Clean Energy Finance Corporation.

As a result, New South Wales is now home to four major solar farms and nine major wind farms with an additional 13 major renewable energy projects currently under construction across the state. The share of renewable energy in the New South Wales energy mix has more than doubled over the past six years.

New South Wales has around 12,000 megawatts of large-scale renewable energy projects that are either approved or in the New South Wales planning system, representing \$15 billion of potential investment. This is in addition to 1,300 megawatts of projects that are already under construction across the state in regional locations like Glen Innes, Dubbo, Parkes, Crookwell and Griffith.

- (2) The Government supports the achievement of the national Renewable Energy Target of 33,000 gigawatt hours of clean energy by 2020 and is working to remove barriers to investment under this target in New South Wales. The Government has an aspirational objective to achieve net zero emissions across the economy by 2050, and is focused on the transition to a modern, reliable and affordable energy future.
- (3) The Government is working to finalise implementation of the Renewable Energy Action Plan, removing unreasonable barriers to new renewable energy projects and business models. The Government is also working to finalise initiatives for funding under the Climate Change Fund.
- (4) and (5) The Government supports an orderly, private sector-led transition to a modern, reliable and affordable energy system, and supports the clean energy industry to deliver the investment needed to enable this transition. The Government is also working to finalise initiatives for funding under the Climate Change Fund.
- (6) Renewable energy sites are identified by the private sector and subject to rigorous, merit-based assessment through the New South Wales planning system. The Government assists the private sector to identify appropriate sites by providing information about the state's significant renewable energy resources in the NSW Renewable Energy Map, which can be found on the Department of Planning and Environment's website at www.resourcesandenergy.nsw.gov.au/energy-supply-industry/renewable-energy/renewable-resources-map.

The Government is also working with the Australian Energy Market Operator (AEMO) to support the development of an Integrated System Plan and identify the best locations for potential new energy zones in New South Wales. This plan will support the private sector to connect new renewable energy projects including wind and solar farms.

The Government has invested significant support in initiatives that build and strengthen social cohesion. The Community Partnership Action (COMPACT) Program supports an alliance of community partners who are committed to safeguarding social cohesion against fear, hate and division. The Premier's Fund for Social Cohesion is a grants program that supports community led events and activities that bring together people from a range of cultural backgrounds to celebrate diversity.

The Community Cohesion Ambassadors Program aims at empowering a team of community influencers and role models to stand united as champions for community harmony and deliver a strong, public message against hate, fear and division. Further, Multicultural NSW administers a Grants Program that provides funds to organisations to deliver community projects and activities that seek to strengthen community harmony and social cohesion.

Answer-

(1) Destination NSW owns, manages and produces Vivid Sydney on behalf of the Government and works with event partners, land owners and other government agencies to increase accessibility to the event.

In 2017, Cushman & Wakefield became Vivid Sydney's inaugural Accessibility & Inclusion Partner delivering financial support to develop a cohesive program to provide infrastructure and facilities to make the Vivid Light Walk accessible for all attendees.

A Vivid Sydney Access and Inclusion Coordinator is also engaged to assist access guests pre-plan their trip and to provide information about accessible services and facilities. To further enhance Vivid Sydney as an accessible and inclusive event for all guests, the Access and Inclusion Coordinator liaises directly with specialist disability and accessibility groups to facilitate Vivid Sydney's access and inclusion initiatives.

In 2017, more than \$107,000 was spent to make Vivid Sydney an inclusive event. Specific accessibility measures within the Vivid Sydney program include:

- Encouraging lighting designers creating installations for the Vivid Light walk to consider features to provide sensory, tactile, auditory or visual interactivity options to event goers
- Specially designed accessibility map, detailing routes that are level and avoid steps
- Accessible information booths at Circular Quay and Darling Harbour, with lower counter tops for access guests in wheelchairs, plus offering water bowls for Guide Dogs
- Text to Talk function via VividSydney.com, offering short descriptions of each Vivid Light Walk installation for screen reader or smartphone devices with accessibility options
- Audio described tours of Lighting of the Sydney Opera House Sails led by specially trained Sydney
  Opera House staff for people with vision impairment and their companions to experience the centre
  piece of Vivid Sydney
- Managed access areas for access visitors at Sydney Opera House and the Overseas Passenger Terminal, plus an all-weather managed accessible chill out zone at Darling Harbour which was undercover and located close to accessible amenities and ramps
- Dedicated drop-off zones and parking areas for access visitors
- Auslan interpreters at Vivid Ideas Game Changer major events and hearing loop systems at Game Changer venues including Roslyn Packer Theatre Walsh Bay and Sydney Town Hall.

(2) As the Government's tourism and major events agency, Destination NSW supports initiatives to assist the tourism industry in how to make attractions, destinations and events accessible to people of all ages and abilities, helping to promote maximum participation and enjoyment for all visitors to New South Wales.

Destination NSW works with event partners, landowners and other government agencies, to increase accessibility to events including Vivid Sydney and has been actively engaged in the Accessible Tourism Project, established by the NSW Department of Family and Community Services.

The Newcastle 500 took place for the first time in November 2017 and had dedicated facilities and services to ensure all attendees could make the most of the event. Specific information concerning accessible facilities, including wheelchair friendly viewing points and amenities was made available via the Supercars Australia website.

The following provisions were in place at all times during the three-day event:

- An accessible lift located at the pedestrian bridge on Wharf Road (opposite Customs House) with a lift operator to assist patrons.
- All residents with accreditatio0n had access to a wheelchair friendly shuttle service within the track.
- A pathway providing wheelchair access to Newcastle Ocean Baths, via the tunnel near Telford Street.
- The path at the east end of Scott Street to Shortland Esplanade provided wheelchair access to Newcastle Ocean Baths.
- A phone number was set up and communicated to the community for those requiring assistance.
- Two wheelchair accessible stands located trackside. Supercars Australia refers to these as 'Accessible Viewing Areas'.

In 2014-15, Parkes Shire Council received \$79,570 through the Contestable Fund of the Regional Visitor Economy Fund for cabin development and site upgrading at Spicer Caravan Park. The project sought to meet identified gaps in the market by providing sites for Recreational Vehicle (RV) travellers by levelling five unpowered sites, installing laybacks to an additional five sites and construct three high quality self-contained cabins, one of which is accessible.

In 2016-17, the Government supported the \$140,000 Local Government NSW Enabling Accessible Tourism project which received support under the Commonwealth Tourism Demand-Driver Infrastructure program. The project, is being delivered in the South Coast, Northern Rivers and Central West to improve the provision of information on tourism services, attractions and activities in regional New South Wales destinations for people with disability, their family and their carers.

Destination NSW is supporting the Local Government NSW project by making changes to the accessible dataset in the Australian Tourism Data Warehouse database for the collection of this information, based on Local Government NSW's extensive research. Destination NSW has provided funding of \$7,500 for the development of the criteria for assessment and the tagging of listed products providing accessibility information to enable a consumer requiring this information to determine if it is suitable for them.

Destination NSW has presented at workshops organised by Local Government NSW around regional New South Wales to promote the Get Connected program, Destination NSW's online listing program, and the Australian Tourism Data Warehouse distribution channel and how this platform provides a solution to the collection and distribution of inclusive tourism content.

Destination NSW's Get Connected program includes enhanced accessibility reporting, which allows operators to outline how their products and experiences suit a broader range of accessibility needs. This enables visitors searching for information on accessible travel experiences in New South Wales on sydney.com or visitnsw.com to gain a better understanding of whether products meet their needs.

New South Wales tourism operators who list their businesses on Destination NSW's websites can apply accessibility filters to their listing, which make it possible for visitors to understand whether a tourism product meets their needs.

The accessibility filters include:

- Suitable for guests with sufficient mobility to climb two or three steps, but would benefit from fixtures and fittings to aid balance
- Suitable for guests who depend on the use of a wheelchair in a seated position at all times
- Suitable for guests with high support needs who use a hoist and always travel with a carer
- Suitable for guests with a hearing impairment, from mild hearing loss to profoundly deaf
- Suitable for guests with a vision impairment. Attained by providing for guests with partial vision impairment or total loss of usable vision
- Disabled access available and contact operator for details.

Information on accessible facilities in Sydney is also outlined in The Official Sydney Guide which is available at Visitor Information Centres, visitor kiosks, hotels and attractions throughout Sydney and at Sydney International Airport.

- (4) Destination NSW has supported a range of events in the Central Coast through its major event investment and Regional Flagship Events Program. In line with the actions taken to make Vivid Sydney and other events more accessible, Destination NSW works with event partners, landowners and other government agencies, to increase accessibility to events.
- \*7604 TAFE NSW DAPTO ACCESS POINT—Ms Anna Watson asked the Minister for Tourism and Major Events, and Assistant Minister for Skills—
  - (1) How many students have utilised the TAFE NSW Dapto Access Point in the last three months (as at 15 February 2018)?

Every eligible student who wishes to attend a New South Wales government school will be given a place at their local school.

The Department of Education regularly purchases land for new schools or school expansions to meet changing demographics and ensure demand for public school places is satisfied. While there is not sufficient demand to require land acquisition, this situation will continue to be monitored. I'm advised, however, that Dapto Public School is subject to a major capital works project that will provide new permanent teaching spaces and the removal of demountables.

- \*7608 DISABILITY ADVOCACY SERVICES—Ms Jenny Aitchison asked the Minister for Multiculturalism, and Minister for Disability Services—
  - (1) What disability advocacy services will be available for people with a disability in the Maitland electorate when the Government ceases funding for disability advocacy services in 2018?
  - (2) What provisions will the Government put in place to ensure the continuation of advocacy services for people with a disability in the Maitland electorate?

#### Answer—

Once individuals receive their National Disability Insurance Scheme (NDIS) funding package, they are able to choose how this funding will be spent and who they spend it with. NDIS participants may have activities funded within their NDIS plan that closely align with advocacy activities.

Advocacy and information organisations can choose to register as an NDIS provider to provide direct services to NDIS participants, and provide supports that maximise outcomes for these individuals.

The Information Linkages and Capacity building (ILC) functions of the NDIS will assist people to connect with their local communities and mainstream supports. Importantly, ILC support is available to people with or without an NDIS plan.

When the NDIS is fully operational around Australia, \$130 million each year will be provided for ILC supports. The latest New South Wales round of ILC grants closed on 30 November 2017 with up to \$46 million available to NSW for projects commencing from 1 July 2018. This represents an investment of around four times the existing New South Wales specialist disability advocacy funding under the current system.

Disability advocacy and information organisations are well positioned to access the ILC grants. The outcomes of the ILC National Readiness Grants are expected shortly, with the New South Wales jurisdictional ILC Grants to follow.

Commonwealth funded programs such as the National Disability Advocacy Program (NDAP) will fund independent, systemic advocacy and legal review and representation. The Commonwealth Government recently announced \$60 million in funding to extend the NDAP and other advocacy programs to 30 June 2020. This includes continuing funding for NDAP and NDIS Appeals and Disability Representative Organisations (DRO) programs.

Advocacy services provided through NDAP and NDIS Appeals Programs will continue to be funded in the Hunter region including Maitland.

On 14 December 2017, the Commonwealth announced an increase of \$875,000 under the DRO program for the provision of advocacy and representation services for people with disability to \$5.3 million to 30 June 2020.

There will be no change in New South Wales Government investment in advocacy supports which provide assistance to vulnerable people, including people with disability, to engage with mainstream services such as health, mental health, housing and education.

After full Scheme rollout, the Government will retain a strong focus on promoting community inclusion. The NSW Disability Inclusion Act, passed in 2014, means that the NSW Disability Council and its supporting groups will continue to represent people with disability and provide advice to the Government on emerging issues impacting on community access and inclusion.

The Government continues to offer support to farmers throughout New South Wales including those experiencing drought conditions in the Hunter Valley. This includes providing assistance through the \$300 million Drought Strategy that was launched in February 2015.

Since 1 July 2017, 245 new Farm Innovation Fund Loans have been approved, with a total value of nearly \$45 million. These loans have been used for activities that can help in preparing for, or managing drought- activities like installing tanks, silos, irrigation, fencing, bores, and desilting dams. In the same time period, 235 applications for Farm Business Skills Grants have been approved, with a total value of more than \$549,000. This training can help farmers with vocational training and the development of farm business plans, including risk management.

The Department of Primary Industries (DPI) also recently approved the appointment of two new rural support workers as part of the Rural Resilience Program. These new workers are on the ground in Scone and Dubbo, and will help bring farmers together and inform them how to access the support that they need. The NSW DroughtHub provides a central place for farmers and their families to go for information and links to a wide range of additional drought assistance from the Commonwealth and New South Wales Governments. This includes assistance such as:

- Farm Management Deposits
- Rural Financial Counselling Service
- · Farm Debt Mediation
- An enhanced network of weather stations across New South Wales
- Taxation measures
- · Managing Farm Risk Programme
- Enhanced social and community support for drought affected farmers including Rural Resilience Program and Rural Support Workers

In addition to the support offered through DPI and the Rural Assistance Authority, Local Land Services (LLS) has been actively working with producers on the ground across the Hunter region to help them manage their livestock and properties during these difficult times including:

- assessing pasture conditions and stock management.
- assessing animal health and welfare concerns,
- issuing roadside grazing permits, Travelling Stock Route agistment and assistance with pest animal problems.

### Hunter LLS has also been:

- running non-stop control programs, assisting landholders in drought affected areas to remove pest species, especially wild dogs and pigs.
- More than 1,000 pigs have been controlled by the Hunter LLS team in the Upper Hunter since the start of January 2018.
- More than 400 landholders have attended our drought management events across the region in recent months.

LLS District Vets have been attending weekly cattle sales across the Hunter, monitoring animal welfare and providing support to landholders. They are also assisting with property visits to help producers manage their herd in difficult conditions.

Hunter LLS has also offered delayed payment plans to ratepayers affected by drought conditions in the

region, during the current rate period.

In 2017, there were 591 Active Approved Counsellors contracted by Victims Services to provide counselling services throughout New South Wales, compared with 316 Active Approved Counsellors in 2010.

It is inappropriate to provide the sex and location of Approved Counsellors for privacy reasons.

Each school in New South Wales will have a planned approach to support the wellbeing of all students. Schools prepare students to be familiar with assessment processes. Teachers are well-placed to monitor and respond to the wellbeing needs of their students.

I am advised information about public online consultation was distributed through university student networks in July 2017. Women's officers, student counsellors and university staff attended stakeholder consultation workshops in Bankstown, Nowra and Sydney.

(1) The Energy and Water Ombudsman NSW resolves a wide variety of energy and water complaints. The most common energy complaints relate to high bills.

The Government is working to put downward pressure on prices for all customers across New South Wales, including in the Hunter region. The Government:

- Sought a new national rule requiring retailers to provide customers with advance notice of any price changes
- Implemented the Energy Bill Relief Package which increased all energy rebates by 20 per cent and prohibited fees for leaving a contract early, fees for paper bills and fees for paying a bill at Australia Post. It also helps households and small businesses replace inefficient appliances
- Introduced new obligations on retailers under the NSW Social Programs for Energy Code to assist customers that receive energy rebates to identify the most appropriate deal
- Requests all retailers to adopt the Australian Energy Regulator's (AER) Sustainable Payment Plans Framework. This Framework provides guidance for retailers on how to assist certain groups of customers in paying their bills.
- (2) Data obtained from the Australian Energy Market Operator shows that from March 2016 to February 2017 the average wholesale price for electricity in New South Wales was \$72.94 per megawatt. For the period of March 2017 to February 2018, the average wholesale price was \$86.80 per megawatt.

What is the Government's policy position on offshore oil and gas exploration off the coast of Newcastle?

Answer—
I am advised:

The Government is opposed to seismic testing off the coast of Newcastle.

The reason for the Government's opposition is our concern with the inadequacies of the Commonwealth's offshore requirements for exploration.

Under Petroleum Exploration Permit 11, proposed seismic testing will take place in Commonwealth waters from Newcastle down to Sydney. The permit is held by Asset Energy Pty Limited. The term of the permit was recently extended by the Commonwealth Government- a renewal the Government was opposed to.

The Government made it quite clear that we remained opposed to the extension of Petroleum Exploration Permit 11. This was in line with the decision taken in November 2015 to oppose its extension.

The reasons for our opposition included the significant inconsistencies between the Commonwealth's offshore and the New South Wales onshore assessment and performance requirements in relation to exploration and titleholders across a wide range of considerations. These include technical, financial, reporting, environmental and community consultation standards.

Although petroleum exploration permits are jointly administered by the State and Commonwealth, the Government's objections to seismic testing were overridden.

The work New South Wales has done in the last few years to reform the legislative framework for onshore assessment and performance requirements means that New South Wales' requirements are now much, much more rigorous than the offshore requirements that the Commonwealth Government has in place.

What steps is the Government taking to make rising electricity costs more affordable for consumers?

Answer-

I am advised:

The Government provides help for households that are facing energy bill stress through the Energy Bill Relief Package, announced in September last year.

From 1 July 2017 there was a 20 per cent increase to all energy rebates as part of the Energy Bill Relief Package. Rebates include the Low Income Household Energy Rebate, the Family Energy Rebate, the Gas and LPG Rebate, the Medical Energy Rebate, Energy Accounts Payment Assistance and Life Support Rebate.

The Government has abolished some key retailer fees, putting the needs of the customer first. This includes removal of retailer early termination fees, fees when paying bills over the counter at Australia Post and fees for choosing to receive paper bills. This also includes retailers charging customers leaving electricity and gas contracts before their end-date, and the recovery of upfront benefits for signing the original contract. This means that customers are free to leave expensive contracts to find a better deal.

The Energy Bill Relief Package will also assist households and small businesses when upgrading to energy efficient appliances and equipment.

For households, the Government has the appliance replacement offer, which helps homes in need by providing discounts when replacing old appliances with new energy efficient appliances. We also help households to save on their energy consumption with LED efficient lighting. Customers can gain a discount of about \$150 to replace their lights with the latest LED technology, with the help of a service provider that is accredited by the Government. LEDs use 90 per cent less power than traditional light bulbs, this can provide households with up to \$2,100 of energy savings over the lifetime of the lights.

The Government also provides assistance to New South Wales small businesses to replace their appliances with high energy rating equipment and upgrading their lighting to LED technology to help them save money on energy bills, be more energy efficient and at the same time help the environment.
