Answer—

(1) In 2013, Destination NSW conducted an assessment of the Australian Independent Music Awards based on data provided by the event's organisers.

However, as Destination NSW did not invest in this event no post-event evaluation was undertaken to obtain actual data.

(a) Destination NSW is not the event owner of either the ARIA Awards or the Australian Independent Music Awards, and as such cannot release information on the performance of these events.

(2) The organisers can submit an event submission to Destination NSW for consideration. The submission would be subject to Destination NSW's usual due diligence. Events are evaluated within a competitive landscape and must show that they meet Destination NSW's investment criteria.

(1) No specific budget allocation was set aside for review work by Mr John Brogden.

(2) No member of the committee has been paid for their work, however, the Office of Sport has reimbursed \$60.77 in expenses for car parking costs.
