*2617 FEDERAL GOVERNMENT PAYMENTS-Mr Richard Amery asked the Treasurer-

- (1) What is the description of all categories of Federal Government payments to the State Government?
- (2) Which of the categories in (1) above are considered as income when determining the State Budget?
- (3) Which of the categories in (1) above are not considered as income when determining the State Budget?

Answer-

- (1) Federal Government payments are classified under the following headings in the State's financial publications;
 - (i) Commonwealth General Purpose Grants (approximately 56% of grant revenue)
 - (ii) Commonwealth Specific Purpose Grants (approximately 30% of grant revenue)
 - (iii) Commonwealth National Partnership Payments (approximately 14% of grant revenue)
 - (iv) Other Grants and Subsidies (less than 1% of grant revenue)
 - (v) Transfer payments from the Commonwealth Government on-passed by New South Wales to Third Parties (approximately \$3 billion)
- (2) Items categorised (i) to (iv) are considered as income when determining the State Budget.
- (3) Item (v), transfer payments from the Commonwealth Government that New South Wales on-passes to third parties, is excluded in the determination of income for the State Budget.
- *2618 FORMER BALMAIN LEAGUES CLUB SITE—Ms Linda Burney asked the Premier, and Minister for Western Sydney—
 - (1) Has the Department of Planning or the Planning Assessment Commission directed Rozelle Village to reduce the size or scope of their current proposal for the former Balmain Leagues Club site?
 - (2) (a) Has the Premier ever had any discussions with any representative, employee or advocate for Rozelle Village or Balmain Leagues Club about the current proposal for the redevelopment of the former Balmain Leagues Club site?

(b) When and where did these discussions take place?

- (3) What representations have been made by representatives, employees or advocates of Rozelle Village or Balmain Leagues Club to the Premier or the Government since the current proposal for the redevelopment of the former Balmain Leagues Club site was submitted?
- (4) Has the Premier ever discussed personally with Mr Ben Elias current or former proposals for the redevelopment of the former Balmain Leagues Club site?
- (5) Has Mr Elias or any other representative or advocate of Rozelle Village or Balmain Leagues Club ever lobbied the Premier or his office seeking to prevent the Government from returning control over the former Balmain Leagues Club site to the Joint Regional Planning Panel or Leichhardt Council?

Answer—

I am advised:

- (1) This question should be referred to the Minister for Planning and Infrastructure.
- (2) to (5) There are no records of the Premier meeting with representatives, employees or advocates for Rozelle Village or Balmain Leagues Club. The Premier has received correspondence in regard to Rozelle Village and Balmain Leagues Club.
- *2621 CANTERBURY CHILD AND FAMILY INTERAGENCY—Ms Linda Burney asked the Minister for Family and Community Services, and Minister for Women—
 - (1) Can the Minister confirm the withdrawal of \$41,892 per annum in funding from the Canterbury Child and Family Interagency?
 - (2) As the Canterbury Local Government Area is the most disadvantaged in the Metro Central region and this funding is essential for the provision of services to families and children by the Interagency, when will the funding be reinstated?

Answer-

(1) and (2) Further funding has been secured for the Canterbury Child and Family Interagency to continue to operate until June 2014. A local service provider, Koorana Child and Family Services, is the auspice for this project.

*2623 IMMIGRATION SETTLEMENT PLANNING COMMITTEE—Mr Robert Furolo asked the Minister for Citizenship and Communities, and Minister for Aboriginal Affairs—

In reference to the NSW Auditor-General's Report "Settling humanitarian entrants in New South Wales: Services to permanent residents who come to New South Wales through the humanitarian migration stream":

- (1) When will the review of the NSW Government Immigration Settlement Planning Committee and its Terms of Reference be completed?
- (2) Who are the current members of the committee?
- (3) Are there plans to change the membership of the committee?
- (4) Which non-government organisations involved in providing settlement services will be consulted?
- (5) When will these organisations be consulted?
- (6) Has the Community Relations Commission formally requested the Commonwealth to provide regular data on humanitarian entrants including information about planned release of asylum seekers from detention?
- (7) What systems will be in place to ensure that any regular information from the Commonwealth will be provided to non-government settlement service providers in a timely fashion?

Answer-

(1) The Department of Premier and Cabinet and the Community Relations Commission is undertaking to complete the review of the composition and Terms of Reference of the NSW Government Immigration and Settlement Planning Committee by early 2013.

- (2) The Committee's membership currently comprises representatives of:
 - The Community Relations Commission For a multicultural NSW (Chair)
 - The Department of Premier and Cabinet (including the Division of Local Government);
 - The Department of Trade and Investment, Regional Infrastructure and Services;
 - The NSW Ministry of Health;
 - The Department of Education and Communities;
 - The Department of Family and Community Services (which includes Ageing, Disability and Home Care, Housing NSW, and Community Services);
 - The NSW Police Force;
 - The Department of Finance and Services; and
 - The Commonwealth Department of Immigration and Citizenship.

(3) The objective of the review is to ensure that the Committee has the responsibility and authority to be the central point for developing and implementing settlement policy and planning in NSW.

Any recommendations to change the membership of the Committee will need to be in keeping with this objective.

As part of the review, consideration will be given to:

- Lines of reporting on the deliberations of the Committee; and
- Which agencies should be represented on the Committee and the appropriate level of representation.

(4) Under the Terms of Reference of the Review, the Review will consider:

- The role and function of Commonwealth-funded settlement services; and
- Community needs and expectations of NSW government services

Consultations with non-government organisations involved in providing settlement services will support these considerations of the Review.

(5) The Commission consults with settlement service providers through quarterly meetings with the NSW Settlement Services Coalition. These consultations will be maintained throughout the course of the Review.

(6) The Community Relations Commission, as the NSW representative on the Select Council on Immigration and Settlement, has secured agreement from the Commonwealth that the Department of Immigration and Citizenship will provide a coherent data set of statistics on a quarterly basis that will enable NSW to plan for and monitor the settlement of people migrating to NSW, and where available, relocating to NSW.

The Minister for Immigration and Citizenship has agreed to provide quarterly data to the NSW government on asylum seekers released into the community in NSW on a Bridging Visa E on a confidential basis.

(7) The responsibility for the provision of timely settlement data ultimately rests with the Commonwealth. Data provided to the Community Relations Commission is forwarded to non-government settlement service providers as it arrives and this data is also publicly available from the Department of Immigration and Citizenship's website.

Following representations made by the Community Relations Commission on behalf of NSW at the Select Council on Immigration and Settlement, the Department of Immigration and Citizenship has sought further advice on what data is required to assist with planning in NSW.

The Community Relations Commission consulted with members of the NSW Government Immigration and Settlement Planning Committee and has requested regular data on the number and location of several categories of permanent and temporary migrants. The Commission has also requested that the information available from the Department of Immigration and Citizenship's website is made more userfriendly and accessible.

The Community Relations Commission is exploring mechanisms that will enable it to provide data in a timely and accessible fashion.

*2624 MOBILITY PARKING SCHEME—PENALTY NOTICES ISSUED—Mr Robert Furolo asked the Treasurer representing the Minister for Finance and Services, and Minister for the Illawarra—

In reference to the penalty notices for offences related to the Mobility Parking Scheme (MPS):

- (1) Of the 1,539 penalty notices issued in 2011 for offences related to the misuse of disabled parking permits, what is the breakdown of how many penalty notices were issued for which specific offence?
- (2) Of the 1,539 penalty notices issued in 2011 for offences related to the misuse of disabled parking permits, how many of these were for repeat offenders?
- (3) Does the 1,539 penalty notices issued in 2011 for offences related to the misuse of disabled parking permits include penalty notices issued for the offence of parking in disabled parking spot while not carrying a MPS permit?
- (4) How many penalty notices were issued in 2010 for offences related to the misuse of disabled parking permits?
- (5) How many penalty notices were issued in 2009 for offences related to the misuse of disabled parking permits?

(1) Of the 1,539 penalty notices issued in 2011, the breakdown of offences is as follows:

*2625 SURPLUS LAND ADJOINING M4 VIADUCT—Mr Robert Furolo asked the Minister for Transport representing the Minister for Roads and Ports—

In relation to remedial works for the surplus land adjoining the M4 viaduct:

- (1) Has the independent environmental assessment of the land been made available to the Harris Park Community Centre?
- (2) Has the independent environmental assessment of the land been made available to Parramatta

Council?

- (3) What is the estimated cost of the remediation works?
- (4) When is the remediation works due to start?

Answer—

I am advised:

- (1) No. Roads and Maritime Services has corresponded directly with Parramatta Council about this matter.
- (2) Yes.
- (3) Approximately \$250,000.
- (4) Remediation is not presently scheduled. Roads and Maritime Services is liaising with Parramatta Council regarding this matter.

*2626 MOTOR REGISTRIES—Mr Robert Furolo asked the Minister for Transport representing the Minister for Roads and Ports—

In relation to motor registries in NSW:

- (1) What is the current average waiting time for customers who visit motor registries in NSW?
- (2) How many people visited a motor registry in NSW during 2011-12?
- (3) How many people visited a motor registry in NSW during 2010-11?
- (4) How many motor registries currently operate in NSW?
- (5) What type of services do people visiting motor registries access at the motor registry?
- (6) What is the age profile and demographics of customers who visit motor registries?
- (7) How many staff currently work in NSW motor registries, as at August 2012?

Answer-

I am advised:

- (1) The average waiting time target for RMS motor registries is 8-10 minutes.
- (2) 9,115,526.
- (3) 8,780,764.
- (4) A complete list of motor registries is available on the RMS website.
- (5) Services accessed at motor registries include:
 - Customer transactions e.g. change of personal details
 - Defect transactions
 - · Vehicle registration
 - Finance transactions
 - Firearm/security transactions
 - Licence transactions
 - Boat licence transactions
 - Number plate transactions.

(6) The age profile of customers for the period 1 August 2011 to 31 July 2012 was as follows:

*2627 MARITIME OFFICES—Mr Robert Furolo asked the Minister for Transport representing the Minister for Roads and Ports—

In relation to Maritime offices in NSW:

- (1) How many Maritime offices currently operate in NSW?
- (2) Are any of the Maritime offices currently co-located with another NSW Government agency?
- (3) How many staff currently work in a Maritime office, as at August 2012?
- (4) How many people visited a Maritime office in 2012-11?
- (5) How many people visited a Maritime office in 2011-12?
- (6) What is the current waiting time for people visiting a Maritime office?

Answer—

I am advised:

- (1) This information is available on the Roads and Maritime Services website.
- (2) Yes.
- (3) There were 158 staff working in Maritime offices as at 31 August 2012.
- (4) Roads and Maritime Services does not record this information.
- (5) Roads and Maritime Services does not record this information.
- (6) Roads and Maritime Services does not record this information.

*2628 BETTER BOATING PROGRAM—Mr Robert Furolo asked the Minister for Transport representing the Minister for Roads and Ports—

In relation to the Better Boating Program (BBP):

- (1) What is the funding allocation for the BBP in 2012-13?
- (2) What was the funding allocation for the BBP in 2011-12?
- (3) What was the funding allocation for the BBP in 2010-11?

Answer—

I am advised:

Better Boating Program funding allocations are published on the Roads and Maritime Services website.

- *2629 PHYSICAL ACTIVITY IN PRIMARY SCHOOLS—Ms Sonia Hornery asked the Minister for Education—
 - (1) What is the Minister doing to address the Auditor-General's report indicating that 30% of Government primary schools don't provide the mandatory two hours of planned physical activity each week?
 - (2) What steps is the Minister undertaking to alleviate the student obesity epidemic and ensuring participation in physical activity at school?

Answer-

(1) As Minister for Education, I recognise the importance of regular physical activity in supporting the health and learning of young people, and I am proud that the Performance Audit on Physical Activity in New South Wales Government Primary Schools recognises the exemplary nature of the Department of Education and Communities' curriculum based and extra curricula sport and physical activity programs. I also welcome the opportunity to review current programs and practices and make improvements where appropriate.

A Departmental Advisory Group has reviewed and accepted the recommendations and an implementation plan is currently being developed and will be provided to me within the appropriate timeframe.

(2) With regard to student obesity rates the Department is a partner with parents in addressing this important health issue and it should be acknowledged that lack of physical activity is one of a number of contributing factors which also include unhealthy nutritional habits.

The Department currently has a range of very successful physical activity programs such as the Premiers Sporting Challenge, Live Life Well @ School and the School Swimming Scheme. Additionally a suite of programs including Munch + Move, Crunch & Sip, as well as whole school messages such as Healthy Kids 5 Key Messages and Fresh taste @ School for canteens aim to

improve healthy eating habits in children. Many of these programs have been developed in partnership with the Ministry of Health.

*2630 TAFE HUNTER AND GLENDALE INSTITUTE—Ms Sonia Hornery asked the Minister for Education—

- (1) What are the names of the courses that the Government has cut at the TAFE Hunter and Glendale institute?
- (2) Will the Minister guarantee restoration of funds for TAFE Hunter and Glendale Institutes so that teacher jobs won't be cut, support services won't disappear and student courses and ultimately qualifications for the work force won't be lost?

Answer—

(1) TAFE NSW Institutes regularly review their course offerings and adjust offerings each Semester. Adjustments are made according to the local skill requirements and demand for training services in each region across New South Wales.Adjustments to program offerings have accommodated growth in apprentice and trainee enrolments and enrolment growth in other critical skills shortage areas in the Hunter and Central Coast regions.

Due to a significant decrease in student demand, courses not being offered by TAFE NSW - Hunter Institute in Semester 2, 2012 include:

Newcastle Campus - Diploma of Metallurgy; Diploma Digital Media (Programming); Certificate III Polymer Composites (Processing)

Belmont Campus - Certificate III in Aquaculture

Glendale Campus - Certificate III in Hospitality

Hamilton Campus - Certificate III in Hospitality (Commercial Cookery and Patisserie) - non-trade Singleton Campus - Diploma Information Technology

Maitland Campus - Advanced Diploma Computer Systems Technology

Newcastle and Ourimbah Campus - Advanced Diploma of Music Business; Advanced Diploma in Sound Production

Tomaree and Belmont Campus - Career Education and Employment for Women.

The Institute will monitor the situation with a view to offering these courses if demand increases to a sustainable level.

(2) No permanent teachers have lost their job because of the adjustments to program offerings at TAFE NSW - Hunter Institute.

Part-time casual teachers have been affected by the changes to teaching hours, as hours have decreased or increased across campuses.

Support services have not been reduced, and Hunter Institute continues to ensure priority is given to training that meets the needs of industry and the community.

*2631 ELECTIVE SURGERY WAITING TIMES—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—

Noting the report by the Centre for Independent Studies that NSW elective surgery waiting times have slipped by 70 per cent, what is the Minister for Health doing to reverse this trend?

Answer-

The NSW Government is committed to ensuring that all patients waiting for elective surgery are treated within clinically recommended timeframes. The National Partnership Agreement on Improving Public Hospital Services requires States to ensure that patients receive their surgery within the clinically recommended timeframe and has set progressive targets for all States.

92% of patients received their surgery within the clinically recommended timeframes in April to June 2012.

- *2632 CRIME PREVENTION—EXTRA RESOURCES AND STAFF—Ms Sonia Hornery asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
 - (1) With more than 90 life threatening armed robberies reported in the Hunter this year, will the Minister

be providing extra resources and staff to prevent further life threatening crimes? (2) If so, how much and when?

Answer-

I am advised that Operation Blade has been established to review all armed robberies in the Hunter, to identify links between incidents and identify common offenders. Local Area Commands in the area have organised strike forces and joint operations to manage investigations and target offenders. Some of these have led to significant arrests.

- *2634 ORTHOPAEDIC SPECIALISTS WAITING TIMES—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—
 - (1) How many patients are waiting for appointments to see orthopaedic specialists at the John Hunter Hospital as at 31 July 2012?
 - (2) Of those patients, what percentage of patients are being seen in the allocated triage times?
 - (3) How many patients have waited longer than 365 days?

Answer-

I am advised:

(1) to (3) The NSW public hospital system aims to ensure all people have timely access to health care and acknowledges that there are often waiting times for certain procedures. Priority for admission is based on the treating clinician's decision following review of each individual. NSW Health is working towards all patients being treated within their clinical priority timeframes.

Patients are encouraged to undergo a clinical review with their specialist if they feel that their condition has deteriorated. A clinical review gives the specialist an opportunity to reassess the patient and, if clinically warranted, to review the clinical priority category of the patient.

*2635 DEMOUNTABLE BUILDINGS—Ms Sonia Hornery asked the Minister for Education—

- (1) How many demountable buildings are there in public schools in the electorate of Wallsend?
- (2) Why has the Government not fulfilled its promise to replace over 5,000 school demountables throughout NSW?

Answer—

- (1) 53.
- (2) The Government did not make such a commitment. The demountable replacement program was set up by the previous Government and had scheduled the program to end in the 2010-2011 financial year with no future funding provisions.
- *2636 PLASTIC SURGERY FOR TRAUMA OR EMERGENCY PATIENTS—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—
 - (1) Given the John Hunter Hospital has the busiest trauma department in NSW, why is there no access to after-hours plastic surgery for trauma or emergency patients in Newcastle?
 - (2) Will the Minister provide funding for such services so that patients suffering serious trauma are not transferred out of the region?

Answer—

I am advised:

(1) and (2) John Hunter Hospital has a range of surgeons available after hours to treat patients in an emergency. The Hospital utilises a statewide-referral service where patients can receive treatment throughout the state and clinicians can also seek advice from specialist plastic surgeons at other facilities when treating a patient, if required.

John Hunter Hospital does have surgeons who do Micro-vascular surgery, including trauma surgeons and hand surgeons, as well as Otolaryngology (Head and Neck) Surgeons, who would provide treatment for trauma patients.

- *2637 NATIONAL ENERGY CUSTOMER FRAMEWORK—Ms Sonia Hornery asked the Minister for Resources and Energy, Special Minister of State, and Minister for the Central Coast—
 - (1) Why has the Government refused to sign up to the national energy customer framework?
 - (2) Will the Government implement a similar price comparison website that will allow consumers the

ability to compare electricity deals?

Answer—

- (1) and (2) The NSW Government was one of the first to enact the national legislation, which will be effective once proclaimed and once the Government is assured that NSW customers will have the strongest protections possible.
- *2640 SHARING OF INFORMATION—WORKING GROUP—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

What was the result of the working group established to look at barriers in the justice system to the sharing of information?

Answer-

I am advised:

The Department believes the member is asking about the Joined Up Justice - Police project. The Department of Attorney General and Justice (DAGJ) together with the NSW Police Force (NSWPF) developed a business case to improve the exchange of information between the two agencies.

The business case for the "Joined up Justice - Police" project was approved in July 2012 with \$15.542 million allocated over two years. The project has commenced with the planning and prioritisation of a joint program of work. The first stage of the project focuses on the delivery of electronic Apprehended Violence Orders (eAVOs). The eAVO system is planned for delivery in December 2012.

This project will create a modern and disciplined exchange of data between the NSWPF and the courts. It will improve the quality and timeliness of the exchange of operational information and enhance the integrity of the justice system.

*2641 VICTIMS COMPENSATION SCHEME—REVIEW—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

When will the results of the review of the Victims Compensation Scheme be released?

Answer-

The Government is currently considering the PricewaterhouseCoopers review of the Victims Compensation Scheme.

- *2644 SAVINGS IDENTIFIED IN HAMBURGER REVIEW—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
 - (1) Have the savings identified in the Hamburger Review to be achieved within 2 to 6 months in fact been realised?
 - (2) If not, why not?

Answer-

I am advised:

The Hamburger Review identified a number of potential organisational efficiencies for Corrective Services NSW.

This process of change is ongoing and to date, considerable progress has been made in implementing a number of reforms. Savings have already been achieved through the process of staff accepting voluntary redundancies.

The new Commissioner of Corrective Services has announced the new structure which will be implemented within the next few months.

*2645 RESTRICTION TO COMPUTER RESOURCES—Mr Paul Lynch asked the Minister for Mental Health, Minister for Healthy Lifestyles, and Minister for Western New South Wales—

- (1) Is forensic patient Saeed Dezfouli being prevented from pursuing tertiary studies by being restricted in his access to computer resources?
- (2) If so:
 - (a) What is the basis for this decision?
 - (b) Is this more restrictive than conditions applicable to Corrective Services inmates?

Answer—

I am advised:

(1) and (2) The Forensic Hospital has been developed to be in line with international best practice and provides a range of therapeutic rehabilitation programs.

Mr Dezfouli has access to a range of educational opportunities, including the Tertiary Preparation Programme and the Open Training and Education Network.

Due to security considerations it is not possible for forensic patients to have private computers. However, patients have access to the computer room, and printed material in order to participate in their studies.

*2646 INSULIN INFUSION PUMPS—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regards to the provision of insulin infusion pumps for children with diabetes:

- (1) How many children with diabetes are on the books of New South Wales paediatric specialist diabetes outpatient clinics?
- (2) How many of these children in the state are using these pumps?
- (3) Which units in the state prescribe and monitor these pumps?
- (4) What is the average cost?
- (5) Who pays for these pumps and the ongoing education?
- (6) What provisions are there for children whose parents do not have the ability to pay for one of these pumps?

Answer-

I am advised:

(1) to (6) An estimated 2,900 children and adolescents in NSW have type I diabetes.

Funding of pumps and consumables is a Commonwealth responsibility and questions relating to this should be directed to the Commonwealth Minister for Health.

All centres in NSW that are involved in managing children with type 1 diabetes prescribe and monitor these pumps. NSW Health employs diabetes educators and other support staff to provide ongoing education to patients and their families.

*2647 OBESITY AND METABOLISM CLINIC—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regards to the Obesity and Metabolism Clinic at Camden Hospital:

- (1) What is the total staffing (FTE) of this clinic?

I am advised:

(1) to (6) The creation of the first ever healthy lifestyles portfolio by the NSW Government demonstrates our commitment to preventative health and promoting healthy lifestyles.

In order to keep people healthy and out of hospital, the NSW Government has already:

- Established a NSW Preventative Health Fighting Fund estimated to be \$120 million over four years;
- Established a NSW Office of Preventative Health located in South Western Sydney to focus on health promotion, and
- Established a Ministerial Taskforce on Preventative Health to provide advice on strategies to enhance individual and population health and prevent avoidable hospital admissions.

With these initiatives in mind, all Local Health Districts will be reviewing which initiatives are best to implement locally to assist in reducing childhood and adult obesity.

I am advised that current referral criteria for the Obesity and Metabolism Clinic at South Western Sydney requires patients to be 18 years of age or over and have a BMI greater than 40 kg/sq m (maximum weight

230 kg). Participants must also be able to attend regular clinic appointments and commit to 45 minutes of moderate intensity activity each day including a minimum of three exercise classes a week. Based on individual disease groups there are a range of other criteria for these groups.

*2648 ADDITIONAL NURSES APPOINTED—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regards to the Minister's claim that "400 additional nurses have been appointed" on the Central Coast (Hansard 16 August 2012):

- (1) to (4) Workforce and activity level data, including bed usage data, is published in the Ministry of Health's Annual Report. The 2011-12 Annual Report will be published shortly.
- *2649 EDMUND BLACKET CAR PARK—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) Now that the Edmund Blacket Car Park has been closed, how long does it take for staff to walk to the proposed parking alternatives in the William Inglis stables?
 - (2) Has extra security staff been rostered to escort staff if needed?
 - (3) Have staff rosters, duties, or numbers been modified to allow for any extra time this walk to the cars would take?
 - (4) When will the Edmund Blacket Car Park re-open?

Answer-

I am advised:

(1) to (4) Depending on work location, it takes approximately five to ten minutes for staff to walk from the alternative car parking. Security staff are available to escort staff after hours, although there has been no increase in demand for after hours staff escorts. It is anticipated that the car park will re-open in May 2014.

*2650 OPERATING THEATRES—RANDWICK HOSPITALS CAMPUS—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

- (1) The South Eastern Sydney Local Health District funded an external consultancy review of operating theatres in 2010/2011. The recommendation from the review was that a single management structure be created and implemented.
- (2) The consultancy report was widely circulated. Further implementation planning is required, following which formal consultation with staff and the relevant industrial associations will occur.

- (3) Yes, through efficient use of resources, focussing on appropriate access and patient safety.
- (4) No.
- (5) NSW Health services promote high quality safe patient care at all times.
- (6) Yes.
- *2651 ADDITIONAL NURSES EMPLOYED—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

(1) and (2) The NSW State Government committed to employing 2,475 additional nurses and midwives in our first term, and 14 months into that term we have already surpassed that target.

The 2012-13 budget builds on the important work already done in increasing nurse numbers across NSW by allocating a further \$64 million to recruit approximately 500 additional nurses at public hospitals. In addition, \$4.4 million will be allocated to employing more Clinical Nurse/Midwife Educators and Clinical Nurse/Midwife Specialists, and a further \$1.9 million will go to supporting the Health Professionals Workforce Plan.

- *2654 PRINCES HIGHWAY FIGTREE—UPGRADE—Mr Ryan Park asked the Minister for Transport representing the Minister for Roads and Ports—

In relation to the upgrade of the Princes Highway Figtree:

- (1) (a) Will the entire project be completed by the end of 2012?
 - (b) If not, why and when will the project be completed?
- (2) Is the project still within the original budget?
- (3) What is the estimated final cost of this upgrade?

I am advised:

- (1) (a) The entire project will be completed by the end of 2012, weather permitting.
 - (b) Not applicable.
- (2) Yes.
- (3) The estimated final cost of this project is \$14.7 million.
- *2655 ABILITY LINKS TENDER—Mrs Barbara Perry asked the Minister for Ageing, and Minister for Disability Services—
 - (1) With regards to the failure of the Ability Links tender process, how many applications were there?
 - (2) Why were no providers successful in meeting the tender?
 - (3) In terms of tender requirements, how was it envisaged that Ability Links employers should separate their delivery of Ability Links coordinators while still drawing on their service provider to support the Ability Links program?
 - (4) When was the decision made to set up an Ability Links taskforce?
 - (5) Was the Ability Links taskforce set up in direct response to the failure of the Ability Links tender?

- (c) lack of understanding about the Ability Links NSW model
- (d) not meeting technical or other tender requirements.
- (3) Tenderers that directly deliver specialist disability services funded by the NSW and Australian governments, were required to demonstrate that Ability Links NSW will operate independently of these services. This sub-criterion was critical to ensure that Ability Links NSW maximises community inclusion outcomes for people with a disability, their families and carers.

Ageing, Disability and Home Care did not state how this separation should be achieved. Tenderers were expected as part of their response to determine, where relevant, how to achieve such separation from any disability services delivered by the tendering organisation or consortium members.

- (5) Yes in part. Additionally the taskforce has been established to gather information from the planning and implementation of the NSW trial of the NDIS. Results of which will inform Government's long term plans for disability services.
- (6) Coordinators will be announced before 1 July 2014.
- (7) The Government remains committed to Ability Links NSW being fully operational by 1 July 2014.
- (8) No
- (9) There have been over 20 evaluations across Australia and internationally, and an independent review of previous literature and evaluations. Development of the NSW model, Ability Links NSW, was guided by evaluations in Western Australia, Scotland and the United Kingdom.
- (10) Ability Links NSW builds on existing local area coordination. Unlike existing programs Ability Links will be subject to policy parameters for a reformed disability system based on individualised funding arrangements and person centeredness.

*2657 COMMENTS IN COURT OF CRIMINAL APPEAL—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

What is the Government's response to the comments of Simpson J in the Court of Criminal Appeal on 27 February 2012 in the case of Boughen at paragraphs 109 and 110?

Answer—

The Government is committed to encouraging the use of more non-custodial and community-based sentences as an alternative to full-time incarceration for less serious offences. The NSW Law Reform Commission is currently reviewing sentencing legislation including Intensive Correction Orders.

- *2658 AUSTRALIAN VACCINATION NETWORK—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) (a) Is the Minister aware of the comments on 15 August 2012 on WIN TV regarding a story on a measles epidemic, by Ms Dorey of the "Australian Vaccination Network", that vaccines have been linked to autism?
 - (b) If yes, what action has the Minister taken to correct the public record?
 - (2) Does the Minister have a view on the ongoing activities of the "Australian Vaccination Network"?

Answer—

I am advised:

(1) and (2) The Australian Vaccination Network has not provided accurate information to parents about the risks and benefits of immunisation. Any link between the measles vaccine and autism has been conclusively discredited by numerous studies and reviews by credible experts, including the World Health Organisation, the American Academy of Paediatrics and the UK Medical Research Council.

In 2013, the NSW Ministry of Health will be implementing an immunisation awareness campaign to educate and inform the community and immunisation providers about the importance of ensuring that children are fully immunised on time, including for measles.

*2659 REVIEW OF PATHOLOGY TESTS—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regards to the failure to follow up pathology test results in NSW hospitals, and the fact that 20,000 pathology tests were not reviewed in a Sydney hospital in a four-month period in 2011 of which 14.7% were abnormal (Archive of Internal Medicine, 13 August 2012):

- (1) What action has the Minister taken to address this issue?
- (2) What future action is planned?
- (3) How will the outcomes of any actions taken by the Minister be measured?
- (4) How many Incident Information Management System (IIMS) relating to this issue were raised in the year July 2011 to June 2012?

Answer—

I am advised:

- (1) to (4) NSW Health welcomes the study by the University of NSW and looks forward to reviewing these results from early 2011 in more detail. Since that time there has been considerable effort to improve the way patient discharge planning is managed:
 - A mandatory policy has been implemented requiring all hospitals to meet new standards for admission, clinical review, planning for discharge, referrals and transfer of care out of hospital. As part of that policy a new transfer checklist is required for all admitted patients before they go home that reviews all referrals, appointments, and follow-up information including medication advice in plain language.
 - The Government is also working with the Commonwealth on better integration of IT systems with the general practice sector, so that follow up by the patient's GP can be better organised. Three pilots are currently underway.
 - The Clinical Excellence Commission (CEC) and the Agency for Clinical Innovation continue to work with local clinicians to improve processes and practice around clinical diagnosis and review.
- *2660 SHARK FINNING—Ms Clover Moore asked the Minister for Primary Industries, and Minister for Small Business—

Given a critically endangered grey nurse shark was found washed up on a northern New South Wales beach without a fin and that there are reports of illegal and underground shark finning in Australian waters:

- (1) What powers does the Department of Primary Industries have to search sea vessels in New South Wales waters?
- (2) What search operations for illegal shark finning has the department carried out in the last 12 months?
- (3) How are operations determined with regard to location and timing?
- (4) What action will the Government take to prevent illegal shark finning in New South Wales waters?

Answer-

- (1) A fisheries officer may stop and detain a boat; board and search the boat for fish, inspect fishing gear or any record relating to the fishing activities of the boat, and; break open and search any hold or container on the boat that the officer has reason to believe contains fish, fishing gear or any such record.
- (2) There have been a number of inspections in the last 12 months in the New South Wales fishery that targets sharks. Fisheries officers continually and routinely inspect fishing vessels in their daily operations for illegal catch, including shark fins.
- (3) Fisheries officers target fishers, fishing vessels and processing establishments that are involved in the shark fishery or have the capacity to take, receive or process sharks. Operations are supported by intelligence gathered from industry and the community and respond to fleet movements, environmental factors and catch information.
- (4) There are strict laws in place to prohibit the possession of shark fins on board any vessel in NSW unless they are attached to the shark. Fisheries officers will continue to regularly undertake inspections of NSW and Commonwealth fishing vessels for illegally taken fish, including shark fins.
- *2662 HOMOPHOBIA—Ms Clover Moore asked the Attorney General, and Minister for Justice—

Noting the Victorian Government has funded a groundbreaking television, social media and postcard "No to Homophobia" campaign in order to address harassment against lesbian, gay, bisexual and transgender people:

- (1) What evidence does the NSW Government have about homophobia, harassment and violence?
- (2) What community education and social marketing campaigns has the NSW Government funded or provided?
- (3) What plans does the NSW Government have to provide or fund anti-homophobia campaigns directed to mainstream audiences?
- (4) Will the Government develop a similar social media and television campaign against homophobia in NSW?

Answer-

I am advised:

(1) The Department of Attorney General and Justice (DAGJ) commissioned research into homophobic violence in NSW, which informed the 2007-2012 Working Together: Preventing Violence Against Gay, Lesbian, Bisexual and Transgender People Strategic Framework.

The Framework is a whole of government policy outlining the Government's commitment to reducing the incidence of prejudice related violence and creating safer environments for gay, lesbian, bisexual and transgender (GLBT) people. A Network of Government Agencies (NOGA) implements the Framework and reports annually on achievements under its five key priority areas.

The Anti-Discrimination Board (ADB) responds to enquiries and complaints made under the Anti-Discrimination Act 1977 from people who feel they have been discriminated against on the grounds of homosexuality.

- (2) I refer to my answer to Written Question 0156. Since then, additional community educational and other campaigns funded or provided by the NSW Government under the 2007-2012 Strategic Framework, as reported to the Department, include:
 - launch of a Bullying Compliance Strategy by WorkCover in 2011 across a number of industry sectors to combat the rising incidence of workers compensation claims and costs resulting from bullying
 - training courses for Gay and Lesbian Liaison Officers conducted by the NSW Police Force (NSWPF) in 2011 and 2012. Additional training and support was provided in 2011 to School Liaison Police (SLP) attached to schools participating in the Department of Education and Communities Proud Schools pilot program aimed at addressing homophobia in schools
 - Legal Aid NSW funded and supported the Safe Relationships Project (SRP): Domestic Violence Court Assistance of the Inner City Legal Centre, providing advocacy, referral and information to GLBT people who are experiencing domestic violence in 2010-2011
 - Community Services provided funding until June 2012 (through the Supported Accommodation Assistance Program) to AIDS Council Of NSW (ACON), Twenty10 Gay and Lesbian Support Services and the Gender Centre to deliver services to the GLBT community.

The ADB also employs a part-time Community Education Officer to provide education to community groups across NSW about all grounds of discrimination and vilification, including on the grounds of homosexuality.

(3) None other than those referred to in answer (2).

Questions about the planned delivery or funding of anti-homophobia campaigns by other NSW Government agencies should be directed to the responsible Ministers.

- (4) Refer to answer (3).
- *2663 PIG DOG HUNTING—Ms Clover Moore asked the Minister for Primary Industries, and Minister for Small Business—
 - (1) What investigations has the Government made to reports that dogs used in pig dog hunting sometimes escape and become feral in native bush land?
 - (2) What investigations has the Government made to reports that the practice of pig dog hunting can scatter feral pigs across a wider area making the problem worse?
 - (3) What investigations has the Government made to reports of cruelty to dogs used in pig dog hunting including:
 - (a) dogs travelling in small cages on the back of cars for prolonged periods in the sun;
 - (b) dogs not being fed for prolonged periods so that they are hungry before they hunt;
 - (c) injuries like bites from scared feral pigs?
 - (4) What investigations has the Government made to reports from property owners of pig dog hunters trespassing on private land and causing damage including cutting fences?

Answer—

- (1) Nil.
- (2) There is no evidence that pig dog hunting scatters feral pigs across the landscape any further than they already exist.
- (3) Any suspected acts of cruelty are reported to the Prevention of Cruelty to Animals Act 1979 enforcement agencies, these being; RSPCA NSW, Animal Welfare League NSW and NSW Police. Reports of cruelty to dogs are received by these agencies from time to time. It is understood that no prosecutions have been made relating to the use of dogs to hunt pigs.
- (4) Any person trespassing on private land would be subject to the provisions of the Inclosed Lands Protection Act 1901 and the Crimes Act 1900 enforced by NSW Police.
- *2664 POLICE NUMBERS—Ms Clover Moore asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

Noting community calls for stronger policing in Kings Cross following serious crime and violence, and my ongoing calls to increased police resources to address alcohol-related crime and anti-social behaviour:

- (1) What additional resources will the Government allocate for policing in this command?
- (2) How will the Government ensure that inner city police commands have sufficient officers to manage late night crowds in Kings Cross, Surry Hills, City Central and The Rocks commands?
- (3) Will the Government increase police numbers in these commands to ensure effective policing?
- (4) What further action will the Government take to improve safety in the inner city?

Answer-

I am advised:

Workforce allocations take into account a range of factors including crime rates. The NSW Police Force maintains a strong presence in the Kings Cross precinct, particularly on Friday and Saturday nights. As well as general duties officers, Specialist Commands including the Mounted Police Unit, Public Order and Riot Squad, Gangs Squad, Homicide Squad, Dog Unit, Police Transport Command and the Alcohol and Licensing Enforcement Command deploy resources to Kings Cross and the inner city as needed.

The Government has announced its contribution to the joint plan of management for the Kings Cross precinct. This includes Operation Rushmore, which will see a blitz of high visibility policing in the area over summer, commencing 28 September 2012. Drug dogs will be able to patrol Kings Cross streets, without police first getting a warrant, as well as patrolling metropolitan and inter-city train lines with no warrant.

Police will continue to work with other agencies including the Office of Liquor, Gaming and Racing to tackle issues of alcohol-related crime, anti-social and violent behaviour in the inner city of Sydney.

*2665 SHOOTINGS—Ms Clover Moore asked the Attorney General, and Minister for Justice—

With respect to increasing numbers of stolen firearms and 89 shootings in NSW this year so far:

- (1) What data does the Government have about increased numbers of stolen firearms and their use in criminal activity?
- (2) What action has the Government taken to address the problems of stolen firearms?
- (3) What action has the Government taken to address crime involving firearms?
- (4) What liaison has the Government carried out with other States and Territories and the Commonwealth Government for national action to address access to firearms and gun crime?
- (5) What further action will the Government take to reduce access to stolen firearms and criminal activity involving firearms?

Answer—

I am advised:

(1) According to the NSW Bureau of Crime Statistics and Research (BOCSAR), NSW recorded crime data shows the number of stolen and recovered firearms increased from 601 in the 12 months to June 2011 to 731 in the 12 months to June 2012. Over the 24 months ending June 2012, the trend in the number of stolen/recovered firearms was stable. BOCSAR does not record figures about the use of stolen firearms in criminal incidents.

(2) and (3) The Government has ensured that the NSW Police Force (NSWPF) and other agencies such as the NSW Crime Commission have the powers and resources they need to continue to investigate and prosecute firearms related crime. I also refer the member to the answer to question on notice 1447.

Earlier this year the Government introduced an aggravated form of the drive-by shooting offence through the Crimes Amendment (Consorting and Organised Crime) Act 2012. Offenders now face 16 years imprisonment where such a shooting is performed in the course of organised criminal activity.

The Parliament has recently passed amendments to the Firearms Act 1996, which will impose stricter controls on the sale of ammunition. Further questions on this Act should be addressed to the Minister for Police and Emergency Services.

(4) Firearms related crime will continue to be considered through the Standing Council of Law and Justice (SCLJ) and the Standing Council on Police and Emergency Management (SCPEM).

At the June 2012 meeting of the SCPEM my colleague, the Minister for Police and Emergency Services, agreed to a range of activities to progress a national response to firearms crime.

(5) The Government is continuing to work with other jurisdictions through the SCLJ and the SCPEM to address thefts of firearms and related firearms crime.

*2666 LITERACY AND NUMERACY TEACHERS—ILLAWARRA—Mr Ryan Park asked the Minister for Education—

- (1) How many of the promised 60 extra literacy and numeracy teachers for the Illawarra are currently employed in local schools?
- (2) What are the names of the schools where these teachers are located?
- (3) What is the timeframe for the remaining teachers to be in place?
- (4) What schools will be receiving these teachers?
- (5) Why will only 50 of these teachers be in place across NSW by the end of this year when the original commitment was for 200 by the end of 2012?

Answer-

- (1) There are two Instructional Leaders, Literacy and Numeracy, currently employed in Illawarra and South East Region schools.
- (2) The Instructional Leaders are located at Warilla North Public School and Warrawong Public School.
- (3) The equivalent to 900 additional full time teaching positions will be allocated in the time period 2012-2016.
- (4) The identification and selection of schools, including those in the Illawarra and South East Region, to receive additional resources under the Literacy and Numeracy Action Plan will be ongoing over the five years of the government commitment. For this reason it is not possible to provide a final list of schools.

Fire & Rescue NSW has an excellent record in meeting response times across New South Wales. The use of time adjustments allows Fire & Rescue NSW to select and deploy the firefighting resources which can most quickly respond to an incident.

- (2) The average waiting time for a person who is referred to the Concord Centre for Mental Health varies depending on which unit the patient is being referred to and bed availability. Acutely mentally ill persons who present to the Concord Centre for Mental Health Admission Office are seen and a decision to admit or discharge is made within two hours of presentation.
- (3) There is no patient who is acutely mentally ill currently waiting for a bed at the Concord Centre for Mental Health.
- (4) Over 100 patients can be accommodated.
- (5) Acutely mentally ill patients can be admitted to mental health facilities at Royal Prince Alfred Hospital in Sydney Local Health District and Bankstown, Liverpool and Campbelltown Hospitals in South Western Sydney Local Health District, subject to bed availability. Patients accepted and waiting for inpatient rehabilitation remain in their local facility until a bed becomes available.
- (6) Patients are usually discharged to follow-up from a Community Mental Health Centre. The person may accept ongoing contact voluntarily or may be required to accept treatment under a Community Treatment Order, authorised by the Mental Health Act.

(7) The largest single source of referral is by a hospital and emergency department within the same health service.

*2678 NEW K-10 SYLLABUSES-Ms Carmel Tebbutt asked the Minister for Education-

Professional learning and curriculum support will continue to be priorities following the realignment.

Teachers and school leaders will have access to teams of curriculum advisors with responsibility for supporting schools in the delivery of the curriculum, including the implementation of the Australian Curriculum. This expertise will be relevant to early learning, primary and secondary schools, with a clear requirement to work through learning stages.

Professional learning is embedded in the work of all the State office teams, whether it is curriculum, specialist programs, Aboriginal education, disability or health and wellbeing.

There will also be a team dedicated to ensuring that the professional development of teachers and school leaders is high quality and linked to professional standards.

Answer-

I am advised that any changes to authorised strength between May and June 2012 are as a result of the creation of stand-alone Traffic & Highway Patrol and Police Transport Commands. Officers who were

already performing highway patrol or commuter crime-related duties are no longer counted in Local Area Command numbers, rather they are counted under the respective of the two Commands and go towards the total number for Field Operations shown on the strength figures.

*2697 PRIVATE CAR PARKS—FINES ISSUED—Ms Tania Mihailuk asked the Minister for Fair Trading—

What action will the Minister take to prevent private companies such as Australian National Car Parks from issuing "fines" to NSW consumers?

Answer-

If a private car park operator in NSW issues a payment notice that does not comply with the Australian Consumer Law, NSW Fair Trading will take appropriate compliance action in accordance with the law.

- *2698 PRIVATE CAR PARKS—COMPLAINTS RECEIVED—Ms Tania Mihailuk asked the Minister for Fair Trading—
 - (1) How many complaints have been received in the last twelve months by NSW Fair Trading regarding private companies such as Australian National Car Parks issuing "fines" to NSW consumers?
 - (2) What advice has the Minister received regarding potential action by the Government to address this issue?

Answer-

During the last twelve months, NSW Fair Trading has received no identified complaints relating to "fines" from private car park operators. Private car park operators in NSW issue payment notices which comply with the Australian Consumer Law.

I am advised that private car parking operators across the nation are presently under active surveillance by Australian Consumer Law regulators. As part of this project, NSW Fair Trading is engaging with a number of NSW-based businesses to ensure that they are fully aware of their ongoing obligations under the Australian Consumer Law.

Where there is evidence of breaches of the law, Fair Trading will take action accordingly.

*2699 NEW REQUIREMENTS FOR PETROL SIGNS—Ms Tania Mihailuk asked the Minister for Fair Trading—

Why is the Minister waiting 12 months to introduce new requirements for petrol signs in NSW?

Answer-

Under the new fuel price sign requirements, all New South Wales service stations will be required to have a fuel price sign (or signs) which:

- in the case of a service station which sells up to four fuels, displays the price of all of those fuels; and
- in the case of a service station which sells more than four fuels, displays the prices of at least four fuels, being LPG and/or diesel if these are sold, together with the top-selling fuels for that service station, so as to add up to a total of four fuels.

The price displayed is to be price per litre available to all retail customers, that being the normal price without any discounts or special offers. In the case of ethanol blend petrol, regular unleaded petrol and premium petrol, the octane rating of the petrol, rounded down to the nearest whole number, will be required to be displayed on the bowser.

The new requirements will come into effect on 1 September 2013, in order to give service stations time to amend their signboards, if necessary. The Government has consulted with industry and considers one year to be a reasonable transition period.

*2700 REPLACEMENT OF SERVICE STATION SIGNAGE—Ms Tania Mihailuk asked the Minister for Fair Trading—

I reference to your media comments that only a limited number of service stations in NSW will need to replace their signs in order to comply with new Government Regulations, how many service stations in NSW will need to replace their signs as a result of the new regulation?

*2703 OXFORD STREET CLEARWAY—Ms Clover Moore asked the Minister for Transport representing the Minister for Roads and Ports—

With the Oxford Street clearway impacting local businesses through noise and pollution from fast moving traffic, and fewer parking spaces for shoppers travelling by car, at a time when business is already suffering from the global financial crisis and on-line retail:

- (1) What assessment was made after the opening of the Cross City Tunnel in 2005, which reduced traffic along Oxford Street between Taylor Square and Queen Street by an estimated 30 per cent, on the need for the clearway?
- (2) What assessment was made after the opening of the Eastern Distributor in 1999, which took through-traffic off Oxford Street, on the need for the clearway?
- (3) How do east-bound traffic numbers along Oxford Street during the afternoon clearway compare with numbers on southwest-bound King Street Newtown, which has one less lane of traffic in each direction?
- (4) How do traffic volumes travelling east-bound in the afternoon justify the need for three dedicated traffic lanes?
- (5) Will the Government help small businesses by removing the clearway on Oxford Street east-bound?
- (6) If not, will the Government introduce a one-year trial with Roads and Maritime Services, Woollahra Municipal Council and the City of Sydney jointly collecting and reviewing data?

Answer-

I am advised:

- (1) Local traffic impacts were assessed after the Cross City Tunnel opened as part of the Paddington local area traffic management plan. However, the assessment focussed on traffic on local streets in adjacent suburbs, not on Oxford Street.
- (2) Traffic counts, intersection performance, travel times, heavy vehicle usage and public transport data was collected in the period August to October 2000. Similar data was collected for the period October to November 2001, after completion of the Local Area Improvement Program.

A final study report was prepared, based on the data collected in October to November 2001. The study indicated that traffic flows on Oxford Street between Crown Street and Bourke Street continued to increase, but congestion had decreased.

- (3) Traffic data indicates that between 3pm and 5pm the traffic volume in Oxford Street is lower than King Street,Newtown, however, between 5pm and 7pm the volume in Oxford Street is higher than King Street, Newtown.
- (4) Oxford Street is an important public transport corridor, with the bus lane in Oxford Street forming part of three strategic bus corridors. On the northern side of Oxford Street (outbound), bus lane restrictions apply between 3pm and 7pm. During this period 280 buses use the bus lane, carrying over 10,000 commuters.

The bus lane is needed for the 280 buses to provide reliable and efficient services.

- (5) In response to shop traders along Oxford Street at Darlinghurst, Roads and Maritime Services is currently reviewing traffic conditions on Oxford Street.
- (6) Roads and Maritime Services and the State Transit Authority will monitor bus travel times and general traffic conditions along Oxford Street and will await the outcome of the review.
- *2704 MOTOR REGISTRY CLOSURES—Mr Ryan Park asked the Minister for Transport representing the Minister for Roads and Ports—
 - (1) Will the Minister guarantee that no RMS motor registry will be closed in the Illawarra?

Answer—

I am advised:

- (1) Crash tests with motorcyclist dummies have been undertaken internationally. University of NSW studies of motorcyclist crashes into safety barriers have recommended improvements to crash test protocols.
- (2) The Centre for Road Safety and Roads and Maritime Services are interested in testing safety barriers for motorcyclist safety, and are assessing the feasibility of designing and conducting tests.
- (3) The incidence of injury or death caused by impact with Wire Ropes Safety Barriers (WRSB) is very low. According to University of NSW research, of 1261 fatal motorcycle crashes in Australia in the years 2001 to 2006, only six were a result of impact with a WRSB. This is less than 0.5% of motorcyclist fatalities.
- (4) Research on the safety of WRSBs for motorcyclists has been undertaken by the Transport and Road Safety group at the University of New South Wales. The research found that WRSBs have half the fatality rate of W-Beam barriers.
- (5) Research on the relative safety of barrier types for motorcyclists found that WRSBs were the safest barrier for motorcyclists. The fatality rate of WRSBs is approximately half that of steel barriers and two-thirds that of concrete barriers.
- *2725 TRAFFIC COUNTS—Mr Robert Furolo asked the Minister for Transport representing the Minister for Roads and Ports—

In relation to the traffic counts published by Roads and Maritime Services (RMS):

- (1) For which roads does the RMS publish traffic counts?
- (2) How regularly does RMS publish traffic counts for these roads?
- (3) Why does the traffic count for the M4 published on the RMS website only go to May 2010?
- (4) (a) Are there plans to ensure the traffic count for the M4 is updated?
 - (b) If so, when will the information be updated?
- (5) (a) Are there any plans to publish traffic counts on major roads which currently do not have their traffic counts published on the RMS website?
 - (b) If so when?

Answer—

I am advised:

- (1) RMS currently collects traffic volume information across the NSW classified road network at strategic points.
- (2) RMS is developing a new interactive internet service which will allow customers to click at a point on a map and get the traffic volume information. This information will be updated by RMS annually.

In the mean time, RMS has established a contact email and hotline service for customers wishing to get RMS traffic volume information. This service is available at riss.info@rms.nsw.gov.au or by calling 13 22 13

(3) Traffic information for the M4 Motorway began to be published on the RMS website on 17 February 2010 when the operation of the M4 returned to the NSW Government.

This traffic information was published to inform road users on how traffic patterns may have changed with the removal of the toll. However customer demand for this information was not high and was subsequently removed from the website.

M4 traffic information will be included as part of the new RMS service. This information is also currently available by emailing riss.info@rms.nsw.gov.au or by calling 13 22 13.

- (4) (a) and (b) Publishing the traffic volumes on the M4 will be part of the new RMS interactive service.
- (5) (a) and (b) As part of the new RMS service, an interactive map is being developed that will show the traffic volumes at key points on the road network. Anyone wishing to be notified when this map is published by RMS can register their interest by emailing riss.info@rms.nsw.gov.au
- *2726 SAFETY BARRIERS—Mr Robert Furolo asked the Minister for Transport representing the Minister for Roads and Ports—

With regards to safety barriers used on NSW roads:

- (1) What are the types of safety barriers used on NSW roads?
- (2) Have all the safety barriers currently used on NSW roads been crash tested using motorcycles?
- (3) (a) What safety barrier type has not been crash tested with motorcycles?

(b) For those safety barriers are there plans to conduct crash testing with motorcycles and when?

- (4) What standards apply to the use of safety barriers in NSW?
- (5) Do the standards for safety barriers in NSW consider the impact on motorcyclists?
- (6) How often are the standards for safety barriers reviewed?
- (7) When is the next review of safety barrier standards?
- (8) What is the process for the review of safety barriers in NSW? Will the review include the impact on motorcyclists?

Answer-

I am advised:

(1) There are three main types of permanent safety barriers used on NSW Roads. The first barrier type is the "rigid barrier", which is a concrete barrier. The second is the semi-rigid barrier. The most common type of semi-rigid barrier is the w-beam, which is sometimes called "Armco" barrier. The final barrier type is the flexible barrier. The wire rope safety barrier is a flexible barrier.

The flexible barrier type is favoured by the Centre for Road Safety and Roads and Maritime Services, as it is less likely to cause injuries in a crash.

(2) and (3) I refer you to the answer to Written Question LA 2724.

(4) Part 6 of the "Road Design Guide", entitled "Safety Barriers for Roads and Bridges".

On local roads, local councils have the final say as to barrier installation.

(5) The design standards have three design vehicles, the passenger car, the medium rigid (8 tonne) truck, and the semi-trailer. This is consistent with American and European standards.

(6) to (8) Standards for barrier installation on NSW State roads are currently under review. This is a nationwide review, as part of the wider effort to improve Australia's roads. The review has produced a set of documents called the "Austroads Guide to Road Design". The section of the guide that is relevant to safety barrier installation is due to be re-released.

The design standards review process takes approximately three years. Once finalised, it is expected that periodic review will take place on a three to five year cycle.

Additionally, Roads and Maritime Services runs frequent barrier acceptance panels, designed to discuss, analyse and ultimately accept or not accept new barrier products for use on NSW roads. These panels involve other states' road authorities. The panels consider the safety of all road users, including vulnerable road users, for each barrier type, and identify any potential hazards of new barrier products.

*2727 ROAD SAFETY EDUCATION CAMPAIGNS—Mr Robert Furolo asked the Minister for Transport representing the Minister for Roads and Ports—

In relation to road safety education campaigns:

- (1) What is the total allocation for road safety communication in 2012-13?
- (2) How much of the road safety communication budget in 2012-13 is being used for television advertisements?
- (3) How much of the road safety communication budget in 2012-13 is being used for radio advertisements?

- (5) How much of the road safety communication budget in 2012-13 is being used to pay for advertising agents?
- (6) (a) How much of the road safety communication budget in 2012-13 is being used for consultants?(b) What were the consultants engaged to do?
- (7) (a) Apart from advertisements on television, radio and newspapers and the costs of any advertising agents and consultants?
 - (b) What other activities will the 2012-13 road safety communication budget fund?
- (8) What was the total allocation for the road safety communication budget in 2011-12?
- (9) What was the total allocation for the road safety budget in 2010-11?

Answer-

- (1) \$21.6 million.
- (2) \$4 million has been approved to date.
- (3) \$1.7 million has been approved to date.
- (4) \$0.15 million has been approved to date.
- (5) \$1 million has been approved to date. This includes the agency fees for the production of the new 'Plan B' campaign, as well as the agency fees across the nine existing road safety campaigns.
- (6) (a) Nil.

(b) Not applicable.

(7) (a) and (b) Campaign effectiveness testing; outdoor advertising on road side and in-venue; online advertising; and cinema.

Regional up-weighting of campaigns in local media has been approved to support local needs in addressing key road safety issues.

Other marketing campaigns, such as website development and management is funded to support key initiatives, production of support materials e.g. posters and brochures.

- (8) \$15.6 million.
- (9) \$14.6 million.
- *2728 M9 MOTORWAY CORRIDOR—Mr Robert Furolo asked the Minister for Transport representing the Minister for Roads and Ports—

In relation to the M9 Motorway Corridor:

- (1) What work has been undertaken to identify a route for the M9 Motorway corridor?
- (2) Has the route been selected?
- (3) What is the route?
- (4) What action has been taken to reserve land necessary for the M9 Motorway?
- (5) Is any land on the proposed route currently owned by government agencies, authorities or Government Trading Enterprises?
- (6) What is the value of acquiring the land necessary for the M9 Motorway?
- (7) Has the NSW Government budgeted any funds to identify the route or to acquire land for the M9 Motorway?

The draft NSW Long Term Transport Master Plan identifies the need to reserve important transport corridors to enable the cost efficient, long term development of the transport network. Transport for NSW will work with the Department of Planning and Infrastructure, to improve the process for identifying and protecting corridors and, over time, secure the land required to deliver new transport infrastructure.

The draft NSW Long Term Transport Master Plan identified the Outer Sydney Orbital/M9 corridor for long term transport requirements.

The final NSW Long Term Transport Master Plan will be released later this year.

*2729 M5 EAST TRAFFIC VOLUMES—Mr Robert Furolo asked the Minister for Transport representing the Minister for Roads and Ports—

In relation to traffic volumes on the M5 East:

- (1) What is the current average daily traffic volume for the M5 East?
- (2) What was the average daily traffic volume in 2011?
- (3) What was the average daily traffic volume in 2010?
- (4) What percentage of current average daily traffic volume on the M5 East consists of heavy vehicles?
- (5) What percentage of 2011 average daily traffic volume on the M5 East consists of heavy vehicles?
- (6) What percentage of 2010 average daily traffic volume on the M5 East consists of heavy vehicles?

Answer-

I am advised:

- (1) 98.033.
- (2) 100.592.
- (3) 98,920.
- (4) 7.9%.
- (5) 7.9%.
- (6) 7.5%.
- *2730 NUMERACY AND LITERACY LEVELS—ABORIGINAL CHILDREN—Ms Sonia Hornery asked the Minister for Education—
 - (1) (a) Has the Government failed to improve numeracy and literacy levels among Aboriginal children in NSW?
 - (b) If so, why has this happened?
 - (2) (a) Is the Government ensuring each child has access to sufficient resources and support?(b) If not, why?
 - (3) How will the Minister address the gap between Aboriginal and non-Aboriginal students in reading and numeracy?

Answer-

(1) (a) and (b) In August 2012, the Auditor-General released his Performance Audit Improving the literacy of Aboriginal Students in NSW public schools. This Audit looked at the Department's processes over the last decade that were designed to improve the literacy of Aboriginal students. This included the processes of the previous government.

I refer the Member back to the Performance Audit, Improving the literacy of Aboriginal Students in NSW public schools, and to the key findings of the Auditor-General.

The NSW Government is committed to closing the literacy and numeracy outcomes gap between Aboriginal students and all students in NSW. The factors influencing Aboriginal student outcomes are complex and multifaceted. Persistent system-wide effort will be required in order to significantly reduce the gap in literacy and numeracy outcomes between Aboriginal and non-Aboriginal students.

(2) (a) Yes.

(b) New South Wales government schools use available resources to meet the needs of each of their students, including Aboriginal students. In addition to the global public school allocations, the NSW Government provides approximately \$75 million each year to support a range of targeted initiatives designed to improve learning outcomes for Aboriginal students and improve the way the Department works with Aboriginal families and communities.

In addition to school based strategies for improving the reading and numeracy gap between Aboriginal and non-Aboriginal students, two new initiatives are being developed by the Department of Education and Communities that will have a significant impact on Aboriginal student literacy and numeracy outcomes. These are Connected Communities and Early Action for Success.

The Connected Communities strategy is an innovative approach for the planning and delivery of quality education for Aboriginal students that will be implemented in 15 schools servicing 12 of the most complex, vulnerable and disadvantaged communities in NSW from 2013. It will drive improved educational outcomes for Aboriginal students through linking learning to other related services.

Government schools in these locations will become the hubs of their communities, delivering not only quality and relevant education, but also linking with services such as health, welfare, early childhood education and care and vocational education and training in a holistic response to address local needs.

The Government, through its Literacy and Numeracy Action Plan, is investing \$261 million over 5 years from 2012-2016 to support students who are most at risk of not reaching minimum standards in literacy and numeracy.

Each of the Government, Catholic and Independent sectors have developed implementation plans to achieve the state plan targets. Each sector is required to track and report on the achievements of the students in the schools nominated for the intervention.

Early Action for Success is a Department of Education and Communities initiative that improves students' literacy and numeracy skills through a targeted approach working with primary schools. This initiative has four key features: instructional leadership; personalised learning; assessment for learning; and, high quality professional learning with a focus on the early years of schooling K-2. Funding for the appointment of 50 hands-on Instructional Leaders in public schools with the greatest need, many of which have Aboriginal students, has been provided.

Instructional Leaders, Literacy and Numeracy will also form part of the Connected Communities strategy and will be appointed to the 10 Connected Communities schools with Kindergarten to Year 2 enrolments. Whilst these communities have a high proportion of Aboriginal students, remedial strategies put in place will support improved achievement in Literacy and Numeracy outcomes for all students.

- *2731 SAFETY STANDARDS FOR CONSTRUCTION WORKERS—Ms Sonia Hornery asked the Treasurer representing the Minister for Finance and Services, and Minister for the Illawarra—
 - (1) What is being done in response to media reports indicating the use of negligible perimeter scaffolding on work sites in the Hunter region (ABC News 9 August 2012)?
 - (2) How is the Minister ensuring employers do not cut corners in occupational health and safety by using minimal or lesser quality products in the protection of employees?

Answer-

(1) In response to the ABC News media report on 9 August 2012, a representative from WorkCover met with the Construction, Forestry, Mining and Energy Union (CFMEU) State Organiser on 20 August 2012, to formally discuss the safety concerns raised.

WorkCover addressed each of the safety concerns raised by the CFMEU relating to the identified construction sites in the Hunter region. All work health and safety issues, including the safe use of perimeter scaffolding were satisfactorily addressed by the contractors. This was communicated in writing to the CFMEU on 21 August 2012, with no further issues raised.

(2) The Work Health and Safety Act 2011 and Work Health and Safety Regulation 2011 places an overarching duty on persons conducting a business or undertaking to ensure the safety of workers, with prescriptive requirements addressing high risk issues such as working on scaffolding and falls from heights.

WorkCover inspectors attend construction sites across New South Wales on a daily basis to verify compliance with work health and safety legislation and relevant Australian Standards. During each workplace visit, inspectors pay particular attention to the risk of falling from heights and evaluate any control measure implemented, such as scaffolding or perimeter edge protection, for its adequacy and take action to address any breach identified.

WorkCover also engages regularly with key construction industry stakeholders, such as the Master Builders' Association, Housing Industry Association, trade unions and employer groups, providing information, advice and assistance on falls from heights and scaffolding issues in the industry.

- *2732 MOTOR REGISTRY CLOSURES—Ms Sonia Hornery asked the Minister for Transport representing the Minister for Roads and Ports—
 - (1) Will the Minister be closing any motor registries in the Hunter region?
 - (2) If so:
 - (a) Which registries and when?
 - (b) How many staff will lose their jobs as a result of the closure?

Answer-

I am advised:

There are no current plans to close any motor registries in the Hunter region.

- *2733 NEWCASTLE LOCAL AREA COMMAND—AUTHORIZED STRENGTH—Ms Sonia Hornery asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
 - (1) What is the authorized strength of the Newcastle Local Area Command (LAC)?
 - (2) Is the LAC operating at or above the authorized strength number of 90 per cent?
 - (3) If it is operating below 90 per cent, why?

Answer-

Information about police authorised and actual strength is available on the NSW Police Force website, www.police.nsw.gov.au

Operational capacity in the Newcastle City Local Area Command as at 24 August 2012 was 98%.

- *2734 EXPANSION OF CONTAINER PORTS—Ms Sonia Hornery asked the Minister for Transport representing the Minister for Roads and Ports—
 - (1) Why has the Government chosen to expand Port Botany and Port Kembla and not the Hunter region as a site for a full-scale container port?
 - (2) Given that 80 per cent of containers leave Port Botany by road, how will the Government accommodate the extra traffic when the M5 motorway is already heavily congested during peak-hour traffic?
 - (3) Why has the Government chosen to expand ports that do not have sufficient resources to support their expansion?

Answer—

I am advised:

- (1) and (3) These questions should be redirected to the Treasurer as they relate to the Ports refinance transaction.
- (2) The NSW State Infrastructure Strategy and the NSW Long Term Transport Master Plan address the future transport needs of Port Botany.
- *2735 ACE SERVICE CLOSURE—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—
 - (1) Why was a decision made by John Hunter Hospital to close the ACE Service, which supports women who experience antenatal and postnatal depression?
 - (2) When was this decision made?
 - (3) Was it due to funding cutbacks in Hunter Health?
 - (4) How much money will the Government save by closing this service?
 - (5) (a) Are there other services available to women experiencing antenatal and postnatal depression?

(b) If not, will the closure of this service adversely impact on women's health in the Hunter?

Answer-

I am advised:

(1) to (3) A recent review of the ACE service conducted by John Hunter Hospital identified that the service lacked integration with Maternity Services, Mental Health and Child and Family Health Services, and was not working within a contemporary midwifery model.

ACE staff were informed of the decision to integrate the service on 2 August 2012 and the ACE Service ceased to operate on 31 August 2012. The service was integrated into Maternity Services, Mental Health and Child and Family Health Services to provide high quality, contemporary service to the women who require these services.

(4) Resources are being redirected into midwifery roles within the Division of Maternity and Gynaecology. There are no savings from these changes to service delivery.

(5) The Family Care Midwives Team is available to women experiencing antenatal and postnatal depression. The Family Care Midwives Team provides an efficient contemporary model of care that works within the Primary Maternity Services Framework of Australia in accordance with the model set out in the Families NSW Supporting Families Early Package.

*2736 EXTRA LITERACY AND NUMERACY TEACHERS—Ms Sonia Hornery asked the Minister for Education—

- (1) How many of the promised extra literacy and numeracy teachers for the electorate of Wallsend are currently employed in local schools?
- (2) What are the names of the schools where these teachers are located?
- (3) What is the timeframe for the remaining teachers to be placed?
- (4) What schools will be receiving these remaining teachers?

Answer-

- (1) There are no extra literacy and numeracy teachers (Instructional Leaders, Literacy and Numeracy) currently employed in the electorate of Wallsend.
- (2) Not applicable.
- (3) The equivalent of 900 additional full time teaching positions will be allocated in the time period 2012-2016.
- (4) The identification and selection of schools, including those in the electorate of Wallsend, to receive additional resources under the Literacy and Numeracy Action Plan will be ongoing over the five years of the government commitment. For this reason it is not possible to provide a final list of schools.
- *2737 WORKERS ENTITLEMENTS—Ms Sonia Hornery asked the Treasurer representing the Minister for Finance and Services, and Minister for the Illawarra—

Given the Government has applied to the Industrial Relations Commission to change 98 workplace awards of 80,000 NSW public sector workers, why is the Government allowing such an erosion of workers entitlements?

Answer—

The Government is paying public sector workers a minimum 2.5 per cent wage increase, which is currently above inflation. Increases above 2.5 per cent per annum can be awarded if employee-related savings have been achieved.

An application was made to the Industrial Relations Commission in June 2012 to vary provisions in the Crown Employees (Conditions of Employment) Award to enable wage increases above 2.5 per cent to be provided. As per the wages policy, no changes will be made without the agreement of all parties or the Industrial Relations Commission.

The Government believes its wages policy is fair for public servants and affordable for the State, particularly in the current economic environment.

*2738 JOBS FOR THE HUNTER—Ms Sonia Hornery asked the Minister for Transport—

Why did the Minister award the contract to build buses to a Queensland company rather than to a local Hunter region company?

Answer-

I am advised:

A trial of double deck buses commenced on 27 August 2012 using buses manufactured by BusTech, which is based in Queensland. 40 percent of BusTech's employees reside in NSW.

BusTech has in the past been awarded contracts for the manufacture of buses ordered by the previous government.

- *2739 BROTHEL LICENSING AUTHORITY—Mr Paul Lynch asked the Minister for Resources and Energy, Special Minister of State, and Minister for the Central Coast—
 - (1) Who were the members of the working party examining the issue of establishing a Brothel Licensing Authority?
 - (2) From whom did the working party seek or receive submissions?

Answer-

(1) and (2) The Government has tasked the Department of Premier and Cabinet, assisted by an interagency Working Party, to lead the development of options to implement this commitment.

The Working Party is inviting submissions on the Issues Paper from all interested parties which will feed into options for the Government's consideration.

*2740 CANCELLATION OF TRAIN SERVICES—Mr Paul Lynch asked the Minister for Transport—

- (1) What was the reason for cancellation of train services from Liverpool to the City on 27 August 2012?
- (2) How many such trains were cancelled on that day?
- (3) What steps will be taken to prevent this occurring again?

Answer-

I am advised:

(1) to (3) Some trains from Liverpool to the City were affected by emergency overhead wiring repairs near Auburn on Monday 27 August 2012. Experienced train controllers made decisions to limit the impact of the incident on the wider network.

A significant program of investment focused on improving rail infrastructure and making it more reliable is currently underway. When disruptions to rail services occur, incident response staff and station staff work hard to minimise inconvenience, restore services as quickly as possible and keep customers informed of the latest service information.

*2741 SOCIAL BENEFIT BONDS-Mr Paul Lynch asked the Attorney General, and Minister for Justice-

Has the Joint Development Phase of the Trial for a Recidivism pilot of Social Benefit Bonds involving Social Finance and Mission Australia and the Department of Attorney General and Justice been completed?

Answer-

As this trial is being led by the Treasury, the question should be redirected to the Treasurer.

*2742 NSW LAW REFORM COMMISSION REPORT NO 135—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

What is the Government's response to NSW Law Reform Commission Report No 135 "People with cognitive and mental health impairments in the criminal justice system - Diversion"?

Answer—

The Government is carefully considering the 55 recommendations made in the NSW Law Reform Commission's (LRC's) report on the diversion of people with cognitive and mental health impairments in the criminal justice system.

The Department will set up a committee, including senior officers from key mental health, disability and criminal justice agencies, in order to prepare a whole of government response to the LRC's report.

*2743 NSW LAW REFORM COMMISSION REPORT NO 134—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

What is the Government's response to NSW Law Reform Commission Report No 134 "Sentencing - Interim report on standard minimum non-parole periods"?

Answer—

I am advised:

The NSW Law Reform Commission's (LRC) recommendation on standard minimum non-parole periods (SNPP) was made on an interim basis, pending monitoring and review of the SNPP scheme and consideration of the LRC's final report.

The review of the SNPP scheme will be deferred until the Government has carefully considered the LRC's final report.

- *2744 CORRECTIVE SERVICES CENTRES—FOOD FOR INMATES—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
 - (1) What changes have been made in corrective services centres this year to the provision of food for inmates and in the purchase of ingredients for inmates to make their own food?
 - (2) What was the basis for such changes?
 - (3) Are rice, garlic and tomatoes no longer available for purchase?
 - (4) Has this decrease in range made it less likely that some inmates will work because they can no longer buy what they want?
 - (5) In making this decision, was any consideration given to culturally specific food needs?

Answer—

I am advised:

- (1) All perishable food items were removed from the Male and Female Corrective Services NSW (CSNSW) Grocery Buy Up (the buy up list).
- (2) The basis for this change was food health and safety issues.
- (3) Pre-cooked rice is available; however, raw rice is no longer available. As fresh garlic and tomato are perishable items they are not available; however, tinned tomatoes are available.
- (4) There is no evidence to suggest that it is less likely that some inmates will work because they can no longer buy what they want. Inmates, through the local Inmate Development Committees, have the opportunity to nominate product items that they would like to see added or removed from the buy up list twice per year.
- (5) CSNSW endeavours to provide all inmates with a balanced and varied diet. The buy up list contains culturally friendly food items. These items have been identified and added to the buy up list in response to advice received from Official Visitors, the Cultural and Linguistic Coordinator, the Chaplaincy Advisor and Justice Health.
- *2745 SUPERANNUATION ENTITLEMENTS—FORMER PARTNERS OF JUDICIAL OFFICERS—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

What proposals does the Attorney General have to alter current superannuation entitlements and arrangements concerning former partners of judicial officers?

Answer—

I am advised:

On 20 September 2012 the Commonwealth Parliament passed the Judges and Governors-General Legislation Amendment (Family Law) Bill 2012 (Cth). This Bill will enable a former spouse of a judge to receive his or her share of a superannuation benefit as a separate benefit at the time of a family law split.

My Department will consider whether similar amendments should be made in NSW.

*2746 HAMBURGER REVIEW—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

Which recommendations, if any, of the Hamburger Review have not been implemented by the Government and/or Corrective Services NSW?

Answer-

I am advised:

The Knowledge Consulting Independent Review of Corrective Services NSW Organisational Management Structure (the Hamburger Review) dated 11 January 2012 made 61 recommendations, including that a further 14 reviews be undertaken.

Implementation of the Hamburger Review is being oversighted by a Restructure Implementation Team consisting of Laurie Glanfield, Director General, Department of Attorney General and Justice, Peter Severin, Commissioner of Corrective Services NSW (CSNSW) and Ken Moroney, former Police Commissioner.

The Director General commissioned a second report to ensure that implementation of the recommendations was proceeding according to plan.

On 2 August 2012, Knowledge Consulting provided a second report which resulted in a number of recommendations made in the Hamburger Review being superseded.

I can advise that, as at 8 October 2012, the implementation status of the Hamburger Review recommendations is as follows:

20 recommendations have been implemented;

- 15 recommendations have been partially implemented;
- 17 recommendations have not yet been implemented; and

9 recommendations were superseded by the second report.

- *2747 CONTRACT WITH ATMAAC INTERNATIONAL—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

The contract for security patrols at closed correctional centres (Kirkconnell, Berrima and Parramatta) was entered into on 7 October 2011.
- (2) (a) Yes.

(b) Corrective Services NSW (CSNSW) had a contractual arrangement with ATMAAC International Pty Limited for perimeter security at a number of correctional centres; general/static security (including boom gate operations, protection and security at correctional centres which have been closed and security services at CSNSW head office and Community Offender Support Program residential facilities); and alarm monitoring of offenders subject to electronic monitoring.

- (3) At midnight on 2 September, 2012.
- (4) Pacific Rim Employment Pty Limited has replaced ATMAAC International in providing boom gate and perimeter security services and alarm monitoring services. Triple O Security Pty Limited has replaced ATMAAC International in providing security patrols at closed correctional centres.
- (5) 3 September, 2012.
- *2748 FUNDING FROM DESTINATION NSW—Mr Ryan Park asked the Minister for Tourism, Major Events, Hospitality and Racing, and Minister for the Arts—
 - (1) Over the 2011-12 financial year, how much funding from Destination NSW was allocated to the:
 - (a) Hunter region;
 - (b) Illawarra region?

Answer-

(1) Funding provided under these programs in 2011-12 for:

- (a) and (b) Penalty rates for security staff are in accordance with the Health Employees Conditions of Employment (State) Award. There are no proposals at present to vary penalty rates under that Award. Any Award variations would need to be made by the Industrial Relations Commission of New South Wales.
- (2) and (3) The security services at Sydney Children's Hospital, Randwick, are provided by Prince of Wales Hospital under a shared services agreement.

There are currently no plans to privatise security services at The Children's Hospital at Westmead or Sydney Children's Hospital, Randwick. There are currently no plans to reduce staffing numbers of security services at The Children's Hospital at Westmead or Sydney Children's Hospital, Randwick. Should this change, in accordance with the consultative arrangements outlined in the Award, The Sydney Children's Hospitals Network will consult with key stakeholders. *2755 INNER CITY HIGH SCHOOLS-Ms Clover Moore asked the Minister for Education-

Given that the Department of Education and Communities is not currently investigating any options for additional high school facilities in the inner city (Question 2278):

- (1) Are Conservatorium High School, Cleveland Street Intensive English High School, Sydney Boys High School and Sydney Girls High School open for general secondary school enrolment?
- (2) Has Newtown High School of Performing Arts reached capacity and has its catchment area reduced and cannot take additional general enrolments?
- (3) When will Sydney Secondary College reach capacity and be unable to take additional general enrolments or have its catchment area reduced?
- (4) (a) Is the Sydney Secondary College Blackwattle Bay campus operating at 100 per cent capacity for Year 11 and Year 12?

(b) If so, what plans does the Government have to address this?

- (5) What other high school options are available for inner city students?
- (6) (a) Has the Government made any assessment of using the Cleveland Street Intensive English High School campus for additional high school capacity?

(b) If so, would places be offered at this campus and when?

- (7) Have inner city primary school principals been advised that Cleveland Street Intensive English school will be incorporated as a campus for Sydney Secondary College?
- (8) What other options has the Government considered to provide access to high school for inner city students beyond 2016?
- (9) What is the Government's policy about students having to travel past selective high schools they are unable to attend in order to reach a comprehensive high school?
- (10) What is the Government's policy about the maximum time students should have to travel to get to school?
- (11) What is the Government's policy about requiring students to travel out of their local area to reach a high school that has places available for them?

Answer-

(1) No.

(2) Newtown High School of the Performing Arts has reached its capacity and the designated local intake area for the school has been reduced. However, students residing within that area who apply for enrolment and are eligible for enrolment are enrolled. Students residing outside the local designated intake area can apply for enrolment through an audition process.

(3) and (4) Sydney Secondary College accepts enrolments from its designated local area. Students residing within that area who apply for enrolment and are eligible for enrolment are enrolled. The Sydney Region of the Department of Education and Communities does not have plans to redraw catchment areas for the College.

(5) Alexandria Park Community School is an option available to inner city students.

(6) The Department has no plans to change the function of Cleveland Street Intensive English High School.

(7) No.

(8) Department asset planners consider many factors, including demographic trend analysis, consultation with Council, developers and NSW Planning and Infrastructure, and local circumstances. Options for high school access for students in the inner city area beyond 2016 are still being explored.

(9) to (11) A child is entitled to be enrolled at the government school that is designated for the intake area within which the child's home is situated and that the child is eligible to attend.

(12) Transport for inner city students to reach high schools was part of the planning process for the current provision of government schools in the Sydney Local Government Area.

(13) The Department liaises with Transport NSW to provide transport to government schools.

- *2756 STRATEGIC LAND USE PLAN FOR SYDNEY BASIN—Ms Clover Moore asked the Minister for Planning and Infrastructure, and Minister Assisting the Premier on Infrastructure NSW, Leader of the House—
 - (1) (a) Will the Government rule out mining in the Sydney basin, such as through a strategic land use plan?
 - (b) If not, why not?
 - (2) (a) Will the Government develop a strategic land use plan for mining in urban areas such as Sydney?(b) If not, why not?
 - (3) (a) Will the Government develop a strategic land use plan for mining in all areas with water sources that feed Sydney's water supply?

(b) If not, why not?

Answer-

- (1) As part of the development of the Metropolitan Strategy for Sydney, the Government will examine land use conflicts around mining in the Sydney basin and appropriate policy options to address these issues.
- (2) Issues relating to mining in Sydney are being addressed through the Metropolitan Strategy for Sydney.
- (3) Preliminary work has commenced on the preparation of a Strategic Regional Land Use Plan for the Southern Highlands, which includes part of Sydney's drinking water catchment. The Illawarra Regional Strategy, which also includes part of Sydney's drinking water catchment, will also be reviewed. Mining issues will be fully considered as part of these two planning excercises.
- *2757 FAST FOOD LABELLING—Ms Clover Moore asked the Minister for Primary Industries, and Minister for Small Business—

Given standard food outlets in New South Wales only have to display information about energy content for each standard food item and the average energy intake, while other components are associated with obesity:

- (1) What consideration will the Government give to introducing mandatory requirements for food outlets to display information about:
 - (a) saturated fats;
 - (b) trans-fats;
 - (c) salt content;
 - (d) sugar content;
 - (e) nutrition?
- (2) What action has the Government taken to encourage fast food outlets to provide information about the content of food on their menu with regard to fat, salt, sugar and nutrition?
- (3) What plans does the Government have for further work to encourage fast food outlets to provide nutritional labelling?

Answer—

- (1) NSW was the first state to mandate the display of nutrition information on menus in standard food outlets. Part of this program is a legislated requirement to review the terms and policy objectives of the initiative and table a report of the review in Parliament by 1 February 2013. Extension of the requirements to things such as salt and fat will be assessed.
- (2) The NSW Government has worked closely with industry during the implementation of the mandatory display of kilojoules. This has resulted in industry partnering with the Authority in the development of key consumer messages which have been rolled out voluntarily by various businesses. Other work has included industry participation in the development of the NSW government's 8700.com.au campaign, which supports the menu display requirements and provides general nutrition information.
- (3) The legislated review needs to be completed, as does a formal evaluation of the work done to date. Finally, consideration needs to be given to how all of this work fits in with national food regulatory policy. Once this work is done, the NSW Government will be in a sound position to make decisions with respect to further initiatives, based on solid evidence.
- *2758 GAS EXPLORATION IN SYDNEY—Ms Clover Moore asked the Minister for Resources and Energy, Special Minister of State, and Minister for the Central Coast—

- (1) What licences to explore for gas exist for the Sydney basin?
- (2) What applications to explore for gas or renew existing licences to explore for gas in the Sydney basin are pending?
- (3) What plans does the Government have to revoke existing licences to explore for gas in the Sydney basin?
- (4) What plans does the Government have to rule out any exploration or mining in the Sydney basin? Answer—
- (1) to (4) The list of petroleum titles and applications is available on the Division of Resources and Energy website.

*2759 GONSKI SCHOOL REFORMS-Ms Clover Moore asked the Minister for Education-

Noting that the Prime Minister has announced that that the Commonwealth Government will provide new funds for schools in response to the 2011 "Review of Funding for Schooling" or Gonski report:

- (1) What assessment has the NSW Government made about the Gonski report and its recommended:
 - (a) new funding model for schools;
 - (b) new "schooling resource standard";
 - (c) loadings for socioeconomic background, disability, English language proficiency, Indigenous students, school size, and school location?
- (2) Does the NSW Government support the Gonski report recommendations that students receive the same level of resources in all school sectors?
- (3) How will the NSW Government ensure needed resources for NSW schools?
- (4) What liaison has the NSW Government had with the Commonwealth and other States and Territories to implement the Gonski report;
- (5) What action has been taken to implement these recommendations in NSW?
- (6) What further action will the NSW Government take to improve school resources and standards?

Answer-

(1) New South Wales believes the "base" plus "loadings" framework outlined in the Gonski report to be conceptually sound, and that the loadings put forward by the Gonski model broadly capture the areas of greatest need.

(2) The Gonski report does not recommend that students receive the same level of funding in all school sectors.

(3) The NSW Budget for education has increased by \$383 million to a total of \$13.83 billion in 2012-13.

(4) and (5) New South Wales works with the Commonwealth through the Council of Australian Governments and the Standing Council on School Education and Early Childhood. The NSW Government remains committed to dealing constructively with the Commonwealth about the Gonski reforms. However, the NSW Government is receiving \$2.5 billion less in revenue each year compared to when we were elected.

NSW will not make Budget decisions based on vague promises of money at some point in the future.

The NSW Government has consistently called on the Commonwealth to commit to the lion's share of the funds required.

It is very frustrating that the NSW Government still has no detail about how much, if any, funding is on the table.

The NSW Government looks forward to receiving a detailed response from the Commonwealth on each of the Gonski recommendations, including modelling and funding arrangements.

(6) New South Wales is already taking a proactive approach towards school funding reform with the implementation of a new Resource Allocation Model for government schools, under the Local Schools, Local Decisions reform agenda. Like the Gonski Model, the Resource Allocation Model uses a "base" plus "equity-loadings" structure, thereby improving the mechanism by which resources are targeted to the areas of greatest need.

*2760 PROTECTING ORGANIC FOOD FROM GM CONTAMINATION—Ms Clover Moore asked the Minister for Primary Industries, and Minister for Small Business—

Noting that a Western Australian organic farmer is taking Supreme Court action after he lost organic certification for 70 per cent of his 478 hectare farm in 2010 due to contamination by genetically modified (GM) seeds from his neighbour's property:

- (1) What proportion of canola crops in New South Wales are GM?
- (2) Is the Government aware of any cases of non-GM farms being contaminated with GM seed in New South Wales?
- (3) What consideration will the Government give to requiring GM farmers to notify neighbours that their property will grow GM crops?
- (4) What consideration will the Government give to requiring GM farmers to direct harvest GM canola with bans on cutting and leaving crops on the ground for days where they can be blown or washed on to neighbouring land?
- (5) Given many consumers want to avoid GM food and GM-free canola sells at a higher price, what support will the Government give to non-GM farmers who want to prevent GM contamination?
- (6) What action will the Government take to ensure New South Wales retains a strong organic farming industry?

Answer-

- (1) In 2010 GM canola represented about 7.6% of the total NSW canola crop.
- (2) No.
- (3) In NSW the Gene Technology (Crop Moratorium) Act 2003 permits GM cotton or canola to be grown in research trials or as a commercial crop provided these activities are appropriately licensed by the Commonwealth.

The Commonwealth's Office of the Gene Technology Regulator (OGTR) undertakes a comprehensive risk assessment for each licence application, including risks to neighbouring properties. The OGTR prepares a Risk Assessment and Risk Management Plan (RARMP) for each application. The OGTR's determination may impose conditions on licence holders to ensure adequate management of identified risks.

- (4) The RARMP prepared by the OGTR for each licence application addresses such risks, if identified.
- (5) There have been no reported cases of GM contamination in NSW, including of organic crops.
- (6) The Government supports the current process for managing licence applications for GM crops.

*2761 ILLAWARRA SOUTH EAST REGION SCHOOLS-Mr Ryan Park asked the Minister for Education-

In relation to the Illawarra South East region of schools:

- (1) What projects were nominated for funding under the Major Capital Works process in the 2011-12 and 2012-13 financial years?
- (2) What projects were successful for each of those years?

Answer-

- (1) In 2011-12 and 2012-13, there were 20 projects in the Illawarra and South East Region that were nominated for funding under the Major Capital Works process.
- (2) No major capital works projects were approved for the Illawarra and South East Region in 2011-12 or 2012-13. They will be considered for inclusion in a future capital works program.
- *2762 PROTECTION FROM THE SUN GUIDELINES-Mr Ryan Park asked the Minister for Education-

- (2) In the financial year 2011-12 approximately 2 percent of public housing dwellings were vacant.

- *2771 SOLAR ENERGY REBATE—Mr Clayton Barr asked the Minister for Resources and Energy, Special Minister of State, and Minister for the Central Coast—

With regard to the Solar Energy Rebate in NSW, will the Government continue to reduce its contribution to the scheme in direct proportion to the contribution designated by IPART to the energy providers?

Answer-

The Government has assured customers that they will continue to receive their 60 cent or 20 cent tariff until the Scheme ends on 31 December 2016.

The Independent Pricing and Regulatory Tribunal (IPART) has determined that the retailer companies receive an unjustified financial benefit from the Scheme by receiving the electricity generated from solar panels for free.

A number of energy retailers have used these additional profits to offer voluntary financial incentives for customers with solar panels.

Therefore some customers may have received an additional five to eight cents on top of the Solar Bonus payments. This payment has been at the discretion of the retailer and does not form part of the Solar Bonus Scheme.

Acting on the recommendation of IPART, the Government is now requiring energy retailers to contribute 7.7 cents per kilowatt hour to the cost of the financially unsustainable Scheme. This will reduce the costs passed on to all NSW households.

Some energy retailers have since decided to withdraw their voluntary incentive payment. This is a matter for the customer and their retailer.

The Member would be aware that the former Government established a financially unsustainable scheme which the households of NSW continue to pay for via a component of their electricity bills.

The Government will continue doing all it can to rein in rising electricity prices caused by the Solar Bonus Scheme.

(4) The government is focused on successfully completing the transactions for Port Botany and Port Kembla in 2012-13 with the proceeds to be invested in Restart NSW for use on priority infrastructure works as determined by Infrastructure NSW. The Government has not considered any other Port transactions beyond these.

*2775 FIRE STATIONS—ELECTORATE OF CESSNOCK—Mr Clayton Barr asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

With regard to fire stations in the electorate of Cessnock:

Between 15 August 2012 and 5 September 2012 Abermain, Bellbird, Kearsley and Weston fire stations were taken offline for periods of between 1 and 18 hours at such times as required. FRNSW can take fire stations offline that are positioned in areas where they can be covered by personnel from adjoining areas. There have been no occasions where four or more stations were shut/offline at any one time in the Cessnock electorate for this period.
- *2776 SCHOOL ZONE FLASHING LIGHTS—Mr Clayton Barr asked the Minister for Transport representing the Minister for Roads and Ports—

With regard to the safety and security initiatives known as School Zone Flashing Lights:

- (1) Do all schools located on highways in New South Wales have School Zone Flashing Lights?
- (2) If not, when will the installation for these schools be finalised?

Answer-

- (1) The NSW Government made a 4-year, \$13 million election commitment to install school zone flashing lights. This means approximately 540 flashing lights will be installed in school zones. In addition, in May 2012 an additional \$4 million was committed for the rollout of flashing lights in regional areas, which will result in about 160 additional regional school zones with flashing lights.
- (2) This equates to the Government committing \$17 million over 4-years and means flashing lights will be installed in approximately 700 school zones over that period, compared to 411 school zones in the previous government's last term.

- (4) Will these positions be retained in the 2013-14 financial year?

Answer-

- (1) Yes.
- (2) Yes.
- (3) \$604,840 has been allocated to these six positions in 2012-13.
- (4) Yes.

*2778 PHONE SCAM—Ms Tania Mihailuk asked the Minister for Fair Trading—

- (1) Is the Government aware of a scam in which individuals are contacted by phone, informed they are owed a refund from their bank for overpayment and must provide details for a 10% GST fee?
- (2) If so, what action has the Government taken to prevent consumers from being ripped off by this scam?

Answer—

I am advised that NSW Fair Trading has investigated this type of scam, among others. As the operators of these scams appear to originate from overseas, Fair Trading has been unable to identify the traders involved. A number of media releases have been issued since 2010, warning the public to avoid the scam, hang up on the call and report the matter to Fair Trading.

As part of the NSW Government's fight against scammers, last year Fair Trading introduced a mobile phone Scam Buster app which can be downloaded for free from the Apple App Store and the Android Market. Scam Buster allows consumers to report suspected scams to Fair Trading and provides advice on the latest scams targeting the community. This initiative compliments the regular scam awareness information sessions conducted by Fair Trading.

Fair Trading is also exploring ways to investigate complaints which involve the international transfer of funds for goods and services which are never delivered to the consumer.

*2779 PREVENTION OF MANUFACTURING JOB LOSSES—Ms Tania Mihailuk asked the Deputy Premier, Minister for Trade and Investment, and Minister for Regional Infrastructure and Services—

What action will the Minister take to prevent manufacturing jobs being lost in the greater Bankstown area, including Chullora Industrial Park?

Answer—

The NSW Government regards manufacturing as a key sector of the State's economy and has a number of initiatives designed to support and strengthen the sector.

The Government is developing an Industry Action Plan to position the manufacturing sector for strong growth, resilience, improved innovation and productivity, global competitiveness, and new investment opportunities over the next decade. The Plan is due for release by the end of 2012. Manufacturers in the greater Bankstown area already registered for payroll tax can use the Government's Jobs Action Plan.

Eligible businesses that increase their employment levels can receive a payroll tax rebate following the employment of each additional employee in a position that is a new job.Smaller manufacturers can use the services provided to small businesses through the Office of the Small Business Commissioner. The Commissioner supports small businesses throughout the State by providing advocacy and low cost dispute resolution services.The Government also recently launched Small Biz Connect, a new advisory service to assist small businesses.

*2780 M5 EAST AND M5 WEST MOTORWAYS—Ms Tania Mihailuk asked the Minister for Transport representing the Minister for Roads and Ports—

Given the Transport Master Plan has highlighted the importance of the M5 East Motorway, will the Government commit to constructing the M5 East Motorway in conjunction with the M5 West Motorway?

Answer—

Construction of the \$400 million M5 West Widening commenced in August after the NSW Government signed a contract with Interlink Roads.

The Premier and Minister for Western Sydney Barry O'Farrell has announced the NSW Government will proceed with Infrastructure NSW's recommendation to deliver a key motorway project for Sydney's west.

The 33-kilometre WestConnex tollway will link Sydney's west with the airport and the Port Botany precinct, and will include the M4 extension and duplication of the M5 East to King Georges Road.

*2781 NSW TRANSPORT MASTER PLAN—PRODUCTION COSTS—Ms Tania Mihailuk asked the Minister for Transport—

What was the total cost of producing the NSW Transport Master Plan, including:

- (a) public consultation sessions;
- (b) hire of external consultants or personnel;
- (c) staff;
- (d) printing and related costs;

(e) other?

Answer—

I am advised:

The cost of producing the Draft Long Term Transport Master Plan was substantially less than what the previous government spent developing their ten different plans over sixteen years.

Consulting with the community to develop the Long Term Transport Master Plan will ensure the people of NSW do not have to pay for cancelled, failed or indefinitely deferred projects, such as the CBD Metro or North West Metro as they did under the previous government.

*2782 NEW TRANSPORT INFRASTRUCTURE PROJECTS—Ms Tania Mihailuk asked the Minister for Transport—

Given that the Transport Master Plan identifies Bankstown as a major centre, what new transport infrastructure projects will the Government commit to Bankstown in recognition of this status?

Answer—

The draft NSW Long Term Transport Master Plan sets the direction for transport planning for the next 20 years, providing a framework for transport policy and investment decisions that respond to key challenges. The Government's transport infrastructure investments will be guided by the final Long Term Transport Master Plan to be released later this year.

 - (1) What investigations are currently underway to allow B-triple heavy vehicles to travel on Mount Ousley Road?
 - (2) When will a decision be made about allowing these vehicles to use this road?

Answer-

I am advised:

- (1) There are currently no investigations underway to allow B-Triples to travel on Mount Ousley Road.
- (2) Not applicable.

*2788 ASBESTOS CONTAMINATION AT CALLAN PARK—Mr Jamie Parker asked the Treasurer representing the Minister for Finance and Services, and Minister for the Illawarra—

- (1) When did the Minister first become aware of allegations of asbestos contamination at Callan Park?
- (2) What steps has the Minister taken to investigate these allegations?
- (3) What steps has the Minister taken to ensure the safety of former patients and hospital workers at the site?

Answer-

In March 2011, WorkCover responded to a complaint about a building in the Callan Park precinct. WorkCover's investigation found that the material complained of did not contain asbestos. However, it was identified that other areas of the building contained asbestos that was starting to deteriorate.

WorkCover has been assisting and providing advice to Sydney Harbour Foreshore Authority, who manages large parts of the site, in regard to asbestos registers and the management of facilities that it controls. Sydney Harbour Foreshore Authority has boarded up and sealed off many potentially hazardous buildings over the past year.

In July 2012, an occupational hygienist engaged by Sydney Harbour Foreshore Authority confirmed that the potential health risk posed by the external materials identified at Callan Park is considered negligible while it is undisturbed. Further, the asbestos materials are being managed in a manner consistent with the regulatory guidelines adopted in schools and other commercial settings.

Due to continued break-ins and damage to some areas of the site, Sydney Harbour Foreshore Authority has engaged a licensed asbestos removalist to remove disturbed asbestos. The work has been notified to WorkCover and approved. WorkCover is working with the Sydney Harbour Foreshore Authority to ensure that disused buildings with asbestos materials remain properly secured.

- *2789 ASBESTOS CONTAMINATION AT CALLAN PARK—Mr Jamie Parker asked the Minister for Mental Health, Minister for Healthy Lifestyles, and Minister for Western New South Wales—
 - (1) When did the Minister first become aware of allegations of asbestos contamination at Callan Park?
 - (2) What steps has the Minister taken to investigate these allegations?
 - (3) What steps has the Minister taken to ensure the safety of former patients and hospital workers at the site?

Answer—

I am advised:

(1) to (3) The Sydney Harbour Foreshore Authority carried out a hazardous material survey of buildings at Callan Park under its control in 2011. As a result, a number of buildings were boarded up and locked and signs placed on doors warning of potential asbestos contamination. The SHFA subsequently invited WorkCover to inspect the site and the SHFA has advised that WorkCover were satisfied that the controls were satisfactory.

In May 2012 a claim of exposed asbestos at Callan Park was raised with the NSW Ministry of Health. The Ministry of Health and the SHFA (who have control and management of a significant portion of the campus) investigated the claim. On investigation a number of bags of building materials were found within an area managed by the SHFA. The material did not originate from the Callan Park site. The bags were removed and subsequent air monitoring detected no airborne asbestos fibres.

Regular asbestos audits of all the buildings on the Callan Park site were carried out by the former Central Sydney Local Health Service when the site was operating as a hospital. These audits included condition reports and subsequent hazard rating to ensure that patients and staff were not exposed to asbestos. Information was also recorded relating to asbestos removal and containment works that were carried out at the site when it was operating as a hospital.

The NSW Ministry of Health continues to work with WorkCover and the SHFA to ensure ongoing containment of existing asbestos and to appropriately manage any asbestos related issues should they arise.

*2790 ASBESTOS CONTAMINATION AT CALLAN PARK—Mr Jamie Parker asked the Minister for Health, and Minister for Medical Research—

- (1) When did the Minister first become aware of allegations of asbestos contamination at Callan Park?

- (2) The EPA has no regulatory role in relation to the management of asbestos contained within the building at Callan Park.
- (3) This question should be directed to my colleague, the Minister for Health.
- *2792 FAIRFIELD LOCAL AREA COMMAND—DROP IN STRENGTH—Mr Guy Zangari asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

Noting the Authorised Strength Number at Fairfield Local Area Command (LAC) fell from 198 to 168 between June and July 2012 and the Actual Strength Number fell from 197 to 165 for the same period (NSW Police Force website):

Can the Minister explain the drop in both the Authorised Strength Number and Actual Strength Number at the Fairfield LAC from the June to July 2012 period?

Answer—

I am advised that changes to authorised strength are as a result of the creation of standalone Traffic &Highway Patrol and Police Transport Commands. Officers who were already performing highway patrol or commuter crime-related duties are no longer counted in Local Area Command numbers, rather they are counted under the respective strength of the two Commands and go towards the total number for Field Operations shown on the strength figures.

*2793 FAIRFIELD LOCAL AREA COMMAND—AUTHORISED AND ACTUAL STRENGTH—Mr Guy Zangari asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

What are the Authorised and Actual Strength figures for the Fairfield Local Area Command for August 2012?

Answer-

Information about police authorised and actual strength is available on the NSW Police Force website, www.police.nsw.gov.au

*2794 TOUGHER PENALTIES—Mr Guy Zangari asked the Minister for Transport representing the Minister for Roads and Ports—

Is the Minister planning to introduce tougher penalties, including loss of licence for motorists repeatedly caught using mobile phones while driving?

Answer-

I am advised:

The offence of using a mobile phone while driving attracts a minimum penalty notice fine of \$298 and 3 demerit points. The allocation of 3 demerit points is consistent with the nationally agreed position. NSW applies increased fines and demerit points for certain offences in an operating school zone and mobile phone offences are included.

Police may charge a driver rather than issue an infringement notice. On conviction in a court, fines of up to \$2,200 may be imposed. The court may take into account previous offences in determining the appropriate punishment.

There is also scope for police to charge a driver with a more serious offence under road transport law. For example, if a court determined that a driver's actions were reckless or posed a danger to the public, the driver could face a penalty of an automatic disqualification from driving for at least 3 years, a fine up to \$3,300, and imprisonment of up to 18 months for a first offence if convicted.

*2795 FAIRFIELD COMMUNITY SERVICE CENTRE—VACANCIES—Mr Guy Zangari asked the Minister for Family and Community Services, and Minister for Women—

How many vacancies are there in the Fairfield Community Service Centre office?

Answer—

There is no baseline number of funded positions or authorised staffing establishment against which to report vacancies.

Community Services continues to make permanent appointments in line with its budget and service delivery requirements

The project will be partly funded by Government and partly funded by tolls. The draft Long Term Transport Master Plan has an action to investigate a consistent distance-based tolling regime.

It is envisaged that the tolling strategy would be similar to that on the M7, with motorists charged according to the distance travelled, with a maximum charge in place.

Answer-

- *2805 AFTERMARKET EXHAUST PIPES—Ms Sonia Hornery asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
 - (1) Are aftermarket exhaust pipes legal on motorcycles and cars in NSW?
 - (2) How can Hunter Highway Patrol Officers, working in traffic, determine that an exhaust is illegal?

Answer-

The NSW Police Force has advised me:

- (1) The fitting of aftermarket exhaust pipes or systems is permitted in NSW providing the components comply with Schedule 2 of the Road Transport (Vehicle Registration) Regulation 2007 and the Protection of the Environment Operations (Noise Control) Regulation 2008.
- (2) Highway Patrol police rely on their expertise to detect vehicles fitted with illegal exhausts. Offensive noise emitted from illegal exhausts is easily detected and is often the trigger for further examination of the equipment by police.

If a defective exhaust is detected, police may issue a defect notice for its repair and/or certification by a licensed repairer, or an Environment Protection Authority (EPA) notice in cases where the driver is to take the motor vehicle to the EPA to be assessed. Infringements can also be issued to the offending driver for the modifications.

*2806 INFRASTRUCTURE FUNDING FOR THE HUNTER—Ms Sonia Hornery asked the Minister for Planning and Infrastructure, and Minister Assisting the Premier on Infrastructure NSW, Leader of the House—

Noting the Regional Development Australia Hunter chief executive has stated that "The Hunter risks missing out on a slice of more than \$5 billion in infrastructure funding if councils and planning authorities do not put aside territorial differences and take a 'big picture' approach" (Newcastle Herald 5 September 2012), what steps is the Government taking to ensure that planning authorities work with local and Federal governments to ensure that the Hunter receives its fair share of the \$5 billion worth of infrastructure funding?

Answer-

The NSW Government has formed a project control group to oversee infrastructure planning work in the

region. This group has the following agency representation:

- Hunter Development Corporation
- · Department of Planning and Infrastructure
- Transport for NSW
- RDA Hunter
- Department of Premier and Cabinet
- Infrastructure NSW
- Infrastructure Australia/Department of Industry and Transport
- Hunter Councils

With representation from a range of key agencies across three tiers of government, the work of this group will ensure NSW is in the best possible position to secure infrastructure funding. This work is on track to be complete within the timeframe set by the Commonwealth, that is, by the end of June 2013.

*2807 LITERACY AND NUMERACY PERFORMANCE—Ms Sonia Hornery asked the Minister for Education—

Which schools in the electorate of Wallsend are in the lowest quartile of literacy and numeracy performance in Year 3 NAPLAN?

Answer—

Measures of Literacy and Numeracy performance by schools in NSW are constructed from student results in the NAPLAN testing program. The NAPLAN test domains are reading, writing, spelling, grammar and punctuation and numeracy. There is no overall literacy result. In NSW the performance in NAPLAN reading is used as the indicator of literacy achievement.

The mean score for each of the test domains is subject to measurement and sampling error. Analysis of 2012 NAPLAN results indicates that one school in the Wallsend electorate, Cardiff North Public School, is placed in the lowest quartile for Year 3 numeracy. However, when considering the pattern of confidence intervals for this school's results, as published in My School, the result falls across the lowest and second lowest quartile range.

The Government is committed to providing services which will assist children, young people and their families recover from the harm caused by child sexual assault. A wide range of counselling and support services are provided by NSW Health across the state to support child victims of sexual assault.

*2811 REPLACEMENT OF CEDAR COTTAGE PROGRAMS—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

- (1) What programs will be introduced to replace the Cedar Cottage programs?
- (2) When will such programs be introduced?

The Regulations which govern the referral and assessment for the two-year diversion program known as Cedar Cottage, do not apply in respect of people charged after 1 September 2012.

The Government is committed to bringing sexual assault offenders to justice and providing a range of programs for sex offenders to address offending behaviours and prevent re-offending. For adult offenders, Corrective Services NSW has a range of programs to treat sex offenders, including the Custody-Based Intensive Treatment (CUBIT) program.

However, the Government does not plan to introduce a specific alternative program to replace Cedar Cottage.

Answer-

I am advised:

(1) The NSW Centre for Road Safety records data about traffic crashes which conform to the national guidelines. A crash is included based on the following criteria:

- The crash was reported to the police;
- The crash occurred on a road open to the public;

- The crash involved at least one moving vehicle;
- The crash involved at least one person being killed or injured, or at least one motor vehicle being towed away.

This enables a focus on major crashes resulting in casualties or motor vehicles being towed.

Roads and Maritime Services staff have direct access to traffic crash data and reporting systems.

(2) The NSW Centre for Road Safety does, however, routinely provides crash data to government insurance agencies such as the Motor Accidents Authority and WorkCover.

(3) Crash data is used in evidence-based nominations of locations for treatment under Black Spot Programs.

(4) Crash data is available on request to the NSW Centre for Road Safety.

(5) A simplistic listing of locations in line with the total number of crashes does not support the safe system approach to road safety. This simply documents locations with a high number of crashes, rather than targeting crash severity or particular causes of crashes.

Blackspot programs are based on economic analysis and benefits to costs assessment and are further prioritised by the number of certain types of crashes and fatalities or casualties at the location. Local Area Commands regularly undertake high visibility policing operations which target criminal and anti-social behaviour and may include a focus on stealing from retail stores, where intelligence suggests this type of crime is occurring.

The Sex Crimes Squad and the Child Abuse Squad of the NSW Police Force were established to ensure the provision of a specialist adult and child sexual assault service to support Local Area Commands across NSW.
