 - (1) What is the total cost of the recently announced upgrade of the Blacktown and Mount Druitt Hospitals?
 - (2) (a) How much of this money is being spent at the Mount Druitt Hospital?
 - (b) How is this money being spent at the hospital?
 - (3) (a) Is any of the money mentioned in questions (1) and (2) above made up with any funds from the Federal Government?
 - (a) If so, how much money from the Federal Government is involved and for what is it being spent?

Answer-

I am advised:

(1) to (3) Blacktown Mount Druitt Hospital (BMDH) functions as one hospital on two campuses (Blacktown campus and Mount Druitt campus). The BMDH Stage 1 expansion project has a total capital value of \$324 million.

At Mount Druitt campus the project will deliver:

- 10 additional rehabilitation beds:
- extra emergency department capacity with the establishment of a new urgent care centre;
- eight extra dental chairs in an expanded dental facility; and
- expanded support services including the Central Sterilising Services Department and imaging.

The \$324 million project is funded by the NSW Government (\$296 million) with an additional \$28 million Commonwealth (COAG) funding provided to create a sub-acute capacity in mental health and rehabilitation.

*2964 GLENDALE TRANSPORT INTERCHANGE—Mr Robert Furolo asked the Minister for Transport representing the Minister for Roads and Ports—

In relation to the Glendale Transport Interchange:

- (1) What funds have been allocated to the Pennant Street Bridge?
- (2) When is construction of the Pennant Street Bridge due to start?

Answer-

I am advised:

- (1) \$15 million towards the construction of a road bridge and associated roads at Glendale has been allocated to Lake Macquarie Council. Lake Macquarie Council has also secured \$7 million.
- (2) In addition to the NSW Government commitment of \$15 million, Lake Macquarie City Council was to contribute \$10 million to the project and seek a further \$25 million from the Federal Government.

Lake Macquarie City Council has now called for tenders for the detailed design of the project, with the tenders closing on 4 December 2012 and appointment anticipated in March 2013.

Lake Macquarie City Council will commence initial demolition work in February 2013, and detention works in May 2013.

It is anticipated that stage one construction will commence in mid-2014 and end mid-2015.

*2965 LEMON TREE PASSAGE ROAD—Mr Robert Furolo asked the Minister for Transport representing the Minister for Roads and Ports—

- (1) \$5 million has been allocated to Port Stephens Council over four years for the upgrading of Lemon Tree Passage Road, commencing in 2011-12.
- (2) The construction of the Pennant Street Bridge is being managed by the Lake Macquarie City Council.
- *2966 CARDIFF CBD ROADS—Mr Robert Furolo asked the Minister for Transport representing the Minister for Roads and Ports—

In relation to roads in the Cardiff CBD:

- (1) What funds have been allocated to the upgrade of Ocean Street?
- (2) When are works due to start for Ocean Street?
- (3) What funds have been allocated to the upgrade of Dudley Street?
- (4) When are works due to start for Dudley Street?
- (5) What funds have been allocated to upgrade the intersection on Crockett Street, Cardiff South?
- (6) When are works due to start for the intersection at Crockett Street, Cardiff South?

Answer-

I am advised:

- (1) and (2) A \$200,000 allocation was made in 2011-12 to Lake Macquarie City Council for work on Ocean Street, Dudley. Work was completed in November 2011.
- (3) and (4) No further funds have been allocated for work on Dudley Road at this stage.
- (5) and (6) \$800,000 was allocated in the 2011-12 State Traffic Management Program. The work commenced in May 2012 and was completed in July 2012. \$747,000 was spent in 2011-2012 and \$8,000 was spent finalising the works in 2012-13. The work involved widening of Crockett Street to separate left and right turning motorists, and a slip and acceleration lane on Hillsborough Road for motorists who turn left from Crockett Street.

- (2) Work on Bondi Road includes asphalt resurfacing and kerb and gutter repair work.
- (3) and (4) All work on Bondi Road is now complete, with the exception of one area between Ben Eden Street and Waverley Crescent which is planned for completion by late November or early December 2012.

- (1) Have flashing lights been installed at Kensington Public School?
- (2) If not what funds have been allocated in the 2012-2013 budget to install flashing lights at Kensington Public School?

Answer-

I am advised:

- (1) and (2) Flashing lights were installed at Kensington Public School in May 2011.
- *2970 WYONG ROAD GOSFORD—Mr Robert Furolo asked the Minister for Transport representing the Minister for Roads and Ports—

In relation to Wyong Road Gosford:

- (1) What funds have been allocated to upgrade Wyong Road?
- (2) When are works due to start on the upgrade of Wyong Road?
- (3) When is the upgrade of Wyong Road due to be completed?

Answer—

I am advised:

- (1) There are several projects on Wyong Road at the moment:
 - (a) F3 Freeway/Wyong Road interchange upgrade \$12 million allocated in 2012-13.
 - In 2011, the NSW Government committed \$8 million over four years to improve the performance during morning and afternoon peak periods of the following intersections on Wyong Road:
 - (b) Wyong Road/Pacific Highway at Tuggerah \$3 million allocated in 2012-13 for planning.
 - (c) Wyong Road intersections with Chittaway Road/Enterprise Drive, Tumbi Creek Road/Mingara Drive and Tumbi Road \$600,000 allocated in 2012-13 for planning.
- (2) Work is due to start as follows:
 - (a) The construction of the F3 Freeway/Wyong Road upgrade is currently underway.
 - (b) Wyong Road/Pacific Highway at Tuggerah is currently in concept design with environmental impact assessment due for completion in early 2013. Detailed design and land acquisition will follow in 2013-14 before construction can start.

- (c) Wyong Road intersections with Chittaway Road/Enterprise Drive, Tumbi Creek Road/Mingara Drive and Tumbi Road are currently in strategic design. Timing of construction has not yet been determined
- (3) The F3 Freeway/Wyong Road upgrade which is currently under construction is expected to be open to traffic in early 2013, weather permitting.
 - It is too early in the development phase to provide a timeframe for construction completion of the remaining intersections.

 - (1) (a) Has the Minister responded to the General Manager of Newcastle City Council who requested funding to upgrade transport stops in the Newcastle Local Government Area to meet the disability standards for accessible public transport?
 - (2) (b) If not, when will the Minister discuss his request?
 - (3) Why is Newcastle City Council not eligible to apply for assistance under the Country Passenger Transport Infrastructure Grants Scheme?

Answer-

I am advised:

- (1) and (2) Yes.
- (3) The Country Passenger Transport Infrastructure Grants Scheme (CPTIGS) awards grants to improve passenger transport infrastructure in rural, regional and remote communities of NSW.

To be eligible for CPTIGS funding, proposed projects must be located outside the Greater Sydney, Newcastle and Wollongong metropolitan regions.

*2974 ADAMSTOWN RAILWAY GATES—Ms Sonia Hornery asked the Minister for Transport—

Will the Minister remove the Adamstown railway gates, now that the transport department's own draft master plan listed the removal of the level crossing as an "immediate short-term project?

Answer—

It is regrettable that the issue of the Adamstown railways gates was left unresolved by the previous Government.

Transport for NSW will consider and assess measures to improve traffic management solutions at Adamstown.

Transport for NSW will also investigate the feasibility of grade separated options for the Adamstown Level Crossing.

- 2975 GLENDALE TRANSPORT INTERCHANGE—Ms Sonia Hornery to ask the Minister for Transport—
- *2976 GOULBURN POLICY ACADEMY SEPTEMBER CLASS—Ms Sonia Hornery asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
 - (1) Why was the September class at Goulburn Police Academy cancelled when there have been more than 100 armed robberies in the Hunter and at least 104 shootings in Sydney this year alone?
 - (2) Is the Minister responding to these significant increases in crime?
 - (3) Will the Minister increase police numbers in the Hunter and across NSW?

Answer-

I am advised:

New Probationary Constables are deployed in May, August and December each year to replace and add to existing police numbers. No graduating classes have been cancelled. Since the May 2011 attestation a total of 119 probationary constables have been deployed to the Hunter region.

The NSW Government will boost the authorised strength of the NSW Police Force by a total of 859 police officers. The Government has already delivered 210 of these officers since December last year. This significant commitment will see the authorised strength of the Police Force reach a record 16,665 officers in August 2015.

Operation Blade was established to review all armed robberies in the Hunter, identify links between incidents and identify common offenders. Local Area Commands in the area organised joint strike forces

to manage investigations and target offenders. A number of joint operations have also been established, some of which have led to significant arrests.
