#### (Paper No. 88)

\*2106 ROOTY HILL RAILWAY STATION—EASY ACCESS FACILITIES—Mr Richard Amery asked the Minister for Transport—

- (1) When will the Rooty Hill Railway Station be provided with easy access facilities to assist the elderly, disabled and mothers with prams who use this station and currently need to climb stairs?
- (2) Where does this station stand on the list of stations to gain such facilities?

Answer—

(1) and (2) On 30 April 2012 the Government announced a new Transport Access Program which will deliver accessible, modern, secure and integrated transport infrastructure. This includes station upgrades, better interchanges, ferry wharf upgrades and commuter car parks.

Over \$100 million has been allocated to the first round of the Transport Access Program, which will see improvements at over 35 locations over coming months.

More planning and design work will now occur to see which projects will come next. This will be based on criteria including patronage, the needs and demographics of customers who use the location, whether important services such as hospitals or educational facilities are nearby, and the accessibility of other nearby transport interchanges and facilities.

Rooty Hill is being considered as part of that process.

\*2110 PLAN-IT YOUTH PROGRAM-Ms Sonia Hornery asked the Minister for Education-

\*2112 DENTAL HEALTH-Ms Clover Moore asked the Minister for Health, and Minister for Medical Research-

Noting that poor oral health is a major factor in many diseases, costs about \$5.3 billion each year, some people cannot afford dental treatment and there are 120,000 on public dental waiting lists in NSW:

- (1) (a) How many electorate of Sydney residents are on public dental health waiting lists?
  - (b) What delays can they expect before getting treatment?
- (2) Are more people on public dental waiting lists than on public hospital waiting lists?
- (3) Does NSW have the lowest dental funding per capita of all States and Territories?
- (4) Was there a real decrease in funds for oral health in 2011-12?
- (5) Do fewer than 16 per cent of registered dentists work in the public sector and are there high vacancy rates in these services?
- (6) Do the States and Territories have overall funding responsibility for public dental services under National Health Reform Agreements?
- (7) What action has the Government taken to:
  - (a) implement the NSW Oral Health Strategic Directions Plan 2011-20;
  - (b) increase funds for the Oral Health Fee for Service Scheme;
  - (c) fund public dental outreach services in rural and remote areas;
  - (d) provide additional funds for the Voluntary Dental Intern Program;
  - (e) employ oral health promotion officers in each Local Health District;
  - (f) improve capital infrastructure for public dental services;
  - (g) improve oral health research and data collection?
- (8) What action has the Government taken in response to proposals from the NSW Oral Health

Alliance?

(9) What further action does the Government plan to increase access to dental treatment, expand the dental workforce, and improve dental health?

Answer—

I am advised:

- (1) (a) and (b) Waitlist data for public oral health care is not collected on the basis of electorates.
- (2) Yes. The current ambulatory dental treatment waiting list is 116,200 persons, as at 31 March 2012, a 25% overall reduction since June 2008.
- (3) The funding of oral health services in Australia is a complex mix of personal out-of-pocket expenditure by individual's private health insurance benefits and rebates and programs publicly funded by both the Commonwealth Government and the State Government. State funding differentials are often used to simplistically compare State government commitments to public dental services. The role of the Australian Government funding and differences between State dental service delivery models and economies of scale are not factored into these differentials.

The 2007 Australian Institute of Health & Welfare's National Survey of Adult Oral Health 2004 – 2006 and the NSW Health Child Dental Health Survey 2007 show that the state of oral health of children and adults in NSW is equal if not better than other jurisdictions, including Queensland.

NSW has invested in upstream prevention of dental diseases through water fluoridation, oral health promotion and working collaboratively with the dental professions and community organizations to promote oral health.

- (4) NSW Government funding for Public Oral Health Services increased from \$169.4 million in 2010-11 to \$173.7 million dollars in 2011-2012, an increase of 2.54%.
- (5) Yes. Vacancy rates vary between Local Health Districts.
- (6) The Chronic Disease Dental Scheme, the Teen Dental Plan and the recent Federal Budget demonstrate that the Commonwealth Government accepts a role in funding dental services.
- (7) to (9) The Ministry of Health is currently finalising the NSW Dental Health Action Plan taking into consideration the advice of the NSW Taskforce, the National Advisory Council on Dental Health report and the recently announced Federal Budget initiatives.
- \*2116 HOUSING NSW APPEALS—Ms Clover Moore asked the Minister for Family and Community Services, and Minister for Women—

Noting that the Housing NSW Appeals Committee reports that inadequate consideration of information, evidence, policy or options is responsible for nearly 80 per cent of their recommendations for change of decision:

- (1) How many internal appeal requests did Housing NSW receive for the Inner City Area, CS1 Allocation Zone in the last 12 months?
- (2) What proportion of these internal appeals resulted in a change of decision?
- (3) What is the expected timeframe for internal appeals to be processed, and what is the current backlog of appeals?
- (4) What action has been taken to reduce the appeals backlog in the inner city?
- (5) How does Housing NSW train and support officers to ensure that they obtain appropriate information and correctly apply Housing NSW policy?
- (6) What action has Housing NSW taken to prevent the need for internal appeals?
- (7) What impact has the introduction of Housing Pathways had on requests for appeals?
- (8) Will Housing NSW employ more Client Service Officers to ensure adequate time and attention can be given to applications in order to reduce the number of appeals?

Answer-

(1) to (8) Housing NSW received less than two internal appeals per week for the Inner City allocation zone in the last 12 months and over 50% resulted in a decision being changed. Internal appeals are generally completed within 20 days depending on the complexity.

Clients are regularly advised of the appropriate supporting material that is required to enable their eligibility for various forms of housing assistance to be assessed. Initial decisions around housing assistance are often changed on appeal when clients later provide additional information.

Housing NSW employs various workplace learning methods for existing client service staff in order to maintain their skills. New staff also attend an Induction Program. In addition, all staff have access to policies and procedures which are regularly reviewed.

Given the small number of appeals in the inner city allocation zone there has been little impact following the introduction of Housing Pathways.

\*2117 NIGHT DEVELOPMENT WORK—Ms Clover Moore asked the Minister for Transport representing the Minister for Roads and Ports—

With regard to road work by the Roads and Maritime Services (RMS) or projects by other State agencies such as Ausgrid and private developers, which the RMS requires be done at night to prevent impact on traffic flow during the day:

- (1) How does the RMS determine whether road work must be done at night?
- (2) To what extent does the impact of noise from night work on local residents form part of that determination?
- (3) For RMS road work, what notification of local residents does the RMS do before night road work takes place?
- (4) For work by other State agencies and private developers, what notification does the RMS require?

Answer—

I am advised:

(1) Roads and Maritime Services' (RMS) first preference is for work to be undertaken, whenever possible, during normal working hours. However, decisions as to whether road work is able to be undertaken during the day are determined by a combination of factors. These include:

- Worker and driver safety.
- Impact of work on traffic network.
- Restrictions from other organisations, such as public utilities, for connections to utility services.
- Conditions of approval requirements or restrictions.

(2) If it is decided to undertake road work at night, other requirements come into place such as using reasonable and feasible measures to reduce the impact of construction noise. These measures may include:

- · Modifying work programs and using new, less noisy technology.
- Letting neighbours know when noisy work will occur.
- Installing temporary structures, e.g. noise barriers or temporary acoustic modifications to homes.
- Scheduling respite periods during extended noisy activity.
- Temporary relocation of residents may be considered as an option for major road projects where substantial night-time noise impacts are present for extended periods of time.

Although noise reduction measures are implemented, intrusive noise is often unavoidable during construction work.

(3) RMS policy is to notify local residents of night work at least seven days before the work occurs. Generally this would involve the distribution of written notifications. These may be supplemented by media advertising and roadside signage such as use of Variable Message Signs.

(4) Notification requirements are determined by the relevant approval conditions associated with the work and the community notification policies of the organisation undertaking the night work.

\*2118 PEDESTRIAN-RELATED ACCIDENTS—Mr Ryan Park asked the Minister for Transport representing the Minister for Roads and Ports—

Given the number of road accidents involving pedestrians recently, what plans does the Minister have to reduce the number of pedestrian-related accidents in NSW, such as education and awareness campaigns?

Answer-

Since the start of the year, there has been an increase in pedestrian fatalities, with 25 pedestrians killed in NSW as at midnight, 17 May 2012, which is 12 more than the same period last year.

Whilst these numbers are the result of tragic accidents, there aren't any specific trends underlying these crashes. However, initial findings show that nine of these fatalities were aged under 25 and eight of these were aged over 70. It is a reminder to drivers to remain vigilant, look out for pedestrians and slow down in areas where pedestrians are about.

The Government has a range of programs in place to address the safety of pedestrians, with programs addressing vehicle speeds shown to be effective at reducing pedestrian casualties. This includes programs such as:

- 40 km/h high pedestrian activity zones
- School zone flashing lights
- Pedestrian fencing
- Upgrading of pedestrian facilities across the State's network
- Safety cameras at high risk intersections.
- A comprehensive package of road safety education resources for children, teenagers and their parents and carers
- School road safety education program
- Early childhood road safety program
- Messaging around driveway safety
- Older pedestrian campaign program and workshops conducted within the community by Local Government

I can advise that the Government is investigating a new "share the roads" campaign to improve the interaction between pedestrians and other road users.

It is anticipated that this campaign will look to create a level of respect between road users, including pedestrians, drivers, bicycle riders and motorcycle riders.

Further, the Pedestrian Council of Australia has recently launched a new campaign titled "Don't tune out - stop, look listen and think", targeting pedestrians across Sydney. This campaign is highlighting the need for pedestrians to be aware of traffic when listening to portable music devices in the road environment.

- \*2122 RADIOACTIVE WASTE FACILITIES—Mrs Barbara Perry asked the Minister for the Environment, and Minister for Heritage—
  - (1) Is the Lidcombe Office of Environment and Heritage (OEH) the only facility licensed to take hazardous radioactive waste left from the cleanup of the former uranium smelter site at Hunters Hill?
  - (2) Are any other facilities around NSW licensed to take any hazardous radioactive waste from the Hunters Hill site?

Answer—

There are a number of facilities in NSW licensed under the Radiation Control Act, including universities or hospital stores, that are able to store radioactive materials.

- (1) A manual count of peak hour vehicle movements was undertaken on 29 February 2012 and 1 March 2012 at the Allandale Road and Jurd Street intersection. In the morning peak hour on Allandale Road there were 632 northbound vehicles and 587 southbound vehicles, while on Jurd Street there were 103 eastbound vehicles and 85 westbound vehicles. In the afternoon peak hour on Allandale Road there were 437 northbound vehicles and 907 southbound vehicles, while on Jurd Street there were 76 eastbound vehicles and 56 westbound vehicles.
- (2) A manual count of the peak hour vehicle movements was undertaken on 26 and 27 July 2011 at the Allandale Road and McGrane Street intersection. In the morning peak hour on Allandale Road there were 587 northbound vehicles and 491 southbound vehicles, while on McGrane Street there were 96 eastbound vehicles and 56 westbound vehicles. In the afternoon peak on Allandale Road there were 466 northbound vehicles and 837 southbound vehicles, while on McGrane Street there were 100 eastbound vehicles and 38 westbound vehicles.
- (3) A manual count of the peak hour vehicle movements was undertaken on 26 and 27 July 2011 at the Allandale Road and Ferguson Street intersection. In the morning peak hour on Allandale Road there were 613 northbound vehicles and 543 southbound vehicles, while on Ferguson Street there were 207 westbound vehicles. In the afternoon peak on Allandale Road there were 674 northbound vehicles and 801 southbound vehicles, while on Ferguson Street there were 170 westbound vehicles.
- (4) Roads and Maritime Services (RMS) has no recent traffic count information relating to Sperry Street, Cessnock.
- (5) Under the RMS Traffic Program, intersection upgrades are considered for funding on the basis of delay to motorists and the cost effectiveness of improvements. The amount of delay at the above intersections is low relative to current priorities. Under the Road Safety Program, intersections are considered on a road safety cost-benefit basis.
- (6) RMS is currently arranging for the relocation of the two marked foot crossings on Allandale Road near Jurd Street and McGrane Street. The crossings will be moved 40 metres away from each intersection so that they are on two way, two lane road. This will reduce the risk of vehicles passing stopped vehicles at the crossings.

RMS is investigating traffic flows in the area. Any further proposals will need to compete with other worthwhile projects across the State for future funding.

The budget allocation for the Spectacles Program was overspent consistently and unsustainably under the previous Government.
