- *4962 AVAILABILITY OF THE NEW STREET PROGRAM—Mr Paul Lynch asked the Minister for Health, and Minister for Medical Research—
 - (1) In what parts of New South Wales is the New Street Program available?
 - (2) In what parts of New South Wales is the New Street Program unavailable?

Answer-

Four New Street services are currently delivered across six sites around New South Wales.

- *4963 INFRASTRUCTURE IN THE HUNTER REGION—Ms Sonia Hornery asked the Treasurer, and Minister for Industrial Relations—
 - (1) Are the Government's budget cost overruns on Sydney infrastructure projects impacting on the rollout of capital investment in infrastructure in the Hunter region?
 - (a) If so, what is the Government's strategy to address the cost overruns to ensure that capital investments in Wallsend electorate infrastructure are not delayed from commencement?

Answer-

Currently approved and budgeted Hunter projects will proceed based on their own individual funding arrangements.

*4964 LAKE MACQUARIE TRANSPORT INTERCHANGE—Ms Sonia Hornery asked the Minister for Roads, Maritime and Freight—

Considering a Morrison Low consultant's report found that the Pennant Street and Munibung Road works section of the Lake Macquarie Transport Interchange will generate net benefits of more than \$98 million, will the Government now fully fund and commit to a schedule for the works' completion?

Answer—

I refer to my previous response LA 4694.

- *4965 BERESFIELD POLICE STATION—Ms Sonia Hornery asked the Minister for Police, and Minister for Emergency Services—
 - (1) How many hours per day are police officers located at the Beresfield Police Station?
 - (2) How many hours per day are residents able to have face to face contact with officers at Beresfield Police Station?

Answer-

Beresfield police station is staffed subject to operational considerations. The Suburb of Beresfield is also serviced by Maitland police station, as are other suburbs in the area.

Local Area Commands (LACs) are required to maintain a First Response Policing Agreement which ensures that, at a minimum, there is always a certain number of police rostered on to meet expected demand.

- *4966 2016 OUT OF ZONE SCHOOL APPLICATIONS—Ms Sonia Hornery asked the Minister for Education—
 - (1) How many out of zone applications were made in 2016 for placements in 2017 at each of the following schools:
 - (a) Waratah West Public School;
 - (b) Plattsburg Public School;
 - (c) Waratah High School;
 - (d) Shortland Public School?

Answer—

I'm advised that all schools are required to follow the Department of Education's enrolment policy. Every eligible student who wishes to attend a New South Wales public school will be given a place at their local school. Where non-local enrolment is possible and places exceed availability, a placement panel is formed. The placement panel considers non-local enrolment applications in line with the department's policy.

*4967 SYDNEY WATER PARTNERSHIP SERVICING—Mr Chris Minns asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—

Please detail by line item the \$572,895 spent on "Partnership Servicing" outlined on page 64 of the Sydney Water Annual Report 2015-16?

Answer-

In 2015-16, Sydney Water dispensed over 60,000 litres of water at events - the equivalent of 100,000 (600ml) plastic bottles of avoided plastic waste. This also equates to a saving to our customers of \$220,000 by choosing tap water rather than bottled water. A detailed list of our partnerships are included below:

*4968 PLANNED WASTEWATER MAIN RENEWAL OR REHABILITATION—Mr Chris Minns asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—

How many kilometres of planned wastewater main renewal or rehabilitation were not completed in 2015-16 (ref p70 Sydney Water Annual Report 2015-16)?

Answer—

3.5 kilometres of planned wastewater main renewal or rehabilitation were not completed in 2015-16.

The question considers 2015-16, however these renewal and rehabilitation programs were managed to IPART's four-year price period 2012-16.

For the four-year price period 2012-16, we planned to deliver 100 kilometres of renewals or rehabilitation. We actually delivered a total of 107.9 kilometres.

*4969 SYDNEY WATER ANNUAL REPORT—Mr Chris Minns asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—

What was meant by "more income from service charges" mentioned on page 124 of the Sydney Water Annual Report 2015-16?

Answer-

Sydney Water levies fixed service charges to customers for connections to its water and wastewater systems and other systems it manages. Total service charges in 2015-16 were \$1,422 million (including social program grants), which was \$9 million higher than target, due mostly to a price escalation which is determined by the Independent Pricing and Regulatory Tribunal.

*4970 SYDNEY WATER HIGHER ASSET CHARGES—Mr Chris Minns asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—

What were the higher asset charges of \$23 million mentioned on page 28 of the Sydney Water Annual Report 2015-16?

Sydney Water incurs asset charges on water and wastewater infrastructure assets in the form of depreciation, impairments and net losses from disposals. Total asset charges in 2015-16 were \$276

*4971 PAYROLL TAX REBATE SCHEME—Mr Paul Scully asked the Minister for Finance, Services and Property—

million, which was \$23 million higher than in 2014-15 due to increased depreciation.

- *4972 CHANGE TO PENALTY RATES—Mr Paul Scully asked the Treasurer, and Minister for Industrial Relations—
 - (1) Has the Treasury undertaken any analysis on the impact of the recent decision of the Fair Work Commission to change penalty rates for weekend work in the retail, pharmacy and café industries?
 - (a) If not, why not?
 - (b) If so, what was the expected impact on:
 - (i) Employment;

- (ii) Hours worked per employee;
- (iii) Gross state product?
- (2) Will the Government make a submission to the Fair Work Commission in relation to transitional arrangements to the reduction in Sunday penalty rates by Friday, 24 March 2017?
 - (a) If not, why not?

Answer-

- (1) NSW Treasury conducts analysis of the wide range of factors affecting employment and GSP in NSW on an ongoing basis. This analysis is reflected in the budget and economic forecasts regularly published by NSW Treasury.
- (2) All submissions are available online at https://www.fwc.gov.au/. The Government is confident that the Fair Work Commission will take into account all relevant information when considering transitional arrangements.
- *4973 SMALL BUSINESS EMPLOYMENT INCENTIVE SCHEME—Mr Paul Scully asked the Deputy Premier, Minister for Regional New South Wales, Minister for Skills, and Minister for Small Business—
 - (1) How many small businesses in the Wollongong electorate have received a grant under the Small Business Employment Incentive Scheme in each of the 2015-16 and 2016-17 financial years (to 7 March 2017)?
 - (2) What was the average grant received by small businesses in the Wollongong electorate under the Small Business Employment Incentive Scheme in each of the 2015-16 and 2016-17 financial years (to 7 March 2017)?
 - (3) What was the average grant paid to small businesses in New South Wales under the Small Business Employment Incentive Scheme in each of the 2015-16 and 2016-17 financial years (to 7 March 2017)?

Answer—

This Question needs to be referred to the Minister for Finance, Services and Property, the Hon Victor Dominello MP, as the Minister with responsibility for administering this program.

- *4974 MOBILE PHONE REGULATION—Mr Jamie Parker asked the Minister for Innovation and Better Regulation—
 - (1) What action is being taken in New South Wales to close the mobile phone regulation loophole whereby the owner of a mobile service is not consulted or advised when a switch of provider is made, and only becomes aware of the switch after the phone service is disconnected?
 - (2) How many members of the public have reported identity theft via theft of their mobile phone bills in the last 12 months in New South Wales (to 7 March 2017)?
 - (3) What action is being taken to implement a change in the legislation to require secondary proof of identity and a built-in delay before any switch is implemented to protect New South Wales mobile phone customers against identity theft and fraud?

- (1) Regulation of the telecommunications industry in New South Wales and Australia is the responsibility of the Commonwealth Government, and is administered by the Department of Communications and the Arts, with the portfolio Minister being the Minister for Communications, Senator the Hon Mitch Fifield. The NSW Government has no power to change Commonwealth legislation or close regulatory loopholes outside of its jurisdiction. - (2) Identity theft lies outside of my portfolio responsibilities and is a criminal matter.
- (3) The policy framework setting out the obligations of mobile service providers can be found in the following Commonwealth legislation: telecommunications Act 1997, the Telecommunications (Consumer Protection and Service Standards) Act 1999, and the Telecommunications (Interception and Access) Act 1979. As this legislation is administered by the Commonwealth, I advise persons interested in the matter to get in contact with the Department of Communication and the Arts or the Minister for Communications.
- *4975 ROOKWOOD GENERAL CEMETERY TRUST—Mr Ryan Park asked the Minister for Lands and Forestry, and Minister for Racing—

- (1) Have you engaged an Administrator to investigate the governance at the Rookwood General Cemetery Trust?
 - (a) If so, has the Administrator engaged a legal firm to deal with a dispute with the General Manager?
 - (i) If so, how much has been paid to date (to 6 March 2017) to this firm?
 - (ii) Are you aware or not if this particular law firm uses a computer program to determine how much funds it needs to receive before settling the case?
 - (b) When do you expect this dispute to be settled?

Answer-

- (1) In 2016 an Administrator was appointed to manage the affairs of the Rookwood General Cemeteries Reserve Trust, following an independent investigation into governance and operational concerns raised by community stakeholders and trust board members.
 - (a) The Rookwood General Cemeteries Reserve Trust has engaged an independent firm to deal with a dispute with the former Chief Executive Officer.
 - (i) The amount paid by the Trust to the firm to March 2017 is \$207,000.
 - (ii) I am not aware if the firm involved uses such a system.
 - (iii) The Government is not a party to the dispute. This is a matter for the parties involved.
- *4976 CHARLESTOWN NORTHERN CONTROL CENTRE—Ms Jodie Harrison asked the Minister for Police, and Minister for Emergency Services—
 - (1) When was the most recent assessment of required full time equivalent employment numbers at Charlestown Northern Control Centre conducted?
 - (a) What were the results of this assessment?
 - (b) Were any changes made to staffing numbers and arrangements in response to the results?

Answer—

Charlestown Northern Control Centre is a NSW Ambulance facility. The question should be addressed to the Minister for Health.

- *4977 ROZELLE GOODS YARDS—Mr Jamie Parker asked the Minister for Transport and Infrastructure—
 - (1) Has Railcorp yet surrendered to Roads and Maritime Services (RMS) its state-held lease covering the Rozelle Goods Yards, which features a two-track rail corridor linking the old Goods Line (now the Inner West Light Rail) to White Bay?
 - (2) If RMS obtains this lease, will it have the right under current legislation to remove all existing rail infrastructure without further government scrutiny as it has stated it intends to do?
 - (a) Will this removal go ahead before the relevant stage of the WestConnex tollway has been approved?
 - (i) If so, what effect will this have on the cost and time frame of bringing a high-capacity surface rail corridor into a redeveloped Bays Precinct in the future?
 - (3) What is the most accurate timeframe for light rail delivery to The Bays Precinct otherwise?
 - (4) When will a plan for the West Metro station be provided for the community to read?
 - (5) When will the Glebe Island Bridge be re-opened to local active transport?

Answer-

(1) and (2) There is no lease covering Rozelle Rail Yards. RailCorp only owns a very small portion of land in this area and has been directed to transfer ownership of part of that land to Roads and Maritime Services

Operational infrastructure currently located on RailCorp's land is being protected and will possibly be relocated.

- (3) The Government is investigating a range of transport options to support the Bays Precinct, including delivery timeframes for transport investment that would complement Sydney Metro West in servicing the Bays Precinct.
- (4) The Government will work with the community and industry to deliver Sydney Metro West, including a new railway station servicing the Bays Precinct.
- (5) I refer you to my previous response, LA 4919.

- *4978 PROPOSED MALDON-DOMBARTON RAIL LINE—Mr Paul Scully asked the Minister for Roads, Maritime and Freight—
 - (1) In the Illawarra Mercury on 2 March 2017 you note that "The proposed Maldon-Dombarton rail line isn't a high priority, as existing capacity is adequate to support passenger and freight demand on the Illawarra network."
 - (a) On what basis were priorities ranked?
 - (b) How long is existing capacity of the Illawarra network expected to remain "adequate"?
 - (2) Will the Government release the evaluation report from the Register of Interests process conducted by Transport for NSW which commenced on 13 October 2014?
 - (a) If not, why not?

Answer—

(1) A number of initiatives to increase freight volumes to and from Port Kembla are already planned or underway.

In February 2017, Infrastructure Australia concluded a review of the Maldon to Dombarton business case noting that the project costs currently outweigh the economic benefits.

(2) This report contains commercial-in-confidence information and cannot be released.

Answer—

I'm advised that all schools are required to follow the Department of Education's enrolment policy. Every eligible student who wishes to attend a NSW government school will be given a place at their local school. The department does not have fixed enrolment capacities at NSW government schools. Schools have the capacity to adapt to fluctuating enrolments through the use of a combination of temporary and permanent teaching spaces. Where non-local enrolment is possible and places exceed availability, a placement panel is formed. The placement panel considers non-local enrolment applications in line with the department's policy

- *4980 JOBS OF TOMORROW SCHOLARSHIP SCHEME—Mr Paul Scully asked the Deputy Premier, Minister for Regional New South Wales, Minister for Skills, and Minister for Small Business—
 - (1) How many scholarships have been provided under the Jobs of Tomorrow scholarship scheme since 1 January 2016 (to 7 March 2017)?
 - (2) How many applications have been received for scholarships under the Jobs of Tomorrow scholarship scheme since 1 January 2016 (to 7 March 2017)?
 - (3) How many scholarships have been provided to residents of the Wollongong electorate under the Jobs of Tomorrow scholarship scheme since 1 January 2016 (to 7 March 2017)?
 - (4) How many applications have been received from residents of the Wollongong electorate for scholarships under the Jobs of Tomorrow scholarship scheme since 1 January 2016 (to 7 March 2017)?

- (1) and (2) As at 7 March 2017, a total of 1,680 applications for Jobs of Tomorrow scholarships have been submitted by students. Of these 1 ,611 students were eligible and approved for a scholarship.
- (3) and (4) For residents living in the Wollongong electorate, 35 applications were submitted. A total of

34 were eligible and approved for a scholarship.

 - (1) How many applications for new public housing placements in the Wallsend electorate were outstanding as at:
 - (a) 1 July 2015?
 - (b) 1 July 2016?

*4984 REMOTE WITNESS FACILITIES AND AUDIO VISUAL LINKS—Mr Paul Lynch asked the Attorney General—

When will you expand remote witness facilities and audio visual links in courts to ensure that high quality facilities are available to victims and other witnesses across the State?

Answer—

The Audio Visual Link Consolidation Project continues to expand access for victims and other witnesses to remote witness and courtroom facilities.

*4985 INTELLECTUAL DISABILITY RIGHTS SERVICES FUNDING—Mr Paul Lynch asked the Minister for Family and Community Services, Minister for Social Housing, and Minister for the Prevention of Domestic Violence and Sexual Assault—

What funding will you provide to the Intellectual Disability Rights Services after 1 July 2017?

Answer-

I am advised that Intellectual Disability Rights Services (IDRS) is funded in accordance with the Disability Inclusion Act 2014 (NSW) and Regulation. Therefore this matter should be referred to the Minister for Multiculturalism and Minister for Disability Services.

- *4986 TABLING OF A REPORT—Mr Paul Lynch asked the Attorney General—
 - (1) Has the recently tabled report entitled 'Report on the Operation of the Government Information (Public Access) Act 2009: 2015 -2016' dated February 2017 been placed on the Information and Privacy Commission website?
 - (a) If not, why not?

Answer-

Yes.

*4988 SYDNEY WATER INCREASED SYSTEM ASSET VALUES—Mr Chris Minns asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—

What is meant by increased system asset values mentioned on page 29 of the Sydney Water Annual Report 2015-16?

Answer—

System assets are infrastructure that deliver water, wastewater and stormwater services to customers through an integrated network of various assets.

Total system assets increased from \$14,543 million as at 30 June 2015, to \$16,052 million as at 30 June 2016.

The increase is due to a combination of new system assets delivered under the capital investment program, and recognition of finance leases, together with a lift in asset values.

*4989 DIVIDENDS PAID TO GOVERNMENT—Mr Chris Minns asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—

Would the Minister support a line item in the "World Class Performance" score card performance summary on dividends paid to Government as outlined in the Sydney Water Annual Report?

Answer-

The matter of Sydney Water's dividend payment is a matter for the Shareholding Ministers, not the Portfolio Minister.

Payment of the dividends is subject to a joint review between Sydney Water and Treasury prior to the end of each financial year and is a well-established process.

Payment of dividends by Sydney Water is subject to conditions precedent, including confirmation of financial capacity to pay, and maintaining an investment grade credit rating.

*4990 PRIVATISATION OF SYDNEY WATER—Mr Chris Minns asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—

Does the Minister guarantee not to privatise Sydney Water?

Answer-

The NSW Government will not privatise Sydney Water.

*4991 SYDNEY WATER ASSET DISPOSALS—Mr Chris Minns asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—

Can the Minister nominate what losses on asset disposals Sydney Water was referring to on page 30 of the Sydney Water Annual Report 2015-16?

Answer—

Losses on asset disposals are incurred when Sydney Water disposes of assets that have a remaining written down value, for example, replacing ageing water mains that may have minimal residual life. The value of the residual life is expensed to the statement of profit and loss. Net losses from disposals of assets increased from \$9.4 million in 2014-15 to \$17.2 million in 2015-16, due to a higher volume of asset renewals and replacements, particularly watermains and treatment plants.

*4992 ACCESS TO COMMUNITY TRANSPORT—Ms Julia Finn asked the Minister for Transport and Infrastructure—

What is the Government doing to increase access to community transport for disadvantaged members of the community in Granville, particularly those who are aged or living with disabilities?

Answer-

Since 2011, the Government has invested significantly in community transport, and continues to invest, to increase access for disadvantaged community members, including the community of Granville.

The Government made an initial \$12 million funding commitment over 4 years for the Community Transport Program. This represents a 100 per cent funding increase over the period and was the first boost to the program since 1998.

In March 2015, the Government committed to an additional \$12 million over a further 4 year period for the Community Transport Program, commencing in 2015-16.

The Government continually seeks new and innovative transport solutions to improve the public transport experience for commuters across the state.

The Government identified a new tunnel through the Illawarra Escarpment as part of the Mainline Acceleration program within the State Infrastructure Strategy in 2014. This was also included as part of the Rail Corridors Strategic Study in 2014.

Further opportunities for transport improvements across New South Wales, including the Illawarra region, will be considered as part of the Government's Future Transport Strategy.

*4994 INTELLECTUAL DISABILITY RIGHTS SERVICES—Mr Paul Lynch asked the Attorney General—

What funding will be provided for Intellectual Disability Rights Services after 1 July 2017?

Answer-

On 5 April 2017, the Government announced it will provide more than \$6 million in additional funding for community legal centres over the next two years to make up for the

Commonwealth funding shortfall.

Funding for the Community Legal Centres Program is administered by Legal Aid NSW and will be finalised on confirmation of the State budget and funding from the Public Purpose Fund. Subject to this confirmation, the Intellectual Disability Rights Service (IDRS) will receive the same level of funding in 2017-18 as it did in 2016-17.

IDRS also receives funding administered by Legal Aid NSW under the Care Partner Program which will be finalised soon for 20.17-18.Legal Aid NSW also provides full grants of aid on a case by case basis to represent clients eligible for legal aid, including practitioner's fees.

The majority of Government funding received by the IDRS is provided by the Department of Family and Community Services.

The fall in the recycling rate from 88 per cent in 2014-15 to 71 per cent in 2015-16, equates to a reduction of 155,000 tonnes of recycled waste in 2015-16.

However, total waste generated in 2015-16 fell by 139,000 tonnes, or 42 per cent, which accounts for most of the reduction in the tonnes of waste recycled.

Sydney Water's capital works program makes up about 80-90 per cent of total waste generated. The volume of waste generated each year, and the associated recycling rates, can vary significantly depending on the types of projects and types of waste.

The contracts the Government has relating to GovConnect specify the purchase of services from the suppliers, and at the commencement of the contracts, the service delivery model agreed to by the Government and suppliers was 70 per cent onshore and 30 per cent offshore. However the direct employment of staff by contract vendors is the responsibility of those suppliers.
- (2) The Department expects any 457 visa holders working for GovConnect are employed to meet critical skills shortages and are engaged in accordance with Department of Immigration and Border Protection requirements.

There are no new policy implications for New South Wales arising from the announcement referred to. New South Wales already has appropriate laws and regulations in place to allow for the appropriately authorised import and warehousing of medicinal cannabis products. It is anticipated that the new Commonwealth policy may streamline access and reduce costs for patients for whom these products have been lawfully prescribed

Answer-

The Medical Board of Australia registration data shows that as at September 2016 there were 110 palliative care medicine specialists registered in New South Wales, out of a total of 318 registered in Australia.

Palliative care in New South Wales is provided in a networked arrangement. This allows specialist palliative care services to support and complement primary care services, ensuring the broadest access to palliative care support.

In 2012, the Government launched its NSW Plan to increase access to palliative care 2012-2016. To implement this plan, the Government has made significant funding enhancements to palliative care. This

includes: \$35 million over four years from 2012-13 for community-based palliative care services, and a further \$32 million over four years from 2015 which was announced as part of the government's election commitments; which includes a \$12 million Flexible Funding Pool to enhance capacity in palliative care in local health districts.

This funding has been used to deliver a range of new services for palliative care patients. These new services include:

- The Last-Days-of-Life Home Support Service, which provides 'packages' of care for palliative patients in their homes, to enable patients to die at home if that is their wish. Services include personal care and domestic assistance. More than 6,000 support packages have been completed since December 2013.
- The NSW Paediatric Palliative Care Program provides statewide enhanced access to specialist
 expertise, including on an after-hours basis for medical practitioners needing advice. The number of
 paediatric palliative care patients in NSW is small and therefore the program provides a "pop-up"
 service, which mobilises specialist supports around a dying child and their family.
- A statewide palliative care Volunteer Support Project, which provides training and support to volunteers who work in palliative care. There are approximately 1 ,200 palliative care volunteers providing support in New South Wales.
- The Palliative Care After Hours Helpline, which provides advice and support for palliative care patients, their carers and families, and health professionals.
- The Agency for Clinical Innovation has also developed the Palliative and End of Life Care- A Blueprint for Improvement (known as 'The Blueprint') to enhance standard of care in each local health district.

- (1) The Environment Protection Authority (EPA) is reviewing the NSW Industrial Noise Policy to reflect contemporary science and make it easier to use and interpret. Any changes to the document, including its title, will be considered by the NSW Government.
- (2) The approach that was published for consultation maintains a penalty for low frequency noise that better targets the levels that cause increased annoyance.

The approach was proposed as the provisions in the Industrial Noise Policy are not supported by current science and understanding of the effects of low frequency noise.

(3) Between 2013 and 2016, five per cent of mine noise complaints made to the EPA were specifically about low frequency noise.

Will any components of the new XPT train carriages be built in Newcastle?

The aim is to have 100 per cent of the components of the new XPT replacement fleet assembled in New South Wales. All locations in New South Wales which meet the project objectives will be considered.

Over the next few months, Transport for NSW will be consulting with industry and other key stakeholders to get their ideas and develop a plan to procure and deliver the best possible solution for the people of New South Wales.

The material is forwarded to ACE colleges where it is made available as downloadable documents. ACE co lleges and libraries also display the material on their premises and printed material is sent to local residents.
- (2) The program is delivered in the Fairfield Local Government Area by the Fairfield City Council through the Fairfield City Library and the Whitlam Library at Cabramatta. Fairfield City Council can provide details on the number of courses delivered.

- (1) The formation of Defence NSW is an initiative of the NSW Defence and Industry Strategy 2017. The preparation of this strategy included four consultation sessions with industry in Sydney, Newcastle, Nowra and Queanbeyan. The draft strategy was presented to industry leaders including prime contractors, SMEs and representative associations for comment, which were incorporated into the final strategy where possible. Internal consultations have included the Department of Premier and Cabinet.
- (2) Defence NSW will have six full time staff once recruitment is completed.
- (3) Defence NSW will have about \$1.5 million for operational expenses in addition to staff costs of \$900,000 (staff costs not subject to GST).
- (4) Defence NSW will be based in the existing Department of Industry offices at Parramatta.
- (5) Defence NSW will be headed by the Director, Defence Industries in the Industry Development branch of the Department of Industry.

- *5036 SERVICE NSW CENTRALISED CALL CENTRE—Mr Clayton Barr asked the Minister for Finance, Services and Property—
 - (1) What was the average on hold wait time for customers who use the Service NSW centralised call centre from 1 July 2016 to 28 February 2017?
 - (2) What was the longest on hold wait time for customers from 1 July 2016 to 28 February 2017?
 - (3) Are on hold wait times assessed from when a customer speaks to an area that can assist them or from when an operator answers and before they are transferred to another area?

Answer-

- (1) The average time a customer waited on hold to speak to a Customer Service Representative between 1 July 2016 and 28 February 2017 was under 7 minutes.
- (2) During the period 1 July 2016 to 28 February 2017, one customer experienced a wait time of approximately 2 hours. This was isolated to one queue line only the average wait times across all queues was 37 seconds for the same day. Strategies were implemented to reduce wait times for the affected queue and service levels improved. During the same period, Service NSW was experiencing an increase in call volumes of around 40 per cent.
- (3) The wait time is calculated during the time a caller spends in the queue before their call is answered by a Customer Service Representative.

Service NSW is constantly working to improve the experience for customers. To address periods of high demand, Service NSW introduced an automated call-back feature. This service allows the customer to choose to remain on hold or to receive a call-back while maintaining their place in the queue.

- *5043 SYDNEY OPERA HOUSE OPERA BAR—Mr Alex Greenwich asked the Minister for Planning, Minister for Housing, and Special Minister for State—
 - (1) Since 1983, what development approvals, including modifications, have been given for the operation of the Sydney Opera House Opera Bar (to 9 March 2017)?
 - (a) What are the details of these approvals?
 - (2) To what extent do approvals permit amplified music outside?
 - (3) To what extent do approvals permit permanent structures?
 - (4) To what extent is the Opera Bar's development approval being investigated and when did investigations commence?

- (1) to (4) In 1985, the City of Sydney gave development consent (44/85/0511) for refurbishment of the Opera House forecourt and undercover walkway. The consent contains sound level restrictions that apply to music. The Sydney Opera House Trust Act 1961 also sets out purposes for which the Opera House can be used.
- (5) The Department of Planning and Environment has an open investigation as a result of complaints received in 2016.

- *5044 SYDNEY OPERA HOUSE CONSERVATION MANAGEMENT PLAN—Mr Alex Greenwich asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—
 - (1) When was the existing Conservation Management Plan prepared for the Sydney Opera House?
 - (2) When was an update of this plan due?
 - (3) What work has taken place to update the plan, including for it to reflect its listing by the United Nations Educational, Scientific and Cultural Organisation?

Answer-

- (1) It was adopted by the Sydney Opera House Trust on 23 June 2003.
- (2) The policies embedded in the plan state that the Opera House should review the document by July 2008. A review of the plan commenced in 2007.
- (3) Consultation with the NSW Office of Environment and Heritage, the NSW Heritage Council and the Australian Department of the Environment and Energy has been undertaken. The Plan has also been placed on public exhibition. Seven submissions were received and all submissions were considered in the preparation of subsequent drafts. An expert peer review panel was appointed by the Sydney Opera House Trust to review and finalise the Plan.

Policies in the Plan were reviewed against and developed in line with the UNESCO World Heritage Operational Guidelines for the Implementation of the World Heritage Convention.

- (4) The Plan will be submitted to the NSW Heritage Council. It will also be submitted to the Australian Heritage Council, via the Australian Department of the Environment and Energy. The Department of the Environment and Energy represents Australia in all matters relating to the Convention Concerning the Protection of the World Cultural and Natural Heritage and liaises with UNESCO about Australia's World Heritage-listed sites, including the Sydney Opera House.
- (5) Final approval of the Plan is expected later in 2017.

Answer—

Authorised Inspectors from local health district public health units and the NSW Ministry of Health conduct regular compliance monitoring and enforcement activities. Individuals found in breach of the law can be issued with a warning or on the spot fine of \$300. Penalties of up to \$5,500 may apply to business owners if individuals are observed smoking in a commercial outdoor dining area.

NSW Police are also authorised to issue on the spot fines of \$300 to individuals who breach the smoking bans at transport stops under the Passenger Transport Regulation 2007.

The majority of outdoor smoking bans were introduced in January 2013, with commercial outdoor dining laws taking effect in July 2015. The issuance of fines under the Smoke-free Environment Act 2000 commenced in mid-2014 after a period of educative enforcement.

Enforcement activity is being targeted to those areas where there is lower compliance with smoking bans. Some identified hotspots include train stations and bus shelters. Authorised Inspectors are collaborating with NSW Police to target transport stops with extended surveillance planned throughout 2017.

*5047 REFUGEES SETTLING IN THE FAIRFIELD ELECTORATE—Mr Guy Zangari asked the Minister for Family and Community Services, Minister for Social Housing, and Minister for the Prevention of Domestic Violence and Sexual Assault—

What measures have been taken to ensure fair and equitable treatment to the Family and Community Services clients who are presently on the social housing waiting list considering the large-scale influx of refugees who are due to settle in Fairfield by the end of 2017?

Answer-

I am advised that the Commonwealth Government, through the Department of Social Services, provides initial settlement support to refugees through the Humanitarian Settlement Service program. Exit from this program is based on clients achieving clearly defined settlement outcomes, including residing in long-term accommodation.

The Department of Family and Community Services reviews all applications received for housing assistance and considers any indicators of priority need before matching clients with the most appropriate housing assistance products. All applications are reviewed on their individual merits against a standard set of eligibility criteria.

 - (1) Has the New South Wales Environment Protection Authority (EPA) received an investigation report that establishes the nature and extent of contamination at the site of the new Wentworth Point Public School?
 - (a) If so, when was it received?
 - (b) If so, is it available to the public?

 - (6) If the area is found to have safety aspects that cannot be mitigated, will CAMS announce publicly that the track is not certifiable before it is built?
 - (7) If this sound modelling shows harmful levels in the living environments of residents as per the Australian standards, what action will you take?
 - (8) Can the successful implementation of the Newcastle 500 be guaranteed with current staffing levels?
 - (9) What funds have been allocated to Destination NSW (DNSW) for the hosting of the Newcastle 500?

Answer—

- (1) Noise exposure does not form part of the Fédération Internationale de l'Automobile (FIA) track safety guidelines. The FIA is not a regulatory body in the context of noise limits and abatement.
- (2) (a) to (c): Ensuring public safety and welfare is the first priority throughout the event. Supercars Australia is working with acoustic engineers and Government agencies to develop a noise management plan that will identify and work to mitigate noise related impacts during the event.
- (3) Refer to Question 1 and 2 responses.
- (4) No, CAMS will not be undertaking independent sound modelling. Supercars will conduct sound monitoring during the Newcastle 500 race per its sporting regulations. CAMS will be involved in this monitoring as it conducts the judicial process.
- (4) (a) Refer to question 4 response.
- (5) The track design will be certified by CAMS ahead of the race. It is then the responsibility of the track engineers to ensure construction is as per the certified design.
- (6) As indicated in the question 5 response the circuit will be certified prior to the event commencing and will be done so as per the established process required by CAMS and FIA.
- (7) No sound modelling is undertaken by CAMS or FIA. Supercars Australia is working with acoustic engineers and Government agencies to develop a noise management plan that will identify and work to mitigate noise related impacts during the event.
- (8) Resources are being appropriately managed to ensure a successful event.
- (9) Event investment is commercial-in-confidence between the event proponent and the Government's tourism and major events agency, Destination NSW.

(10) Major events such as the Newcastle 500 undergo rigorous due diligence and strategic analysis to determine an event's return on investment against key performance indicators. This is includes a post event evaluation analysis. Pending collation of survey data from the event, results relating to overnight visitation and economic impact may be released.

Forecasted visitation and economic impact, already publicly stated, is based on the five year duration of the event. The overall success of the Newcastle 500 will be determined at the end of the five-year event period.

- (1) The Department granted consent for use of the Sydney Opera House forecourt for outdoor events and functions in 2004. The consent contained conditions that allowed the operation of events for up to 48 days per year for a period of 3 years.
- (2) The consent has been modified on three occasions.
- In 2005, the consent was modified to allow additional outdoor events over a maximum of 127 days a year. In 2007, a condition of the consent was modified to continue to hold events for a further year. In 2008, the consent was modified to continue to hold events until 31 December 2009.
- (3) In 2016, the Department investigated the uses being made of the southern forecourt and monumental steps of the Sydney Opera House during the period 2010-2016. That investigation resulted in a penalty notice being issued to the Sydney Opera House Trust for noise exceedances during an outdoor performance which occurred on 15 November 2015.
- (4) and (5) The complaints received by government were about the use of the southern forecourt and monumental steps after 31 December 2009. These complaints were investigated and led to a penalty notice for noise exceedances which occurred at an outdoor performance on 15 October 2015. The Department found that the consent had not lapsed, remained in force and could be modified .
- (6) The Department notified surrounding landowners, including the closest residents at 1 Macquarie St, of the public exhibition of the application and invited comment and feedback.
- (7) Public notice of the application was placed in the Central Sydney Courier on Wednesday 10 August 2016. On 12 August 2016, the Department also issued a media release on the application to Sydney metropolitan newspapers and on our website inviting comment on the modification.
- (8) The Department consulted with the NSW Heritage Office in accordance with established practice.
