- \*2688 SCHOOL UNIFORMS—Mr Richard Amery asked the Deputy Premier, Minister for Transport, Minister for Finance representing the Minister for Education and Training, Minister for Industrial Relations, Minister for the Central Coast, and Minister Assisting the Minister for Finance—
  - (1) Are students encouraged to wear school uniforms in public schools in New South Wales?
  - (2) Is it compulsory for all students to wear uniforms in these schools?
  - (3) Will a student's formal education be affected if they do not wear a school uniform?
  - (4) What procedures should a parent take if they choose not to send their children to school in uniform? Answer—
  - (1) The New South Wales Government supports the wearing of school uniforms by students in public schools and students are encouraged to wear school uniform.
  - (2) The School Uniform Policy (2004) makes the wearing of school uniforms, which are agreed upon by school communities, mandatory in all New South Wales public schools.
  - (3) Students may be excluded from certain educational activities for not wearing school uniform where the exclusion is necessary for reasons of health and safety of the student or of other students for example where they breach occupational health and safety guidelines. Such action may also be required if a student's clothing compromises agreed upon school community standards which are detailed in the school uniform requirements and might be considered damaging to the image of the school in the larger community context. Alternative educational activities are provided in such circumstances.
  - (4) Parents should raise any concerns regarding school uniforms with the principal of their child's school. Principals negotiate with parents and carers to resolve issues and avoid conflict when a student does not wear the school uniform. In promoting the wearing of school uniform, principals are sensitive to economic, personal, social and cultural factors affecting individual students and their families.
- \*2689 REVESBY COMMUTER PARKING—Mr Alan Ashton asked the Deputy Premier, Minister for Transport, Minister for Finance—

What proposals are there to increase the commuter car parking at Revesby to improve the viability of the operation of Revesby turnback facility?

Answer—

I am advised:

The Government is committed to an expansion of commuter car parking by an extra 4,000 car spaces. These will be built in Sydney's west under a \$45 million strategy to expand and improve commuter parking facilities at key locations across Sydney. This is part of the Premier's \$660 million Urban Transport Statement.

Initial investigations for commuter car parking at Revesby are complete with sites identified for further investigation.

RailCorp recently engaged Parsons Brinckerhoff to undertake a more detailed commuter car parking and interchange scoping study for Revesby. The study will provide preferred options and concepts for bus interchange and commuter car parking improvements at Revesby for consideration and decision by Government. This study is nearing completion.

It is anticipated that the next steps will involve a decision about the specific projects to be progressed at Revesby and liaison with stakeholders including Bankstown City Council and land owners, where appropriate.

Consideration is being given to the timing of improvements at Revesby having regard to the turnback works at Revesby and later proposed rail line quadruplication works.

\*2690 REVESBY TURNBACK FACILITY—Mr Alan Ashton asked the Deputy Premier, Minister for Transport, Minister for Finance—

What is the estimated date for the completion of the Revesby turnback facility at Revesby station?

Answer-

I am advised:

The Revesby Turnback Project is scheduled for completion in 2008.

- \*2691 RTA'S BICYCLE MASTERPLAN 2010—Mr Mike Baird asked the Minister for Health representing the Minister for Roads, and Minister for Commerce—
  - (1) What progress has been made on the items in the RTA's Bicycle Masterplan 2010 that relate to the two major off-road cycleways promised for the Northern Beaches:
    - (a) Chatswood to Warringah Mall;
    - (b) Harbour Bridge to Warringah Mall?
  - (2) When will these projects be completed?
  - (3) Have any bicycle groups from the Northern Beaches been consulted on these two projects?
  - (4) Are detailed maps or plans available?

Answer-

I am advised.

Design development for the section of cycleway between Ernest Street/Ridge Street and the Sydney Harbour Bridge will be undertaken following completion of the section between Chatswood Railway Station and Ernest Street/Ridge Street. This section includes the cycleway between Artarmon Reserve and Merrenburn Avenue, Naremburn as part of the Lane Cove Tunnel project.

Other local cycling facilities continue to be provided through road infrastructure projects, some of which were not represented in BikePlan 2010. These major projects have altered the delivery priorities as originally outlined in BikePlan 2010.

It is worth noting that in 1999, BikePlan 2010 committed to delivering an average of 200km of cycling facilities per year. The NSW Government has exceeded those projections, providing an average of 233 km of new cycling facilities each year since 1999.

\*2692 BEAR COTTAGE—Mr Mike Baird asked the Minister for Health—

Will the Minister join the local MP on a visit to Bear Cottage to enable her to consider a contribution from the NSW Government towards the running of the facility?

Answer-

The Member for Manly's question amounts to an invitation to a facility in his electorate. I suggest that the Member contacts my office so that his invitation can be considered in the customary manner.

- \*2693 MANLY JETCAT SERVICES—Mr Mike Baird asked the Deputy Premier, Minister for Transport, Minister for Finance—
  - (1) What were the reasons for the high number of JetCat cancellations in the March-April period?
  - (2) What steps have been taken to avoid a repeat of these circumstances?
  - (3) Has the Minister considered SMS alerts that ferry/JetCat passengers could subscribe to in order to be notified of cancellations?

Answer-

I am advised:

(1) to (3) Service cancellations for the nominated period, were a result of mechanical problems, crew shortages and an exclusion zone in force on the JetCat route due to powerboat racing.

In April 2007, the Government established the Special Commission of Inquiry to conduct a comprehensive top-down review of the entire operations of Sydney Ferries Corporation to ensure commuters benefit from a safe, efficient and customer-focussed ferry service. The Government received the final report of the Inquiry on 31 October, 2007 and copies are available on the NSW Government website at: http://www.nsw.gov.au

Given the wide-ranging nature of the report, and the complexities of the issues involved, the Government will take the appropriate time to fully consider Mr Walker's recommendations before offering a full response. I do however, expect that the Government's response will be finalised shortly.

- \*2694 HIGH SCHOOL EDUCATION—MANLY—Mr Mike Baird asked the Deputy Premier, Minister for Transport, Minister for Finance representing the Minister for Education and Training, Minister for Industrial Relations, Minister for the Central Coast, and Minister Assisting the Minister for Finance—
  - (1) With enrolments to primary schools in the Manly electorate on the rise, what plans does the

Government have in place to cope with increasing demand for high-school education in the area?

(2) Would the Minister consider utilising the Seaforth TAFE site as a co-educational high school?

Answer—

"New Horizons: A Proposal to restructure secondary education provision in the Northern Beaches District" resulted in the creation of the Northern Beaches Secondary College which provided a new future for the education of students on the Northern Beaches, including establishing links between the Freshwater Senior Campus and a university.

The Northern Beaches Secondary College provides a shining example of educational opportunity and innovation, with capacity to address all current and projected enrolment requirements for public secondary education in the Manly electorate.

\*2695 CYCLEWAYS—Mr Mike Baird asked the Minister for Health representing the Minister for Roads, and Minister for Commerce—

Have footpaths been considered for use as cycleways during peak periods?

Answer-

I am advised:

Footpaths in NSW are managed by local councils. The RTA produces guidelines on pedestrian and cycling facilities that provide councils with the relevant information required for them to determine the most appropriate treatment's to cater for both cyclists and pedestrians and implement shared paths for pedestrians and cyclists.

\*2696 141 BUS SERVICE—Mr Mike Baird asked the Deputy Premier, Minister for Transport, Minister for Finance—

Further to preliminary discussions with the State Transit Authority, would the Minister allow a trial of the 141 bus service to see whether usage would justify reinstating the service?

Answer-

I am advised:

Given the low patronage previously achieved and the availability of other State Transit bus services in the area, there does not appear to be sufficient potential demand to justify a trial of the route 141 bus service.

\*2697 BALGOWLAH PIONEER CLUBHOUSE—Mr Mike Baird asked the Minister for Health—

Will the Minister consider meeting at a minimum the additional funding required by the Pioneer Clubhouse in Balgowlah so it can hire at least one additional staff member by May 2008 and retain accreditation by the International Centre for Clubhouse Development?

Answer-

I am advised:

The process for Pioneer Clubhouse, as a Non Governmental Organisation (NGO), applying for additional funds from NSW Health involves the completion of a Registration of Interest for funding under NSW Health NGO Grant funding. This would be completed through the NGO Performance Agreement Coordinator at Northern Sydney Central Coast Area Health Service. To date, no application has been received.

- \*2698 INFRASTRUCTURE PROJECTS—Mr Mike Baird asked the Minister for Health representing the Minister for Roads, and Minister for Commerce—
  - (1) How many staff managed infrastructure projects at the NSW Public Works Department in March 2003?
  - (2) How many staff managed infrastructure projects at the Department of Commerce in March 2008?

Answer—

I am advised:

The former Department of Public Works and Services was incorporated into the newly formed Department of Commerce in April 2003. The Office of Public Works and Services undertakes primarily the same functions as those carried out previously by the Department of Public Works and Services.

A similar proportion of staff are directly involved in management of infrastructure projects within the Office of Public Works and Services as were previously engaged in the former Department of Public Works and Services.

\*2699 NSW MARITIME RENTS—Mr Mike Baird asked the Minister for Small Business, Minister for Regulatory Reform, Minister for Ports and Waterways—

Why has the rent charged by NSW Maritime increased by more than five times in the past two years for some residents leasing land in Fairlight, including a cancer patient who was charged \$495 in 2004 and \$2.680 in 2006?

Answer—

NSW Maritime administers waterfront leases in Sydney Harbour, principally for private jetties, mooring pens, swimming baths and boatsheds.

Rental for these private facilities is determined based on a formula recommended by the Independent Pricing and Regulatory Tribunal (IPART) in a 2004 Report titled Review into Rentals for Waterfront Tenancies on Crown Land in NSW. Copies of this Report are available from the IPART website.

In 2007, NSW Maritime conducted a comprehensive review of domestic leasing arrangements, including the operation of the IPART rental formula. The review was an open process and invited comments from the public.

As a result of the review, the Government made a number of changes to domestic leasing policies. Lessees in Fairlight are among the beneficiaries of these changes.

- \*2700 CHATSWOOD-EPPING RAIL LINE OPENING—Ms Gladys Berejiklian asked the Deputy Premier, Minister for Transport, Minister for Finance—
  - (1) Given that some State Government websites have information that is now out of date, will you confirm the date of the opening of the Chatswood-Epping rail line?
  - (2) If not, why not?

Answer-

I am advised:

The Epping Chatswood Rail Line is the most significant infrastructure project currently underway in NSW.

The line is on schedule to be handed over to CityRail for a rigorous testing and training program later this year. This program will include emergency evacuation training, testing of security and CCTV systems and ensuring that emergency services, train crew and station staff are all familiar with the new line and stations.

On completion of the testing program we will commit to the opening of the line.

\*2701 CHATSWOOD-EPPING RAIL LINE DELAY—Ms Gladys Berejiklian asked the Deputy Premier, Minister for Transport, Minister for Finance—

In relation to your response to a previous written question regarding the opening of the Chatswood-Epping rail line, has the opening of the line been delayed even further?

Answer-

I am advised:

The Epping Chatswood Rail Line is the most significant infrastructure project currently underway in NSW.

The line is on schedule to be handed over to CityRail for a rigorous testing and training program later this year. This program will include emergency evacuation training, testing of security and CCTV systems and ensuring that emergency services, train crew and station staff are all familiar with the new line and stations

On completion of the testing program we will commit to the opening of the line.

\*2702 EPPING ROAD BUS SERVICES—Ms Gladys Berejiklian asked the Deputy Premier, Minister for Transport, Minister for Finance—

\*2707 ROADS FUNDING—Mr Peter Debnam asked the Minister for Health representing the Minister for Roads, and Minister for Commerce—

In relation to RTA roads funding and the Minister's response to Question 1552:

- (1) Given the Minister's response that, "information on roads projects across NSW, including the electorate of Vaucluse is publicly provided in Budget papers and regularly updated in community newsletters and on the Roads and Traffic Authority website at www.rta.nsw.gov.au", where in the "Budget papers" or on "the Roads and Traffic Authority website" can specific information on road projects, including maintenance funding, in the electorate of Vaucluse be found?
- (2) If specific information on road projects, including maintenance funding, in the electorate of Vaucluse is not publicly available, will the Minister make it publicly available?

Answer-

I am advised:

More than \$5 million has been allocated to a range of projects in the Vaucluse electorate over the past 4 years. This includes funding for road safety, road network maintenance and traffic and transport.

- \*2710 FARMER EXIT ASSISTANCE—Ms Pru Goward asked the Minister for Climate Change and the Environment, Minister for Women, Minister for Science and Medical Research, and Minister Assisting the Minister for Health (Cancer)—
  - (1) Of the \$12 million Farmer Exit Assistance from the \$37 million Native Vegetation Assistance

# Program:

- (a) How much has been spent;
- (b) Which properties have been purchased and at what value;
- (c) How many more properties are currently in the valuation stage;
- (d) What criteria were used to assess the appropriateness of purchasing these properties?
- (2) What information and analysis did the Department base its decision on?

#### Answer—

- (1) Of the \$12 million Farmer Exit Assistance Package from the \$37 million Native Vegetation Assistance Program:
  - (a) \$2.9 million has so far been spent on purchasing two properties.
  - (b) The properties purchased to date are:
    - "Kewilpa", near Casino, for \$1.2 million; and
    - "Estuary Creek", near Grafton, for \$1.7 million.
  - (c) Four further properties are currently in the valuation stage.
  - (d) The criteria used to assess property purchases, as documented in the Native Vegetation Assistance Package Business Plan 2007/2008, relate mainly to demonstrating the loss of viability of a farm business as a result of being unable to undertake planned broadscale clearing.
- (2) The Department of Environment and Climate Change provides project oversight of the assistance package but does not determine funding allocations.

If a landholder is unable to gain approval to clear native vegetation from their Catchment Management Authority through the Property Vegetation Plan process, they can submit an application for exit assistance to the NSW Rural Assistance Authority, which is an expert body in the area of farm viability. The Authority will assess the claimed loss of commercial viability and, if eligible, forward the application to the Nature Conservation Trust.

The Trust, which has expertise in land acquisition and covenanting, will commission an independent valuation of the property and make an offer to purchase the land based upon that valuation.

The Package operates on a first-come-first-served basis, and the Nature Conservation Trust processes applications in the order in which they are received while funds remain available.

\*2711 RAINWATER TANK SUBSIDIES—Ms Pru Goward asked the Minister for Climate Change and the Environment, Minister for Women, Minister for Science and Medical Research, and Minister Assisting the Minister for Health (Cancer)—

According to the model developed by the Department of Planning for BASIX, which the Department of Environment and Climate Change uses to estimate water savings:

- (1) What are the water savings of the money spent per annum on rainwater tank subsidies?
- (2) What calculations has the Department made regarding the cost-effectiveness of these subsidies?
- (3) What are the details of the model used to make these calculations?

## Answer-

- (1) The rainwater tank rebate program under the Climate Change Fund commenced on 1 July 2007. As at 22 April 2008, 12,823 rainwater tank rebates had been paid or were approved to be paid, saving 548 million litres of potable water per year.
- (2) Rebates paid since 1 July 2007 total \$5,900,000. The annual report on the Climate Change Fund required to be submitted to Parliament will include further analysis of all the Fund's programs.
  - In establishing the rainwater tank rebate program under the Climate Change Fund, the NSW Government recognised that NSW residents want to take action to save water. The program was based on Sydney Water's program which had been successfully operating since 2002.
- (3) The model from BASIX used by the Department of Environment and Climate Change in calculating water savings uses inputs of tank size, connected roof area, the number of internal connections, post code (to determine locational and climate factors), and number of occupants. Typical water use and efficiencies of toilets, washing machines and gardens are assumed in the modelling.
- \*2722 COURT COSTS—Ms Katrina Hodgkinson asked the Minister for Community Services—
  - (1) What was the cost to the Department of Community Services budget of retaining the services of barristers and solicitors to represent the Department of Community Services in child custody hearings during the financial years:
    - (a) 2002-03;

- (b) 2003-04;
- (c) 2004-05:
- (d) 2005/06;
- (e) 2006-07:
- (f) to date in 2007-08?
- (2) How many child protection cases were brought before the courts in each of these years?
- (3) In how many of each of these cases was more than one solicitor and one barrister retained for each case?
- (4) By year, in how many of these cases was a Queens Counsel or Senior Counsel retained by the Department of Community Services?
- (5) Were there any cases that required the services of more than one QC or SC to represent the Department of Community Services?
- (6) On how many occasions did this occur?

## Answer-

- (1) The Department of Community Services uses in-house departmental legal officers, the Crown Solicitor and external private legal practitioners to conduct care matters before the Children's Court.
  - Information is not kept as to the aggregated cost to the State of the Crown Solicitor appearing in care proceedings before the Children's Court. The Crown Solicitor would appear in less than 5% of all care matters and will usually brief junior Counsel. The costs of the Crown Solicitor for so appearing are a matter for the Hon John Hatzistergos, MLC, Attorney General.
- (2) Data on the number of Children's Court care matters data is provided by the Attorney General's Department on a calendar year basis.
- (3) No aggregated information is held as to the number of legal representatives engaged in each matter.
- (4) No Queens Counsel or Senior Counsel have been engaged to conduct care proceedings for the Director-General in the Children's Court in any of the years specified.
- (5) No.
- (6) Not applicable.

# \*2724 COWRA HOSPITAL—Ms Katrina Hodgkinson asked the Minister for Health—

Has the Greater Western Area Health Service refused to replace the baby heart monitor at the Cowra Hospital despite concerns by staff that maternity care is being compromised by this old equipment?

## Answer-

I am advised by the Chief Executive of the Greater Western Area Health Service:

A new CTG machine was introduced to service at Cowra Hospital on 6th May 2008.

- \*2725 CONFUSED AND DISTURBED ELDERLY—LONG JETTY—Mrs Judy Hopwood asked the Minister for Health—
  - (1) What is the current status and role of the Confused and Disturbed Elderly Unit (CADE) at Long Jetty?
  - (2) How many patients are accommodated?
  - (3) What was their average length of stay in the years 2003, 2004, 2005, 2006 and 2007?

## Answer-

I am advised by the Chief Executive of the Northern Sydney and Central Coast Area Health Service:

(1) to (3) The CADE Unit at Long Jetty is an in-patient unit, part of Northern Sydney Central Coast Area Health Service. The patients are admitted under the care of a Staff Specialist Geriatrician with psycho-geriatrician input. The role of the unit is that of a short term assessment, treatment and management unit for patients with moderate to severe dementia and challenging behaviours.

There are, on average, 16 available beds in the CADE unit at Long Jetty Hospital.

The average length of stay (ALOS) for the CADE unit for the financial years dating back to 2002/03 is as follows:

## \*2726 TUBERCULOSIS—HORNSBY HOSPITAL—Mrs Judy Hopwood asked the Minister for Health—

- (1) Have there been any notifications in Hornsby Hospital of tuberculosis for the years 2003 to 2007 inclusive?
- (2) If so, how many and what subsequent treatments have been undertaken?
- (3) Has there been correspondence or communication related to this to the Federal Government?
- (4) Are there immigration implications?

## Answer-

## I am advised:

- (1) and (2) The Chief Executive, Northern Sydney and Central Coast Area Health Service advises the Hornsby Hospital chest clinic reported 82 cases of tuberculosis managed by the chest clinic from 2003 to 2007 inclusive. All patients notified with tuberculosis in New South Wales are given a standard treatment of an antibiotic regimen. A physician with expertise in tuberculosis treatment monitors all patients in order to ensure that treatment is effective.
- (3) Yes, the NSW TB Program reports all tuberculosis data to the Commonwealth Department of Health and Ageing on a routine basis.
- (4) It is estimated that globally, one third of the world is infected with tuberculosis. Many developing countries have high rates of tuberculosis. People from these high burden countries migrate to Australia and a small proportion will go on to develop tuberculosis. All migrants from these high burden countries undergo pre-migration screening for tuberculosis. Migrants with abnormal chest x-rays and no evidence of active tuberculosis are referred to migration screening services in New South Wales for follow up. These cases are managed effectively by the NSW TB Program as demonstrated by the low rates of tuberculosis in New South Wales.
- \*2728 TRANSFER SYSTEM FOR TEACHERS—Ms Sonia Hornery asked the Deputy Premier, Minister for Transport, Minister for Finance representing the Minister for Education and Training, Minister for Industrial Relations, Minister for the Central Coast, and Minister Assisting the Minister for Finance—

With the proposed changes to the staffing arrangements at Public Schools, what effect will it have on the normal transfer system for teachers?

# Answer—

Priority transfers continue under the new school teacher staffing procedures. Priority transfers are nominated transfers when a teacher needs to move schools because of changed enrolment or curriculum patterns, incentive transfers for teachers who have served the required number of years in a rural or remote school, and compassionate transfers.

When a vacancy occurs, the first action is to run a computerised match to see if any teachers with a priority transfer match the position. There is no power of veto to the appointment by the receiving school, or by the school education director or regional director when a priority transfer applicant matches the position.

Service transfer opportunities for classroom teachers also continue under the new school teacher staffing procedures. There are different procedures that apply depending on whether the service transfer form has been lodged before or after 13 April 2008.

Under a transition arrangement until Term 2, 2010, teachers who had an active service transfer application as at 13 April 2008 are considered for appointment once priority transfers have been made.

Where a service transfer applicant matches the position, the teacher will be appointed if the last vacant position at that school was not filled through service transfer. The teacher is not automatically appointed if the last vacant position was filled through service transfer. In this case, the school chooses from a suite of options to fill the position, one of which is service transfer.

From Term 2, 2010 where there are no priority placements to be made, schools will be able to choose how to fill a position, either through advertisement, or from the service transfer, graduate recruitment or employment lists.

\*2729 ROADSIDE MAINTENANCE—CRONULLA—Mr Malcolm Kerr asked the Minister for Health representing the Minister for Roads, and Minister for Commerce—

  - (1) How much is being expended to repair Wagga Wagga Base Hospital children's ward?
  - (2) Has the extent of the white ant problem been underestimated?
  - (3) How much over the allocated budget will have to be spent to rectify the problem?
  - (4) When will the work be completed?
  - (5) Have other issues identified been addressed in the refurbishment, for example infection control, OH&S and air conditioning and partitioning of the ward to allow a degree of privacy for adolescent patients?

Answer-

I am advised by the Chief Executive Greater Southern Area Health Service:

- (1) The children's ward repairs and refurbishment scope is currently being finalised. Accurate project costing cannot be finalised until detailed design is complete and quotations are received.
- (2) The extent of damage has now been fully inspected and the required remedial works incorporated into the revised project scope.
- (3) All works carried out to-date have been non-discretionary and repairs associated with the white ant damage will be funded and delivered in line with the current planned paediatric ward upgrade.
- (4) The current program should be complete later in the year.
- (5) All identified issues have been incorporated in the design solution, with specific consideration to infection control, privacy, OH&S and environmental controls.
- \*2731 SYDNEY TO MELBOURNE RAIL LINE UPGRADE—Mr Daryl Maguire asked the Deputy Premier, Minister for Transport, Minister for Finance—
  - (1) Has the Australian Rail Track Corporation (ARTC) given you an update on progress of the Sydney to Melbourne rail line upgrade?
  - (2) Is the upgrade on time?
  - (3) Is the upgrade on budget?
  - (4) How many level crossings have been closed?
  - (5) How many have been identified for closure?
  - (6) Which level crossings, by name, have been identified?
  - (7) When can landholders expect to be consulted regarding proposed crossing closures?

Answer—

I am advised:

Matters regarding inter-state freight transportation are the responsibility of the Federal Government, while the NSW Government is primarily responsible for passenger transport.

- \*2732 PARRAMATTA TO EPPING RAIL LINK—Mr Wayne Merton asked the Deputy Premier, Minister for Transport, Minister for Finance—
  - (1) Does the Government intend to build the Parramatta to Epping rail link, which was scrapped from the original Parramatta to Chatswood line?
  - (2) If yes, what is the anticipated commencement date of such works?

Answer-

I am advised:

(1) and (2) The decision to defer the rail line between Parramatta and Epping followed a review of options for delivering the line and consideration of ways to best improve the reliability, safety and cleanliness of the existing rail network.

While the previously proposed section of rail line from Parramatta to Epping has been deferred, the rail corridor to Parramatta has been preserved so that this project may go ahead in the future.

The deferral of this project has allowed the Government to direct funds to the \$1.8 billion Rail Clearways Program to untangle the CityRail network.

This initiative, along with the recently announced Sydney Link program, which consists of major transport projects including the South West Rail Link and North West Metro, aims to provide commuters with modern, integrated and efficient transport options to accommodate Sydney's growth as a global city.

- \*2733 APPLICATIONS FOR ADDITIONAL BUSES—Mr Wayne Merton asked the Deputy Premier, Minister for Transport, Minister for Finance—
  - (1) How many additional buses have been requested by bus operators in North West Sydney that have not been approved to date?
  - (2) If applications for additional buses have been approved but are yet to be supplied, what is the anticipated delivery date of such buses?
  - (3) What is the average cost of each bus?

## Answer-

I am advised:

- (1) to (3) All additional buses currently requested through the Metropolitan Bus System Contract in north west Sydney have been approved and are in service.
- \*2735 ENVIRONMENT EDUCATION—Ms Clover Moore asked the Deputy Premier, Minister for Transport, Minister for Finance representing the Minister for Education and Training, Minister for Industrial Relations, Minister for the Central Coast, and Minister Assisting the Minister for Finance—

Given the urgency of action to prevent global warming and the need for all citizens to take practical steps to reduce our environmental impacts:

- (1) What assessment has the NSW Government carried out of school curricula to ensure that all students learn about global warming and its potential impacts?
- (2) What curriculum materials has the NSW Government developed to provide learning about global warming and environmental sustainability to all NSW students?
- (3) What is the minimum time a NSW school student spends learning about these subjects each year?
- (4) What action has the NSW Government taken to ensure that all schools incorporate into their activities practical examples of environment education such as growing food, harvesting rainwater, collecting solar electricity, and reducing transport emissions?
- (5) What proportion of NSW schools:
  - (a) harvest rainwater for non-drinking purposes;
  - (b) recycle grey water for non-drinking purposes;
  - (c) purchase "Greenpower" electricity;
  - (d) have photovoltaic cells to collect solar electricity; and
  - (e) use solar hot water systems?
- (6) What plans does the NSW Government have to ensure that all NSW schools:
  - (a) harvest rainwater for non-drinking purposes;
  - (b) recycle grey water for non-drinking purposes;
  - (c) purchase "Greenpower" electricity;

# Answer-

(1) to (4) The NSW Department of Education and Training Environmental Education Policy for Schools (2001) requires all government schools to develop and implement a Schools Environment Management Plan which addresses the sustainable management of schools, grounds and resources, and to link these sustainable management actions with the school curricula.

Students learn about environmental sustainability through science, technology and Human Society and Its Environment, all of which are mandatory courses in years K-10.

In November 2007, a new website, 'Sustainable Schools NSW', was jointly launched by the Minister for Education and Training and the Minister for Environment and Climate Change that provides access for all NSW schools and students to information about incorporating environmental sustainability learning into a school's curriculum.

The Iemma Government has committed to providing \$20 million for energy efficiency and \$20 million for water efficiency and rainwater tanks in government schools and \$5 million for student initiated energy efficiency projects during this term of government.

- (5) (a) A large number of government schools have rainwater tanks installed and the Department of Education and Training ensures that all new schools are provided with rainwater tanks.
  - (b) The use of recycled grey water for non-drinking purposes in schools is currently under review by the Department of Education and Training.
  - (c) Approximately 90 per cent of government schools are on 6 per cent "Greenpower electricity".
  - (d) 123 government schools have photo voltaic cells installed to collect solar electricity.
  - (e) Government schools do not generally have hot water systems installed, other than small water heaters in school canteens.
- (6) (a) The Iemma Government has committed \$20 million over four years for the Climate Change initiative to provide water tanks for NSW government schools.
  - (b) The Department of Education and Training, in conjunction with other agencies, is developing a state-wide policy on the use of grey water.
  - (c) The Department of Education and Training is committed to purchasing a minimum of 6 per cent "Greenpower" electricity and is working towards all schools using 6 per cent "Greenpower" electricity.
  - (d) and (e) The Department of Education and Training actively participates in any programs announced by the Government and supports schools in the installation of photovoltaic cells to collect solar electricity and the installation of solar hot water systems.
- \*2736 PRISONER REHABILITATION—Ms Clover Moore asked the Minister for Police, Minister for the Illawarra representing the Attorney General, and Minister for Justice—

With respect to the USA Second Chance Act 2007, which provides funding for ex-prisoner mentoring programs, job training and rehabilitation:

- (1) What analysis has the NSW Government made of this legislation and its impact on recidivism and reintegration of ex-prisoners?
- (2) What ex-prisoner mentoring programs does the NSW Government fund, and how much money has been allocated for this purpose over the past five years?
- (3) What is the evidence about the effectiveness of ex-prisoner mentoring programs?
- (4) Is the Government aware of the StAMP Mentoring Program operated by the Community Restorative Centre with funds from Marrickville Council, Lord Mayor Clover Moore Salary Trust and City of Sydney?
- (5) What evaluation has been carried out on the StAMP program and what are the results?
- (6) What plans does the NSW Government have to provide and expand mentoring programs for exprisoners?

## Answer-

# I am advised:

- (1) The Second Chance Act (US) is reported to have been signed into law by President Bush on 9 April 2008. Obviously, an analysis of it and its impact would be premature.
- (2) The Member is referred to the Annual Reports of the Department of Corrective Services and Attorney General's Department.
- (3) I am advised there is a wealth of publicly available literature on mentoring programs.
- (4) Yes.
- (5) The Department of Corrective Services is not privy to any official evaluation.
- (6) The Government is constantly exploring opportunities to reduce recidivism.

## \*2737 DRUG TREATMENT—Ms Clover Moore asked the Minister for Health—

Noting that there have been numerous drug treatment trials across many jurisdictions since the 1999 NSW Drug Summit:

- (1) What is the current expert opinion about the most effective treatments for drug addiction, and specifically for:
  - (a) alcohol;
  - (b) tobacco;
  - (c) heroin and other opiates including prescribed drugs;

- (d) methamphetamine or "ICE";
- (e) cocaine?
- (2) What does current evidence inform us about the effectiveness of:
  - (a) QUIT programs;
  - (b) alcohol addiction programs;
  - (c) needle exchange programs;
  - (d) methadone and similar replacement treatments;
  - (e) safe injecting facilities;
  - (f) heroin-supported therapy under medical supervision for people with longstanding addictions?
- (3) What research or reviews of research in other jurisdictions has the NSW Government carried out into successful drug treatment programs that could be used in NSW?
- (4) What research or reviews of research in other jurisdictions does the NSW Government plan to carry out into successful drug treatment programs that can be used in NSW?

# Answer-

(1) and (2) I refer the Member to the Australian National Council on Drugs Research Paper 3, entitled 'Evidence supporting treatment: the effectiveness of interventions for illicit drug use' available on the Council's website at www.ancd.org.au. I am advised that this document provides a summary of the major reviews of clinical interventions for illicit drugs. Consideration is given to the reliability and validity of the evidence reviewed.

The National Drug and Alcohol Research Centre have published a document entitled 'The Treatment of Alcohol Problems: A Review of the Evidence', which lays out the evidence for different treatment approaches.

In relation to the tobacco dependence, treatment includes (singly or in combination) behavioural and pharmacological interventions such as brief advice and counselling, intensive support, and administration of pharmaceuticals, that contribute to reducing or overcoming tobacco dependence in individuals. The course of action that may be recommended to a client will be determined based on the level of nicotine dependence.

Current international evidence suggests that health care workers should provide brief interventions including asking about smoking status, advising of the benefits of quitting in a personalised and appropriate manner, assessing motivation to stop, assisting smokers through support, recommendation to use nicotine replacement therapy (NRT), referral to more intensive support services and routine follow up.

It should be recognised, however, that support and treatment to help smokers stop is one of a range of approaches to tobacco control. It is an issue not just for individual health professionals in their work with smokers, but for the entire healthcare system. It complements other approaches (like policies to tax tobacco products, restrictions on their use and advertising, regulation of their contents and labelling, public information and education) but addresses a specific group: those who want to stop and need help.

There are numerous programs to support smokers to quit. However, not all are evidence based. The major 'quit' program funded by the NSW Government is the Quitline. The services of the Quitline are based on available international evidence, which suggests that advice from doctors, structured interventions from nurses, and individual and group counselling are effective interventions, and that personalised materials are more effective than standard materials, as well as all forms of NRT being effective.

(3) and (4) The NSW Government supports the National Drug Strategy and participates in The Intergovernmental Committee on Drugs and The Ministerial Council on Drug Strategy. The National Drug Strategy Website, at <a href="http://www.nationaldrugstrategy.gov.au">http://www.nationaldrugstrategy.gov.au</a> emphasises that research is a continuing high priority under the National Drug Strategic Framework.

NSW Health is informed by the research being undertaken by the National Drug and Alcohol Research Centre located in Sydney, the National Drug Research Institute in Perth, and the National Centre for Education and Training on Addiction in Adelaide. A number of publications and research articles are available on the website.

# \*2745 PATIENT TRANSFER BUDGET—Mr Robert Oakeshott asked the Minister for Health—

- (1) In both dollar terms and as a percentage of overall budget, what amount of each Area Health Service budget is forfeited or transferred to cover the expense of patient transfer and treatment outside the Area Health Service in question?
- (2) In both dollar terms and as a percentage of overall budget, what amount is allocated to each Area

Health Service for the treatment of patients from another Area Health Service?

- (3) Is money for the transfer and treatment of patients between Area Health Services accounted for on a per patient treatment basis, or on an annual estimate?
- (4) If done as an annual estimate, what safeguards are in place to promote delivery and promotion of new services closer to a patients home, if an Area Health funding formula discourages this development through a reduction in the annual estimate of costs incurred as a consequence?

## I am advised:

(1) The initial budget allocated to Area Health Services each year is not adjusted (either by way of forfeiture or transfer) for the transport to and treatment of patients in other Area Health Services.

Provision is made within each Area Health Service initial budget for transport costs, including ambulance transport and also the Transport for Health program which provides support for patients in remote and rural areas to access treatment services in other Area Health Services when this is clinically justified.

At 30 June each year a technical adjustment is made to Area Health Service budgets for the services provided to "out of Area" patients. This adjustment is part of the normal end of year accounting processes and does not impact treatment costs, either actual or budget, throughout the year. The adjustment is calculated on a per patient basis.

- (2) No budget allocation is made. Refer to (1) above.
- (3) and (4) Refer to (1) above.

## \*2746 RESOURCE DISTRIBUTION FORMULA—Mr Robert Oakeshott asked the Minister for Health—

- (1) In both a dollar and percentage term, how far above or below equity of Resource Distribution Formula is each Area Health Service in NSW as at January 1 2008?
- (2) What moves are currently being made to deliver equity to Area Health Services that are below equity?

# Answer—

## I am advised:

(1) and (2) Each year the Department of Health, in its Annual Report, reports on the performance indicator "Resource Distribution Formula (RDF) and the weighted average distance from RDF target for Area Health Services".

The RDF outlines a broad target and does not identify the total level of resources available, as funding of Area Health Services takes into account a range of other factors. These include the recurrent requirements of new facilities as they come into operation, developments in Australian Government funding arrangements and funding available in the State Health Budget.

- \*2747 PORT MACQUARIE BASE HOSPITAL PATIENT TREATMENT COSTS—Mr Robert Oakeshott asked the Minister for Health—
  - (1) What is the average cost per patient treatment at Port Macquarie Base Hospital as at March 1 2008?
  - (2) What was the average cost per patient treatment at Port Macquarie Base Hospital on March 1 2005?
  - (3) What is the average cost per patient treatment for the same two dates (March 1 2005 and March 1 2008) for the 7 peer hospitals that were used as the benchmark for performance for Port Macquarie Base Hospital for the period that it was a privately run public facility from 1992 through to 2005?

## Answer-

## I am advised:

- (1) to (3) The Department of Health does not routinely report cost per patient data, as average cost comparison data alone is an incomplete and potentially misleading comparator of hospital performance and peer benchmarking. The Department of Health uses a suite of performance indicators including financial, workforce, access and patient flow measures to monitor health system and hospital performance. Useful hospital performance data is routinely reported on the NSW Health website at http://www.health.nsw.gov.au/hospitalinfo/perfsumm.html
- \*2748 KOOMPAHTOO LOCAL ABORIGINAL LAND COUNCIL—Mr Greg Piper asked the Minister for Police, Minister for the Illawarra representing the Attorney General, and Minister for Justice—

Will the Attorney General explain why no prosecutions have been mounted against those who the ICAC recommended be prosecuted after its findings regarding the Koompahtoo Local Aboriginal Land Council were announced in 2005?

  - (1) What is the status of the report prepared by Dr John Nelson, commissioned by the former Minister for the Environment and Climate Change regarding the removal of the plague of flying fox bats from the Park?
  - (2) Does the Minister agree with the findings and recommendations made by Dr Nelson?

The Department of Environment and Climate Change has already provided assistance to Council, including funding for Dr Nelson's investigation. As the regulator, it would not be appropriate for the Department to fund the relocation program.
- \*2761 AIR COOLING PROGRAM—Mr Rob Stokes asked the Deputy Premier, Minister for Transport, Minister for Finance representing the Minister for Education and Training, Minister for Industrial Relations, Minister for the Central Coast, and Minister Assisting the Minister for Finance—
  - (1) Has the Department of Education and Training completed the prioritisation of competing projects for the 2007-08 Air Cooling Program?
  - (2) What schools in the Pittwater electorate will benefit from the 2007-08 Air Cooling Program?

The 2007/08 \$5 million Air Cooling Program is currently underway, providing air cooling to schools in the hotter parts of the state. Schools in the Pittwater electorate are not currently included in the air-cooling program, pending the completion of air cooling projects in hotter parts of the state.

Given fighting and bullying is an increasing problem at the school bus changeover point at South West Rocks Road and Old Station Road:

- (2) Will the Minister implement detailed policy to control issues of fighting and bullying at school bus interchange points?

Answer-

Over the past twenty four months there has been a decrease in incidents of fighting and bullying at the South West Rocks and Old Station Road interchange. There have been no reported incidents in the past twelve months.

Local schools have clear systems in place to manage student safety as children leave school and enter buses. Schools in partnership with the bus company have developed safety procedures and expectations of students when travelling on buses and changing buses at the interchange. Of an afternoon 7 buses bring students from various locations to this school bus interchange. Students remain seated within the bus until all buses arrive and they then move to their next appropriate bus and are again supervised by the bus driver.

Should any behaviour incidents occur on buses or at the bus interchange the bus driver is encouraged to consult with the school and consequences of behaviour may be dealt with by the school in the context of the school discipline policy and/or by the bus company.

- (1) and (2) Two ambulances operate out of Tuncurry Ambulance Station during the day. One ambulance vehicle operates out of the station during the night and there is another vehicle available oncall.
- (3) and (4) The Ambulance Service does not collect data on the number of responses on the basis of Local Government Areas.

All ambulance movements across the Northern Division are dispatched and coordinated from the Northern Operations Centre to ensure that the closest available ambulance resource to an emergency is sent

To manage demand on ambulance services, ambulance crews are routinely deployed to an area during peak demand from surrounding ambulance stations to ensure there is adequate coverage to assist with workload as required.

In the circumstances, should the Trustees be successful in purchasing the land, I will provide an undertaking that the Department will not take any action to enforce the provisions of the positive covenant, provided that the land is not used for educational purposes.
