*3962 INDIGENOUS INCARCERATION RATE—Ms Sonia Hornery asked the Minister for Corrections, Minister for Emergency Services, and Minister for Veterans Affairs—

Following the release of the 2016 'Closing the Gap' report, what is the Government doing to reduce the indigenous incarceration rate?

Answer—

The Government recognises that Aboriginal offenders continue to be over-represented in custody. Corrective Services NSW (CSNSW) has developed a strategic plan to support Aboriginal offenders to desist from re-offending and to reduce their rate of incarceration. This involves focusing on education and vocational training, and employment.

- CSNSW has several programs which are specifically intended for Aboriginal offenders. They include the Balund-a Program; the Gundi Program; the Yetta Dhinnakkal Program; the Girrawaa Program and the Nura Warra Umer Program. Details regarding these programs are available on the internet.
- Funding has recently been received as part of the Reducing Re-offending Strategy to establish 10 high intensity units that will deliver rehabilitation programs to inmates serving short sentences. Aboriginal offenders will be prioritised to these units which will be spread across a number of correctional centres.
- The CSNSW Aboriginal Advisory Council provides a forum for CSNSW to engage with Aboriginal people of significant standing in the community, and with professionals with expertise related to social justice, as well as the legal and health care systems.
- CSNSW also collaborates with a number of other agencies in its efforts to reduce the rate at which Aboriginal people are incarcerated. These include:
 - the Eden Local Aboriginal Lands Council which manages the Bundian Way Project
 - Redfern Local Area Police Command and the Redfern Community regarding the Never Going Back Program for Aboriginal male inmates
 - the Aboriginal Housing Office
 - a number of Aboriginal organisations in the community which run post-release support programs such as Tribal Dreaming (New Horizons) and the Muru Program.

Juvenile Justice also has a number of programs and initiatives to address the overrepresentation of Aboriginal and Torres Strait Islander young people in custody.

- The Youth on Track early intervention scheme provides family-based intervention and support to young people who are at risk of long-term involvement in the criminal justice system.
- Other initiatives include the provision of therapeutic interventions to address offending behaviour; Dthina Yuwali, a drug and alcohol program; the My Journey, My Life program which aims to reduce the incidence of inter-generational violence; access to educational programs, and opportunities for young offenders to participate in driver safety education programs and to obtain their driver licence.
- To maintain connections with family and country, young offenders are held in custody close to their home, where possible. They also have access to local elders and community members who visit centres to run cultural programs and provide mentoring to young offenders. All Juvenile Justice centres have an Aboriginal Consultative Committee which includes local community groups and elders who visit centres regularly to engage with young offenders and provide them and staff with cultural guidance.
- Juvenile Justice recognises that by recruiting and retaining Aboriginal staff, it will develop a better capacity to work with Aboriginal young people. Approximately 12.6 per cent of the total Juvenile Justice workforce identifies as Aboriginal or Torres Strait Islander.

Has the Commercial Fishers Business Adjustment Program been assessed for workplace health and safety risks which may occur as a result of the introduction of the Program?

Answer—

This question should be directed to the Minister for Primary Industries and Minister for Lands and Water.

*3966 SOUTH WENTWORTHVILLE SOCIAL HOUSING—Ms Julia Finn asked the Minister for Family and Community Services, and Minister for Social Housing—

- (1) How many social housing tenancies are there in Land and Housing Corporation owned properties in the suburb of South Wentworthville?
 - (a) How many residents are in these properties?
- (2) How many of these tenancies are managed by a community housing provider?
- (3) How many of these properties and tenancies are considered 'transitional'?
 - (a) What plans does the Government have for these properties?
- (4) How many properties owned by Land and Housing Corporation in South Wentworthville are protected on the NSW Heritage register?
 - (a) What protections apply to these properties?
- (5) What plans does the Government have to increase the number of social housing tenancies or tenants in South Wentworthville?

Answer-

The number of tenancies varies.

- *3967 LAND FOR THE KANGY ANGY RAIL MAINTENANCE FACILITY—Mr David Mehan asked the Minister for Transport and Infrastructure—
 - (1) How much was paid for the land of Kirsty Payne in relation to the Kangy Angy Rail Maintenance Facility?
 - (2) How much was paid, or agreed to be paid, for the Council owned land at the site?
 - (3) What is the depth of water of the wetland located at the site?
 - (a) Are there frogs in the water?
 - (b) Has a survey of wildlife using the wetland been undertaken?
 - (i) If so, what is the result of the survey?
 - (4) Is the Swift Parrot and Regent Honeyeater located at the site?
 - (a) If so, how many are there?
 - (b) Do they have homes there?
 - (c) What will you do to protect them?
 - (5) What is the estimate cost of the bridge proposed to access the site?
 - (6) Does a bridge need to be built to access other sites, particularly Warnervale and Bushells Ridge, assessed for the proposed Kangy Angy Rail Maintenance Facility?
 - (7) Do the Warnervale and Bushells Ridge sites have wetland upon them?
 - (8) Do the Warnervale and Bushells Ridge sites have frogs, Swift Parrots and Regent Honeyeaters upon them?

Answer-

- (1) and (2) Properties were acquired in accordance with the (NSW) Land Acquisition (Just Terms Compensation) Act 1991.
- (3) and (4) The proposed site at Kangy Angy is not classified as wetland under the State Environment Planning Policy.

The Review of Environmental Factors and Species Impact Statement included detailed field surveys and have considered potential impacts to the environment including flora and fauna.

No threatened aquatic species were identified within the project site. The Impact Statement is available on the Transport for NSW website.

- (5) The estimated cost is commercial-in-confidence.
- (6) to (8) Warnervale and Bushells Ridge have not been selected as preferred sites.
- *3968 UPGRADE OF MARRICKVILLE RAILWAY STATION—Ms Jo Haylen asked the Minister for Transport and Infrastructure—
 - (1) What is the delay in completing the upgrade of Marrickville Train Station?
 - (2) Why has work appeared to cease?
 - (3) When will the street works on Station Street be completed?
 - (4) What is the purpose of the hoarding on Illawarra Road?
 - (5) How many workers are on site each day?
 - (6) Is the upgrade being delivered on schedule?

(7) What is the current budget for the upgrade?

Answer-

- 1) The Marrickville Station upgrade is progressing well with all improvements to the station and station platforms now complete.
- (2) The works outside the station are still continuing and include works adjacent the entrance on Illawarra Road and Station Street.
- (3) Later this year.
- (4) Hoarding on Illawarra Road is in place to allow for road realignment works and traffic signal modification. The hoardings are expected to be removed shortly.
- (5) An average of 12 workers have been on site each day over the past month. This figure is expected to increase to 20 on average for the delivery of the external works.
- (6) Yes.
- (7) \$33 million.
- *3969 FUNDING FOR COMMUNITY LEGAL CENTRES—Ms Jo Haylen asked the Attorney General—
 - (1) In the last two financial years to 14 September 2016, when have community legal centres been advised of their funding allocations or grants from Government departments?
 - (2) What is the reason that community legal centres are advised late in the preceding financial year?
 - (3) What action is the Government taking to provide funding certainty to community legal centres?

Answer-

I am advised that Legal Aid NSW administers community legal centre funding on behalf of the Government, the Public Purpose Fund Trustee and the Commonwealth Government.

*3970 REPAIR AND REPLACEMENT OF PUBLIC HOUSING FENCING—Mr Edmond Atalla asked the Minister for Family and Community Services, and Minister for Social Housing—

Who has responsibility for the repair and replacement of Public Housing fencing that adjoins local government land/property?

Answer-

The Department of Family and Community Services will negotiate with adjoining private owners or public authorities on the installation or repair of dividing fences separating the land on the common boundary line.

*3971 GAP FEE FOR SKIN CANCER PROCEDURES—Mr Edmond Atalla asked the Minister for Health—

Will the Government be covering the shortfall of the 'gap' fee for patients requiring skin cancer procedures considering the Medicare rebate freeze?

Answer-

Gap payments are not relevant to public patients in NSW Health hospitals. Skin cancer treatment provided to public patients in NSW public hospitals will continue to be free of charge.

*3973 AIR-CONDITIONED TRAINS ON THE WESTERN LINE—Mr Edmond Atalla asked the Minister for Transport and Infrastructure—

What percentage of trains on the Western Line are air-conditioned?

Answer-

100% of timetabled services on the T1 Western Line use air-conditioned trains.

*3974 FAILURE TO VOTE FINES—Mr Edmond Atalla asked the Minister for Finance, Services and Property—

Will the Government waive the penalties for those who failed to vote at the recent local government elections due to the low levels of publicity?

Answer_

The NSW Electoral Commission is required by law to issue a penalty notice when someone fails to vote. The notice gives the option to give a reason in writing for not voting. Any request for a waiver of the

penalty notice to the Office of State Revenue would be based on the individual circumstances and in consultation with the NSW Electoral Commission.

*3975 REASONABLE ACCESS TO TRAIN STATIONS—Mr Edmond Atalla asked the Minister for Transport and Infrastructure—

What future planning is the Government providing to deliver railway stations in the west around residential density?

Answer-

The Government, in conjunction with the Commonwealth Government, is currently investigating improvements to rail in Western Sydney through the Western Sydney Rail Needs Study. An initial set of options has been identified and the study is currently out for consultation.

*3976 PUBLIC TOILETS ON POLLING DAYS—Mr Edmond Atalla asked the Premier, and Minister for Western Sydney—

Are there any provisions for the use of public toilets to be made available to booth workers on Election Days, following a number of complaints of inaccessible toilets during the recent Local Government Election on 10 September 2016?

Answer-

The NSW Electoral Commission advises that training and procedures are in place to ensure that amenities are made available to workers on election days.

- *3977 BARIATRIC SURGERY IN NEW SOUTH WALES—Mr Ryan Park asked the Minister for Health—
 - (1) What is the number of bariatric surgery procedures in New South Wales performed by the public health system?
 - (2) What is the average wait time in the public health system for patients waiting for bariatric surgery?
 - (3) How does a patient qualify to be publicly treated for bariatric surgery?

Answer-

Information on the elective surgery waiting times of all hospitals throughout New South Wales is available on the Bureau of Health Information website at http://www.bhi.nsw.gov.au/healthcare observer/elective surgery.

Local health districts wishing to undertake bariatric surgery must have appropriately contracted and credentialed clinicians that have approval to undertake this procedure by the local new interventions assessment committees (or equivalent). Bariatric surgery is not considered as a discretionary or cosmetic procedure as per the Waiting Time & Elective Surgery Policy PD2012_11 (pages 4-8).

Patients wishing to access bariatric surgery in the public health system are required to attend a designated multidisciplinary bariatric clinic. Patients are considered for bariatric surgery following assessment and approval from the multidisciplinary team after all non-surgical options have been exhausted.

*3978 FULL-TIME AND PART-TIME EQUIVALENT AMBULANCE OFFICERS—Mr David Harris asked the Minister for Health—

How many full-time equivalent and part-time equivalent ambulance officers were stationed at Toukley and Wyong in each year from 2012 to 2016 (as at 13 September 2016)?

Answer-

In 2015, the Government committed to employ 53 extra paramedics, including 35 specialist paramedics and 18 paramedics for the Helicopter Retrieval Network.

The 2016-17 NSW Budget will include a \$150 million boost for NSW Ambulance personnel and infrastructure, including the recruitment of more than 100 new paramedics.

The Budget funding package will include \$12.8 million to employ 85 extra paramedics to work in metropolitan and regional centres, as determined by NSW Ambulance. The Budget will also include \$5.1 million to finish recruiting 35 specialist paramedics, two years earlier than promised at the 2015 State election.

*3979 LIBRARY FUNDING—Ms Jenny Aitchison asked the Minister for Local Government—

How much money did the Government allocate to funding libraries in the Maitland Local Government Area in each of the years from 2011 to 2016 (as at 13 September 2016)?

Answer-

The proposed upgrade is currently in detailed design. Proposed work includes the provision of new lifts and canopies, a family accessible toilet, installation of accessible parking and taxi bays on both sides of the station, footpath improvements, lighting and CCTV.

*3981 EAST MAITLAND DISTRICT COURT HOUSE—Ms Jenny Aitchison asked the Attorney General—

What plans are there for the East Maitland District Court House in the next year, two years and five years from 13 September 2016?

Answer-

I am advised that the Chief Magistrate and the Chief Judge are responsible for the sittings of e Local Court and the District Court respectively.

*3982 STAMP DUTY—Ms Jenny Aitchison asked the Minister for Finance, Services and Property—

How much money is paid to the Government from stamp duty on properties purchased in the suburb of Gillieston Heights in the Maitland electorate?

Answer-

 - (a) Private property;
 - (b) Local, state or Commonwealth Government property?

Answer-

A list of New South Wales government schools with security fencing, as at 1 July 2016, is available on the Department of Education's website.

- *3985 SALE AND PURCHASE OF SOCIAL HOUSING PROPERTIES—Ms Jenny Aitchison asked the Minister for Family and Community Services, and Minister for Social Housing—
 - (1) How many Social Housing properties have been sold in each 12 month period from 30 June 2011 to 2016 (as at 13 September 2016) in the Maitland electorate?
 - (a) In each of those years, how many additional Social Housing properties were built or purchased?

Answer—

NSW Land and Housing Corporation (LAHC) continually reviews the suitability of the properties it owns to ensure they meet the needs of the social housing system. LAHC may sell properties which have become uneconomical to maintain or repair, as well as properties which have a high market value, or properties which no longer align to the demand in the area. The money raised is used to fund the building of new homes, in highly accessible locations and which meet the needs of social housing tenants. If a property is not redeveloped for social housing purposes it is disposed of through an open market process.

- *3986 SCHOOLS AT CAPACITY IN THE MAITLAND ELECTORATE—Ms Jenny Aitchison asked the Minister for Education—
 - (1) How many public schools in the Maitland electorate are at 100 per cent capacity or more?
 - (2) How many public schools in the Maitland electorate were deemed at capacity or more at the end of 2015?
 - (3) What are the schools in the Maitland electorate that are currently at capacity or more?

Answer-

Every student who wishes to attend a New South Wales government school will be given a place at their local school. Accordingly, the Department of Education does not have fixed enrolment capacities at New South Wales government schools. Schools have the capacity to adapt to fluctuating enrolments though the use of a combination of temporary and permanent teaching spaces.

- *3988 ONLINE PAYMENT OF VEHICLE REGISTRATION—Ms Jenny Aitchison asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—
 - (1) Are Roads and Maritime Services (RMS) now sending out an additional registration paper to customers who have paid online through Service NSW, which gives the receipt number and date of payment?
 - (2) Is this an additional process and an additional cost to RMS?
 - (a) If so, what is this additional cost to RMS?
 - (3) Why has this change occurred?

Answer-

Roads and Maritime Services does not generally send out additional registration papers to customers who have paid online through Service NSW. The customer normally receives an online receipt.

However, there are circumstances when Roads and Maritime posts updated registration papers to customers. An example of this is when a customer elects a shorter period of registration online than the default 12 months. In these cases, a second certificate of registration is posted to the customer with the updated period of registration.

This is not a new process

Answer-

I am advised that this question should be referred to the Minister for Finance, Services and Property as Property NSW is handling the sale.

- *4004 NEWCASTLE LOCKOUT LAWS—Mr Tim Crakanthorp asked the Deputy Premier, Minister for Justice and Police, Minister for the Arts, and Minister for Racing—
 - (1) Can the Government confirm that it is reviewing the lockout laws for Newcastle?
 - (a) If so, when will this be completed?

Answer—

The NSW Bureau of Crime Statistics and Research and the University of Newcastle have previously undertaken research that concluded these measures have significantly reduced alcohol-related violence in Newcastle.

The Hon. Ian Callinan AC, in his report on the recent review of other lock out measures in Kings Cross and the Sydney CBD, also noted the success of the Newcastle measures in reducing alcohol-related assaults and improving amenity.

*4005 REVITALISING NEWCASTLE ADVERTISING CAMPAIGN—Mr Tim Crakanthorp asked the Minister for Planning—

What is the cost of the Government's current advertising campaign for the Revitalising Newcastle project?

*4007 NEWCASTLE EAST END PROJECT—Mr Tim Crakanthorp asked the Minister for Planning—

What process has the Government undertaken to ensure that investors that are interested in the Newcastle East End site are aware of the Government's commitment to lower heights limits than are currently zoned for this area?

Answer-

Keeping heights in line with the master plan

UrbanGrowth NSW and The GPT Group have been clear in all public statements and in the EOI documentation (which includes the Expressions of Interest conditions, returnable schedules and the Information Memorandum), that the vendors will not support any increase in height to what was approved by the Joint Regional Planning Panel (JRPP).

One of the key sales terms in the EOI states that, "The Purchaser is restricted from increasing the height of the proposed buildings in accordance with the DA approved master plan".

Respondents will also be evaluated on their response to compliance with the height restrictions as set out in the DA approved master plan and their understanding of the Newcastle LEP and DCP and the Newcastle Urban Renewal Strategy and how the Respondent's vision complies with the objectives of these documents.

Newcastle City Council is the consent authority for future DAs, and the master plan approved by council allows for heights of up to \sim RL40.

Gateway determination for height building controls in CBD
