(1) The New South Wales planning system facilitates affordable housing through the State Environmental Planning Policy (Affordable Rental Housing) 2009 (ARHSEPP) and State Environmental Planning Policy No. 70-Affordable Housing (Revised Schemes) (SEPP 70). Delivery of affordable housing is primarily by the private sector including by community housing providers.

Between 2011-12 and 2016-17 financial years approximately 156 development applications and complying development applications may have been determined under the ARHSEPP within Wallsend. By year:

In addition, affordable housing schemes under State Environmental Planning Policy No 70-Affordable Housing (Revised Schemes) (SEPP70), operated by the City of Sydney Council in Ultimo/Pymont, Green Square and Southern Employment Lands have resulted, during the SEPP's operation, in around 740 affordable rental dwellings for very low to moderate income households in the Local Government Area (LGA).

SEPP 70 was recently expanded to five additional LGAs: Canada Bay, Inner West, Northern Beaches, Randwick and Ryde. This is the first time new councils have been included in the SEPP since it was established in 2002 and will lead to more affordable housing being delivered in these council areas.

(3) The Department of Planning and Environment is not involved in constructing or acquiring housing, including student housing.

(4) As with affordable housing, the Department of Planning and Environment does not deliver student housing directly. However, it is understood that student housing providers utilise the existing boarding house provisions under the State Environmental Planning Policy (Affordable Rental Housing) 2009 to deliver student accommodation. Between 2011-12 and 2016-17 financial years approximately 247 boarding house development applications may have been determined by New South Wales councils under the ARHSEPP. As the Department of Planning and Environment is not directly involved in provision, it is not known how many were for student accommodation or affordable.
