*0921 PALLIATIVE CARE UNITS-Mr Edmond Atalla asked the Minister for Health-

What plans are in place to resource Palliative Care Units with specialist nurses to be at par with Victorian resource levels?

Answer-

I am advised that:

Local Health Districts are responsible for determining their palliative care workforce needs In every facility across New South Wales, nursing and hospital management make an assessment of staffing requirements based on a range of factors including patient safety, clinical needs, professional Judgment, previous experience and safe systems of work.

*0922 MOUNT DRUITT HOSPITAL—Mr Edmond Atalla asked the Minister for Health—

Are there any plans to open an 'ice' treatment clinic at Mount Druitt Hospital?

Answer—

I am advised:

Western Sydney Local Health District will provide drug rehabilitation services at Mount Druitt and provide access to an enhanced treatment program that addresses the rising trend in crystal methamphetamine use. This new development is as a result of the election commitment to expand Stimulant Treatment Program across New South Wales.

*0923 ONCOLOGY DEPARTMENT AT MOUNT DRUITT HOSPITAL—Mr Edmond Atalla asked the Minister for Health—

Are there any plans to resource an oncology department at Mount Druitt Hospital?

Answer—

I am advised.

Oncology services are currently provided at both Westmead Hospital and the Blacktown Hospital campus and service patients throughout the District and beyond.

*0924 PARKING RATES AT BLACKTOWN AND MOUNT DRUITT HOSPITALS—Mr Edmond Atalla asked the Minister for Health—

Why do concessional parking rates apply to Blacktown Hospital and not Mount Druitt Hospital, considering that Blacktown and Mount Druitt Hospitals are considered as one hospital with two campuses?

Answer-

I am advised.

*0925 FIRE AND RESCUE UNIT, MOUNT DRUITT—Mr Edmond Atalla asked the Minister for Corrections, Minister for Emergency Services, and Minister for Veterans Affairs—

Are there any plans to relocate the Mount Druitt Fire and Rescue Unit to the Mount Druitt Hospital grounds?

Answer-

Fire and Rescue NSW has advised me:

A new fire station will be built at Mount Druitt on land that was previously part of the Mount Druitt Hospital grounds.

*0926 CHILD RESTRAINT OFFENCES—Mr Edmond Atalla asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive CouncilWhat educational programs are being targeted in the Mount Druitt electorate to address the issue of motor vehicle child restraint offences, considering Mount Druitt has the highest level of these offences in New South Wales?

Answer-

I am advised:

Transport for NSW launched the 'They're Counting on You' child car seats road safety campaign in June 2014, which promotes the correct use of child car seats to help reduce injuries and deaths. The campaign is delivered through:

- Digital displays
- Outdoor advertising
- Shopping centre advertising
- Radio
- Posters and fliers.

An important part of the campaign is a website specifically targeting the issue (childcarseats.com.au). On the website, parents and carers can compare safety ratings for a wide range of seats. The website also:

- explains the legal requirements for using child car seats in Australia
- has valuable information about using a child car seat correctly
- helps parents and carers find an Authorised Restraint Fitting Station.

The child car seats campaign is also heavily promoted at the local level through the NSW Local Government Road Safety Program; a partnership between Transport for NSW, Roads and Maritime Services and councils. The program funds a full time road safety officer at Blacktown Council. In 2014-15, the Blacktown Road Safety Officer provided members of the community with vouchers which can be used at their local Authorised Restraint Fitting Station to receive a free child car seat installation or safety check. A similar scheme is in place for 2015-16.

*0927 DRIVING LICENCE RENEWAL PERIOD—Mr Edmond Atalla asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—

Why are people aged over 44 not eligible to renew their driving licence for a period of 10 years?

Answer-

I am advised:

All drivers must meet the medical standards set out in the Assessing Fitness to Drive, available on the Roads and Maritime Services website.

For car (class C) and rider (class R) licences, drivers must pass an eyesight test every 10 years up to 45 years of age. An eyesight test must be done every five years and annually from age 75.

*0928 MOUNT DRUITT MOTOR REGISTRY—Mr Edmond Atalla asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—

Are there any plans to close down the Mount Druitt Motor Registry in favour of a proposed Service NSW centre?

The number of social housing properties that are vacant in any area changes on a daily basis as properties are vacated by tenants and prepared for reletting.

 - (1) How many 4-bedroom residences are available to people on the social housing waiting list in:
 - (a) The Blacktown Local Government Area (LGA);

Answer-

(1) Station customer service staff will receive face-to-face training designed to familiarise them with the Opal card top up machine's functionality.

When an Opal card top up machine goes live at a station, training staff are on site to provide support and assistance to customer service staff. Follow up support from the training team is also available to staff should it be needed after the machine's installation.

(2) During the training sessions, customer service staff complete a module in the customer operation of an Opal top-up machine. This module gives instruction to customer service staff on how to assist customers in the use of the machine, including troubleshooting assistance and support.

Additionally, in the lead-up to installation and at the opening of a new Opal top up machine, communication packages are provided to customer service staff.

- *0946 CRIME OF CONSORTING—Ms Jodi McKay asked the Deputy Premier, Minister for Justice and Police, Minister for the Arts, and Minister for Racing—
 - (1) Since April 2012, how many people have been:
 - (a) Arrested for the crime of consorting;
 - (b) Convicted for the crime of consorting;
 - (c) Issued with a warning for the crime of consorting?

Answer—

The Bureau of Crime Statistics and Research (BOCSAR) analyses NSW recorded crime statistics and provides these for a range of offences.

*0947 BODY CAMERAS—Ms Jodi McKay asked the Deputy Premier, Minister for Justice and Police, Minister for the Arts, and Minister for Racing—

How many body cameras will be operational in each of the years from 2015-16 to 2017-18?

Answer-

The Government has allocated \$4 million over two years to the NSW Police Force for its rollout of the first tranche of body worn cameras.

This allocation includes \$3.65 million in the 2015-16 Budget.

*0948 INTERSECTION OF AUSTRALIA AVENUE, HOMEBUSH BAY DRIVE AND UNDERWOOD ROAD—Ms Jodi McKay asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—

What is the Government doing to upgrade the roundabout at the intersection of Australia Avenue, Homebush Bay Drive and Underwood Road?

Answer—

I am advised:

The Government has made an election commitment of \$2 million towards improvements at the intersection of Australia Avenue, Homebush Bay Drive and Underwood Road to improve safety and congestion.

Investigations are underway to consider options to reduce congestion at the roundabout. The community will be given the opportunity to give feedback as investigations continue.

*0949 PAEDIATRIC HOSPITAL IN CAMPBELLTOWN—Mr Greg Warren asked the Minister for Health—

What is the timeline and completion date for the promised paediatric hospital to be built in Campbelltown as announced during the 2015 State Election campaign by the Government?

Answer-

I am advised:

The Government is proud to have delivered the \$134 million Stage 1 redevelopment of Campbelltown Hospital. Patients are now receiving care in the new multi storey clinical services building.

The Government will deliver on its commitment of a \$300 million injection of funds to begin the Campbelltown Hospital stage 2 major redevelopment The \$300 million includes provision for the planning for enhanced paediatric services in south west Sydney.

*0950 ROADS AND MARITIME SERVICES OFFICE IN CAMPBELLTOWN—Mr Greg Warren asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—

How many transactions were completed at the Roads and Maritime Services office in Campbelltown during the 2014-15 financial year?

Answer-

I am advised:

This matter is the responsibility of the Minister for Finance, Services and Property.

*0951 SOUTHWEST RAIL LINK EXTENSION—Mr Greg Warren asked the Minister for Planning—

(1) Will the Minister meet with a delegation of residents (including residents from the Wildfire estate) to

allow them to voice their concerns regarding the proposed Southwest Rail Link extension?

- (2) How does the Government plan to assist and compensate residents of Wildfire estate and other effected residents for stress and potential financial loss?
- (3) Were residents, local Members of Parliament and other stakeholders effected by the Southwest Rail Link extension notified and communicated with regarding the extension?
 - (a) If so, on what date did this occur?
 - (b) If so, what type of notification and what form of communication was provided?

Answer-

I am advised that these questions should be directed to the Minister for Transport.

*0952 DIRECTOR OF TAFE-Mr Paul Lynch asked the Attorney General-

- (1) Did the current Director of TAFE, South Western Sydney Institute previously retire from the institution now known as TAFE under what is known as the 'old super scheme'?
- (2) Is that Director now employed under additional contractual arrangements receiving payments in addition to his previous superannuation benefits?

Answer-

This question should be directed to the Hon John Barilaro MP, Minister for Skills.

*0953 INVESTIGATION INTO LIFELINK PROGRAM—Mr Paul Lynch asked the Attorney General—

What investigation has been carried out into the Lifelink Program and the management of it by staff in your Department?

Answer-

I am advised by the Department of Justice there has been a post implementation review of the roll-out of the Lifelink project.

*0954 DIRECTOR OF PUBLIC PROSECUTIONS ACT—Mr Paul Lynch asked the Attorney General—

- (1) How many requests have you received under section 29 of the Director of Public Prosecutions Act since becoming Attorney General?
 - (a) When were such requests received?
 - (b) To what did such requests relate?

Answer-

From time to time, where it is appropriate in the ordinary course of the exercise of the Director of Public Prosecution's duties, matters are referred to the Attorney General to exercise the Attorney General's corresponding functions under section 29 of the Director/cif Public Prosecutions Act 1986.

*0955 BIRTHS, DEATHS AND MARRIAGES—Mr Paul Lynch asked the Attorney General—

- (1) Are certificates issued by the Registry of Births, Deaths and Marriages any longer checked against applications for accuracy before being sent to customers?
 - (a) Is customer identification checked?

Answer—

I am advised by the Department of Justice that prior to printing certificates, Registry staff review a preview of the certificate in Lifelink to check its accuracy before it is sent to the customer.

I am further advised that customer identification is checked by Registry staff to ensure entitlement and proof of identity requirements are met.

*0956 AUDIT BY PRICEWATERHOUSECOOPERS—Mr Paul Lynch asked the Attorney General—

- (1) Did the previous Attorney direct that PricewaterhouseCoopers (PwC) conduct a full audit of processes at the Registry of Births, Deaths and Marriages?
- (2) Did this audit by PwC occur?
 - (a) If not, why not?
 - (b) Was this audit subsequently conducted internally?

Answer-

I am advised by the Department of Justice that it is not aware of any direction of the former Attorney General directing a full audit of processes at the Registry of Births, Deaths and Marriages.

*0957 BARBARO V R [2014] HCA 2-Mr Paul Lynch asked the Attorney General-

- (1) What is your response to the High Court decision in Barbaro v R [2014] HCA 2 disavowing the permissibility of the prosecution agreeing in charge negotiations to submit to the court a specific range for the appropriate sentence?
- (2) What is your response to the NSW Law Reform Commission suggestion in Report No 141 at 3.67 (p55) to refer this issue to the NSW Sentencing Council for review?

Answer-

I am advised, following the case of Barbaro v R [2014] HCA 2, that no legislative intervention is required at this time.

The Government is currently considering the recommendations of the NSW Law Reform Commission Report No 141. The Department of Justice will provide me with advice for.-eo.nsideration on the issues raised.

*0958 LIFELINK-Mr Paul Lynch asked the Attorney General-

What was the total cost of the introduction of the Lifelink Program in your Department?

Answer-

I am advised by the Department of Justice that the total cost of the Lifelink Project was \$17.3 million.

*0959 CHANGE OF NAME APPLICATIONS-Mr Paul Lynch asked the Attorney General-

- (1) Did an external audit recommend in or about 2009 that two Departmental Officers should check change of name applications in the Registry of Births, Deaths and Marriages?
 - (a) Was that recommendation immediately implemented?
 - (b) Has that position now been altered so that only one officer checks the application?

Answer-

I am advised by the Department of Justice that two people check change of name applications prior to registration.

*0960 APPLICATIONS TO THE SUPREME COURT—Mr Paul Lynch asked the Attorney General—

- (1) In the period 2 April 2015 to 11 August 2015, how many applications to the Supreme Court have you authorised to detain sexual offenders after the expiry of the period of imprisonment to which they were sentenced?
- (2) In the period 2 April 2015 to 11 August 2015, how many applications to the Supreme Court have you authorised to detain violent offenders after the expiry of the period of imprisonment to which they were sentenced?

Answer-

I am advised by the Department of Justice that the Crown Solicitor is instructed by the Office of General Counsel, Department of Justice, in respect of the preparation and bringing of applications under the Crimes (High Risk Offenders) Act 2006 on behalf of the State.

I am further advised that in the period 2 April 2015 to 11 August 2015 the Crown Solicitor received instructions from the Office of General Counsel to commence two applications for continuing detention orders in respect of high risk sexual offenders and two applications for continuing detention orders in respect of high risk violent offenders.

- *0961 NEWCASTLE INNER CITY BYPASS—Ms Sonia Hornery asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—
 - (1) What is the current status of the Newcastle Inner City Bypass Stage 5 plans?
 - (2) Will Stage 5 plans be put on public display in the near future?(a) If so, when?
 - (3) What is the expected commencement date of works on Stage 5?
 - (4) What is the expected completion time for Stage 5?

Answer-

I am advised:

Planning is well under way for the 3.4 kilometer final section of Newcastle Inner City bypass between

Rankin Park and Jesmond.

In the 2014-15 Budget, the Government committed \$150 million from Restart NSW towards construction of the \$280 million stage five section from Rankin Park to Jesmond. \$4 million has been allocated in the 2015-16 Budget to continue planning for stage five.

Roads and Maritime Services expects to display the refined concept design for community and stakeholder comment later in 2015, with construction to start in 2017 and open to traffic by the end of 2019.

- *0962 WALLSEND MOTOR REGISTRY OFFICE—Ms Sonia Hornery asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—
 - (1) Is there a plan to convert the Wallsend Motor Registry office to a Service NSW Centre?
 - (a) If so, when is this to occur?
 - (b) If so, has there been any notification or consultation regarding this change?

Answer-

I am advised:

This matter is the responsibility of the Minister for Finance, Services and Property.

- *0963 WARATAH LOCAL AREA COMMAND—Ms Sonia Hornery asked the Deputy Premier, Minister for Justice and Police, Minister for the Arts, and Minister for Racing—
 - (1) What was the total number of police officers stationed at Waratah Police Station as at 30 June 2014 and 30 June 2015?
 - (2) Will any additional police officers be allocated to the Waratah Local Area Command at the next rollout of new police officers?
 - (a) If not, why not?

Answer—

I am advised:

Police officers are allocated to Local Area Commands, with the Commander responsible for staffing at individual police stations. This can vary from day to day depending on operational requirements.

The allocation of police resources is determined by the Commissioner based on operational need.

Waratah Local Area Command has not existed since 2008.
