- *4882 HUNTER REGION COUNSELLING SERVICES FOR MEN—Ms Sonia Hornery asked the Minister for Family and Community Services, and Minister for Women—
 - (1) How will the phone counselling services for men, as mentioned in the "It Stops Here" document, operate in the Hunter region?

(2) How many other behavioral change programs for men will be introduced in the Hunter region? Answer—

The Men's Referral Service provides telephone counselling, information and referral. The service is available via 1300 766 491 across all of New South Wales, including the Hunter Region.

*4883 HUNTER REGION CHILDREN IN CARE—Ms Sonia Hornery asked the Minister for Family and Community Services, and Minister for Women—

- (1) How many foster children in the Hunter region are in the care of the Department of Family and Community Services (FACS)?
- (2) How many foster children in the Hunter region are in the care of non-government agencies?
- (3) Based on guidelines set by the NSW Office of the Children's Guardian, how regularly should FACS representatives visit children in foster care for welfare checks?
- (4) Are current figures available of the rate of FACS visits to foster children in the Hunter region?(a) If so, what are these figures?
 - (b) If not, why not?

Answer-

(1) -(2) Information and statistics about children and young people in out of home care is available in the Department's Annual Statistical Reports.

(3) - (4) The NSW Standards for Statutory out of home care (OOHC) are available on the Office of the Children's Guardian's website and are not prescriptive on how often children should be visited by their caseworker. This Government is delivering on Wood recommendations to transfer children in OOHC to the non- government sector. NGO's are able to provide regular home visits to children in OOHC.

*4884 NATIONAL DISABILITY INSURANCE SCHEME—Ms Sonia Hornery asked the Minister for Family and Community Services, and Minister for Women representing the Minister for Ageing, Minister for Disability Services, and Minister for the Illawarra—

Does the National Disability Insurance Scheme Act 2013 override the Disability Services Act 1993?

Answer-

The National Disability Insurance Scheme Act 2013 (the NDIS Act) is not intended to override the Disability Services Act 1993 (DSA).

The NDIS Act is intended to operate concurrently with state disability laws as outlined in section 207(1) of the Act. This section says that this Act is not to apply to the exclusion of a law of a State or Territory to the extent that that law is capable of operating concurrently with this Act.

In the event of an inconsistency between the two laws, the NDIS Act will override the DSA in accordance with section 109 of the Commonwealth Constitution.

*4885 PORT OF NEWCASTLE LEASE—Ms Sonia Hornery asked the Treasurer, and Minister for Industrial Relations—

If the Government receives more than the estimated \$700 million for the 99 year lease of the Port of Newcastle, will the Hunter region receive more of the lease proceeds than the \$350 million pledged for a light rail system servicing Newcastle's central business district?

Answer—

The proceeds will be invested in the Government's infrastructure fund, Restart NSW, with 30 per cent of funds reserved for projects in regional areas.

The Government will invest \$340 million from the transaction in the revitalisation of the Newcastle CBD, including the light rail project. These proceeds are in addition to the \$120 million total already allocated from the Hunter Infrastructure and Investment Fund (\$60m) and Restart NSW (\$60m).

The term of the proposed lease is 98 years.

- *4886 PORT OF NEWCASTLE LEASE COMMUNITY LIAISON GROUP—Ms Sonia Hornery asked the Treasurer, and Minister for Industrial Relations—
 - (1) What criteria is used to select members of the community liaison group formed to provide input on the Government's plans for the long term lease of the Port of Newcastle?
 - (2) Who is responsible for selection of the community liaison group?
 - (3) How many members will be on the community liaison group?

Answer-

These questions would be more appropriately directed to the Minister for Roads and Ports.

*4887 INDEPENDENT LOCAL GOVERNMENT REVIEW PANEL—Ms Sonia Hornery asked the Minister for Local Government, and Minister for the North Coast—

The Local Government in NSW Future Directions Opinion Poll prepared for the Independent Local Government Review Panel found that Hunter residents scored councils relatively low on their ability to understand community needs and act in the best interest of the community:

What is the Government doing to support local councils and improve this result?

Answer-

I provide the following details in response to your questions:

The Government established the Independent Local Government Review Panel at the request of the then Local Government and Shires Associations of NSW (now Local Government NSW), to review the governance, structure and boundaries of local government in New South Wales. To inform its work, the Panel has commissioned research consistent with the intent of the review and its Terms of Reference.

- *4888 PARRAMATTA COMMUNITY JUSTICE CENTRE—Ms Sonia Hornery asked the Attorney General, and Minister for Justice—
 - (1) Will the new centralised Community Justice Centre in Parramatta have specific mediators to deal with referrals from community organisations such as Aboriginal groups, housing co-operatives and women's centres?
 - (2) If not, why not?

Answer-

I am advised:

The backroom operations for providing mediation services will be centralised at the Parramatta Community Justice Centre, which will deal with all referrals for mediation in NSW. Mediators will continue to be made available and sent wherever clients are located.

- *4889 FADED SCHOOL ZONE SIGNS—Ms Sonia Hornery asked the Minister for Transport representing the Minister for Roads and Ports—
 - (1) Has the Government responded to the National Roads and Motorists' Association's recent Keep School Zones Safe survey which showed 41 per cent of Hunter and Central Coast school zone signs had faded and 73 per cent had not been updated to comply with Australian standards?
 - (2) If not, when will the Government take action on this issue?

Answer-

I am advised:

As part of the rollout of flashing lights, school zone signage is being upgraded to fluorescent signage. As at 30 September 2013, 10,000 signs have been replaced, about 40 per cent of the total in New South Wales. The Government is continuing the rollout, so every school in New South Wales has a set of flashing lights by December 2015.

Schools can request Roads and Maritime Services replace damaged signs and carry out maintenance, such as tree trimming around school zone signs, either through Roads and Maritime regional offices, the local Traffic Committee or by calling customer service on 13 22 13.

- *4890 JOHN HUNTER HOSPITAL THEATRE NURSE VACANCIES—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—
 - (1) Has the Hunter New England Local Health District filled the seven budgeted positions for theatre

nurses at John Hunter Hospital?

(2) If not, why not?

Answer-

I am advised:

All seven theatre nurse positions have been filled and all nurses have begun work at John Hunter Hospital.

*4891 CRIMES LEGISLATION AMENDMENT (GANGS) ACT PROSECUTIONS—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

How many prosecutions have there been of offences introduced by the Crimes Legislation Amendment (Gangs) Act 2006:

- (a) Prior to 26 March 2011;
- (b) After 26 March 2011?

Answer-

I am advised:

The NSW Bureau of Crime Statistics and Research (BOCSAR) holds the information in relation to the number of charges finalised in NSW criminal courts for offences introduced into the Crimes Act 1900 by the Crimes Legislation Amendment (Gangs) Act 2006 for those respective periods.

- *4892 INMATE SUPPORT SERVICES-Mr Paul Lynch asked the Attorney General, and Minister for Justice-
 - (1) Why have tenders not been called for the inmate support service strand of Corrective Services NSW funding?
 - (2) Why has funding been refused for Prisoners Aid NSW beyond 1 July 2014?
 - (3) Have you refused to meet representatives of Prisoners Aid NSW?(a) If so, why?

Answer-

I am advised:

- (1) Corrective Services NSW (CSNSW) undertook a review of its Community Funding Program which resulted in the development of the Funded Partnership Initiative (FPI). Tenders under the FPI closed on 11 November 2013.
- (2) Every three years CSNSW opens a tender process and invites applications for a range of inmate services. The Prisoners' Aid Association of NSW did not submit a tender application.
- (3) CSNSW met with the Prisoners' Aid Association of NSW in relation to the FPI and the tender process on two occasions.

*4893 ROSS SELLER JUDGMENT—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

What action is proposed against lawyer Ross Seller particularly bearing in mind the recent judgment of the NSW Supreme Court?

Answer—

I am advised:

No complaint has been filed to date with the Office of the Legal Services Commissioner against this lawyer in relation to the judgement of the Supreme Court in Symond v Gadens Lawyers Pty Limited (2013).

Criminal charges have been laid against Mr Seller that are unrelated to Symond v Gadens Lawyers Pty Limited (2013). As required by the Legal Profession Act 2004, Mr Seller notified the Law Society of those charges being laid. If convicted, Mr Seller will be required under section 67 of Act to show cause as to why he considers himself to be a fit and proper person to hold a solicitor's practising certificate.

*4894 NSW HEALTH PATHOLOGIST EXPERT ADVICE—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

Do you propose to respond to the letter from Uther, Webster and Evans dated 4 November 2013, a copy of which was sent to you concerning a directive preventing Ministry of Health pathologists providing advice or evidence at the request of lawyers for defendants?

The school principals at Ashcroft, Fairfield, Cabramatta, Canley Vale, Curran and Rosemeadow Public Schools have been advised that the projects at their schools will be continuing beyond 30 June 2014.

*4898 MOTORISED BICYCLES—Mr Paul Lynch asked the Minister for Transport representing the Minister for Roads and Ports—

What steps do you propose to:

- (a) Ban motorised bicycles;
- (b) Regulate motorised bicycles;
- (c) Licence motorised bicycles;
- (d) Impose speed limits on motorised bicycles?

Answer-

I am advised:

Legal power assisted pedal cycles are typically powered by a low output motor of up to 200 watts, which is usually electric, with the primary source of power still being from the rider pedalling, and the attached motor providing a small amount of additional assistance.

Under existing New South Wales legislation, motorised bicycles which have a power output exceeding 200 watts are illegal to use on roads, footpaths and public areas. They do not meet the standards for a power assisted pedal cycle and are dangerous for the rider and other pedestrians.

It is largely impractical for petrol driven engines capable of propelling a bicycle to be under the 200 watt power limit. Subsequently, virtually all of the petrol powered engines currently being attached to motorised bicycles exceed this power limit and so are illegal for use on a road or road-related area in New South Wales.

I have asked the NSW Centre for Road Safety to undertake a review of petrol powered bicycles. The review is currently underway.

Under the New South Wales roads legislation, power assisted pedal cycles, where the primary source of power is the rider pedalling, are considered a form of bicycle and are subject to the same laws and road rules as a conventional bicycle.

*4899 PROPOSED WOLLONGONG PRIVATE HOSPITAL DEVELOPMENT—Ms Noreen Hay asked the Minister for Health, and Minister for Medical Research—

Three companies indicated interest in the project and were given the opportunity to provide more comprehensive sets of proposals. Two of these companies withdrew their interest during August 2013 and the third submitted a proposal in mid-November 2013. The Ministry of Health and the Illawarra Shoalhaven Local Health District are currently considering whether the proposal represents a viable and deliverable solution for the development of a car park along with a co-located hospital.

(1) - (2) The rate for all vessels is \$2.00 per metre per day. Fees paid by existing clients that are currently below this rate are being increased incrementally until 1 July 2014. The fees currently being paid range from \$0.66 per metre per day to \$2.00 per metre per day.

(3) Moorings are charged one month in advance. There is a 10 per cent discount for vessels that have approval to operate commercially. There is a 20 per cent discount if two vessels are rafted together.

*4910 FORT STREET PRIMARY SCHOOL TRAFFIC CONCERNS—Mr Ryan Park asked the Minister for Transport representing the Minister for Roads and Ports—

In relation to concerns surrounding the safety of pedestrians, cyclists and motorists in and around the Fort Street Primary School:

Has monitoring been carried out in relation to safety at this location?

- (a) If so, what measures will be implemented as a result of this monitoring?
- (b) If not, when will monitoring take place?

Answer-

I am advised:

The signage on the shared path at Fort Street Public School was assessed and faded markings were upgraded. Roads and Maritime will install cross hatched marking on the bridge deck to further raise awareness for both cyclists and pedestrians. This work is expected to be completed by the end of December 2013.

Roads and Maritime will continue to monitor community feedback.

*4911 FLOOD PRONE AREAS IN MOUNT DRUITT—Mr Richard Amery asked the Minister for Planning and Infrastructure, and Minister Assisting the Premier on Infrastructure NSW, Leader of the House—

- (1) Are parts of the Mount Druitt electorate identified as flood prone?
- (2) What action is being taken to ensure that new housing developments are not built in flood prone areas?
- (3) Are discussions held with the insurance industry regarding land releases in areas identified as flood prone?

Answer-

I am advised:

- (1) Yes.
- (2) The applicable development controls for flood prone land are contained in Part A of the Blacktown Development Control Plan 2006 under Section 8 Development of Flood Prone Land and Section 9 Local Overland Flooding Major Drainage and Local Runoff.
- (3) Decisions on land releases in flood prone areas are made in accordance with the requirements of the Environmental Planning and Assessment Act 1979.

- (1) Design and development work has started.
- (2) \$4 million in the 2013-14 financial year.
- (3) \$4 million in the 2013-14 financial year.
- (4) A completion date has not been determined.

*4913 MOUNT KEIRA DEMONSTRATION SCHOOL FLASHING LIGHTS—Mr Ryan Park asked the Minister for Transport representing the Minister for Roads and Ports—

Is there a time line for installing flashing lights at Mount Keira Demonstration School?

- (a) If so, when will the lights be installed;
- (b) If not, why not?

Answer-

I am advised:

On 11 June 2013, the Government announced an acceleration of the school zone flashing lights program, to ensure every school in New South Wales has a set of flashing lights by December 2015. This means around 1,500 schools that would have missed out, will now receive flashing lights.

Roads and Maritime is consulting with schools that do not have flashing lights, including Mount Keira Demonstration School, to determine the approach for the installation of flashing lights.

A rollout schedule will be developed once the consultation process is complete.

- (1) What is the progress of the report into the Maldon to Dombarton Rail Link being conducted by Transport for NSW on behalf of the Commonwealth?

Answer—

I am advised:

Transport for NSW is not preparing a specific report into the Maldon to Dombarton Rail Link on behalf of the Commonwealth. Rather, Transport for NSW is managing the planning and pre-construction design work to support the potential future delivery of the project.

Information regarding the scope and progress of work being undertaken is available on the Transport for NSW website.

*4916 MALDON TO DOMBARTON RAIL LINK—Mr Ryan Park asked the Minister for Transport—

- (1) What is the progress of the report into the Maldon to Dombarton Rail Link being conducted by Transport for NSW on behalf of the Commonwealth?
- (2) When will this report be completed?
- (3) When will this report be available to the public?

Answer-

I am advised:

*4917 TAFE NSW DISABILITY SERVICES—Mr Ryan Park asked the Minister for Education—

- (1) How much funding was allocated for the Disability Services component of the TAFE NSW budget over the last five financial years?
- (2) How much funding was allocated for the Disability Services component of the TAFE NSW budget over the last five financial years for the TAFE Illawarra Institute?

Answer—

The TAFE NSW budget does not allocate separate funding for Disability Services. Students with a disability are integrated into the mainstream and Institutes use their budget allocation to meet the resource needs of these students.

- *4918 ILLAWARRA YOUTH UNEMPLOYMENT—Ms Anna Watson asked the Minister for Family and Community Services, and Minister for Women representing the Minister for Ageing, Minister for Disability Services, and Minister for the Illawarra—
 - (1) Has the Minister received the report on youth unemployment that he said he requested at the estimates hearing for the Legislative Council's General Purpose Standing Committee No. 1 on Thursday, 15 August 2013?
 - (2) Will the Minister release this report?(a) If not, why not?
 - (3) What is the level of youth unemployment in the Illawarra region?

Answer-

I receive regular updates on Illawarra labour force statistics from NSW Trade & Investment.

I am advised that ABS data in original terms shows the unemployment rate for the Illawarra region in October 2013 was 5.5 per cent and 6.1 per cent for Wollongong. For New South Wales it was 5.8 per cent and 5.6 per cent for Australia as a whole.

The youth unemployment rate for the Illawarra region in October 2013 stood at 15.1 per cent, while it was 17.2 per cent for Wollongong, 12.7 per cent for total New South Wales, and 12.2 per cent for Australia.

- *4919 RELOCATION OF GOVERNMENT DEPARTMENTS—Ms Anna Watson asked the Minister for Family and Community Services, and Minister for Women representing the Minister for Ageing, Minister for Disability Services, and Minister for the Illawarra—
 - (1) What government departments and agencies is the Minister examining for relocation to the Illawarra region as stated in his evidence to the Legislative Council's General Purpose Standing Committee No. 1 on Thursday, 15 August 2013?
 - (2) Is the Shellharbour electorate being considered as a location for these government departments and agencies?
 - (a) If not, why not?
 - (3) Has the Government relocated any existing government departments and agencies to the Illawarra region since March 2011?
 - (a) If not, why not?

Answer—

(1) - (2) The Government has set a target of relocating 1,500 public sector jobs from metropolitan Sydney to regional New South Wales by 2021.

The Government has also issued a Call for Lease Proposals (CLP) to construct a new building to accommodate the Illawarra based State Emergency Services headquarters to be available in 2016.

The CLP seeks proposals for 5,000m² of office space in the areas between Thirroul and Shellharbour. The project will generate approximately 300 jobs during construction and support 250 ongoing skilled positions.

(3) NSW Fisheries has relocated seven positions from Cronulla to Wollongong and 31 positions to Nowra.

- *4920 COMPULSORY DRUG TREATMENT CORRECTIONAL CENTRE—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
 - (1) What is the Government's response to the Review of the Compulsory Drug Treatment Correctional Centre pursuant to the Crimes (Administration of Services) Act 1999?
 - (2) Granted that in the four years since its establishment the Compulsory Drug Treatment Correctional Centre has never been at 100 per cent capacity, are referrals to the centre accepted from the Sydney Drug Court, the Hunter Drug Court as well as the Parramatta Drug Court?(a) If not, why not?
 - (3) How many positive tests for non prescription drugs occurred for participants in Stage 1 of the Compulsory Drug Treatment Program in the periods:
 - (a) 1 July 2011 to 30 June 2012;
 - (b) 1 July 2012 to 30 June 2013;
 - (c) 1 July 2013 to date?

Answer—

I am advised:

The Government is currently considering the recommendations of the review. Corrective Services NSW does not collect drug testing data based on Program stages.

*4921 SHALVEY PUBLIC SCHOOL FUNDING—Mr Richard Amery asked the Minister for Education—

- (1) Has needs based funding for Shalvey Public School been reduced by nearly \$35,000?
- (2) What circumstances changed at this school to warrant such a reduction in needs based funding?
- (3) What impact has this funding change had on programs being run at Shalvey Public School?

Answer-

- (1) Shalvey Public School equity funding for 2013 was \$843,057. In 2014 the funding for the two new equity loadings (socio-economic and Aboriginal backgrounds) is \$794,536. Funding to schools in the Mount Druitt electorate increased by \$2,065,726.
- (2) In 2014, the Department of Education and Communities is introducing a fairer funding model for all schools, which reflects the characteristics of individual schools and their students. The new Family Occupation and Education Index captures the data on every student enrolled in every New South Wales public school. Schools with a high score on the Family Occupation and Education Index and the highest proportion of disadvantaged students will be funded at the highest level under the new

equity loading for socio-economic background. This loading funds student need, not schools on a program and it considers all public schools across the state. For 2014, the needs based funding for Shalvey Public School has been allocated according to the new funding model.

(3) Shalvey Public School will receive a combined equity allocation of \$794,536 and will be well placed to deliver quality educational programs and employ equity funded staff positions. The school is currently undertaking an evaluation of existing programs and planning for 2014. Key programs will remain with some minor adjustments to staffing. In the longer term, the new funding model will provide a more sustainable way for the school to plan over time, rather than make large adjustments in response to being 'on' or 'off' a program.

*4922 WINDSOR BRIDGE REPLACEMENT PROJECT—Mrs Barbara Perry asked the Minister for Transport representing the Minister for Roads and Ports—

- (1) Has Roads and Maritime Services procured any goods or services in relation to any phase of the Windsor Bridge Replacement Project on the basis of a single invitation?
- (2) Has Roads and Maritime Services undertaken or arranged to have undertaken any works in the vicinity of the Windsor Bridge Replacement Project which would have any connection with the project if approved?
- (3) Has any land been acquired in respect to this project?
- (4) Have any project alliance team building activities taken place in anticipation of the construction phase of the Windsor Bridge Replacement Project?
- (5) Is it correct that under the terms of the alliance contract there will be no penalty payments to the construction contractor Baulderstone, or any other contractors, if the Minister determined the project would not proceed because it constitutes a misuse of public money?

Answer-

I am advised:

- (1) Refer to answers LA Question 4489 and LA Question 4372.
- (2) Yes. Roads and Maritime has undertaken archaeological test excavations, geotechnical investigations, survey work and noise monitoring to inform the environmental assessment and the design of the project.
- (3) No.
- (4) A number of preparatory workshops have been held.
- (5) Should the Windsor Bridge replacement project not receive planning approval, the alliance agreement with the contractor contains a provision that would allow it to be terminated with reimbursement of costs incurred to date.

Undertaking relevant parts of the procurement process to allow for the project to ramp up quickly if approved, and terminated appropriately if the project does not proceed, is an established and sensible practice. This process has previously been used for other infrastructure projects, including for the Inner West Busway project along Victoria Road on the Iron Cove Bridge under the former Labor government.

*4923 BALMAIN PRESCHOOL FUNDING-Mr Jamie Parker asked the Minister for Education-

What funding was allocated to preschools in the Balmain electorate for the financial years ending:

*4924 SALE OF ILLEGAL TOBACCO IN BANKSTOWN—Ms Tania Mihailuk asked the Minister for Fair Trading—

- (1) How many instances of illegal tobacco sales in the Bankstown electorate has the Department of Fair Trading investigated in 2013?
- (2) What actions have been taken to prevent the sale of illegal tobacco in Bankstown and across New South Wales?

Answer-

The registration of tobacco retailers falls within the portfolio responsibilities of the Minister for Health, the Hon Jillian Skinner MP. The question therefore should be referred to the Minister for Health for response.

*4925 REAL ESTATE LICENCE REGULATIONS-Ms Tania Mihailuk asked the Minister for Fair Trading-

What regulations exist to stop a person without a real estate licence being approved to operate as part of a real estate franchise group?

Answer-

The Property, Stock and Business Agents Act 2002 (the Act) requires all real estate businesses to have a licensee in charge and that licensee must be appropriately licensed for the work being carried out. This applies no matter how the business is structured and therefore applies to businesses that are franchises.

In addition the Act requires that a person must not carry out the functions of a real estate salesperson unless the person is the holder of a certificate of registration, and is employed by a licensed person or a corporation that holds a licence.

If a licensee enters into a franchise agreement, the Act requires that they notify Fair Trading within 30 days.

*4926 UNLICENSED TRADESPEOPLE—Ms Tania Mihailuk asked the Minister for Fair Trading—

What measures are the Government taking to crack down on unlicensed tradespeople, aside from encouraging customers to check whether operators are licensed on the Fair Trading website?

Answer—

The licensing regime under the Home Building Act 1989 establishes standards for competence, probity, contracts, statutory warranties and home warranty insurance to protect people against faulty or incomplete work. NSW Fair Trading is also responsible for administering the Electricity (Consumer Safety) Act 2004.

The Government is committed to protecting consumers from unscrupulous traders and stamping out unlicensed operators through a variety of actions including:

- the annual My Place Program which combines the provision of education information to both traders and consumers along with ensuring compliance with the relevant legislation;
- leading the national strategy to stamp out travelling conmen;
- joining forces with CrimeStoppers to raise consumer awareness of unlicensed tradespeople;
- using specific powers under the Fair Trading Act 1987 to issue public warnings and penalty notices; and
- pursuing prosecutions of breaches to deter others.

*4927 GENERAL PRACTITIONERS IN BANKSTOWN—Ms Tania Mihailuk asked the Minister for Health, and Minister for Medical Research—

How does the number of general practitioners in the Bankstown electorate compare to the state average?

Answer—

I am advised:

As the Commonwealth Government is primarily responsible for the supply of general practitioners throughout Australia, this question should be directed to the Commonwealth Minister for Health.

*4928 MALEK FAHD ISLAMIC SCHOOL-Ms Tania Mihailuk asked the Minister for Education-

- (1) Will the Malek Fahd Islamic School in Greenacre be re-registered by the NSW Board of Studies in 2014?
 - (a) If not, why not?
 - (b) If not, how will the students at the school be accommodated in 2014?

The Board of Studies considered the applications for the renewal of the school's registration and accreditation under the Education Act beyond 2013 at its meeting on Tuesday 10 December 2013.

While progress has been made in relation to the areas of the school's non-compliance with the Education Act, the Board continues to have concerns about the school's compliance with the requirements for registration and accreditation. Accordingly, the school's period of registration and accreditation has been extended until 31 December 2014 during which time the school is required to address the Board's concerns.

The school will be subject of further inspection early in Term 1, 2014, and subsequently as required, to expedite the resolution of the Board's concerns.

*4929 LIQUOR LICENCES IN THE BANKSTOWN ELECTORATE—Ms Tania Mihailuk asked the Minister for Tourism, Major Events, Hospitality and Racing, and Minister for the Arts—

- (1) How many liquor licences are currently in use across the Bankstown electorate?
- (2) How many liquor licences were in use across the Bankstown electorate in:
 - (a) 2012;
 - (b) 2011?

Answer-

The liquor licensing database established in 2008 by the Office of Liquor, Gaming and Racing is not capable of producing reports about licensed premises based upon electorates.

*4930 FOOD SAFETY BREACHES IN BANKSTOWN—Ms Tania Mihailuk asked the Minister for Primary Industries, and Minister for Small Business—

Noting that the NSW Food Authority's website lists almost 100 penalty notices issued for food safety breaches in Bankstown over the past 12 months:

What educational programs are being implemented in the Bankstown area to raise awareness of food safety and reduce the number of breaches?

Answer-

The NSW Food Authority, in conjunction with a number of councils including Bankstown City Council, is rolling out its 'hot bread shop project' targeting high risk food handling and food safety issues in 'at risk' businesses. Bankstown City Council's food safety education program includes free introductory food handler training provided in six languages with the help of interpreters and translated educational material. The training is delivered in Vietnamese, Arabic, Cantonese, Mandarin and Thai. Council also provides basic food handler training to temporary food stall operators and on-site training for schools and child care centres.

*4931 FIRE HAZARD REDUCTION OPERATIONS—Ms Tania Mihailuk asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

What bushfire hazard reduction operations will be conducted before summer at:

- (a) Lake Gillawana;
- (b) Flinders Slope;
- (c) Shortland Bush;
- (d) Georges River National Park;
- (e) Bushland on Henry Lawson Drive between the Hume Hwy and Milperra Rd?

Answer—

I am advised by Fire and Rescue NSW:

Extensive bushfire hazard reduction operations have already been undertaken in Georges River National Park. Proposals for hazard reduction in other areas, including Lake Gillawana, Flinders Slope and Shortland Bush, have been submitted to the local Bush Fire Management Committee. These are prioritised and undertaken as resource and weather conditions allow.

A small area of bushland on Henry Lawson Drive (near hazel Street) has been identified as requiring hazard reduction. This will be undertaken in December/January 2014.

*4932 INTERSECTION OF STACEY STREET AND GRIFFITHS ROAD—Ms Tania Mihailuk asked the Minister for Transport representing the Minister for Roads and Ports—

- (1) When will the Roads and Maritime Services' review of the intersection at Stacey Street and Griffiths Road in Bankstown be completed?
- (2) Will Roads and Maritime Services put in place any temporary safety measures while the review is being completed given another serious accident occurred at the intersection on Monday 11 November 2013?

Answer—

I am advised:

(1) Roads and Maritime expects traffic flow, pedestrian flow and crash data analysis for this intersection to be completed by the end of March 2014. The analysis will inform the most appropriate treatment to reduce the number and severity of crashes at this intersection.

(2) Roads and Maritime is engaging with police to monitor this intersection.

*4933 NUMBER OF AMBULANCES-Mr Clayton Barr asked the Minister for Health, and Minister for Medical Research-

How many ambulances were operating in the Ambulance Service of NSW fleet in the financial years:

- (a) 2010-11;
- (b) 2011-12;
- (c) 2012-13?

Answer-

I am advised:

In the respective financial years there were the following number of ambulances in the fleet:

- (a) 999;
- (b) 1018;
- (c) 1021.

*4934 OUT OF AREA AMBULANCE RESPONSE—Mr Clayton Barr asked the Minister for Health, and Minister for Medical Research—

- (1) How many ambulances are located in the Hunter New England Health area?
- (2) Is there a maximum distance an out of area ambulance is expected to travel to respond to a call when local ambulances are not available?
- (3) Is there a maximum time frame an out of area ambulance is expected to travel to respond to a call when local ambulances are not available?

Answer-

I am advised:

There are currently around 150 ambulance vehicles allocated to the Hunter New England Sector.

There is no maximum distance or timeframe for ambulances responding to emergencies. Ambulance Control Centre staff will always respond the nearest available resources as necessary to a patient requiring emergency care, regardless of which station or region a crew started from.

To continually improve response times, NSW Ambulance has:

- Adjusted crew deployments to better match available resources to known demand patterns in Sydney and rural areas;
- Linked Ambulance patients to the appropriate healthcare community and non-emergency department pathways;
- Continued use of Extended Care Paramedics to reduce the number of patients needing hospital transport; and
- · Enhanced Rapid Responder models.
- *4935 PATIENT TRANSPORT UPON DISCHARGE—Mr Clayton Barr asked the Minister for Health, and Minister for Medical Research—
 - (1) Do hospitals have a responsibility to ensure that patients who are transported to hospital by ambulance have available transport to their homes upon discharge?
 - (2) What avenues are available to discharged patients who were transported to hospital by ambulance to return to their homes when there is no direct public transport to their suburb?

Answer-

I am advised:

Local Health Districts are expected to provide all possible advice and assistance to patients to ensure they have suitable discharge arrangements. Patients are advised that it is best to organise transport home with family members or friends upon discharge, regardless of their initial mode of transport to hospital. However, if a patient has no one to collect them or they are in a hospital a long way from home, the hospital may be able to assist with transport.

The Isolated Patients Travel and Accommodation Assistance Scheme (IPTAAS) provides financial assistance to help with travel and accommodation costs for people (and eligible escorts) who need to travel long distances to access specialist treatment not available locally. First response agreements are held with Local Area Commands not individual police stations.

*4938 MARITIME REGISTRATIONS—Mr Clayton Barr asked the Minister for Transport representing the Minister for Roads and Ports—

When will all Roads and Maritime Services offices be able to process maritime registrations and not have to send the registrations elsewhere for processing?

Answer-

I am advised:

As at 4 December 2013, 115 Roads and Maritime registries across the state can process paperwork for all maritime transactions, including registrations. Of these, 41 are fully integrated Roads and Maritime service centres, and six are Maritime service centres where only maritime registration transactions can be completed. Integrated registries are continually expanding.

The Government is establishing Service NSW centres throughout New South Wales. All Service NSW centres will be able to process maritime registrations on site. The rollout of Service NSW has commenced, with 12 sites currently operational and another six planned for delivery in 2014.

*4940 ABORIGINAL PLACES DEVELOPMENT BUFFER ZONES—Mr Clayton Barr asked the Minister for the Environment, and Minister for Heritage—

How many Aboriginal Places that are registered and gazetted with the Office of Environment and Heritage are protected from current or proposed development by a buffer zone of:

- (a) A maximum of 20 metres?
- (b) Greater than 20 metres?

Answer—

I am advised as follows:

- (1) The Aboriginal Place provisions under the National Parks and Wildlife Act 1974 do not provide for buffer zones. Consequently, buffer zones for Aboriginal Places cannot be gazetted.
- (2) As above.
- *4941 PREMIER'S CHRISTMAS GALA CONCERT—Mr Clayton Barr asked the Minister for Family and Community Services, and Minister for Women representing the Minister for Ageing, Minister for Disability Services, and Minister for the Illawarra—

With regard to the Premier's Christmas Gala Concerts to be held at Newcastle Civic Theatre in 2013:

- (1) Who made the decision to only allow ticket issuing and collection from the theatre itself (excluding tickets issued to Electorate Offices)?
- (2) Is this process the same for all venues in 2013?
- (3) Why was ticketing not made available online or via telephone considering that the regional concerts appeal across a wide geographic region?

Answer—

- (1) This decision was made by the Department of Family and Community Services after discussions with all four venues for the 2013 concerts.
- (2) Yes.
- (3) To ensure seniors from the local areas had the first opportunity to attend the concerts in their area, tickets were made available in the first instance only by local box office bookings in person. These arrangements were negotiated with and on the advice of the venues in each concert location.

The Department of Family and Community Services carefully monitored the release of tickets with the venues in each of the four locations. In the days following the ticket release, the Department agreed with each venue that if they had tickets remaining or returned, that they would accept phone bookings from eligible seniors, at their discretion. This has occurred at all four venues.

*4951 CONCESSION TICKETS FOR OLDER PEOPLE ON PUBLIC TRANSPORT—Mr Alex Greenwich asked the Minister for Transport—

Noting the Tourism and Transport Forum recommendation that concession tickets on public transport for older people outside peak travel hours would reduce peak demand and increase off peak public transport use:

- (1) What assessment has the Government made of this proposal?
- (2) What research has the Government conducted on similar concessions in other jurisdictions?
- (3) What does the evidence from jurisdictions where these concessions are available suggest about costs and benefits?
- (4) What plans does the Government have to implement or trial such a scheme?

Answer-

I am advised:

The Government provides all Seniors Card holders with a half fare public transport concession, available in peak and off-peak periods.

\$2.50 excursion fares are also available to Seniors Card holders, which can generally be used for travel during peak and off-peak times, including:

- \$2.50 Pensioner Excursion Ticket, valid for all day travel on trains, buses, light rail and most ferries throughout the greater Sydney area;
- \$2.50 Country Pensioner Excursion Ticket, valid for one-way journeys on NSW TrainLink Regional train and coach services wholly outside of the greater Sydney area; and
- \$2.50 Regional Excursion Daily ticket, valid for all day travel on local bus services throughout rural and regional New South Wales.

The Government has no plans to change these arrangements.

The Government will retain the \$2.50 fare for seniors and pensioners when the Opal Senior/Pensioner card is introduced.

*4952 LATE NIGHT TRANSPORT IN SYDNEY—Mr Alex Greenwich asked the Minister for Transport—

Noting the Sydney City Centre Access Strategy, which notes the need for improved public transport late at night given train services do not operate between midnight and 4.30am:

- (1) What assessment has the Government made of providing late night shuttle trains between Kings Cross, Town Hall and Central Train Stations in order to help the large number of people visiting the area get home?
- (2) What assessment has the Government made of extending train services later at night or earlier in the morning?

Answer-

I am advised:

(1) - (2) and (5) In 2012, the Government announced the Plan of Management for Kings Cross to address concerns about violence and anti-social behaviour.

The Plan's late night transport initiatives include additional late night bus services, increased security guard numbers and improved queuing facilities at secure taxi ranks, a trial of prepaid taxi fares, additional wayfinding and late night transport service information at Kings Cross Station, and traffic management improvements to favour the movement of public transport services leaving Kings Cross.

Late night buses from Kings Cross are preferable to trains because bus services better match late night public transport demand, offer direct connections with the NightRide bus network, and provide a more manageable environment in the event of an incident.

New late night bus services are one-way services – customers can travel safely home from Kings Cross, but trouble makers are unable to use these services to travel into Kings Cross late at night.

(3) - (4) Cities of comparable size and density around the world have found the level of demand for public transport after midnight is generally best met by bus services.

(6) As stated in the City Centre Access Strategy, the Government will work to simplify and extend the late night public transport network to provide more integrated late night bus services that connect to key late night hubs.

*4953 CYCLING AND ROAD SAFETY EDUCATION—Mr Alex Greenwich asked the Minister for Transport representing the Minister for Roads and Ports—

Noting the increase in the number of people riding bicycles, reports in some media about conflict between different road users, and that cyclists coming into the Sydney central business district come from a variety of areas on a range of different routes:

- (1) How does the Government monitor the number of people riding bicycles?
- (2) How is this number reported to the community?
- (3) What statewide community education programs about road safety and road rules does the Government provide directed to:
 - (a) Cyclists;

- (4) What plans does the Government have to increase road safety education in response to the increase in people riding bicycles and media reports of conflict between different road users?

Answer-

I am advised:

(1) - (2) Roads and Maritime has installed automatic bicycle counters at 31 sites on key bicycle routes in the Sydney metropolitan area. Annual average counts and average weekday counts are available on the Bicycleinfo website: www.bicycleinfo.nsw.gov.au.

(3) New South Wales conducts a number of state-wide road safety education campaigns that run annually. The NSW Road Safety Education program is also available to one million school students.

The inaugural Road Rules Awareness week was held in February 2013. This campaign will be extended in 2014.

Information on these programs can be found on the Centre for Road Safety website.

(4) - (5) Transport for NSW is currently finalising a Cycling Safety Strategy. An early initiative from the strategy has seen a partnership with the Amy Gillett Foundation.

The Centre for Road Safety has committed \$400,000 to the NSW Safe Cycling Communities campaign, which sends messages to both drivers and bicycle riders about sharing the road and road rules. To date, over 30 billboards across the state advise bicycle riders to 'Stop on the red' and drivers to pass bicycle riders safely, with the 'A Metre Matters' message.

The next phase will include radio advertising about sharing the road, and a broader education campaign to increase community understanding about road rules and sharing the road with bicycle riders.

- *4954 ELIZABETH BAY MARINA LEASE—Mr Alex Greenwich asked the Minister for Transport representing the Minister for Roads and Ports—

I am advised:

- (1) The lease is currently operating under a Tenancy at Will agreement, which can be terminated by either party giving three months notice.
- (2) The former lease, which commenced in 1985, was not subject to a public tender process.
- (3) The lease expired on 31 December 2009.

- (4) A site assessment has been undertaken in accordance with Commercial Lease Policy and the site was identified as being suitable to being put to the market.
- (5) No.
- (6) The site will be managed in accordance with all relevant State and Commonwealth laws, and applicable government guidelines and policies, including the NSW Government Procurement Policies and Guidelines, Independent Commission Against Corruption guidelines, and relevant Road Management Authority policies and guidelines.
- (7) A community consultation strategy will be developed prior to release of the initial Expression of Interest.
- (8) It is proposed that the site be put to the market through an Expression of Interest.
- *4955 DISEASED DUCK MEAT—Mr Alex Greenwich asked the Minister for Primary Industries, and Minister for Small Business—
 - (1) Is the Government aware of any reports of duck meat from diseased birds being sold in New South Wales?
 - (2) How many inspections of duck farms were made this year to check for diseased ducks?
 - (3) How many inspections of abattoirs where ducks are slaughtered for meat were made this year to check for diseased ducks?
 - (4) What disease prevention strategies are required on duck farms, given vaccines and antibiotics are not commonly used due to their expense?
 - (5) What assessment has the Government made on the treatment of diseased ducks on duck farms?
 - (6) What assessment has been made on the safety of ammonia exposure in duck farming, given substantially larger amounts are created in duck farming than chicken farming?
 - (7) What investigations has the Government conducted into same species feeding (after rendering) in duck farming, given large death rates due to diseases?

- (2) NSW DPI does not carry out routine inspections of duck farms to check for diseased ducks.

- (4) It is recommended that duck farms have documented and implemented biosecurity procedures to prevent the introduction of diseases to duck farms.

- (6) Workplace Health and Safety Regulations require that ammonia is kept at safe levels for workers.
- (7) Adequate rendering procedures should eliminate any pathogenic microorganisms.

- (9) The current New Zealand list of prohibited imports does not include ducks.
- *4956 DUCK FARMING PRACTICES—Mr Alex Greenwich asked the Minister for Primary Industries, and Minister for Small Business—
 - (1) What proportion of duck farms in New South Wales currently practice de-billing or bill trimming?
 - (2) What research has the Government done into the pain and suffering experienced by a duck when its upper bill is trimmed?
 - (3) What research has the Government done into the ongoing suffering experienced by a duck that has had its upper bill removed?
 - (4) What consideration will the Government give to banning de-billing given it is not practiced widely?

- (10) A national review of the Model Code of Practice for the Welfare of Animals Domestic Poultry and conversion to standards and guidelines is scheduled to begin this year. The review will include the recommendations relating to ducks.
- (11) Standards and guidelines for ducks will be included as a separate chapter in the revised standards and guidelines for domestic poultry.
- *4957 PRIVATISED DISABILITY SERVICES—Mr Alex Greenwich asked the Minister for Family and Community Services, and Minister for Women representing the Minister for Ageing, Minister for Disability Services, and Minister for the Illawarra—

With respect to the privatisation of all disability services from next year in preparation for the national DisabilityCare Australia scheme:

The transition to the National Disability Insurance Scheme (NDIS) model of service delivery is not a "privatisation" of services. It is the transfer of service capacity to where it is needed to ensure the NDIS can operate as planned.

The Anti-Discrimination Act 1977 will continue to operate in its current form in respect of the protections offered and services delivered by the non-government sector (NGO), in the same way it applies to the NGO sector at present.

The passing of the National Disability Insurance Scheme (NSW Enabling) Bill 2013 is the start of a long transitional process where we will communicate with people with disability (or consumers), their families and carers, staff members and service providers. This will include each party's rights and obligations under anti-discrimination legislation.

- *4958 PUBLICATION OF PARLIAMENTARY ENTITLEMENTS—Mr Alex Greenwich asked the Attorney General, and Minister for Justice—

The previous Government considered the Ombudsman's recommendation and, after consulting with the Presiding Officers of the Parliament, determined that the recommendation should not be accepted. There is no plan to reconsider the recommendation at this time.

In 2009, the Ombudsman suggested that the issue of publication of information about the use of parliamentary entitlements should be considered as part of the first statutory review of the GIPA Act. As the GIPA Act is scheduled for statutory review in June 2014, this issue can be considered as part of that review.

*4967 WILLMOT PUBLIC SCHOOL—Mr Richard Amery asked the Minister for Education—

- (1) Has needs based funding for Willmot Public School been reduced by over \$48,000?
- (2) What circumstances changed at this school that would warrant such a decrease in funding?
- (3) What programs at Willmot Public School will be affected by this reduction in needs based funding?

Answer—

- (1) No. In fact funding to schools in the Mount Druitt electorate for the two new equity loadings (socioeconomic and Aboriginal backgrounds) increased by \$2,065,726.
- (2) In 2014, the Department of Education and Communities is introducing a fairer funding model for all schools, which reflects the characteristics of individual schools and their students. The new Family Occupation and Education Index captures the data on every student enrolled in every New South Wales public school. Schools with a high score on the Family Occupation and Education Index and the highest proportion of disadvantaged students will be funded at the highest level under the new equity loading for socio-economic background. This loading funds student need, not schools on a program and it considers all public schools across the state. For 2014, the needs based funding for Willmot Public School has been allocated according to the new funding model. The school also has a reducing enrolment pattern and this has affected total funding levels.
- (3) Willmot Public School will receive a combined equity allocation of \$456,012 and will be well placed to deliver quality educational programs and employ equity funded staff positions. The school is currently undertaking an evaluation of existing programs and planning for 2014. Key programs will remain with some minor adjustments to staffing. In the longer term, the new funding model will provide a more sustainable way for the school to plan over time, rather than make large adjustments in response to being 'on' or 'off' a program.

*4968 SCHOOL TEACHER NUMBERS—Ms Carmel Tebbutt asked the Minister for Education—

Noting the NSW Auditor-General's Report, Volume Nine 2012: Focusing on Education and Communities which shows the number of teachers in New South Wales declined by 380 in 2011-12 and the NSW Auditor-General's Report, Volume Five 2013: Focusing on Education which shows the number of teachers increased by 97 in 2012-13:

How does the Minister explain the claim that the Government has employed an additional 520 teachers since its election?

Answer-

The NSW Auditor-General's Reports, Volume Nine 2012: Focusing on Education and Communities and Volume Five 2013: Focusing on Education are based on changes in the numbers (headcount) of permanent teachers between 1 March 2011, 2012 and 2013 from the Department of Education and Communities' personnel system.

The employment of an additional 520 teachers since the Government's election relates to the Department's Workforce Profile data showing the change in full-time equivalent (FTE) teacher numbers between 30 June 2011 and 30 June 2012, where total teacher FTE increased from 61,144 to 61,664 for all teacher employment categories (permanent, temporary and casual).

CJC uses a variety of venues to provide mediation services in the Hunter Region, as it does across New South Wales. There are no set venues.

- *4974 LEGAL AID IN LOCAL COURT MATTERS—Ms Sonia Hornery asked the Attorney General, and Minister for Justice—
 - (1) How much money will be saved and jobs lost as a result of the decision to make Legal Aid only available to local court defendants who face imprisonment if convicted?
 - (2) What avenues for legal assistance remain for people intending to defend minor charges in the local court?

Answer-

I am advised:

There has been no reduction in staff in the Criminal Law Division, nor are there any planned reductions in staff, as a result of the decision to make legal aid only available to local court defendants who face a real possibility of imprisonment if convicted.

Free legal advice and minor assistance is also available to all individuals facing charges through advice clinics. These are available at Legal Aid offices around New South Wales and at some outreach locations.

The granting of legal aid will still be available to people who are not at risk of imprisonment in some circumstances.

*4975 HUNTER AND CENTRAL COAST PRIORITY SCHOOLS PROGRAM DEBATING COMPETITION—Ms Sonia Hornery asked the Minister for Education—

In 2014 funding for equity programs such as the former Priority Schools Program will be distributed directly to schools through the Resource Allocation Model.

In 2014 primary schools will have the choice to enter the Premier's Debating Challenge or form networks with other schools to conduct more localised competitions if they choose to do so.

- *4976 JOHN HUNTER HOSPITAL STAFFING LEVELS—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—

Answer—

I am advised:

Hunter New England Local Health District declined the request for an independent review on the grounds that John Hunter Hospital had already reviewed staffing numbers and provided this detail in discussions with NSW Nurses and Midwives' Association representatives, who had not raised any specific issue or concern with what was presented.

I am advised that this was supported by the Industrial Relations Commission which ruled on 28 October 2013 that an independent review was not necessary and that the Hunter New England Local Health District and the Nurses and Midwives' Association should consult on this matter.

This matter has since been closed by the Industrial Relations Commission.

John Hunter Hospital reviews its theatre nursing staff numbers monthly to ensure service demand is met.

- *4977 MANUFACTURING INDUSTRY IN HUNTER REGION—Ms Sonia Hornery asked the Deputy Premier, Minister for Trade and Investment, and Minister for Regional Infrastructure and Services—
 - (1) How is the Government ensuring that no more jobs are lost from the manufacturing industry in the Hunter region?
 - (2) What is the Government doing to create career paths for apprentices currently working in the manufacturing industry in the Hunter region?

Answer-

(1) The Government recognises the vast potential of the Hunter and is committed to supporting the region's continued growth. The Government, through NSW Trade & Investment oversees a range of initiatives which support local manufacturing and investment in the Hunter region. Key programs include the Regional Industries Investment Fund (RIIF), which provides financial assistance for projects that result in or promote economic growth in the region and payroll tax relief provided to manufacturing businesses taking on new employees through the Jobs Action Plan.

Other initiatives supported by NSW Trade & Investment include:

- A roundtable discussion of 15 of the Hunter's leading exporters hosted by RDA Hunter, which focused on a range of issues that will assist the region to grow as an export hub;
- A stakeholder roundtable convened by RDA Hunter in November 2013 that explored opportunities for growth in the Hunter region;
- The Hunter Infrastructure Forum, Mining Industry Forum and Defence Forum meetings, which are held monthly by HunterNet to inform local businesses about investment opportunities;
- Hunter Stakeholder group monthly meetings, in which NSW Trade & Investment, Ausindustry, Enterprise Connect, the Office of Environment & Heritage and Austrade collaborate to provide assistance to local manufacturing and other key industry sectors;
- The HunterNet Defence Project, which helps accelerate supply chain collaboration by identifying opportunities, building relationships, enhancing skills and helping SMEs win defence related contracts; and
- Support for the annual Hunter Manufacturing Awards which showcase best practice in manufacturing.

(2) The Government provides support to HunterNet, founder of the HunterNet Group Training Company which provides companies with structured on the job training programs and connects apprentices and trainees on behalf of employers throughout the Hunter region. The company ensures that training is tailored to satisfy the needs of employers, apprentices and trainees.

The Government also supports the RDA Hunter ME Program, a path for high school students to experience and explore career opportunities in the manufacturing industry.

The Director of Public Prosecutions (DPP) responded to the request for a review of the decision in this case on 13 November 2013. That response advised that the DPP had considered the request for review and did not propose to change the terms of his advice to NSW Police Force.

- *4982 VANDALTRAK GRAFFITI MANAGEMENT SYSTEM—Mr Paul Lynch asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
 - (1) Does the Endorsement Policy (or any other policy) of the NSW Police prevent them from using, receiving or viewing information from the VandalTrak Graffiti Management System concerning graffiti?
 - (2) If so, how can this policy be changed to allow NSW Police to access valuable information and material in the fight against graffiti?

Answer—

- I am advised the NSW Police Force's continued association with VandalTrak would breach its Sponsorship and Endorsement Policy. The NSW Police Force is obliged to adhere to Government guidelines relating to the procurement of goods and services.
- (2) The NSW Police Force fights graffiti as part of a broader Government anti-graffiti strategy. The NSW Graffiti Hotline enables the public to report graffiti in their community. The hotline can be called on 1800 707 125 from 9am to 5pm Monday to Friday, excluding public holidays. It enables Local Government Areas to receive referrals in real time to ensure a rapid response to graffiti removal.

Members of the public can also report incidents of graffiti or vandalism through the Police Assistance Line (131 444). The NSW Police Force responds to all reported incidents of malicious damage to public property and makes every effort to identify and charge the persons responsible.

*4983 EMPLOYMENT OF MATT DANIEL BY LIVERPOOL COUNCIL—Mr Paul Lynch asked the Minister for Local Government, and Minister for the North Coast—

The vacant land at Hoxton Park Road between Memorial Avenue and Maryvale Avenue owned by Roads and Maritime is surplus to road infrastructure requirements.

The land is zoned R4 High Density Residential under the Liverpool Local Environmental Plan 2008, permitting a wide range of uses with council consent.

The land will be sold in accordance with Government Property Principles contained in the Department of Premier and Cabinet's Memorandum M2012-20 and in line with the Treasurer's direction TD 469.01.

*4986 COMMUNITY JUSTICE PROGRAM—Mr Paul Lynch asked the Minister for Family and Community Services, and Minister for Women representing the Minister for Ageing, Minister for Disability Services, and Minister for the Illawarra—

When will the Minister provide adequate resources to the Community Justice Program to meet demand

On 3 December 2013, the Government launched Ready Together. By the conclusion of this program, the Community Justice Program will deliver 400 places with an annual budget of \$40.6 million.

The Cemeteries Agency, to be established as part of the Government's cemeteries and crematoria reforms and report to the Minister for Primary Industries, will work with Department of Planning and Infrastructure to assess current and future interment needs and develop planning strategies for cemetery space to meet those needs.

- *4992 LEGACY PAYMENTS FOR OLYMPIC FACILITIES—Mr Richard Amery asked the Minister for Sport and Recreation—
 - (1) Does the Government provide various councils with legacy payments for the upkeep of Olympic facilities?
 - (2) Has the Government provided Blacktown Council with legacy payments for the management and upkeep of the Olympic Park at Rooty Hill?
 - (a) If so, how much money has been paid to Blacktown Council since these payments commenced?
 - (3) Will the Government continue to provide these legacy payments to Blacktown Council and other councils?

Answer-

- (1) I am advised Sport and Recreation has only provided Blacktown City Council with funding for the upkeep of Blacktown International Sports Park.
- (2) I am advised by Sport and Recreation that between 2002-04 and 2012-13 Sport and Recreation provided Blacktown City Council with a total of over \$8 million in funding. The former Government provided Blacktown City Council with funding between 2004-05 and 2011-12 without any formal agreement. In 2012-13 a new one year funding agreement was negotiated.
- (3) Blacktown City Council has been advised that any future requests for funding would need to be supported by a comprehensive business case.

- *4993 MOUNT DRUITT SWIMMING POOL—Mr Richard Amery asked the Minister for Local Government, and Minister for the North Coast—
 - (1) Was the site of the Mount Druitt swimming pool being used as a public swimming pool at the time it was transferred to the Blacktown City Council?
 - (2) Was there any condition imposed that the land must be used for a public swimming pool?
 - (a) If so, is the Minister aware that the Blacktown City Council proposes to close the swimming pool, and sell the land for residential development?

Answer-

I provide the following details in response to your questions:

- (1) Council has advised the Division of Local Government that the pool was constructed approximately 40 years ago for the State Planning Authority. Council entered into a deed at that time to operate the pool. Ownership of the site was transferred to Council approximately 15 years ago.
- (2) I am further advised that there are no encumbrances on the Certificate of Title, and Council is unaware of any usage conditions imposed on the transfer of the site to Council.
 - (a) The management of assets and decisions relating to the allocation of a council's resources are matters for each individual council to determine.

*4994 DAPTO TAFE-Ms Anna Watson asked the Minister for Education-

- (1) Is the Minister aware of any plans by the Illawarra Institute of TAFE to dispose of the buildings and land at the Dapto TAFE campus or lease the buildings and land to a private training provider under the Smart and Skilled program?
 - (a) If so, on what date did the Minister become aware of these plans?
- (2) Will the Minister commit to retaining the buildings and land at the Dapto TAFE campus as an asset owned and managed by TAFE NSW?
 - (a) If not, why not?

Answer—

- (1) No. TAFE Illawarra is reviewing and adjusting its course offerings to match the changing patterns of employment and demand for training in its region. This review does not include the disposal or leasing of buildings or land at Dapto Campus.
- (2) Facilities at Dapto Campus will be retained as a TAFE NSW asset while they are required for the delivery of approved educational and training programs.
- *4995 RENAMING OF FLINDERS RAILWAY STATION—Ms Anna Watson asked the Minister for Finance and Services—

What is the progress of the Geographical Names Board of New South Wales' consideration of the proposal to rename the railway station formerly known as Flinders Railway Station to Shell Cove Railway Station?

Answer-

The proposed name 'Shell Cove Station' does not meet the Geographical Names Board of New South Wales' guidelines as the railway station is located outside the suburb of Shell Cove.

The Board has invited Transport for NSW to submit a revised proposal.

 - (2) Will the number of traffic cameras that provide images to the Live Traffic NSW App be increased?
 - (a) If so, when will they be increased;
 - (b) If not, why not?

Answer—

I am advised:

(1) No. The cameras used on the Live Traffic NSW website and mobile apps are special web cameras installed just for use by online customers.

- (a) The Transport Management Centre has access to more than 1,400 closed-circuit television cameras across New South Wales. However, these cameras are used for operational traffic management purposes and are not appropriate for displaying on the website and apps.
- (2) Yes. Twenty additional live traffic cameras were activated in December 2013, including locations on the M1 Pacific Motorway and M1 Princes Motorway, which will allow customers to plan their journeys more effectively. These new cameras are available on the Live Traffic NSW website and in the smartphone applications.

The Live Traffic NSW website and smartphone apps have also been upgraded to be faster, simpler and more useful for smartphone users. The apps have all the latest traffic information, personalised incident alerts, and access to live traffic cameras.

- *4997 TENDERS FOR PROVISION OF HOMELESSNESS SERVICES—Mr Ryan Park asked the Minister for Family and Community Services, and Minister for Women—
 - (1) Why has an open tender not been announced for the provision of specialist homelessness services, given the committment to do so by 18 November 2013?
 - (2) Is the Minister aware that agencies have engaged consultants and suspended staff holiday leave in order to assist in the preparation of tenders?
 - (3) How does the Minster intend to assist these agencies with the tender process?
 - (4) When will the Minister provide certainty around the time frames for implementing reforms to the provision of specialist homelessness services?

Answer-

An updated timeframe for tender opening and closing has been announced and information on the Government's reform of the Specialist Homelessness Service sector is available on the Housing NSW website.

- *4998 NEWINGTON COLLEGE STUDENT TRAVEL PASS—Ms Carmel Tebbutt asked the Minister for Transport—
 - (1) Will the Government continue to provide Newington College students residing in the inner west with both a bus and train pass so they have access to safe and timely alternate modes of transport when after school commitments prevent them from using the designated school bus?
 - (2) If not, why not?

Answer-

I am advised:

The School Student Transport Scheme ensures that all New South Wales school students, who do not live close to their school, have access to education through free travel to and from school. Transport for NSW is required to select the most appropriate and cost-effective transport mode for each student.

From the end of 2013, Transport for NSW will no longer issue students with both train and bus passes for the journey to and from Newington College, as a suitable journey can be taken by buses alone.

There are a number of bus routes operating within 900 metres of the school. This includes Route 444 for students travelling between Stanmore and Balmain, Rozelle and Ryde. Students who need to interchange in the Sydney CBD can use Route 428 from Addison Road, a 450 metre walk from the school.

This decision does not prevent Newington College students travelling on other services, including train services. School students are entitled to half price fares when using trains, buses and ferries.

*4999 CRITICAL INDUSTRY CLUSTERS IN THE HUNTER VALLEY—Mr Clayton Barr asked the Minister for Primary Industries, and Minister for Small Business—

- (1) What criteria were used to determine which vineyards were included in the recently released Government maps of critical industry clusters in the Hunter Valley?
- (2) What criteria were used to determine which horse breeding areas were included in the maps?
- (3) Were any existing and established vineyards not included in the maps?(a) If so, on what grounds?
- (4) Were any existing and established horse breeding properties not included in the maps?(a) If so, on what grounds?

Answer-

- (1) Viticulture enterprises included in the exhibited maps comprise three categories: vineyards, cellar door/wineries and wine industry related tourism. The remapping identified establishments currently used as a vineyard and confirmed through one or more of the following:
 - Full member of the Hunter Valley Vineyard Association as listed on the Hunter Valley Wine Industry Association website.
 - Submitted a Livestock Health and Pest Authority annual return indicating "vineyard" in the past year.
 - Identified on a council database of vineyards (Muswellbrook Shire Council), contains vineyards mapped by AGL from aerial photograph analysis.
- (2) Equine enterprises included in the exhibited maps comprise three categories: horse breeding, horse husbandry and horse sales. The remapping has so far identified horse breeding enterprises through one or more of the following sources:
 - The list of members of the Hunter Thoroughbred Breeders Association and the Australian Stock Horse Society.
 - The database of horse studs compiled by Upper Hunter and Muswellbrook Councils.
 - The Livestock Health and Pest Authority annual return which specified 15 or more horses.
- (3) The purpose of the public exhibition of the viticulture critical industry cluster maps is to determine whether all existing and established enterprises have been identified. Enterprises that meet the criteria and submit the relevant information by the closing date will be considered by Government as additions to the critical industry cluster area.
- (4) The purpose of the public exhibition of the equine critical industry cluster maps is to determine whether all existing and established enterprises have been identified. Enterprises that meet the criteria and submit the relevant information by the closing date will be considered by Government as additions to the critical industry cluster area.

The Ministerial Consultative Committees are representative of the local community and aim to work with the Government on the needs, interests and concerns of the multicultural community in New South Wales.

- (2) Under Local School, Local Decisions resources to provide English language instruction will be allocated to schools annually. Principals will develop, implement and report annually on a school plan that connects student learning outcomes and the school budget.
- *5008 ACCOUNTABILITY OF LOCAL SCHOOLS LOCAL DECISIONS—Mr Guy Zangari asked the Minister for Education—

What specific monitoring and accountability mechanisms will the Minister establish to ensure future Local Schools Local Decisions program implementation complies with the Community Relations Commission and Principles of Multiculturalism Act?

Answer-

The Department's current Multicultural Education Policy addresses the requirements of and complies with the Community Relations Commission and Principles of Multiculturalism Act 2000. Under Local Schools, Local Decisions, principals will be required to develop, implement and report annually on a school plan that connects student learning outcomes and the school budget.

Answer—

(1) Cemeteries on land for which a Crown reserve trust has been established include:

- Rookwood Cemetery, jointly managed by a trust board and a corporation;
 - 10 cemeteries managed by 6 trust boards;
- 5 cemeteries managed by 5 corporations; and
- 118 cemetery reserves under trust management by 54 local councils.

In addition, there are 1073 cemetery reserves managed by 120 local councils under LGA s48 and 5 cemetery reserves in the Unincorporated Far West Region managed by the NSW Government.

Answer-

The Government is proceeding with the redevelopment of all large residential centres by mid 2018. The Government is committed to providing modern and appropriate accommodation for people with disability.

- *5024 PORT OF NEWCASTLE LEASE—Mr Clayton Barr asked the Treasurer, and Minister for Industrial Relations—
 - (1) Will the successful lessor of the Port of Newcastle be required to pay the full purchase price within the first three years to ensure the promised funds for Newcastle can be provided by the Government?
 - (2) Will the Treasurer confirm that contracts entered into between the successful lessor and the Government will include a clause that no sublease can be entered into by the lessor and a third party to ensure the community will always be aware of the use of the Port?

Answer-

(1) An upfront payment, as was the case for Ports Botany and Kembla, will be made for the lease of the Port of Newcastle.

The Government will invest \$340 million of transaction proceeds in the revitalisation of the Newcastle CBD, including the light rail project. These proceeds are in addition to the \$120 million total already allocated from the Hunter Infrastructure and Investment Fund (\$60 million) and Restart NSW (\$60 million).

- (2) The lease, as is the case for Ports Botany and Kembla, will include port stewardship obligations and permitted uses of the leased area. The lease will be a registered and publicly available document at the Land Titles Office.

The Radio School pilot program was successfully rolled out in November 2012 to frontline staff at a number of locations on the Illawarra Line. Customers at these locations enjoyed a marked improvement in the quality of announcements.

The full program rollout commenced in August 2013 across the Sydney Trains and NSW TrainLink networks, and is due for completion in June 2014.

- *5027 JOHN HUNTER HOSPITAL NEUROSURGEON WAITING TIME—Mr Clayton Barr asked the Minister for Health, and Minister for Medical Research—
 - (1) What is the expected waiting time to be given an appointment with a neurosurgeon at John Hunter Hospital?
 - (2) How many neurosurgeons are available to see public hospital patients at John Hunter Hospital?
 - (3) What waiting time is deemed unacceptable for an appointment not to be allocated at John Hunter Hospital?

Answer-

I am advised:

Patients referred to John Hunter Hospital's outpatient clinics to see a neurosurgeon are offered an appointment based on their clinical urgency on advice from referring GPs.

Five neurosurgeons are available to see patients at John Hunter Hospital.

Patients who believe there has been a change in their condition while waiting for an appointment are advised to visit their treating GP again so a revised referral can be issued and their clinical priority re-evaluated.

*5028 SPECIALIST EDUCATIONAL CONSULTANCY CONTACTS CESSNOCK ELECTORATE—Mr Clayton Barr asked the Minister for Education—

As a result of the reduction to the statewide network of Multicultural and English as a Second Language (ESL) Consultant, Refugee Support Officer and Community Information Officer positions, who will public schools in the Cessnock electorate now contact:

- (b) For support if there is a breakdown in community relations or cultural misunderstanding between their school and the local community;
- (c) For advice about enrolling and supporting a newly arrived family with children of unknown ages and visa subclass who do not speak English;
- (d) In order to access ESL professional learning programs for class teachers so that they can provide a culturally inclusive and language rich classroom learning environment for all students?

Answer-

Through the Local Schools, Local Decisions education reform, principals will make decisions about the type and level of support required to meet the needs of their students and their communities. Schools will have much more flexibility to direct resources according to local priorities. This includes strategies for countering racism, determining the best way to establish effective partnerships with families, and English language and settlement support for students, including newly arrived migrant and refugee students.

Multicultural and ESL Advisors in the Equity team in the Department's Learning and Leadership Directorate will work in collaboration with Educational Services Directors and their teams located throughout New South Wales to build the capacity of school leaders and assist schools in accessing the professional learning they need to implement appropriate programs and strategies.

- *5031 ILLEGAL STREET DRAG RACING—Ms Tania Mihailuk asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
 - (1) What measures are being implemented to deter illegal street drag racing on New South Wales roads particularly in light of the recent fatality in Greenacre?
 - (2) What measures have been implemented to deter illegal street drag racing in the Bankstown electorate in the past year?

Answer-

The NSW Police Force has advised me that its Traffic and Highway Patrol Command (THPC) works with the Centre for Road Safety and Roads and Maritime Services through the Road Safety Coordination Group to address road safety issues including street racing. Known social media sites are regularly monitored and high visibility patrols conducted in identified areas to deter and detect racing. THPC is also working with the Environmental Protection Authority, Councils, private land owners, car enthusiast clubs and local shows to educate and limit opportunities for street racing.

A number of recent operations have been conducted in the Sydney metropolitan region, along with high visibility patrolling and stationary enforcement in locations known for street racing. Police advise that street racing in the Bankstown Local Area Command is generally opportunistic rather than planned, and the THPC has no current complaints about street racing in the area.

There is a highly visible police presence in the Bankstown area, with the Bankstown Highway Patrol's nine marked vehicles supported by Region resources, Traffic Strike Force and Traffic Support Group as required. In the past year, 115 street racing offences were detected and vehicle sanctions imposed. Eight of these were in Bankstown.

*5032 RAISING AWARENESS OF CARDIOVASCULAR DISEASE—Ms Tania Mihailuk asked the Minister for Mental Health, Minister for Healthy Lifestyles, and Minister for Western New South Wales—

What measures have been implemented in the Bankstown electorate to raise awareness of the lifestyle factors which are contributing to the increased instances of cardiovascular disease?

Answer—

I am advised:

Bankstown-Lidcombe Hospital provides a cardiac rehabilitation program for patients who have had a cardiac event. This includes exercise programs and information to patients and their families about heart disease and how to better manage lifestyle factors such as exercise regimes and diet.

The Hospital also coordinates a heart failure clinic for chronic and complex patients. As part of the clinic a Registered Nurse visits patients and facilities in the community and provides education on risk factors and provides individual management plans.

Other awareness strategies include "heart week" providing for the community a free service which includes checking blood pressure, body mass index and waist circumference measurements and offering community awareness on the risk factors and how to prevent heart disease through lifestyle changes. Education leaflets about the service are made available to the community in culturally and linguistically appropriate languages at these events.

A further initiative known as The Heart Support Program also offers patients and families ongoing education in the community. The patron of this program, a Cardiologist at Bankstown, attends community meetings every six weeks to discuss awareness and prevention of heart disease. Additional initiatives of this group include attendance at shopping centres and large retail outlets promoting heart health and offering support and advice for health checks.

*5033 RAISING AWARENESS OF DRUG AND ALCOHOL RISKS—Ms Tania Mihailuk asked the Minister for Mental Health, Minister for Healthy Lifestyles, and Minister for Western New South Wales—

What measures have been implemented in the Bankstown electorate to increase awareness regarding the lifestyle risks associated with the consumption of drugs and alcohol?

Answer—

I am advised that:

The South West Sydney Local Health District provides a range of services in the Bankstown area to address harms associated with drug and alcohol use. The Bankstown Community Health Centre offers drug and alcohol counselling and harm minimisation services including brief intervention, referral and provision of clean injecting equipment. In addition, an Opioid Treatment Unit, which provides treatment for opioid dependence, is located at Bankstown-Lidcombe Hospital.

South West Sydney Local Health District's Drug Health Services also liaise with NEAMI, a local nongovernment organisation which provides mental health rehabilitation and recovery, to promote awareness of drug and alcohol issues and advise treatment options.

The District also supports the Bankstown Community Drug Action Team, comprising membership from local service providers whose focus is drug and alcohol prevention. During Drug Action Week in June 2013, the Bankstown Community Drug Action Team collaborated with local youth workers from Barnardo's to conduct a range of activities to occupy young people and provide health education on drug and alcohol related issues.

In addition, the 'Drug info at your library' resource and book collection is on permanent display at the Bankstown Library. The collection is a partnership between NSW Ministry of Health and the State Library of NSW which provides access to reliable and authoritative information on drugs and alcohol for the New South Wales community. The Bankstown City Library and four Bankstown library branches have 65,375 registered library members (2011-12).

Free drug and alcohol information resources are also available to Bankstown residents through the NSW Health drug and alcohol information website www.yourroom.com.au - for viewing and online ordering. In the last 12 months more than 2,000 resources have been delivered to services in Bankstown including Bankstown Hospital and Bankstown Women's Health Centre.

The Ministry of Health has also implemented the state-wide 'Know when to say when' campaign which ran between January and May 2013. The campaign addressed the issue of excessive alcohol consumption and the potential social and lifestyle impacts.

*5034 PAWNBROKER INTEREST CHARGES—Ms Tania Mihailuk asked the Minister for Fair Trading—

- (1) How many instances of breaches to the interest charging provisions of the Pawnbrokers and Second Hand Dealers Act 1996 have been investigated by NSW Fair Trading in the past two years?
- (2) What measures is NSW Fair Trading implementing to protect consumers from illegal interest charges

by pawnbrokers?

Answer—

Sections 32A and 32B of the Pawnbrokers and Second-Hand Dealers Act 1996 (the Act) concern the charging of interest by pawnbrokers. NSW Fair Trading has no records of alleged breaches of these sections over the past two years. Accordingly Fair Trading has not conducted any investigations of breaches to the interest charging provisions of the Act in that time.

Fair Trading conducts proactive operations on pawnbrokers and second-hand dealers to check for compliance with the Act, which includes checking forbreaches of the interest charging provisions. Fair Trading also acts on complaints received from the public.

*5035 LICENSED PAWNBROKERS-Ms Tania Mihailuk asked the Minister for Fair Trading-

- (1) How many licensed pawnbrokers are operating in New South Wales?
- (2) How many licensed pawnbrokers are operating in the Bankstown electorate?
- (3) How does this figure compare proportionately to other electorates within New South Wales?

Answer—

The total number of licensed pawnbrokers in New South Wales is 754. Licensing data is not recorded on an electoral basis and therefore data is not available on the number of licensed pawnbrokers in an electoral area. Accordingly, comparisons cannot be made between electorates.

*5036 DUNC GRAY OLYMPIC VELODROME—Ms Tania Mihailuk asked the Minister for Sport and Recreation—

What support has the Government provided to Bankstown City Council and the Bankstown Sports Club to ensure the future viability of the Dunc Gray Olympic Velodrome site?

Answer-

I am advised:

Sport and Recreation provides no direct operating subsidy to Bankstown City Council or the operator, Bankstown Sports Club. Any request for funding from Bankstown City Council or Bankstown Sports Club would need to be supported by a comprehensive business case.

*5037 SPECIALIST EDUCATIONAL CONSULTANCY CONTACTS BANKSTOWN ELECTORATE—Ms Tania Mihailuk asked the Minister for Education—

As a result of the reduction to the statewide network of Multicultural and English as a Second Language (ESL) Consultant, Refugee Support Officer and Community Information Officer positions, who will public schools in the Bankstown electorate now contact:

- (a) For support in dealing with an incident of racism at their school;
- (b) For support if there is a breakdown in community relations or cultural misunderstanding between their school and the local community;
- (c) For advice about enrolling and supporting a newly arrived family with children of unknown ages and visa subclass who do not speak English;
- (d) In order to access ESL professional learning programs for class teachers so that they can provide a culturally inclusive and language rich classroom learning environment for all students?

Answer-

Through the Local Schools, Local Decisions education reform, principals will make decisions about the type and level of support required to meet the needs of their students and their communities. Schools will have much more flexibility to direct resources according to local priorities. This includes strategies for countering racism, determining the best way to establish effective partnerships with families, and English language and settlement support for students, including newly arrived migrant and refugee students.

Multicultural and ESL Advisors in the Equity team in the Department's Learning and Leadership Directorate will work in collaboration with Educational Services Directors and their teams located throughout New South Wales to build the capacity of school leaders and assist schools in accessing the professional learning they need to implement appropriate programs and strategies.

*5038 LIVE MUSIC AND PERFORMANCE ACTION PLAN—Mr Alex Greenwich asked the Minister for Tourism, Major Events, Hospitality and Racing, and Minister for the ArtsRegarding the Live Music and Performance Action Plan developed by the City of Sydney's Live Music and Performance Taskforce which reports that this industry generated revenues of \$1.21 billion in Australia in 2009-10 and identified significant barriers to live music and performance in New South Wales:

- (7) What consideration has been given to streamlined and more flexible temporary liquor licences for live music and performance venues?
- (8) What consideration has been given to financial assistance programs that support live music and performance venues?
- (9) What other action does the Government plan to support and promote live music and performance venues?

Answer—

The Government was not represented on the task force. The Government will consider the taskforce report as part of the development of the NSW Arts and Cultural Policy.

*5039 OXFORD STREET LIQUOR LICENCE FREEZE—Mr Alex Greenwich asked the Minister for Tourism, Major Events, Hospitality and Racing, and Minister for the Arts—

Regarding the freeze on new and expanded liquor licences on Oxford Street, Darlinghurst which is set to end on 24 December 2013:

- (1) What assessment has been made of the risk that lifting restrictions in the Kings Cross Plan of Management, including the liquor licence freeze and ID scanning, will cause licensed venues to proliferate in Oxford Street, Darlinghurst?
- (2) Will a tool to prevent saturation of licensed premises and cumulative impacts be available for use on Oxford Street, Darlinghurst from 24 December 2013?
- (3) To what extent has the Government identified the number of venues and patrons that Oxford Street, Darlinghurst can sustainably accommodate, given NSW Bureau of Crime Statistics and Research data shows a strong link between alcohol outlet density and assaults?
- (4) Will the Minister extend the liquor freeze on Oxford Street to ensure that drops in alcohol related crime in this location are not reversed?

Answer-

- (1) An evaluation of the various strategies under the Kings Cross Plan of Management will be undertaken to inform future decisions regarding the Kings Cross precinct. Possible displacement effects will be considered as part of this evaluation.
- (2) The Environment and Venue Assessment Tool (EVAT) is currently being trialled in the City of Sydney (including the Oxford St/Darlinghurst freeze precinct) and City of Newcastle local government areas. This tool provides evidence-based risk assessments for each new liquor licence application in the two trial areas. The trial continues until March 2014, and the outcomes of an evaluation of the EVAT trial will be considered by the Government in mid 2014.
- (3) While the Government has not determined a maximum number of venues or patrons for the Oxford St/Darlinghurst precinct, applications in higher density areas will be assessed by the EVAT as higher risk. As part of the EVAT trial, these risk assessments are currently being used to inform the

Independent Liquor & Gaming Authority's decision making for new licence applications in the two trial areas.

- (4) Alcohol related crime data for the Oxford St/Darlinghurst freeze area has informed the Government's decision to extend the Oxford St/Darlinghurst liquor licence freeze to 24 June 2015.
- *5040 SYDNEY HARBOUR CLEAN UP—Mr Alex Greenwich asked the Minister for the Environment, and Minister for Heritage—
 - (1) When were remediation works in relation to dioxin pollution in Homebush Bay and Sydney Harbour completed?
 - (2) Which sites have been cleaned up since the commercial fishing ban was introduced in early 2006 due to dioxin contamination?
 - (3) What sites does the Government plan to clean up in the future?
 - (4) What pollutants other than dioxins have been found and removed from Homebush Bay and Sydney Harbour?
 - (5) What intergenerational change in relevant fish species have been found with regard to contaminated sediment and dioxin levels in Homebush Bay and Sydney Harbour ?
 - (6) What conclusions have been made on remediation outcomes?
 - (7) What further work is required to remove contamination from Homebush Bay and Sydney Harbour? Answer—

I am advised as follows:

- (1) Remediation works in Homebush Bay were completed in 2009. There have been no other remediation works related to contamination by dioxins in Sydney Harbour.
- (2) The site cleaned up due to contamination by dioxins was approximately 8 hectares of Homebush Bay.
- (3) Remediation of elevated levels of tars in Kendall Bay is to be remediated by Jemena Gas Networks (NSW) LTD under regulation by the Environment Protection Authority.
- (4) Lead contamination has been found and removed in Homebush Bay by Orica.
- (5) The testing of fish for assessment of intergenerational change in levels of dioxins is scheduled for 2014-15.
- (6) The testing in 2014-15 will inform the assessment of remediation outcomes.
- (7) No further remediation work is planned for Homebush Bay. Remediation is planned for Kendall Bay. (refer to note 3 and 6 above)
- *5041 NATIVE VEGETATION ACT COMPLIANCE—Mr Alex Greenwich asked the Minister for the Environment, and Minister for Heritage—
 - (1) How many breaches of the Native Vegetation Act 2003 have been detected over the last three years?
 - (2) Of these breaches, how many hectares of native vegetation were cleared?
 - (3) How does the Government monitor compliance with the Act?
 - (4) How does the Government encourage compliance with the Act?
 - (5) What assessment has the Government made of the importance of native vegetation and habitat on private land in protecting biodiversity and threatened species?
 - (6) Does the Government remain committed to banning the clearing of native vegetation on private land?

Answer—

I am advised as follows:

- (1) For the period July 2010 until June 2013, the NSW Office of Environment and Heritage (OEH) undertook 361 compliance actions for alleged breaches of the Native Vegetation Act 2003. These actions included issuing warning letters, penalty notices, remedial directions and undertaking prosecutions.
- (2) For the period July 2010 until June 2013, OEH undertook nine successful prosecutions in relation to 592 hectares of alleged illegal clearing, and issued 59 directions to remediate 4,004 hectares of cleared land. OEH does not keep data on the area of alleged illegal clearing related to warning letters and penalty notices as accurate collection of spatial data requires significant work and validation that is not warranted for these lower risk cases.
- (3) Monitoring activities include field surveillance by OEH staff; reports from other Government authorities; reports from the public via the 131 555 Environment Line, targeted charter aircraft surveillance; and a state-wide satellite monitoring program using Landsat and SPOT5 imagery.

LEGISLATIVE ASSEMBLY QUESTIONS AND ANSWERS Tuesday 14 January 2014

- (4) This Government actively promotes compliance with native vegetation legislation by assisting the community to understand and meet their legislative obligations. This includes developing and publishing fact sheets on the OEH website and working with Catchment Management Authorities to disseminate information at field days and directly to landholders. Promotional campaigns include advertisements in local media across the state about the state-wide satellite monitoring program, and informing others who work with landholders including clearing contractors, stock and station agents, and lenders about the requirements of the law. Media coverage of court actions also helps ensure that the minority of people considering breaching the law are aware of the potential consequences.
- (5) The importance of native vegetation on private land in providing habitat for biodiversity and threatened species has long been recognised by scientists, is widely accepted in the community, and is acknowledged by this Government. There is a wealth of information on the OEH website about the value of native vegetation.
- (6) The focus of this Government is on building an effective, streamlined system for the management of native vegetation on private land that supports farmers to manage native vegetation on their land. We have started this work with the introduction of the Native Vegetation Regulation 2013 and we will continue this work with the exhibition of new self-assessable codes for certain clearing activities in the New Year. Clearing is not now, and has never been, banned on private land. This Government remains committed to appropriate management of native vegetation, including through sensible exemptions to allow a range of activities such as day to day farming activities and to protect life and property from the threat of bushfire.

 - (1) How many fines have been issued for illegal hunting in the last three years?

 - (a) Game and feral animals;
 - (b) Dogs used in hunting such as pig dog hunting?

- *5043 BACKPACKER IMPACTS ON KINGS CROSS—Mr Alex Greenwich asked the Premier, and Minister for Western Sydney—

With regard to growing reports that some backpacker hostels in Kings Cross create significant noise and anti-social behaviour impacts associated with hundreds of patrons consuming liquor late at night on the premises and adjacent footpaths:

- (1) What assessment has the Government made of this issue?
- (2) What discussions have occurred between Government agencies to develop a whole-of-government response to this issue including the NSW Police Force, the Department of Planning and Infrastructure, the Office of Fair Trading and the Independent Liquor and Gaming Authority?
- (3) What liaison has occurred with the City of Sydney on this issue?
- (4) What legislative changes is the Government considering to deal with this issue?
- (5) What consideration will the Government give to requiring all backpacker hostels to establish a plan of management that includes rules to prevent noise and anti-social behaviour?
- (6) What other action does the Government plan to address this concern?

Answer-

The compliance of backpacker hostels in Kings Cross is a matter for the City of Sydney under the relevant planning controls.

- (7) What plans does the Government have to ensure all police officers are briefed on LGBTIQ history and cultural competency prior to working at major LGBTIQ events such as the Mardi Gras Festival?
- (8) What assessment has been made of the public order risks during the Sydney Mardi Gras Festival and how will this assessment determine the scale and approach of policing at the 2014 festival?

- (13) What measures has the Government taken to restore confidence in potential overseas visitors about safety and policing at Mardi Gras Festival events?
- (14) What information and education materials will the Government provide to overseas visitors to ensure they understand relevant legislation and police operations when attending Mardi Gras Festival events?
- (15) What other action will the Government take to ensure the reputation of future Sydney Mardi Gras Festivals have not been damaged by the incidents that occurred in 2013?

Answer-

The Department of Premier and Cabinet convenes whole of government planning meetings for the Mardi Gras Parade. Planning meetings include representatives of Sydney Gay and Lesbian Mardi Gras, NSW Police and stakeholders such as City of Sydney Council and the Transport Management Centre. On the day of the parade, representatives of NSW Government agencies along with a representative from Mardi Gras, oversee management of the Parade from the NSW Police Operations Centre.

Local Area Command and Major Events and Incidents Group Commanders are consulting and working closely with the Sydney Gay and Lesbian Mardi Gras Organising Committee in preparation for the 2014 Mardi Gras Festival.

As with all police operations, thorough and ongoing risk assessment processes will be undertaken during the planning phase to determine any risks and appropriate mitigation strategies. Police are working with the Mardi Gras Organising Committee to develop appropriate briefing material for officers deployed to

festival events and the CEO of Mardi Gras 2014 will address police during the final pre-festival deployment briefing.

The NSW Police Force's policy on Sexuality and Gender Diversity 2011-2014 Working with lesbian, gay, bisexual, transgender, intersex and queer (LGBTIQ) people supports all NSW police officers to gain a better understanding of LGBTIQ issues.

Whilst reaffirming its commitment to working productively with LGBTIQ people, the policy formalises a commitment to working with these communities to prevent and reduce crime and the fear of crime.

LGBTIQ specific cultural training is provided to all student police officers prior to attestation and the LGBTIQ Corporate Spokesperson is working with Mardi Gras and other community representatives to enhance and expand training material in this area for wide circulation to all ranks within the NSW Police Force.

The NSW Police Force is committed to the Gay and Lesbian Liaison Officer (GLLO) program and will continue to ensure the program is achieving its goals. Region Sponsors for Sexuality and Gender Diversity have been appointed in all police Regions and will provide support to the GLLO network at a regional level.

There are approximately 200 police GLLOs located across metropolitan and regional Local Area Commands in New South Wales. Their primary focus is to improve the capacity of officers within their commands to work effectively with communities in response to key issues such as prejudice related violence, domestic violence in same sex relationships and challenging homophobic bullying in schools.

Regarding drug dog operations, at the Mardi Gras After Party a senior officer will be deployed to assess determinations made by arresting police and provide advice to officers to ensure they are exercising search powers appropriately and that people being searched understand their rights and obligations in terms of compliance. Searches will be conducted in enclosed search areas in a manner that takes into account issues such as privacy and gender sensitivity. Police uniforms are an operational matter for the NSW Police Force. Appropriate uniforms allow police officers to be easily identified during an event.

The LGBTIQ Corporate Spokesperson and officers from Surry Hills Local Area Command have been working with the Inner City Legal Centre and ACON's Anti Violence Project in relation to the publication of joint advice regarding legislation, individual rights and behavioural expectations for visitors and all those involved in Mardi Gras festival events.

Members of the LGBTIQ community may be assured that the NSW Police Force is committed to interacting appropriately with all victims of crime and has a responsibility to respond to and treat victims, and indeed all members of the community, with compassion, courtesy and respect.

The Government, through Destination NSW, has continued its support for the Mardi Gras in 2014 and is working with the Mardi Gras Board.

The Mardi Gras is an important event on the New South Wales Major Events Calendar and we will continue to invest in this event to ensure it continues to be an intern ational draw card for tourist to Sydney.

In 2013 Destination NSW played a major role in promoting the 35th anniversary; as they did in 2012 by working with the Mardi Gras Board to reinvigorate the parade, including securing Kylie Minogue as the Ambassador.

Tourism figures over the past two years have indicated an increase in overnight visitation and a resurgence in crowd numbers, showing the success of the event and its importance of to the New South Wales visitor economy.

*5045 ALEXANDRIA PARK COMMUNITY SCHOOL—Mr Alex Greenwich asked the Minister for Education—

- (1) What plans does the Government have to upgrade and expand library facilities at Alexandria Park Community School Senior Campus?

During the preparation of that report, extensive community consultation was undertaken, including written submissions, and consultation with the community and opinion leaders. All submissions and the result of all consultation were taken into consideration in making recommendations for the future use of the site. The recommendations from that report, notably that the site remains in public ownership and that a trust be established to manage the site, were accepted by the Government.

 - (1) For the Greater Metropolitan Region of Sydney, including the Sydney, Hunter and Illawarra regions, a 2005 report indicated that critical shortages will occur by 2036 and all current grave sites may be used by 2050, if not before. For some communities the shortage will be imminent. The report indicates that there were 680,000 grave sites available at that time.
 - (2) Unknown, there has been no further count of grave site numbers since the 2005 report.
