# 10 AUGUST 2016

#### (Paper No. 80)

\*3733 SKILLED OCCUPATIONS LIST-Ms Jo Haylen asked the Minister for Health-

- (1) Will the Minister provide a response to plans mooted by the Commonwealth Government to remove general practitioners (GPs), resident medical officers, surgeons and anaesthetists from the Department of Immigration's Skilled Occupations List?
- (2) What will be the impact on GP services in New South Wales, particularly in regional New South Wales where demand for GP services is high?
- (3) How does the Minister plan to improve access to general practitioner services in light of the Commonwealth's plans?

Answer-

(1) to (3) All jurisdictions and the Commonwealth will discuss this issue at the November 2016 meeting of the Health Workforce Principal Committee.

New South Wales continues to address rural medical workforce issues including through:

- The NSW Health Professionals Workforce Plan 2012-2022 which contains a broad range of strategic initiatives, including targeted rural workforce growth and development.
- Expanding the Rural Generalist Training Program.
- Funding \$1.2 million over four years for the Metropolitan Access Scholarship Program, which supports rural-based medical trainees to undertake training at metropolitan hospitals.
- The Rural Preferential Recruitment Program, which enables junior doctors to complete their internship in a rural hospital. A total of 115 interns were recruited via this program for 2016, an increase of 21 from 2015.
- NSW Health has supported the Rural Doctors Network since 1988. In 2016-17, \$1.54 million has been granted to support GP recruitment and training.
- The Area of Need Program supporting recruitment of international medical graduates.
- \*3734 ITEMS RECOVERED FROM DEMOLISHED HABERFIELD HOMES—Ms Jo Haylen asked the Minister for Planning—
  - (1) Have items recovered from Haberfield homes demolished for Westconnex and identified as being of value been retained and/or sold by the private companies contracted to demolish the properties?(a) Who has been the beneficiaries of these sales?
  - (2) Have private companies benefited from the sale of heritage or valuable items recovered from homes acquired for other infrastructure projects including the Lane Cove Tunnel or Northconnex?

Answer-

Condition B24 of the M4 East determination requires the proponent to salvage items and materials from heritage items (excluding potential heritage items) as advised by an independent heritage consultant. How the items are reused in the project is to be detailed in the Urban Design and Landscape Plan. Any residual items and materials must be made available, through a process to be developed by the proponent in consultation with the relevant council(s), to property owners within the locality or heritage conservation area from where the item or material originated.

I am advised that the Department of Planning and Environment has not identified any breach of this condition.

Information on the remaining issues should be sought from the Minister for Roads, Maritime and Freight.

\*3735 WESTCONNEX CONSTRUCTION SITES—Ms Jo Haylen asked the Minister for Planning—

- (1) Has the removal of buildings and homes for the Westconnex construction sites in Haberfield and Ashfield amplified noise levels from the site beyond what was predicted in the Environmental Impact Statement?
- (2) Do the noise levels emanating from the sites reflect the levels in the Minister's conditions of approval?
- (3) Considering the number of complaints about noise from the sites, what actions are being taken to mitigate noise and provide respite to neighbouring residents?

Answer-

I am advised that, as at 7 September 2016, all complaints in relation to the New M5 approval that have been received by the Department have been investigated or are in the process of being investigated by the Department. No breaches of conditions have been identified.

Every person who has made a complaint has received a response from the Department in person, by phone, or by email to assess their concerns.

- \*3736 MARRICKVILLE AND ASHFIELD FIRE STATIONS—Ms Jo Haylen asked the Minister for Corrections, Minister for Emergency Services, and Minister for Veterans Affairs—
  - (1) How many full-time and part-time equivalent staff are currently based at Marrickville and Ashfield fire stations?
  - (2) What is the average response time for both stations?
  - (3) How many vehicles are based at each station?
    - (a) What is the average age of vehicles at each station?
    - (b) What is the timeline for vehicles to be replaced at both stations?

#### Answer—

(1) Marrickville and Ashfield fire stations both have 21 full-time firefighters who work a 24 hour roster across four shifts.

(2) Average response times, based on a 12 month average from the time a call is assigned until fire trucks arrive on scene at an incident, are as follows:

Marrickville Fire Station: six minutes 33 seconds.

Ashfield Fire Station: six minutes 53 seconds.

(3) Both fire stations have one fire truck based at the station, scheduled for replacement in the 2018-19 financial year. The fire truck at Marrickville is 11.5 years old and the fire truck at Ashfield is 11 .8 years old .

- \*3737 WOMEN LIVING IN BOARDING HOUSES—Ms Jo Haylen asked the Minister for Mental Health, Minister for Medical Research, Assistant Minister for Health, Minister for Women, and Minister for the Prevention of Domestic Violence and Sexual Assault—
  - (1) What support is the Government offering to women living in boarding houses who are fleeing domestic violence and housing insecurity to provide pathways into more secure housing?
  - (2) How many calls to the Link to Home Service have been made by women living and facing difficulties in boarding houses?

Answer—

The 2016-17 NSW Budget invests \$100 million over four years for the Start Safely housing program. Start Safely provides private rental subsidies for people leaving domestic violence. Funding has been doubled and includes \$43 million over four years in base funding and \$57 million over four years under the Future Directions reform of Social Housing.

- \*3738 COOKS RIVER—Ms Jo Haylen asked the Minister for Industry, Resources and Energy representing the Minister for Primary Industries, and Minister for Lands and Water—
  - (1) How many times a year are the booms in the Cooks River cleared of litter?
  - (2) Are there plans to install other litter booms along the river?
  - (3) Has Sydney Water assessed the impact of wetlands and trees along the banks of the river in ridding it of pollutants?

(a) If so, what are the benefits to water quality of having trees along the banks of the river?

Answer—

- (1) 52.
- (2) Yes.
- (3) The benefits associated with wetlands and trees differs according to the setting. Between 2013 and 2015 Sydney Water replaced sections of the concrete channel along the Cooks River with more natural riverbanks at a comparable renewal cost. The work has improved the natural environment

and character of the river. as well improving the stormwater system an providing habitat for native birds and animals. This was determined to be the optimal solution for this site.

- \*3739 HOUSING NSW PROPERTIES IN THE GRANVILLE ELECTORATE—Ms Julia Finn asked the Minister for Family and Community Services, and Minister for Social Housing—
  - (1) How many Housing NSW properties in the Granville electorate have outstanding maintenance orders as of 1 August 2016?
  - (2) How much planned maintenance is yet to be completed as of 1 August 2016?
  - (3) What is the total cost of the outstanding maintenance works as of 1 August 2016?

Answer-

The number of NSW Land and Housing Corporation properties that are undergoing maintenance in any location changes on a regular basis.

Information on maintenance expenditure is available in the FACS Annual Report at www.facs.nsw.gov.au.

- \*3740 M4 WIDENING PROJECT—Ms Julia Finn asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—
  - (1) How many homes have been compulsorily acquired for the M4 Widening Project?
  - (2) How many homes are yet to be compulsorily acquired for the M4 Widening Project?
  - (3) How many residents have requested that their homes be voluntarily acquired for the M4 Widening Project?

(a) How many residents have had their request approved?

- (4) How many homes are yet to be voluntarily acquired for the M4 Widening Project?
- (5) What is the total budget for the M4 Widening Project for:
  - (a) Compulsory acquisitions?
  - (b) Voluntary acquisitions?

Answer—

There are 427 properties required to support the construction of all stages of the WestConnex project. This includes a mixture of residential and commercial properties and land owned by councils or public authorities.

As at 15 August 2016, there are 318 properties which have already been acquired for the first two stages of the project. The remaining 109 properties are currently at varying stages of acquisition and Roads and Maritime is working with the property owners throughout this process.

The total cost of completed property acquisitions so far is around \$692 million.

\*3741 OFFICE OF TRUSTEE AND GUARDIAN IN GOSFORD-Mr David Harris asked the Attorney General-

How many staff are employed at the Office of Trustee and Guardian in Gosford?

Answer—

The NSW Trustee and Guardian is changing the way in which it delivers services to people to respond to client feedback, better protect and support vulnerable people in the Gosford area.

I am advised that as at 19 August 2016 there were nine staff employed in the Gosford office.

\*3742 EXTENSION OF KURRAJONG ROAD—Mr Edmond Atalla asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—

Are there any plans for the Government to fund the extension of Kurrajong Road from the Mount Druitt CBD to St Marys CBD?

Answer-

Both Kurrajong Road and Kurrajong Avenue are local roads under the administration of Penrith City Council and Blacktown City Council respectively. Roads and Maritime Services is not aware of any plans to extend Kurrajong Road or Kurrajong Avenue.

\*3743 MOUNT DRUITT COMMUTER CAR PARK—Mr Edmond Atalla asked the Minister for Transport and Infrastructure—

Are the foundations of the Mount Druitt Commuter Car Park structurally fabricated to allow for additional levels to be constructed for the future expansion of this car park?

Yes.

Answer-

- \*3744 CROWN LAND LEASES—Ms Julia Finn asked the Minister for Industry, Resources and Energy representing the Minister for Primary Industries, and Minister for Lands and Water—
  - (1) How many Crown leases are administered in the following local government areas:
    - (a) Cumberland Council;
    - (b) City of Parramatta Council?

Answer—

(1) (a) No leases are administered by the Department of Industry - Lands in the local government area of Cumberland Council.

(b) One lease is administered by the Department of Industry - Lands in the local government area City of Parramatta.

\*3745 ACCESS TO WESTERN SYDNEY PARKLANDS—Mr Edmond Atalla asked the Minister for the Environment, Minister for Heritage, and Assistant Minister for Planning—

Can a provision be made for 24 hour access to the Western Sydney Parklands for those cyclists who use the parklands as a short cut out of opening hours?

Answer-

Cyclists are already able to use tracks on lands managed by the Western Sydney Parklands Trust, 24 hours a day.

- \*3747 PHASING OUT COMPUTED TOMOGRAPHY SCANS—Mr Edmond Atalla asked the Minister for Health—
  - (1) Is the Government phasing out the use of Computed Tomography (CT) Scans in New South Wales hospitals?

(a) If so, will the CT Scans be replaced by MRI Machines which have no radiation exposure?

Answer-

CT and MRI are not interchangeable diagnostic modalities. In NSW, clinicians have the responsibility for making the decision on the appropriate medical imaging modality to use for diagnosing and treating patients. Depending on the presenting condition, it may be more appropriate to use one modality over another. These decisions are based on the best available evidence.

\*3748 REASONABLE ACCESS TO TRAIN STATIONS-Mr Edmond Atalla asked the Minister for Planning-

What future planning is the Government providing to deliver railway stations in the west around residential density?

Answer—

I am advised that this question should be referred to the Minister for Transport and Infrastructure.

\*3749 REINTRODUCTION OF TOLLS ON THE M4 MOTORWAY—Mr Edmond Atalla asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—

With the reintroduction of a toll on the M4 Motorway, will the 'Cashback' scheme be available to motorists using this road?

Answer—

Tolls for WestConnex have been publicly announced. WestConnex will use distance based tolling similar to that used on the M7.

Answer-

(1) I understand that across the State, over the 2015-16 financial year, a total of 9,457 First Home Owner Grants were paid, compared with 8,500 over the previous financial year. This is an increase of 957 or 11.3 per cent.

The Government is committed to increasing housing supply as a means of addressing housing affordability. I note that there there 71,162 dwelling approvals in New South Wales in 2015-16. This is higher than in any previous financial year and is more than double the level recorded in 2010-11 and in 2011-12.

Answer-

(1) At least 2,730 affordable dwellings were provided in 2014-2015. Figures for 2015-2016 are not yet available. A separate breakdown for the inner city is not available.

(2) Housing affordability is a relative term. Affordable housing may include subsidised rental accommodation, including social housing. It may also refer to shared equity models, or to cheaper market housing. $\land$ 

(3) More than 12,000 affordable homes have been delivered since 2011.

(4) A large number of affordable homes have been provided in the inner city, through Government Urban Renewal projects and on Government owned sites, including:

SEPP 70 – Green Square/ Ultimo Pyrmont	550 affordable rental dwellings delivered.

(5) The Department has commenced a review of the existing housing SEPPs.

The Department has held meetings with stakeholders and councils, emailed councils to ask for their ideas and conducted an online survey of certifiers, designers and builders specialising in secondary dwellings.

Broad community consultation will take place in coming months.

The Government is committed to looking at ways to increase the supply of affordable housing on government land, including through Urban Growth and Land and Housing Corporation.

(6) The provision of Affordable Housing is an objective of the Environmental Planning and Assessment Act 1979, and is a matter for which local government is empowered to seek contribution for, either through voluntary planning agreements or via SEPP 70.

The Department of Planning and Environment will continue to work with local government and the Greater Sydney Commission on the delivery of more affordable housing through strategic planning under the Commission's district plans and local councils' housing strategies.

The Department is currently reviewing SEPP 70 as part of the Housing SEPP Review. The review has included stakeholder feedback on SEPP 70.

(7) New South Wales is a member of the Affordable Housing Working Group, being led by Commonwealth Treasury. Treasury NSW is leading this process and further questions should be directed to the Treasurer.

(8) The State Environmental Planning Policies - Affordable Rental Housing, Housing for Seniors and People with Disability, and SEPP 70 - Affordable Housing (Revised Schemes) are currently being reviewed as part of the overall SEPP review program. (2) Clause 16 of the Protection of the Environment Operations (Clean Air) Regulation 2010 provides an owner of a motor vehicle is guilty of an offence if the vehicle emits excessive air impurities such as visible smoke while being used. Clause 23 of the regulation also provides it is an offence to remove or disconnect anti-pollution devices from a motor vehicle.

(3) The EPA can issue a penalty notice to vehicle owners whose vehicles emit excessive smoke. Roads and Maritime Services (RMS) Enforcement Operations Inspectors are authorised to report smoky vehicles to the EPA.

The EPA partners with RMS in the M5 East- Heavy Vehicle Emission Reduction Program. Under this program RMS officers report heavy vehicles observed emitting excessive smoke in the M5 East tunnel to the EPA, which can result in the EPA issuing penalty notices that carry fines of \$2000 against vehicle owners.

There are also mechanisms through which members of the community can submit reports about smoky vehicles to the EPA. This may result in the EPA issuing an advisory letter to a vehicle owner, or a defective vehicle notice where multiple reports are received.

(1) to (3) The key objective of the Business Adjustment Program is to improve the long-term viability of the commercial fishing industry by instilling greater meaning and value in commercial fishing shares, which was the original intention of the Fisheries Management Act 1994. The adjustment program will enable Government to remove red tape and inefficiencies imposed on fishers that have been implemented in the past and has stifled their viability historically. It is not the aim of the Program to reduce the supply of local seafood. In fact, as part of the Program the Government is investing in a stronger industry by offering low interest rate loans to nominated fishers who want to invest in a better future and funding projects that support the fishing industry and consumption of local seafood, such as improving community awareness and pursuing new labelling requirements for cooked seafood.

(3) The Government intends to run a subsidised share trading market in order to assist active fishers to purchase the shares they need.

(4) Share linkages have been tailored to fit specific classes and regions as per the recommendations of the Structural Adjustment Review Committee's final report.
