(1) State Environmental Planning Policy (Affordable Rental Housing) 2009 (Affordable Rental Housing SEPP) does not contain any rent setting or income eligibility requirements for boarding houses. However, boarding house rooms tend to be more affordable than other forms of housing because of their size and shared facilities.

The Department of Fair Trading manages the NSW Boarding House Register, which includes some data on rents.

(2) The Minister for Finance, Services and Property is responsible for land tax in New South Wales.

- (3) The Department of Planning and Environment is currently reviewing the State's housing policies to ensure that they respond to current conditions and community expectations. During the course of the review we are examining ways to help increase housing diversity and affordable housing across the State. The review includes consideration of the Affordable Rental Housing SEPP boarding house provisions.

- (1) As of 15 May 2018, there are around 3,300 people that have not yet to transitioned to the National Disability Insurance Scheme (NDIS) and are still in receipt of individual or block funding from the New South Wales Department of Family & Community Services. The majority of these people are expected to complete their transition to the NDIS by 30 June 2018.
- (2) The full scheme NDIS agreement, signed by the New South Wales and Commonwealth Governments on 25 May 2018, includes funding provisions to enable continued funding for existing clients if they have not yet transitioned to the scheme as at 30 June 2018.

Answer-

I am advised:

It is important that the strategic plans which address the future supply and demand for affordable housing are tailored to meet the needs of the areas to which they apply.

A Metropolis of Three Cities - the Greater Sydney Region Plan, released in March 2018, includes an action to implement Affordable Rental Housing Targets in defined precincts in Greater Sydney.

The Greater Sydney Commission's five District Plans, also released in March 2018, require that councils and other planning authorities prepare Affordable Rental Housing Target Schemes.

These targets will be created after a process of viability testing and are generally expected to be in the range of 5–10 per cent of new residential floor space in urban renewal and land release areas.

The Greater Sydney Commission stipulates that Affordable Rental Housing Targets will be able to be varied by precinct according to the local development conditions and viability, rather than flat rates applying over broad areas. This will ensure that the targets do not impede the overall housing supply, and are sensitive to local conditions.

Outside of Sydney, Regional Plans also address the need for affordable housing at the regional level.

Answer-

I am advised:

- (1) Roads and Maritime and Services (RMS) as the Proponent will undertake the comparative analysis. Should RMS decide to progress Option B for purposes other than parking and works that would not adversely impact on the acoustic amenity of residents, the comparative analysis must be submitted to the Department of Planning and Environment for approval. The Department would undertake a rigorous review of the report, ensuring its integrity.
- (3) and (4) These are matters for the Minister for Roads.
- (5) The Department did not consider air quality to be an issue requiring a comparative analysis as in both options the expected impacts would be consistent.
- (6) This is a matter for the Minister for Roads.
- (7) A modification would only be required if the proposed use of the site is not consistent with the approval.
- (8) All construction sites require a level of mitigation to reduce potential amenity impacts. Option B is a feasible option for tunnelling and support facilities. However, given the assessment identified that the level of impacts would be comparatively less under Option A, it was considered that RMS should identify additional mitigation measures that would be implemented to achieve comparable environmental outcomes and for this to be demonstrated in a report.

I am advised:

- (1) Use of Option B was approved as the assessment considered it a suitable site for the establishment of a construction ancillary facility. The comparative analysis requirement is a safeguard for the community to ensure that residents adjacent to Option B would not be subjected to amenity impacts greater than that which residents adjacent to Option A sites would experience.
- (2) The length of time taken to establish a construction ancillary facility is not a matter for consideration when determining an application. I have been advised that although the Option B site may take comparatively longer to establish, possession of the site can be achieved earlier as the Option A sites are

currently being used as a construction facility for the M4 East project. This would reduce the difference in the length of time taken to commence operations.

The assessment of the M4-M5 Link project is based on the information provided in the Environmental Impact Statement, submissions received, and Submissions and Preferred Infrastructure Report for the project. The Environmental Impact Statement and Submissions and Preferred Infrastructure Report presented two options - A and B - for construction compounds at Haberfield and Ashfield. The Department of Planning and Environment, while preferring Option A, did not discount Option B as it is a feasible option for tunnelling and support facilities.
