*1534 PORCINE PRION PREVALENCE—Mr Roy Butler asked the Minister for Agriculture and Western New South Wales—

What is the prevalence of porcine prion in domestic and feral pig populations in New South Wales?

Answer—

The prevalence of porcine prion in domestic and feral pig populations in New South Wales is not known as there is no known significant risk of porcine prion in domestic or feral pig populations in New South Wales to livestock or human health.

Porcine Prion disease is a form of transmissible spongiform encephalopathy (TSE). TSEs are extremely rare and The Commonwealth Department of Agriculture reports the TSE surveillance activities to the World Organisation for Animal Health (OIE). This enhances market confidence in Australian animals and animal products. - *1540 RECRUITMENT EXECUTIVE DIRECTOR EARLY CHILDHOOD EDUCATION—Ms Jodie Harrison asked the Minister for Skills and Tertiary Education representing the Minister for Education and Early Childhood Learning—
 - (1) Why was the advertising period for the recruitment of the Executive Director of Early Childhood Education, a senior Government position, so brief?
 - (2) Why is the appointment only for a six-month period?

Answer-

There was a need to expeditiously appoint an acting Executive Director, Early Childhood Education while permanent recruitment was progressed. The permanent recruitment process is underway.

- *1541 MOBILITY PARKING PERMIT SCHEME AUTISM ELIGIBILITY—Ms Jo Haylen asked the Minister for Transport and Roads—
 - (1) Is it correct that autism has been removed from the list of eligible conditions under the Mobility Parking Permit Scheme?
 - (a) If so, when was the decision made to remove autism from the list of eligible conditions under the Mobility Parking Permit Scheme?
 - (i) Prior to this decision, how many mobility parking scheme permits were issued on the basis of an applicant's autism in each of the preceding five financial years (as at 16 October 2019)?
 - (ii) In each year, what was this as a percentage of the total number of Mobility Parking Scheme permits issued?
 - (b) How many applications have been made on the basis of an applicant's autism since the decision to remove autism from the list of eligible conditions from the Mobility Parking Scheme Permit (as at 16 October 2019)?

Answer-

I am advised:

- (1) The Mobility Parking Scheme (MPS) provides parking concessions to people with mobility disability. If eligible, Roads and Maritime Services will issue a licence-style card called an MPS permit.
 - (a) There has been no change to the list of eligible conditions under the MPS. To be eligible, you must be permanently blind or have a mobility disability, which is defined by legislation as someone:
 - unable to walk due to the permanent or temporary loss of use of one or both legs, or other permanent medical or physical condition;
 - whose physical condition is detrimentally affected as a result of walking 100 metres; or
 - who requires the use of crutches, a walking frame, callipers, scooter, wheelchair or other similar mobility aid.

- (b) This information is not recorded in the Roads and Maritime Services record system (DRIVES).
- *1542 SELF-FUNDED RETIREE ENERGY REBATE—Ms Jo Haylen asked the Minister for Energy and Environment—
 - (1) How many people have taken up the self-funded retiree energy rebate since it became available on 1 July 2019 (as at 16 October 2019)?
 - (2) What is the Government's target take-up by the end of the year and is it on track (as at 16 October 2019)?
 - (3) How much money has the Government spent on promoting the self-funded retiree energy rebate (as at 16 October 2019)?
 - (4) Considering reports that some households will see average increases in electricity prices of \$320 for households and \$920 for small businesses in the next year, will the self-funded retiree rebate really help?
 - (5) How did the Government arrive at the subsidy amount?
 - (6) How many people have used the online "one click energy switch?"
 - (7) How many users have switched to lower cost energy plans after using the service?
 - (8) What is the total cost to the Government of managing the "one click energy switch?"
 - (9) Considering the Premier's comments on 2GB on 4 July 2019 that she is "too busy" to sign up for the Energy Switch program, how does the Minister expect working households to do so?

Answer-

I am advised that:

- (1) As at 16 October 2019, Service NSW had received more than 5,000 applications for the self-funded retiree rebate, which is branded as the Seniors Energy Rebate.
- (2) All individuals who meet the following eligibility criteria can apply for the rebate:
 - They are an independent retiree and New South Wales resident;
 - They have a valid Commonwealth Seniors Health Card, and;
 - They are the account holder, or one of the account holders, named on the electricity bill.
- (3) As at 22 October 2019, the Government has spent \$406.75 for Search Engine Marketing for the Seniors Energy Rebate.
- (4) The Government is focused on easing the cost-of-living pressures faced by individuals and households across the state. The Government believes the new Seniors Energy Rebate of \$200 will help make energy more affordable for eligible households. Further, the premise of the question is wrong as the Australian Energy Market Commission's most recent Electricity Price Trends report estimates that electricity prices will fall in New South Wales over the next two years.
- (5) The Government has reduced the cost of living and cut taxes by hundreds of millions of dollars in the past year through popular programs such as Active and Creative Kids, CTP savings, energy rebates, the Baby Bundle, Stamp Duty concessions, Caravan Registration rebate, Payroll Tax cuts and the Opal Fare cap. The Seniors Energy Rebate works in conjunction with these other cost of living measures.
- (6) As at 16 October 2019, about 80,000 electricity bill and 11,000 gas bill comparisons have been made for individuals.
- (7) As at 16 October 2019, over 10,900 customers initiated a change in electricity providers, saving customers about \$4.83 million. More than 1,300 households initiated a change in gas providers, saving customers more than \$197,000.
- (8) This question should be referred to the Minister for Customer Service.
- (9) I refer to my responses to questions 6 and 7.
- *1543 RETIREMENT VILLAGE INSPECTIONS—Ms Jo Haylen asked the Minister for Better Regulation and Innovation—
 - (1) How many people are employed in the unit dedicated to enforcing regulations under the Retirement Villages Act 1999?
 - (2) How many inspections of retirement villages have occurred under the auspices of the Act in each of the past five financial years (as at 16 October 2019)?
 - (3) How many detailed investigations of retirement villages have occurred under the auspices of the Act in each of the past five financial years?
 - (4) Of these inspections and investigations, how many enforcement orders or actions have been made in each year?
 - (a) What data is collected during these inspections?

Answer—

- (1) NSW Fair Trading undertakes proactive compliance programs targeting non-compliance with the legislation it administers within the real estate and property sector. Investigations may also be initiated in response to an identified breach of legislation. These non-compliance activities include the Retirement Villages Act 1999 (the Act). There are currently 14 staff members who are dedicated to real estate and property compliance in New South Wales which includes compliance in the retirement village sector. In addition, Fair Trading has a specialist investigation unit that undertakes investigations under the legislation administered by Fair Trading. The investigations conducted by the unit generally relate to serious misconduct and offences against industries regulated by Fair Trading.
- (2) The Real Estate and Property unit was established in 2016. Targeted compliance programs are developed utilising intelligence from complaints and enquiries received by NSW Fair Trading. A proactive compliance audit was undertaken in 2017. This included a desk top audit of 60 retirement villages with 18 of the these independently operated and 42 operated by 11 large organisations. A further proactive compliance audit was undertaken in 2019 targeting retirement villages within the Hills District with eight retirement villages being inspected. In addition, the Retirement Villages Ambassador has proactively visited 40 retirement villages and was in attendance for 10 forums for current residents. Over 3,270 current and prospective residents attended these events.
- (3) Fair Trading has conducted two (2) detailed investigations under the Act.
- (4) In 2018, one penalty infringement notice was issued under section 181 (2) of the Act for failure to pay a refund resulting in financial detriment.
 - (a) For every inspection completed under a proactive compliance program, a 'Record of Inspection' is completed that identifies the following:
 - Date, time, address and contact details of the retirement village and the operator;
 - Registration requirements;
 - Information regarding compliance with the requirements under the Act for when residence enter a village;
 - Information regarding compliance with the requirements under the Act for Annual management meeting;
 - Information regarding compliance with the requirements under the Act for budgets and audits;
 - Information regarding compliance with the requirements under the Act for when a residence is leaving the village.
- *1544 NEW SOUTH WALES CIVIL AND ADMINISTRATIVE TRIBUNAL—Ms Jo Haylen asked the Minister for Better Regulation and Innovation—
 - (1) In each of the past five financial years, what has been the total number of cases heard in the New South Wales Civil and Administrative Tribunal (NCAT) lodged by retirement village residents against retirement village operators (as at 16 October 2019)?
 (a) Of these cases how many have found in favour of residents?
 - (a) Of these cases, how many have found in favour of residents?
 - (2) In each of the past five financial years, what has been the total number of mediations by the Office of Fair Trading between retirement village residents and retirement village operators (as at 16 October 2019)?
 - (a) Of these cases, how many have found in favour of residents?
 - (3) What resources and support is available to residents in these circumstances?

Answer-

- (1) This question needs to be directed to the New South Wales Civil and Administrative Tribunal (the Tribunal) as NSW Fair Trading does not hold this data.
- (2) A mediation service for retirement villages was made available from October 2018. In 2018 one application for mediation was received between a resident and an operator however this matter was resolved a day before the scheduled mediation date. In 2019 to date there have been fourteen applications for mediation between a resident and an operator. Out of the fourteen mediation applications, five were resolved, one application was resolved prior to the mediation scheduled date, and one was withdrawn. The remaining five mediation applications were not resolved and the parties were advised of their option to lodge a claim with the NSW Civil and Administrative Tribunal for a determination on their dispute.
- (3) Fair Trading's voluntary mediation services help the parties involved in the dispute find options that could address everyone's concerns. Mediation can take place onsite at the village or at another

mutually acceptable location as agreed to by the parties. Fair Trading can further arrange interpreters to attend if required. Information on how to prepare for a mediation, and what happens during the mediation is available on the Fair Trading website. Additionally, since the launch of the Retirement Village Ambassador program, the Retirement Village Ambassador, Ms. Kathryn Greiner AO, has presented to more than 1,900 residents of retirement villages and prospective residents. Ms. Greiner brings considerable understanding of issues faced by those living in retirement villages, having led the inquiry into New South Wales retirement villages in 2017. Ms. Greiner is also the Chairperson of the Ministerial Advisory Committee on Ageing and provides advice on issues and concerns of older citizens to the Government. In her role as Ambassador, Ms. Greiner visits various locations and retirement village communities across New South Wales to:

- Inform residents about the changes to retirement village laws;
- Listen to issues faced by residents and present these issues to the Government;
- Advocate for residents where appropriate, including representing the residents' perspective to create awareness and generate recommendations for further change;
- Monitor and report on continuing and emerging issues faced by the sector.
- *1545 RETIREMENT VILLAGE NUMBERS—Ms Jo Haylen asked the Minister for Better Regulation and Innovation—
 - (1) How many retirement villages are registered in each New South Wales State electorate?
 - (2) How many residents live in retirement villages in each New South Wales State electorate?

Answer-

- (1) There are 667 registered retirement villages currently registered in New South Wales. The Retirement Villages Register does not record retirement village locations by electorate.
- (2) NSW Fair Trading does not keep a record of the number of residents currently residing in retirement villages.
- *1546 MOTOR VEHICLE WEIGHT TAX-Ms Jo Haylen asked the Minister for Transport and Roads-
 - (1) How many people have applied to reduce the motor vehicle weight tax by 40 per cent (as at 16 October 2019)?
 - (a) Geographically, where has this had the greatest and the least impact?
 - (b) To what extent has this been taken up by older residents and pensioners?
 - (c) To what extent has this been taken up by families?
 - (2) Has the Government collected data on the number of people who have accessed the tax reduction in terms of those who use caravans for recreational purposes and those that use the House as a primary dwelling?
 - (a) If not, why not?
 - (b) If so, what is the breakdown?
 - (3) What has been the total cost to the Government of reducing the motor vehicle weight tax by 40 per cent since it was introduced (as at 16 October 2019)?
 - (4) Does the Government measure the average costs charged by caravan parks for caravan registration?(a) If not, why not?
 - (b) If so, how have registration charges changed in each of the past five financial years?
 - (5) What has been the total cost to the Government of advertising and promoting the tax reduction?
 - (6) Has the Government modelled the total amount of money provided through the scheme returned to local governments in cases where they manage caravan parks?

Answer-

I am advised:

- (1) The 40 per cent reduction in motor vehicle weight tax has been automatically applied to new registrations and renewals of privately-registered towed caravans and purpose-built camper trailers from 255kg up to 4.5 tonnes since 1 November 2018.
- (2) No. Caravans are registered for either private use or business use. The 40 per cent reduction in motor vehicle tax for caravans and camper trailers from 255 kilograms up to 4.5 tonnes recognises that caravans are used less on New South Wales roads than the average car.
- (3) The cost of implementing the 40 per cent reduction in weight tax was \$490,332.
- (4) No. Transport for NSW does not regulate fees charged by caravan parks.
- (5) Costs to promote changes in legislation are part of Transport for NSW standard operating budget.
- (6) No.

*1547 APPRENTICE VEHICLE REGISTRATION REBATE—Ms Jo Haylen asked the Minister for Transport and Roads—

- (1) How many people have taken up the Apprentice Vehicle Registration Rebate in each financial year since it was first introduced (as at 16 October 2019)?
- (2) What has been the total cost of the Apprentice Vehicle Registration Rebate in each year since the program was introduced (as at 16 October 2019)?

*1548 CREATIVE KIDS PROVIDERS-Ms Jo Haylen asked the Minister for Customer Service-

(1) As of 16 October 2019 the Creative Kids team have reviewed 4181 providers who applied to be part of the program.

(b) Of the 406, the ineligibility status of providers have been categorised by the following:

NSW State Emergency Service (SES) volunteer numbers and complaints referred are reported on an annual basis in the agency's annual report. NSW SES does not track volunteer numbers per unit, as these numbers regularly fluctuate.

The NSW SES Complaints Management Framework articulates the process for managing complaints within the NSW SES. Resources associated with the framework are available to all NSW SES volunteers and staff. The NSW SES Probity and Standards Unit is responsible for the implementation of this framework and management of serious or complex grievances.

There was a total of 39 (over the past five financial years) complaints against paid SES staff members received by NSW SES Probity & Standards. Three of those complaints resulted in disciplinary action.

*1551 WALLSEND ELECTORATE POLICING—Ms Sonia Hornery asked the Minister for Police and Emergency Services—

*1561 WARNERVALE AIRPORT REVIEW—Mr David Mehan asked the Minister for Planning and Public Spaces—

- (1) When was the Warnervale Airport (Restrictions) Act 1996 last reviewed by your department?
 - (a) Was the review publicly advertised?
 - (b) When was the review completed?
 - (c) What was the result of the review?
 - (d) How much did the review cost?

In 2015, Wyong Shire Council requested the repeal of the Warnervale Airport (Restrictions) Act 1996 (the Act). A review was undertaken in 2016 to consider whether the Act should be repealed. Since this review was undertaken, a compliance investigation undertaken by the then Department of Planning and Environment determined that the former Wyong Council had extended the runway of Warnervale Airport and triggered the daily flight limit contained in the Act. This daily flight cap has limited the ability of community groups who regularly use the Airport.

To provide certainty to the community, the NSW Government has announced an independent review that will make recommendations on the necessary legislative amendments to facilitate the operations of the Airport in a manner consistent with that prior to when the flight movement restrictions were triggered.
