- *1369 NARRABRI COURT HOUSE—Mr Roy Butler asked the Attorney General, and Minister for the Prevention of Domestic Violence—
 - (1) How many members of staff are currently employed at the Narrabri Court House?
 - (2) On a given day how many are rostered to work at the Narrabri Court House?
 - (3) Is the Attorney General aware that due to the lack of staff, members of the Narrabri community have been unable to access services at the Narrabri Court House on numerous occasions?
 - (4) Is the Attorney General aware that the Narrabri community has received no notification regarding the reduced availability of services?

Answer-

I am advised:

Narrabri Court is staffed by a full time registrar and three additional staff when court sits.

There has been no reduction of services at Narrabri Court House. In July 2019, the Department of Communities and Justice increased the number of operating days at the Narrabri Court Registry from four to five days (excluding the fourth Thursday of each month).

- *1370 DECOMMISSIONING OF THE MENINDEE TO BROKEN HILL PIPELINE AND IMPACT ON LANDHOLDERS—Mr Roy Butler asked the Minister for Water, Property and Housing—
 - (1) Has Essential Energy applied to the Government for \$60 million in funding for the decommissioning and replacement of the Menindee to Broken Hill Pipeline?
 - (a) If so, has this request for funding been approved?
 - (i) If not, why not?

Answer—

I am advised:

In May 2019, IPART determined that Essential Energy required revenue of \$3.3 million over the three years to 2021-22 to fund the consequential works, including the decommissioning and replacement of the Menindee to Broken Hill Pipeline.

- *1371 HEIGHT OF THE NEW WILCANNIA WEIR—Mr Roy Butler asked the Minister for Water, Property and Housing—
 - (1) Will the new Wilcannia Weir have an increased height?
 - (a) What will the height of the new weir be?
 - (b) Has this height been documented in Water NSW's Wilcannia Weir Project planning?

Answer-

I am advised:

- (1) Yes.
 - (a) 1 metre.
 - (b) Yes.
- *1372 LEETON HOSPITAL DOCTOR—Mrs Helen Dalton asked the Minister for Health and Medical Research—

Considering that Leeton District Hospital has been without an on-call doctor for several days during September, will the Murrumbidgee Local Health District employ a full-time doctor at Leeton District Hospital?

Answer—

Two full-time Career Medical Officer position have been advertised since June 2019. Both positions will remain advertised until a suitable applicant is found. From October 2019 I am advised there will be seven doctors providing medical services at the Leeton District Hospital, with two additional doctors

commencing since August 2019. Locum medical officers continue to support the hospital by providing medical coverage for any roster gaps.

- *1373 GROUNDWATER LICENCES—Mrs Helen Dalton asked the Minister for Water, Property and Housing—
 - (1) What protections are in place to ensure that the granting of new groundwater extraction licences does not over commit groundwater reserves?
 - (2) Considering the high volume of approvals for groundwater extraction licences, what protections are in place to ensure that existing groundwater extraction licence holders are able to continue extracting as per their licence conditions?

Answer-

I am advised:

- (1) For each groundwater source, a maximum volume of extractable groundwater is defined in the relevant water sharing plan. To be able to extract groundwater, users must obtain shares on the water market for the water source their bore is targeting. The exception to this is groundwater for very small volume domestic and stock use.
- (2) At a local scale, each proposed new application or each proposed increase in pumping, is subject to an impact assessment which ensures impacts on existing users, on the aquifer itself, and on connect rivers and other groundwater dependent ecosystems are acceptable.
- *1374 REGIONAL TAX EXEMPTION—Mrs Helen Dalton asked the Treasurer—
 - (1) Considering the Legislative Assembly Committee Inquiry into Zonal Taxation report recommended the Government exempt the purchase of commercial and industrial property in regional New South Wales from stamp duty when businesses relocate from Greater Sydney or from outside New South Wales from 1 July 2019, why has the Government not implemented this recommendation?
 - (2) Does the Government plan to implement this recommendation in the future?

Answer-

- (1) The Government has provided its response to the recommendations of the Report of the Inquiry into Zonal Taxation, outlining the initiatives that government is taking in support of regional growth.
- (2) The Government will continue to assess the appropriateness of all existing taxation policy settings.
- *1375 APPLICATIONS FOR DISASTER RELIEF FUNDING RECEIVED BY THE RURAL ASSISTANCE AUTHORITY—Mr Philip Donato asked the Minister for Agriculture and Western New South Wales—
 - (1) How many applications for Disaster Relief Funding have been received by the Rural Assistance Authority relating to events occurring within the Orange electorate, which includes Forbes, Parkes, Cabonne and Orange Local Government areas, for the following calendar years:
 - (a) 2016;
 - (b) 2017;
 - (c) 2018;
 - (d) 2019 (as at 24 September 2019)
 - (2) How many of those applications have been successful and the applicants benefiting receipt of disaster relief funding for the following calendar years:
 - (a) 2016;
 - (b) 2017;
 - (c) 2018;
 - (d) 2019? (as at 24 September 2019)

Answer-

- (1) The number of applications received was:
 - (a) 2016 Forbes: one loan, three transport subsidies; Parkes: one loan; Cabonne: one loan; Orange:
 - (b) 2017 Forbes: three loans, 212 grants approved, ten transport subsidies approved; Parkes: twelve loans, 203 grants, one loan; Cabonne: three loans, three grants; Orange: 0.
 - (c) 2018 Forbes: two loans, one transport subsidy; Parkes: one loan, one grant; Cabonne: one loan; Orange: 0.
 - (d) 2019 Forbes: 0; Parkes:one loan; Cabonne:one loan; Orange: 0.

- *1376 IMPLEMENTATION OF PERFORMANCE AUDIT RECOMMENDATIONS—Mr Philip Donato asked the Minister for Skills and Tertiary Education representing the Minister for Education and Early Childhood Learning—

Considering the Department of Education Secretary Mr Mark Scott's acceptance of all seven recommendations in relation to the NSW Auditor General's Performance Audit Report examining Information and Communication Technology (ICT) in schools for teaching and learning in June 2017, has the Department fully met all recommendations, in particular recommendations 1, 3, 4, and 7?

Answer-

The recommendations from the Information and Communication Technology (ICT) in Schools for Teaching and Learning Performance Audit Report collectively describe a framework of continuous improvement in a dynamic technology environment, and the Department of Education has met them by developing a set of implementation plans which complement the individual recommendations.

Some of these recommendations align to existing programs and are in progress, some have been implemented in full, and others require further assessment. The Department's implementation progress is monitored by its internal Audit Directorate, and reported annually to the Public Accounts Committee.

- *1377 EDUCATION FUNDING IN GOVERNMENT SCHOOLS—Mr Philip Donato asked the Minister for Skills and Tertiary Education representing the Minister for Education and Early Childhood Learning—
 - (1) What is the current funding per year for the Technology for Learning (T4L) program in New South Wales Government schools?
 - (2) Is this funding allocation appropriate to meet the needs of all students, without placing increased financial pressure on families to subsidise Information and Communication Technology (ICT) in Government schools?
 - (3) Does the current Bring Your Own Device (BYOD) policy place financial pressures on families, where Principals are not implementing appropriate ICT for student teaching and learning or appropriate funding is not being delivered to schools by the Department of Education?

Answer—

- (1) \$35.3 million.
- (2) Schools are provided with a ratio of computers centrally under the Department of Education's regular T4L Computer Equipment Rollout and they may choose to supplement the number of devices available to their students above what is provided, with their local funding and budget allocation.

The Bring Your Own Device (BYOD) Policy is also available to schools who choose to participate in a student owned device program, to further supplement technology in their school. Implementation of a BYOD program is a local decision, made in consultation with the local community and based on the individual teaching and learning strategies of the school.

- (3) Schools who implement a BYOD program have a number of options available to support students who may not own an appropriate device, including using needs-based funding to ensure loan equipment is available, or working with suppliers to provide parents with additional sourcing options.
- *1378 DECLINE IN NAPLAN RESULTS—Mr Philip Donato asked the Minister for Skills and Tertiary Education representing the Minister for Education and Early Childhood Learning—

Considering the annual pay increases for senior officers of the Department of Education (DoE) from 2016-18, there has been a decline in NAPLAN results in Year 5 reading and numeracy, Year 7 reading and numeracy and Year 9 reading for regional and remote students in 2018. While the Government states they are increasing funding to schools, where is this money going to improve our children's educational and wellbeing outcomes or to staffing and wages of DoE employees?

Answer—

The Government has increased the State Budget expenses allocation for government schooling from approximately \$12 billion in 2016-17 to \$13.8 billion in 2018-19. Schools are provided funding through the needs-based Resource Allocation Model (RAM). The funding recognises student need in every New South Wales public school. This is delivered largely through equity loadings for low socio-economic background, Aboriginality, low level adjustment for disability, and English language proficiency.

Additional funding is also provided to support initiatives addressing student wellbeing, literacy and numeracy, professional learning and engagement in learning. Additional teams also provide localised and tailored support on the strategic use of resources to maximise student learning.

Schools currently use their needs-based funding to engage additional classroom teachers, instructional leaders to build the capacity and professional knowledge of all teachers, and additional school learning support officers in classrooms.

Funding may also be used to engage specialist support staff and additional expertise such as speech athologists, occupational therapists and additional school counsellor hours.

Department of Education employees receive salary increases in line with the NSW Government Wages Policy. Public service senior executives receive salary increases consistent with the annual determination made under section 24 of the Statutory and Other Offices Remuneration Act 1975.

*1380 QUALITY SCHOOLS REFORM—Mr Philip Donato asked the Minister for Skills and Tertiary Education representing the Minister for Education and Early Childhood Learning—

Has the current bilateral agreement between New South Wales and the Commonwealth on quality schools reform closed the gap relating to the educational and well being outcomes for children and young people in rural and remote areas, especially when compared to those students in metropolitan areas?

Answer—

New South Wales signed the National School Reform Agreement (the Agreement) and Bilateral Agreement with the Commonwealth in November 2018. The Agreement includes a commitment to "meet the needs of students at risk of educational disadvantage (including ... students in rural and regional areas) through evidence based pedagogy, quality teaching and leadership and innovation".

The Department of Education is committed to quality education and recently commenced consultation to renew its 'A Rural and Remote Education: A blueprint for action' strategy. A goal of the Department's Strategic Plan (2018-2022) is to reduce the impacts of educational disadvantage in rural and regional areas. In addition, the Department has a dedicated Rural and Distance Education team located in Bathurst to provide advice and support to staff and students in rural and remote schools.

*1381 FREIGHT TRANSPORT RESTRICTED BY NARROW MULYANDRY BRIDGE—Mr Philip Donato asked the Minister for Regional Transport and Roads—

Considering that an Roads and Maritime Services representative has advised my constituents at Eugowra that freight movements are being restricted along Lachlan Valley Way (Forbes-Cowra Rd) due to the Mulyandry Bridge being too narrow, will the Government give consideration to the widening of this bridge?

Answer-

I am advised:

Freight access on the Lachlan Valley Way between Forbes and Cowra is consistent with the Heavy Vehicle Access Policy Framework. Transport for NSW is enabling freight movement across Mulyandry Bridge with access available to Performance Based Standard (PBS) Level 2B vehicles, which are typically up to 30 metres long. Transport for NSW will continue to work to maximise freight access.

- *1382 EQUITY OF OPPORTUNITY IN RURAL AND REMOTE SCHOOLS—Mr Philip Donato asked the Minister for Skills and Tertiary Education representing the Minister for Education and Early Childhood Learning—
 - (1) What is the Government delivering with the additional \$712 million New South Wales School Equity Program?
 - (2) What is the Department of Education doing currently to improve access and equity to opportunities for students in rural and remote government schools?

Answer-

(1) As per Clause 49 of New South Wales' Bilateral Agreement with the Commonwealth, the New South Wales School Equity Program "will support government schools with higher needs in accordance with

the loadings under the Australian Education Act 2013 and represents an estimate of the government sector equivalent of the Choice and Affordability Fund" from 2020.

(2) The Rural and Remote Strategy 'A Blueprint for Action' launched in 2013, consisted of a range of strategies as part of a broader reform agenda to reduce the gap in educational outcomes between rural students and their metropolitan counterparts. Programs and initiatives from the original blueprint, known as phase one, have been finalised.

Phase two of the strategy was released in 2018 and consisted of two major initiatives:

- Additional incentives related to achieving improved rural teacher staffing outcomes.
- The Government's Connecting Country Schools program, delivering Wi-Fi upgrades and boosting internet capacity in approximately 900 regional schools. This program is nearing completion and has a total allocation of \$69.5 million. It provides an enhanced wireless experience for students and teachers in public schools across regional and remote New South Wales.

A significant number of these initiatives during 2019 were transitioned to operate as business as usual and receive recurrent funding.

The Department of Education has commenced consultation and is considering elements that will be prioritised to form phase three of the Rural and Remote Strategy, targeted to support equity for rural schools and their communities.

*1383 REOPENING OF THE BRIDLE TRACK—Mr Philip Donato asked the Minister for Regional Transport and Roads—

Considering your announcement in September 2018 that the Government would provide \$2 million to the Bathurst Regional Council to be used for a study leading to the reopening of the Bridle Track that once linked Bathurst to Hill End, can you provide details of the expenditure?

Answer-

I am advised:

The Bridle Track is a local road under the care and control of Bathurst Regional Council. The Government provided Bathurst Regional Council with a one off grant of \$2 million from the Regional Road Fund in June 2018 to assist in delivering the works necessary to establish an alternative route. The Council identified the most feasible route and commenced property acquisition and preliminary design. The Bathurst Regional Council has advised that negotiations with property owners along the track have been continuing, with one property complicated by a deceased estate that involves overseas interest. Transport for NSW has been informed that the proper processes are being followed and will continue to work with Bathurst Regional Council to resolve this matter.

- *1384 PUBLIC SCHOOL TEACHERS SALARY WAGE CAP EXEMPTION—Ms Jo Haylen asked the Minister for Skills and Tertiary Education representing the Minister for Education and Early Childhood Learning—
 - (1) Why are public school teachers and school counsellors affected by the standards-based pay anomaly from the 2.5 per cent public sector wage cap not exempted?
 - (2) What is the impediment to a fair and equitable resolution before negotiations begin on a new award, considering that other school systems, including the Catholic school system, have resolved it?
 - (3) Why was there no impediment in resolving a similar issue for school principals?
 - (4) Has Treasury calculated what the total cost would be of resolving the pay discrepancy?
 - (a) What is the total cost?

Answer—

- (1) The New South Wales Public Sector Wages Policy 2011 applies to all public sector employees without exceptions. This policy makes a significant contribution to the maintenance of the Government's responsible fiscal position. Standards based remuneration is not applicable to school counsellors.
- (2) All award negotiations are conducted in accordance with the New South Wales Public Sector Wages Policy 2011 and the teacher's award is no exception. Unlike other school systems the Department of Education introduced standards based remuneration along with the requirement that classroom teachers attain and maintain their accreditation to support quality teaching in New South Wales public schools. The introduction of the current procedures for standards based remuneration under the Crown Employees (Teachers in Schools and Related Employees) Salaries and Conditions Award 2014 was negotiated with and agreed to by the NSW Teachers Federation. The continuation of the procedures in the current Crown

Employees (Teachers in Schools and Related Employees) Salaries and Conditions Award 2017 were also negotiated with and agreed to by the NSW Teachers Federation.

- (3) Standards based remuneration is not applicable to principals and there has been no "similar" issue requiring resolution for principals.
- (4) This matter forms part of the negotiation parameters for a new teacher's award, due to commence on 16 October 2019. The negotiations will be conducted on a confidential, without prejudice basis between the parties to the award, the Department of Education and the NSW Teacher Federation. It is not appropriate for any further comment to be made as this may prejudice the outcome of the confidential negotiations.
- *1385 BUILDINGS IN LIVERPOOL ON THE COMBUSTIBLE CLADDING REGISTER—Mr Paul Lynch asked the Minister for Planning and Public Spaces—

How many buildings within the state electorate of Liverpool are on the combustible cladding register?

*1386 DELAY OF STATUTORY REVIEW—Mr Paul Lynch asked the Attorney General, and Minister for the Prevention of Domestic Violence—

Why is the release of the statutory review of the Coroners Act being delayed by the Taskforce into a review of the coronial process focusing on timeliness?

Answer-

Careful consideration is being given to the statutory review of the Coroners Act 2009.

The Improving Timeliness of Coronial Procedures Taskforce has been established to focus on reducing delay in the coronial jurisdiction. If the Taskforce identifies matters relevant to the statutory review, these will form part of the consideration of the review.

- *1387 ORAL CARE LIVERPOOL HOSPITAL—Mr Paul Lynch asked the Minister for Health and Medical Research—
 - (1) What is the current waitlist time for dental care at Liverpool Hospital?
 - (2) How many oral therapists are employed at Liverpool Hospital?

Answer—

- (1) Public dental services are provided according to criteria that prioritises emergency situations, as well as patient groups in most need and at highest risk of disease. Data is regularly updated and can be accessed online
- (2) Local health districts and hospitals vary staffing profiles and numbers to appropriately meet operational need at any point in time.
- *1388 SENIOR SAVERS CARD—Mr Paul Lynch asked the Minister for Customer Service—
 - (1) Since 1 July 2019 how many people in the electorate of Liverpool have applied for the Senior Savers Card (as at 20 September 2019)?
 - (a) How many applications have been approved?
 - (b) How many applications have been declined?

Answer—

- (1) Since 1 July 2019 there have been a total of 308 completed applications for the Seniors Savers card in the Liverpool electorate (as at 20 September 2019).
- (a) and (b) In order to complete the application process, applicants must provide a Medicare card or Department of Veterans' Affairs identification card to show proof of age. Subject to providing this information, all completed Senior Savers card applications will be approved.
- *1389 RECRUITMENT OF NSW CRIME COMMISSIONER—Mr Paul Lynch asked the Minister for Police and Emergency Services—

When a permanent NSW Crime Commissioner is appointed will there be a proper recruitment process?

*1390 AUSTRALIAN LATIN AMERICA SOLIDARITY ARCHIVE—Mr Paul Lynch asked the Premier representing the Special Minister of State, Minister for the Public Service and Employee Relations, Aboriginal Affairs, and the Arts, Vice-President of the Executive Council—

Why did the State Library refuse to assist in establishing the Australian Latin America Solidarity archive?

Answer—

The Latin America Solidarity Archive was initially offered to the State Library of NSW in August 2011.

The State Library has reviewed correspondence from 2011 until 2013 relating to the offer of the Archive and can find no evidence that it was refused.

At the time of the offer, the collection was located in Brisbane and correspondence was chiefly concerned with establishing its precise contents to determine whether it aligned with the Library's collection acquisition policies.

The Archive has not been sighted by the Library to inform its appraisal.

The owners of the Archive are invited to contact the State Library again to progress discussions about possible acquisition.

*1391 COMBUSTIBLE CLADDING LIVERPOOL HOSPITAL—Mr Paul Lynch asked the Minister for Health and Medical Research—

Where is combustible cladding located in buildings of Liverpool Hospital?

Answer—

No compliance issues for external combustible cladding have been identified at Liverpool Hospital.

*1392 JOB LOSSES AT SERVICE NSW LIVERPOOL CENTRE—Mr Paul Lynch asked the Minister for Customer Service—

Will there be any job losses at the Services NSW Liverpool Centre during the 2019-20 financial year?

*1393 PROPOSED ADDITIONAL COMMUTER CARPARK AT EDMONDSON PARK RAILWAY STATION—Mr Paul Lynch asked the Minister for Transport and Roads—

*1395 MAINTENANCE OF STORM DRAINS IN THE COOGEE ELECTORATE—Dr Marjorie O'Neill asked the Minister for Water, Property and Housing—

Why is there is no proactive plan for the maintenance of storm water drains in the Coogee electorate?

Answer-

I am advised, that Sydney Water does have a proactive plan for maintenance of storm water drains in the

electorate of Coogee.

- *1396 SCHOOL FENCING—Mr Ryan Park asked the Minister for Skills and Tertiary Education representing the Minister for Education and Early Childhood Learning—
 - (1) Is barbed wire fencing still used to fence school properties?
 - (2) Is the Minister aware that barbed wire fencing is used at Bellambi Public School and Corrimal High School?
 - (3) When will this fencing be removed and replaced with more suitable fencing?
 - (a) If there is no plan to remove the fencing, why not?

Answer-

- (1) The Department of Education can confirm that current projects do not include barbed wire fencing.
- (2) The Department has been in contact with both Bellambi Public School and Corrimal High School regarding upgrades to fencing.
- (3) The Department can advise that some of the barbed wire fencing at Corrimal High School has been removed through a school funded project. Although there are no current plans to upgrade the fencing at Bellambi Public School, the Department will provide assistance with a project should a funding source be identified.
- *1397 CHANGES TO CATCHMENTS FOR PUBLIC PRIMARY AND HIGH SCHOOLS—Dr Marjorie O'Neill asked the Minister for Skills and Tertiary Education representing the Minister for Education and Early Childhood Learning—
 - (1) Will the catchments for the public primary and high schools in the electorate of Coogee be changing?
 - (a) If so, how?
 - (b) When will schools be notified of these changes?

Answer-

- (1) (a) There are no current plans to change local public primary and high school catchments that fall in the electorate of Coogee. A small residential area and parklands previously allocated to Randwick Girls High School and Randwick Boys High School have now been allocated to the new Inner Sydney High School. These areas fall within the electorates of Sydney and Heffron.
- (b) Schools were notified of these changes through ongoing consultation meetings from August 2018.
- *1398 15-19 CROWN STREET WOLLONGONG REDEVELOPMENT—Mr Ryan Park asked the Minister for Water, Property and Housing—
 - (1) What are the plans for 15-19 Crown Street Wollongong?
 - (2) As it was advised in 2018 that expressions of interest (EOI) for redevelopment would close on 31 October 2018, how many EOIs were received?
 - (3) Considering it was also advised in 2018 that the site would have works commencing in Mid-2019 and finished by 2022, is this still the timeframe the Department has planned for this site?
 - (a) If not, why?

Answer-

(2) and (3) These assessments were deferred while the government introduced the NSW Gas Plan. The plan was introduced in response to independent advice from Professor Mary O'Kane, then NSW Chief Scientist and Engineer, as set out in the Final Report of the Independent Review of Coal Seam Gas Activities in New South Wales.

The Government has consistently stated it will wait until the proposed Narrabri Gas Project is determined before it determines the 12 petroleum exploration licences renewal applications.

- *1431 COOKS RIVER—Ms Sophie Cotsis asked the Minister for Local Government—
 - (1) What are the Government's current plans to improve the environmental health of the Cooks River as at 22 August 2019?

(2) How much will the Government invest over the forward estimates to improve the environmental health of the Cooks River?

Answer-

The Government has provided financial and technical assistance to Cooks River councils to undertake a scoping study as the first stage of the Cooks Management Program being prepared for the Cooks River.

The study, led by the Cooks River Alliance, has identified biodiversity degradation, stormwater management and water quality as high priority issues.

The Government will continue to provide technical assistance to the councils and financial assistance through the Coastal and Estuary Grants program for this and any eligible works prescribed in the final Coastal Management Program.

- *1432 NEWCASTLE SUPERCARS—Mr Tim Crakanthorp asked the Minister for Jobs, Investment, Tourism and Western Sydney—
 - (1) What conditions of consent need to be complied with for the Newcastle 500 Supercars event?
 - (2) Will the Minister provide a copy of the conditions of consent?
 - (3) Has a risk assessment been undertaken for injuries that may be caused by debris from the race?
 - (4) What warnings are displayed to advise attendees and residents that noise generated from the event may cause hearing damage and/or loss?

Answer—

- (1) Under Section 15 of the Motor Racing (Sydney and Newcastle) Act 2008 conditions of consent for the event relate to:
- (a) public safety;
- (b) environmental protection;
- (c) insurance;
- (d) reporting requirements;
- (e) transport arrangements;
- (f) reinstatement of lands, financial arrangements (including the provision of security);
- (g) event and works planning requirements;
- (h) engineering certification requirements.
- (2) No. The authorisations are not released publicly.
- (3) Event operations are a matter for Supercars Australia as the organisers of the Newcastle 500. Destination NSW requires that Supercars Australia meets the safety criteria specified by the Confederation of Australian Motor Sports, the motor racing governing body, and the Federation Internationale de l'Automobile during all Newcastle 500 races.
- (4) Event operations are a matter for Supercars Australia as the organisers of the Newcastle 500. The Noise Management Fact Sheet prepared by Supercars Australia outlines the findings of the noise assessment as well as mitigation strategies which allow the community and residents close to the track to make informed decisions about their own wellbeing during the event. The Noise Management Fact Sheet can be found on Supercars Australia's website (www.supercars.com/newcastle/).
- *1433 HUNTER SCHOOL OF THE PERFORMING ARTS—Mr Tim Crakanthorp asked the Minister for Skills and Tertiary Education representing the Minister for Education and Early Childhood Learning—

What was the total cost of the new performing arts facilities at the Hunter School of the Performing Arts? Answer—

The budget for the upgrade of the Hunter School of Performing Arts is \$12.67 million.

The total cost will become available at the financial completion of the project.

- *1434 STOCKTON BEACH NOURISHMENT OFFSHORE SAND DREDGING—Mr Tim Crakanthorp asked the Deputy Premier, Minister for Regional New South Wales, Industry and Trade—
 - (1) Is the Deputy Premier aware that offshore sand dredging for beach nourishment purposes at Stockton has been identified as a potential solution to the erosion at Stockton beach?
 - (2) Is the Deputy Premier aware that offshore sand dredging for beach nourishment purposes has worked successfully in Queensland?

- (3) What is the process for gaining approval for offshore sand dredging for beach nourishment purposes in New South Wales?
- (4) Is the Deputy Premier willing to meet with community representatives to discuss offshore sand dredging for beach nourishment purposes at Stockton?
- (5) Considering that the Offshore Minerals Act 1999 No 42 notes that "a reserved block may be put up for tender by the Minister publishing in the Gazette a tender block licence notice", will the Deputy Premier give consideration to calling for tenders for offshore sand dredging for beach nourishment purposes at Stockton?

- *1436 COASTAL EROSION COLLAROY AND STOCKTON—Mr Tim Crakanthorp asked the Minister for Local Government—
 - (1) Since 2011, how much has the Government spent addressing coastal erosion at Collaroy (as at 26 September 2019)?
 - (2) Since 2011 how much has the Government spent addressing coastal erosion at Stockton (as at 26 September 2019)?

Answer—

- *1437 GOVERNMENT PAYROLL FUNCTIONS—Mr Tim Crakanthorp asked the Minister for Customer Service—
 - (1) Have the payroll functions of any Departments been sent offshore?
 - (a) If so, what safeguards are in place to protect the personal information of Government employees' personal data?

Answer-

- (1) Department of Customer Service Payroll transactions are delivered through the outsourced shared service delivery model GovConnect. Department of Customer Service Payroll is finalised by onshore teams
- (a) There is no offshoring of data except for data relating to a service request under controlled conditions. All data is stored on-shore, in a Government certified data centre (GovDC). Hard copy personnel files are stored at Government Records Storage and digital copies are managed onshore in New South Wales.
- *1439 STOCKTON BEACH OFFSHORE SAND DREDGING—Mr Tim Crakanthorp asked the Minister for Local Government—
 - (1) Is the Minister aware that offshore sand dredging for beach nourishment purposes at Stockton has been identified as a potential solution to the erosion at Stockton beach?
 - (2) Is the Minister aware that offshore sand dredging for beach nourishment purposes has worked successfully in Queensland?
 - (3) What is the process for gaining approval for offshore sand dredging for beach nourishment purposes in New South Wales?
 - (4) Will you consider lobbying the NSW Deputy Premier to call for offshore sand dredging for beach nourishment purposes at Stockton?

Answer-

The Government is working closely with the City of Newcastle Council to consider a range of long-term management options to address coastal erosion at Stockton, including the use of offshore sand supplies for beach nourishment.

*1440 STOCK ANIMAL SEIZURE ORDER REVIEW AND APPEAL—Mrs Helen Dalton asked the Minister for Agriculture and Western New South Wales—

Given the potential for high loss of earnings and hardship, why was no right of internal review or appeal to a judicial authority included in the Section 24 power to seize and dispose of stock animals 2012 amendments of the Prevention of Cruelty to Animals Act 1979?

Answer-

Seizure and disposal powers under the Prevention of Cruelty to Animals Act 1979 are a last resort and only taken in cases when stock are at a high risk of distress, or remaining distressed. Prior to this course of action, stock owners are given multiple opportunities to address identified welfare issues. Seizure and disposal only occurs when the Secretary or delegate makes the decision based on a Stock Welfare Panel recommendation that the welfare issues have not been addressed.

- *1441 GRIFFITH AND WADE HIGH SCHOOLS MERGER EVALUATION—Mrs Helen Dalton asked the Minister for Skills and Tertiary Education representing the Minister for Education and Early Childhood Learning—
 - (1) Considering that as Education Minister Adrian Piccoli championed the merger of Griffith and Wade High Schools in Griffith and is now employed by the University of New South Wales, why was the University of New South Wales chosen by the NSW Department of Education to conduct an evaluation of this merger, despite the potential conflict of interest?
 - (2) How will the independence of the evaluation be ensured?

Answer-

- (1) The University of New South Wales was selected to conduct a longitudinal study of the Griffith Secondary Education Project (Murrumbidgee Regional High School) through Department of Education procurement processes that met relevant legislation and policy requirements.
- (2) The Department of Education and the University of New South Wales have signed a Research Agreement which outlines their respective obligations and expectations both legally and ethically, including the processes and protocols to be followed, methodology employed as well as the rights and responsibilities of each party in terms of intellectual property, confidentiality and privacy of all involved.
- *1442 ISOLATED PATIENTS TRAVEL AND ACCOMMODATION ASSISTANCE SCHEME—Mrs Helen Dalton asked the Minister for Health and Medical Research—
 - (1) What type of nightly accommodation is the Isolated Patients Travel and Accommodation Assistance Scheme (IPTAAS), under which a single person receives a nightly accommodation allowance of \$43, intended to cover?
 - (2) Why is this allowance not increased in line with cost of living increases?
 - (3) Considering rising accommodation costs in major cities, what plans does the Government have to raise this allowance?

Answer-

The Isolated Patients Travel and Accommodation Assistance Scheme (IPTAAS) gives people living in regional and rural New South Wales greater access to specialist medical treatments, by helping pay some of their out-of-pocket expenses. The nightly accommodation subsidy for a single person is between \$43 and \$105, depending on the length of stay.

Investment in IPTAAS has more than doubled since 2011-12, from \$12.2 million to \$25.9 million in 2018-19. The Government's investment has provided direct financial assistance to regional patients, in what are often difficult and stressful times.

- *1443 WESTERN HARBOUR PRECINCT AND PYRMONT PENINSULA PLANNING REVIEW—Mr Alex Greenwich asked the Minister for Planning and Public Spaces—
 - (1) When will the Government make public the Greater Sydney Commission's report of the Western Harbour Precinct including the Pyrmont Peninsula Planning Review which is due on the 30 September 2019?
 - (2) Will the Government consider spot rezoning for individual sites based on this review?
 - (3) Will the Government consider reducing existing open green and recreation space based on this review?
 - (4) How will this review link up with plans for improved transport and community facilities to meet community needs?
 - (5) What is the process for making changes to planning controls after this review?
 - (6) How will this review be integrated with existing council controls that have been consulted and approved; and
 - (7) How will the Government provide public comment on any proposed changes?

Answer-

I am advised:

- (1) The Government released the Greater Sydney Commission's report on 5 October 2019. It is available on the Greater Sydney Commission's website.
- (2) The Greater Sydney Commission's report affirmed the Government's position that we must plan for this precinct strategically, rather than on a site-by-site basis to ensure the long-term liveability and sustainability of the area.
- (3) and (4) As Minister for Planning and Public Spaces, it is my priority to ensure there are always opportunities for better quality and more public spaces across Sydney. On one side of the Western Harbour Precinct, the new Cockle Bay development will provide more than a hectare of new open space connecting the CBD with the Darling Harbour precinct. On the other side of the Western Harbour Precinct, the new Fish Markets at Blackwattle Bay includes new public promenades and more than 30,000 square metres of new public open space, as well as, those critical pedestrian, cycling and open spaces connections between Glebe and Pyrmont.

Along with these critical active transport route upgrades, the Premier has fast-tracked the investigation of a Metro station at Pyrmont.

- (5) Any changes to planning controls arising from the master plan would be prepared in accordance with requirements of the Environmental Planning and Assessment Act 1979, including community consultation.
- (6) The Government will work closely with the City of Sydney in undertaking the Place Strategy, recognising that the City has a deep understanding of the Pyrmont peninsula and a long term stake in the area's success
- (7) The community will be consulted during the development of the Place Strategy.
- *1444 COUNCIL PLANNING POWERS—Mr Alex Greenwich asked the Minister for Planning and Public Spaces—
 - (1) Considering the Woollahra Municipal Council's review of response times for development decisions found an increase in response times since the introduction of the Local Planning Panels, what evaluation has the Government carried out into impacts of planning panels across New South Wales, specifically concerning:
 - (a) assessment timeframes;
 - (b) operational costs;
 - (c) transparency;
 - (d) integrity and accountability; and
 - (e) community trust in the planning system?
 - (2) What plans does the Government have to amend this system?

Answer-

I am advised:

In August 2017, the Parliament passed legislation mandating local planning panels across Greater Sydney and in the Wollongong Local Government Areas. The panels commenced operations on 1 March 2018.

Local planning panels were introduced to improve the transparency and integrity at the local planning level and to establish a standard panel model across councils.

Panels are providing additional safeguards, a high degree of probity and accountability to the decision-making process for development applications.

To further enhance integrity in decision-making, in 2018 the then Department of Planning and Environment appointed Nick Kaldas, former New South Wales Deputy Police Commissioner, to review governance arrangement and decision-making in the planning system.

The Kaldas report was released in December 2018 and identified the positive impacts of local planning panels in Greater Sydney and Wollongong.

The Government accepted all 19 recommendations made by Mr Kaldas. A new ethics unit has been established and mandatory probity checks for all local panel members including community members have been undertaken in response to the Kaldas recommendations.

The Kaldas report also recommended that the then Department of Planning and Environment consider extending local panels to the Central Coast and Newcastle.

In August 2019, the Government announced that it would extend the local planning panels to the Central Coast as there is a high level of growth occurring in the region that requires good decision-making to properly implement the Central Coast Regional Plan 2036.

A report reviewing the first six months of operations was published on 19 December 2018 by the University of Technology Sydney Institute for Public Policy and Governance (IPPG) and found that all 34 panels across Greater Sydney and Wollongong had been established and were operational with most surveyed panel members and directors of planning reporting that the panel process is working well. The IPPG six month report can be found on the Department of Planning, Industry and Environment's (the Department) website: https://www.planning.nsw.gov.au/Assess-and-Regulate/Development-Assessment/Local-Planning-Panels/Evaluation-framework.

The Department has engaged the IPPG to monitor and evaluate the implementation of the first 12 months of the operation of the panels. The Department intends to publish the review report once it has worked through the recommendations.

The Department will continue to monitor the operation of panels and investigate any complaints made regarding a specific panel. The Department will also continue to support councils and the panels with guidance to ensure that the panels remain operating effectively.

*1445 VOTING AGE—Mr Alex Greenwich asked the Premier—

- (1) What consideration has the Government given to reducing the minimum voting age to 16 years of age?
 - (a) What liaison has been carried out with the Commonwealth and other State and Territory Governments on this matter?
- (2) What process is required to change the minimum voting age?
- (3) What plans does the Government have to review the minimum voting age?

Answer-

In 2013, the Joint Standing Committee on Electoral Matters ('the Committee') conducted an inquiry into the Parliamentary Electorates and Elections Act 1912 (NSW) ('the Act').

The terms of reference included consideration of the Act's provisions in relation to the entitlement to enrol and vote in New South Wales.

The Committee's report made no recommendation to reduce the minimum voting age from 18 years.

Therefore, the minimum voting age of 18 years was maintained in the Electoral Act 2018 (NSW).

The Government has no plans to review the minimum voting age.

*1446 REGENERATIVE AGRICULTURE—Mr Alex Greenwich asked the Minister for Agriculture and Western New South Wales—

- (1) Considering the increasing interest in regenerative agriculture practices, what information, research, training and support does the Government provide to the farming industries?
- (2) What assessment has the Government made of benefits including:
 - (a) soil retention and health;
 - (b) greenhouse emissions and carbon sequestration;
 - (c) farm productivity;
 - (d) adaptation to climate change?
- (3) What assessment has the Government made of programs in other jurisdictions such as New Zealand?
- (4) What further action will the Government take to support regenerative agriculture?

Answer-

The principle of regenerative agriculture is to restore landscape function and deliver results that include sustainable production, an improved natural resource base, healthy nutrient cycling, increased biodiversity and resilience to change. The NSW Department of Primary Industries (DPI) supports the restoration of multiple-functional landscapes that co-deliver the production of food and fibre, preserve the state's biodiversity and contribute to carbon sequestration.

NSW DPI has a long history in undertaking research and development that support these principles. DPI is a science based organisation and undertakes research and development to develop evidence based responses to promote productive and sustainable agriculture. As such many of the principles underpinning regenerative agriculture are considered best management practice within the farming community. These practices include enhanced grazing management to maintain groundcover whilst

maximising production, reduced till for moisture conservation and improved soil health, and precision irrigation to optimise the use of water.

NSW DPI has a specialist research and development unit (Soil and Water R&D unit) that has 70 staff which examines a range of soil and water management issues in both production and landscapes contexts. The Government invests over \$7 million per annum on this R&D with similar additional funds being contributed by our partners. Key areas of research include soil carbon and nutrient management, protecting soil from degradation, improving crop and livestock management and farming systems to improve access to soil water resources and improving irrigation management. These investments will continue to deliver production and economic benefits as well as enhancing the soil and water resources and the broader environment.

Other specific activities include:

- Research and development to improve the effectiveness of time controlled grazing (EverGraze)
- NSW Primary Industries Climate Change Research Strategy
- Program of work supporting the productive and sustainable use of the soil and water
- Partnering with Mulloon Institute to better understand the effectiveness of landscape rehydration.

DPI through its Registered Training Organisation, Tocal College delivers training to its students in sustainable grazing management in all of its agricultural qualifications (Certificate III to Diploma). Tocal College also recently partnered with Inside Outside Management to deliver a holistic grazing management course which was available to both students and farmers that was subsidised by Hunter Local Land Services.

Over the past 10 years DPI has also completed a number of comparative studies on a range of conventional and alternative grazing and cropping farming systems.

DPI is also aware of the global movement toward regenerative agriculture, and is currently considering how it might inform future New South Wales government policy. This includes recent discussions between DPI and Southern Cross University to scope and develop potential new areas of collaborative research through current and future funding opportunities.

DPI is currently responding to an investment call by Meat and Livestock Australia "to undertake a literature review of the differences between widespread grazing systems (e.g. regenerative versus conventional grazing systems, set stocking vs. intensive grazing systems, biodynamic/organic vs. conventional grazing practices) in terms of soil carbon sequestration rates, soil biology, pasture species persistence and overall economic performance". If the DPI tender is successful, the information generated will provide and inform recommendations on the scientific merit of regenerative agriculture. These recommendations will in turn provide a basis for farmers to assess how they may adopt these principles for their own farming systems.

- *1447 ULTIMO CREATIVE INDUSTRIES PRECINCT—Mr Alex Greenwich asked the Premier representing the Special Minister of State, Minister for the Public Service and Employee Relations, Aboriginal Affairs, and the Arts, Vice-President of the Executive Council—
 - (1) Does the Government still propose to develop an Ultimo Creative Industries Precinct as set out in the Cultural Infrastructure Plan 2025+?
 - (2) Does the Government still plan to keep the Powerhouse Museum open and exhibiting until early 2020?
 - (3) What progress has been made on a Masterplan for the Ultimo Powerhouse Museum site?
 - (4) Does the Government remain committed to retaining ownership of the Ultimo museum site?
 - (5) Does the Government still plan a design and fashion museum at Ultimo?
 - (a) When will a proposal be put on public exhibition?
 - (6) Does the Government still plan a 1,500-seat Broadway-style theatre at Ultimo?
 - (a) When will a proposal be put on public exhibition?
 - (7) What other proposals are being considered for the Ultimo site?
 - (8) How will the Government ensure that the future of the site celebrates local, built and social history and heritage?
 - (9) How will the Government engage the local community, supporters and donors to the Powerhouse Museum about the future of the site?

Answer—

I am advised,

A Final Business Case is being prepared to provide advice to Government on future uses for the current site of the Powerhouse Museum at Ultimo. The Government is committed to retaining a cultural presence at this important site and to supporting the creative industries in New South Wales by developing a precinct where these industries can continue to contribute to the growth of the New South Wales economy. The Final Business Case will be completed later this year and is being informed by the development of a Masterplan. In addition to the development of a creative industries precinct, the Masterplan is investigating a range of other options for the site, including a 1,500-seat Broadway style lyric Theatre and a museum. The Business Case is on track to be presented to Government for its consideration in early 2020.

The Powerhouse will remain open to the public until June 2021, with a staged closure commencing from June 2020. Digitisation of the collection as part of the relocation program commenced with the launch of the Museum's digitisation studio in October.

- *1448 AT RISK CHILDREN AND YOUNG PEOPLE—Mr Alex Greenwich asked the Minister for Families, Communities and Disability Services—
 - (1) What assessment has the Government made of the Victorian Sentencing Council's report 'Crossover Kids': Vulnerable Children in the Youth Justice System' finding that children experiencing childhood trauma, under child protection orders, removed from their families and/or in out-of-home care and residential care are overwhelmingly likely to also experience custodial orders?
 - (2) How does New South Wales data compare to the Victorian data considering the following:
 - (a) That half the children first sentenced aged 10 to 13 were the subject of a child protection report;
 - (b) That Aboriginal and Torres Strait Islander children under child protection orders or residential care made up one third of children sentenced to a custodial order?
 - (3) What systems does the Government have in place to prevent the above findings from occurring to the most vulnerable and at-risk children in New South Wales?
 - (4) What further action does the Government have to break the nexus between childhood trauma, child protection orders and removal from family leading to custodial orders?

Answer—

(1) The New South Wales Government acknowledges the significant overlap between the Youth Justice and child protection systems that exists in all jurisdictions across

Australia. The Australian Institute of Health and Welfare (AIHW) released research in 2018 about the interaction between these two systems across Australia between 1 July 2014 and 30 June 2016. The findings are available at: https://www.aihw.gov.au/getmedia/06341e00-a08f-4a0b-9d33-d6c4cf1e3379/aihw-csi-025.pdf.aspx?inline=true.

(2) Within a New South Wales context, a census of young people in custody conducted by Youth Justice in July 2014 found that of the 283 in custody on that date, 22%

had current Community Services involvement. Of this group:

- 65% were Aboriginal or Torres Strait Islander.
- 12% were in out-of-home care prior to coming into custody.
- 8% were current child protection cases.

There a number of other studies that draw attention to this, including the 2011 Legal Aid NSW issues paper 'The Drift from Care to Crime', and the Forecasting Future Outcomes 2018 insights report from the Stronger Communities Investment Unit of Their Futures Matter. (3) and (4) The benefit of defining vulnerable groups and their expected costs assists in developing costeffective services aimed at improving outcomes for vulnerable children, and identifying the need to intervene early to prevent any impact of future criminal justice involvement.

The Department of Communities and Justice's family preservation programs including Brighter Futures, Intensive Family Preservation and Intensive Family Based Services work to strengthen family functioning and wellbeing. Intensive Family Based Services work exclusively with Aboriginal and Torres Strait Islander families, children and young people. Program data shows that completion of these programs strengthens family functioning.

The integration of Youth Justice into the Stronger Communities cluster provides a valuable opportunity to cultivate a longitudinal, whole-of-system approach to the provision of care, intervention and case management of shared clients in child protection, out of home care and Youth Justice, to improve their individual circumstances and life trajectory, and to address the underlying factors that contribute to a child or young person entering the child protection or criminal justice systems.

- *1449 BAY PRECINCT CREATIVE INDUSTRIES PRECINCT—Mr Alex Greenwich asked the Premier representing the Special Minister of State, Minister for the Public Service and Employee Relations, Aboriginal Affairs, and the Arts, Vice-President of the Executive Council—
 - (1) Does the Government still propose a 'facility for cultural activities' in the Bay Precinct as set out in the Cultural Infrastructure Plan 2025+?
 - (2) What proposals have been developed and are being considered?
 - (3) When will these proposals be made available for community comment and input?

Answer—

- (1) As outlined in the Cultural Infrastructure Plan 2025, Create NSW will investigate opportunities for the inclusion of appropriate cultural facilities and programs alongside the mix of working, retail and other activities in the Bays. Cultural infrastructure will support renewal and development by creating vibrant, socially connected places which help to retain and develop local identity, improve liveability and support successful transitions in a changing urban environment.
- (2) Create NSW will continue to contribute to infrastructure planning in the Government's planned developments, including the Bays Precinct, alongside Infrastructure NSW and Transport for NSW.
- (3) The Bays will be an exciting mix of heritage assets, such as the White Bay Power Station, with new open public spaces, community facilities, commercial and residential sites, and working harbour uses.

(1) to (4) Public dental services are provided according to criteria that prioritises emergency situations, as well as patient groups in most need and at highest risk of disease. Data is regularly updated and can be accessed from the NSW Health website.

The NSW Health Policy Directive 'Priority Oral Health Program and Waiting List Management' outlines recommended maximum waiting times for dental care based on oral health needs. National Partnership Agreements from 2013-17 between the Commonwealth and State Governments resulted in a significant increase in public dental service provision including increases in employment of the number of dental teams in public dental services, increased clinic hours and chair availability, and increased utilisation of the NSW Oral Health Fee for Service Scheme (OHFSS) vouchers issued to private practitioners.

NSW Health dental facilities are staffed by a mix of appropriately trained dental officers, dental therapists, oral health therapists and dental assistants. Districts vary staffing profiles and numbers to appropriately meet operational needs at any given time. The total New South Wales expenditure budget on public dental activity (excluding the mobile dental program) is approximately \$238 million for 2019-20. This includes an additional \$30 million funding provided by the Government since 2016-17.

(5) and (6) The Government is continuing negotiations with the Commonwealth Government to improve public dental services through the National Partnership Agreement and to negotiate long term, sustainable funding arrangements for public dental services, including extension to the Commonwealth Child Dental Benefit Scheme.

*1452 SCHOOLS FUNDING MECHANISMS WALLSEND ELECTORATE—Ms Sonia Hornery asked the Minister for Skills and Tertiary Education representing the Minister for Education and Early Childhood Learning—

Considering that some public schools in the Wallsend Electorate are in competition with groups such as community groups, sporting organisations and churches for community grants, what mechanisms are available for schools to seek more funding from the Department to address maintenance and infrastructure issues?

Schools can contact their local Asset Management Unit to discuss funding options for maintenance and infrastructure projects.

Maintenance and capital funding is available to schools and is allocated annually. This includes funding for minor and major works projects.

In addition, the Department of Education has specialist funding programs which are available to schools. The Asset Management Unit can assist school principals to identify funding pathways and submit funding applications.

In addition to congestion metrics, metrics of traffic performance such as Level of Service, Delay, Queue Lengths and Volume Capacity Ratio are used to assess links, turning movements, individual intersections and networks of intersections.
- (b) JTR and FFSR metrics are derived from google data sourced from mobile users. Other performance metrics come from traffic models that use inputs gathered by conducting surveys through people or video cameras. The data is analysed through the model and developed into performance metrics.
- *1455 ROAD CONGESTION WALLSEND ELECTORATE—Ms Sonia Hornery asked the Minister for Transport and Roads—

Answer-

I am advised:

The planning proposal for 194-214 Oxford Street and 2 Nelson Street Bondi Junction was considered by the former Sydney East Joint Regional Planning Panel, which found that it had strategic merit and unanimously recommended that it proceed to Gateway determination.

The Department issued a Gateway determination and the proposal proceeded to public exhibition. Given the large amount of community interest in the proposal, the Department sought advice from the Independent Planning Commission (the Commission) when the proposal was sent to the Department for final determination.

The Commission found the proposal had strategic and site-specific merit and should proceed to finalisation. In considering the heritage impacts associated with the proposal, the Commission found that the impacts to the local and State heritage items were acceptable and can be adequately addressed at the development application stage. In relation to overshadowing of Centennial Park, the Commission found that the overshadowing was acceptable as it was only for a small area of the park and only for a period of one hour in mid-winter in the morning.

In relation to heritage conservation zones, they are a matter for Waverley Council.

Given the recommendation from the Planning Panel and the Commission that the proposal should proceed to finalisation, the planning proposal was finalised and the amendment to the Local Environmental Plan was made on 20 September 2019.

Before any development can occur on the site, a development application must be lodged and assessed by Waverley Council. This will provide the public an opportunity to comment on any future development on the site.
