- *4244 MENTAL HEALTH SERVICES—Mr Anoulack Chanthivong asked the Minister for Health and Medical Research representing the Minister for Mental Health, Regional Youth and Women—
 - (1) How much funding was allocated to mental health services in the following local health districts in the 2017-18 financial year:
 - (a) South Western Sydney;
 - (b) South Eastern Sydney;
 - (c) Illawarra Shoalhaven;
 - (d) Murrumbidgee?
 - (2) How much funding was allocated to mental health services in the following local health districts in the 2018-19 financial year:
 - (a) South Western Sydney;
 - (b) South Eastern Sydney;

 - (3) How much funding was allocated to mental health services in the following local health districts in the 2019-20 financial year:

Answer-

Direct mental health budget allocations are published within the Local Health District's service agreement. The published amounts do not incorporate indirect funding which is included in other line items (such as Teaching, Training and Research, and Small Rural Hospitals).

Each local health district has a service agreement which is published on the website of that Local Health District.

*4245 DEVELOPMENT APPLICATION ELIGIBILITY REQUIREMENTS—Mr Roy Butler asked the Minister for Customer Service—

Considering smaller organisations in the Barwon electorate may not have available funds to support a Development Application prior to seeking a grant, will the eligibility guidelines for the Club Grants Category 3 Fund Infrastructure Grants be changed so that organisations do not require an approved Development Application to apply for this grant funding?

Answer-

The approved development application eligibility requirement is in place to ensure projects as assessed and presented for funding consideration are ready to proceed with all designs, approvals and assessment requirements complete and in place. This ensures equity for all applicants, so that grants awarded to organisations are determined for projects that are fully developed and shovel ready.

Previously some projects approved for funding were stalled for significant periods, resulting in either major scope changes due to development approval requirements, and in some cases, not able to proceed due to development consents not approved. The requirement is in place to prevent this occurring and it also provides assurance, as far as is possible, that the proposed infrastructure can proceed as described in the application with minimal risk.

Further, the Clubgrants Category 3 Infrastructure Grants Program receives hundreds of applications each round from all over the state that meet all current eligibility requirements, including the development consent requirement (over 600 in 2019-20).

*4246 LOCAL SPORT GRANT PROGRAM ELIGIBILITY GUIDELINES—Mr Roy Butler asked the Minister for Sport, Multiculturalism, Seniors and Veterans—

Considering smaller organisations in the Barwon electorate may not have available funds to support a Development Application prior to seeking a grant, will the eligibility guidelines for the Local Sport Grant Program be changed so that organisations do not require an approved Development Application to apply for this grant funding?

Answer-

I am pleased to say that 12 clubs and associations in the Barwon electorate were awarded a total of \$92,569 in funding under the 2019/20 Local Sport Grant Program.

Grant programs administered by the Office of Sport are very competitive and require funding awarded to be expended within timeframes as set out in the Terms and Conditions or Funding Agreements.

Development Application approval provides the Office with reliable evidence and certainty to ensure that the proposed project has been well planned, scoped, and approved by the relevant authority, prior to any commitment of funding.

The Office of Sport will continue to review criteria when developing Guidelines for future grant programs.

*4247 BARWON ELECTORATE HOMELESSNESS—Mr Roy Butler asked the Minister for Water, Property and Housing—

Considering that in 2016 the Barwon electorate was ranked 35 for homelessness across the 93 NSW electorates and the contributors to homelessness are prevalent, how much of the \$22 billion in the Communities Plus building program has been allocated to the Barwon electorate to create more social housing properties?

Answer-

I am advised:

The Communities Plus building program seeks to renew existing social housing estates and sites to deliver new mixed tenure communities with private, affordable and social housing to achieve better social outcomes. The Communities Plus model relies on land value to build new and replacement social housing, funded by private housing also being built, and then sold, on the site.

There are no plans to utilise the Communities Plus model in the Barwon electorate.

- *4248 COMMUNITY HOUSING TENANTS—Mr Roy Butler asked the Minister for Families, Communities and Disability Services—
 - (1) Will new policies be implemented to aid Community Housing tenants relocating to new Community Housing quickly if:
 - (a) The Community House they are tenanted in is damaged?
 - (b) The tenant is in a Domestic Violence situation and has no shelter to go to?
 - (c) The tenant wishes to relocate to another town/city to be closer to family for support?

Answer—

I am advised:

Each community housing provider has an internal policy that outlines how it will respond to property damage and to tenants experiencing domestic violence who have nowhere safe to go.

Typically, community housing providers' immediate response is to undertake a safety assessment with the tenant, NSW Police Force and any other stakeholders. Where required, community housing providers assist the tenant to link to supports to ensure their safety and to access immediate alternative accommodation. For example, through a Specialist Homelessness Service, Temporary Accommodation or an escalated internal transfer. Once the tenant experiencing domestic violence is safe, providers will work with them on their longer term housing solution. The Government can provide a range of assistance to people at risk of homelessness including RentChoice, Start Safely and RentStart products.

Where a tenant wishes to relocate, the Department of Communities and Justice or the community housing provider can assist the tenant to complete a transfer request and provide the relevant documentation. Depending on their circumstances, the tenant may be approved for a priority transfer.

*4249 MENTAL HEALTH AND DOMESTIC VIOLENCE PROGRAM OVERSIGHT COMMITTEE—Mr Roy Butler asked the Minister for Health and Medical Research representing the Minister for Mental Health, Regional Youth and Women—

Will an oversight committee be formed to link Mental Health and Domestic Violence programs within

New South Wales?

Answer—

NSW Health is already working with the Department of Communities and Justice and other interagency partners on Domestic and Family Violence (DVF) issues through existing governance structures.

This includes contributing to interagency state-wide DFV reform activities through the Domestic and Family Violence Reform Delivery Board (DFVRDB). The DFVRDB is the lead governance body for overseeing domestic and family violence reforms.

NSW Health is actively engaged with interagency structures at the state and local level to support the delivery of key DVF programs and initiatives. This includes NSW Health representation at all Safety Action Meetings (SAMs) across New South Wales. SAMs are regular meetings of local service providers that aim to prevent or reduce serious threats to the safety of domestic and family violence victims.

NSW Health is also a partner agency in the Local Coordinated Multi-Agency Offender Management Program, with practitioners from Alcohol and Other Drugs and Mental Health services engaged with the program at local sites.

 - (3) Is there a complaints process to the Government in relation to Tomra?
 - (4) Is there an exclusive contract for Tomra for Return and Earn?
 - (a) When does the contract expire?

- *4251 YARRIE LAKE FLORA AND FAUNA TRUST—Mr Roy Butler asked the Minister for Water, Property and Housing—
 - (1) What entity/governance structure has been prescribed for the Yarrie Lake Flora and Fauna trust?
 - (2) Could the Member for Barwon be provided with the Yarrie Lake Flora and Fauna Trust appointment instrument and a plan of management if one is required?
 - (3) Are the financial and other reports for the last 12 years available for this Trust?

Answer-

I am advised:

- (1) The Yarrie Lake Flora and Fauna Trust is a community-based Crown Land Manager.
- (2) Appointment instruments are published in the Government Gazette. The Yarrie Lake Flora and Fauna Crown Land Manager is a community-based Crown Land Manager. As such, there is no requirement for a formal plan of management.
- (3) Reports are available for the 2009, 2010 and 2011 financial years. The Department is working with the current Board to meet its financial reporting requirements.
- *4252 CROWN LAND RESERVE TRUSTS—Mr Roy Butler asked the Minister for Water, Property and Housing—
 - (1) Are board vacancies for Crown Land Reserve Trusts always advertised?
 - (2) What are the annual reporting requirements for Crown Land Reserve Trusts?

(3) Does each trust have a specific appointment instrument and a plan of management?
(a) How are these obtained by the public?

Answer-

I am advised:

- (1) Board vacancies for Crown Land Reserve Trusts are generally advertised. However, if a vacancy occurs after recent Board appointments, the vacancy may be filled from the list of earlier applicants, and ad-hoc applications may also be accepted where there has been some difficulty in filling positions.
- (2) Non-Council Crown Land Managers are required to submit an annual report each year, as prescribed by the Crown Land Management Regulation 2018.
- (3) Non-Council Crown Land Managers have an appointment instrument which is provided to new Board members following advertisement of their appointment in the Government Gazette of New South Wales.

Non-Council Crown Land Managers are not required to adopt Plans of Management (PoM) for their reserves. However, where PoMs are submitted and adopted for some high usage and sensitive sites, these are listed on the publicly available Reserve Manager website: https://reservemanager.crownland.nsw.gov.au/land-management/plans-of-management

- *4253 NEWCASTLE INTERCHANGE CUSTOMER SERVICE COUNTER—Mr Tim Crakanthorp asked the Minister for Transport and Roads—
 - (1) Will uniform size perspex screens be installed along the entire length of the Newcastle Interchange customer service counter to protect staff?
 - (a) If not, why not?
 - (2) Will a permanent glass shield be installed at the Newcastle Interchange customer service counter to protect staff?
 - (a) If not, why not?

Answer—

*4254 MENTAL HEALTH TREATMENT IN GRIFFITH—Mrs Helen Dalton asked the Minister for Health and Medical Research representing the Minister for Mental Health, Regional Youth and Women—

Considering the response to LA Q2175 that Wagga Wagga "meets the requirements for the [Griffith] population" in terms of hospital mental health beds, what support does the Government give to families who cannot afford to travel two to three hours to Wagga Wagga for mental health treatment?

Answer—

Patients who require an acute mental health admission in Wagga Wagga are transferred by the Murrumbidgee Local Health District Patient Transport Service or by NSW Ambulance. Care after discharge from hospital is provided in Griffith by the Griffith Community Mental Health team.

The majority of people with a mental health condition do not require admission to an acute mental health facility. Consumers and their families from Griffith and surrounding communities can access local specialist mental health services in the community. A comprehensive range of free publicly funded mental health services are available in Griffith. These services also outreach to surrounding towns.

- *4255 ENVIRONMENTAL WATER ACCOUNTS—Mrs Helen Dalton asked the Minister for Energy and Environment—
 - (1) When did you first become aware that your department's environmental water access licence No. 36338 was being used by foreign corporation Webster Limited and Duxton Water to park water?
 - (2) Is it appropriate for foreign companies to use government environmental water accounts to store water for irrigation or water trading purposes?
 - (3) Can ordinary mum-and-dad Australian farmers access government environmental water licences to store water?

Answer-

I am advised that:

(1) The Department of Planning, Industry and Environment - Environment, Energy and Science Group

(DPIE-EES) periodically trades environmental water and carryover space.

All decisions on water trading are undertaken within the Department, under appropriate delegation. As per the response to the question on notice raised on 26 August 2020, I was briefed on this matter.

- (2) The Department undertakes commercial trades to provide environmental benefit by helping to balance water availability and demand across seasons and water sources, and contribute to the cost of water charges associated with the holding and use of water licences. The Department trades in a 'blind' market to ensure there is no discrimination of buyers or sellers.
- (3) The Department trades in the same way as other water users through broker networks and online platforms, ensuring broad and open access for buyers and sellers, without identification. All licence holders within the relevant water source can access this option through normal market processes.
- *4256 ALMOND FARM IN HILLSTON—Mrs Helen Dalton asked the Minister for Water, Property and Housing—
 - (1) Considering that a foreign company has bought a \$98 million almond orchard in Hillston, which includes more than 11,000 megalitres of water entitlements and that almond farms use vast amounts of water and create few local jobs, what is the Government doing to ensure this purchase benefits the Riverina community?
 - (2) Has the Government expressed any concerns about this purchase with the Commonwealth Government?

Answer-

In March this year, the Commonwealth Treasurer announced that all monetary thresholds for Foreign Investment Review Board assessment had been temporarily set to \$0. This lowered threshold guaranteed any sale was assessed by the appropriate agency.

New South Wales has a publicly searchable NSW Water Register and Water Access Licence Register which provides information about every water licence in New South Wales. In addition, the Australian Tax Office (ATO) maintains a Register of Foreign Ownership of Water Entitlements, to provide greater transparency on the level of foreign ownership of Australia's water entitlements.

All foreign investors with an interest in a water right or registerable water entitlement (which includes irrigation rights, the right to hold water, and/or the right to take water from a water resource in Australia) are required to register with the ATO.

*4257 ENGAGEMENT FOR INFORMAL CARERS—Ms Jodie Harrison asked the Minister for Families, Communities and Disability Services—

Considering the issue of "digital exclusion of carers" in the context of the COVID-19 pandemic was raised in the 29 June 2020 meeting of the Carers Advisory Council, what steps is the Government taking to ensure informal carers are still being engaged in times of heightened social distancing and isolation?

Answer—

In October 2020, Minister Lee, Acting Minister for Seniors and I jointly wrote on this matter to our Commonwealth counterparts in response to a letter we received from the Carers Advisory Council, the Disability Council and the Ministerial Advisory Council on Ageing.

We wrote to the Commonwealth about the barriers that seniors, carers and people with disability face in accessing digital technology and the subsequent inequities that follow in accessing services and social exclusion.

I am advised that throughout the pandemic, Carers NSW has been providing advice by website and newsletter to support carers, and has developed a range of COVID-19 fact sheets for carers, available at: http://www.carersnsw.org.au/publications/resources.

It is a priority in the NSW Carers Strategy: Caring in New South Wales 2020-2030 that carers have better access to information, services and supports. The NSW Carers Strategy can be accessed at: https://www.facs.nsw.gov.au/inclusion/carers/nsw-carers-strategy.

*4258 MENTAL HEALTH SUPPORT FOR INFORMAL CARERS—Ms Jodie Harrison asked the Minister for Families, Communities and Disability Services—

Considering the poor reported mental health outcomes for informal carers, what mental health support is available for informal carers?

Answer-

The Government's social media campaign Its Caring was launched in Carers Week and is available at: https://www.caring.dcj.nsw.gov.au/. The Service NSW carers portal can be accessed at: https://www.service.nsw.gov.au/guide/carers. Both these resources encourage carers to contact the Commonwealth Carer Gateway for support.

I am advised services offered through the Commonwealth Carer Gateway include counselling, connection with other carers, coaching, courses and emergency respite services. It can be accessed at: https://www.carergateway.gov.au/.

The Commonwealth Government provided extra financial support to Carer Gateway providers under its COVID-19 mental health response. All providers have received funding specifically to address carer mental health in the pandemic including the four providers in New South Wales listed at: https://www.carergateway.gov.au/help-advice/getting-help.

- *4259 DISABILITY STRATEGY IMPLEMENTATION—Ms Jodie Harrison asked the Minister for Skills and Tertiary Education representing the Minister for Education and Early Childhood Learning—
 - (1) Considering that a representative from the COVID-19 Taskforce and the Department of Education's Relieving Director Disability Strategy Implementation attended the Carers Advisory Council Meeting on 29 June 2020 to provide an update on the Department's Disability Strategy implementation, what elements of this strategy are specifically targeted towards carers?
 - (2) What elements of this strategy are expected to broadly impact carers?
 - (3) What progress has been made on the strategy's implementation?

Answer—

Almost every aspect of the Disability Strategy seeks to improve the lives of students with a disability by ensuring they are known, valued and cared for. One of the markers of success for the Disability Strategy is for parents and carers to be treated like partners in their child's education.

In 2020 the Government released its Inclusive Education Statement for Students with a Disability, which also addresses parent and carer inclusion. The Government is committed to consulting with parents and carers on inclusive education including developing inclusive practice resources and updating policy.

To ensure families and carers of students with additional learning and support needs can find the advice and information they need to support their child through their education journey the Department has also developed new online resources.

The Government is further committed to improving the family experience by streamlining the access request process, and improving communication and reporting to parents and carers of students with additional support needs of the outcomes of this process.

- (3) In November 2020, I will table the 2020 Progress Report: Improving outcomes for students with disability. This report provides the progress that the Department has made in 2020 for students with disability. The report will note that two-thirds of the key focus areas of the Disability Strategy are well progressed.
- *4260 CARERS WEEK EVENTS GRANTS—Ms Jodie Harrison asked the Minister for Families, Communities and Disability Services—
 - (1) Considering that Carers Week events grants for 2020 will not be issued due to safety considerations as a result of the COVID-19 pandemic, what "other carer support activities" as stated on the Carers NSW website will be funded in lieu of these grants?
 - (2) What is the dollar figure of funding provided for these carer support activities?

Answer—

I am advised that carer support activities that comply with COVID-19 restrictions will be delivered over the month of October, starting in National Carers Week, 11 to 17 October.

The Government funds Carers NSW the peak organisation for carers in New South Wales. To celebrate carers and recognise the significant contribution carers make each and every day, Carers NSW hosted a range of online wellbeing workshops and webinars during National Carers Week.

The Its Caring campaign is a social media campaign to recognise and promote the important role carers play in New South Wales communities. It will also be shared on screens in medical waiting rooms and pharmacies and can be accessed at: https://www.caring.dcj.nsw.gov.au/.

The new NSW Carers Strategy: Caring in NSW 2020-2030 and the first two year Action Plan under the Strategy, was launched on 12 October 2020 during National Carers Week. Information about the Carer's Strategy, including carer projects funded are available at: https://www.facs.nsw.gov.au/inclusion/carers.

The Carers Investment Program commenced from 1 July 2018 and will fully re-invest Carers Grant funding of \$5.6 million over three years. The funding of face to face events for carers will be revisited in 2021, dependent on the COVID-19 situation.

- *4261 INFORMAL CARERS—Ms Jodie Harrison asked the Minister for Families, Communities and Disability Services—
 - (1) Considering the economic contribution of informal carers in New South Wales, how much would it cost for the Government to provide the services provided by unpaid informal carers in New South Wales?
 - (2) How many hours of care are provided for free by informal carers in New South Wales each year on average?
 - (3) What is the economic cost, in terms of lost employment opportunity and economic activity, to informal carers in New South Wales on average?

Answer-

The cost to the Government if it were to provide the services provided by the many informal carers in New South Wales equates to about \$25 billion, and amounts to approximately 692 million plus hours of care a year. I am further advised the Carers Investment Program commenced from 1 July 2018 and will fully reinvest Carers Grant funding of \$5.6 million over three years.

- *4265 INFORMAL CARERS—Ms Jodie Harrison asked the Minister for Families, Communities and Disability Services—
 - (1) How many carers provide informal care in New South Wales as at 13 October 2020?
 - (a) If an exact figure cannot be determined:
 - (i) What is the approximate figure?
 - (ii) What barriers exist preventing the provision an exact figure?

Answer-

I am advised:

There are 854.300 carers in New South Wales.

*4266 GIG ECONOMY WORKER PROTECTION—Ms Jo Haylen asked the Minister for Better Regulation and Innovation—

Considering the tragic deaths of two food delivery couriers on New South Wales roads over the past month, what action will the Government take to ensure gig economy workers are best protected by workers compensation and Workplace Health and Safety legislation?

Answer—

The NSW Police Force is the lead agency for these type of matters as they directly relate to road regulations and safety.

SafeWork NSW is monitoring the incidents to ensure they are being notified as required under work health and safety (WHS) legislation.

The Government is currently sponsoring a major research project into the gig economy. The first phase of the project, involving comprehensive research and a survey of gig economy workers in the food delivery industry, has now been completed.

The next stage of the project will engage with gig economy platforms and gig economy workers to identify practical measures and initiatives that can improve workplace safety. These measures will by trialled in the workplace early next year and their impact evaluated.

A final evaluation report will be completed in the third quarter of next year and will include recommendations to Government on policy changes that may be needed to New South Wales' workplace safety regime.

- *4267 FRESHWATER CLASS FERRIES MAINTENANCE BUDGET—Ms Jo Haylen asked the Minister for Transport and Roads—
 - (1) What is the total annual maintenance budget for the Freshwater-class ferries?
 - (2) How will Sydney Ferries and Transport for NSW manage the capacity constraints on the Manly-Circular Quay route during the peak Summer months when the capacity of the proposed Emerald-class catamarans is less than half that of the Freshwater class?
 - (a) What community consultation has been undertaken regarding this decision?

Answer-

I am advised:

(1) The annual maintenance budget for the Sydney Ferries fleet is a component of the overall contract value for the Ferry System Contract between Transport for NSW and Transdev Sydney Ferries.

Transport for NSW estimates the annual maintenance budget for a Freshwater Class vessel is on average between \$1 million and \$1.5 million per vessel per year (averaged over a five year period).

(2) By operating more frequently, similar overall service capacity will be provided over summer.

The Freshwater Class provides for around 2,850 customers per hour (in each direction when the summer timetable is in place. The Emerald Class will provide for up to 2,800 customers per hour.

(3) Customer requirements are a key consideration when planning service changes.

Customer feedback and research on customer satisfaction drivers shows that timeliness and convenience are important for our customers. Many other factors, like connectivity between modes and customer travel patterns are also considered.

The proposed service change will increase services in a typical week from 492 to 820 (an increase of 328), while journey times will reduce by around eight minutes. This means that during a typical week a service will be provided for customers every 20 minutes on weekdays (rather than every 30 minutes), and every ten minutes on weekends (rather than every 30 minutes). This increased frequency will also improve connections with other transport services and provide more choice.

Capacity has also been better aligned with customer demand, ensuring there are more services when our customers want to travel. On a typical weekend, capacity will be increased during the day to accommodate an additional 500 customers per hour in each direction compared to the current service. This means leaving fewer people behind on busier days throughout the year.

By increasing service frequency, reducing journey time and ensuring enough capacity for customers when we know they want to travel, the changes are going to improve the service provided on this important public transport route.

- *4268 FRESHWATER CLASS FERRIES ANNUAL BENEFIT—Ms Jo Haylen asked the Minister for Jobs, Investment, Tourism and Western Sydney—
 - (1) Has the Government modelled the annual benefit of the Freshwater-class ferries to the New South Wales economy?
 - (a) If so, what is the estimated benefit?
 - (2) Has the Government modelled the annual benefit of the Freshwater-class ferries to the local economy in Manly?
 - (a) If so, what is the estimated benefit?
 - (3) What is the view of Destination NSW in regards to the decision by Transport for NSW to retire the much-loved Freshwater-class ferries to Manly?

Answer—

This is a matter for the Minister for Transport.

- *4269 ONLINE DATING APP COMPANIES—Ms Jo Haylen asked the Minister for Police and Emergency Services—
 - (1) What powers do the NSW Police Force have to require online dating app companies to provide the personal contact information, previous conversations or other data and information in the event that a user makes a rape or sexual assault allegation involving another user?
 - (2) On how many occasions in each of the past five financial years has the NSW Police Force sought to obtain such information from the following companies under the circumstances listed above:
 - (a) Tinder?
 - (b) Bumble?
 - (c) Hinge?
 - (d) Grindr?
 - (e) OK Cupid?
 - (f) Match.com?
 - (g) Other?
 - (3) On how many occasions in each of the past five years has information been provided by the companies once sought from NSW Police Force?
 - (4) On how many occasions in each year was the information provided further used in the investigation of rape or sexual assault allegations?

Answer-

I am advised:

- (1) Australian law enforcement jurisdictions do not have the legal power to compel foreign-based online dating platforms to provide data.
- (2) to (4) The NSW Police Force has sought to arrange for online dating platforms to communicate directly with them using their external information request management system iASK, however online dating platforms have not agreed to this request. As such, centralised records are not available.
- *4270 PERSONAL MOBILITY DEVICES—Ms Jo Haylen asked the Minister for Transport and Roads—

Considering that the New South Wales Productivity Commission has recommended that the Government revise laws to encourage Personal Mobility Device innovation and use (2020 Productivity Commission Green paper, Draft Recommendation 4.14), will the Government now act to make the use of these devices legal, including e-scooters? If not, why not?

Answer-

I am advised:

Future Transport 2056 sets out the Government's long term vision for mobility and transport provision in New South Wales and aims to harness rapid change and innovation to support a modern, innovative transport network. This includes a commitment to enable devices such as Personal Mobility Devices to be used safely on the network to assist with short journeys within centres and to connect people to public transport and other transport modes.

Transport for NSW is currently working with the National Transport Commission and other jurisdictions to develop a regulatory framework for the safe use of these devices. While we proactively look to technology and industry partners to improve mobility and create seamless transport experiences, the safety of our customers is absolutely paramount.

Extensive community stakeholder and industry consultation specifically around e-scooters was conducted through the Electric Scooter Advisory working group and based on the recommendations of this group, Transport for NSW does not support an e-scooter trial at this stage. While it is acknowledged that shared electric scooters are operating in a number of other jurisdictions, there have been safety concerns raised. Currently, the Government does not deem it to be appropriate to run a trial without the proper infrastructure, technology or resources required to ensure compliance.

Formal consideration of any future trial would require all recommendations of the report were met, and considered within the context of our broader network.

In our response to COVID-19, we are working to encourage active transport with pop-up cycleways and lower speed limits being rolled out at a number of locations to provide safer environments for pedestrians and cyclists.

*4271 BUDGET IMPACTS ON WOMEN—Ms Jo Haylen asked the Treasurer—

- (1) Will the Government make efforts to outline the specific impacts on women of the upcoming State Budget?
- (2) Will the Government issue a Women's Budget Statement?
 - (a) If not, why not?

Answer-

Consistent with past years, Budget Paper No. 1 Budget Statement will outline key measures in the NSW Budget, including major new expense, revenue and capital expenditure measures.

The preparation and delivery of the financial and policy information in the Budget is driven by requirements set out in the Government Sector Finance Act 2018, which was passed by both houses of Parliament two years ago.

The 2020-21 NSW Budget includes measures to directly support women. Key initiatives include:

- \$10.0 million over two years to fund return to work grants of up to \$5,000 to cover costs associated with returning to the workforce. The program focuses on women from industries highly impacted by COVID-19, low income cohorts, and other groups who face additional challenges engaging with paid work post COVID-19.
- \$17.0 million over two years to pilot a package for in-home care for pregnant women suffering from hyperemesis gravidarum (severe morning sickness) to better understand and treat the condition.
- Ongoing funding for Women NSW to advance gender equity and improve economic opportunities for women and girls through women's policy, including delivery of the Investing in Women Grants Program.

In addition, the NSW Budget provides targeted employment and training support measures that will benefit women, including:

- \$57.4 million over four years to create a landmark Trades Skills Pathways Centre, with a focus on bringing women into this traditionally male-dominated workforce
- \$17 million over two years for skilling, mentoring and job matching in the care economy, with a focus on disability care
- Up to 20,000 additional aged care sector training places over the next 12 months.

The Budget also introduces a Gender-Neutral Parental Leave initiative into the NSW Public Sector. From July 2021, 14 weeks of parental leave entitlement for the primary carer will be extended to men as well as women, and the secondary carer's leave entitlement will increase from one week to two weeks. This aims to improve workforce participation and retention rates for women, incentivise use of parental leave and position the NSW Public Service as a leading family-friendly Employer of Choice.

*4272 DENTAL CARE WAITLIST—Ms Jo Haylen asked the Minister for Health and Medical Research—

- (1) How many people are currently on the waitlist for dental care in New South Wales?
- (2) How many people were awaiting dental care in New South Wales as of 1 March 2020?
- (3) How did the suspension of elective surgeries during the height of the COVID-19 pandemic impact the length of time people on the dental care waitlist have to wait for treatment?
- (4) How does the Government intend to manage any delays for those awaiting dental care?

Answer-

Public dental services are provided according to criteria that prioritises emergency situations, as well as patient groups in most need and at highest risk of disease.

Data is regularly updated and can be accessed from the NSW Health website.

The NSW Health Policy Directive 'Priority Oral Health Program and Waiting List Management' outlines recommended maximum waiting times for dental care based on oral health needs.

*4273 CATARACT SURGERY—Ms Jo Haylen asked the Minister for Health and Medical Research—

- (1) How many people are currently on the waitlist for cataract surgery in New South Wales?
- (2) How many people were awaiting cataract surgery in New South Wales as of 1 March 2020?
- (3) How did the suspension of elective surgeries during the height of the COVID-19 pandemic impact the length of time people on the waitlist for cataract surgery have to wait for treatment?
- (4) How does the Government intend to manage any delays for those awaiting cataract surgery?

Answer—

(1) and (2) The Bureau of Health Information provides public quarterly updates on waitlist numbers by category.

I am advised the median wait time for ophthalmology surgery reduced in the April to June 2020 quarter, when compared to the same time in 2019.

(3) and (4) New South Wales public hospitals have been working to restore normal elective surgery activity levels since 1 July 2020, with a focus on those patients who had their procedure delayed due to COVID-19 restrictions.

The Government has committed up to \$388 million in additional funding to boost elective surgery activity by further partnering with private hospitals to support the completion of elective surgeries that were postponed due to the pandemic.

*4274 CANCER SCREENING—Ms Jo Haylen asked the Minister for Health and Medical Research—

- (1) How is the Government responding to the sharp fall in cancer screening during the COVID-19 pandemic, as outlined in the Australian Institute of Health and Welfare's Cancer Screening and COVID-79 in Australia report?
- (2) How will the Government specifically seek to increase screening as the pandemic continues?
- (3) How will the Government seek to address the expected influx of cancer-related illnesses as a result of the fall in screening?
- (4) What funding will be allocated to address the issue?

Answer-

The Australian Institute of Health and Welfare (AIHW) data referenced in the question has shown that the impact of COVID-19 on routine screening was clearest for BreastScreen Australia. BreastScreen services in New South Wales were suspended for seven weeks between late March and early May.

Once services resumed, a number of actions were taken to promote screening. This included contacting patients to rebook, offering extended hours for screening in some locations, and mobile vans are being redeployed to areas with the greatest need to reduce the backlog. The Cancer Institute NSW also developed a social media advertising campaign, direct communications and clinic support material.

Since the resumption of services, records indicate more than 395,000 women have been invited to make a mammogram appointment and, as at the end of September 2020, more than 126,000 women have been screened.

I am advised the national cervical and bowel cancer screening programs were not suspended due to COVID-19, and the AIHW data appears to indicate that COVID-19 did not directly affect bowel cancer screening rates. The AIHW reported that the number of cervical screening tests was expected to be lower due to the program changing from a two-yearly pap test to a five-yearly Cervical Screening test.

*4275 MOBILE PHONE DETECTION CAMERA REVENUE—Ms Sonia Hornery asked the Minister for Transport and Roads—

Will the \$31 million in fines revenue received from drivers caught by mobile phone detection cameras between March and August 2020 in New South Wales go towards road safety education, specifically mobile phone use?

Answer—

I am advised:

Since its establishment in 2012, all speed camera, mobile phone detection camera and red light camera revenue is invested into the Community Road Safety Fund and used to fund priority road safety programs

in New South Wales, including: enhanced enforcement conducted by the NSW Police Force, road safety infrastructure upgrades, public education campaigns and road safety education programs.

The following actions were implemented to support the Mobile Phone Detection Camera Program (the Program) to educate the community and ensure awareness and improved compliance with the law, including:

- an extensive campaign on various media outlets including television, radio and social media, to raise community understanding about the Program, key messages about the road rules, that penalties apply for camera-detected offences and to thank drivers for driving safely.
- the installation of general network signage including 22 new fixed signs at key locations, such as at state borders and major airports, and the use of 304 variable message signs across the State to ensure drivers are aware of camera-based enforcement of illegal mobile phone use.
- dedicated web pages that provide information about the Program and related road rules.

*4276 RESTART NSW FUND—Ms Sonia Hornery asked the Treasurer—

Will the \$150 million in the Restart NSW Fund set aside for the Newcastle Inner City Bypass Stage 5 works be reallocated to projects in the Wallsend electorate now that the Federal Government has funded the construction of the road?

Answer-

The Commonwealth Government has not committed to fund the total cost of the Newcastle Inner City Bypass. I am advised that the balance of reserved Restart funds not already committed to fund project works (around \$136 million) remains available to fund the balance of the State's contribution to the Inner City Bypass Project.

*4277 POLICE SUPERANNUATION SCHEME NOTIFICATIONS—Ms Sonia Hornery asked the Treasurer—

- (1) Considering legislation that governs the Police Superannuation Scheme does not specify which persons can notify State Super following the death of a member, are changes to legislation being considered to restrict who can notify superannuation companies about the death of a member?
 - (a) If not, what plans are in place to ensure that errors or vexatious notifications that are made would not see the spouse of a member have their pension cut off?

Answer-

State Super has advised, to its knowledge, there has never been a vexatious notification from anyone to advise of the death of a pensioner in order to have their pension 'cut off'. Accordingly, no changes to current procedures are proposed.

*4278 ONLINE ABUSE REPORTING MECHANISMS—Ms Sonia Hornery asked the Attorney General, and Minister for the Prevention of Domestic Violence—

Considering the rise of online abuse and harassment during the COVID-19 lockdown, particularly towards girls and young women aged 15 to 25, what is being done to strengthen reporting mechanisms to ensure social media platforms are taking down comments and accounts once reported?

Answer—

I am advised:

The regulation of social media is a matter for the Commonwealth Government.

The Commonwealth eSafety Commission is the Commonwealth Government agency responsible for keeping Australian citizens safe online. Among other things, the eSafety Commissioner's functions include administering a civil penalties scheme to assist with the removal of intimate images or videos from online platforms and facilitating the taking down of serious cyberbullying material targeting an Australian child.

Some forms of online abuse may also constitute intimate image offences under New South Wales law. Under the Crimes Act 1900 (NSW), it is an offence to record or distribute an intimate image without consent. Where a person is convicted of such an offence, a court may order them to remove or delete the offending image.

*4279 SCAVENGER HUNTS—Ms Sonia Hornery asked the Minister for Skills and Tertiary Education representing the Minister for Education and Early Childhood Learning—

- (1) Considering the recent spate of risky and depraved challenges in end-of year scavenger hunts, what plans and procedures are in place to prevent this kind of behaviour from occurring in future by New South Wales government school students?
- (2) What disciplinary action do students face by participating in or planning these events?

Answer—

(1) The Government is committed to providing safe and supportive schools for all students and teachers. More than 800,000 students are enrolled in New South Wales public schools and the majority of them engage successfully in their schooling. There are times however, when the behaviour of a small number of students affects their own, or others', safety or wellbeing.

The Department of Education has policies and resources in place to support schools to prevent inappropriate and dangerous behaviour and to address issues effectively, where they do occur. School discipline processes can also be applied in response to an incident that has taken place outside of school hours and off school premises, provided there is a clear and close connection between the school and the conduct of students.

Consistent with the Education Act 1990 and Departmental policy, schools may develop additional components for their school discipline policy to meet local needs.

- (2) School principals have the authority to take action when the behaviour of a student is detrimental to themselves or others, or to the achievement of high quality teaching and learning. In New South Wales public schools, suspensions apply for physical violence, use or possession of a prohibited weapon, firearm or knife, or for any student possessing or using a suspected illegal substance.
- *4280 HUNTER AMBULANCE SERVICE REVIEW—Ms Sonia Hornery asked the Minister for Health and Medical Research—
 - (1) Considering the May 2020 announcement of a review into the Hunter Ambulance Service to address workplace grievances where four senior NSW Ambulance staff across the Hunter Region have resigned or been stood down in the last few months. when will the review into workplace grievances be completed?
 - (2) When will Senior Duty Operation Manager's positions be permanently filled?

Answer-

- (1) The review mentioned in the Newcastle Herald on 7 May 2020 referred to the process for addressing grievances in the sector. I am advised new processes have subsequently been implemented to facilitate the tracking of grievances raised by staff.
- (2) All management recruitment is centrally completed in statewide assessment centre campaigns. I am advised the next round of management recruitment will be completed in the new year.
- *4281 HUNTER REGION DRUG AND ALCOHOL REHABILITATION FACILITIES—Ms Sonia Hornery asked the Minister for Health and Medical Research—
 - (1) Are there any Government-run drug and alcohol inpatient rehabilitation facilities in the Hunter Region?
 - (a) If so, how many beds are available?
 - (b) If so, how many people are on the waiting list?

Answer—

A range of alcohol and other drug services are offered in the Hunter region, including services delivered by non-government organisations (NGOs) funded by NSW Health.

Further information can be found at the NSW Health, and Hunter New England Local Health District websites.

*4282 NEWCASTLE INNER CITY BYPASS STAGE 5—Ms Sonia Hornery asked the Minister for Transport and Roads—

What has caused the cost of the Newcastle Inner City Bypass Stage 5 to increase from \$280 million to \$450 million?

Answer-

I am advised:

Major features of the bypass have changed significantly since the 2014 estimated cost of the project was released.

These changes will improve traffic conditions and safety for all road users. They have been made based on community consultation and feedback, and following detailed investigations.

Changes to the design which have affected the cost estimate include:

- introduction of a bridge to allow free flow of the Jesmond cycleway
- upgrade to the John Hunter Hospital interchange to a full interchange with ramps in both directions
- upgrade of the northern interchange from a roundabout on Newcastle Road to an offset signalised interchange
- upgrade of the southern interchange to provide improved cyclist connectivity
- introduction of a shared path bridge over Newcastle Road
- new retaining walls at the southern interchange following geotechnical investigations
- increased ground treatment cost due to historical mining
- increased earthworks cost due to identification of coal and other poor materials during geotechnical investigations.
- increased construction duration due to the additional and upgraded infrastructure.
- *4283 INTENSIVE FAMILY PRESERVATION PROGRAM—Ms Sonia Hornery asked the Minister for Families, Communities and Disability Services—

Considering the importance of the Intensive Family Preservation Program to vulnerable families, what plans are in place to ensure that funding for this program continues past 31 December 2020?

Answer-

The Government recognises the critical role family support programs play in improving the safety and wellbeing of children, and in preventing abuse, neglect and entries to out-of-home care.

I am advised that the Department of Communities and Justice has offered extensions for all family preservation service contracts that were due to expire on 31 December 2020 for a further six months until 30 June 2021. Service providers have been notified of this decision.

It is expected that clarity about longer-term funding will be available once the NSW Budget is announced on 17 November 2020

- *4284 COURT EMPLOYEE CRIMINAL RECORD CHECKS—Mr Paul Lynch asked the Attorney General, and Minister for the Prevention of Domestic Violence—
 - (1) Are there arrangements in place to conduct criminal record checks of all employees who work within the Law Court Building in Queen's Square, specifically the employees of all maintenance contractors and sub-contractors?
 - (2) If so, are the results of such checks received before any such employees commence working in the building?

Answer-

I am advised:

All maintenance and sub-contractors engaged by Law Courts Limited complete a national police check, the results of which are received prior to the person commencing work in the Law Courts building.

*4285 RESPONSE TO CORRESPONDENCE—Mr Paul Lynch asked the Attorney General, and Minister for the Prevention of Domestic Violence—

What is your response to emails to you dated 13 September 2020 and 26 September 2020 from Abbas Raza Alvi, President of the Indian Crescent Society of Australia Incorporated?

Answer-

I am advised:

A response was provided to Mr Alvi on 13 October 2020 confirming that, under the Justices of the Peace Act 2002 (the Act), New South Wales Justices of the Peace (JPs) are not authorised to witness signatures on overseas documents or those documents required by an organisation or agency from overseas, or to perform other tasks under overseas laws.

New South Wales JPs have not had legal authority to witness foreign documents since the commencement of the Act. However, the law does not restrict JPs from certifying copies of overseas original documents, such as a birth certificate, if JPs are satisfied that the document is a true and accurate copy. This law has not changed and there is no current commitment to revise it.

*4286 NEW SOUTH WALES SHERIFF—Mr Paul Lynch asked the Attorney General, and Minister for the Prevention of Domestic Violence—

What is your response to comments about the New South Wales Sheriff in paragraphs 114-118 in the judgement of the Industrial Relations Commission in Browne v Industrial Relations Secretary on behalf of the Department of Communities and Justice [2020] NSWIRCOMM 1056?

Answer—

It is not appropriate for me to comment on this matter.

- *4287 RESPONSE TO CORRESPONDENCE—Mr Paul Lynch asked the Attorney General, and Minister for the Prevention of Domestic Violence—
 - (1) Do you propose to respond to the letter sent to you by email on 23 September 2020 by Simon Fell? (a) If so, when will you respond?

Answer-

I am advised:

The Department of Communities and Justice acknowledged Mr Fell's correspondence on 16 October 2020 and will provide a substantive response once all the relevant material has been reviewed and considered.

- *4288 CRIMES ACT CHARGES—Mr Paul Lynch asked the Attorney General, and Minister for the Prevention of Domestic Violence—
 - (1) Since the introduction of s93Z of the Crimes Act how many times has the Office of the DPP been requested by the police to proceed with charges under this section?
 - (2) Why were charges not proceeded with against Stipe Lozina under s93Z of the Crimes Act?

Answer-

I am advised:

- (1) Three.
- (2) The independent Office of the Director of Public Prosecutions (ODPP) determined that the criminality of the conduct was more appropriately covered by two charges of intimidation pursuant to section 13 of the Crimes (Domestic and Personal Violence) Act 2007. The offence of intimidation is punishable by a maximum penalty of five years imprisonment, greater than section 93Z's maximum penalty of three years imprisonment. These offences covered the same conduct.

The ODPP also considered that the fact the accused's conduct was religiously motivated could be dealt with as an aggravating factor on sentence pursuant to section 21A(2)(h) of the Crimes (Sentencing Procedure) Act 1999.

- *4290 LIVERPOOL HOSPITAL DEVELOPMENT—Mr Paul Lynch asked the Minister for Health and Medical Research—
 - (1) Do plans for the redevelopment of Liverpool Hospital involve creating 'activity based workplaces'?
 - (2) Does this mean the elimination of the majority of offices for medical, nursing and allied health staff and the implementation of an 'open plan office'?
 - (3) Has any thought been given to the need for senior medical staff to have quiet and private places in which to work?
 - (4) Has an assumption been made that a design that may work well in the Ministry of Health Head Office is inappropriate for medical, nursing and allied health staff in a busy quaternary hospital?
 - (5) Has any thought been given to the likelihood that staff may seek alternate employment at institutions with more appropriately designed workplaces?

Answer-

Activity Based Working (ABW) accommodates staff in a range of settings, both enclosed and unenclosed, tailored to the type of work the staff members undertake and the proportion of their working hours spent engaging in different tasks.

ABW provides a range of work settings that are purposefully designed for individual tasks, such as open spaces for group work and meetings, or quiet "do not disturb" areas for more focused work.

All designs for the Liverpool Health and Academic Precinct redevelopment are in line with NSW Health policies. Designs have been developed in consultation with Liverpool Hospital staff representatives of

All consumers currently admitted to the mental health service have complex mental health needs. Some people have been receiving longer-term care in designated non-acute or sub-acute mental health inpatient units and are only transferred to acute mental health units if their mental health deteriorates to the point they need a higher level of care.

The Pathways to Community Living Initiative is supporting these people to transfer to the community and they are at various stages of discharge. Some patients also have complex physical health needs that can be difficult to manage in the community. Liverpool Hospital is working to ensure mental health consumers are matched with suitable accommodation providers so that they have the best chance of a supported recovery in the community.

- *4293 AMALGAMATED LOCAL COUNCILS REVIEW—Ms Tania Mihailuk asked the Minister for Local Government—

Answer-

(1) The Department of Education monitors population and development trends so that it can plan to meet enrolment needs in government schools across New South Wales. The Department's long term projections are informed by census data and dwelling and population projections provided by the Department of Planning and Environment in conjunction with local councils. These projections align with the Government endorsed 2016 Common Planning Assumptions. The Department reviews the demographic need for school facilities on a continual basis.

Numerous strategies are used to manage enrolment demands in the short to medium term. This includes enforcing the Department's enrolment policy to restrict out-of-area enrolments and reviewing school intake areas to improve and rebalance utilisation across schools in a local area.

In cases of sustained and stable enrolment increases, the Department provides additional permanent facilities, or new schools as necessary.

Department of Education enrolment projections indicate there is sufficient student places in eastern suburbs secondary schools to accommodate projected demand.

(2) Planning is currently underway to upgrade Randwick Girls' High School and Randwick Boys' High School. The proposed works involve an upgrade to incorporate community accessible features.

A Project Control Group (PCG), including the Principals and the Director, Educational Leadership, has been established and has been meeting monthly since May 2020. In addition to the PCG and in line with

standard governance, a Project Reference Group including School Infrastructure NSW, school and community representatives has been meeting monthly since June 2020, to communicate project progress and progress the project's community consultation strategy.

- (3) In 2020 there are 31 surplus primary teaching spaces and 27 surplus secondary teaching spaces in the Coogee electorate.

The SSTS provision provides free public transport in some instances where student crowding or school locations, such as remote school locations not close to existing public transport networks, high numbers of students from rail stations, then dedicated school services may be employed.

The eastern suburbs of Sydney has a bus network of high-frequency regular services and these largely afford high level of access to a transfer point where regular or dedicated school services can be accessed if there is no direct service.

Transport for NSW acknowledges that the present arrangements require students to use, and in some cases, transfer between bus and bus/rail services. However, this requirement is not unique and generally applies where sufficient regular route services are available and existing route services connect with other bus or rail services.

Under the contractual arrangements between Transport for NSW and bus operators in metropolitan areas, operators may generally only introduce direct school bus services where no alternative public transport services are available.

- metropolitan (including Sydney CBD): 16 properties (8.74 per cent of the portfolio)
- regional: 167 properties (91.26 per cent of the portfolio)

- (3) All commercial properties, and any tenancies relating to them, are managed on behalf of PDNSW by Jones Lang LaSalle (JLL). JLL provide leasing, facilities and asset management services.
- (4) PDNSW has 24 third-party tenancies which vary from small entities (for example coffee carts, markets) to large corporates and organisations.

All tenancies are subject to formal occupancy agreements that detail the obligations of the tenant. PDNSW and JLL then apply the relevant legislation, regulation and policy when assessing issues that arise through the life of a tenancy agreement.

Issues that arise are addressed on an individual basis specific to the issue.

(a) COVID-19 rent relief was assessed for those entities that requested relief against the "Retail and Other Commercial Leases (COVID-19) Regulation 2020 (NSW) (Regulation)".

The application of rent relief considered areas disproportionately affected and has been applied in accordance with the requirements of the Regulation.

Subsequent to the placement and removal of the rock platforms, platypus have been observed swimming in the river adjacent to the construction site.

While the project includes the demolition of the old bridge, those piers located in the river will remain in place and continue to support those aquatic species, including the platypus population.

I am advised:

Fees for access to information are set by section 64 of the Government Information (Public Access) Act 2009 (GIPAA) and have remained consistent since that Act commenced in 2010. A statutory review of the Act in July 2017 found that there was no strong case to change the fees charged. There are currently no plans for a further review of GIPAA.

The Government is committed to ensuring citizens' right to access government information. GIPAA requires that open access information held by a public sector agency is proactively released to the public by that agency free of charge.

In addition, public sector agencies can discount processing charges where applicants can demonstrate financial hardship or where the information applied for is of special benefit to the public generally. The Government also operates a number of programs which facilitate citizens' access to particular government information at low or no charge, including the Department of Communities and Justice's Care Leaver Records Access unit.

In 2020, there have been 36 legal actions against drivers in New South Wales for failing to observe the minimum passing distance for cyclists. Since the rule came into effect on 1 March 2016, there have been a total of 164 legal actions against drivers in New South Wales. Three of these were within the Leichhardt Police Area Command (PAC), one of which was in 2020.

In 2020, there have been 4,359 legal actions against riders in New South Wales for failing to wear an approved bicycle helmet, 24 of which were in Leichhardt PAC.

All road users, whether motorists, truck drivers, cyclists or pedestrians have a responsibility to pay attention and follow the rules. Police enforce the road rules equally and conduct traffic operations for the safety of everyone.

Why is the construction industry excluded from the Government's Small and Medium Enterprise and Regional Procurement Policy?

Answer—

The Government is committed to supporting small and medium businesses with more opportunities to work with and provide services to government.

The Government spent more than \$40 billion on goods, services and construction in 2019-20, with around \$16.6 billion being spent with 51,000 small and medium businesses in New South Wales.

While Government agencies are responsible for conducting their own procurements - in line with the NSW Procurement Policy Framework to ensure suppliers are sourced with consideration for value for money, fair and open competition and more – the Government is making it easier to do business with government.

For example, recently all active registered Government suppliers have been migrated to the buy.nsw Supplier Hub, a digital service that makes it easier for businesses to register to sell to Government and manage their information.

For a business, the Supplier Hub is a dashboard providing them with access to all procurement related actions where a business update their information, edit their profile and view their opportunities in a single place.

For a government department, the Supplier Hub offers a complete list of all the suppliers who have registered to do business with Government. It is easy to navigate the website and shows a complete business profile.

In addition, the Government's Small and Medium Enterprise and Regional Procurement Policy is making it easier for small businesses to connect and contract with the Government via a number of initiatives. For example under the Policy, a small business exemption allows agencies to purchase goods or services valued up to \$50,000 directly from a small business, even where those goods or services are available on a whole-of-government arrangement.

Other initiatives exist to encourage businesses in the construction sector engage with Government – for example NSW Procurement Board Direction Access (PBD-2019-03). Access to government construction procurement opportunities by small and medium sized enterprises, which also contains a small business exemption which provides that agencies may purchase construction services valued up to \$50,000 (excluding GST) directly from a small business, even where those goods or services are available on a whole-of-government arrangement, provided the supplier's rates are reasonable and consistent with normal market rates.

The Maldon to Dombarton rail line is important to achieving the longer term objective of separating passenger and freight services on the Illawarra and South Coast rail lines to ensure improvements for people and the movement of goods.

Infrastructure Australia completed a review of the Maldon to Dombarton freight line in 2017 and found the project costs outweigh the economic benefits. As such, there is no plan to complete the construction of the freight line at this time.

Future Transport 2056 identifies completion of the line as a project for investigation in the 10 to 20 year horizon. This recognises the need to improve the efficiency and reliability of rail freight movements between the Illawarra and Greater Sydney, particularly between Port Kembla and the intermodal terminals in the west of Sydney when the port's container terminal is developed in the future.
