- *1849 TRANSPORT AND ROADS—PENINSULA PARK, WENTWORTH POINT—Mr D'Adam asked the Leader of the Government in the Legislative Council, Special Minister of State, Minister for the Public Service and Employee Relations, Aboriginal Affairs, and the Arts, Vice-President of the Executive Council representing the Minister for Transport and Roads—
 - (1) Given there has been no work on the Peninsula Park Wentworth Point since the 2019 election, when will further construction begin?
 - (2) What is the new completion date for Wentworth Point Peninsula Park?
 - (a) What date was the final design approved?
 - (b) When will a construction schedule be released to the public?
 - (3) Has Transport NSW committed funds to build this park?
 - (a) If so, what is the amount of funds committed?

Answer-

I am advised:

Transport for NSW is planning the next stage of redevelopment of Wentworth Point, including the Peninsula Park, boating facilities, and public domain improvements.

Transport for NSW will engage with City of Parramatta Council, the community and other stakeholders throughout the planning and delivery process as soon as it has more to say.

- *1850 POLICE AND EMERGENCY SERVICES—POLICE ESTIMATES OF CROWDS—Mr D'Adam asked the Minister for Finance and Small Business representing the Minister for Police and Emergency Services—
 - (1) What methods are used by NSW Police to estimate the number of attendees at public events and protests?
 - (2) Are the methods codified in any procedure or manual?
 - (a) If so, where is this published?
 - (3) Who in the NSW Police hierarchy is responsible for calculating and publicising the estimated number of people attending a public event or protest?

Answer-

I am advised:

- (1) The NSW Police Force uses geospatial mapping and crowd science principles to determine crowd capacities. This calculation takes into consideration the event location and its topography.
- (2) No.
- (3) The NSW Police Force will establish a Forward or Major Even Commander for each event where crowd assessments will be a part of their operational role.

- (1) Unified Security is an existing panel supplier contractor on the Whole of Government Security Contract 1400840 and was engaged from that panel to undertake some of the hotel quarantine private security arrangements.
- (2) Total expenditure and committed costs for Unified Security contract work from April 2020 to August 2020 amounts to c. \$11.37m.
- (3) Yes, as part of Whole of Government Security Contracts 1400840.
- (4) Selection of all Government Security Contractors are based on merit capacity, capability, performance and price.

Principals are not required to report centrally on individual discussions with the school community. They deal with any issues that are raised on a school by school, case by case basis, in accordance with the Controversial Issues in Schools Policy.

I am advised:

- (1) The Public Interest Advocacy Centre (PIAC) received the following funding from the NSW Government through the Community Legal Centres Program:
 - (a) \$184,812 in 2019-20.
 - (b) \$182,838 in 2018-19.
 - (c) \$148,330 in 2017-18.
 - (d) \$143,470 in 2016-17.
 - (e) \$138,687 in 2015-16.
- (2) Over the financial years 2015-16 to 2019-20, PIAC reported to Legal Aid NSW on the ongoing delivery of legal assistance services in NSW funded by the Community Legal Centres Program. Reporting for the program included outputs and outcomes for the following projects:
 - (a) The Homeless Persons' Legal Service (HPLS) providing free legal assistance to people who are homeless or at risk of homelessness at 15 outreach clinics in Sydney and Newcastle;
 - (b) Policing and Detention Project focusing on police powers and discretion; and
 - (c) Discrimination Project focusing on systemic discrimination against people with a disability and

sex discrimination.

All projects are ongoing and will provide legal assistance services in 2020-21.

(3) Under the Community Legal Centres Program, PIAC must focus its legal assistance services to people experiencing financial and social disadvantage in NSW.

The PIAC HPLS provides free legal advice and assistance to people who are homeless or at risk of homelessness. It also aims to address and reduce the causes of homelessness by tackling legal, individual and systemic barriers, such as those that prevent people who are homeless, or at risk of becoming homeless, from accessing and maintaining appropriate, stable housing.

The HPLS operates 15 outreach clinics in areas of Sydney, Western Sydney and Newcastle with disadvantaged communities including the Wayside Chapel and Matthew Talbot Hostel in inner Sydney, Parramatta Mission in western Sydney, and the Salvation Army Community Centre in Raymond Terrace.
