- *2202 WATER, PROPERTY AND HOUSING—TRAVELLING STOCK RESERVES—Mr Field asked the Minister for Mental Health, Regional Youth and Women representing the Minister for Water, Property and Housing—
 - (1) In regards to Crown Land identified as having the public purpose of Travelling Stock, what is the effect of the land co-existing with a Western Lands Lease?
 - (a) How does such a status change the usage rights for the non-leaseholder?
 - (b) Are there any restrictions for the Western Lands Leaseholder on this land?
 - (2) How many reserves with the public purpose of Travelling Stock have been revoked but continue to co-exist with Western Lands Leases in each of the calendar years of:
 - (a) 2020?
 - (b) 2019?
 - (c) 2018?
 - (3) Can the Minister provide an approximation of how many hectares the answer to the above question equates to for each of the calendar years of:
 - (a) 2020?
 - (b) 2019?
 - (c) 2018?

Answer-

I am advised:

(1) Western Lands leases are Crown leases managed under the Crown Land Management Act 2016 and Travelling Stock Reserves often co-exist or overlay these leases and form part of the lawful leasehold estate

Most of the 1.5 million hectares of Travelling Stock Reserves that co-exist with Western Lands leases are managed and occupied by leaseholders and remain available for the exclusive use of the leaseholder, but are subject to rights of use by bona fide travelling stock.

Local Land Services is responsible for issuing 'permits' to move stock.

- (a) Where a Travelling Stock Reserve co-exists with a Western Lands lease it does not change the usage rights for 'non-leaseholders' because clause 62 of the Local Land Services Regulation 2014 prohibits 'non-leaseholders' from using the reserve.
 - An exception to this is where a permit is obtained from Local Land Services for the movement of stock. The leaseholder retains exclusive possession of the lease and the right to exclude all parties, other than those with a permit to move stock.
- (b) The only restriction for a Western Lands leaseholder whose lease co-exists with a Travelling Stock Reserve is that the land must be made being available, if required, for the use of bona fide travelling stock, if a permit has been issued by Local Land Services.
- (2) When a Travelling Stock Reserve is revoked, it ceases to co-exist with a Western Lands lease. Therefore no Travelling Stock Reserves were revoked that then continued to co-exist with a Western Lands Lease.

Answer-

I am advised that:

1-3. Estimates of feral goat numbers in New South Wales are based on aerial surveys undertaken by the Department of Planning, Industry and Environment in conjunction with the commercial Kangaroo Management Program, which is generally west of the Great Dividing Range. This region correlates with the greatest concentration of feral goats in New South Wales.
