The CWLA were advised that in accordance with the NSW Government's Land and Property Strategic Framework, the site will be first offered to other NSW Government agencies for theiruse. If there is no interest from other NSW Government agencies, TAFE NSW willplace the property onto the open market.

DCS will continue to consult directly with these organisations throughout the review.
