Small amounts of bonded asbestos were recently indentified by an M4-M5 Link Tunnels contractor at the St Peters Interchange site, a former landfill site.

The M4-M5 Link Tunnels contractor is meeting all SafeWork NSW requirements at this site, to ensure the safety of its workers and the community.
