- * 5596 VOLUNTEER MANAGEMENT ACTIVITY—Ms Jo Haylen to ask the Minister for Families, Communities and Disability Services—
 - (1) Has the Minister spoken to the Commonwealth Minister for Families and Social Services regarding the Federal Review of Volunteer Management Activity (VMA) and the potential impacts on small, local volunteer organisations and neighbourhood centres in New South Wales?
 - (2) What action will be taken to ensure small, local volunteer organisations and neighbourhood centres in New South Wales do not close as a result of changes to Commonwealth funding for VMA?
 - (3) Have these changes been considered as part of the development of the NSW Volunteering Strategy 2020-2030?
 - (4) How will these changes, if implemented, impact the delivery of the Volunteering Strategy 2020-2030?

Answer-

I am advised:

- (1) The Department of Communities and Justice spoke with the Commonwealth Department of Social Services regarding their review of Volunteer Management Activity and the potential impacts on small, local volunteer organisations and neighbourhood centres in New South Wales.
- (2) New South Wales has been advised that the Department of Social Services is working with Volunteer Resource Centres and state peaks during a consultation and design period for the Volunteer Management Activity Program. The Department of Communities and Justice continues to support local neighbourhood centres through recent five year funding contracts in the Targeted Earlier Intervention program.
- (3) The Department of Social Services changes to the volunteer management activity were announced after the NSW Volunteering Strategy 2020-2030 was developed. However, the NSW Volunteering Strategy continues to value, grow and invest in volunteering across New South Wales and support the volunteering sector to be resilient, responsive and innovative.
- (4) The Department of Communities and Justice will continue to work closely with Department of Social Services and the New South Wales Centre for Volunteering on the impact of the changes and the ongoing support of the volunteering sector.
- * 5597 COVID-19 IMMUNISATIONS IN PRISONS—Ms Jo Haylen to ask the Minister for Health and Medical Research—
 - (1) How many COVID-19 vaccinations have been administered to incarcerated people in corrections facilities in New South Wales (as at 4 May 2021)?
 - (2) How many second-dose COVID-19 vaccinations have been administered to incarcerated people in corrections facilities in New South Wales (as at 4 May 2021)?

Answer-

(1) - (2)

I am advised that from 10 March 2021, the AstraZeneca vaccine has been made available to eligible correctional staff and residents under the COVID-19 vaccine national roll-out strategy in New South Wales. Planning is underway to facilitate access to the Pfizer (COMIRNATYTM) vaccine for correctional residents under 50 years old, following updated advice from the Australian Technical Advisory Group on Immunisation.

COVID-19 statistics for New South Wales are released daily at 11am, including the number of COVID-19 vaccine doses administered in the 24 hours up to 8pm the previous day. Vaccination numbers and further information are available on the NSW Health website.

- * 5598 BUILDINGS THAT DO NOT REFLECT APPROVED RENDERING—Ms Jo Haylen to ask the Minister for Planning and Public Spaces—
 - (1) What powers does the Department of Planning, Industry and Environment have to force developers to rectify buildings where a completed building does not reflect the rendering as approved through the planning process?
 - (2) Are there any regulations or laws regarding the accuracy of architectural renderings submitted through the planning process?
 - (a) What obligations exist for developers and architects when it comes to renderings in the planning process?
 - (3) What recourse exists for local communities when a building does not match the designs offered in the planning process, due to poor materiality, cut corners in construction, or amendments obscured through the use of private certifiers?

Answer-

- (1) A building must be constructed in accordance with the development consent, including the approved plans and specifications listed in that consent. If the planning approval has not been complied with, the consent authority may give a development control order to the owner of the premises to comply with the planning approval.
- (2) Schedule 1 of the Environmental Planning and Assessment Regulation 2000 sets out the documents that must be submitted with a development application, such as site plans and elevations or sections that show the proposed external finishes and heights of any proposed buildings.
 - For residential apartment buildings subject to the provisions of State Environmental Planning Policy No. 65 Design Quality of Residential Development, drawings of the proposed development within the context of the surrounding streetscape, photomontages and, where appropriate, models of the proposed building are also required.
 - Architectural renders or perspective illustrations of proposed buildings are provided mainly to assist in visualising the proposed development and generally do not form part of the development consent.
- (3) An occupation certificate authorising the occupation or use of a new building must not be issued by the principal certifier appointed to a project unless the design and construction of the building is consistent with the development consent.

- * 5600 30KM PER HOUR SPEED ZONES—Ms Jo Haylen to ask the Minister for Transport and Roads—
 - (1) At which locations in New South Wales are the Government and local councils trialling 30km/hr speed zones?
 - (2) Are the trials being managed by Transport for NSW or local councils?
 - (3) How is the trial being evaluated?
 - (a) How is Transport for NSW monitoring the trials?
 - (4) What support, financial or otherwise, has Transport for NSW offered to councils seeking to establish 30km/hr speed zone trials?

- (5) What plans does Transport for NSW have to extend the trials to other areas?
- (6) What is the total number of locations in New South Wales zoned with a speed limit of 40km/hour?

Answer-

I am advised:

(1) - (3)

Transport for NSW (TfNSW) has installed 30 km/h speed zones and speed limits in Manly, Penrith, Parramatta, the City of Sydney, and several other Local Government Areas (LGAs). TfNSW is monitoring these locations to ensure a safe and reliable road network is provided for all road users. The 30 km/hr speed zones and speed limits are not trials.

- (4) TfNSW provides funding for the installation and review of speed limits on New South Wales roads.
- (5) Speed zone reviews are done through the speed management program within TfNSW. The Draft Speed Zoning Guidelines provide further information about signposting and suitable locations for 30 km/h zones. TfNSW works regularly with local councils in response to safety concerns, police input and community advocacy to review and adjust speed zones.
- (6) As at 10 May 2021, there are 372 suburbs, in 96 LGAs, with 40 km/h speed zones in New South Wales.
- * 5601 PAID ZONE STICKERS—Ms Jo Haylen to ask the Minister for Transport and Roads—
 - (1) When was the decision made to install "paid zone" stickers at train stations cross New South Wales, including Lewisham and Summer Hill?
 - (a) Why was the decision made to do so?
 - (2) What directive was made to station staff and transport officers in regards to fining pedestrians, cyclists or residents accessing pedestrian thoroughfares such as those in Lewisham and Summer Hill?
 - (3) How many transport fines have been issued to pedestrians, cyclists or residents using the pedestrian tunnels at Lewisham and Summer Hill since the installation of these "paid zone" stickers (as at 4 May 2021)?
 - (4) Given the potential of these stickers to cause confusion for pedestrians, cyclists and residents seeking to use public thoroughfares at stations, will the Minister consider removing them?

Answer-

- (1) In December 2019.
 - (a) The purpose of the "paid zone" is to remind customers to tap on before using public transport in the absence of a physical barrier.
- (2) There has been no directive given. Transport Officers aim to educate customers across the network and encourage customers to tap on and off when using public transport.
- (3) One fine was issued in the concourse area of Summer Hill Station to a customer who intended to travel without a valid ticket.
- (4) The zones do not target residents, pedestrians and cyclists using the stations as a thoroughfare. Additional messaging will be added at Summer Hill and Lewisham stations to reinforce this.

- * 5602 55 LIVINGSTONE ROAD MARRICKVILLE—Ms Jo Haylen to ask the Minister for Water, Property and Housing—
 - (1) What is the value of the maintenance and repairs backlog at 55 Livingstone Road, Marrickville?
 - (2) What was the estimated cost of damages to 55 Livingstone Road, Marrickville, caused by the recent rain and floods?
 - (3) How many residents at 55 Livingstone Road, Marrickville, are still awaiting repairs as a result of the rain and floods of March 2021?
 - (4) In each of the past five financial years, what has been the annual amount of money expended on repairs and maintenance at 55 Livingstone Road, Marrickville?

Answer-

- * 5603 EFFECT OF MARCH FLOODS ON SOCIAL HOUSING—Ms Jo Haylen to ask the Minister for Water, Property and Housing—
 - (1) What is the total cost of the damage to social housing properties owned and managed by the Government across New South Wales from rain and flooding in the March storms?
 - (2) What is the total cost of the damage to social housing properties owned and managed by the Government in the Summer Hill electorate from rain and flooding in the March storms?
 - (3) As of 15 March 2021, what was the current maintenance backlog in social housing properties in New South Wales?
 - (4) What is the current maintenance backlog in social housing properties in New South Wales as of 27 March 2021?
 - (5) How many social housing properties are still awaiting repairs due to the rain and flooding?
 - (6) How many social housing dwellings across New South Wales were rendered uninhabitable by the rain and floods?
 - (7) How many residents in social housing were relocated because their dwellings were rendered uninhabitable by the rain and floods?

Answer-

- (1) The weather event resulted in an estimated cost of \$1.5 million.
- (2) The data requested is not available at electorate level.
- (3) Land and Housing Corporation (LAHC) directly bases its maintenance expenditure on priority and need. LAHC maintains public housing properties through responsive maintenance repairs and planned maintenance programs. Responsive maintenance, including work arranged in response to calls from tenants to the contractor managed maintenance line, is delivered within timeframes detailed in the Asset Maintenance Services Contract, and prioritised through the criticality repairs matrix considering safety and risk.
- (4) As advised in response to question 3.
- (5) Any immediate safety and make safe works were completed following the extreme weather event.

* 5604 INTALLATION OF FISHWAYS AND FISH LADDERS—Mr Philip Donato to ask the Minister for Agriculture and Western New South Wales—

Considering LA Q5581, in which you responded "Audits of fish passage barriers in the Lachlan catchment occurred in the late 2000s", when will fishways or fish ladders be installed at fish passage obstructions, which include weirs at Condobolin, Kiacatoo, Booberoi, Jemalong and Forbes?

Answer—

Timelines for fishway construction at Condobolin, Kiacatoo, Booberoi, Jemalong, or Cottons Weir are yet to be finalised.

* 5605 ESCALATING SUICIDE RATES—Mr Philip Donato to ask the Minister for Health and Medical Research representing the Minister for Mental Health, Regional Youth and Women—

Regarding statistics published on NSW Health's NSW Suicide Monitoring System which show that suicide deaths outside of Greater Sydney in the month of January have almost doubled, from 30 in January 2019, 40 in January 2020 and 56 in January 2021, what steps have been taken to address this rapidly escalating suicide rate?

Answer-

Comparing suicides between individual months to support an argument that suicides are 'rapidly escalating' is highly misleading and extremely dangerous.

The NSW Suicide Monitoring shows that the total number of suicide deaths in regional New South Wales reduced by 45, or 10 per cent, in 2020 compared to 2019. In 2021, suspected or confirmed suicide deaths in regional New South Wales reduced from 56 in January to 29 in February, and declined further again in March to 28. There will always be variability when comparing individual months; comparisons could readily show a decrease as it can an increase.

The Member should exercise caution in cherry picking data.

- * 5606 TOWARDS ZERO SUICIDES INITIATIVES—Mr Philip Donato to ask the Minister for Health and Medical Research representing the Minister for Mental Health, Regional Youth and Women—
 - (1) Regarding the Government's October 2018 announcement of a \$87 million funding commitment over three years for the Towards Zero Suicides initiatives, which three years within the 2018-23 Strategic Framework for Suicide Prevention has the \$87 million in funding been or will be allocated?
 - (2) What is the proportion of funding for each of the three years?
 - (3) What suicide prevention initiatives have been funded?
 - (a) How much funding has been allocated to each of those initiatives?

Funding has been allocated across the 2019-20 to 2021-2022 financial years:

- 2019-20: \$19.7 million
- 2020-21: \$33.7 million
- 2021-22: \$33.7 million

In the Westmead 2036 Draft Place Strategy what provision is made for the expansion of psychiatric health services in the Westmead Health Precinct?

Answer—

Given the timeframes outlined in the Westmead 2036 Draft Place Strategy and the very nature of health care innovation, it is too early to be definitive as to the exact mix of health services to be provided as part of the strategy.

* 5608 PARRAMATTA FEMALE FACTORY AND INSTITUTIONS PRECINCT—Ms Julia Finn to ask the Premier representing the Special Minister of State, and Minister for the Public Service and Employee Relations, Aboriginal Affairs, and the Arts—

What is the status of the application for World Heritage Listing of the Parramatta Female Factory and Institutions Precinct?

Answer-

A feasibility study has been completed to assess the potential of the Parramatta Female Factory being included in the World Heritage List. I am currently reviewing the report's findings.

- (4) As at 5 May 2021, for Cumberland LGA, 50,638 dine vouchers have been redeemed.

In addition, under the National Energy Retail Rules (the Rules), a customer's bill meter must be read at least once every 12 months to reconcile retail bills based on estimated meter readings. The Rules also allow customers to submit a self-reading of the meter to correct an estimated reading and the retailer will amend the bill based on the customer's meter reading.
 - (a) In the 12 months between May 2020 and April 2021, Jemena undertook 1,625,547 remote meter readings.

The count includes people observed to be sleeping in cars, tents or makeshift structures as well as those sleeping in open spaces such as on the streets or in parks. Assertive outreach services to people sleeping rough have been operating in inner-city Sydney since 2017, in partnership with local health and homelessness services. In 2019 assertive outreach was expanded to Newcastle and Tweed Heads and then rapidly expanded in 2020 to cover almost 60 local government areas (LGAs) across New South Wales.

Between February 2020 and February 2021, assertive outreach services supported 140 people who were sleeping rough in the Newcastle LGA to secure stable long-term housing, 25 of whom were women.

Over the same time period, assertive outreach services supported 25 people who were sleeping rough in the Lake Macquarie LGA to secure stable long-term housing. Seven were women.

The NSW Homelessness Strategy 2018-2023 recognises the wide range of circumstances that can contribute to a person experiencing homelessness and the different forms that homelessness can take. The strategy is available at: https://www.facs.nsw.gov.au/about/reforms/homelessness.

The 2020-21 NSW Budget includes \$1 billion in continued funding towards a range of homelessness and social and affordable housing programs.

This includes funding for Specialist Homelessness Services (SHS) that provide targeted responses for women, with or without children, who are homeless or at risk of homelessness, including funding for 86 women's refuges across the state.

The 2019-20 Budget includes an investment of \$1 billion to continue the Government's commitment to tackling housing and homelessness.

This includes funding for six Specialist Homelessness Services in Newcastle and Lake Macquarie providing support, referral and information, and after hours responses for people at risk of homelessness.

Reducing homelessness is one of the Premier's 14 Premier's Priorities. The Government has set a target to reduce street homelessness by 50 per cent across New South Wales by 2025. More information is available at: www.dcj.nsw.gov.au/streethomelessness

The 2021 New South Wales street count was completed between 2 February and 1 March 2021. In the Newcastle Local Government Area (LGA), the number of people counted fell from 52 in 2020 to 19 in 2021, a 63 per cent reduction. In the Lake Macquarie LGA, the number of people counted fell from 33 in 2020 to 18 in 2021, a 45 per cent reduction.

Since March 2017, the Government worked in partnership with the non-government sector to conduct Assertive Outreach street patrols in inner Sydney. Assertive Outreach is an evidence-based practice to combat street homelessness. These teams have supported many people experiencing street homelessness find pathways to long-term housing.

In 2019, the Department of Community and Justice and its partners expanded these services to Tweed and Newcastle. This was followed by further expansion to 58 LGAs in April 2020, including Lake Macquarie.

Small businesses in the Liverpool local government area have benefited, and continue to benefit from, a range of COVID-19 support measures, including:

- \$10.5 million in \$10,000 Small Business Support Grants to 1058 small businesses
- \$1.8 million in \$3,000 Small Business Restart Grants to 601 small businesses
- \$1.9 million consumer spend with 123 small business registered to accept Dine & Discover vouchers (as at 31 May 2021)
- 885 small businesses successfully registered for the \$1500 small business fees and charges rebate (as at 31 May 2021).

* 5662 STRATEGIES TO REDUCE ROAD FATALITIES IN FAIRFIELD EAST—Mr Guy Zangari to ask the Minister for Transport and Roads—

In light of recent road fatalities and car accidents in Fairfield East, what strategies, other than mobile and fixed speed cameras, will the Government implement to address road safety in this area?

Answer-

I am advised:

Reducing road trauma is a key priority for the Government. Towards Zero represents the Government's commitment to reducing road trauma and achieving the ultimate goal of zero deaths and serious injuries on New South Wales roads.

Children's road safety is paramount and a key focus of Towards Zero. The Government has implemented a safe system within New South Wales school zones where a maximum 40km/h speed limit applies and high-visibility safety treatments like signage, road markings and flashing lights are in place. Higher fines and demerit points also apply within school zones.

Every school in New South Wales has at least one set of school zone flashing lights including schools in the Fairfield electorate. There are now more than 6,500 school zone flashing lights in place to warn motorists when they enter a school zone. Transport for NSW (TfNSW) maintains those flashing lights to

a high standard, and also installs new flashing lights wherever a new school is opened at a location without an existing set.

Further, the School Crossing Supervisor Program currently funds more than 1,300 supervisors at more than 900 crossings across New South Wales. Within the Fairfield Electorate, 11 schools have a School Crossing Supervisor at 13 crossing locations. TfNSW employs 17 School Crossing Supervisors within the Fairfield Electorate. This includes permanent part time and casual employees.

The New South Wales Safer Roads Program prioritises funding to provide essential infrastructure to make roads in New South Wales safer. TfNSW directly delivers or coordinates local councils to deliver projects under the Program.

The Government has implemented a range of measures to address agricultural labour shortages.

The Government is providing a 50 per cent subsidy to the cost of mandatory quarantine costs for overseas agricultural workers, reducing the cost to industry from \$3,000 per person to \$1,500 per person.

The Government has also launched the 'Help Harvest NSW' website to connect agricultural employers with out of work Australians.

- * 5665 KOSZIUSZKO NATIONAL PARK'S PLAN OF MANAGEMENT—Mrs Helen Dalton to ask the Minister for Energy and Environment—
 - (1) Given that Kosciuszko National Park's Plan of Management (PoM) prohibits new overhead transmission lines, why is the Government proposing an amendment to the PoM to exempt Snowy 2.0 from the requirement to install all new transmission lines underground?
 - (a) Has the Government already agreed to overhead transmission lines, despite the Environment Impact Statement for overhead lines having only recently been exhibited?

Answer—

The proposed Snowy 2.0 Kosciuszko National Park Plan of Management amendment does not pre-empt the Environmental Planning and Assessment Act 1979 approval process for the proposed new transmission

lines. However, it will allow the activity to be granted tenure if the project is approved by the Minister for Planning and Public Spaces.

Legislative changes under the Snowy Hydro Corporatisation Act 1997 already enable the Snowy 2.0 project to be undertaken for a period of three years from initial construction, despite any provisions of the Kosciuszko National Park Plan of Management - this plan of management amendment will allow for this to continue.

- (1) The Port Botany and Port Kembla Port Commitment Deeds were not amended as a consequence of the announcement of the long-term lease of the Port of Newcastle in November 2013.
- (2) The Port Commitment Deeds are commercial in confidence and the State cannot disclose the specific terms of these arrangements that have been commercially negotiated and entered into with private parties.

- * 5676 LAND AND HOUSING CORPORATION PLAYGROUNDS—Mr Tim Crakanthorp to ask the Minister for Water, Property and Housing—

- (1) The Australian Building Codes Board is responsible for the ongoing development and reform of the National Construction Code (Code). The Office of the Board continues to monitor the available information relating to potential impacts of mechanical ventilation systems on the transmission of COVID-19.
- (2) The Code contains minimum necessary requirements relating to the provision of ventilation in new buildings and new building work. Compliance with the Code can be achieved through natural ventilation such as window and door openings or by way of mechanical ventilation.
 - For mechanical ventilation, the Deemed-to-Satisfy provisions of the Code require systems to be designed in accordance with Australian Standard 1668.2 2012 The use of ventilation and air conditioning in buildings Mechanical ventilation in buildings. This standard sets out the design requirements for mechanical air handling systems, and requirements for ventilation based on the need to control odours, particulates and specific gases.
- (3) The Government is continuing to monitor available information relating to the transmission of COVID-19 including the impacts of mechanical ventilation. Where appropriate and supported by evidence, the Government in conjunction with other relevant bodies, will consider any necessary actions to reduce the risk of transmission.
- * 5678 ELECTRIC VEHICLES PLAN—Mr Alex Greenwich to ask the Minister for Energy and Environment—

What changes will the Government make to the electric vehicles plan as a result of the Ernst & Young evaluation in the September 2020 report "Uncovering the hidden costs and benefits from Electric Vehicles"?

'My Aged Care' was established by the Commonwealth Government as the primary source of information for older people and their carers regarding the types of aged care services available. The Older People's Advocacy Network is federally funded to deliver the National Aged Care Advocacy Program. For further information see: https://www.myagedcare.gov.au/

NSW Health is funded by the Commonwealth Government to deliver aged care assessments, which determine eligibility for aged care services. As part of this assessment role, the Government provides information and support to older people and their carers regarding the aged care services they need.

* 5680 ABORIGINAL FLAG—Mr Alex Greenwich to ask the Premier—

- (1) What consideration has the Government given to flying the Aboriginal flag permanently on the Sydney Harbour Bridge?

Transport for NSW has sought funding under the State Voluntary Planning Agreements program to undertake a Transport Masterplan for Raymond Terrace Road, between Metford Road and McFarlanes Road, as well as Thornton Road and Metford Road.

The masterplan aims to support developments in the Chisholm and Thornton areas by investigating existing and future traffic capacity and constraints, and providing multimodal transport opportunities. Work on this masterplan is expected to begin early in the 2021-22 financial year pending funding approval.

Answer-

I am advised:

- (1) The NSW Police Force continuously monitors crime trends, workload distribution and resource allocation for all parts of New South Wales, including Beresfield. The NSW Police Force has not currently identified an operational requirement for a 24-hour police station in Beresfield.
- (2) The Bureau of Crime Statistics and Research (BOCSAR) is responsible for maintaining statistical databases on crime and criminal justice in this State. Questions relating to crime statistics are best directed to the Attorney General as the Minister responsible for BOCSAR.
- (3) NSW Police Force staffing numbers allocated to individual Local Area Commands 2009 cannot be compared to Police Districts in 2021 for various reasons. These include the centralisation of a number of positions into Police Commands between 2012 and 2014, which resulted in staff relocation and the transfer of officers. In addition, during 2017 and 2018, there was a significant reengineering of the NSW Police Force, which involved the amalgamations of some Local Area Commands and the establishment of Police Area Commands and Police Districts.

As of 4 May 2021, the authorised number of police positions at the Port Stephens-Hunter Police District was 214. As at 30 June 2019, there were 205 and 210 at 30 June 2020. Port Stephens-Hunter Police District has responsibility for Maitland Police Station.

All police positions attached to Police Districts and Police Area Commands are flexible resources available to respond to incidents across Command and District boundaries. Local resources are supplemented by specialist police who are managed centrally but can be deployed to meet the changing community needs and respond to crime patterns and emerging issues.

As part of the Government's 2018 commitment to an additional 1,500 police officers, the Port Stephens-Hunter Police District was allocated five new positions in 2019-20, and six new positions in 2020-21.

- (4) As with staffing numbers, vehicle allocation data from 2009 cannot be compared with the current year. Since the 2019 financial year, 11 police vehicles have been allocated to the Maitland Police Station.

Answer-

- (1) The Government applies the National Environment Protection (Ambient Air Quality) Measure (AAQ NEPM) which provides national standards and a framework for the monitoring and reporting of six common air pollutants: carbon monoxide, ozone, nitrogen dioxide and sulfur dioxide, lead and particles as PM10 and PM2.5.
 - (a) The AAQ NEPM was amended in 2016 for PM10 and PM2.5 standards. In April 2021, Environment Ministers agreed to vary the standards for ozone, sulfur dioxide and nitrogen dioxide.
 - (b) Yes.
- (2) Motor vehicles are one of the main human-made sources of PM2.5 and nitrogen oxides in Sydney, as outlined in the Draft Clean Air Strategy 2021-2030.
- (3) In the last decade air quality in Sydney East has remained stable.
- (4) I am advised future trends in air quality are difficult to predict due to variations in natural and human-made pollution sources, and the complex dispersion and atmospheric transformation of local and regional emissions.
- (5) The Government released the Draft Clean Air Strategy 2021-2030 for public consultation from 18 March to 23 April 2021. It includes actions to achieve better preparedness for pollution events, cleaner industry, cleaner transport, engines and fuels, healthier households and better places. A final Clean Air Strategy will be released this year.

- (6) As stated above one of the key priority areas in the draft Clean Air Strategy is cleaner transport, engines and fuels. Government actions to further reduce air pollution from motor vehicles include supporting uptake of electric vehicles, supporting sustainable, healthy and smart travel choices and improving regulation of vehicle and fuel emissions.
