- \* 6606 EDUCATION AND EARLY CHILDHOOD LEARNING—SAFE SCHOOLS PROGRAM—The Hon. Mark Latham to ask the Minister for Education and Early Childhood Learning—
  - (1) Given that the Safe Schools program is banned in New South Wales schools, what action has been taken against the Student Support Officer at the Denison College of Secondary Education (which covers Bathurst and Kelso High Schools) who last month distributed dozens of gender fluidity guides (including Safe Schools) to 150 teachers?

Answer—

The resource shared by the officer at Denison College of Secondary Education – Bathurst was a Victorian Government resource which is not approved or endorsed by the NSW Government. It was not used as part of the teaching and learning program in any classroom, and was sent to staff without the principal's permission.

The matter was reviewed by the Department's Professional Ethical Standards directorate, and the officer has been counselled.

Although the resource in question was not a Safe Schools resource, I will note that the Safe Schools program is not, and has never been, part of the NSW Curriculum and the Department of Education does not promote this program or its resources.

- 6607 WATER, PROPERTY AND HOUSING—WATER NSW TENDER FOR A PUMPED HYDRO INSTALLATION AT GLENNIES CREEK DAM—The Hon. Mark Latham to ask the Minister for Mental Health, Regional Youth and Women representing the Minister for Water, Property and Housing—
  - (1) Did Goldwind win the Water NSW tender for a pumped hydro installation at Glennies Creek Dam in the Hunter Valley after three leading Australian tenders were disqualified?

    - (b) Can the Minister confirm whether the disqualifications related to conduct of an unlawful or illegal nature?

No tender has been awarded for a pumped hydro station for Glennies Creek Dam.

Under the Request for Proposal (RFP) process, seven proponents were invited to submit formal proposals for 12 competing schemes. Throughout the RFP stage, a Probity Advisor provided oversight to ensure fair process and selection was undertaken in accordance with defined RFP criteria. At no stage did Water NSW disqualify any proponent.

Further oversight will take place through the obligations of the proponent to meet all regulatory and statutory compliance, in accordance with planning development approval processes, and the Commonwealth's Foreign Investment Review Board (where it is applicable).

Answer-

(1-2) The Make Ready Service was delivered as part of the \$184 million Sydney Ambulance Metropolitan Infrastructure Strategy (SAMIS) program. The service operates at ten metropolitan superstations at Bankstown, Liverpool, Penrith, Blacktown, Northmead, Artarmon, Randwick, Haberfield, Kogarah and Caringbah, where costings and efficiencies are based on the large number of ambulance vehicles operating with a high volume of responses each day. The Make Ready Service does not operate in regional areas.

There are no plans to introduce the Make Ready Service at Hamilton. This is due to operational factors, including the number of vehicles operating at the station and the infrastructure required.

- (3) The NSW Land and Housing Corporation (LAHC) takes between 16-18 working days to complete works on a standard vacant restoration, subject to any local planning regulations or consent approvals.
- (4) Vacant restorations are a high priority for LAHC. LAHC works closely with its maintenance contractors and the Department of Communities and Justice to ensure re-letting of the vacated property in the shortest time possible. The NSW Government, like a private landlord, has a responsibility to ensure that a vacant property is clean, safe and habitable before it is re-let.

Answer-

(1) It is not possible to determine the number of current recreational fishing fee holders at a given point in time as there are numerous fee periods that fishers can pay (3 day, 1 month, 1 year, 3 years). At

any given date there are fee periods expiring. A best representation of fee holders is to present the data over a period of time. Additionally, available electronic reports only contain fisher address postcode (not electorates). Fee holder information for 2019/2020 filtered by way of address postcode is provided below. However, it is noted that some postcodes overlap electorates. For example postcode 2259 overlaps Wyong, The Entrance and Swansea electorates. This means a proportion of the number of fishers is duplicated or triplicated across the electorates.
