* 6693 ENERGY AND ENVIRONMENT—OFFSHORE WIND FARMS—The Hon. Mark Latham to ask the Special Minister of State, and Minister for the Public Service and Employee Relations, Aboriginal Affairs, and the Arts representing the Minister for Energy and Environment—

Answer—

- (1)
 - (a) On 22 December 2020, the City of Newcastle wrote to me asking that the Government consider the inclusion of offshore wind as an opportunity in the ‘Hunter’ Renewable Energy Zone (REZ). I asked Department staff to meet with the City of Newcastle.
- (2) Whether an offshore area might form part of the REZ will require further analysis and consideration, including consultation with the Australian Government.
- (3) I am advised:
 - (a) Nil.
 - (b) Between 2013 and 2015, CLEANaS was awarded grant funding of \$92,000 for community energy projects.

Answer—

- (1) The NSW Government has committed \$300 million for the Rouse Hill Hospital development. Work is expected to start before March 2023. The scope of the overall development will be determined following the completion of clinical services planning. Procurement is an ongoing process and takes place throughout all project stages.

NSW Health uses the NSW Treasury Employment Calculator to estimate the number of jobs supported by its infrastructure projects. Ongoing workforce numbers for the new Rouse Hill Hospital will be determined by the local health district prior to commencing operations.
