  - (a) Each Community Working Party (CWP) is named after the community they represent. 1.Wentworth/Dareton CWP (inclusive of Wentworth, Dareton, Buronga, Namatjirra Ave and Gol Gol), 2.Broken Hill CWP, 3.Menindee CWP, 4.Ivanhoe CWP, 5.Wilcannia CWP, 6.Cobar CWP, 7.Bourke CWP, 8.Enngonia CWP, 9.Weilmoringle CWP, 10.Walgett CWP, 11.Collarenebri CWP, 12.Goodooga CWP, 13.Coonamble CWP, 14.Gulargambone CWP, 15.Lightning Ridge CWP, 16.Brewarrina CWP
  - (b) All of the Community Working Parties are active in the Assembly to various degrees dependent on the individual community.
- (2) Aboriginal Affairs NSW has provided the following funding to the auspicing body for Murdi Paaki Regional Assembly for the delivery of various projects and grants:
  - (a) 2018/2019 Financial Year \$442,500
