(1-3) Education and training for GPs is an Australian Government responsibility.

NSW Health does not hold information on the number of GPs and non-GP services offering medical or surgical abortion.

(4) October 2019, the Secretary, NSW Health, wrote to all local health districts and to GPs to inform them of the provisions in the *Abortion Law Reform Act 2019* and what had changed for health practitioners in NSW.

A framework to support termination of pregnancy services in accordance with the Act was issued to provide clarity and safety for registered health practitioners and guide the development of local protocols for termination of pregnancy undertaken in facilities.

NSW Health funds the NSW Pregnancy Choices Helpline 1800 008 463 and website which provides support with free and confidential information on pregnancy choices in NSW, including details about accessing abortion information, support and services.

I am advised that minimal supervision has occurred on just over 300 occasions for small classes in Years 11 and 12 at Canobolas Rural Technology High School. Classes have been merged just over 200 times for Years 7 to 10.

Minimal supervision does not mean students miss out on a lesson. Sometimes when casual teachers are unable to be sourced at the last minute, classes are merged to ensure continuity of education for students.

Canobolas Rural Technology High School has been in a period of leadership transition in 2021. The current Relieving Principal commenced in April 2021 and will remain until the end of the 2021 year.

Canobolas Rural Technology High School has 11 positions that are currently unfilled by a permanent teacher. Nine positions are filled in a temporary capacity.

The Department of Education monitors population growth and development trends to ensure the necessary educational infrastructure is provided to meet current and future enrolment demand. Upgrades will be assessed for funding against competing projects in schools across the State.

The Department has assessed the needs for Concord, and surrounding areas, and a new high school is being developed to cater for the growing population in Sydney Olympic Park, Concord West and Wentworth Point. It is anticipated that the new high school will relieve enrolment pressure at Concord High School.

The Department is therefore not currently planning to upgrade Concord High School.

The school currently has six vacancies.

Murrumbidgee Regional High School has 12 positions that are currently unfilled by a permanent teacher. All positions are filled in a temporary capacity. Five of these positions have had recruitment finalised with a permanent teacher commencing in 2022.
