- * 7201 BETTER REGULATION AND INNOVATION—WORKPLACE INCIDENTS AT SHOALHAVEN ZOO—The Hon. Emma Hurst to ask the Minister for Finance and Small Business representing the Minister for Better Regulation and Innovation—
 - (1) In answers to questions on notice published on 9 August 2021, the Minister indicated that SafeWork NSW has received notifications in relation to four workplace incidents at Shoalhaven Zoo in the last five years (excluding the 2020 lion attack):
 - (a) What are the details of each of these four notifications?
 - (b) Were these notifications a result of a report from a member of the public or an employee of Shoalhaven Zoo?
 - (c) Why did these notifications not result in a full investigation or prosecution action?

Answer—

(1) As at 25 August 2021, SafeWork NSW advised that it has been notified of four incidents relating to the Shoalhaven Zoo since 2015. This excludes the incident relating to a lion in 2020. Details of each of the incidents notified to SafeWork are provided below.

Incident one

(a) Reference 2-114600

Date notified to SafeWork NSW: 9 August 2015

On 9 August 2015, a casual zookeeper injured their elbow while completing animal care tasks. The worker had closed, but not latched, the adjoining gate between the water buffalo and camel enclosures. The camel chased the water buffalos into the enclosure where the worker was struck by a buffalo and injured their elbow when they came into contact with the ground. The injured worker underwent surgery, recovered from their injuries and returned to pre-injury duties.

- (b) Notification source: employer representative
- (c) The incident was investigated by SafeWork NSW; however, evidence did not support prosecution action. The decision not to take prosecution action was based on the worker's injuries, the injured worker's own actions and the worker being aware of required control measures for the movement of animals. The Inspector issued an improvement notice and worked with the employer to improve systems to manage this workplace activity. The employer complied with the improvement notice and no further action was required.

Incident two

(a) Reference 2-120183 & 15-1130

Date notified to SafeWork NSW: 17 June 2016

On 17 June 2016, SafeWork NSW were notified that a worker had become ill and was taken to hospital. The worker returned a positive result for zoonotic disease -Q Fever.

- (b) Notification source: employer representative.
- (c) In accordance with SafeWork NSW triaging protocols, this incident did not meet the requirements for an Inspector Response. An administrative response letter was provided to the person conducting a business or undertaking (PCBU). However, during a SafeWork NSW audit of administrative letters an Inspector Response was requested to ensure the PCBU had put in place preventative measures.

The inspection found the employer had taken steps to develop a Q fever program including risk assessment and vaccination program. As reasonable control measures were introduced by the employer, no notices were issued, and no further action was required.

Incident three

(a) Reference 2-128500

Date notified to SafeWork NSW: 1 July 2017

On 1 July 2017, SafeWork NSW received notification of a worker injured on 30 June 2017 while performing duties in the zoo knackery. The worker was injured when their knife slipped going across their wrist. The injured worker received first aid and was taken to hospital receiving stiches and was released on the same day.

- (b) Notification source: employer representative.
- (c) In accordance with SafeWork NSW triaging protocols, this incident did not meet requirements for an Inspector Response. An administrative response letter was provided to the PCBU. No further action was required or taken.

Incident four

(a) Reference 2-131989 & 15-5097

Date notified to SafeWork NSW: 21 November 2017

On 21 November 2017, a worker was performing duties in the zoo knackery when he accidently pierced their own stomach with their knife. The injured worker was taken to hospital for treatment but did not receive any stitches and returned to pre-injury duties.

- (b) Notification source: employer representative.
- (c) In following SafeWork NSW triaging protocols, this incident did not meet requirements for an Inspector Response. An administrative response letter was provided to the PCBU. However, during a SafeWork NSW audit of administrative letters an Inspector Response was requested to ensure the PCBU had put in place preventative measures.

The inspection found that the employer had standard operating procedures for the knackery and a training program, in which the worker had been trained. The injured worker was a casual staff member with over 20-years-experience in abattoirs. Appropriate personal protective equipment (PPE) was provided to workers, and the employer correctly consulted with staff. No further action was required or taken.
