- \* 7572 POLICE AND EMERGENCY SERVICES—KAMMOUN V COMMISSIONER OF POLICE—The Hon. Robert Borsak to ask the Minister for Sport, Multiculturalism, Seniors and Veterans representing the Minister for Police and Emergency Services—
  - (1) In the matter of *Kammoun v Commissioner of Police*, NSW Police Force [2021] NSWCATAD 273, Senior Constable Sachin Raj and Senior Constable Michael Matic both made multiple claims in their respective statements about an incident involving Mr Kammoun on 2 September 2020, that under cross examination were found to be false and omitted key events:
    - (a) Was Senior Constable Raj investigated by the NSW Police Force Professional Standards Command?
      - (i) Was any disciplinary action taken?
      - (ii) If so, what action was taken?
    - (b) Was Senior Senior Constable Matic investigated by the NSW Police Force Professional Standards Command?
      - (i) Was any disciplinary action taken?
      - (ii) If so, what action was taken?
    - (c) Does the Minister believe that it is 'in the public interest' for Senior Constable Raj and Senior Constable Matic to remain employed as sworn officers in the NSW Police Force?
    - (d) Does the Minister believe that Senior Constable Raj and Senior Constable Matic are 'fit and proper' persons, to be employed by the NSW Police Force?

Answer-

I am advised:

This matter has been referred to the NSW Police Force Professional Standards Command, and is being assessed in accordance with Part 8A of the Police Act 1990. I have full confidence in the Commissioner of the NSW Police Force to act accordingly. It would be inappropriate for me as Minister, to make any further comment at the current time.

- \* 7573 WATER, PROPERTY AND HOUSING—SYDNEY WATER SYDNEY SCIENCE PARK—The Hon. Mark Latham to ask the Minister for Mental Health, Regional Youth and Women representing the Minister for Water, Property and Housing—
  - (1) In September 2015 did Sydney Water respond to the proposed Sydney Science Park (SSP) rezoning at Penrith City Council by saying that:
    - (a) "It does not have an integrated water servicing strategy for the proposed development and has made no additional system capacity allowance for the servicing of the project"?
    - (b) "Sydney Water will not be funding trunk or lead-in infrastructure for the proposed science park development"?
    - (c) "The proponent is required to prepare an integrated water management plan that considers water, wastewater (including centralised and decentralised treatment) and storm water"?
    - (d) "The proponent will be required to demonstrate that the servicing of the project will be at no cost to the Government, including Sydney Water"?
  - (2) Why did the Minister announce in December 2020 a partnership arrangement between Sydney Water and the SSP whereby Sydney Water would invest \$200 million to build an integrated water system and associated infrastructure at the SSP, initially with the capacity to produce 1.2 million litres of water each day?
    - (a) Why did Sydney Water change its position from September 2015?

(3) What role did the Minister play in breaking the 'no cost to government' position at the SSP by making a \$200 million funding contribution to the proponent, Celestino?

#### Answer—

In 2008, under the previous Government, developer contributions for water infrastructure were set to zero. Under the zero developer charges operating environment, Sydney Water's policy required developers to forward fund major water infrastructure where there was development risk. Sydney Water would then reimburse major infrastructure costs to the developer as development occurred.

Exceptions to this funding and reimbursement model were based on Sydney Water's infrastructure plans and the site's planning status.

Under Sydney Water's policy for rezoned land and accelerated development, if Sydney Water believed there remained development risk, the proponent would need to forward fund infrastructure. That funding and certain components of that funded infrastructure would be reimbursable under a commercial agreement as development progressed.

Under the final commercial agreement between Sydney Water and Celestino, Celestino provided up-front funding. Some funding is reimbursable as regulated or 'standard servicing', and some is non-reimbursable being unregulated 'enhanced services' that are delivered on a purely commercial basis. This investment is staged, subject to demand and may require further commercial agreements.

Of these, 1,857 (or 10.8%) were DV assault reoffenders (i.e. someone who had had been legally proceeded against for domestic violence related assault incidents who had also been legally proceeded against for prior domestic violence related assault incidents within the previous 12 months).
- (b) There is no readily available data to show how many people charged with domestic violence assault in a given 12 month period had been charged with domestic violence assault at any time in the past. Based on a cohort of 16,946 persons proceeded against for domestic violence assault in the 12 months to June 2020, 3,742 (22.1%) had been proceeded against for a domestic violence assault within the previous 10 years.

# I am advised:

The NSW Police Force commenced proceedings against Brian Houston by way of Future Court Attendance Notice.

The matter was listed for first mention at Downing Centre Local Court on Tuesday 5 October 2021 and has been adjourned until 23 November 2021.

The matter has recently been taken over by the Office of the Director of Public Prosecutions, and the complainant will continue to be informed of the progress of the matter in accordance with the Prosecution Guidelines.

The NSW Police Force has not commenced any extradition action in relation to this matter, and as it is now before the Court, it would be inappropriate for me as Minister to make any further comment at the current time.

# Answer—

As advised in response to Budget Estimates Supplementary Question 84, the share of tax savings from salary packaging is retained by the Health entities, principally local health districts. For reform to be considered, employee-related cost savings and workforce productivity improvements would need to be realised.

#### Answer-

#### I am advised:

Pursuant to Clause 3 of the Rural Boundary Clearing Code states that the code does not apply to certain council areas unless the council requests inclusion. Hawkesbury City Council is one of the local government areas yet to opt into the scheme. There are a range of other avenues for landholders to manage risk such as the 10/50 code and bush fire hazard reduction certificate program. I would encourage Hawkesbury City Council to opt-into the code.

  - (1) Given the Minister announced that \$60 million would be made available through the New South Wales Government's Creative Capital program, will the Minister please provide the below details:
    - (a) How much of this money will be spent during the 2021-22 financial year?
    - (b) How much of this money will be spent during the 2022-23 financial year?
    - (c) How much of this money will be reserved for Minor Works and Equipment Projects?
    - (d) How much of this money will be reserved for Medium to Large Projects?
    - (e) How much of this money will be reserved for Indigenous projects?
    - (f) Will successful projects have mandated local supply requirements?

(a-e) There is no pre-determined amount allocated to each financial year from the program, or to each project round. Final allocations will be informed by the demand for each round.

Financial commitments from each round will be made according to the timetable for announcements as set out in the Guidelines, which are available at: https://www.create.nsw.qov.au/create-infrastructure/creativecapital/

The program cash flow will be dependent upon the delivery timetables of the projects.

- (2-3) The \$60 million investment is open to eligible applicants from any part of NSW, including Regional NSW and Western Sydney. The funding of infrastructure needs of organisations across NSW will increase access and participation to quality local spaces for local communities who need more or improved cultural facilities.

As set out in the Guidelines, the assessment process will consider how well the applications meet all of the assessment criteria, and demand by art form and distribution across the State.

Individual applications are required to demonstrate how they address all of the assessment criteria. This includes demonstration of how the requested investment will support at least one Priority Activity, which are outlined in the Guidelines. The outcome of each Priority Activity will enable more people to have access to and participate in the arts.

# Answer-

The Powerhouse Parramatta project will create more than 4,000 direct and indirect jobs, including more than 300 trainees and apprentices, with hundreds more jobs to be supported upon completion. This figure comes from the Social and Economic Impact Assessment completed in the statutory planning phase, as well as assessments made by tenderers in the tender phase.

All major projects funded by governments across Australia are required to have an Australian Industry Participation Plan, which sets out the process for Australian industry to compete for work on the project. Summaries of these plans are published by the Commonwealth Department of Industry, Science, Energy and Resources.

I am also advised Lendlease is committed to partnering with Western Sydney communities and businesses to deliver the Powerhouse Parramatta.

Landowners in NSW are supported in meeting their obligations under s63 of the Rural Fires Act 1997 by a range of initiatives to clear vegetation on their property. Methods of clearing vegetation may include burning, mechanical clearing, mowing and slashing.

Landowners managing vegetation under a biodiversity scheme may need to burn to meet the ecological outcomes for that type of vegetation. The method chosen by the landowner is a matter for them in meeting the requirements of the biodiversity scheme and any other environmental requirements, for example the Protection of the Environment Operations Act 1997.

Landowners who need to undertake burning on their properties can do so if they comply with permits and notice requirements under the Rural Fires Act 1997 and the relevant environmental constraints such as their biodiversity agreement. Should a permit be required, it is issued at no cost.

Where a landowner fails to meet their obligations under s63 of the Rural Fires Act 1997, the NSW RFS can inspect the land and determine if a bushfire hazard exists. If a hazard does exist then the NSW RFS Commissioner may issue a notice requiring hazard reduction works to be done. If the landowner fails to comply then the NSW RFS may carry out the works and recover the costs.
