- * 6272 VENTILATORS IN THE MURRUMBIDGEE LOCAL HEALTH DISTRICT—Mrs Helen Dalton to ask the Minister for Health and Medical Research—
 - (1) As at 11 October 2021, how many ventilators are there in:
 - (a) Griffith Base Hospital?
 - (b) Deniliquin Hospital?
 - (c) Wagga Wagga Base Hospital?
 - (2) Will patients from Hay, Hillston, Moama, Leeton, Barham, Berrigan, Deniliquin and Tocumwal requiring ventilators be treated in Griffith Base Hospital?
 - (3) If the number of patients requiring ventilators in hospitals within the Murrumbidgee Local Health District (MLHD) exceeds the number ventilators in MLHD hospitals, to where will patients be transferred?

Answer-

Since March 2020, the Government's response to COVID-19 has been flexible and scalable to respond to the evolving situation. The Government has committed to help transform our healthcare system to increase its capacity and ensure it is well placed to manage the ongoing impacts of COVID-19.

NSW Health monitors Intensive Care Unit (ICU) utilisation and capacity in real time and can significantly expand ICU beds if required. Additional ventilators and other necessary equipment have been purchased to meet increased demand for ICU services. Each person diagnosed COVID-19 positive is assessed by a respiratory physician with an appropriate treatment pathway decided in collaboration with the patient and their carers.

The New South Wales public health system is highly integrated and local health districts throughout the state work collaboratively to ensure patients receive the care and treatment they need.

Local health districts and speciality health networks have developed workforce surge and demand management plans to ensure there is sufficient capacity across New South Wales to manage both non-COVID-19 patients and patients with COVID-19. - * 6273 EMPOWERING HOMES PROGRAM—Mrs Helen Dalton to ask the Treasurer, and Minister for Energy and Environment—
 - (1) Considering the Empowering Homes Program is currently a pilot and only available to select postcodes:
 - (a) What are the preliminary results of the pilot program?
 - (b) When will it be extended to households beyond the pilot area, including those in the Murray electorate?

Answer-

- (1) The Empowering Homes Program pilot has been extremely valuable in providing learnings on the household solar-battery and green finance sectors.
 - (a) As at 15 October 2021, the pilot had delivered:
 - 3.4 MWh of energy storage capacity installed
 - 1.9 MW of new rooftop solar installed
 - \$4.9 million in dispersed loans
 - \$6.3 million of installed clean energy technology.
 - (b) The initial pilot was expanded from nine local government areas (LGAs) to 24 LGAs in December 2020, to further test key aspects of the program's design and delivery. The insights developed are currently being analysed and will be used to inform future stages of the program.
- * 6274 OPERATING THEATRE IN LEETON HOSPITAL—Mrs Helen Dalton to ask the Minister for Health and Medical Research—
 - (1) How much did the Government spend upgrading the Leeton District Hospital operating theatre in 2010?
 - (2) Why has the operating theatre not been used since 2016?
 - (3) Is the operating theatre not being used because the wrong paint was used and the recovery room is 11 centimetres too small?

(4) Does the Government plan to downgrade Leeton District Hospital and rename it the Leeton Health Service?

Answer-

- (1) In 2010, the Government allocated \$280,000 to upgrade the Leeton District Hospital.
- (2) In 2017, the very low numbers of referred patients were insufficient to schedule regular surgical sessions, and nursing staff were unable to maintain the required perioperative skills to safely provide patient care.
- (3) No.
- (4) Leeton District Hospital has been referred to as "Leeton Health Service" on the Murrumbidgee Local Health District website since 2016. The website lists all District Hospitals as a "Health Service" to advise the general public that the facility provides a diverse range of health services.

There is no plan to change the name of the hospital.

- * 6275 REMOTE RESCUE TUBES—Mr Philip Donato to ask the Minister for Police and Emergency Services—
 - (1) Will consideration be given to the funding and installation of Remote Rescue Tubes at inland waterways which attract recreational water activities, as a step towards reducing the incidence of drowning deaths in rural and regional New South Wales?
 - (a) If so, will this be prioritised to be delivered prior to the commencement of the 2021-22 summer season?

Answer-

I am advised:

Local councils have a range of safety and enforcement responsibilities for inland waterways. This includes the identification of water safety risks and responsibility for determining appropriate measures for addressing these risks. Local councils are best placed to determine if rescue tubes would be an appropriate measure for addressing water safety risks in their local government area.

- * 6276 STRATEGIC BUSINESS CASE FOR THE SYDNEY-CENTRAL WEST (ORANGE & PARKES) RAIL—Mr Philip Donato to ask the Deputy Premier, Minister for Regional Transport and Roads, and Minister for Regional New South Wales—
 - (1) What is the progress or status of the Strategic Business Case for Sydney-Orange- Parkes rail, worked on jointly by the Government and the Federal National Faster Rail Agency?
 - (2) Has the NSW Cabinet considered this Business Case?

Answer—

I am advised:

The Government and Commonwealth Government are currently considering the findings of the Sydney-Orange-Parkes strategic business case.

The Government remains committed to delivering fast rail and is taking the time to get this right. Further information will be released in due course.

- * 6277 FAST RAIL ROUTE TO THE CENTRAL WEST—Mr Philip Donato to ask the Deputy Premier, Minister for Regional Transport and Roads, and Minister for Regional New South Wales—
 - (1) Given the 2021-22 NSW State Budget allocated \$4.3 million to continue planning for a Fast Rail route to the Central West:
 - (a) What is this planning?

(b) What does it entail?

Answer—

I am advised:

The Government is committed to delivering a Fast Rail Strategy.

This Strategy will launch the next phase of the fast rail network and will include a detailed design and blueprint for delivery as well as outline the economic and social benefits.

- * 6278 CENTRAL WEST RAIL ROUTE—Mr Philip Donato to ask the Deputy Premier, Minister for Regional Transport and Roads, and Minister for Regional New South Wales—
 - (1) Considering your discussions with the Chairman of Bathurst Rail Action and the two stage approach to faster rail to the Central West (Western Advocate, 30 June 2021):
 - (a) Why has this strategy not been announced?
 - (b) Has an optimal faster rail route been proposed between Lithgow, Bathurst and Orange?
 - (c) How many stages are being considered?
 - (d) What time saving is proposed between Lithgow and Orange?
 - (e) What upgrades are being considered for the Orange to Parkes Line, within the Orange electorate?
 - (f) What route is proposed to bypass the Blue Mountains suburban route?

The Government remains committed to delivering fast rail and is taking the time to get this right. Further information will be released in due course.

Following the release of the Fast Rail Strategy, the Government will work closely with stakeholders and engage with communities, local government, business and industry to refine the program.

Answer—

NSW Fair Trading first published a public warning about Hashmi eyeliner products on 24 July2018 not 20 September 2018.

On 20 September 2018, Fair Trading published a notification relating to the public warning with additional information.

- * 6282 INTERSTATE CONSUMER COMPLAINTS—Mr Alex Greenwich to ask the Minister for Better Regulation and Innovation—
 - (1) Can state consumer protection agencies take action on consumer complaints where the service provided or consumer is in another state or territory?
 - (2) Does the NSW Civil and Administrative Tribunal have interstate jurisdiction for consumer complaints?

- (3) What options are available for NSW consumers to resolve complaints about goods and services provided by an interstate business?
- (4) Has the Government raised these concerns through the Legislative and Governance Forum on Consumer Affairs?
 - (a) If so, what action has been taken as a result?
 - (b) If so, what further action will the Government take to provide cross-jurisdiction consumer protection?

Answer-

- (1) Generally yes, however the exception to this may be where the contract was entered into or goods/services were provided by a trader in another state or territory and:
 - the trader is required to be licensed by that state or territory; and/or
 - the matter is covered by other specific state-based legislation.

If the consumer does not reside in New South Wales and the trader operates interstate, NSW Fair Trading will advise customers to lodge the matter in the relevant jurisdiction.

- (2) This is a matter for the Attorney General.
- (3) New South Wales residents who have a problem with a product or service they purchased in another state or territory of Australia can discuss the matter with Fair Trading and can lodge a complaint with Fair Trading. Fair Trading will follow its usual complaint handling processes and will endeavour to assist the consumer and trader reach an agreement to resolve the complaint. If the matter remains unresolved, Fair Trading will provide the consumer and trader with appropriate options to pursue the matter, such as applying to a court or tribunal and seeking legal information and advice.

Where the contract was entered into or goods/services were provided by a trader in another state or territory and:

- the trader is required to be licensed by that state or territory; and/or
- the matter is covered by other specific state-based legislation.

Fair Trading will advise New South Wales residents to lodge the matter in the relevant jurisdiction.

(4) (a) and (b)

On 26 June 2020, National Cabinet agreed to a Review of the COAG Councils and Ministerial Forums (Review) with a view to rationalising and resetting the structure and work programs.

On 23 October 2020, National Cabinet accepted the Review's recommendations to reduce the number of ministerial forums including the disestablishment of the Legislative and Governance Forum on Consumer Affairs. Forums in the disestablished category concluded existing work and ceased operating in their current form as at 1 February 2021. Consumer affairs Ministers now meet as required under the Consumer Ministers' Network (CMN) to discuss consumer protection issues and vote on amendments to the Australian Consumer Law (ACL).

The Consumer Senior Officials Network (CSON), formerly Consumer Affairs Australia and New Zealand, is a network of state and territory consumer affairs regulators that support the CMN. Part of CSON's role is to ensure that regulators work together to ensure the consistent application and enforcement of the ACL across Australia.

CSON releases an annual ACL 'Year in Review' report, which provides an update on the work of the Commonwealth and the states and territories in implementing, strengthening and improving the ACL. The Year in Review reports are available at https://consumer.gov.au/australian-consumer-law/year-review.

- * 6283 DIGITAL DIVIDE—Mr Alex Greenwich to ask the Minister for Customer Service, and Minister for Digital—
 - (1) What evidence does the Government have about increasing the divide between citizens who have access and capacity to operate in a digital world and those without this advantage?
 - (2) What programs and support does the Government provide to bridge this gap?
 - (3) Given the increasing reliance on digital access and services for Government programs, what further action will the Government take to reduce the digital divide?

Answer-

(1)

- According to the 2021 <u>Australian Digital Inclusion Index</u>, the digital divide has narrowed slightly in the last year at a national level (from an average Index score of 67.5 in 2020, to 71.1 in 2021).
- Australia-wide, 11% of the population remains 'highly excluded' (Australian Digital Inclusion Index).
- Digital exclusion affects some cohorts and communities more than others. Mobile-only users, remote First Nations communities, people who did not complete secondary school, and low-income households are more likely to be digitally excluded. People over 75 years of age are also more likely to be digitally excluded but their index score has improved substantially during Covid (increasing by 6.1 points from 41.3 to 47.4).
- Culturally and Linguistically Diverse Australians are generally more digitally included than other Australians. People in this demographic group recorded a 2021 Index score of 73.9 (up 3 on the 2020 score of 70.9).

(2)

- Service NSW digital kiosks in Service Centres and Mobile Service Centres are available to customers to use to complete transactions if they do not have access to a digital device. Service NSW also provides assistance to use the kiosks. All Service NSW centres also have Wi-Fi available to our customers to assist with digital access.
- The Department of Customer Service's Digital Restart Fund invests in a number of digital inclusion initiatives from across government, including the Department of Education's Rural Access Gap direct intervention package. This is a major service transformation to accelerate the Schools Digital Strategy delivery to address disadvantage in rural and remote schools with a pathway to improved operations and anywhere, anytime learning. This is being rolled out across 1002 schools totalling around 210,000 students.
- NSW participates in a national-level working group on digital inclusion with other states, sharing best practice across government.

(3)

- The next iteration of the Beyond Digital strategy is being launched on 23 November 2021, with a renewed focus on digital inclusion and accessibility.
- * 6284 RURAL FIRE SERVICE VOLUNTEERS—Mr Alex Greenwich to ask the Minister for Police and Emergency Services—
 - (1) Is there an independent external complaints process for Rural Fire Service volunteers?
 - (2) What is the process for Rural Fire Service volunteers to have complaints about assault, bullying, intimidation, discrimination and vilification addressed?

- (3) What assessment has the Government made of complaints about the Rural Fire Service having developed a culture that endorses this type of behaviour and what action has the Government taken to address this?
- (4) What consideration has the Government given to a Royal Commission or other independent inquiry into complaints from Rural Fire Service volunteers?
- (5) How many volunteer complaints were made each year since 2011 and what is the trend in complaint outcomes?
- (6) What plans does the Government have to ensure Rural Fire Service volunteers' complaints are property addressed?

Answer-

I am advised:

(1 - 3) The NSW Rural Fire Service (RFS) views any such complaints from members of any agency seriously and is committed to ensuring members feel safe, supported and able to speak up about any matters of concern.

RFS volunteers can report serious matters directly to their Brigade Captain or Group Officer, or to the District Manager if there are concerns about reporting at brigade level. If an RFS volunteer believes their concerns have not been actee on at the local level, the matter can be escalated to their District Manager or Area Commander. For serious matters, including those that may potentially involve criminal offences, members can report directly to NSW Police and / or the RFS Performance and Conduct unit.

Volunteers can also make complaints to external bodies such as the NSW Ombudsman, the Independent Commission Against Corruption or Anti-Discrimination NSW. There are also avenues to make applications to external tribunals, for example, the NSW Civil and Administrative Tribunal (NCAT).

The RFS is also currently undertaking a comprehensive review of its grievance and disciplinary framework. The RFS has invited all members to participate in a Grievance & Discipline Review Survey to provide their views on its existing processes, including people's awareness of, confidence in and experience with them and ideas for improvement. A survey report was provided to all members on 21 June 2021.

- (4) The NSW RFS has identified workplace conduct as a priority project in 2021. The project is committed to improving the RFS approach to the management of grievance and disciplinary issues and preventative programs to encourage an inclusive and 'speak up' culture in the workplace.
- (5) The NSW RFS holds summary data on staff and volunteer complaints from 2014 onwards.

While no clear trend is evident in the outcomes of these matters, action taken as a result of complaints made over this time has included remedial action (for example, counselling, training or mediation), formal cautions or reprimands, suspension, or termination of employment or removal from membership. A number of matters did not proceed for various reasons, including due to the complainant not proceeding or the matter being referred to the NSW Police Force.

(6) The NSW RFS has announced a comprehensive review of its grievance and discipline processes (please refer to question 1).

Members' feedback and best practice principles are central to the review.

The NSW RFS has:

• Undertaken a member survey to gain feedback about our current processes and suggestions for any new framework. A large number of responses was received (approximately 2,500).

- Established a 'Speak Up' independent review process while new workplace conduct management procedures are being developed
- Engaged an expert to research and propose a best practice model for resolving workplace conduct matters
- Begun the detailed design for new end-to-end procedural requirements for the resolution of workplace conduct matters, in alignment with the best practice report

The project will continue over the coming months, with a new framework being implemented in the second half of 2022. Formal consultation with members to seek feedback about the new framework and procedures will begin in early 2022.

- * 6285 MENTAL HEALTH COUNSELLING—Mr Alex Greenwich to ask the Minister for Health and Medical Research representing the Minister for Mental Health, Regional Youth and Women—
 - (1) What data does the Government have about increased need for mental health counselling and support as a result of pandemic restrictions?
 - (2) What are the trends in emergency department presentations for mental health conditions during the pandemic?
 - (3) What additional funding or support has the Government provided for counselling and support beyond telephone information and emergency treatment in hospitals?
 - (4) How has the Government worked with the Commonwealth Government to expand Medicare-funded psychology services to meet increased need?
 - (5) What further plans does the Government have to increase access to counselling for mental health conditions?

Answer-

- (1-2) Throughout the COVID-19 pandemic, there was an increase in people seeking support for their mental health. Of note, there are a range of reasons why people access mental health services, beyond the impacts of the pandemic. The use of telehealth meant that many people could continue to access support while restrictions were in place. The use of Medicare mental health services and calls answered by crisis lines have increased throughout 2020 and 2021. The Mental Health Services in Australia report is available on the Australian Institute of Health and Welfare website and details the use of these services.
 - During periods of lockdown, there were decreases in the number of presentations to emergency departments. Otherwise, presentations have remained higher than in previous years.
- (3-5) The Government announced a number of supports for New South Wales residents since the beginning of the pandemic and has worked closely with the Commonwealth Government to ensure people are able to access the mental health services they need. In May 2020, the Government announced a suite of support measures, including funding for over 180 additional specialist, community-based mental health clinicians and peer support workers to assist vulnerable populations. The funding for this initiative has now been extended, with \$90 million allocated over four years from 2021-22 to 2024-25.

Additionally, the Government has announced two support packages since the beginning of 2021 to support New South Wales residents during, and emerging from, lockdown.

A joint \$17.5 million package was announced by the Government and the Commonwealth Government in July 2021, which included a number of supports for parents, young people, people in mandatory isolation, and culturally and linguistically diverse communities.

On 18 October 2021, the Government also announced funding for the single biggest investment in mental health since the pandemic began with a record \$130 million Mental Health Recovery

Package to address the immediate and longer-term impacts of COVID-19 on the people of New South Wales.

The Government is also working with the Commonwealth Government on the implementation of Head to Health pop-up clinics. These clinics are staffed by teams of mental health support workers including psychologists, mental health nurses, mental health occupational therapists, social workers and peer workers and will provide additional mental health support for people living in New South Wales who have been substantially affected by the COVID-19 pandemic.

- * 6286 MULTI-USER FACILITY—Mr Alex Greenwich to ask the Minister for Planning and Public Spaces, and Minister for Transport and Roads—
 - (1) To what extent has the Port Authority of New South Wales assessed the conditions imposed on the Hanson state significant development at Glebe Island by the Independent Planning Commission (IPC), given it is a similar development and in the same operating environment as the multi-user facility?
 - (2) What are the reasons for the differences in conditions set by the Port Authority of New South Wales for its own multi-user facility under its review of environmental factors, to the conditions set for Hanson development by the IPC on:
 - (a) Ship movements, loading and unloading time limits?
 - (b) Noise limits?
 - (c) Shore-to-ship power investigations?
 - (d) Noise mitigation?
 - (e) Silo height limitations?
 - (3) To what extent will the Government consider aligning conditions for the multi-user facility with the conditions for the Hanson development?

Answer—

I am advised:

- (1) The Port Authority of NSW (Port Authority) carefully reviewed and considered the Independent Planning Commission's (IPC's) Statement of Reasons for Decision and Development Consent to assist with its considerations concerning the proposed use of the Glebe Island site and any broader implications for the Bays Port Precinct.
- (2) Each development proposal was assessed in accordance with the relevant requirements of the Environmental Planning and Assessment Act 1979 (EPA Act) and the Environmental Planning and Assessment Regulation 2000 (EPA Regulations) by the appropriate approval authorities. The two approved facilities have some similarities, however different environmental impacts and planning considerations were taken into account.
 - The IPC's consent was granted to Hanson more than two years after the approval of the multi-user facility. Consent was pursuant to its statutory functions and following its own processes, including taking into consideration the assessment and draft conditions from the Department of Planning, Industry and Environment.
- (3) The multi-user facility and the Hanson approvals are subject to valid development approvals, and both developments will be required to meet the conditions imposed for those respective approvals. Granted approvals are fixed, unless proponents seek to modify them in accordance with any provisions available to them under the EPA Act and Regulations.

It would not be appropriate for an existing approval to be automatically treated as subservient to later-granted development approvals - however, future environmental and operational management plans for both developments will be prepared taking into account surrounding land uses so that impacts, including any arising out of concurrent construction or operational projects, are managed effectively. The Port Authority is also committed to, and is already managing noise at a precinct level through its Port Noise Policy, which is referenced in the IPC Hanson approval.

- * 6287 CATCH-UP LEARNING PROGRAM—Mr Alex Greenwich to ask the Minister for Skills and Tertiary Education representing the Minister for Education and Early Childhood Learning—
 - (1) What assessment has the Government made of the Smith Family's Catch-Up Learning online tutoring program, which showed significant success in literacy and numeracy improvements for struggling students, including under conditions of remote learning and pandemic restrictions?
 - (2) What support does the Government provide for this program to be provided across NSW?
 - (3) What plans does the Government have to fund and support this program for students struggling with literacy and numeracy?

Answer-

Both my office and the Department of Education have met with the Smith Family to discuss their Catch-Up Learning online tutoring program. The Government has provided \$337 million for schools to employ additional staff to deliver targeted, intensive small-group tuition in 2021. In addition, a further \$383 million has been delivered to extend the program into 2022.

* 6288 ANTI-ASIAN RACISM COVID-19 PANDEMIC—Mr Alex Greenwich to ask the Minister for Counter Terrorism and Corrections representing the Minister for Sport, Multiculturalism, Seniors and Veterans—

Considering the continuing reports of aggressive and abusive racist attacks on Asian Australians during the COVID-19 pandemic, what action will the Government take to address racism in the community and provide greater prevention programs?

Answer—

NSW agencies have worked throughout the COVID-19 pandemic to support communities impacted by racism.

The NSW Community Resilience and Response Plan (COMPLAN) Committee, chaired by Multicultural NSW and comprised of senior officers from NSW agencies, has convened throughout the pandemic to identify, monitor and share information about racism and hate related to the COVID-19.

As early as February 2020, Multicultural NSW issued a statement condemning racism and encouraging community to follow factual advice from NSW Health to combat the spread of false information.

Also in February 2020, the NSW Chief Health Officer delivered a video message about COVID-19 and community support, reinforcing that racism does not have place in our society.

In July 2020 the NSW Government announced \$3 million in additional funding to expand the COMPACT Program. 15 new partnership projects involving an alliance of over 50 partner ogranisations were funded to inspire and empower young people to stand up and stand united against fear, hate and division as champions for community harmony.

In October 2020, NSW Police Force and Multicultural NSW co-hosted a workshop with the Police Commissioner's Multicultural Advisory Council (PMAC) on current threats to social cohesion and strategies for enhancing social cohesion in NSW both during and after the pandemic.

In December 2020, Multicultural NSW organised another online forum with Chinese community leaders to discuss the impact of COVID-19 on the community.

Upon becoming Minister, one of my first meetings was with the Chinese Australian Forum in June 2021, where issues were raised around the increase of racism towards the Chinese Australian community during the COVID-19 pandemic.

In August 2021, Multicultural NSW activated the COMPACT Alliance through a series of action groups focussed on addressing the social cohesion impacts of the Delta outbreak of COVID-19.

In September 2021, Multicultural NSW partnered with the Office of Community Safety and Cohesion to deliver workshops on Safeguarding Social Cohesion during COVID- 19.

The Office of Community Safety and Cohesion has also been rolling out the Safeguarding Social Cohesion during COV!D-19 workshops for local councils through September and October 2021.

- * 6289 ACCESSIBLE SOCIAL HOUSING—Mr Alex Greenwich to ask the Minister for Families, Communities and Disability Services—
 - (1) How many social housing tenants in inner-city social housing are approved and waiting for transfer to an accessible property because their current accommodation does not meet their needs?
 - (2) How many of these tenants have been waiting for an accessible home for more than:
 - (a) One year?
 - (b) Two years?
 - (c) Five years?
 - (d) 10 years?
 - (e) More than 10 years?
 - (3) What plans does the Government have to speed the transfer of social housing tenants who need an accessible home?

Answer-

I am advised that under the Department of Communities and Justice (DCJ) transfer policy, a social housing tenant can apply for a transfer to another property managed by either DCJ or a community housing provider participating in Housing Pathways if there is change in their circumstances that affects their housing needs.

There are a number of reasons why a tenant may request a transfer including under-occupancy, medical condition/disability or a requirement for a change in location.

The waiting time a tenant will experience depends on a number of factors including the reason for transfer and the number of suitable properties that are available in the required location.

DCJ may head lease properties from the private market to sublease to tenants, where housing supply in an area does not meet the demand for housing (causing a backlog of applicants DCJ is unable to house). - * 6290 HIGH SEVERITY CROWN FIRES—Mr Alex Greenwich to ask the Minister for Jobs, Investment, Tourism and Western Sydney, and Minister for Trade and Industry—
 - (1) What assessment has the Government made of the research report 'The severity and extent of the Australia 2019-20 Eucalyptus forest fires are not the legacy of forest management' published in Nature Ecology & Evolution (May 2021)?
 - (2) What action has the Government taken in response to the evidence that trees in previously logged areas were as likely to crown scorch on the mildest bushfire days as were trees in undisturbed forests on severe bushfire days?
 - (3) What plans does the Government have to restrict logging in native forests given the increasing evidence of worse fire impacts after logging and expected increase in severe bushfires?

This question is the responsibility of the Deputy Premier, Minister for Regional New South Wales, and Minister for Regional Transport and Roads, the Hon. Paul Toole, and should be referred him.

- * 6291 PERMANENT QUARANTINE FACILITIES—Ms Jodie Harrison to ask the Minister for Jobs, Investment, Tourism and Western Sydney, and Minister for Industry and Trade—
 - (1) Noting the Government taking responsibility for hotel quarantine, why isn't the Government acting to build purpose-built permanent quarantine facilities?
 - (a) Will the Government consider investing in permanent quarantine facilities for COVID-19 and future pandemics?
 - (2) Does the Government have future plans to establish permanent quarantine facilities to address the recognised problem of airborne virus transmission occurring in existing hotel quarantine?
 - (a) If so, what are they?
 - (3) Is the Government taking action in regards to quarantine following their careful consideration of the Victorian COVID-19 Hotel Quarantine Inquiry Interim Report?
 - (a) If so, what action is being taken?

Answer-

The Government has administered the largest hotel quarantine program of any state or territory in Australia. From the beginning of the pandemic to November 2021, New South Wales has quarantined over 255,000 travellers in police-managed hotels.

As of 1 November 2021, international arrivals who are fully vaccinated with a vaccine recognised or approved by the Therapeutic Goods Administration (TGA) do not have to undertake mandatory quarantine. However, if they are not fully vaccinated and arrive in New South Wales from an overseas location, they will continue to be required to undertake a 14-day mandatory quarantine period.

The Government position on a purpose-built permanent quarantine facility is that it must be built, owned and operated by the Commonwealth Government, in view of the substantial efforts made by New South Wales in quarantining returning Australians to date and consistent with the Commonwealth Government's overarching responsibility for quarantine matters.

The New South Wales quarantine program has comprehensive end-to-end processes and has continued to evolve. Changes implemented are considered in relation to risk to the New South Wales community, which has changed over time with the development of variant strains of COVID-19 and the community vaccination rate. Since 29 March 2020, changes to the program have been significant and include:

- an enhanced infection prevention and control auditing program
- air pressure testing and heating ventilation
- air-conditioning optimisation
- introduction of surveillance staff testing (now ceased)
- mandatory vaccination of border and quarantine workers.

- * 6293 ACCESS TO QR CODE CHECK-IN APPLICATIONS—Mr Paul Lynch to ask the Minister for Customer Service, and Minister for Digital—
 - (1) Have NSW Police been prohibited from accessing information from QR Code check-in applications?
 - (a) If not, why not?

Answer-

Service NSW has not provided NSW Police with access to any COVID Safe Check-in data.

The Public Health (COVID-19 General) Order 2021 specifies that:

- contact details provided when checking in to a premise are to be used or disclosed only for the purposes of contact tracing during the COVID-19 pandemic [Part 5, Clause 5.5]; and,
- specifically **excludes** the Health Minister from being able to grant an exemption to the protections in clause 5.5 [Part 7, Clause 7.1].

In relation to your answer to Question no 5961 how is it possible there are no records of the concerns after the email on 26.3.21 from the Liverpool Electorate Office to the Department of Family and Community Services?

Answer—

I am advised:

The Department of Communities and Justice (DCJ) conducted an extensive search in relevant electronic document and records management systems and were unable to verify or locate the email sent. There are no formal written representations from Mr Paul Lynch MP on the tenant's file about any tenancy related concerns.

On 21 October 2021, following contact with Mr Lynch's office, DCJ confirmed that correspondence was sent to an invalid email address. Mr Lynch's office has since resent the correspondence directly for urgent action and the correct email address has been provided to Mr Lynch's office for future correspondence.

* 6297 COMPLIANCE BY COUNCILS - DISCLOSURES OF PECUNIARY AND OTHER INTERESTS—Mr Paul Lynch to ask the Minister for Local Government—

What steps will you take to ensure the increase in the low levels of compliance by the Council sector in respect of their requirement to make available on their websites disclosures of pecuniary and other interests as referred to in the Report by the Information Commissioner from July 2021 on the operation of the Government Information (Public Access) Act?

The requirement for councils to publish councillors' and designated persons' disclosures of interests on their websites is prescribed under the Government Information (Public Access) Act 2009 (the GIPA Act) and the Government Information (Public Access) Regulation 2018. The Information Commissioner is responsible for oversight and enforcement of compliance with the relevant statutory requirements.

I support the Information Commissioner's recommendations and their focus on assisting councils to improve compliance with their obligations under the GIPA Act and have advised them that the Office of Local Government is available to assist in communicating the compliance report's outcomes and recommendations to the local government sector.

- * 6298 OPERATION MONZA REPORT—Mr Paul Lynch to ask the Minister for Police and Emergency Services—

The Information and Privacy Commission (IPC) adopts a risk-based approach to regulatory priorities to inform its forward work program. The increased reliance by State Owned Corporations on the cabinet-inconfidence conclusive overriding presumption against disclosure may demonstrate a need to promote its appropriate use as part of the IPC's forward work program.

I will continue to support the IPC in the implementation of its work program.

The Government Information (Public Access) Act 2009 also contains mechanisms which can be used to ensure appropriate use of the cabinet-in-confidence conclusive overriding presumption against disclosure, including review rights (Part 5) and offence provisions (Part 6, Division 2). The Information Commissioner also has investigation and reporting powers (Part 3, Division 3 of the Government Information (Information Commissioner) Act 2009).

It is the Information Commissioner's role to promote public awareness of these mechanisms. I will continue to support the Information Commissioner in her role.

The vast majority of spaces in schools are adequately ventilated through natural and mechanically assisted ventilation.

Air purification is only recommended where air quality is compromised by bush fire smoke or where natural ventilation cannot be achieved. The Department of Education will provide air purifiers to schools as required.

The department's approach to ventilation in schools is strongly supported by expert advice.

The Department of Planning, Industry and Environment is currently finalising a new State Environmental Planning Policy for Housing (Housing SEPP). The proposed Housing SEPP will update planning provisions that incentivise the delivery and retention of affordable housing, including infill affordable housing and boarding houses.

Affordable housing developed under the new Housing SEPP will need to be managed by a registered community housing provider and be made available to people on moderate, low, and very low incomes.

The Housing SEPP will also carry forward the existing provisions from SEPP 70 that allow councils to develop an affordable housing contributions scheme. It is optional for a council to develop such a scheme, but a number of councils have indicated an intention to do so through their Local Housing Strategies. Where councils adopt affordable housing contribution schemes, they can levy affordable housing contributions on new development in re-zoned areas.

It is anticipated that the Housing SEPP will be finalised before the end of the year.

exhibited consultation draft, is available at www.planningportal.nsw.gov.au/housing-sepp.

Under its 2017 Housing Affordability and Diversity Policy, Landcom was required to provide 5 to 10 per cent of all new dwellings as affordable rental housing. In June 2021, Landcom updated its Housing Policy after I issued a statement of priorities.

The updated Landcom Housing Policy applies to new projects and sets new targets, including the following requirements:

- A minimum of 10 per cent of all new housing is affordable, including a minimum of 5 per cent affordable rental housing, plus affordable ownership and other housing products which improve affordability;
- A minimum of 30 per cent of all medium and high-density housing will meet or exceed requirements for Livable Housing Australia's Silver Level certification, providing more accessible housing options; and

- A minimum of 15 per cent of all housing will be diverse, such as seniors housing, terrace homes and manor homes.

This includes specialist support for young people, crisis and transitional accommodation for families and adults, and support for people experiencing domestic and family violence.

DCJ is operating assertive street outreach services in the Ballina, Byron Shire, Clarence Valley, Kyogle, Lismore, Richmond Valley and Tweed local government areas. Since it commenced in the Northern Rivers in August 2019, DCJ's assertive outreach services have supported 174 people sleeping rough into long-term housing (as at 30 September 2021).

DCJ has also allocated 40 packages through the Together Home program to the Northern Rivers that cover Lismore, Tweed, Byron, and the Clarence Valley. Together Home provides people sleeping rough with access to stable accommodation linked to wraparound supports.

The Department of Communities and Justice (DCJ) will undertake further consultation with the sector and people with lived experience from 2022 to support a review of the Protocol, and development of the next Homelessness and Housing strategies. DCJ funds the Public Interest Advocacy Centre's StreetCare team to provide consumer consultation and input into housing and homelessness policy and service delivery.

The NSW Regional Housing Taskforce established in July 2021 by the Hon. Rob Stokes MP, Minister for Planning and Public Spaces undertook extensive consultation through July and August 2021 with more than 500 people across regional NSW including councils; community groups; housing, not-for-profit and development sectors; Local Aboriginal Land Councils, business groups and members of the public.

Housing and homelessness peaks also hold regular public forums which advise all levels of government, such as Shelter NSW's Local Housing Forum held on 14 October 2021 to discuss key housing issues and what Councils can practically do to help local communities.
