 - (1) In the calculation of carbon emissions reductions in New South Wales, what account is taken of the Australia Clause in the Kyoto Protocol, that is, restrictions on land clearing are counted in as carbon emissions reductions?
 - (2) What proportion of New South Wales carbon emissions reductions are comprised of the Australia Clause for:
 - (a) Calendar year 2020?
 - (b) The decade 2010-2020?
 - (c) Projections for the 50 per cent reduction target by 2030?
 - (d) Projections for Net Zero target by 2050?
 - (3) What are the details?

Answer—

I am advised:

(1-3) The Australian Government maintains national, state and territory emission inventories. National emissions are published for United Nations Framework Convention on Climate Change (UNFCCC) rules and Kyoto Protocol rules.

NSW and other state/territory inventories are based on UNFCCC rules and include all sectors including land use, land use change and forestry. Emission projections for NSW are compiled for all UNFCCC sectors.

- (1)
- (a) Principals have an opportunity to seek appointment of an eligible temporary teacher to a permanent teaching position when they are up to a local recruitment choice. Up until July 2021, one transfer point schools have only been able to access this opportunity for permanent part time positions. School staffing operations work on a calendar year, not a financial year. Figures below indicate the total number of permanent vacant positions filled using this mechanism for each calendar year.
 - (i) 32 positions filled in the 2017 calendar year
 - (ii) 54 positions filled in the 2018 calendar year
 - (iii) 57 positions filled in the 2019 calendar year
 - (iv) 74 positions filled in the 2020 calendar year
 - (v) At 22 November 2021, approximately 114 positions have been filled, and it is anticipated this number will continue to increase as more vacancies are filled this year.3

- (1) The proposed Western Sydney Freight Line project is noted in Future Transport 2056 for implementation in 10 20 years subject to a business case. It is intended as a dedicated 24/7 rail freight line to Western Sydney.
- (2) The commencement of the Western Sydney Freight Line is subject to the creation a business case.
- (3) The predicted annual volume of air cargo is forecast to be approximately 220,000 tonnes.
- (4) The estimated cost of land acquisition for the Western Sydney Freight Line rail corridor will be determined during the business case for the project.
- (5) The Government has acquired 14 hectares of land for the future Western Sydney Freight Rail line. This represents a small percentage of land required for the rail corridor.
