- * 8476 HEALTH—ACCOMMODATION OF HEALTH CARE PROVIDERS—The Hon. Rose Jackson to ask the Minister for Women, Minister for Regional Health, and Minister for Mental Health representing the Minister for Health—
 - (1) How much did NSW Health spend on the housing and accommodation of health care providers (HCPs) in the following financial years:
 - (a) 2018/19?
 - (b) 2019/20?
 - (c) 2020/21?
 - (d) 2021 to date?
 - (2) How many HCPs were placed in accommodation for less than 1 month?
 - (a) What is the cost of this in the following financial years:
 - (i) 2020/21?

Answer—

(1-4) Since March 2020, the NSW Government has committed more than \$4 billion to support the health system in its response to the COVID-19 pandemic. Part of this response has included free temporary accommodation being made available to support frontline staff, as well as for vulnerable community members who are either at risk of contracting or who have tested positive to COVID-19 and are unable to self-isolate at home.

Further to this, the NSW Government recently announced \$45.3 million to deliver modern, sustainable accommodation for health workers in three local health districts (LHDs), being Southern NSW, Murrumbidgee and Far West LHDs.

This builds on the \$30 million already pledged by the NSW Government for health worker housing and accommodation in the Hunter and Western NSW, and extends the overall funding package to more than \$75 million in total.

- * 8477 EDUCATION AND EARLY LEARNING—HEALTH ADVICE IN SCHOOLS—The Hon. Mark Latham to ask the Minister for Education and Early Learning—
 - (1) I refer the Minister to the statement by Premier Perrottet at the Committee for Economic Development of Australia (CEDA) on 25 February when the Premier said in relation to RAT surveillance testing in schools, "Health completely disagreed with this approach by the way, they didn't want it":
 - (a) Did the Department of Education reject the health advice?
 - (i) If so, for what reason?
 - (b) What other health advice has the Department of Education rejected in relation to COVID-19 in schools?

(c) Why has the Department of Education accepted health advice for Vaccination Mandates when these have aggravated critical teacher shortages in Government schools, with at least 7000 teachers fired or stood down?

Answer-

The Department of Education works closely with NSW Health and follows expert health advice, including from the Australian Health Protection Principal Committee and the Doherty Institute.

Modelling by the Doherty Institute presented to National Cabinet on 5 November 2021 noted that in areas with high levels of ongoing transmission, "incursions into school settings will be inevitable" and "surveillance testing substantially reduces the risk that incursions will lead to outbreaks".

This advice informed the NSW Government approach to surveillance testing programs in schools and early childhood education services during Term 1 2022. The Victorian Government, as well as other states and territories, adopted a similar approach.

Since 8 November 2021, it has been a requirement under the Public Health (COVID-19 Vaccination of Education and Care Workers) Order that employees who work in schools or early childhood education are only able to do so if they are fully vaccinated or hold a valid medical contraindication certificate.

The Department's position on vaccination is based on NSW Health advice, informed by the Australian Technical Advisory Group on Immunisation (ATAGI). The latest advice is that keeping COVID-19 vaccination up-to-date provides the best protection against the virus, including reducing the risk of severe disease and hospitalisation.

The assertion that 7000 teachers have been "fired or stood down" as a result of the vaccination mandate is completely false.

- * 8478 EDUCATION AND EARLY LEARNING—PENNANT HILLS HIGH SCHOOL—The Hon. Mark Latham to ask the Minister for Education and Early Learning—
 - (1) Why have year 8 students at Pennant Hills High School been asked to complete a health class assignment on Black Lives Matter (BLM) and HeForShe?
 - (2) Does the Minister regard BLM as an American leftist political body suitable for PDHPE studies in New South Wales, especially given its stated commitment to defunding police, abolishing the nuclear family and encouraging street protests, rioting and looting?
 - (3) Will the Government update its Controversial Issues in Schools policy to declare BLM as controversial, requiring parental permission for school studies?
 - (4) What have the parents at Pennant Hills High said about the study of BLM?
 - (5) Why wasn't Australian content on health issues chosen for the health class?
 - (6) Why is Pennant Hills High running political classes for Year 8 under the cover of PDHPE?

Answer-

The Year 8 unit of study is titled "Welcoming Difference". The two groups referred to are significant contemporary examples of challenges in inclusivity, equality and respectful relationships. The NESA Syllabus Outcomes addressed during this task include:

- PD4-3 Investigates effective strategies to promote inclusivity, equality and respectful relationships.
- PD4-10 Applies and refines interpersonal skills to assist themselves and others to interact respectfully and promote inclusion in a variety of groups or contexts.
- PD4-3 Investigates effective Strategies to promote inclusivity, equality and respectful relationships.

Australian content is the primary focus that is delivered as part of the unit of work. Lesson 2 is a detailed Case Study of the 'Close the Gap Campaign' providing an Aboriginal perspective that is also a mandatory requirement of all syllabuses.

This unit was presented to classes in 2021, refined as part of the usual teacher reflection process, and offered again in 2022. There have not been any comments or complaints to the school regarding the content of the unit of work or the assessment task.

The study of controversial issues is acceptable for educational purposes, consistent with the syllabus, and the approach taken by teachers is sensitive, objective and balanced.

The Controversial Issues in School policy, and associated procedures, has recently been reviewed and will be released later in the year.
