    - (a) What are the "other hospitals" referred to in the New South Wales Mothers and Babies Report 2020?
    - (b) How many births occurred in each of the hospitals defined as "other hospitals"?

#### Answer-

(1)

(a-b) Detailed information on maternity care and perinatal outcomes is reported for individual hospitals by maternity service level for facilities where at least 200 mothers gave birth in 2020.

I am advised that hospitals with fewer than 200 births are reported as "other hospitals" to reduce the risk of individual patients being identified when presenting detailed information on the specific aspects of maternity care and perinatal outcome.

Answer-

The Principal manages any complaints raised by parents, carers, students, members of the community and staff using the Department of Education's Complaint Handling Policy and Procedures.

I am aware of one local MP representation in 2021 on behalf on the school's P&C regarding a request for an offsite classroom for disengaged students.

In my response to this representation, I noted the school currently operates a Wellbeing Centre that provides, encourages and supports community wellbeing services to ensure that all students are holistically supported throughout their educational journey at the school. The work of the centre closely aligns with the Department's Wellbeing Framework for Schools, which is committed to supporting students connect, succeed and thrive at every stage of their development and learning.

The school also runs a learning space (Hub) that provides targeted and intensive support to students with a strong focus on emotional regulation and increasing each student's capacity to positively engage in learning. Staff who work in the Hub work closely with the teaching and wellbeing teams, parents, carers and interagency personnel to support students with their learning and wellbeing.

I understand senior officers from the Department have followed up with the Principal regarding the videos. The school managed the incidents in the videos consistent with the School's Discipline Policy. Appropriate disciplinary action and wellbeing support was promptly applied. There have been no further incidents reported related to these matters.
