- \* 1185 TRANSPORT—TRAINLINK COACHES AND TRAINS ACCESSIBILITY—Ms Abigail Boyd to ask the Special Minister of State, Minister for Roads, Minister for the Arts, Minister for Music and the Night-time Economy, and Minister for Jobs and Tourism representing the Minister for Transport—
  - (1) Can the Minister advise, how many TrainLink trains are fully accessible to date?
  - (2) How many TrainLink coaches are fully accessible to date?
  - (3) What are the specific accessibility requirements for TrainLink trains?
    - (a) What are the specific accessibility requirements for TrainLink coaches?
  - (4) Can the Minister advise if there are plans to roll out an accessibility program to upgrade or replace inaccessible Trainlink trains?
    - (a) Are there plans to roll out an accessibility program to upgrade or replace inaccessible TrainLink coaches?

#### Answer-

- (1) All NSW TrainLink electric and diesel intercity trains are fully accessible. The XPT and Xplorer trains are accessible via a ramp for passengers with limited mobility.
- (2) All NSW TrainLink coaches are installed with wheelchair lifts to assist passengers with limited mobility.
- (3) NSW TrainLink regional trains have limited accessibility. NSW TrainLink staff are available to assist passengers at the time of booking to identify whether their accessibility needs can be accommodated. The NSW Government Regional Rail project is replacing the current XPT, XPLORER and Endeavour fleet with 29 safer, comfortable and more accessible trains.
  - (a) All NSW TrainLink timetabled full-size coaches and minibuses are fitted with wheelchair lifts to provide enhanced accessibility for passengers.
- (4) Transport for NSW is replacing the ageing NSW regional rail fleet of XPT, XPLORER and Endeavour trains. The new trains will provide improved safety, accessibility, facilities and reliability for passengers who travel from many NSW regional centres to Sydney, as well as Canberra, Melbourne and Brisbane.

The new regional fleet is being designed to be accessible and inclusive for all passengers and compliant with the Disability Standards for Accessible Public Transport (DSAPT).

The new trains will have modern and accessible features such as single-deck carriages, wider doors than the current fleet, charging points for mobile devices, real-time, internal and external visual displays and announcements, priority/accessible seats, accessible toilets and spaces for passengers using mobility aids.

Transport for NSW is also delivering the Mariyung Fleet which has been designed to comply with the DSAPT and has involved consultation with various stakeholders throughout the design process, including the Accessible Transport Advisory Committee.

The Mariyung Fleet is the most accessible and inclusive double deck train fleet in NSW, with accessible toilets, wheelchair access and priority seating, and dedicated accessible spaces located close to doors, windows and amenities. V-Set trains were designed before the DSAPT came into effect in 2002.

(a) NSW TrainLink is considering accessibility as part of future commercial negotiations with coach operators. All NSW TrainLink coaches are installed with wheelchair lifts to assist customers with limited mobility.

#### Answer—

(1)

(a) Inmates must be sentenced. Applications from inmates are assessed on a case-by-case basis.

Universities and other tertiary institutions often use online assessments, online peer discussion forums and internet-based research. These online requirements pose security challenges that mean that all requests to participate in university studies cannot be facilitated by correctional centres.

(b)

- (i) The range of education programs available at correctional centres is impacted by the role and function of a centre and available staff resources.
- (ii) In order to reduce the risk of recidivism, Corrective Services prioritises offenders who have the highest risk of reoffending and identified need for education programs. An inmate's earliest possible release date will also impact on the prioritisation, timing, and placement in an education program.
- (2) Yes.
  - (a) Inmates must be sentenced. Applications from inmates are assessed on a case by case basis. The majority of vocational programs are delivered face to face by TAFE and other providers, given the practical nature of the courses delivered, together with paper based training and assessment materials.

(b)

(i) CSNSW has a broad range of vocational programs, traineeships, apprenticeships, literacy and numeracy and digital literacy programs. There are some centres where the full range of education and training services are not offered or are limited, due to the role and function of the centre and nature of the vocational courses.

- (ii) In order to reduce the risk of recidivism, Corrective Services prioritises offenders who have the highest risk of reoffending and identified need for education programs. An inmate's earliest possible release date will also impact on the prioritisation, timing, and placement in an education program.
- (3) Libraries are located in all correctional centres with inmates afforded regular access to materials.
