- (5) How much is allocated in any budget for civil claims against police for the year 2023-2024?
 - iCare (the NSW Government insurer) have provided the NSW Police Force with an estimate based on civil litigation claims reported between 1 July 2023 and 8 November 2023, this estimate is \$13, 008, 231.91. This amount will increase as further claims are received.
 - The NSW Police Force have been advised by iCare that a forecast estimate of future liability claims against the NSW Police Force for civil litigation is not available. iCare, as the Government insurer, provides policies to Treasury Managed Fund agencies and specified covered individuals for a range of liabilities and a discrete breakdown cannot be provided for civil litigation liabilities only.

- * 1402 PREMIER—THE VOICE AND GOVERNMENT EMPLOYEES—The Hon. Tania Mihailuk to ask the Minister for Climate Change, Minister for Energy, Minister for the Environment, and Minister for Heritage representing the Premier—
 - 1) Can the Minister assure government employees who voted 'No' at the referendum, that they will not suffer any repercussions in their workplace?

Answer—

While the NSW Government supported a 'Yes' vote in the referendum on an Indigenous Voice to Parliament, the Government respects the result and the decision of the people of NSW.

The way in which government sector employees voted at the referendum is a personal matter with no bearing on how they are treated in the workplace.

All government sector employees are expected to comply with the core values expressed in the *Government Sector Employment Act 2013* and the Code of Ethics and Conduct for NSW government sector employees.

- * 1403 CLIMATE CHANGE—VOICE TO THE NSW PARLIAMENT—The Hon. Tania Mihailuk to ask the Minister for Climate Change, Minister for Energy, Minister for the Environment, and Minister for Heritage—
 - (1) On the 14th of October, New South Wales voted to overwhelmingly reject The Voice to Parliament, with the latest count of the 'No' vote at of over 60 percent, will the Government respect the decision

of the New South Wales voters, who resoundingly rejected the Voice to Parliament, and rule out legislating a Voice to the New South Wales Parliament?

Answer—

The NSW Government has consistently stated that our commitment is to undertake consultation to determine whether Aboriginal communities in New South Wales prefer a Treaty or agreement-making process, and if an agreement-making process is preferred, what that process would look like. The Government is committed to not pre-empting the outcome of a conversation about Treaty.

Speculating on the content or timing of the consultation process is premature and not in keeping with the commitment for the process to be shaped by Aboriginal people and their aspirations.

- * 1404 ABORIGINAL AFFAIRS AND TREATY—TREATY LISTENING TOUR—The Hon. Tania Mihailuk to ask the Special Minister of State, Minister for Roads, Minister for the Arts, Minister for Music and the Night-time Economy, and Minister for Jobs and Tourism representing the Minister for Aboriginal Affairs and Treaty, Minister for Gaming and Racing, Minister for Veterans, Minister for Medical Research, and Minister for the Central Coast—
 - (1) The Government has announced \$5 million has been allocated for a year long "listening tour" asking Indigenous communities about a treaty, please provide an update on how the consultation is being undertaken including:
 - (a) locations,
 - (b) times, and
 - (c) dates of the community consultations?
 - (2) Specify which entities, organisations and individuals are receiving a share of the \$5 million for the listening tour?

Answer-

I am advised:

- (1) Consultation has not commenced, nor have locations, times or dates been set.
- (2) The \$5 million committed to support the consultation process has not been allocated as the consultation process has not been finalised.
- * 1405 LOCAL GOVERNMENT—WRAN LEISURE AQUATIC CENTRE—The Hon. Tania Mihailuk to ask the Minister for Agriculture, Minister for Regional New South Wales, and Minister for Western New South Wales representing the Minister for Local Government—
 - (1) The Wran Leisure Centre is now planned for closure, however construction for the replacement community centre has not begun, which will deprive local residents, including many elderly and social housing tenants of the only publicly available recreational facility in the area, why is the Council closing the Wran Leisure & Aquatic Centre prior to the construction of the Community Centre at Thurina Park, given it is planned for another section of the Park?
 - (2) Will the Government intervene and stop the Council from depriving local residents of the only publicly available facility in the area?

Answer—

This is a matter for Canterbury-Bankstown Council to determine in consultation with the local community.
