* 3498 CORRESPONDENCE REGARDING RESURFACING PROJECT - MONA VALE ROAD—Mr Rory Amon to ask the Minister for Transport representing the Special Minister of State, Minister for Roads, Minister for the Arts, Minister for Music and the Night-time Economy, and Minister for Jobs and Tourism—

On 7 August 2024, the Parliamentary Secretary for Roads, Ms Anna Watson MP sent a letter to the Member for Pittwater (Ministerial Correspondence – TfNSW ref: 02148237) advising that ConnectSydney was undertaking a 'resurfacing project along Mona Vale Road in August 2024':

- (1) Could the Minister please provide further details of this resurfacing project, including:
 - (a) What precise sections of the road will be resurfaced?
 - (b) What is the nature of the resurfacing works?
 - (c) Will it be repairs of potholes only or more comprehensive works?

ConnectSydney is currently resurfacing sections of Mona Vale Road between Richmond Avenue and the St Ives Showground. Local residents have been notified of these works, which are expected to be completed by 29 September 2024.

Works will be undertaken on large sections of pavement in the westbound lanes only and will include removing and replacing sections of asphalt to create a smoother and safer road surface.

- * 3506 WATER SAMPLES BEACH WATCH TESTING STATIONS—Mr Rory Amon to ask the Minister for Customer Service and Digital Government, Minister for Emergency Services, and Minister for Youth Justice representing the Minister for Climate Change, Minister for Energy, Minister for the Environment, and Minister for Heritage—

- (2) The most recent water samples were taken from Pittwater swim sites on 7 August 2024 and tested for bacteria (enterococci). All swim sites recorded low bacteria counts (colony forming units per 100 millilitres) and were identified as suitable for swimming:

The Department of Education's Code of Conduct and the 'Child Protection: Responding to and Reporting Students at Risk of Harm' policy and procedures. They are available in the department's policy library at: https://education.nsw.gov.au/policy-library

All department staff, and non-department staff working in education settings, are required to complete annual child protection training. Staff are taught how to recognise the indicators and factors of abuse, how to respond to ensure the safety of all students and how to appropriately report these concerns.

The department's Professional and Ethical Standards Directorate (PES) provides significant training and support to employees, in particular principals and workplace managers, in relation to the reporting of allegations of employee misconduct involving child protection concerns.

PES is responsible for the investigation of allegations of employee misconduct. The Office of the Children's Guardian administers, oversights and audits PES investigations into allegations made about employees that are reportable under the Children's Guardian Act 2019.

In the period 1 January to 31 December 2023 PES progressed 247 allegations of reportable conduct for investigation. In the period 1 January to 30 June 2024 PES progressed 100 allegations of reportable conduct for investigation.

Reportable conduct includes a sexual offence, sexual misconduct, ill-treatment or neglect of a child, assault against a child, failure to protect or failure to report offences under the Crimes Act 1900 and behaviour that causes significant emotional or psychological harm to a child.

* 3517 PERSONALISED NUMBER PLATES—Mr Matt Cross to ask the Minister for Transport representing the Special Minister of State, Minister for Roads, Minister for the Arts, Minister for Music and the Night-time Economy, and Minister for Jobs and Tourism—

In relation to personalised number plates:

- (1) What defines / determines personal plates?
- (2) When were personal plates introduced?
- (3) Are there individuals who owned a plate before personal plates were introduced, that now have a plate considered to be a personal plates?
 - (a) If yes, do these individuals need to pay for personal plates?

I am advised

- (1) Personalised Plates are plates where the content is selected by the customer from a defined syntax within a certain range set by Transport for NSW.
- (2) 1969.

- (3) Plates issued prior to 2000 do not attract an annual fee unless the plate has changed hands and the recipient is not exempt (direct family member) or the customers lose their Special Number Plate rights due to non-renewal.
- * 3518 BIODIVERSITY CONSERVATION ACT 2016—Mr Matt Cross to ask the Minister for Customer Service and Digital Government, Minister for Emergency Services, and Minister for Youth Justice representing the Minister for Climate Change, Minister for Energy, Minister for the Environment, and Minister for Heritage—

In relation to the Biodiversity Conservation Act 2016:

(1) Are there any plans to expand power to local governments / councils for enforcement in relation to Section 13.29, "Responsibility of landholder for activities carried out on the land"?

Answer-

(1) At present, there are no specific reform proposals relating to enforcement of Section 13.29 of the Biodiversity Conservation Act 2016 (BC Act).

As indicated in the NSW Plan for Nature, the NSW Government is committed to amending and strengthening the BC Act. This will include consideration of enhancements to compliance and enforcement powers and penalties.

The Government is considering the scope and timing for reforms to the BC Act. Stakeholders, including local councils and landholders, will be consulted as part of determining proposed amendments.

- * 3519 ILLEGAL POISONING OF TREES IN KILLARA—Mr Matt Cross to ask the Minister for Customer Service and Digital Government, Minister for Emergency Services, and Minister for Youth Justice representing the Minister for Climate Change, Minister for Energy, Minister for the Environment, and Minister for Heritage—

- (1) On 10 July 2024, the Department of Climate Change, Energy, the Environment and Water (DCCEEW) received a report that trees that are part of Blue Gum High Forest had allegedly been poisoned at 14-16 Buckingham Road in Killara. Blue Gum High Forest is listed under the Biodiversity Conservation Act 2016 as a critically endangered ecological community.
 - (a) This matter is currently under investigation. The DCCEEW Compliance Policy and prioritisation procedures are applied to these matters and the investigation is completed as appropriate. No further information can be provided at this stage.
- * 3520 GIPA APPLICATION FUND PROCESSING—Mr Matt Cross to ask the Premier—

In relation to the Government Information (Public Access) (GIPA) Act:

Health services are not provided on an electorate basis.

BreastScreen NSW provides free breast cancer screening mammograms to asymptomatic women over 40 years of age, including for women who use hormone replacement therapy. Permanent clinics and mobile vans provide the service at more than 250 locations across NSW.

Ongoing care and treatment of women with breast cancer is not part of the BreastScreen NSW program. The patient's specialist will arrange any imaging services needed, such as surveillance mammograms or ultrasounds.

Clients can return to BreastScreen for ongoing mammograms 5 years after a cancer diagnosis if cleared by their specialist.

* 3528 ACCESS TO MEDICAL TREATMENT—Mrs Helen Dalton to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast—

With respect to the Griffith Base Hospital:

I'm advised:

The NSW Statewide Severe Burn Injury Service provides clinical guidance and virtual care services for local management of appropriate burns patients by clinicians at Griffith Base Hospital. Patients requiring specialised burns treatment are referred to Concord Repatriation General Hospital or the Children's Hospital at Westmead.

The \$250 million Griffith Base Hospital redevelopment will support the delivery of a specialist orthopaedic service to the Griffith region, including access to surgery and a multi-disciplinary fracture clinic. The new Clinical Services Building is due for completion in 2025. Major and complex trauma patients will continue to be initially referred to the designated trauma centre at Wagga Wagga Base Hospital.

- * 3529 STUDENT SUPPORT OFFICERS—Mrs Helen Dalton to ask the Deputy Premier, Minister for Education and Early Learning, and Minister for Western Sydney—
 - (1) Given the essential role that Student Support Officers play in supporting students' academic and emotional well-being across New South Wales, what measures is the Minister taking to ensure continued investment in these positions to meet the growing needs of students?

There are more than 2,000 wellbeing roles in NSW public schools, including school psychologists, school counsellors, student support officers, wellbeing nurse coordinators and school chaplains/wellbeing officers.

The department also has a School Counselling and Telepsychology Rural and Remote Schools team of senior psychologists education providing support to students and schools in rural and remote areas through a combination of in-person and telepsychology services.

- * 3530 WENTWORTH POINT HIGH SCHOOL—Ms Stephanie Di Pasqua to ask the Deputy Premier, Minister for Education and Early Learning, and Minister for Western Sydney—

The NSW Government has invested an additional \$13 million to reduce the spread of feral pigs and other pests across NSW. This, along with the services provided by LLS, such as landholder education, have seen successful results in invasive pest management.

The project scope was revised due to the global escalation of building costs within the construction industry. The updated design delivers on current clinical and support priority areas and provides a development zone to allow a staged approach to deliver the full master plan, pending future additional funding.

- (2) The DoE as CLM requires consent from the Minister for Lands and Property to enter into any agreement longer than 12 months.

I'm advised:

Health services are not provided on the basis of electorate or local government area. NSW Health does not centrally collect vacancy rates for positions and is unable to provide the average nursing vacancy rate.

The Rural Health Workforce Incentive Scheme (RHWIS) enables participating health organisations to offer incentives and benefits at rural and remote locations with hard-to-fill and critical vacancies. Incentive packages of up to \$20,000 can be provided to those willing to relocate and work in these positions. Incentives and benefits include an additional rural and regional health allowance, accommodation assistance, relocation benefits, travel assistance, and ongoing professional development.

The Whole of Health Nursing Agency Panel arrangement will go live in September 2024. This contract arrangement gives all health organisations access to a range of appropriate nursing agencies that have fixed pre negotiated fees. Health organisations can access any of the approved nursing agencies on the panel arrangement to assist with filling their short-term staffing vacancies.

The NSW Health Deployment Program provides nurses, midwives and allied health professionals to fill short-term vacancies across regional, rural and remote NSW for 2 to 13 weeks. Health organisations can use the NSW Health Deployment Program as a temporary measure to fill staffing vacancies as a priority while recruitment is underway.

* 3542 PROPOSED DAM SAFETY LEVY—Mr Brendan Moylan to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast representing the Minister for Water, Minister for Housing, Minister for Homelessness, Minister for Mental Health, Minister for Youth, and Minister for the North Coast—

- (1) What steps are you undertaking to ensure that rural and regional hospitals receive an adequate supply of IV fluids during the current shortage?
- (2) How can you ensure an equitable distribution of these fluids, so that regional hospitals don't miss out?

Answer—

I'm advised:

NSW Health is taking all possible steps to minimise any potential disruptions to our services and patients caused by the intravenous (IV) fluid supply issues including:

- Monitoring existing stock at facilities throughout its highly networked health system via twice weekly audits.
- Centralising supply and distribution of available stock of highly impacted products to ensure equitable access amongst all facilities this includes metropolitan, rural and regional facilities.
- Establishment of Intravenous Fluids Stewardship Groups across NSW Health facilities including those in rural and regional areas to act as the central, local resource of expertise on IV fluids, their management and conservation during this disruption to supply.
- Provision of state-level recommendations to ensure conservation of supply and equity of access.

At this stage, every facility has equitable access to the IV fluids they require to continue to provide safe patient care with clear escalation pathways in place should supply or clinical concerns arise.

- * 3544 FLOODING IN PRIVATE FARMLAND—Mr Brendan Moylan to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast representing the Minister for Water, Minister for Housing, Minister for Homelessness, Minister for Mental Health, Minister for Youth, and Minister for the North Coast—

The Gwydir Reconnecting Watercourse Country Program aims to address constraints to environmental flows in the Gwydir floodplain by implementing a range of measures designed and implemented in partnership with watercourse landholders and the broader community.

The NSW Department of Climate Change, Energy, the Environment and Water (DCCEEW) - Biodiversity Conservation & Science (BCS) is responsible for the Gwydir Reconnecting Watercourse Country Program. This is therefore a matter for the Hon Penny Sharpe, MLC, in her capacity as Minister for the Environment.

Scabies is a skin condition that is prevalent in the community. In line with NSW Health infection management and control protocols, Illawarra Shoalhaven Local Health District took immediate action when a case of scabies was identified in a patient at Wollongong Hospital on 22 July 2024. An initial outbreak management meeting was held on 25 July 2024.

Following the identification of multiple cases, on 26 July 2024 the District provided advice to Ministry of Health staff, who subsequently advised the Minister's Office.

The District escalated its response when it identified cases had spread to additional wards on 1 August 2024. As part of the outbreak response, the District rolled out a comprehensive plan to inform key stakeholder groups including staff, health support services, primary care and aged care networks. The District also provided regular media updates.

The EPA is continually updating IFOAs to protect newly listed and at-risk species and ecosystems.

Destination NSW has offered some live streaming for Vivid Sydney events since 2022, with the First Light event and drone shows live streamed to domestic and international audiences.

As an election commitment, the NSW Government committed \$450,000 over four years to fund Get Skilled Access to enhance accessibility and disability inclusion knowledge within the tourism sector. Destination NSW is delivering this commitment and collaborating with Get Skilled Access to enhance accessibility and disability inclusion knowledge within the visitor economy.

Vivid Sydney:

Destination NSW proudly supported the Hidden Disability Sunflower during Vivid Sydney 2024. Festival and event staff were trained to identify and support attendees wearing the Hidden Disability Sunflower lanyard or wristband ensuring an inclusive experience for attendees.

The Vivid Sydney website provides information for attendees about accessibility services and facilities at the festival. Additionally, festival staff and volunteers are trained to provide information and assistance to attendees with access needs.

In 2024, in consultation with Autism Spectrum Australia, Vivid Sydney created an Accessibility Toolkit and Visual Story to make it easier for people to plan their visit. This provided specific information on accessibility. The Visual Story for Vivid Sydney 2024:

I am advised:

- (1) Scientific evidence published by the Commonwealth Scientific and Industrial Research Organisation (CSIRO) and academics, along with the experience of fire services, point to hazard reduction burns as an effective method of controlling fuel loadings.
- (2) The target for hazard reduction in 2023/24 was 324,609ha (306,415ha from burning and 18,194ha from mechanical works).
 - Each Bush Fire Management Committee (BFMC) develops a Bush Fire Risk Management Plan (BFRMP), which includes hazard reduction plans, for its relevant geographic area. The BFRMP is a strategic document that identifies community assets and values that may be at risk from bush fire and identifies coordinated multi-agency objectives and associated treatment strategies to reduce the risk over a five-year period.
- (3) Unsuitable weather conditions again impacted hazard reduction work in 2023/24. Despite this, fire services and land managers treated 139,927ha, offering protection to 129,711 properties. Work not completed in 2023/24 will be carried into 2024/25.
- (4) The RFS has a long history of working with the scientific community to better understand the complexities of fire behaviour and fuel management, including the CSIRO and a long-standing collaboration with the University of Wollongong.
 - The NSW Bushfire and Natural Hazards Research Centre was established in response to a recommendation of the NSW Bushfire Inquiry, and is a research consortium led by the Hawkesbury Institute for the Environment at Western Sydney University, in partnership with the University of NSW, University of Wollongong, Australian National University, University of Melbourne and University of Tasmania.
 - The work of the Natural Hazards Research Australia and its predecessors the Bushfire and Natural Hazards Cooperative Research Centre also inform bush fire protection works.

All local resources are supplemented by specialist police (highway patrol, major crime squads, covert resources), which are managed centrally but can be deployed across boundaries to meet changing community needs and respond to crime patterns and emerging issues.
