* 3847 PROCEEDS OF CRIME ACQUIRED BY EDDIE OBEID—The Hon. Leslie Williams to ask the Minister for Police and Counter-terrorism, and Minister for the Hunter—

- (1) What action has been taken since the NSW Crime Commissioner committed in 2021 to revisiting its investigation into the confiscation of the proceeds of crime acquired by Eddie Obeid and his family?
- (2) What is the current estimated value of those proceeds of crime?
- (3) Will the Government, with advice from the NSW Crime Commissioner, consider special legislation to recover those proceeds of crime?

Answer—

I am advised:

- (1 - 2) This matter remains under investigation by the NSW Crime Commission. An outcome is anticipated in early 2025.
- (3) The Criminal Assets Recovery Act 1990 enables proceeds of serious crime related activities to be recovered.

3848 ANIMAL WELFARE GRANT—Mr Roy Butler to ask the Minister for Skills, TAFE and Tertiary Education representing the Minister for Agriculture, Minister for Regional New South Wales, and Minister for Western New South Wales—

* 3849 CLINICAL EARLY INTERVENTION ASSESSMENTS FOR 4-5 YEAR OLDS—Mr Roy Butler to ask the Deputy Premier, Minister for Education and Early Learning, and Minister for Western Sydney—

Can the Minister advise of the availability and regularity of access of clinical early intervention assessments for 4- and 5-year-olds in the Barwon electorate?

Answer—

The Health and Development Checks in Early Childhood Education and Care (ECEC) program is a partnership between the Department of Education and NSW Health to bring free 4-year-old Health and Development Checks to preschool and long day care services. This is a free opt-in program. The program is currently available in the Far West and Western NSW Local Health Districts, which cover the Barwon electorate.

To support participation of ECEC services in the program in 2024, the Department of Education offered a one-off Health and Development Participation Grant worth \$7,500.

58 ECEC services, including Aboriginal Community Controlled Organisations, from the Far West and Western NSW local health district have received this grant funding in 2024. Of these 58 services, 14 are located in the Barwon electorate.

Answer—

I am advised that:

Fire and Rescue NSW (FRNSW) has a network of 29 aerial appliances across the state to provide appropriate fire response to all areas. In line with standard operational practices, FRNSW relocates appliances within its fleet to maintain medium and high-rise rescue and firefighting capability across the state. Aerial platforms are not permanently allocated to stations under fleet replacement or other or other capital works programs.

- * 3851 DIABETES CLINICAL SERVICES IN COWRA—Ms Steph Cooke to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast—

With respect to increased demand for Diabetes Clinical services in Cowra:

- (1) Will the Minister please advise the actions being taken to ensure that residents of Cowra and surrounding towns are not waiting for years for basic clinical diabetes services, such as insulin pump starts and glucose monitoring?
- (2) Will the Minister please confirm if the Care Partnership available through Western NSW Diabetes Hub is only available for Type 2 Diabetics?
- (a) If so why?

Answer—

I'm advised:

Diabetes care is traditionally managed by general practitioners, who may refer some patients to endocrinologists, diabetes educators, dieticians and other health professionals. Some of these professionals are available locally, some are virtual, and others will require patients to travel to larger centres, such as Orange.

The recently established Care Partnership - Diabetes program aims to improve patient access to clinical diabetes services in Western NSW. It works with the Cowra Health Service and local general practitioners to determine how it can complement local services, increase access to diabetes services, and support the workforce to provide high quality diabetes care.

The Care Partnership - Diabetes program is specifically designed to improve health outcomes for people living with Type 2 diabetes in the Far West and Western NSW local health districts, in response to their significantly high rates of Type 2 diabetes.

People living with Type 1 diabetes and gestational diabetes are managed through traditional service providers including general practitioners, endocrinologists, obstetricians and other healthcare professionals.

- * 3852 COOTAMUNDRA PATHOLOGY—Ms Steph Cooke to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast—

With respect to Cootamundra Pathology:

- (1) Would the Minister please advise if the Government is closing this diagnostic service?
 - (a) Why?
- (2) Would the Minister please advise what criteria is met to close a diagnostic service?
- (3) Would the Minister please advise when will this close come into effect?

Answer—

I'm advised:

No decision has been made to close the Cootamundra Pathology Department.

NSW Health Pathology is consulting with local clinical teams, hospital and pathology staff and community members to explore the feasibility of a regional networked service model for the Cootamundra and Young region.

The consultation will continue throughout October and November 2024.

- 3853 SUPPORTING REGIONAL COMMUNITIES—Ms Steph Cooke to ask the Minister for Skills, TAFE and Tertiary Education representing the Minister for Agriculture, Minister for Regional New South Wales, and Minister for Western New South Wales—

- * 3854 JUGIONG POLICE OFFICERS RESIDENCE—Ms Steph Cooke to ask the Minister for Police and Counter-terrorism, and Minister for the Hunter—

With respect to The Jugiong Police Officers Residence:

- (1) Will the Minister please advise the timeline of the restoration of the Jugiong Police Officers Residence?
- (2) Will the Minister please confirm if the moving of the Jugiong Police Officer to Yass will affect the Policing presence in Jugiong?
- (3) Will the Minister please confirm that once the restoration of the Police Officer Residence is complete, the presiding officer for Jugiong will be returned to Jugiong and not stay in Yass permanently?

Answer—

I am advised:

- (1) This property was vested to Property and Development NSW. Questions relating to the restoration of the residence are a matter for Property and Development NSW and fall within the portfolio responsibilities of the Minister for Small Business, Minister for Lands and Property, Minister for Multiculturalism and Minister for Sport.
- (2) Police presence will be retained in the Jugiong area with the Jugiong officer continuing to provide a policing service, supported by police from Yass and specialist police such as highway patrol, and

other police district resources, which can be deployed across boundaries to meet changing community needs and respond to crime patterns and emerging issues in the area.

- (3) It is anticipated that the officer will return to Jugiong on completion of the works.

* 3855 PALLIATIVE CARE NURSES—Ms Steph Cooke to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast—

With respect to Palliative Care Nurses in regional New South Wales:

- (1) Would the Minister please advise how many Palliative Care Nurses are based across the following health Districts?
- (a) Murrumbidgee Local Health District?
- (b) Western Local Health District?
- (2) Would the Minister please advise what areas/locations do these Nurses cover?
- (a) and how much work time is allocated to each area?
- (3) Would the Minister please advise how many patients are currently in palliative care across the following areas?
- (a) Murrumbidgee Local Health District?
- (b) Western Local Health District?
- (4) Would the Minister please advise how is the Government supporting additional Palliative Care Nurses for regional New South Wales?

Answer—

I'm advised:

- (1) Murrumbidgee Local Health District - There are 21.5 FTE palliative care nurses - an increase of 10 FTE since 2019. They are supported by community nurses across the District.
- Western NSW Local Health District - The nursing workforce for the District-wide Specialist Palliative Care Service is 30.45 FTE - an increase of 13 FTE since 2019.
- (2) Murrumbidgee Local Health District - A District-wide service has been established with workforce clusters in Wagga Wagga, Griffith, West Wyalong, Cootamundra, Deniliquin, Tocumwal, Tumut and Corowa.
- Western NSW Local Health District - End of life and palliative care is provided through inpatient facilities, residential aged care facilities and in the community, including in people's homes. Palliative care is provided by a range of nursing roles, including specialist palliative care nurses. Specialist palliative care nurses are located in 5 main multidisciplinary hub teams, based in Bathurst, Dubbo, Orange, Mudgee, Parkes/Forbes (Lachlan), with satellite nursing positions based at Cowra and Lightning Ridge.
- For Murrumbidgee and Western NSW local health districts, the time spent providing care across the different sites is based on need and demand and would fluctuate significantly depending on patient referrals.
- (3) At 24 October 2024, Murrumbidgee Local Health District had 123 registered palliative care clients, and there were 399 registered in Western NSW Local Health District.
- (4) NSW Health has allocated additional funding over 5 years (2022-23 to 2026-27) to enhance the workforce for end of life and palliative care in NSW.

The World Class End of Life Care funding commitment (2022-23 to 2026-27) is helping local health districts and specialty health networks to employ extra nurses, allied health professionals, doctors and support staff. Districts are recruiting professions relevant to local needs and models of care.

This is estimated at more than 570 FTE across NSW by 2026-27. NSW Health supports locally relevant models of care. Provision of palliative care in regional and remote areas requires flexible use of resources and infrastructure to meet a broad range of needs. The NSW End of Life and Palliative Care Framework (2019-2024) prioritises equitable access to quality care. This includes the use of alternative care models to provide services in rural and remote areas. For example, non-clinical home packages, loan equipment and appropriate use of virtual care services.

* 3856 NSW SHERIFFS STRIKE ACTION—Ms Steph Cooke to ask the Attorney General—

With respect to NSW Sheriffs in regional New South Wales:

- (1) Would the Attorney General please advise how many times have court houses across the Cootamundra electorate been closed as a result of strike action from Sheriffs?
- (2) Would the Attorney General please advise how many court cases across the Cootamundra electorate were affected as a result of this strike action?
- (3) Would the Attorney General please advise what is the Government doing to ensure the impacts of these strikes do not have a profoundly negative impact of rural and regional areas?

Answer—

I am advised:

(1 - 3) Court houses were at periods required to close across several locations as a result of industrial action resulting in delays across the Cootamundra Electorate. The NSW Sheriff's Office worked with rural and regional court houses to minimise the impacts of the industrial action where possible, including:

- Forecasting disruptions to help courts put in place plans around scheduling listings and to assess whether cases may be affected.
- Using private security contractors to support Sheriff's Officers to ensure service continuity.
- Moving all regional matters to being heard online via Audio-Visual Link.

The Public Service Association of NSW has since accepted an offer from the NSW Government.

From Monday, 21 October 2024, all industrial action was ceased across the state and normal operations resumed.

* 3857 INCREASED DEMAND ON RENTAL PROPERTIES—Ms Steph Cooke to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast representing the Minister for Water, Minister for Housing, Minister for Homelessness, Minister for Mental Health, Minister for Youth, and Minister for the North Coast—

- (2) Will the Minister please advise how long have these people been on a wait list?
- (3) Will the Minister please advise what action the Government is taking to support people unable to get into a rental?
- (4) Will the Minister please advise what is being done to support accommodation for workers in regional New South Wales areas?

Answer—

I am advised:

- (1 - 2) These are matters for the Hon. Anoulack Chanthivong, in his capacity as Minister for Better Regulation and Fair Trading.
- (3) Homes NSW offers a variety of private rental assistance to clients on the NSW Housing Register, including:
- Tenancy Facilitation - provides clients with information about how to search and apply for housing in the private rental market. This service is offered to people who need limited assistance and who have the capacity to sustain a tenancy but need additional help and information to navigate the private rental system.
 - Statement of satisfactory tenancy - if a former Homes NSW tenant has a satisfactory tenancy history, Homes NSW can provide a statement of satisfactory tenancy to help them secure private rental housing when they are leaving, or have left, public housing.
 - Private Rental Brokerage Service - assists clients by developing and enhancing their capacity to access the private rental market. Clients direct the process as much as possible, to build their confidence and skills.
 - Bond Extra - helps clients with a limited or poor tenancy history, to establish a private rental tenancy. It guarantees a grant of up to \$1,500 (including GST), payable to the landlord or real estate agent, if the tenant incurs rental arrears and/or damages to the property over and above the value of the rental bond.
 - Private Rental Subsidy - A medium-term subsidy to help approved applicants access affordable private rental accommodation while waiting for a suitable social housing property to become available. A Private Rental Subsidy aims to help clients in the greatest need, who have a disability and are at risk in their current accommodation.
 - Rent Choice - A private rental subsidy, that is gradually reduced over time (for up to 36 months). Clients may be eligible if they are escaping domestic and family violence, are a war veteran, or are a young person aged 16 - 24.
 - Rentstart Bond Loan - a loan, which is repayable to Homes NSW, to pay the bond for a new tenancy in the private rental market.
 - Advance Rent - provided to approved clients as a grant, not repayable to Homes NSW. Available for clients moving into accommodation such as caravan parks, registered boarding houses and hostels, where a deposit is required but there is no requirement for a bond to be lodged at the Rental Bond Board.
 - Tenancy Assistance - assistance to maintain a private tenancy through help with payment of rental or water arrears, or a combination of both. Paid as a grant and not repayable to Homes NSW.
 - Temporary Accommodation - provides short term accommodation in low cost motels, caravan parks or similar for clients who are homeless.

- (4) NSW Government agencies currently provide or incentivise housing for key workers such as teachers, police and health workers. For example, the NSW Government has around 1,300 teacher and 660 police homes across remote and regional parts of the state and has delivered 143 of 271 new teacher and police homes, planned to be in place by June 2026. The NSW Government has committed \$200.1 million for key health worker accommodation across rural and regional NSW. Approximately 500 health workers will benefit from this program in regional areas of the State. This commitment is part of the historic \$6.6 billion investment for Building Homes for NSW program.

Homes NSW is also working to improve the provision of key worker housing, which includes considering the types of workers served and the locations where housing is available.

- * 3858 SEVERE FROST EVENTS—Ms Steph Cooke to ask the Minister for Skills, TAFE and Tertiary Education representing the Minister for Agriculture, Minister for Regional New South Wales, and Minister for Western New South Wales—

With respect to the recent severe frost events:

- (1) Will the Minister please advise how many farming properties across the Cootamundra electorate have been affected and to what cost?
- (2) Will the Minister please advise what actions are being taken by the Government to ensure impacted farmers are being supported financially?
- (3) Will the Minister please advise what actions are being taken by the Government to work with the Commonwealth Government to ensure our agriculture industry has the best insurance protection available across all natural elements which can impact on their crops?

Answer—

- (1) I am advised a significant frost event across southern and central NSW, with temperatures down to minus five degrees Celsius (-5° C) has occurred at a critical time of crop development. Producers and their advisors are still assessing crops for potential yield loss and quality decline including the risk of 'pinched grain' and the exact number of paddocks affected in the Cootamundra Shire is not yet known.

Final crop losses will not be fully understood until the completion of the planned 2024 harvest. The extent of economic loss will also depend on capacity of individual growers to convert severely frost affected crops (no or little grain) into livestock income through grazing or conserving high quality fodder (hay or silage).

- (2) Under the NSW Disaster Assistance Guidelines 2021, frosts are not defined as Natural Disasters. The NSW Government is aware of the potential impact to a range of industries, not just broadacre cropping, and has been providing information to producers on managing affected crops through NSW DPIRD website.

Information on frost damage has been provided by NSW DPIRD Agriculture and Biosecurity, and LLS for affected producers.

The 'Feed Quality Service' (FQS) at Wagga Wagga Agricultural Institute (WWAI) has been receiving samples of crop for quality assessment from producers looking to make hay and silage.

The FQS has also been supplying information to producers as part of their on-going service based on years of data and high-quality science and research dating back to trials conducted in the 1990's on drought affected crops for hay and silage production.

I am advised that rainfall after the frost event across areas of southern NSW has benefited yield by allowing plants to compensate by producing grain on shoots unaffected by frost. Areas of southern NSW that received 20mm+ rainfall have experienced some recovery of potential yield in canola, wheat and barley.

- (3) In 2020 the National Farmers Federation delivered the On Farm Financial Risk Management Report which was funded by the NSW Government (<https://nff.org.au/programs/financial-risk-management/>). This report concluded that the costs associated with government intervention in the farm insurance market significantly outweighed the benefits.

I am advised the Commonwealth Scientific and Industrial Research Organisation (CSIRO) is currently undertaking research to develop the underpinning science for a yield-based index insurance product for wheat and potentially other crops.

The NSW Government is committed to supporting farmers manage their risk, and does so through investment in research and development, farmer education and developing tools which allow farmers to better manage climate risk.

NSW's farmers are also able to access concessional loans through the Rural Assistance Authority to support investment in infrastructure.

Answer—

I am advised:

- (1) The Key Worker Accommodation Program was funded in 2022/23 to deliver an additional 271 key worker homes over four years:

Teacher housing - total program: 221 homes with 114 homes delivered to date (FY23 and FY24)

Police housing - total program: 50 homes with 30 homes delivered to date (FY23 and FY24).

- (2) Of these properties:
- (a) 84 are currently tenanted by a Key Worker, as defined by the program.
- (b) One property is currently tenanted by someone other than a Key Worker, as defined by the program.
- (c) Key Worker housing properties (planned and existing) are distributed across NSW LGAs as follows: *

- (3) School principals and teachers and police officers are the specific professions that are eligible to access the Key Worker Program.

- (1) Feral deer are identified as a priority pest in the [North Coast Regional Strategic Animal Management Plan](#). Under the Biosecurity Act 2015, all land managers, on both private and public lands, have a general biosecurity duty to manage the impact of feral deer.

In the Hastings and Camden Haven areas, feral deer management is guided by the [Hastings Feral Deer Management Plan 2020-2024](#). This plan was established in 2020 by the Hastings Feral Deer Working Group, which is coordinated by Local Land Services. The Hastings Feral Deer Working Group consists of a range of stakeholders including North Coast Local Land Services, NSW National Parks and Wildlife Services, Forest Corporation NSW, Port Macquarie-Hastings Council and private land managers.

The Port Macquarie Hastings Feral Deer Plan is due to be updated by the working group in the new year, enabling a review and rescoping of feral deer management within the area.

- (2) All land managers have a responsibility under the Biosecurity Act 2015 to undertake and fund the cost of feral deer management on properties they manage. In the Port Macquarie and Camden Haven areas land managers fund most of the on-ground control action for feral deer.

Local Land Services provide advice and support to all land managers and coordinate cross tenure control programs to achieve greater success.

In addition, Local Land Services provides funding and assistance for wild deer trapping and for contractors to work on private lands. This is funded through Local Land Service rates and the Special Purpose Pest Management Fund.
