#### **13 SEPTEMBER 2016**

- \*3921 TAX-FREE PUBLIC TRANSPORT TRAVEL—Mr Alex Greenwich asked the Minister for Transport and Infrastructure—
  - (1) What assessment has the Government made of the value of the RemServ Queensland salary packaging benefit, which allows employees to salary package public transport travel to and from work, considering the ruling from the Australian Tax Office in favour of the benefit?
  - (2) What assessment has the Government made of a salary packaging scheme for employees travelling to and from work in New South Wales?
  - (3) Would such a scheme:
    - (a) Provide equal treatment for public transport users with private motor vehicle use?
    - (b) Reduce costs to passengers?
    - (c) Increase public transport use?
    - (d) Reduce traffic congestion around the CBD?
  - (4) What plans does the Government have to provide and encourage similar benefits in New South Wales?

#### Answer-

- (1) to (2) An assessment is currently underway.
- (3) (a) Matters relating to tax deductions are the responsibility of the Federal Government.
- (3) (b) to (d) This will be considered as part of the assessment currently underway.
- (4) It would be inappropriate to pre-empt the outcomes of the assessment.
- \*3922 EYE CLINIC AT JOHN HUNTER HOSPITAL—Ms Sonia Hornery asked the Minister for Health—
  - (1) What is the progress of the Eye Clinic at the John Hunter Hospital that has been closed for two years?
    - (a) When it will re-open?

#### Answer—

The John Hunter Hospital Eye Clinic provides services for patients with a range of complex conditions including corneal conditions, diabetic eye disease, significant eye infections, eyelid disorders, lesions and tumours, retinal disorders, uveitis and glaucoma.

Not all generalist services are provided by the hospital as some procedures are best provided in the primary setting through an optometrist, management by a GP, or at a specialised hospital such as the Sydney Eye Hospital. This approach ensures patients receive the care they need in the most appropriate setting.

The John Hunter Hospital Eye Clinic is now providing several additional services since it reopened, including:

- Laser for the treatment of diabetic eye disease, glaucoma treatment and posterior capsular opacity (post cataract surgery)
- Optical Coherence Tomography for diagnoses of retinal conditions
- B scan ultrasound to diagnose retinal conditions in the presence of dense cataracts
- · Auto refractor to diagnoses refractive errors, and
- Lens star to measure axial length prior to cataract surgery.
- \*3923 REGISTERED AGED CARE NURSES IN NEW SOUTH WALES—Ms Sonia Hornery asked the Minister for Health—
  - (1) What is the hourly rate for registered aged care nurses in New South Wales, as at September 2016?
  - (2) What is the hourly rate for registered nurses at general hospitals in New South Wales, such as the John Hunter Hospital?

#### Answer-

Nurses and midwives employed in the New South Wales State public health system, including John Hunter Hospital, are paid in accordance with the Public Health System Nurses' and Midwives' (State) Award.

- \*3924 WOMENS EMERGENCY SHELTER—Ms Sonia Hornery asked the Minister for Family and Community Services, and Minister for Social Housing—
  - (1) How much funding was allocated to the single temporary accommodation facility for women fleeing domestic and family violence in the Wallsend electorate?
  - (2) How many women have sought shelter at this facility in the 2015-16 financial year?

#### Answer-

- (1) Funding is not allocated to hotels and motels that are used as temporary accommodation facilities; they are paid on a per night basis only when they are used.
- (2) Data is not available for individual temporary accommodation facilities.
- \*3925 ADHC TRANSFER PACKAGES—Ms Sonia Hornery asked the Minister for Family and Community Services, and Minister for Social Housing representing the Minister for Ageing, Minister for Disability Services, and Minister for Multiculturalism—

Regarding the transfer packages offered to employees of Aged and Disability Home Care:

- (1) How were the packages calculated?
- (2) Were transparency measures were put in place to ensure all stakeholders were adequately consulted and considered?

#### Answer-

- (1) The National Disability Insurance Scheme (NSW Enabling) Act provides the core terms and conditions for transferred staff. This includes an employment guarantee period of two years for ongoing staff and up to six months for casual and temporary staff. A transfer payment of up to eight weeks is also payable to ongoing staff. These conditions are designed to ensure retention of skilled disability service staff throughout transfer and the continuity of services.
- (2) I am advised staff and their representatives have been briefed on the transfer arrangements and the Department of Family and Community Services holds a monthly disability transfer consultative forum with the Public Service Association.
- \*3926 MANUFACTURE OF TRAIN CARRIAGES IN SOUTH KOREA—Ms Sonia Hornery asked the Premier, and Minister for Western Sydney—

Regarding the Government's decision to have 500 train carriages built in South Korea, will there be benefits for the people of New South Wales and the Hunter?

### Answer-

As this matter relates to the portfolio of the Minister for Transport and Infrastructure, I have referred the question to the Hon Andrew Constance MP.

- \*3927 NSW TRUSTEE AND GUARDIAN OFFICE IN LIVERPOOL—Mr Paul Lynch asked the Attorney General—
  - (1) Are there plans to sell the site of the current NSW Trustee and Guardian office in Liverpool?
    - (a) If not, what is proposed for the usage of the site?

#### Answer-

I am advised that NSW Trustee and Guardian are in discussions with Property NSW about the Liverpool office site.

- \*3928 FIREFIGHTING IN THE LIVERPOOL CBD—Mr Paul Lynch asked the Minister for Corrections, Minister for Emergency Services, and Minister for Veterans Affairs—
  - (1) Where is the nearest firefighting unit to Liverpool CBD to deal with fire in buildings higher than ten stories?
    - (a) Where is the nearest 'bronto' fire appliance to Liverpool CBD?

### Answer-

- (1) Liverpool Fire Station.
  - (a) Parramatta Fire Station.
- \*3929 SURETY BOND REQUIREMENT—Mr Paul Lynch asked the Attorney General—

Why is the NSW Trustee introducing the Surety Bond Requirement pursuant to section 64 of the NSW Trustee and Guardian Act 2009, rather than pursuant to section 68 of the Act?

Answer-

- \*3930 RESOURCES AND NEW HOUSING NSW PROPERTIES—Ms Julia Finn asked the Minister for Family and Community Services, and Minister for Social Housing—
  - (1) What additional resources have been provided to Housing NSW to reduce homelessness in the Granville electorate?
  - (2) How many new properties have been built by Housing NSW since March 2011?

Answer-

Future Directions, the NSW Government's vision for social housing over the next ten years, will see some 18,000 existing housing dwellings renewed in integrated communities providing housing better suited to client needs. Information about Future Directions is available at www.socialhousing.nsw.gov.au.

\*3931 LIVERPOOL LOCAL COURT MAGISTRATES—Mr Paul Lynch asked the Attorney General—

When will the Liverpool Local Court have a full complement of magistrates?

Answer-

I am advised that the Chief Magistrate is responsible for the allocation of magistrates to Local Court sittings.

\*3932 CLOSURE OF THE NSW TRUSTEE AND GUARDIAN OFFICE IN LIVERPOOL—Mr Paul Lynch asked the Attorney General—

When will the NSW Trustee and Guardian Office in Liverpool close?

Answer-

I am advised that the Liverpool Branch of NSW Trustee & Guardian will begin closing in late 2016.

- \*3934 SOCIAL HOUSING MAINTENANCE BACKLOG—Ms Julia Finn asked the Minister for Family and Community Services, and Minister for Social Housing—
  - (1) What is the value of outstanding maintenance works for social housing to be completed in the Cumberland local government area?
  - (2) What is the estimated expenditure in 2016-17 on maintenance works for social housing in the Cumberland local government area?

Answer-

The number of properties undergoing maintenance in any location varies. FACS responds to maintenance requests, and also has planned maintenance programs to keep its properties in good condition and ensure consistent maintenance standards across New South Wales.

- \*3935 INSTALLATION OF SMART METERS—Ms Kate Washington asked the Minister for Innovation and Better Regulation—
  - (1) How many inspectors are currently employed to audit the installation of Smart Meters?
  - (2) How many inspectors will be employed to audit the installation of Smart Meters in New South Wales as of 1 December 2017?

Answer-

- (1) NSW Fair Trading has an established Energy and Utilities Unit which undertakes the agency's responsibilities in relation to gas and electricity safety, and which has responsibility since 1 July 2016 for smart meter regulation. The unit comprises 8 full-time positions for Electrical Safety Investigators.
- (2) The number of inspectors required by 1 December 2017 will be determined using data collected from retailers in relation to the scale and pace of the smart meter roll out.
- \*3936 DECISION ON AGED CARE NURSES IN AGED CARE HOMES—Ms Sonia Hornery asked the Minister for Health—

Did the Minister take into account statistics which show that eight of the top ten locations calling for an emergency ambulance in 2015 were nursing homes when making the decision to remove the requirement for aged care facilities to have a registered nurse on duty 24/7?

Answer—

The Government response to the recommendations made by the Legislative Council Inquiry into registered nurses in New South Wales nursing homes was that the requirement would remain in place until the issue has been considered by the COAG Health Council. The response is publicly available at www.parliament.nsw.gov.au/committees/listofcommittees/Pages/committees.aspx.

Standards set under the Aged Care Act 1997 provide national guidance to ensure appropriate levels of nursing care at aged care facilities.

\*3937 TAXI-SUBSIDY SCHEME—Mr Edmond Atalla asked the Minister for Transport and Infrastructure—

Will the Taxi-Subsidy Scheme still remain available under the National Disability Insurance Scheme?

Answer-

Yes.

- \*3938 ASSESSMENT OF SHERIFF'S OFFICERS—Mr Paul Lynch asked the Minister for Innovation and Better Regulation—
  - (1) Is SafeWork NSW carrying out assessments relating to the safety of Sheriff's Officers and/or their workplaces?
  - (2) When will the assessments be completed?
  - (3) Why are SafeWork NSW Officers refusing to answer questions asked by Sheriff's Officers concerning their assessments?
  - (4) Why won't SafeWork NSW release the results of the assessments they are carrying out in relation to Sheriff's Officers?

Answer-

SafeWork NSW is not carrying out assessments.

The Sheriff's Office has been providing training and instruction across all court jurisdictions dealing specifically with armed offender situations.

Five Security Coordinators commenced travelling around the state to provide this training to court locations and to conduct site specific security assessments.

SafeWork is satisfied with the actions being taken by the Sherriff's office to address this issue

- \*3939 WOMEN'S REFUGES IN WOLLONGONG—Ms Jenny Aitchison asked the Minister for Family and Community Services, and Minister for Social Housing—
  - (1) Can the Minister confirm whether the two women's refuges in Wollongong have a constant waiting list for women escaping domestic violence of 20 at any given time?
  - (2) Can Wollongong provide adequate services to women escaping domestic violence if up to 20 women are waiting for assistance at any given time?

Answer-

The number of women on the list varies according to demand. Clients are supported by Outreach Case Managers who work with other service providers to ensure women who are homeless or at risk of homelessness due to domestic and family violence have access to services. The NSW Domestic Violence Line is also available to provide counselling and support.

\*3941 INDIGENOUS STUDENT SCHOOL ATTENDANCE—Ms Sonia Hornery asked the Minister for Education—

Considering the release of the 2016 'Closing the Gap' report, what is the Government doing to improve indigenous student school attendance?

Answer-

Under the Department of Education's School Attendance Policy, encouraging the regular attendance of all students, including Aboriginal students, is a core school responsibility. Schools across NSW, with support from 110 Home School Liaison Officers and 26 Aboriginal Student Liaison Officers, monitor the regular attendance of students and develop strategies to support students with attendance issues through school Learning and Support Teams.

Personal Learning Pathways is a specific strategy to monitor the attendance of Aboriginal students, with individualised actions developed in partnership with Aboriginal students, their parents or carers and teachers, when and where required.

Three schools participate in the Remote Schools Attendance Strategy, which includes the employment of School Attendance Monitors and Officers who work with families, communities and schools to improve attendance

\*3942 INDIGENOUS HEALTH—Ms Sonia Hornery asked the Minister for Health—

Considering the release of the 2016 'Closing the Gap' report, what is the Government doing to improve indigenous health outcomes?

Answer—

This is a matter for the portfolio of the Assistant Minister for Health.

\*3943 ACTION AGAINST POLICE OFFICERS—Mr Paul Lynch asked the Deputy Premier, Minister for Justice and Police, Minister for the Arts, and Minister for Racing—

What action has been taken against the police officers who assaulted Liam Monte in Sydney CBD on April 19 2013?

Answer-

The NSW Police Force has advised me that it has recently received a complaint against a police officer relating to an alleged assault against Mr Monte. The investigation into this complaint will be suspended pending the outcome of current legal proceedings in relation to this incident. Upon conclusion of the complaint investigation, police will take action in relation to any adverse findings according to the requirements of the Police Act 1990.

- \*3944 HOUSEBREAKING OFFENCES—Mr Paul Lynch asked the Attorney General—
  - (1) How many people have been convicted in NSW Courts of offences under sections 109(2), 111(2), 112 (2) and 113(2) of the Crimes Act 1900 in the periods:
  - (a) 1.1.14 31.12.14;
  - (b) 1.1.15 31.12.15; and
  - (c) 1.1.16 3.6.16?

Answer-

I am advised that this information can be found by contacting the NSW Bureau of Crime Statistics and Research.

- \*3945 ABORIGINAL LEGAL SERVICE CUSTODY NOTIFICATION SERVICE—Mr Paul Lynch asked the Attorney General—
  - (1) (a) Will you amend the rules relating the use of the Aboriginal Legal Service Custody Notification Service (CNS) so that a notification is made to the CNS if an Aboriginal person is detained by police for apparently being intoxicated?
  - (b) If so, when?
  - (c) If not, why not?

Answer-

I am advised that a Police Critical Incident Investigation is underway and the matter has also been referred to the NSW Coroner. The NSW Government will closely consider any findings and recommendations for legislative amendments.

- \*3946 SERVICES FOR LYMPHEDEMA PATIENTS—Mr Greg Piper asked the Minister for Health—
  - (1) What services are available to people suffering from lymphedema in the Central Coast Area Health District and in the southern parts of the Lake Macquarie electorate?
    - (a) Are those services meeting demand and consistent with service levels in other Area Health Districts?

Answer—

Specialised lymphoedema assessment and treatment is provided in the Central Coast Local Health District by the occupational therapy outpatients service, with a limited service to the acute wards of Gosford and Wyong Hospitals.

The lymphoedema outpatients service receive approximately 15 new patient referrals per month. As at August 2016, the service had 487 patients. Patients receive screening and an appointment on receipt of

the referral. Due to demand, the Central Coast Local Health District's existing services were reorganised to provide a once-weekly outpatient clinic at Wyong Hospital, which has enabled easier access for residents within the northern catchment area.

Meeting demand for patients suffering from lymphoedema is a complex process with clients at various stages of treatment, requiring differing clinical needs and levels of urgency. In the Central Coast Local Health District, urgent clients are prioritised and clinically appropriate strategies are employed to manage client waiting times.

### \*3947 MORISSET HOSPITAL SITE—Mr Greg Piper asked the Minister for Health—

What action is being taken to secure the unoccupied buildings on the Morisset Hospital site from unlawful access and vandalism?

#### Answer-

Unused buildings on the Morisset Hospital site have been boarded up wherever possible to minimise access and security services provide regular patrols of the campus. A boom gate has also been installed to enable the lock down of the campus at night and security monitoring cameras have been installed in strategic locations across the Morisset Hospital campus. Staff are also encouraged to remain vigilant for suspicious activities, particularly after hours.

- \*3948 DRIVER LICENSING ACCESS SERVICE PROGRAM—Mr Paul Lynch asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—
  - (1) (a) What assessment has been made of the financial viability of the RMS funded Driver Licensing Access Service program?
  - (b) Is there any evidence that the recipients of such funding are successfully operating under the program's business contracting model?

#### Answer—

- (1) (a) An evaluation is planned to commence at the end of the 2016-17 financial year.
- (1) (b) Participants who have completed the program have secured employment, become role models in their communities and are helping others obtain a licence or are the first in their family to have held a licence

Through a public tender, an approved panel of 18 service providers was created. Contracts are used to engage panel members to deliver driver licensing access services which include learner licence and provisional licence targets. These contracts are managed by RMS regional project officers, who monitor progress against agreed milestones and release funds when milestones are achieved.

- \*3949 PRINCE OF WALES HOSPITAL PATHOLOGY UNIT—Mr Ron Hoenig asked the Minister for Health—
  - (1) Will the Minister confirm whether the pathology service at the Prince of Wales Hospital has been placed in a separate unit discrete from the Hospital's general operations?
    - (a) If so why?
  - (2) Which other New South Wales public hospitals have had, or will have, their pathology services placed in a separate unit discrete from the general operations of the hospital in question?
  - (3) Does the Government have any plans to privatise pathology units, including at the Prince of Wales Hospital, Randwick?
    - (a) If so, have buyer/buyers for the pathology services at New South Wales public hospitals been identified?

#### Answer-

NSW Health Pathology provides public pathology services to the Randwick campus. This includes the public hospitals (Prince of Wales Hospital, Sydney Children's Hospital and Royal Hospital for Women) and the Prince of Wales Private Hospital. There has been no change to the physical location of public pathology services at the Randwick campus. The pathology laboratory and collection centres remain on the hospital campus and play an integral role the hospital's operations and the provision of quality care for patients.

Public pathology laboratories, and most NSW Health pathology collection services, are located on public hospital campuses in the local health districts they serve.

- \*3950 PEST MANAGEMENT BY THE NATURAL RESOURCES COMMISSION—Mr Ryan Park asked the Minister for Industry, Resources and Energy representing the Minister for Primary Industries, and Minister for Lands and Water—
  - (1) Will the Government adopt the recommendations of the Natural Resources Commission to change the status of wild deer from game to pest species in recognition of the serious socio-economic impact this pest has on communities in the Illawarra and across New South Wales?
  - (2) What actions will the Government take to ensure decisive, well-funded, coordinated deer control programs will be in place in the Illawarra and across New South Wales?

#### Answer-

The Government is currently considering the Natural Resources Commission's final report.

- \*3951 M1 PRINCES MOTORWAY INTERCHANGE AT MOUNT OUSLEY—Mr Ryan Park asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—
  - (1) Given that community consultation and feedback on the preferred option for the M1 Princes Motorway Interchange at the base of Mount Ousley has now closed, what was the participation rate?
  - (2) What outcomes were decided as a result of the community consultation and feedback?
  - (3) How will residents and the local community be informed of any additional changes made to the preferred option on the M1 Princes Motorway Interchange at the base of Mount Ousley?
  - (4) What date will the community be informed about the concept design and environmental impact assessment?
  - (5) Will the community have further opportunity to leave feedback and comment on the concept design or environmental impact assessment?
  - (6) What is the expected date for public display of the concept design and environmental assessment for the preferred option?
  - (7) What is the construction timeline and funding timeline for the M1 Motorway Interchange at the base of Mount Ousley?

#### Answer—

Roads and Maritime Services received submissions on the preferred option. The community will have further opportunity to provide feedback during the concept design and environmental assessment.

Any refinements to the preferred option will be identified during consultation of the concept design phase. Dates and funding information for the planning phase is available on the Roads and Maritime Services website.

Funding and timing for construction is yet to be confirmed.

- \*3952 GRAFFITI IN THE ILLAWARRA—Mr Ryan Park asked the Deputy Premier, Minister for Justice and Police, Minister for the Arts, and Minister for Racing—
  - (1) What strategies are in place to reduce and prevent Graffiti attacks in the Illawarra?
  - (2) In relation to Memorial Drive, Woonona and the continual attacks of graffiti, could the Minister please provide information regarding the amount of police patrols associated with eradicating graffiti crime in this area?
  - (3) Could the Minister please provide information in relation to prosecutions or reported incidents to the graffiti hotline about graffiti on Memorial Drive?

#### Answer-

The Government is committed to reducing graffiti vandalism around NSW and has implemented a number of measures to help to support this goal.

I am advised the NSW Police Force conducts ongoing audits of venues selling spray paint cans to ensure they comply with the Graffiti Control Act 2008. Wollongong Local Area Command also identifies and patrols locations likely to be subject to graffiti incidents and addresses graffiti offences as part of daily policing tasks. There have been no prosecutions or incidents reported to the graffiti hotline about graffiti on Memorial Drive.

In addition, the Government has established a State-wide graffiti removal and prevention day. In partnership with Graffiti Removal Australia, Graffiti Removal Day 2016 will be on Sunday 30 October 2016.

- \*3953 NOISE CAMERAS IN NEW SOUTH WALES—Mr Ryan Park asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—
  - (1) How many noise cameras are there installed in New South Wales?
  - (2) What legislation is in place to enforce noise camera infringements in New South Wales?
  - (3) Since 2013 what steps has the Government taken to legislate the issuing of fines from noise cameras in New South Wales?
  - (4) Since 2013 how many fines have been issued to offenders due to high noise pollution on Mount Ousley Road?

Answer-

- (1) Two
- (2) to (4) Roads and Maritime has developed and trialled noise camera technology, to detect vehicles emitting excessive engine braking noise. The Government is hopeful the National Transport Commission will prepare amendments to the National Heavy Vehicle Legislation to provide for regulation of compression braking noise. The Government will consider a Statewide rollout of the noise camera system when the regulation is enacted.
- \*3954 ILLAWARRA ESCARPMENT STATE CONSERVATION AREA AND ROYAL NATIONAL PARK—Mr Ryan Park asked the Minister for the Environment, Minister for Heritage, and Assistant Minister for Planning—
  - (1) How much money is budgeted to control wild deer in the Illawarra Escarpment State Conservation Area and Royal National Park in the 2016-17 and 2017-18 financial years?
  - (2) What programs are in place, and are planned to be implemented to control wild deer in the Illawarra Escarpment State Conservation Area and Royal National Park in the 2016-17 and 2017-18 financial years?

Answer-

- (1) In 2016-17, \$8,250 is allocated to the Illawarra Escarpment State Conservation Area and \$30,000 is allocated to Royal National Park for deer control programs. It is anticipated that similar funding will be allocated to these programs in 2017-18.
- (2) The National Parks and Wildlife Service manages deer as a pest species in accordance with its regional pest management strategies. Deer management programs are identified as a priority in the Metro South West and South Coast regional pest management strategies. The regional pest management strategies can be found at www.environment.nsw.gov.au/pestsweeds/RegionPestManagement.htm.
- \*3955 TRANSPORT FOR NEWCASTLE OPERATOR APPOINTMENT—Ms Sonia Hornery asked the Minister for Transport and Infrastructure—

When will the new operator for Transport for Newcastle be appointed?

Answer-

Late 2016.

\*3956 POLICE TRANSPORT COMMAND OFFICERS—Ms Sonia Hornery asked the Deputy Premier, Minister for Justice and Police, Minister for the Arts, and Minister for Racing—

How many Police Transport Command Officers are currently working as at September 2016 on NSW trains?

Answer-

The authorised strength of the Police Transport Command (PTC) was 610 as at July 2016, meeting a commitment to staffing levels made when the Command commenced operations in 2012.

The allocation of resources is a matter for the Commissioner. The PTC uses intelligence driven rostering and strategies to target known offenders and crime hot spots by deploying police to places where crime may be expected to occur.

#### Answer—

On 11 October 2016, the Government gave in principle support to give the greyhound racing industry one final chance in NSW, subject to it agreeing to the strictest regulations to clamp down on animal cruelty.

The Greyhound Industry Reform Panel, chaired by former Premier Morris Iemma and with representatives from industry and the RSPCA, will determine the new regime. It will ensure that NSW greyhound racing has the strictest regulatory guidelines in the country and prioritises animal welfare.

The Panel will consider:

• mandatory life bans as well as increased jail terms for live baiting

- registering all greyhounds for their entire lives
- an independent regulator with strong new powers to ensure transparency and accountability
- substantially increased resources for enforcement and prosecution as well as animal welfare

Subject to the Panel's recommendations, legislation will be introduced early in 2017 to repeal the ban on greyhound racing and establish the new regulatory regime.
