\*3789 RAILWAY PLATFORM SMOKING FINES—Dr Andrew McDonald asked the Treasurer, and Minister for Industrial Relations representing the Minister for Finance and Services, and Minister for the Illawarra—

With regard to the enactment of the Tobacco Legislation Amendment Act 2012:

- (1) Have any commuters been fined or charged under any act for smoking on a railway platform or train since 1 July 2012?
- (2) If so, how many?

Answer—

(1) Yes.

(2) 1,843.

\*3790 BUILDER SHORTAGES—Ms Tania Mihailuk asked the Minister for Education—

In regard to Master Builders Association estimates that 80,000 builders throughout Australia will retire by the end of the decade, what action will the Government take to address the possible shortage of builders in NSW?

Answer—

The NSW Government has a number of strategies in place to promote training through an apprenticeship or traineeship in the building industry. These include:

- funding of training for many building and construction trades is available through the Strategic Skills Program and the Apprenticeship and Traineeship Training Program;
- working with industry to shorten construction and joinery apprenticeships and traineeships by introducing competency based progression and reduced nominal terms;
- support for apprentices and trainees including:
  - a travel concession card;
  - a travel and accommodation allowance to attend off the job training if travelling exceeds more than a 120 km round trip;
  - first and second year apprentices may be eligible for a car registration rebate;
  - scholarships are awarded each year for country apprentices experiencing financial hardship;
- working to attract and retain more females into non-traditional trade occupations such as building and construction;
- the Continuing Apprentices Placement Program which assists out of work apprentices to find a suitable employer to continue their apprenticeship;
- provision of exemptions from workers compensation premiums for employers' apprentices through the Apprentice Incentive Scheme;
- under Smart and Skilled reforms to the NSW vocational education system to be implemented in 2014, a NSW Skills List based on labour market analysis, skill shortages and industry consultation will define which qualifications and courses are eligible for government subsidies. Qualifications deemed to be essential to the building and construction industry will be included on the Skills List.
- \*3791 COAL SEAM GAS EXPLORATION LICENCE PEL 267—Mr Clayton Barr asked the Minister for Resources and Energy, Special Minister of State, and Minister for the Central Coast—

With regard to the coal seam gas exploration licence known as PEL 267:

- (1) Will PEL 267 be affected in any way by The Strategic Regional Land Use Policy which was released 11 September 2012?
- (2) Will PEL 267 be affected in any way by measures to further strengthen the regulation of the Coal Seam Gas industry in NSW announced by the Premier and Deputy Premier on 19 February 2013?

Answer-

(1) and (2) Yes.

\*3792 HOUSING NSW TENANT FRAUD UNIT—Ms Tania Mihailuk asked the Treasurer, and Minister for Industrial Relations representing the Minister for Finance and Services, and Minister for the Illawarra—

Will the Minister invest any surplus funds derived from the recent amnesty by the Housing NSW Tenant

Fraud Unit to help address the housing affordability crisis in South-West Sydney? Answer—

On this occasion, I respond on behalf of the Acting Minister for Finance and Services.

Any additional rent will be used to maintain the public housing system.

\*3793 WATER SUPPLY DISCONNECTION—Mr Richard Amery asked the Treasurer, and Minister for Industrial Relations representing the Minister for Finance and Services, and Minister for the Illawarra—

How many persons have had water supply disconnected for non payment of accounts for addresses in the 2770 postcode area in the last two years?

Answer—

Nil.

\*3795 CONDITIONAL REGISTRATION CTP CATEGORY—Mr Clayton Barr asked the Treasurer, and Minister for Industrial Relations representing the Minister for Finance and Services, and Minister for the Illawarra—

With regard to the Conditional Registration CTP Category:

- (1) What areas are classified as "Other"?
- (2) What areas are classified as "Country"?
- (3) Why does "Other" classified Conditional Registration cost approximately 120% more than "Country" classified Conditional Registration?

Answer—

- (1) The "Other" CTP classification for conditionally registered vehicles includes all postcodes in New South Wales excepting those listed below at (2).
- (2) The "Country" CTP classification for conditionally registered vehicles comprises those in the following postcode bands:
  - 2311 to 2312.
  - 2328 to 2490.
  - 2527 to 2529.
  - 2532 to 2551.
  - 2575 to 2739.
  - 2787 to 2899.
- (3) Green Slip premiums are set by the CTP insurers, within limits set by the Motor Accidents Authority, based on the actual claims experience (cost and frequency) of a particular class of vehicle in a particular rating district.

For many of the vehicle classes eligible for conditional registration, the variation in the claims experience and CTP costs between the "Country" and "Other" rating zone is small. In other instances, the variation is larger reflecting the higher risk of claims for these vehicles.

- \*3796 WESTERN SYDNEY OUTFALL PIPES—Ms Linda Burney asked the Treasurer, and Minister for Industrial Relations representing the Minister for Finance and Services, and Minister for the Illawarra—
  - (1) Does Sydney Water have any plans to make Western Sydney Outfall pipes inaccessible as they cross the Cooks River?
  - (2) Is Sydney Water aware of the practice of young men using the exposed pipes as a bridge? Answer—
  - (1) and (2) Yes, permanent security measures will be installed on the aqueduct as part of a project to rehabilitate the main western carrier.
- \*3799 BELMORE RAILCORP FREIGHT LINE—Mr Robert Furolo asked the Minister for Transport—

In regard to the Belmore RailCorp Freight Line:

- (1) How does RailCorp identify that the rolling stock of a private sector rail freight operator is producing abnormal levels of noise?
- (2) Has RailCorp identified that the rolling stock of any private sector freight rail operators using the Metropolitan Freight Network in the vicinity of Paxton Avenue is producing abnormal levels of noise?
- (3) If RailCorp has identified that the rolling stock of a private sector rail freight operator is producing

abnormal levels of noise:

- (a) What communication has RailCorp had with those private sector rail freight operators;
- (b) In what form was the communication made?
- (c) When was the communication was made?

\*3800 MAINTENANCE REPAIR AND UPGRADE OF ROAD PAVEMENTS—Mr Robert Furolo asked the Minister for Transport representing the Minister for Roads and Ports—

Can the Minister advise:

- (1) In regard to the maintenance, repair and upgrade of road pavements on state roads, what is the basis for prioritising road pavement repairs and maintenance?
- (2) Has the Road and Maritime Service undertaken an assessment of the condition of the road pavement of Canterbury Road between King Georges Road and Bexley Road?(a) If ves, what was the result of the assessment?
- (3) Has any sections of the road pavement on Canterbury Road between King Georges Road and Bexley Road been identified for repair, maintenance or upgrade?
  - (a) If yes, when will the works be undertaken?

Answer—

I am advised:

Roads and Maritime Services assesses road pavement conditions annually across the State Road network. Funding is allocated on a State-wide priority basis, and Canterbury Road will be considered for pavement rehabilitation and maintenance upgrade as part of this process.

\*3802 CHILDCARE FACILITIES—Mr Alex Greenwich asked the Minister for Education—

With respect to analysis in The Australia Institute report "Trouble with childcare affordability, availability and quality":

- (1) What programs does the Government provide to help parents and guardians locate childcare that meets their needs, including waiting lists and vacancies?
- (2) What data does the Government have about childcare demand in the inner city?
- (3) What data does the Government have about future demand for childcare in the inner city?
- (4) What support does the Government provide to increase the availability of flexible and responsive childcare options?
- (5) How does the Government support the provision of appropriate land and buildings for childcare facilities?
- (6) What other support does the Government provide to help the establishment of new childcare facilities in high demand area?
- (7) What action has the Government taken with the Commonwealth Government to increase childcare in areas of high need?
- (8) What further action will the Government take to improve childcare affordability, availability and quality?

Answer-

(1) Child care in New South Wales is supported by the Commonwealth Government, through funding provided to parents with children enrolled in eligible care services.

(2) and (3) The NSW Government does not have a role in determining current or future supply or demand for child care places.

(4) The NSW Government provides funding support for approximately 800 preschool services state wide.

(5) to (8) In March 2013, the NSW Government announced a \$5 million capital funding initiative for the community-based preschool sector.

The current review of the NSW planning system will lead to stronger community engagement in key planning decisions and a focus on evidence-based strategic planning, including for child care needs in communities.

In 2014, the NSW Government will roll out a new funding model for community-based preschools that will distribute NSW Government funding more equitably, prioritising preschool access for children in the year prior to school and providing two years of subsidised preschool for disadvantaged children.

- \*3805 STOCKTON CENTRE NURSE TO PATIENT RATIO—Ms Sonia Hornery asked the Minister for Ageing, and Minister for Disability Services—
  - (1) What is the nurse to patient ratio at the Stockton Centre?
  - (2) What is the recommended nurse to patient ratio?

Answer-

There are no patients at Stockton Centre.

- \*3806 POLICE TO POPULATION RATIO NEWCASTLE—Ms Sonia Hornery asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
  - (1) What is the police to population ratio in the Newcastle Local Area Command?
  - (2) How does this compare with the NSW ratio and the police to population ratio in other Australian states?
  - (3) Will the Minister employ more police in the Hunter Region considering its rates of crime are above the state average in 12 out of 17 categories, according to the most recent figures from the NSW Bureau of Crime Statistics?

Answer-

I am advised:

In terms of the allocation of police resources across these areas, a range of factors are considered to determine police strength, such as crime figures, categories of crime, population and demographics, and these are reviewed as changes occur to ensure policing meets demand.

The Government is committed to providing the NSW Police Force with the resources it needs to keep the community safe. Since May 2011, 138 new Probationary Constables have been allocated to Local Area Commands in the Hunter region.

- \*3807 MAINTENANCE ON DEPARTMENT OF HOUSING HOMES—Ms Sonia Hornery asked the Treasurer, and Minister for Industrial Relations representing the Minister for Finance and Services, and Minister for the Illawarra—
  - (1) What is the current budget for maintenance on Department of Housing homes in the Hunter region?
  - (2) (a) Has this budget increased from previous years?
  - (b) If not, why not?

Answer-

- (1) NSW Land and Housing Corporation allocated a budget of \$16.7 million for planned maintenance and upgrading of Land and Housing Corporation properties in the Hunter Region for the current financial year 2012-2013. There is no budget allocation for responsive maintenance by electorate, Local Government Area or suburb. Responsive maintenance is undertaken when tenants contact the call centre.
- (2) (a) No.

(b) Maintenance works are prioritised based on need and available funding is allocated to each job accordingly.

- \*3808 GLOUCESTER AND MANNING HOSPITALS—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—
  - (1) Will the Government reduce services, including maternity services, at Gloucester and Manning hospitals?
  - (2) Will the Government downgrade Gloucester and Manning hospitals?

Answer—

I am advised:

(1) and (2) There are no planned changes to service delivery, including maternity services at either Manning or Gloucester Hospitals.

\*3809 JOHN HUNTER HOSPITAL PALLIATIVE CARE—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—

- (1) Why are there no palliative care staff specialists based at Newcastle's John Hunter Hospital?
- (2) Are there plans to rectify this situation?
  - (a) If so, when?
    - (b) If not, why not?
- (3) Will funding for existing palliative care services in the Hunter Region be maintained or increased?

Answer—

I am advised:

(1) to (3) John Hunter Hospital benefits from the expertise of Hunter New England Local Health District's Palliative Care Network. Palliative Care specialists are on-call 24-hours-day and regularly visit the John Hunter Hospital to provide support and advice.

For those patients with more complex needs who require specialist palliative care, the Calvary Mater Newcastle's Palliative Care Unit is available for phone consultation 24 hours per day and inpatient review once per week.

The District's Cancer Network is considering a range of options to support palliative care services at John Hunter Hospital.

- \*3810 OVERPASS BRIDGE STEWART AV AND HANNELL ST—Ms Sonia Hornery asked the Minister for Transport representing the Minister for Roads and Ports—
  - (1) Does the Government plan to build an overpass bridge connecting Newcastle's Stewart Avenue and Hannell Street?
  - (2) If not, does it have any other plans to alleviate congestion at this intersection?

Answer-

I am advised:

The Government has no plans to build an overpass bridge between Stewart Avenue and Hannell Street.

A Scoping Study is being undertaken to establish a more detailed project plan, including alternative transport arrangements for all modes of transport in the Newcastle City Centre.

- \*3811 FRONTLINE HEALTH SERVICES—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—
  - (1) Does the Government's definition of "frontline health services" include emergency room nurses?
  - (2) (a) Is the Government planning to reduce emergency department nursing staff levels at the John Hunter Hospital by one nurse every morning and one nurse after midnight about four days a week?

(b) If so, why is the Government breaking its promise not to axe frontline health services?

Answer—

I am advised:

- (1) Frontline nurses are all nurses who provide direct patient care.
- (2) There are no plans to reduce nursing staff levels at John Hunter Hospital Emergency Department. Nurse staffing at John Hunter Hospital's Emergency Department is in accordance with the Public Health System Nurses' and Midwives' Award. The Emergency Department is currently fully and appropriately staffed.
- \*3812 DAYS SPENT IN HUNTER-Ms Sonia Hornery asked the Premier, and Minister for Western Sydney-
  - (1) Did the Premier promise, before he was elected Premier, to spend at least one day a month in the Hunter?
  - (2) How many days has the Premier spent in the Hunter since the March 2011 election?

Answer-

Despite the spurious claim in the question, I have happily visited the Hunter on a regular basis, both before and after March 2011 election.

- \*3813 STATEWIDE COMMUNITY AND COURT LIAISON SERVICE—Mr Paul Lynch asked the Minister for Health, and Minister for Medical Research—
  - (1) At which local courts do the Statewide Community and Court Liaison Service operate?

(2) What is the cost of the program at these locations?

Answer-

I am advised:

 and (2) The Statewide Community and Court Liaison Service (SCCLS) is established in 20 Local Courts across NSW. The service provides mental health assessments and reports to the Court to assist Magistrates in making informed decisions about cases involving individuals with mental health problems.

Currently the SCCLS operates in Blacktown, Burwood, Campbelltown, Central, Gosford/Wyong, Liverpool, Parramatta, Penrith, Sutherland, Coffs Harbour, Dubbo, Lismore, Nowra/Milton, Port Macquarie/Kempsey, Tamworth, Wollongong and Wagga Wagga Local Courts. The courts in which SCCLS currently operates were chosen by the Justice and Forensic Mental Health Network in close consultation with the Chief Magistrate's Office. The NSW Government invested \$3.1 million in 2012-2013 for Court Liaison Services across the 20 Courts.

\*3814 GOVERNMENT RESPONSE TO RECOMMENDATIONS - REPORT NO 137—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

What is the response of the Government to the recommendations of NSW Law Reform Commission Report No 137 ' Security for costs and associated orders'?

Answer—

I am advised:

The Department of Attorney General and Justice is currently consulting on the NSW Law Reform Commission's report.

Nine of the report's 11 recommendations relate to the Uniform Civil Procedure Rules 2005. The Uniform Rules Committee is currently considering those recommendations.

The NSW Government response should be finalised during 2013.

\*3815 GOVERNMENT RESPONSE TO RECOMMENDATIONS - REPORT NO 136—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

What is the Government response to the recommendations of NSW Law Reform Commission Report no 136 Jury Directions?

Answer—

I am advised:

The NSW Law Reform Commission's Report no 136, Jury Directions, was tabled on 26 March 2013.

The Department of Attorney General and Justice is currently considering the report's recommendations, in consultation with key stakeholders. This consultation will inform the Government response which is envisaged by the end of 2013.

\*3816 REPLY TO STEVE CANSDELL-Mr Paul Lynch asked the Attorney General, and Minister for Justice-

When does the Director of Public Prosecutions propose to reply in relation to the advice of Greg James QC concerning Mr Steve Cansdell?

Answer—

I am advised:

The advice from Mr James QC was unsolicited advice and as such it is a matter for the NSW Director of Public Prosecutions.

\*3818 LINDA MARKOU—Mr Paul Lynch asked the Premier, and Minister for Western Sydney—

(1) Have you responded to the letter to you from Linda Anne Markou?(a) If so, what was your response?

Answer-

The Office of the Premier responded to correspondence, dated 14 May 2013.

\*3819 INVOLVEMENT OF YOUNG PEOPLE - BRINGELLY—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

(1) Has NSW Animal Rescue approached the Minister or Juvenile Justice concerning their site in Bringelly and the involvement and/or training of young people there involved with Juvenile Justice?(a) If so, what was the Government's response?

Answer—

- (1) Yes.
  - (a) Juvenile Justice has existing pathways and processes for establishing partnerships via the Community Service Order (CSO) scheme which is overseen by local Juvenile Justice Community Services Area Managers, and also through programs offered in centres. Juvenile Justice already maintains a number of partnerships with community organisations in the region. Given the number of community partnerships already in place, and concerns around potential contact between adult and juvenile offenders at this site, Juvenile Justice is not considering this proposal at this time.
- \*3820 IMPLEMENTATION OF RECOMMENDATIONS—Mr Paul Lynch asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
  - (1) Has the NSW Police force implemented recommendations (i) to (v) inclusive of the Ombudsman's Report dated Feburary 2013 into the monitoring of the police investigation into the death of Roberto Laudisio-Curti?
    - (a) If not, why not?

(2) What is the Government response to recommendation (vi) and (vii) in the Report referred to above? Answer—

The Ombudsman's latest report makes seven recommendations including two relating to amending the Police Act 1990, which is a matter the Government will consider as part of an upcoming statutory review of that Act.

The other five recommendations focus on strengthening either the NSW Police Force (NSWPF) Critical Incident Guidelines or police procedures in critical incident investigations.

The Commissioner is considering these five recommendations and any criticisms of NSWPF policies and procedures.

The recommendations are not about police actions at the time of the incident, but the police investigation into those actions.

\*3821 COST ORDERS MADE—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

- (1) Will the Minister agree not to pursue the enforcement of the costs order made against the plaintiff in the proceedings bought on behalf of a forensic patient by his tutor Brett Collins against the Mental Health Review Tribunal in the Supreme Court?
  - (a) If not, why not?

Answer-

I am advised:

Mr Collins has applied for leave to appeal against the order for costs made against him in the Supreme Court. Pending determination of the application, the Court of Appeal has stayed the order for costs. As the matter is before the court it is not appropriate to comment.

- \*3822 GUIDELINES TO CRIME COMMISSION—Mr Paul Lynch asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
  - (1) Has the Management Committee of the NSW Crime Commission issued guidelines to the Crime Commission concerning Criminal Assets Recovery?
    - (a) Do any such guidelines comply with the recommendations in the report by the Police Integrity Commission in Operation Winjana?
  - (2) Where may such Guidelines be viewed?

Answer-

I am advised:

- (1) Yes. In drafting the Guidelines, the recommendations of the Police Integrity Commission in Operation Winjana were taken into account.
- (2) The Guidelines issued on 5 February 2013 are available on the website of the NSW Crime Commission.
- \*3823 SURGICAL WAITING TIMES—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regards to the Surgical waiting times on the "Find your health service" website where the reported quarter is for 1 April 2012 to 30 June 2012 as of 30 April 2013:

When will the latest available data be updated on the site?

Answer—

I am advised:

Up to date information on performance of NSW hospitals is available on the Bureau of Health Information website at www.bhi.nsw.gov.au/home.

\*3824 CREMORNE COMMUNITY MENTAL HEALTH CENTRE—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regards to the Minister's pre-election commitment, when will the Cremorne Community Mental Health Centre be re-opened?

Answer-

I maintain my long-standing commitment to retain the Cremorne Community Centre for the provision of health care to local residents.

The previous Government intended on selling the Cremorne site. I lobbied strenuously to delay the sale and since becoming Minister the buildings at Cremorne have been renovated.

I am advised that mental health services are currently provided from the Royal North Shore and Chatswood community buildings. Community options remain in place for clients who previously attended the Cremorne Community Centre, with mental health consumers and carers reporting their satisfaction with the services being provided from both the Royal North Shore and Chatswood facilities.

The North Shore Ryde Mental Health Service will continue to explore a variety of options for providing services from the Cremorne Community Health Centre. This includes working with Mosman Council to discuss future plans for this community facility.

\*3825 SURGICAL WAIT TIME EXPLANATION—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regards to the Surgical waiting times on the "Find your health service" website.

- (1) Is this reported waiting time
  - (a) Median wait time.
  - (b) Mean wait time.
  - (c) 90th centile wait time.
- (2) Where on the website is this wait time explained?

Answer-

I am advised:

(1) and (2) The NSW Ministry of Health monitors waiting times for planned surgery and for Emergency Department care using nationally agreed measures. These measures are based on clinically recommended time frames, as determined for each patient by their medical practitioner.

All hospitals in NSW use the nationally agreed waiting time measures. The Bureau of Health Information publishes advice on individual hospital performance at www.bhi.nsw.gov.au/home.

\*3826 NSW AMBULANCE PARAMEDICS—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

As of 1 April 2013:

- (1) How many fully qualified paramedics are employed in front line roles by NSW Ambulance Service?
- (2) How many paramedics in training are employed in front line roles by NSW Ambulance Service?

(3) How many vacancies currently exist for qualified paramedics?

Answer-

- (1) to (3) Nearly 3000 fully qualified paramedics and over 100 trainee paramedics are employed in front line roles. Trainee paramedics are only deployed in front line roles when accompanied by a paramedic intern or more senior officer. As at 1 April 2013 there were no paramedic vacancies.
- \*3827 NEPEAN HOSPITAL MATERNITY UNIT BIRTHRATE PLUS STAFFING—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regards to the Maternity Unit at Nepean Hospital.

- (1) How many Full Time Employment nursing and midwifery staff would be required to fully staff this unit, using Birthrate plus as the format?
- (2) When will Birthrate plus staffing be implemented in the Nepean Maternity Unit?

Answer-

(1) and (2) Under the 2011 Nurses' and Midwives' Public Health System (State) Award a midwifery staffing methodology called Birthrate Plus® is in use in NSW. Birthrate Plus® provides a framework to assess the midwifery hours of care required at a service based on a minimum standard of one-to-one midwifery care throughout labour and birth.

The Birthrate Plus® methodology provides a component of a Maternity Unit's staffing. The total staffing of the unit will also include additional FTE for managers, educators, clinical midwifery consultants and nursing work where relevant.

The methodology is currently being used by the Hospital and active recruitment is undertaken by Nepean Blue Mountains Local Health District for any vacancies. Where necessary, experienced casual, agency and overtime staffing is used to continue to provide safe and effective shift coverage.

The Sydney Local Health District is conducting daily sweeps of the area and has installed a sharps waste disposal bin adjacent to the automatic dispensing machine at Redfern Community Health Centre. The City of Sydney Council has advised that its staff currently conduct regular clean-ups of Redfern Oval.

The Sydney Local Health District activated the automatic dispensing machine after hours on 11 April 2013. The automatic dispensing machine is operational outside of business hours of the primary fixed site Needle and Syringe Program outlet.

The Children's Court cannot make a sole parental responsibility order if the parents have not given their consent. Few parents have been prepared to give consent because, if a sole parental responsibility order is made, it will significantly limit their ability to apply to the court in the future to have the orders changed. Hence sole parental responsibility orders are not commonly applied for by carers.

- \*3852 EATING DISORDER TREATMENT BEDS—Ms Anna Watson asked the Minister for Mental Health, Minister for Healthy Lifestyles, and Minister for Western New South Wales—

With regards to inpatient eating disorder treatment beds at Royal Prince Alfred Hospital;

- (1) How many inpatient care beds currently exist at RPA?
- (2) How many individuals were on the waiting list for inpatient care for eating disorder beds as of 1 April 2013?
- (3) What is the average time spent by inpatients occupying these beds?

Answer-

I am advised:

(1) to (6) There are currently two inpatient beds allocated for inpatient treatment of eating disorders at the Royal Prince Alfred Hospital. Two additional beds have been temporarily closed pending completion of the hospital redevelopment. The range of period inpatients occupy these beds can be from three to 127 days. The waiting time for admission is dependent on a patient's clinical need, as determined by their treating doctor.

Any person regardless of age or where they live who is medically compromised as a result of an eating disorder and is assessed as requiring treatment in a hospital has access to a bed in NSW. If any patient is medically unwell they will be admitted to a general hospital bed, on the basis of clinical need.

It is important to note that the majority of people with eating disorders do not require hospitalisation and receive ongoing care through a range of health providers across both the public and private health system and in a range of settings including general practice, day programs and outpatient care. Hospital based inpatient care is primarily required for medical stabilisation when a person's health status is medically compromised or to initiate treatment for people whose resistance to treatment puts them at high risk of medical complications. Many people with eating disorders receive care in general medical, paediatric, as well as child and adolescent mental health and adult mental health wards, depending on their needs at the time.

In the NSW public health system there are more than 25 non-dedicated but specialist eating disorder beds providing acute, developmentally appropriate interventions. These are located within the Sydney Children's Hospital Network, John Hunter Hospital, Westmead Hospital and Royal Prince Alfred Hospital.

In the private NSW Health system there are at least 32 eating disorder beds available for adolescents and adults located at the North Side Psychiatric Clinic and Wesley Private Hospital.

The NSW Government is committed to increasing assistance to people with eating disorders. We are currently implementing a range of measures including training clinicians throughout NSW to identify and treat eating disorders so that treatment can commence as early as possible; funding specialists through the Centre for Eating and Dieting Disorders to improve treatment and support across NSW; and creating the world's first interactive Eating Disorder Online Training Program to train general health and mental health staff in the identification and treatment of eating disorders. The Ministry of Health is also currently reviewing options for increased treatment access across both community and inpatient care.

\*3853 SMOKY TRUCK FINES—Mr Ryan Park asked the Minister for Transport representing the Minister for Roads and Ports—

- \*3857 CHILDREN AT RISK—Mr Guy Zangari asked the Minister for Family and Community Services, and Minister for Women—

What is the Department doing to protect children who are known to be at risk?

Answer-

The NSW Government's child protection legislative reform agenda is designed to improve services and lives for vulnerable children. We need a child protection system that ensures children and young people at Risk of Significant Harm (ROSH) are safe. They system needs to ensure those children that do need to be in state care are on a pathway to a good and productive future.

To achieve this, significant change is required in the way the system works. This means legislative, policy and cultural change across the sector and making our system more flexible, responsive and innovative.

At the heart of these reforms is placing children at the centre of the child protection system. Vulnerable children and young people need us to be proactive and timely. A key component of the reform agenda is to proactively promote good parenting and build the capacity of vulnerable parents to care for their children safely.

In addition to legislative reform, the Department of Family and Community Services has implemented other reforms and strategies to improve the way we protect children at risk.

These reforms include:

- Practice First, a NSW model for child protection and out-of-home care (OOHC) service delivery crafted to be a pragmatic fit with the current resourcing, legislative and policy framework in NSW;
- Structured Decision Making (SDM) tools have been introduced across the state to promote consistency in decision-making when reporting, screening or assessing child protection concerns. The SDM assessments are now a key tool to support NSW child protection system;
- The Intensive Family SupportPreservation Programs support families in crisis whose children and young people (aged 0-15 years) are at risk/imminent risk of removal and placement in OOHC;
- Strengthening Families, which works with families with a child under 9 years or an unborn child who is the subject of a ROSH report;
- Brighter Futures which deliver services and support to families with children aged under 9 years or who are expecting a child, where the child/ren are at high risk of entering the statutory child protection system, including OOHC; and
- Short Term Court Order and Family Preservation and Restoration Project combines legal options in the Children's Court with solid case planning and service provision so that long-term OOHC is avoided by intervening earlier and children are kept safe within their families.

The Department of Family and Community Services is also one of three partners involved in the Joint Investigation Response Teams (JIRT), along with the NSW Police and NSW Health. JIRT Teams enable inter-agency collaboration in responding to serious cases of child abuse, including sexual assault, and neglect.

Community Services is also establishing Child Protection Adolescent Response Teams in each of its regions to strengthen child protection case management to at-risk adolescents and their families.

\*3858 FAMILY ENERGY REBATE—Mr Guy Zangari asked the Minister for Resources and Energy, Special Minister of State, and Minister for the Central Coast—

What is the Government doing to ensure all eligible applicants are made aware of the \$75 Family Energy Rebate?

Answer-

Unlike the previous Government, the O'Farrell Government is committed to providing targeted, ongoing assistance to help households and families struggling to manage the impacts of the previous Government's legacy of power price rises.

The NSW Government continues to actively promote all of its assistance measures on offer, with over 940,000 households currently eligible to receive a rebate.

It should be noted that IPART has determined that NSW electricity bills would be \$171 cheaper from 1 July if Labor scrapped its carbon tax - a tax which has the full support of the NSW Labor Party.

There is no company with the name "Montage Group Vollay Contract Pty Ltd" registered with the Australian Securities and Investments Commission.

(a) One complaint lodged against Montage Group Pty Ltd also relates to Vollay Systems Pty Ltd.

(3) To date, Montage Group Pty Ltd has been issued with penalty notices for unlicensed contracting, taking excessive deposits, and a failure to provide home warranty insurance.

\*3864 TAFE NSW SYDNEY INSTITUTE—Mr Jamie Parker asked the Minister for Education—

- (1) How many positions are to be lost at TAFE NSW Sydney Institute?

- (1) In Stage 1 of the business reforms 36 positions will be declared excess. Stage 2 business reforms are yet to be finalised. Sydney Institute is undertaking business reforms in accordance with its obligations under Fair Work Australia and the NSW Government's Managing Excess Employees Policy.
- (2) In Stage 1 of the business reforms 31 teaching positions have been declared excess.
  - (a) No head teacher positions have been declared excess.
  - (b) No coordinator positions have been declared excess.
- (3) In Stage 1 of the business reforms 1 administrative position will be lost at Sydney Institute. Stage 2 business reform proposals are yet to be finalised.
- (4) Sydney Institute has not refused to allow voluntary redundancies. It has offered a number of voluntary redundancies in Stage 1 of the business reforms.
- (5) Sydney Institute will continue to review all aspects of its business to position itself to be competitive and sustainable into the future. Any future reforms could impact on Sydney Institute administrative staff.

  - (1) When did the Government make the decision to put a hold on accepting any new applications for the Constable Education Program and Rejoinee and Professional Mobility Employment applications?
  - (2) Can the Minister provide, in detail, the reasons for this decision?

I am advised that the NSW Police Force has had to put a temporary hold on accepting any new applications to the Academy, due to the number of applications already received and the fact that there are fewer officers leaving the Force. Over a thousand people are waiting to get into the Academy and start their training. It would be unfair to accept any additional applications when the number of officers leaving the Force, and therefore the number of vacancies, is at an all time low.

The hold on new applications is a temporary measure that will be monitored and reassessed by the NSW Police Force as part of its normal recruiting processes. Meanwhile, police numbers are at record levels, with the Government committed to achieving an authorised strength of 16,665 in August 2015.

\*3867 REMOVAL OF TREES—Mr Ryan Park asked the Minister for Transport representing the Minister for Roads and Ports—

This is part of an annual program for landscaping maintenance and upgrade of the original 1990s landscaping. The budget for the upgrade is \$100,000. New plantings along Memorial Drive will include the Callistemon variety.

There are guard fences on each side of the median as a safety measure.

\*3868 ECONOMIC ASSESSMENT OF MINING AFFECTED COMMUNITIES—Mr Clayton Barr asked the Deputy Premier, Minister for Trade and Investment, and Minister for Regional Infrastructure and Services—

With regard to the Economic Assessment of Mining Affected Communities (February 2013) and the Economic Assessment of Mining Affected Communities (December 2011):

- (1) Are the figures/tables displaying coal royalties per Local Government Area factually incorrect in both reports?
- (2) If both sets of figures, in both reports, are factually incorrect, can you confirm that the figures offered in response to Q 3496 are accurate?
- (3) Can you confirm that the independent auditor responsible for reviewing both sets of data was Hill Rogers Spencer Steer?
- (4) In either report, did the auditing firm raise any concerns about the figures being used?
- (5) Are you confident that NSW received value for money in the auditing process given the factual errors that have been highlighted?

(4) to (6) There are no factual errors in the Assessments.

(7) All local government authorities in NSW were surveyed in 2012. The NSW Association of Mining Affected Councils will have an opportunity to provide input to the Independent Assessment Panel on projects being considered for funding.

\*3869 NEWCASTLE URBAN RENEWAL STRATEGY—Mr Clayton Barr asked the Minister for Planning and Infrastructure, and Minister Assisting the Premier on Infrastructure NSW, Leader of the House—

- (2) How does the Government explain the contradictory statements in the two letters to social housing tenants?

The treatment of the carbon tax supplement in social housing rents is consistent with longstanding policy of including general income support as assessable income in calculating a household's rental subsidy.

Centrelink has no jurisdiction over social housing rent setting.

  - (d) All other Local Government Area's?

(1) (a) to (d) Heavy vehicle movement analyses were conducted for the local government areas for which a response to the survey conducted in 2012 was received. Of the three local government authorities identified, only Lake Macquarie responded to the survey. Mining-related heavy vehicle movements in the Lake Macquarie LGA were estimated at approximately 350 per day. I am advised:

- (1) CCTV cameras and help points are located at each of these stations. The NSW Police Transport Command patrols also cover these locations.
- (2) and (3) On 1 May 2012, the Police Transport Command formally took over responsibility for public transport network security.

The command will see 610 dedicated police officers patrolling public transport by the end of 2014. Further, 150 new Transport Officers will focus on fare evasion. The first tranche of Transport Officers commenced their responsibilities on 13 May 2013.

This important measure builds on our \$40 million Park and Travel Safety Fund to further improve CCTV on station platforms, on trains and in car parks; improve lighting in and around train stations; and increase help point reliability.

\*3879 LEGAL AID AND PUBLIC PURPOSE FUNDING—Mr Alex Greenwich asked the Attorney General, and Minister for Justice—

Noting that the Government's new Principles for Funding of Legal Assistance Services guidelines restrict funds from the Legal Aid & Public Purpose Fund:

- (1) To what extent does Principle 3 prevent funded legal centres from
  - (a) law reform and policy development?
  - (b) lobbying governments and elected officials?
  - (c) public campaigning and advocacy, including media and social media comment and public reform events?
  - (d) community education or training on advocacy skills?
  - (e) representing or advising activist groups, lobbying groups and action groups?
- (2) What consultation or negotiation was carried out with funded organisations before the new Principles were developed?
- (3) What concerns have been raised about the impact of the new Principles and limiting legal centres' capacity to fulfill their role?
- (4) What is the aim in restricting legal centres from involvement from their traditional vital role in law reform?
- (5) What plans does the Government have to ensure that legal centres can continue their role in law reform?

#### Answer-

I am advised:

The new Principles for Funding of Legal Assistance Services ("the Principles") are not intended to restrict funds from Legal Aid NSW and the Public Purpose Fund, but aim to ensure that the limited funds available are directed to those in the community who are most in need.

- (1) The goal of the Principles is to ensure that public funds for legal assistance services are primarily directed towards legal representation, casework and advice for disadvantaged people and vulnerable groups. The Principles also allow Community Legal Centres ('CLCs') to undertake a range of other activities to help disadvantaged people, including community consultation, community capacity building and the provision of factual information, research and advice on law reform and policy issues. The Principles seek to ensure that funding for legal assistance services is not applied towards political advocacy or activism.
- (2) Legal Aid NSW, which administers the CLC Program, was consulted on the Principles before they were finalised.
- (3) Some concerns have been raised about the meaning and impact of the Principles. For instance, some stakeholders have expressed concern that the Principles will lead to a reduction in funding for CLCs, and that the Principles will hamper the ability of CLCs to undertake law reform work and limit the

community's access to justice. Some of these concerns are based on a misunderstanding of the Principles. My Department and Legal Aid NSW will work with CLCs to ensure the Principles are not misconstrued and to assist CLCs with the implementation of the Principles.

- (4) The Principles do not aim to restrict CLCs from undertaking law reform work, but to focus limited resources on the areas for systemic reform that will have the most impact on vulnerable and disadvantaged people.
- (5) The Government expects that CLCs will continue to undertake law reform work. It is anticipated that CLCs will continue to contribute to law reform through submissions and participation in law reform consultative groups with other non-government organisations and the government sector.

\*3880 ANTI-DISCRIMINATION BOARD—Mr Alex Greenwich asked the Attorney General, and Minister for Justice—

- (7) How does the Government allocate funds to the Anti-Discrimination Board for its annual budget and when does the Attorney General's Department advise the Anti-Discrimination Board of its annual budget?
- (8) What plans does the Government have to facilitate and improve the Anti-Discrimination Board's operations and effectiveness?

- (1) to (8) Details of the activities conducted by the Anti-Discrimination Board (ADB) are provided in the ADB's annual report. Activities conducted prior to 1 July 2012, can be found in the past annual reports published online. Details of activities conducted from 1 July 2012 to date will be reported in the 2012-2013 annual report, to be made public shortly.
- \*3881 SOBERING UP CENTRES—Mr Alex Greenwich asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

With respect to the evaluation of Sobering-Up Centres:

- (1) What data does the Government have about similar facilities in other jurisdictions?
- (2) What data will the Government collect to carry out to identify a cost benefit analysis of these facilities?
- (3) What indicators will be used as measures for before and after outcomes?
- (4) What evaluation is proposed to assess the trial of Sobering-Up Centres?
- (5) What stakeholders and experts will be involved and how will they contribute to this evaluation?
- (6) When does the Government plan to report on this evaluation?
- (7) What further plans does the Government have to address alcohol abuse?

Answer—

I am advised:

Data from other Australian jurisdictions has been collected and assessed. An evaluation of the sobering up centres trial will be conducted by an external consultant appointed by Tender.

The evaluation plan will include analysis of the costs of running the Centres and consider these alongside the benefits to the local community. A range of outcome indicators will be measured, through the collection and analysis of data. The evaluation of the three Centres will include stakeholder consultations.

Since its election in 2011, the Government has made the misuse of alcohol a key focus. Initiatives to address this have included: enhanced move-on powers for police officers, a major overhaul of liquor laws designed to enhance public safety, reintroduction and modernisation of the 'intoxicated and disorderly' offence and public health campaigns encouraging drinkers to take responsibility for their own behaviour. This work is ongoing.

\*3882 DARLING HARBOUR EXHIBITION BUILDINGS REUSE—Mr Alex Greenwich asked the Deputy Premier, Minister for Trade and Investment, and Minister for Regional Infrastructure and Services—

- (1) What assessment has the Government made on the potential to disassemble and reuse existing exhibition buildings at Darling Harbour if redevelopment proposals are approved?
- (2) What conclusions has the Government made on the cost savings of reusing the building for other project proposals?
- (3) What action has the Government taken in response to the City of Sydney proposal to reuse two or more bays as a new fish market on the existing fish market site at Blackwattle Bay or at Glebe Island?
- (4) What other proposed projects has the Government identified which could benefit from the cost savings of using the buildings?
- (5) What further action will the Government take to reuse these buildings?

#### Answer-

(1) Engineering advisers undertook a review of the feasibility of reusing the Exhibition Halls. Their advice was that the existing roof and walls had reached the end of their useful life and only the structure could potentially be reused.

(2) The work undertaken to date indicates that any cost saving of reusing the steel structure is minimal and that this saving would be offset by the increased costs arising from the extra time and costs needed to dismantle the building to allow the structural steel to be reused.

(3) to (5) The Government will consider any viable cost effective options for reuse of the steelwork.

\*3883 RSPCA CONCERNS WITH PIG DOG HUNTING—Mr Alex Greenwich asked the Minister for Primary Industries, and Minister for Small Business—

With regard to concerns raised by the Royal Society for the Prevention of Cruelty to Animals in the 24 April Central Western Daily article "No justification for pig hunting":

- (1) What plans does the Government have to discuss concerns that recreational pig dog hunting is "cruel and cannot be justified in any circumstances"?
- (2) What investigation will the Government initiate in response to statements that feral animals are at the mercy of inexperienced hunters who are not always able to bring the animal down with a single shot to the head or heart?
- (3) What assessment will the Government make on the nature of pig dog hunting in hunting magazines and on the internet, given comments that the practices of using dogs to hold pigs is not only extremely cruel, but can cause injuries to the dogs, while stabbing the pig causes a prolonged, painful and distressing death?

#### Answer-

- (1) Under the Game and Feral Animal Control Act 2002 the hunting of feral pigs with dogs is a legal and approved method for licenced hunters to use on public land. Through the licensing process hunters are provided with education in hunting ethics and the humane destruction of animals, and are subject to a comprehensive code of conduct. In addition, all hunters on public and private land are subject to the provisions of the Prevention of Cruelty to Animals Act 1979.
- (2) Over the last seven years regulated hunters have spent more than 85,000 hunter days as volunteers removing more than 91,000 game and feral animals from public land in NSW. This has been achieved without any serious safety incident, injury or fatality to hunters, workers or the public and it has occurred with no reported incidents of animal cruelty.
- (3) It is legal to hunt pigs with dogs in NSW provided it is done ethically, humanely and in accordance with the Prevention of Cruelty to Animals Act 1979 and when on declared public land in accordance with the Game and Feral Animal Control Act 2002 and the NSW Hunting Code of Practice.

Illegal hunting may attract significant fines of up to \$5500, seizure and/or forfeiture of hunting equipment and may also attract criminal charges for various offences including those outlined in the Prevention of Cruelty to Animals Act 1979.

\*3884 NEONICOTINOIDS AND BEES—Mr Alex Greenwich asked the Minister for Primary Industries, and Minister for Small Business—

With respect to the European Union decision to ban neonicotinoids following a series of high-profile scientific studies linking neonicotinoids to devastation of bee colonies:

- (1) What assessment has the Government made of the
  - (a) Health of bee colonies in NSW?
  - (b) Dangers of neonicotinoids?
- (2) What action has the Government taken to ensure that pesticides do not impact on bees and pollination of crops?
- (3) What liaison has been carried out with other States and Territories about neonicotinoids?
- (4) What further action will the Government take to protect bee colonies and prevent these problems?

Answer—

(1) (a) The Department of Primary Industries (DPI) is aware of the North American and European phenomenon known as "Colony Collapse Disorder" (CCD) and have studied it with respect to any implications for Australian honeybees.

At this stage, Colony Collapse Disorder has not had a significant effect on NSW bee colonies.

(b) The Australian Pesticides and Veterinary Medicines Authority (APVMA) and the Australian Government Department of Sustainability, Environment, Water, Population and Communities (DSEWPaC) are both aware of the decision by the European Food Safety Agency to suspend the use of neonicotinoid pesticides pending further assessments of their safety to bees. The APVMA is currently examining the European decision and the information on which it is based prior to making any decision on the future of neonicotinoids in Australia.

- (2) DPI's apiary specialists work closely with the bee industry and the Environment Protection Authority to reduce pesticide risks to bees and to promote practices which benefit agriculture as a whole. At times this includes assisting with investigations of bee mortalities and providing advice to the APVMA regarding the circumstances around major bee poisoning incidents.
- (3) The APVMA is the national regulator responsible for assessing the safety of pesticides, including their effect on bees. The APVMA liaises regularly with states and territories on the progress of its considerations which are also communicated through the APVMA website.
- (4) APVMA has recently published a report of a study it commissioned to examine whether neonicotinoid insecticides present more of a risk to honey bee health than other pesticides that have been in use for many years. The APVMA is now considering this report together with recent assessments by the European Food Safety Agency and advice from national and international experts. The final assessment report from the APVMA is expected around the middle of this year at which time the future of the neonicotinoid insecticides in Australia should become clearer.
- \*3885 CARBON PRICING HOUSING COSTS—Mr Alex Greenwich asked the Minister for Family and Community Services, and Minister for Women—

Noting the Government has stated that social housing rents have been increased in order to cover increased housing costs resulting from the Commonwealth Carbon Pricing and Emissions Trading Scheme:

- (1) What data has the Government obtained or collected about increased costs for social housing providers?
- (2) What inputs for social housing were calculated to increase as a result of the Carbon Pricing and Emissions Trading Scheme?
- (3) What evidence and review was used to determine the level of increased cost for each tenant?
- (4) What assessment has the NSW Government made of measures to prevent or reduce these impacts?
- (5) What further plans does the Government have to prevent carbon pricing impacts hurting low income and vulnerable people?

#### Answer-

The treatment of the carbon tax supplement in social housing rents is consistent with longstanding policy of including general income support as assessable income in calculating a household's rental subsidy.

Most social housing tenants will continue to have their rents heavily subsidised by NSW taxpayers and

will continue to pay only 25 per cent of their household income on rent.

- \*3886 WHITEBRIDGE LAND SELL OFF—Ms Sonia Hornery asked the Minister for Planning and Infrastructure, and Minister Assisting the Premier on Infrastructure NSW, Leader of the House—
  - (1) What steps is the Government taking to ensure that Whitebridge residents are fully included in the decision making process regarding the sale of the Roads and Maritime Services (RMS) owned land in Whitebridge?
  - (2) (a) Does the Government recognize the importance of the land's biodiversity and its proximity to the renowned Fernleigh track?
    - (b) If so, why is the Government considering the sale of the land?

Answer-

I am advised that:

- (1) and (2) This question should be directed to the Minister for Roads and Ports and Deputy Leader of the Government in the Legislative Council, Mr Duncan Gay MLC.
- \*3887 ORICA BLAST OVERPRESSURE MAPS—Ms Sonia Hornery asked the Minister for Planning and Infrastructure, and Minister Assisting the Premier on Infrastructure NSW, Leader of the House—
  - (1) Why has the Government allowed Orica to keep blast "overpressure" maps for its ammonia nitrate manufacturing plant on Kooragang Island confidential?
  - (2) Will the Government take steps to make the "overpressure" maps publicly available?
  - (3) Can the Government guarantee the safety of residents living near the Orica plant?

Answer-

I am advised that:

(1) and (2) Some of the technical information in Orica's project application was provided to the Department in-confidence, for security reasons. This information was considered by the Department in its assessment of the application.

(3) All potentially hazardous facilities are subject to a rigorous risk assessment. Project applications for such facilities are not approved unless the risk assessment demonstrates that the facility does not pose significant risks to the surrounding area. In this regard, the NSW Government has had risk criteria for land use safety planning for more than 20 years, which are recognised nationally and internationally. The risks from the Orica facility meet these criteria.

\*3888 FUEL MONITORING SYSTEM—Ms Tania Mihailuk asked the Minister for Fair Trading—

Will the Government consider establishing a fuel monitoring system equivalent to that operated by the Western Australian Government called FuelWatch?

Answer-

The Federal Government unsuccessfully attempted to introduce FuelWatch nationally in 2008. It failed to pass the Senate because of concerns about:

• its anti-competitive nature-retailers could not reduce their prices for 24 hours; and

• the lack of proof of any reduction in the price of fuel in Western Australia.

The NSW Government is committed to improving price transparency for motorists on fuel prices. That is why during 2012, the NSW information standard for fuel price boards was reviewed and updated, with new requirements commencing on 1 September 2013.

I have also pursued the issue of improving fuel price board information at a national level.

There are already a number of smart phone apps, websites and email notification services available to NSW consumers that provide similar information to FuelWatch. Accordingly, there is no need for a NSW Government-backed FuelWatch scheme.

- \*3889 RESTRUCTURE FAIR TRADING COMPLIANCE AND ENFORCEMENT SECTION—Ms Tania Mihailuk asked the Minister for Fair Trading—
  - (1) How will the Minister ensure that Fair Trading undertake investigations into individual licensees and other operators, considered small, despite the ongoing restructure of Fair Trading Compliance and Enforcement?
  - (2) How many jobs have been lost as a result of restructure of the NSW Fair Trading Compliance and Enforcement section?

(3) How will job cuts affect the important work of NSW Fair Trading in prosecuting illegal business practices?

Answer—

The restructuring of NSW Fair Trading's Compliance and Enforcement Division has enhanced the agency's capacity to undertake investigations into individual licensees and other operators, whether small or large, across a range of industries.

Fair Trading has refocused its resources to maximise compliance and enforcement outcomes. The number of experienced Principal Investigators in the Division has increased, and a suite of dedicated Consumer Protection Officers has been established to monitor the marketplace and carry out compliance checks across a range of industries regulated by Fair Trading.

Fair Trading is becoming more strategic in the way it carries out its compliance and enforcement activities, using evidence based intelligence to target problem industries and take swift action. The recent establishment of a robust intelligence unit will ensure investigations are informed by marketplace trends. A National Projects team has been established to coordinate and drive Fair Trading's contribution to national and state/territory consumer protection projects and to lead key investigations on behalf of all consumer protection regulators.

The restructuring of Fair Trading's compliance and enforcement functions to better protect the integrity of the marketplace and take action against those who break the law is delivering improved compliance outcomes for New South Wales consumers. Fair Trading continues to undertake important compliance and enforcement activities across a range of key industries. Fair Trading is working closely with the NSW Police and other government agencies, including all consumer protection agencies, to take action, including prosecution action, against those who break the law.

\*3890 OPENING OF SERVICE NSW OPENING-Ms Tania Mihailuk asked the Minister for Fair Trading-

Will the Government ensure that no Fair Trading shop fronts are closed prior to a Service NSW service centre opening, so that communities are not deprived of a Fair Trading service for months on end?

Answer—

Service NSW will provide access to more than 840 transactions and services including driving licences and licences issued by NSW Fair Trading.

Following the commencement of Service NSW from 1 July 2013, Fair Trading Centres will cease providing counter services as Service NSW is progressively rolled out across NSW. Fair Trading will continue to provide dispute resolution services, compliance and community education programs.

In regional locations, Fair Trading will maintain a presence in current locations as Service NSW is rolled out. In the Sydney metropolitan area, some operations are being consolidated at Parramatta and Penrith.

Fair Trading is endeavouring to align the closure of counter services as near as possible to the commencement of local Service NSW centres.

In the interim period, customers are able to access Fair Trading services either online through Fair Trading's website (www.fairtrading.nsw.gov.au), by telephone on 13 32 20 or other metropolitan Fair Trading Centres at Hurstville, Penrith and Parramatta.

\*\* During the afternoon peak on Thursday 4 April, a truck jack-knifed southbound on the M7 Motorway at Bernera Road and became tangled in wire fencing. Heavy Vehicle Inspectors attended the scene and the time taken for them to arrive, complete their investigation and remove the truck from the fence resulted in a total clearance time of 202 minutes.

\*3930 ADDITIONAL SPEED CAMERAS INSTALLATION—Mr Ryan Park asked the Minister for Transport representing the Minister for Roads and Ports—

In relation to the Lot 10 Rookwood Cemetery to be developed as a Muslim/Jewish burial ground:

- (1) What will be required to ensure that the land is appropriate for burial?
- (2) Has subdivision of the lot occurred yet?
- (3) Who will pay for the subdivision process?
- (4) Who is expected to develop the land to prepare the land for appropriate use?
- (5) What will be the cost of (4)?
- (6) Who will be funding the development of the land?
- (7) If the answer to (6) is the Cemetery trust, will this have an impact on increasing burial fees?

Answer-

(1) All the soil within lot 10 has been relayed and compacted to accept burials with subsoil drainage and roads constructed to deal with surface drainage.

Within the Muslim section (eastern side of Lot 10), roads, paths and some beams to support headstones have been constructed and the area is ready to accept burials. The Jewish section (western side of Lot 10) will not be further developed until existing Jewish burial space within Rookwood is filled, likely in 10 to 15 years.

I formally opened the site on 8 May 2013.

(2) Under the Government's cemetery reforms, the Muslim, Jewish, Independent, Anglican and General Trusts were dissolved and replaced by a single new trust, the Rookwood General Cemeteries Reserve Trust (RGCRT). As the whole of Lot 10 is managed by the RGCRT, there is no need to subdivide Lot 10 into denominational areas.

An unformed section of Weeroona Road, owned by Auburn Council, is still to be closed and added to Lot 10 and Rookwood Necropolis. However, Council has consented to the works and occupation of this part of the road while the administrative process is finalised.

- (3) RGCRT.
- (4) RGCRT has completed these works.
- (5) RGCRT advises that the cost of developing Lot 10 to the current stage has been approximately \$6m, which has included the relocation of significant electricity and gas services through the site.
- (6) RGCRT.
- (7) No, the price of a burial licence will be same as that charged in other areas of the Cemetery managed by RGCRT.

\*3936 BORONIA ROAD NO STOPPING ZONES REVIEW—Ms Tania Mihailuk asked the Minister for Transport representing the Minister for Roads and Ports—

\*3944 CTP NO-FAULT SCHEME—Ms Tania Mihailuk asked the Treasurer, and Minister for Industrial Relations representing the Minister for Finance and Services, and Minister for the Illawarra—

How will the Minister ensure that a move to a CTP no-fault scheme which allows negligent motorists to apply for compensation will not lead to:

(1) a significant rise to the number of claims; and

(2) an increase in the cost of premiums?

Answer—

The Motor Accident Injuries Amendment Bill 2013 proposes a new first party, no-fault CTP Scheme which is expected to cover up to 7,000 additional people who were at fault in an accident.

The introduction of capped statutory benefits will reduce insurer uncertainty, thus reducing the long term reserving which has led to excessive insurer profits. The new Scheme will also have reduced legal and investigation involvement and costs, and limits on insurer expenses.

The Bill in its current form ensures that these savings will offset the additional costs associated with providing benefits for all those injured in motor vehicle accidents.

This can be provided by an initial triple zero caller or an attending emergency service or paramedics on scene. The dispatch of an ambulance is governed by the Ambulance Control Centres.

The Information Commissioner reports directly to the Parliament and the Joint Committee on the Ombudsman, the Police Integrity Commission and the Crime Commission oversees the Information Commissioner's functions.

The primary focus of the Information and Privacy Commission (IPC) is to conduct reviews and investigations, however it also monitors the outcomes of its recommendations at a general level.

From June 2013 the IPC intends to publish statistical reports on its IPC website. Additionally, the Commissioner will be providing a comprehensive report for this financial year and the overall results of the audit and monitoring activities undertaken by the IPC will be collected into reports to be published later in 2013.

In 2014 the Department of Attorney General and Justice will commence a review of the GIPA Act to determine whether the policy objectives of the Act remain valid and whether the terms of the Act remain appropriate for securing those objectives. This is in accordance with section 130 of the GIPA Act.
