- *4289 WATER SAFETY PROGRAMS—Mr Richard Amery asked the Minister for Sport and Recreation—
 - (1) How does the Government support learn to swim and water safety programs in the Blacktown Local Government Area?
 - (2) What plans are in place for the coming summer to promote water safety and learn to swim programs for the Mount Druitt electorate?
 - (3) Are there any learn to swim programs provided at the Mount Druitt Swimming Pool?
 - (4) Did Blacktown Council consult with the Minister or his department about the planned closure of the Mount Druitt Swimming Pool?

Answer-

- (1)-(3) Information on the Swim and Survive learn to swim program can be found at www.dsr.nsw.gov.au/swimandsurvive.
- (4) Blacktown City Council did not consult with Sport and Recreation about the closure of the Mount Druitt Swimming Pool. They are under no obligation to do so as the operation of local swimming pools is the responsibility of local governments.
- *4290 MOUNT DRUITT PUBLIC HOUSING—Mr Richard Amery asked the Minister for Family and Community Services, and Minister for Women—
 - (1) Since the election of the Government in March 2011, how many dwellings have been added to the public housing stock in the Mount Druitt area?
 - (2) What are the projections for the coming year in relation to an increase in public housing stock in the Mount Druitt area?

Answer-

- (1) Around 40 new public housing dwellings in the Mount Druitt area have been completed since March 2011.
- (2) The budget for new supply across New South Wales is included in the Budget Papers.
- *4291 LOCAL ABORIGINAL LAND COUNCILS—Ms Linda Burney asked the Minister for Citizenship and Communities, and Minister for Aboriginal Affairs—

Regarding the New South Wales Government funding of the Wagonga, Merriman's and Bodalla Local Aboriginal Land Councils (LALC) since 1983:

- (1) How much funding does the Government provide to each of the above LALCs each year over the last 10 year period?
- (2) How much land is under the control of each of these three LALCs?
- (3) How many houses do each of these three LALCs manage?
- (4) Why were homes that Aboriginal people believed they would own under the NSW Aboriginal Lands Trust taken away from them after the formation of the LALCs?
- (5) Do Aboriginal families have any opportunity through the LALCs to acquire their own home or land?
- (6) Is any consideration given to Aboriginal families who have lived in a LALC home over many generations to acquire this home?
- (7) Has the Government done anything to enquire into the deaths of Aboriginal people in these three LALCs over the past 20 years?
- (8) How many of these Aboriginal people were denied access to resources, particularly a permanent home and health care?
- (9) What processes are in place to ensure that all Aboriginal people within the boundary of these LALCs share in the funds distributed by the NSW Government to provide housing and health care to all resident Aboriginal families?
 - (a) Have any of the three corruption prevention recommendations made by the Independent Commission Against Corruption to the Minister and the Government in regards to the Wagonga Land Council been instituted?
 - (i) In particular Recommendation 3: "That the Minister for Aboriginal Affairs considers a review of the operation of Part 10 of the Aboriginal Land Rights Act 1983 in meeting the expectations of the land rights network by excluding individuals who have been found to have engaged in corrupt conduct or in serious misconduct for a period of up to five years."

Answer-

(1) The Government does not fund Local Aboriginal Land Councils on an annual basis. Annual funding allocations are made by the NSW Aboriginal Land Council.

However, in the last 10 year period the Government has directly provided the following approximate funding:

- Wagonga LALC: \$4.5M (water & sewerage infrastructure)
- Merrimans LALC: \$0.5M (water & sewerage infrastructure/asbestos clean-up)
- Bodalla LALC: \$0
- (2) The Government does not hold information regarding the land holdings of Local Aboriginal Land Councils.
- (3) The Government does not hold information regarding the land holdings of Local Aboriginal Land Councils.
- (4) Homes vested in the Aboriginal Lands Trust under the Aborigines Protection Act 1969 were never privately owned by tenants. The management of the homes were transferred to Local Aboriginal Land Councils in 1983 when the Aboriginal Land Rights Act 1983 commenced operation, whereby Local Aboriginal Land Councils became the legal landlords.
- (5) Local Aboriginal Land Councils may initiate housing acquisition schemes to enable Aboriginal families to purchase homes. However, any scheme must be in accordance with the provisions of the Aboriginal Land Rights Act 1983, specifically in relation to land dealings (Part 2, Division 4), Community, Land and Business Plans (Part 5, Division 6) and Community Benefit Schemes (Part 5, Division 1A, Section 52A), and with the approval of their members and the NSW Aboriginal Land Council.
- (6) As above.
- (7) The Government is unaware of any deaths in relation to the Local Aboriginal Land Councils in question.
- (8) Matters relating to health and home care are the respective responsibility of the Minister for Health, the Hon Jillian Skinner MP and Minister for Ageing and Disability Services, the Hon John Ajaka MP
- (9) Matters relating to housing and health care are the respective responsibility of the Minister for Community Services, the Hon Pru Goward MP and the Minister for Health, the Hon Jillian Skinner MP
- (10) The Government is presently considering changes to Part 10 of the Aboriginal Land Rights Act 1983, which has been made public in a discussion paper on proposed regulatory reforms and statewide consultations as part of the five year statutory review of the Act.
- *4293 CASEWORKER ASSESSMENT CENTRES—Ms Linda Burney asked the Minister for Family and Community Services, and Minister for Women—

During your tenure as Minister:

- (1) How many caseworkers have gone through assessment centres?
- (2) Have there been no assessment centre recruits?

Answer—

From April 2011 to 30 August 2013, around 1,000 applicants have attended an assessment centre. Successful candidates are placed on an eligibility list and offered positions as vacancies arise in their preferred locations.

*4294 SYDNEY BUSES—Mr Ron Hoenig asked the Minister for Transport—

Regarding TripView, TripGo and ArrivoSydney, the three applications developed for customers travelling on Sydney buses:

- (1) Do the applications accurately track the arrival time of Sydney buses in bus regions 6-9 in the Eastern Region of Sydney?
- (2) Do the applications accurately track the location of Sydney buses in bus regions 6-9 in the Eastern Region of Sydney?
- (3) Are there any inherent faults in the applications that cause them to fail to provide commuters with full and accurate information as to the timetabling and location of their bus service?
- (4) Since introducing the applications in December 2012, has the Department conducted a detailed review as to the reliability and effectiveness of these applications?

Answer-

We have delivered real time bus tracking and real time train apps for customers through smart phone applications. Seven real time apps are now available, including TripView, TripGo, Arrivo Sydney, Hidden City, Triptastic, Transit Times+ and Jaunt! Sydney. Customers can use their smart phones to locate where buses and trains are on their route and when they will arrive. They can also get directions to the closest bus stop and train station, as well as locate where to buy tickets. *4295 REDFERN STATION—Mr Ron Hoenig asked the Minister for Transport—

- (1) Has Redfern Train Station recently stopped the sale of concession tickets from vending machines outside of peak hours?
- (2) If so, why?

Answer—

I am advised:

To promote a fairer system by targeting fare evasion, changes were recently introduced to the way concession tickets can be purchased at selected stations, including at Redfern Station.

At these selected locations, concession tickets are only available from ticket vending machines before 9.00am Monday to Friday, on weekends and public holidays and when the ticket office is closed. More information can be viewed on the Sydney Trains website at www.sydneytrains.info.

*4300 FAULTY SPEED CAMERAS—Mr Ryan Park asked the Minister for Transport representing the Minister for Roads and Ports—

- (1) Since 1 April 2011, how many speed cameras, red light cameras, point to point cameras, and mobile speed cameras have been found to be faulty?
- (2) Since 1 April 2011, how many requests have been made by Roads and Maritime Services to the Office of State Revenue to not proceed with penalties issued in relation to a faulty camera?
- (3) Since 1 April 2011, how many infringment notices have been refunded as a result of camera error?
- (4) Do motorists have to initiate the process of recovering this money?

Answer-

I am advised:

(1) Fixed digital speed cameras in New South Wales are subject to calibration and accuracy certification procedures for the approved traffic enforcement device, under Clause 35of the Road Transport Regulation 2013 and under Section 137 of the Road Transport Act 2013. Under this Act there is also a requirement to perform a Section 138 certification of camera-recording devices at 30 day intervals. This Act also applies to red light cameras.

Speed cameras are the subject of comprehensive and regular maintenance, testing and certification before approval for use. They are monitored online 24 hours a day seven days a week and any issues that arise are dealt with as soon as possible to ensure motorists are not incorrectly fined. This strict testing regime ensures cameras are working accurately in detecting vehicles exceeding the speed limit and/or running a red light.

Motorists can check the testing certificates relevant to their offence by logging into the State Debt Recovery Office website on www.sdro.nsw.gov.au and clicking a "view camera images" icon located on the right of the screen, which then takes them through the process to view the image, then request the dates of certification. Offence images are only viewable to the registered owner or nominated driver of a vehicle detected exceeding the speed limit and in receipt of a penalty notice.

The camera detects the passing of all vehicles and there are several factors which may cause the flash to be triggered. It is only when the calculations within the camera computer confirm that an offence has been committed, either exceeding the speed limit or running a red light, that the image of the vehicle will be captured for processing.

If there is ever any concern about the operation of a speed camera it is taken offline while a comprehensive investigation is carried out. Any penalties issued to motorists by a camera later found to have a fault are withdrawn.

- (2) Roads and Maritime Services advise that no requests were made by RMS to the Office of State Revenue to cease adjudication of an incident created by a faulty camera.
- (3) None.
- (4) No.

- *4301 TRUCK EXHAUST SMOKE IN M5 EAST TUNNEL—Mr Ryan Park asked the Minister for Transport representing the Minister for Roads and Ports—
 - (1) Since 1 March 2013, how many truck operators have been fined for excessive exhaust smoke in the M5 East tunnel?
 - (2) Did all of these truck operators receive a fine of \$2,000?
 - (a) If not, how many did receive a fine of \$2,000?
 - (b) Did any of the truck operators have their licence suspended?
 - (3) How many truck operators have had their vehicles retrofitted?
 - (a) How many vehicles does this equate to?

Answer-

I am advised:

(1-2) The first and second penalty notices are for \$2,000. On the third infringement, the vehicle is issued a \$2,000 penalty notice and a three month suspension of the registration.

As at 5 August 2013, 96 penalties of \$2,000 had been issued and five vehicles had been issued with a second penalty notice of \$2,000.

As at 19 August 2013, 107 penalties of \$2,000 have been issued and six vehicles have been issued with a second penalty notice of \$2,000.

(3) As at 5 August 2013, four vehicles had signed up to the diesel retrofit program.

As at 19 August 2013, of the seven vehicles now signed up, \$18,000 has been paid for three vehicles.

- *4302 APPIN ROAD—Mr Ryan Park asked the Minister for Transport representing the Minister for Roads and Ports—
 - (1) Since 1 April 2011, what specific investigations and improvements have been undertaken in relation to Appin Road?
 - (2) What, if any, further improvements are planned?
 - (a) When will this work start?
 - (b) What is the budget allocated for these improvements?

Answer-

I am advised:

- (1) Since 1 April 2011, Roads and Maritime Services has carried out the following work on Appin Road:
 - Rehabilitation of the pavement from Loddon River to Dharwal State Conservation Area turn off, completed on 15 May 2011.
 - Rebuilding of the road west of Westcliffe Colliery, completed on 7 May 2012, and resurfacing the road between Bulli Tops and Loddon River, completed on 21 March 2012.
 - Resurfacing between Illawarra Street and Wilton Road, completed on 17 October 2012.
 - Repair of damaged bridge bearings on Appin Road Bridge.
 - Installation of roadside barriers west of Baden Powell Drive to address the most common crash type on Appin Road where vehicles run off the road and hit an object.
- (2) Work planned to be completed on Appin Road in 2013-14 includes:
 - Rehabilitation of the pavement from the Wollondilly Shire Council boundary to 750 metres west of the westbound rest area.
 - Resurfacing of 750 metres of pavement, 1.2 kilometres west of Wedderburn Road.

These two projects have a total cost of \$640,000 and are scheduled for completion by June 2014.

- *4303 WOONONA EAST PUBLIC SCHOOL—Mr Ryan Park asked the Minister for Education—
 - (1) Are demountables in use at Woonona East Public School?
 - (a) If so, are they adequate for the needs of the students and teachers?
 - (2) Are there plans to improve building facilities at Woonona East Public School?
 - (a) If so, what are these plans;
 - (b) If so, what is the time line for these plans;
 - (c) If so, what is the budget for these plans?

Answer-

(1) Yes.

(a) Yes.

(2) Yes.

A project to upgrade the facilities at Woonona East Public School, including the construction of new, permanent administration, staff study, library facilities, and classrooms; and to back convert Block A for classrooms, has been nominated for funding consideration in a future capital works program. The project will continue to be assessed for funding against competing priorities in all government schools.

*4304 RESTART ILLAWARRA INFRASTRUCTURE FUND—Mr Ryan Park asked the Minister for Family and Community Services, and Minister for Women representing the Minister for Ageing, Minister for Disability Services, and Minister for the Illawarra—

In relation to the Restart Illawarra Infrastructure Fund:

- (1) Will the Government publicly release all applications made to the Fund, including those not shortlisted?
 - (a) If so, when?
 - (b) If not, why not?
- (2) Will the Government publicly release the assessments of all projects, including those not shortlisted?
 - (a) If so, when?
 - (b) If not, why not?
- (3) Will the Government make public the assessments of the shortlisted projects, including the investigations into the validity of job creation and economic benefit information provided?

Answer—

- *4305 WESTPAC RESCUE HELICOPTER—Mr Ryan Park asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
 - (1) What evidence did the Government use to support the downscaling of the Westpac Rescue Helicopter Service?
 - (2) What alternative arrangements are going to be in place should people require this service when it is not operating?
 - (3) Why was \$1.5 million funding for this service announced in June 2012 if the service was to be downgraded 12 months later?

Answer-

The Government is committed to the ongoing operations of the Westpac Life Saver Rescue Helicopter (Southern Region). This is reflected in the Government's commitment to the provision of \$1.1 million in funding per year to the service over the next four years, which is \$4.4 million to 30 June 2017. In 2012-13 the Government provided \$1.5 million in funding.

Under the previous Government only \$800,000 in funding was provided shortly before March 2011 as a one off payment without an ongoing commitment to funding.

- *4306 FREE SHUTTLE BUS SERVICES—Mr Ryan Park asked the Minister for Transport—
 - (1) How are the buses that serviced the recently terminated free shuttle bus services in the districts of Liverpool, Blacktown, Bankstown, Penrith, Newcastle and Campbelltown now being used?
 - (2) How much has the Government saved by ending these free shuttle bus services?
 - (3) What are the current estimated daily usage levels of Wollongong's free "Gong Shuttle" bus service?
 - (4) What are the estimated costs of increasing the number of "Gong Shuttle" buses?
 - (5) Does the Government currently have plans to increase "Gong Shuttle" services?
 - (a) If not, why not?

Answer-

As you are aware, the Government recently reviewed the role of free shuttle buses in the transport network. The Wollongong free shuttle bus was retained, but others which attracted low patronage or duplicated other routes have been discontinued.

It is regrettable that proper network planning did not underpin the introduction of the shuttles when they

were rushed into service in the lead-up to the last election.

- *4307 FREIGHT AND PORTS STRATEGY—Ms Anna Watson asked the Minister for Transport representing the Minister for Roads and Ports—
 - (1) When will the Government release its Freight and Ports Strategy?
 - (2) Why has the Strategy scheduled for release in mid 2013 not been released?

Answer-

I am advised:

- (1) The final New South Wales Freight and Ports Strategy will be released later in 2013 subject to Cabinet approval.
- (2) This is the first time the Government has produced a Freight and Ports Strategy and the priority was to ensure extensive consultation was undertaken and considered in the development of the final Strategy.
- *4308 YALLAH TO OAK FLATS UPGRADE—Ms Anna Watson asked the Minister for Transport representing the Minister for Roads and Ports—
 - (1) Has the Government formally requested funding from the Commonwealth Government under the Nation Building Program towards construction of the Yallah to Oak Flats upgrade?
 - (2) If not, why not?

Answer-

I am advised:

- No.
- (2) Projects were prioritised for submission for Commonwealth Government funding under the Nation Building Program taking account of considerations such as delivery timeframes. Projects other than the Yallah to Oak Flats upgrade were considered able to be delivered within the Nation Building Program timeframes.
- *4309 MENTAL HEALTH SERVICES PLAN—Ms Anna Watson asked the Minister for Mental Health, Minister for Healthy Lifestyles, and Minister for Western New South Wales—
 - (1) When will the Government release its Mental Health Services Plan for the Illawarra and South Coast region?
 - (2) Why has the release of the plan been delayed past the scheduled June 2013?

Answer-

The development of a Mental Health Services Plan for the Illawarra Shoalhaven Local Health District was identified in the Illawarra South Coast Regional Action Plan. The final draft of the Plan has been reviewed by the District Board, and the District is now awaiting final review of the Plan by the newly appointed Director of Mental Health prior to publication.

*4311 RENEWABLE ENERGY ACTION PLAN—Ms Anna Watson asked the Minister for Resources and Energy, Special Minister of State, and Minister for the Central Coast—

When will the Government release its Renewable Energy Action Plan?

Answer-

The Renewable Energy Action Plan has been released.

*4312 ILLAWARRA REGIONAL TRANSPORT PLAN—Ms Anna Watson asked the Minister for Transport—

When will the Government publicly release the Illawarra Regional Transport Plan?

Answer-

The Government is currently developing Regional Transport Plans, which will specifically address the needs of regional customers. We are working with local government, stakeholders and local communities across New South Wales to ensure the unique future transport needs and requirements of the Illawarra region are carefully considered.
