- *6019 TRAIN TIMETABLE COMPLAINTS—Mr Nick Lalich asked the Minister for Transport, and Minister for the Hunter—
 - (1) How many complaints about the train timetables were received by Transport for NSW for each of the years from 2011-13?
 - (a) How many of these complaints were from commuters who reside in the Cabramatta electorate?

Answer-

I am advised:

Feedback about the timetable is appreciated. We will continue to closely monitor the performance of the timetable.

- *6020 TEACHERS' AIDES—Mr Nick Lalich asked the Minister for Education—
 - (1) How much has been allocated to the Cabramatta electorate for teachers' aides in Government schools for the 2014-15 financial year?
 - (a) Has this allocation increased or decreased in the last four financial years?

Answer-

For the 2014-15 financial year more than \$990,000 was allocated to the 15 public schools in the Cabramatta electorate to support students with disability and additional learning and support needs in regular classes.

In addition, in 2014 there are 26 specialist support classes across five regular schools and one special school in the Cabramatta electorate.

The funding allocated for the 2014-15 financial year has increased when compared to the 2010-11 financial year.

*6021 FAIRFIELD AND LIVERPOOL HOSPITAL COMPLAINTS—Mr Nick Lalich asked the Minister for Health, and Minister for Medical Research—

How many complaints about Fairfield and Liverpool hospitals were received in:

- (a) 2012; and
- (b) 2013?

Answer—

I am advised:

Of the 28,814 admissions to Fairfield Hospital in 2012 there were 113 complaints. Of the 29,610 admissions to Fairfield Hospital in 2013 there were 116 complaints.

Of the 70,370 admissions to Liverpool Hospital in 2012 there were 538 complaints. Of the 73,738 admissions to Liverpool Hospital in 2013 there were 467 complaints.

- *6022 SENIOR CITIZEN SUPPORT PROGRAMS—Mr Nick Lalich asked the Minister for Family and Community Services representing the Minister for Ageing, Minister for Disability Services, and Minister for the Illawarra—
 - (1) What programs are available in Cabramatta to help senior citizens maintain independent and healthy lifestyles?
 - (2) How much funding does the Government provide to support senior citizens in Cabramatta?

Answer—

(1) - (2) There are a variety of local service programs available in the Cabramatta area across government, non-government and business sectors.

Answer—

I regularly visit Western Sydney in my capacity as Minister for Western Sydney. Information regarding scheduled meetings held with stakeholders, external organisations and individuals will be published in accordance with Memorandum 2014-07 - Publication of Ministerial Diaries.

Answer-

The Bonnyrigg Men's Shed operates under the auspice of Parks Community Network Inc. Details about funding provided to the Network is available in the Department of Family and Community Services (FACS) Annual Report.

- *6025 RESTART ILLAWARRA INFRASTRUCTURE FUND—Ms Anna Watson asked the Minister for Family and Community Services representing the Minister for Ageing, Minister for Disability Services, and Minister for the Illawarra—
 - (1) Has the Government signed a contract with Wollongong City Council regarding the West Dapto Access Road Link for \$22.5 million under the Restart Illawarra Infrastructure Fund?
 - (a) If not, why not?
 - (2) Has the Government signed a contract with the Illawarra Retirement Trust Ltd regarding the care and community centre for \$2.9 million under the Restart Illawarra Infrastructure Fund?
 - (a) If not, why not?
 - (3) How many of the approved projects funded under the Restart Illawarra Infrastructure Fund have actually commenced construction to this date?
 - (4) What are the reasons for the delays in starting the projects funded under the Restart Illawarra Infrastructure Fund?

Answer-

- (1) (4) The 12 projects awarded funding through the \$100 million Illawarra Infrastructure Fund are large scale, high worth projects. The Government is doing its due diligence and ensuring that all of the projects have provided the necessary information and approvals before they progress. This is to ensure that projects funded through Restart deliver the best economic and social outcome possible for Illawarra. The projects are progressing and Infrastructure NSW is responsible for administering the funding agreements.
- *6026 TAFE ENROLMENTS—Ms Anna Watson asked the Minister for Education—

Answer-

TAFE NSW data is recorded by the number of enrolments, not students.

TAFE NSW enrolments by campus are not publicly available. However, enrolments by Institute are published on the TAFE NSW website.

2013 enrolments data by Institute is publicly available in the 2013 TAFE NSW Statistical Compendium at www.tafensw.edu.au/about/assets/pdf/TAFE-NSW-Statistical-Compendium-2013.pdf.

The 2014 TAFE NSW Statistical Compendium will be loaded onto the TAFE NSW website by mid-2015.

*6027 INFRASTRUCTURE PROJECTS IN THE ILLAWARRA—Ms Anna Watson asked the Premier, Minister for Infrastructure, and Minister for Western Sydney—

- (1) Will the Premier ensure that any infrastructure projects included in the sale of poles and wires in the Illawarra must undergo a cost benefit analysis?
- (2) Will any such cost benefit analysis be completed before or after the sale of the State's poles and wires?
- (3) Will these cost benefit studies be released to the public?
 - (a) If so, when?
 - (b) If not, why not?

Answer—

The Government is committed to Rebuilding NSW by unlocking an additional \$20 billion for rebuilding the State's infrastructure by leasing 49% of New South Wales' electricity network or "poles and wires" assets

Rebuilding NSW will improve access to roads, public transport, schools, hospitals, sports and cultural facilities.

Infrastructure NSW will provide an updated State Infrastructure Strategy to the Government later this year. Proposed projects will be assessed by Infrastructure NSW in accordance with existing processes.

- *6028 SHELLHARBOUR HOSPITAL REDEVELOPMENT—Ms Anna Watson asked the Minister for Health, and Minister for Medical Research—
 - (1) What are the remaining administrative requirements, once the planning associated with the Shellharbour Hospital redevelopment is finalised in 2014, before funding for the redevelopment is allocated by the Government?
 - (2) What is the reason for the discrepancy in estimated completion time for the planning of the Shellharbour Hospital redevelopment which was stated to be completed in 2014 (ref Q.5908), and also 2016 (ref 2014-15 Budget papers)?
 - (3) Did any other construction companies submit tenders for the \$6.7 million Ambulatory Care Expansion project at Shellharbour Hospital?
 - (a) If so, what were the names of these companies and their locations?
 - (4) Will the preferred tenderer in the case of the Ambulatory Care Expansion project at Shellharbour Hospital employ Illawarra based subcontractors on the project work?
 - (a) If so, which work?
 - (b) If not, why not?

Answer-

I am advised:

- (1) Prior to the allocation of any capital funding, the final business case is endorsed by the Ministry of Health and issued to Treasury for inclusion in the budget process for funding consideration. The 2016 reference completion date in the 2014-15 Budget papers is an administrative function of the budget process. The actual project completion date remains at early 2015.
- (2) The 2016 referenced completion date in the 2014-15 Budget papers is an administrative function of the Budget process.
- (3) The tenderers for the Shellharbour Ambulatory Care project were selected by Health Infrastructure from the Department of Finance & Services, Prequalified List of Capable Contractors. This list filters prequalified contractors based on the selected project value, region, procurement method, type of project and experience. The selection of the preferred tenderer is done by a panel based on a range of non-price and price criteria.
- (a) The other tenderers were:
- · Donnelly Constructions whose head office is in Sydney.
- Kane Constructions with offices in Sydney, Brisbane and Melbourne.
- Zauner Constructions who is a regional builder with an office on the South Coast.
- (4) The project is being delivered under a construction management form of contract. As such, Health Infrastructure will have transparency during the selection and assessment of subcontractor tenders. Health Infrastructure have put in place with the principle contractor, Fugen Constructions, a process for assessing the subcontract tender with criteria that includes local industry participation and Aboriginal participation, along with other price and non-price criteria.

In addition, Fugen Constructions placed an advertisement in the local papers asking for expressions of interest from suitably qualified subcontractors to tender on the project.

I have been advised to date that only a limited number of subcontracts have been tendered, however they have included local firms or firms that have personnel living locally. In addition I note that the Site Manager on the project lives locally.

Answer-

I am advised:

Roads and Maritime Services anticipates that planning and approval will be completed in 2016.

Roads and Maritime Services is undertaking a series of investigations including complex traffic modelling. These investigations are at an early stage and it is not yet known when the results of these investigations will be finalised.

The work being undertaken is preliminary information gathering, investigation and planning work for improvements to the M1 Princes Motorway between Figtree and Dapto. These improvements will consider the impacts of planned development in the Dapto area and traffic growth from surrounding areas.

Roads and Maritime Services anticipates publishing a report when the preliminary information gathering, investigation and planning work are complete.

- (1) In 2013-14, six projects were nominated for Woonona East Public School and all were considered for funding against competing projects across all New South Wales government schools.
- (2) In 2013-14, five projects were nominated for Figtree High School and all were considered for funding against competing projects across all New South Wales government schools.

- (1) (2) More than 700,000 Opal cards have now been issued. Over 37 million journeys have been taken by customers using the Opal card.
- (3) Level crossings are prioritised for safety upgrades according to a range of criteria.
- (4) I regularly visit stations across the network and will continue to do so.
