Question on Notice 21 May 2018

I appeared as a witness before the Committee on Monday 21 May 2018 as part of its inquiry into the Operation of the Legislation Review Act 1987. This appearance was on behalf of the Public Interest Advocacy Centre in relation to our submission to this inquiry.

During giving evidence, I took the following question on notice: Mr David Shoebridge: Are there any international covenants on the rights of business? Mr Lawrie: Not that I am aware of, but I can take that question on notice.

The United Nations Office of the High Commissioner for Human Rights states that there are nine core international human rights instruments, and a total of 18 key human rights instruments including optional protocols. These instruments are listed on the following page.

None of the 18 key human rights instruments, including optional protocols, are primarily concerned with the 'rights of business'.
