

- (1) That this House notes that on 25 November 2024, the City of Sydney Council unanimously passed a resolution moved by Greens Councillor Matthew Thompson, which resolved that Council:
 - (a) endorse the community campaign for disabled workers to be paid a minimum wage through abolishing the supported wage system, ensuring companies and Australian Disability Enterprises pay disabled workers the same as everyone else,
 - (b) support, in principle, a ban on providing grants, funding, and other forms of support, including non-financial support, to Australian Disability Enterprises or companies that pay their workers less than the national minimum wage, and
 - (c) sign on to the open letter demanding that subminimum wages for disabled workers be abolished, joining over 37 other national organisations and 223 state and local organisations.
- (2) That this House commends City of Sydney Council for being the first council in Australia to publicly commit to banning subminimum wage for disabled workers, which marks a significant moment in driving change to create an inclusive, fairer and equitable society for all.
- (3) That this House calls on the NSW Government to:
 - (a) commit to creating a statewide strategy with a clear timeline for abolishing subminimum wage for disabled workers, and
 - (b) advocate to the Federal Government to abolish subminimum wages nationwide as a matter of priority, alongside action to implement the Disability

Royal Commission's call to reduce workplace segregation and achieve pay parity for people with disability by 2034.

(1) That this House notes that:

- (a) following the unjust arrest, detainment, and death of Mahsa Amini at the hands of Iranian “morality police” for not properly covering her hair, many women in Iran have been protesting the state demanding equal rights and greater freedoms;
- (b) labelled the “Women, Life, Freedom” movement, the series of protests has become a key icon in the struggle for social justice and equality in Iran;
- (c) politically and socially active women in Iran are especially at risk of arrest, torture, and imprisonment, and risks are compounded for women who are ethnic, religious, or political minorities;
- (d) in 2023 alone, 24 women were executed in Iran following the “Women, Life, Freedom” Protests, of whom many were Kurdish;
- (e) these women are met with systemic flaws in Iran’s judicial system, including fabricated charges, torture and coerced confessions, and opaque trials where they are denied access to legal representation during key phases of their trials; and
- (f) when these women are unjustly sentenced to prison, the conditions they face are those of physical and psychological torture, denial of medical care, isolation, harassment, and restricted communication.

(2) That this House:

- (a) recognises the bravery and courage of the Women, Life, Freedom movement and stands in solidarity with those fighting for gender equality and liberation, including Kurdish women activists Verishe Moradi, Pakshan Azizi, and Zeinab Jalalian;
- (b) calls for the revocation of death sentences placed upon Kurdish women activists, including Verishe Moradi and Pakshan Azizi, and calls for the release of all political prisoners in Iran;
- (c) advocates for greater scrutiny into torture allegations and judicial misconduct by the Iranian state;
- (d) supports the abolition of the death penalty in Iran and around the world; and
- (e) demands psychological and financial assistance to the families of political prisoners.

(1) That this House notes that:

- (a) Domestic Violence NSW (DVNSW) has published its evidence-based funding needs for the 2025-26 financial year in its NSW Pre-Budget Submission 2025-26, which is underpinned by member consultation, sector engagement and analysis of latest research and includes the following two key priorities:
 - (i) a 50 percent baseline funding increase for all specialist domestic and family violence services, so that frontline services have sufficient resourcing to meet demand (\$163 million), and
 - (ii) a 50 percent increase in brokerage for specialist domestic and family violence services (\$8.3 million),
- (b) according to DVNSW, a baseline funding increase for specialist domestic and family violence services has remained absent in state budgets to date, despite domestic and family violence rates in NSW continuing to rise, with many specialist services stretched to capacity and unable to meet demand. A 50 percent baseline funding increase for specialist domestic and family violence services would help bring NSW in to line with Queensland, although it would still remain far behind Victoria which spends almost three times as much as NSW,
- (c) frontline domestic and family violence services and their staff provide essential, specialist and life-saving support to victim-survivors, and it is critical that these irreplaceable services are adequately resourced to continue doing this work, and
- (d) in addition to these two key priorities, DVNSW has made numerous targeted calls for recurrent funding to expand critical services across the state,


investment in ensuring equitable access for all and sustainable investment in the implementation of key government strategies.

- (2) That this House commends the invaluable work of DVNSW in advocating on behalf of specialist services and alongside victim-survivors to eliminate domestic and family violence from society.
- (3) That this House calls on the NSW Government to commit to providing a significant and permanent increase in baseline funding for existing domestic and family violence services in the 2025-26 NSW Budget as a matter of priority, in ongoing consultation with DVNSW.


- (a) Kirinari Community Services is a regionally based not-for-profit provider supporting individuals with complex needs living in regional Australia, through specialist services including disability, community housing, aged care, veterans services, out of home care, transport and health. Almost 90 percent of Kirinari's services are in regional NSW, including in the Central West, Riverina Murray, Blue Mountains, New England North West and Mid North Coast regions,
- (b) Kirinari operates as a provider of last resort for people with disability, many of whom have lost or are at risk of losing accommodation or services, or have been turned away from existing services and have nowhere else to go, oftentimes having been admitted into hospital emergency departments before engaging with Kirinari's services,
- (c) people with disability in regional and remote areas face unique and disproportionate barriers to accessing essential supports and services, with a historic lack of culturally appropriate, available and specialist services outside metropolitan areas, and
- (d) the Disability Royal Commission called for the urgent establishment of a co-designed provider of last resort scheme to address the unique barriers to service delivery in areas where there are no suitable providers or mainstream services available, particularly for First Nations people with disability, people in crisis situations, people at risk of losing their accommodation and disability services, people whose needs cannot be adequately met by existing services and people who are at heightened risk of violence, abuse, neglect or exploitation.

- (2) That this House commends the work of Kirinari Community Services in supporting vulnerable individuals in regional communities and advocating for equitable, appropriate and sustainable access to essential services for all people.
- (3) That this House calls on the NSW Government to take direct action to address the significant, chronic and unsustainable gaps in regional service delivery by working with other levels of government and affected communities.



- (a) On 12 December Gidget Foundation Australia and Blooms the Chemist officially opened the Gidget House Mudgee in Mudgee.
- (b) The House was officially opened by Stephen Lawrence MLC at an event well attended by community members including Gidget Foundation Australia founder Zarnie Berthold, Blooms the Chemist Chief Executive Officer Emmanuel Vavoulas, Blooms the Chemist Board Member and Owner-Pharmacist, Sally Whiting, Dugald Saunders MP, Member for Dubbo and Councillors Katie Dicker and Rod Pryor of Mid-Western Regional Council.
- (c) Gidget Foundation Australia is a not-for-profit organisation that exists to support the mental health of expectant, new and potential parents to ensure they receive accessible, timely and specialist care.
- (d) *Gidget* was the nickname of a vibrant young mother who tragically took her own life while experiencing postnatal depression, a diagnosis that she kept to herself. In her honour, her family and friends created Gidget Foundation Australia, which evokes *Gidget's* warmth and lively spirit.
- (e) Perinatal depression and anxiety are recognised mental health conditions affecting 1 in 5 mothers and 1 in 10 fathers. They impact around 100,000 Australians each year, with maternal suicide being a leading cause of death amongst expectant and new mothers

- (a) On 2 February Taonashe Chivhaku, 16 years old, of Dubbo, drowned in the Macquarie River at Sandy Beach.
- (b) Known as Latroy, he was a much-loved son, brother, family member, team member, class mate, friend and community member.
- (c) On the evening of 6 February a vigil was held at Sandy Beach and a huge crowd gathered to sing, cry, light candles, release balloons, support Latroy's family and each other.
- (d) The National Drowning Report 2024 published by Royal Lifesaving Australia records the following:
 - (i) 323 Drowning Deaths in Australia in 2023/24 (a 16% increase on the previous year)
 - (ii) 278 deaths is the 10-Year annual average of drownings.
 - (iii) 82% of all drownings in the last annual period were males
 - (iv) 40% were adults aged 55 and over.
 - (v) 83 were people born overseas
 - (vi) 26% drowned at a Beach, 25% at a River/Creek, 14% in the Ocean/Harbour and 11% in swimming pools



I give notice that on the next sitting day I will move:

1. That this House congratulates US President Trump on his remarkable success during his first three weeks back in the White House, including:
 - a) Ending all federal “diversity, equity & inclusion” initiatives & positions
 - b) Reinstated troops who were discharged for refusing the Covid19 vaccine
 - c) Withdrawn the US from the disastrous Paris Climate Accord and reversed a range of climate regulations
 - d) Opened up more land for drilling & allowing offshore drilling for fossil fuels
 - e) Pardoned Ross Ulbricht, who had already served 11 years for running a website
 - f) Pardoned thousands of January 6 and anti-abortion political prisoners
 - g) Removed the US from the World Health Organisation, end involvement with the UN Human Rights Council (UNHRC), end funding for the UN Relief and Works Agency (UNRWA), and reconsider all intergovernmental organisations
 - h) Appointed Robert Kennedy Junior as Health Secretary to make American healthy again
 - i) Appointed anti-war realist Tulsi Gabbard as Director of National Intelligence
 - j) Introduced the Department of Government Efficiency, led by Elon Musk, which has already found substantial savings
 - k) Issued a hiring freeze for federal bureaucrats
 - l) Committed to renewing his 2017 income tax cuts, and removing tax on tips and Social Security payments
 - m) Put a freeze on all new regulations, and required that 10 old regulations be removed for each new regulation introduced

I give notice that on the next sitting day I will move:

- (1) That this House notes that:
 - (a) Blueberries grown on the NSW Mid North Coast are being treated with the neurotoxin pesticide dimethoate,
 - (b) It was reported in January 2025, that an agronomist in the region has made known that blueberries are being treated with dimethoate just one day before reaching supermarkets,
 - (c) Local media is reporting that residents are raising serious concerns about the intensive use of dimethoate, its environmental implications and its risks to human health, waterways, and local agriculture,
 - (d) Dimethoate is banned in the European Union, and is identified as a possible human carcinogen in the U.S,
 - (e) As of 19 September 2023, the Australian Pesticides and Veterinary Medicines Authority suspended the use of dimethoate in mangoes and avocados, but permitted its use in blueberries.
- (2) That this House acknowledges that: *continued*
 - (a) According to a 2020 study published in the journal *Toxics* by Nazam et al. Dimethoate exposure can lead to DNA damage,
 - (b) According to the *National Library of Medicine* compound summary of dimethoate, it is highly toxic and poses serious risks to human health, including:
 - (i) Central nervous system effects,

- (ii) Respiratory arrest and paralysis, which can be fatal.
- (3) That this House acknowledges that:
- (a) Research published in *Reviews of Environmental Fate and Toxicology* highlight the adverse effects of dimethoate on flora and fauna, including:
 - (i) Impacts on plant photosynthesis and growth,
 - (ii) Harm to birds and aquatic life from agricultural runoff.
- (4) That this House notes that:
- (a) The use of dimethoate directly contradicts the objectives in the *Pesticides Act 1999*, which states that "... to promote the protection of human health, the environment... to minimise risks to human health, the environment..."
- (5) That this House calls on the Government to:
- (a) Strongly advocate to the Federal Government to immediately prohibit all uses of dimethoate,
 - (b) accelerate research and funding for non-toxic pest control alternatives to assist farmers in transitioning away from dimethoate.

Mr PRESIDENT:

I give notice that on the next sitting day I will move:

- (1) That this House notes that:
 - (a) on 5 February the Federal Government passed mandatory minimum sentences for terror offences and displaying hate symbols, and,
 - (b) the laws will impose mandatory minimum jail sentences of 12 months for some hate crimes considered on the lower end of the spectrum, minimum three-year sentence for terror financing, and a minimum six years for other terrorism offences.
- (2) That this House notes that:
 - (a) the Government's decision to pursue mandatory minimum sentencing is contrary to the 2023 ALP National Policy Platform stating: "Labor opposes mandatory sentencing. This practice does not reduce crime but does undermine the independence of the judiciary, leads to unjust outcomes, and is often discriminatory in practice",
 - (b) *the Australian Law Reform Commission* noted that there is no evidence that mandatory minimum sentencing acts as a deterrent or reduces crime, though it does lead to increased incarceration, and,
 - (c) in 2018 *the National Association of Community Legal Centres* stated that mandatory sentencing laws are 'arbitrary and undermine basic rule of law principles by preventing courts from exercising discretion and imposing penalties tailored appropriately to the circumstances of the case and the offender,' and
 - (d) research shows that community-based sentencing options are far more effective in reducing crime.

- (3) That this House calls on the Government to maintain its trust in the judiciary and their expertise and ability to administer sentences, to respect the most fundamental principle of our democracy, the separation of powers and to not reach into the space between those powers.
