Mr PRESIDENT:

- (1) That this House notes that:
  - (a) A common argument used against Native Forestry is that it is not widely used in housing.
  - (b) Housing Industry Association NSW in their submission to the Independent Forestry Panel highlighted that hardwood timber is one of the most commonly used products in building a house, including framing of wall, roofs, structural beams, flooring and decking.
  - (c) It is estimated that between 95 000- 115 000 new dwellings will be completed in 2024 and that 73% of them will use hardwood framing for the load bearing elements of the wall and roof.
  - (d) There is an emerging focus on use of lower embodied carbon emission materials in residential construction, and lower embodied emissions standards largely favour increased utilisation of natural products like timber in construction projects.
  - (e) While tempting to view concrete, steel, and polymer as viable substitutes in the event of government policy restricting supply of timber, this will not improve an embodied emissions rating of a building.
  - (f) A full scope emissions framework would recognise hardwoods sourced locally to be preferrable over interstate or imported timber-based materials, due to lower emissions from transportation.
- (3) That this House reaffirms its support:
  - (a) The native forestry industry in NSW.

#### Mr PRESIDENT:

- (1) That this House notes with concern that according to new research by Unions NSW in the report entitled *Disrespected, disregarded and discarded: Workplace exploitation, sexual harassment and the experience of migrant women living in Australia on temporary visas* published in November 2024:
  - (a) one in two migrant women on temporary visas experience sexual harassment at work,
  - (b) many of these women are working in industries with high levels of precarious employment where channels for reporting are in many instances non-existent or do not reflect the needs of migrant women,
  - (c) sexual harassment is even more common for those working in construction, hospitality, horticultural, retail and cleaning industries. The highest rates are in the construction industry, with four in five migrant women on temporary visas experiencing sexual harassment at work,
  - (d) three in four of those who experienced workplace sexual harassment did not report the incident, with over half indicating they were concerned that reporting could result in losing their job, and many being fearful of uncertainty regarding their immigration status and facing racial and gender workplace discrimination,
  - (e) migrant women on temporary visas believe their employers are not doing enough to protect them from sexual harassment, with a significant number quitting their job because they felt in danger. Those who did report misconduct

- experienced repercussions such as a reduction in shifts, being underpaid, bullying and being fired, and
- (f) to effectively ensure temporary migrant women are safe at work, sexual harassment cannot be addressed in isolation and other issues should be addressed in conjunction.
- (2)That this House further notes the following recommendations by Unions NSW in the report which are directed at state and/or federal governments:
  - (a) that migrant worker centres be established in each state,
  - (b) that culturally appropriate education and training on sexual harassment prevention be developed in each state in collaboration with unions, migrant worker centres, migrant worker community groups and leaders,
  - (c) that a legal framework be implemented at a national level to effectively protect migrant women from sexual harassment,
  - (d) that employers, government agencies, regulators, community legal centres, and other support services implement multilingual sexual harassment reporting channels,
  - (e) that initiative such as bridging programs and streamline skills recognition be developed to assist migrant women in aligning their qualifications with local standards to improve access to employment opportunities,
  - (f) that temporary migrant women be provided with visa protections to ensure they can report sexual harassment without fear of visa cancellation or other negative impacts to their immigration status, and
  - (g) that government agencies introduce reforms to ensure that migrant workers have access to existing legal avenues for addressing sexual harassment.
- (3)That this House affirms that all people deserve to be safe and free from harassment at their place of work.
- (4)That this House calls on the NSW Government to take targeted action to address the concerningly high rates of workplace sexual harassment experienced by migrant women on temporary visas, by working with Unions NSW, migrant women and other levels of government.

- (1) That this House notes that:
  - (a) Tuesday 3 December 2024 is the International Day of People with Disability (IDPwD), and this year's theme is "amplifying the leadership of persons with disabilities for an inclusive and sustainable future",
  - (b) each year, in addition to empowering disability pride, IDPwD stands as a strong call to action for all governments, decision-makers and individuals across society to take action to dismantle ableism and create inclusive and accessible systems, policies, practices and environments,
  - (c) for many in the disability community, the Disability Royal Commission and its final recommendations represented a pivotal turning point in the fight for a genuinely inclusive and accessible society, and it is crucial that all levels of government use this opportunity to take bold action in implementing the necessary change alongside people with disability and their families and representatives, and
  - (d) this year's IDPwD theme calls for greater action to remove the barriers preventing people with disability from being in leadership roles and decision-making spaces, and recognises the importance of people with disability being empowered and involved in decision-making processes that affect their lives.

- (2) That this House celebrates the diversity of the disability community in NSW which includes over 1.3 million people, and affirms the importance of disability-led solutions to create a society rooted in inclusion.
- (3) That this House calls on all levels of government to work with the disability community and their families and representatives to drive bold action to improve the lives of people with disability and pave the way for a truly inclusive, accessible and sustainable future for all.

#### Mr PRESIDENT:

- (1) That this House notes that:
  - (a) two year old Knighted Storm was euthanised by the on-track vet after suffering a neck fracture while racing at Wentworth Park on 14 November 2024, making them the fifth greyhound to be killed on-track at Wentworth Park this year following the deaths of Ruby's Wish, Self Sink, Oceanside and Omega Texas,
  - (b) since greyhound racing resumed in October 2016 after the NSW Government backflipped and reversed the greyhound racing ban, 34 greyhounds have been killed on-track at Wentworth Park, and another 32 dogs have been killed off-track after suffering injuries in their races. During this time, the surrounding community has increasingly called for the government to terminate the lease at Wentworth Park and allow the public to decide the future of the land,
  - (c) within the last week alone, dozens of greyhounds have been injured while racing at Gosford and Richmond tracks, both of which, like Wentworth Park, have undergone costly track upgrades funded by the NSW Government to make them supposedly safe,
  - (d) no track is a safe track for greyhounds, and it is unacceptable that the NSW Premier continues to affirm the NSW Labor Government's support for the greyhound racing industry and ignore the insurmountable well-documented evidence of cruelty, corruption, malpractice and non-compliance, and

- (e) public pressure to shut down greyhound racing in NSW has surged in recent months, with various petitions signed, letters written to parliamentarians demanding action, and regular protests and rallies continuing to be organised and attended by countless people in the community, advocacy groups, activists and politicians.
- (2) That this House calls on the NSW Government to urgently shut down greyhound racing in NSW, close down all existing racing tracks and allow these spaces to be repurposed for community use.

# LEGISLATIVE COUNCIL NOTICE OF MOTION: TURKEYS

Ms Hurst says-

Mr PRESIDENT:

- 1. That this House notes that:
  - a. More than 6 million turkeys are slaughtered in Australia every year
  - b. In intensive agribusinesses, turkeys are raised in barren, artificial and crowded sheds, with no access to natural light nor the ability to express natural behaviours, and are bred to grow at such freakish rates that they cannot support their own body weight, quickly become immobilized, suffer crippling skeletal issues, joint pain, heart attacks, organ failure and lose the ability to fly
  - c. Turkeys are also subject to brutal mutilation practices without anaesthetic or pain relief, including using a hot blade or laser to cut off part of their sensitive beaks, toes and snoods
  - d. Male breeder turkeys are forced to grow so large so fast that they cannot naturally procreate, and instead are hand masturbated by workers who then artificially inseminate the female turkey

- e. Though turkeys in the wild can live to 10 years of age, commercially bred turkeys will be killed when they are just10-18 weeks old, using harrowing methods such as bleeding cones, shackle lines and electrical stunning, which often fails to render the birds unconscious meaning they are fully aware when their throat is cut and they bleed out
- f. Once killed, turkeys can be frozen for up to 3 years before their body is sold at a supermarket, meaning if you are eating a turkey this Christmas, he or she could have been killed in 2021, and their body has been dead for 3 years before you are eating them
- 2. That this House encourages everyone to make compassionate choices this festive season and keep our turkey, pig, cow, chicken, fish, crustacea and any other animal friends off their plate
