

Inquiry into the music and arts economy in NSW
Supplementary questions on notice
Liverpool City Council

- 1. If the NSW Government was to legislate a framework for entertainment precincts across the state which gave councils the option of implementing these in their local area, would your council consider using applying such a concept locally?**

Council welcomes any initiative that will simplify the regulatory provisions for entertainment precincts in particular music and noise. The framework should take into account the impact of mixed used zoning and provide guidance on decision making for future planned mixed use developments. It should explore the potential of incorporating the 'agent of change' principle where by the agent of change is responsible for mitigating the impact of the noise.

The framework could also help Council to establish pedestrian-only zones, accommodate more human scale streetscape design in the public domain for specific areas hence sustainably increasing overall human and economic activity.

- 2. What other steps would you like to see the NSW Government take to support the music scene in your local council area?**

Council would like to see greater support for sustainable long term programming and development of a music industry. Council has provided a number of recommendations in its initial submission for funding and program support. The emphasis being on sustainable long term initiatives that will enable; artists to continue to practice in the region, support for artist in residency programs and community involvement stimulating a grassroots music movement in the region. Further, funding to develop and support live music venues, flagship cultural events and creative start-ups/social enterprises will assist to build the channel for musical performances and artistic expression.

- 3. How many licenced venues are there in your council area, by licence type, have 'no entertainment' or 'no live music' conditions on their development applications?**

Council has attached a list of licenced premises within Liverpool LGA. There is information about different licence types although we do not have a registry listing venues which have 'no entertainment' and/or 'no live music' condition in the LGA. This is administered by the Office of Liquor and Gaming (OLGA) therefore Council cannot provide such information.

- 4. What other conditions on the development conditions of licenced venues in your council area might relate to entertainment? Please provide examples.**

Acoustics and their affect on neighbours is a key consideration when Council considers applications for licenced venues and entertainment venues

Council's conditions of consent in relation to acoustics is currently under review. The conditions may change based on the recommendations of the review to meet the current and future requirements.

5. Please list the venues, by licence type, and the conditions relating to entertainment.

Council is not the regulator of licensed premises therefore cannot provide a list of premises, or the conditions that are stipulated. These are administered by the Office of Liquor and Gaming NSW (OLGA). The OLGA have a list of all premises that are licensed, showing license types and conditions relating to use and entertainment. Liverpool Police would also have access to such information.

The attachment does provide some information that may be useful however.

6. How many commercial properties in your council area that are not licenced premises, would have conditions on their development application that relate to entertainment?

Council does not keep such records but the attached may provide some useful information

7. How many commercial properties relating to the music industry, for example record stores and music stores in your council area, would have conditions on their development application that relate to entertainment?

We are unaware of any music stores or record stores with such conditions in our LGA. Liverpool does though contain a variety of venues offering music related services and products (approximately estimated 10 – 15). Some of these stores/venues such as dance studios, music and singing schools would have noise and operating hour conditions inherent in their conditions of consent usually designed to mitigate acoustic effects on neighbouring properties.
