TO DEVELOP ROSEHILL RACECOURSE**

	Question	Answer
(1)	<p>How do you explain the difference in your evidence to that of your Vice-Chairman Tim Hale about the valuation of the Rosehill site? Why have you been telling ATC members it's worth \$5 billion for sale when no such valuation exists, and the current sale value is just \$1.6 billion?</p>	<p>At its unscheduled Board meeting on 21 November 2023, the ATC Board was provided with preliminary indicative financials/returns of \$4.8 billion for the proposed development of Rosehil Racecourse, as supplied by Mostyn Copper. Following that meeting, Mr Hale requested and was provided with further particulars on the methodology and key inputs used by Mostyn Copper in making that preliminary indicative assessment. Since November 2023, Mostyn Copper's preliminary indicative assessment has been tested and validated with a number of other respected property advisory firms. Therefore, my subsequent statements to members that \$5 billion was an <i>estimated</i> return for the development of the whole of Rosehill stands.</p> <p>In relation to the current sale value of \$1.6 billion, I refer to my evidence provided at the Inquiry hearing (refer to page 10 of the transcript) that the \$1.6m valuation is on the basis of "no rezoning, walk-in, walk-out". We have not communicated this valuation to ATC members because a sale at this price has not, and would not, be considered by the Board to be in the best interests of the ATC members as a whole. Again, I refer to my evidence at the Inquiry hearing (refer to page 10 of the transcript) that this would be "a paltry return for the loss of a premium racetrack" and that "we wouldn't even let that bid through the door".</p> <p>The due diligence process currently being undertaken will scope out all of the relevant inputs, a range of potential options and their valuations, so that accurate information can be considered by the ATC Board and put before the members to ensure there is a fully informed vote.</p> <p>I refer to the evidence of Peter V'Landys at the Inquiry hearing (see pages 57 and 58 of the transcript), where he stated that an expert engaged by Racing NSW for the due diligence investigations has advised that the development value over a period of 30 years is \$23 billion. Garry Charny also provided evidence at the Inquiry hearing (see page 24 of the transcript) that with a 30 year development with a developer on normal terms, taking some development risk, the value of this development is closer to \$20 billion to the ATC.</p>

(2)	What documentation can you provide to the Committee to justify your claim of a \$5 billion value?	See attached Confidential Answers to Supplementary Questions.
(3)	After Steve McMahon informed an ATC consultative committee that the current sale value of Rosehill was \$2 million why wasn't the entire ATC membership informed?	At the consultative committee on 6 July 2024, Steve McMahon noted that the unimproved or "as is" sale value was estimated at \$2 billion (not \$2 million per the question), however he also indicated that there was no proposal to sell at that value. There was no consideration of any kind to sell Rosehill Racecourse on this basis. Again, I refer to my evidence at the Inquiry hearing (on page 10 of the transcript) that a proposal to sell Rosehill for the unimproved value would not "get through the door" with the ATC Board.
(4)	Why wasn't the ATC Board told immediately about the full-sale proposal after Mr. McMahon spoke to you on 26 October last year? How many ATC Board meetings were there between 26 October and 21 November and on which dates?	<p>In short, advising the Board immediately after my discussion with Steve McMahon and Matt Galanos on 26 October 2023, would not have met the requirements of good corporate governance. As recognised in the ATC's Charter and Code of Conduct for Board Members, one of my key roles as Chairman is to ensure that the information provided to the Board is relevant, accurate, timely and sufficient to appropriately inform the Board of developments that may have a material impact on the Club. On 26 October 2023, I did not know whether the concept of a full sale of Rosehill Racecourse would be supported or opposed by Government and the Club's regulator, Racing NSW. If either of these parties was conceptually opposed to a full sale, then the concept would have been immediately non-viable and could not be taken forward. Therefore, I considered that this was essential information to obtain in order to properly and appropriately inform the Board.</p> <p>These inquiries were executed with expediency with meetings held with the Premier, Chris Minns on 30 October 2023 and the CEO of Racing NSW, Peter V'Landys on 1 November 2023. After those meetings, myself and ATC management began making preparations for an urgent unscheduled Board meeting which was held on 21 November 2023</p> <p>Between 26 October and 21 November 2023 (inclusive), there were two Board meetings. A regular scheduled Board meeting was held on 30 October 2023 and an unscheduled Board meeting was held on 21 November 2023.</p>
(5)	Can you please provide the Committee with the Minutes of ATC board meetings from 1 November to 31 December 2023?	See attached Confidential Answers to Supplementary Questions.

(6)	<p>How could Mr. McMahon have been working with the NSW Cabinet Office on a press release for Chris Minns announcing the full sale of Rosehill on 20 November before the ATC Board had considered the matter? Why have you been so determined to push this sale through, avoiding proper due process, for the political benefit of Chris Minns instead of the best interests of ATC members?</p>	<p>The terms of the Memorandum of Understanding (“MOU”) provided by the NSW Government to the ATC required that neither the ATC nor the NSW Government could make public statements about the MOU unless agreed by the other party. Therefore, Steve McMahon provided input to the NSW Cabinet Office on a press release about the signing the MOU to ensure it was factually correct and consistent with ATC’s own planned communications to members. This press release did not announce that a full sale of Rosehill was to proceed, but rather was to be explored further according to the terms of the MOU.</p> <p>I reject that I have been “determined to push this sale through”. At all times I have acted accordingly to my fiduciary duty as a director to explore this proposal fully in the best interest of ATC members as a whole. It is the Board’s obligation to fully explore this concept on the basis that it could potentially yield sufficient funds to secure the Club’s financial future independent of wagering revenue, as well as providing for a new world class premium racecourse, a new state of the art training centre of excellence, and significant improvements at our other racecourses to both racing, training and stabling infrastructure, and to members and spectator facilities. All of these cannot be achieved by the ATC just receiving an increase in current funding by Racing NSW, as was suggested by some witnesses at the Inquiry hearings to date. A revised funding arrangement with Racing NSW would certainly assist the Club’s cash flow and to undertake current maintenance at its tracks. However, the proposed redevelopment of Rosehill Racecourse has the potential to pay for significant uplift in all the facilities at ATC’s racecourses, a new state of the art racecourse and training centre, as well as having substantial funds remaining to provide the ATC with a new source of income which is independent of wagering revenue.</p> <p>Since the ATC Board determined to enter an MOU with Government to explore its proposal regarding Rosehill Racecourse via the Unsolicited Proposal process, the ATC has been engaged in a proper process which is designed specifically for these types of approaches to Government. The USP Stage 2 due diligence investigations will assist the Club to provide its members with the necessary information for a fully informed vote on the matter.</p>
(7)	<p>Given that the ATC membership overwhelmingly opposes the Rosehill sale, and already it has cost the ATC hundreds of thousands of wasted dollars, why are you afraid to put the question to the members immediately and have it resolved?</p>	<p>We do not currently know whether a majority of ATC members support or oppose the proposal to redevelop Rosehill Racecourse. I do not consider that the members have sufficient detail to make a fully informed decision on this matter at this point in time. It is the ATC’s intention to put the matter to a members’ vote once sufficient information on the various aspects of the proposal, including structuring and financial returns, planning, engineering and ecological information, as been obtained as part of the Stage 2 due diligence investigations.</p>

(8)	Who will conduct the ballot of the ATC membership and what integrity measures are in place to protect its accuracy? Are you planning to put the question as one of reclassifying Rosehill as a non-core ATC asset? If not, how will the question read?	<p>To ensure the integrity and accuracy of members' voting on the Rosehill proposal, our intention is to have the ballot conducted by an independent third party. That party is yet to be determined, however, the ATC has previously used Computershare for the conduct of ATC members' voting on the election of directors and other resolutions at AGMs.</p> <p>The wording of the question to be put to ATC members has not yet been determined. This will be determined after the completion of the Stage 2 due diligence.</p>
(9)	What advice has the ATC now received regarding the difficulty in building a metro station box at Rosehill Racecourse and how this will delay the construction and opening of the Sydney West Metro?	To the best of my knowledge, the ATC has not received any advice regarding the specifics or requirements for building of a metro station at Rosehill. I am therefore not able to provide any further assistance on the questions asked here.
(10)	What further contamination testing has the ATC conducted at Rosehill Racecourse and what does this show?	Testing provided to the ATC to date has shown that contamination is minimal and can be remedied by conventional means.
(11)	ATC members are sceptical that proceeds of the sale of Rosehill will ever be spent on upgrading Warwick Farm. What happened to the \$25 to \$50 million raised from the sale of land to Inglis Riverside and why wasn't it used to upgrade spectator facilities at Warwick Farm as promised?	<p>The ATC's records indicate that \$34.6m has been spent to date pursuant to the ATC's obligations under the Voluntary Planning Agreement ("VPA") with Liverpool City Council associated with the sale of land at Warwick Farm to Inglis in 2009. Key areas of spend have been on:</p> <ul style="list-style-type: none"> - Governor Macquarie Drive works, including widening of the road, traffic lights and pedestrian footbridge; - Car park construction; - Slip lane works; - Coopers Paddock bike path works; - Bush regeneration works. <p>The ATC is also still to complete further works required under the VPA estimated at \$2.3m</p>

(12)	Given that SO52 documents show that \$600 million is needed to upgrade Warwick Farm, Canterbury and Randwick, why didn't you proceed with the original plan to raise \$600 million from 3,000 dwellings on the car park land running along the spine of James Ruse Drive at Rosehill as part of the NSW Government's Camellia-Rosehill Place Strategy?	The ATC was pursuing these plans with the former the NSW Government over a period of about 8 years, however, the Government did not resolve to proceed with the necessary rezonings, so the option to proceed with the original plan for 3,000 dwellings never became viable. The Camellia-Rosehill Place Strategy would not have provided the additional funds to provide a new income stream independent of wagering revenue that the current proposal to redevelop the entire Rosehill Racecourse provides.
(13)	Why was Mr McMahon sent to meet with the Premier on 30 October 2023 to discuss the Government's attitude to the sale of Rosehill? Given the critical importance of the matter why didn't you or the ATC CEO attend, as officials far higher up in the ATC hierarchy than Mr McMahon? Shouldn't the ATC leadership have been there?	Mr McMahon is a member of the ATC Senior Leadership Team and government relations is a significant part of his role. Mr McMahon was the key person at the ATC managing the Rosehill-Camellia matter previously and had regular dealings with current and former governments on behalf of the ATC regarding that matter as well as other ATC projects.
(14)	Was Mr McMahon sent due to his close ALP connection to Chris Minns, making this a political project from the beginning?	No. I refer to my answer to question (13).
(15)	Given that the evidence shows the NSW Government solicited this proposal and actually suggested the USP process, why did the ATC agree to a process	The proposal was not solicited by the NSW Government. The ATC initiated the discussions with the Government in relation to its proposal to develop Rosehill Racecourse. Under the MOU executed by DEIT and the ATC, both parties agreed to comply with the Unsolicited Proposals process and to only engage regarding the proposal through that process.

(19)	The Chipping Norton Stakes and the Liverpool City Cup are currently held at Randwick Racecourse. Why are these races not held at Warwick Farm?	The current racing surface, as well as members and general admission facilities are currently not of a sufficient standard for group racing. The characteristics of Warwick Farm racecourse (ie, size, length of straight, tightness of turns etc) are also currently sub-optimal for generating wagering revenue. Substantial investment would be required to justify a decision to return group racing to Warwick Farm. This decision would also require the agreement of Racing NSW as it is the body that sets the racing programme for all NSW thoroughbred racing each year.																																																																																																																								
(20)	For each year between 2013-2023 for Rosehill Racecourse only, what were the average spectator attendance figures by event, and separately by year? 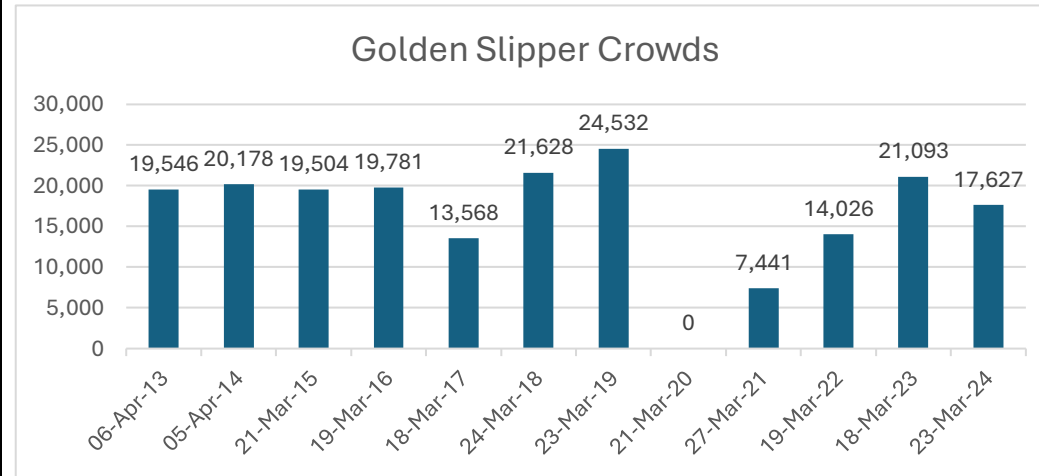

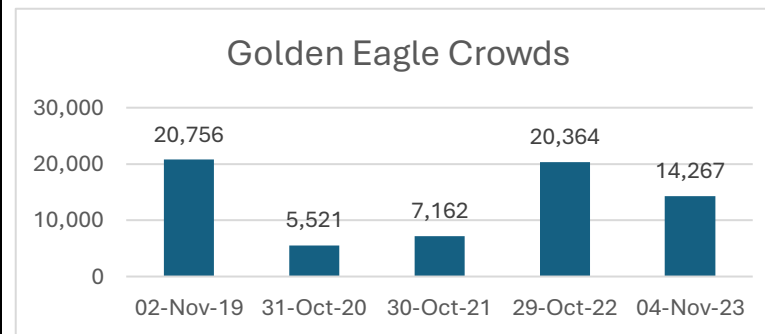

Were any governance concerns raised by board members prior to their consideration of the MoU or Stage 1A submission of</p>	<p>(a) The headwinds currently confronting the ATC include:</p> <ul style="list-style-type: none"> - Approximately 62% of the ATC's revenue is derived from wagering revenue. Only 38% is derived from the ATC's own racing and non-racing activities. Therefore, the downward trend in wagering over the last few years has had, and will continue to have, a significant effect on the ATC's operations. The ATC's revenue received from Tabcorp distributions, via Racing NSW, have declined significantly from a high in FY2021 of \$89.6 million to a forecast of approximately \$72 million for FY2024. This forecast is based on a YTD trend of Tabcorp distributions being down 7.4%. (Although, in the past, Racing NSW has provided a top up payment of \$82.8 million, the ATC has no certainty of this going forward). In the current economic environment it is expected that wagering revenues generally will continue to decline. - Prizemoney commitments for the ATC require payment of \$69 million each year, with Racing NSW contributing a further \$150 million to make a total of \$219 million prizemoney for ATC race each year (including the equine welfare fund deduction of prizemoney). - The ATC is generally not able to generate enough revenue from its racing and non-racing activities to cover its expenses. For example, in relation to training activities the ATC is forecasting a \$7.9 million loss for FY24 and budgeting for that to increase to a \$8.6m loss in the current financial year. - Revenue from sponsorships, membership, admissions and raceday hospitality are all challenged. The current facilities at all four racetracks do not meet the expectations of the next generation of sponsors, members and racegoers. - Significant and ongoing investment is required to maintain and continuously improve our racing and training surfaces and our stabling facilities to ensure that the ATC continues to attract the best trainers, jockeys and horses to provide the very best racing. - The ATC's operating cost base is already very lean. Over FY2023 and FY2024 we removed \$7.8m of operating costs.
