OUESTION 1:

When were you (Shane Hamilton) appointed to the Board of the Westerman Jilya Institute or Mental Health? What is the timing of your board appointment relative to making of the sponsorship funding?

ANSWER:

Aboriginal Affairs NSW provided sponsorship funding for the 2023 Indigenous Suicide Prevention Fundraising Gala, hosted by the Westerman Jilya Institute for Indigenous Mental Health. The sponsorship was approved by Mr Shane Hamilton in his capacity of Deputy Secretary, Aboriginal Affairs in October 2023.

Mr Hamilton was appointed to the board of the Westerman Jilya Institute for Indigenous Mental Health in June 2024.

QUESTION 2:

If you (Shane Hamilton) were not on the Board at the time the sponsorship was made, had you commenced discussion with them about being appointed to the Board?

ANSWER: No.

QUESTION 3:

Did you have a prior association with the organisation?

ANSWER: Mr Shane Hamilton had no association with the Westerman Jilya Institute for Indigenous Mental Health before his appointment to the Board in June 2024.

QUESTION 4:

How was the donation initiated?

ANSWER: Aboriginal Affairs NSW was approached in September 2023 by the Westerman Jilya Institute for Indigenous Mental Health to consider a \$20,000 (incl GST) Gold Sponsorship Package for the 2023 Indigenous Suicide Prevention Fundraising Gala.

QUESTION 5:

What was your understanding of what the sponsorship funding would be used for?

ANSWER: The Westerman Jilya Institute for Indigenous Mental Health is a national not-for-profit Aboriginal community-controlled organisation.

The Institute's goal is the development of culturally and clinically informed mental health and suicide prevention responses, including through increasing the number of Indigenous psychologists working in Australia.

A key program to achieve this goal is the Indigenous Psychology Scholarship Program which provides scholarships and mentoring to support Indigenous psychology students from across Australia including NSW.

The Institute hosts an annual Indigenous Suicide Prevention Fundraising Gala to raise funds for the Indigenous Psychology Scholarship Program.

As at October 2023, 41 Indigenous psychology students had been supported under the program across Australia including seven in NSW.

QUESTION 6:

Given your association with the organisation, what probity measures did you take?

ANSWER: Aboriginal Affairs NSW assessed the Westerman Jilya Institute for Indigenous Mental Health sponsorship request against the Aboriginal Affairs NSW Adhoc Request Sponsorship Policy (the Policy) to determine whether the request complied with the sponsorship requirements as defined in the Policy and was appropriate for Aboriginal Affairs NSW to support. This assessment found the request was consistent with the Policy. All assessment processes and approval procedures as outlined under the Policy were followed.

QUESTION 178:

The consultation will determine whether Aboriginal communities in New South Wales want a treaty or agreement-making process, and if so what that process would look like. Treaty Commissioners will lead these consultations and will deliver a report back to government on consultation findings, with recommendations for next steps.

How many First Nations communities will be consulted throughout the treaty-consultation process?

ANSWER: Aboriginal Affairs NSW has contracted Naree Pty Ltd to lead a project providing consultation and analysis services to support Free, Prior and Informed Consent within Treaty Consultation Processes in NSW. The total value of this contract is \$499,340 (excl GST), which is being funded out of the AANSW budget.

QUESTION 182:

How many Members of Parliament has the Minister briefed on the Treaty consultation process since January 2024?

ANSWER: I regularly brief Members of Parliament on portfolio matters, including Aboriginal Affairs. The Treaty consultation process has not yet commenced.

QUESTION 185:

QUESTION 7

For you and your staff, what protocols are in place for accepting hospitality and/or gifts from?

- (a) Racing NSW and?
- (b) NSW racing clubs

ANSWER

All staff must comply with the Department's Gifts, Benefits and Hospitality Policy and Procedures in relation to any gift offered or accepted.

QUESTION 8

In the past three years what:

- (a) Hospitality, and
- (b) gifts,

have you or your staff accepted from:

- i. Racing NSW and
- ii. NSW race clubs?

ANSWER

- (a) Since 29 May 2022 the Department has maintained a Gifts Benefits and Hospitality Register.

QUESTION 9

On which occasions in the past 10 years has John Dumesny been placed on the selection panel list forwarded to the Racing Minister for determining vacancy and chair appointments to the Racing NSW Board?

ANSWER

Members of selection panel lists provided to the Minister for determining appointment vacancies are confidential.

QUESTION 10

Who else was on the list (approximately 20 names) for the selection panel forwarded to Minister Harris to determine the replacement for the outgoing Russell Balding, as a chair and member?

ANSWER

Lists of potential members of selection panels are confidential.

QUESTION 11

Other than Kevin Greene who did the selection panel put forward as a possible new board member, replacing Mr. Balding?

ANSWER

Selection panel recommendations to the Minister are confidential

QUESTION 12

Minister Harris says he wasn't told of the close, longstanding relationship between Mr. Dumesny and Peter V'Landys: why didn't you tell him in submitting Mr. Dumesny's name for the selection panel, given the obvious conflict of interest in Mr. Dumesny selecting his good friend's boss?

ANSWER

The then Department of Enterprise, Industry and Trade provided advice to the Minister in relation to the process, including identifying potential selection panel members.

All panelists were required to sign conflict of interest declarations and confidentiality deeds in relation to all aspects of the selection process.

- The appointed probity adviser reported that the selection panel members appropriately declared conflicts of interest
- all conflicts were appropriately managed.

QUESTION 13

Did you tell the probity advisor of the information in (4) above? If not, why not

ANSWER

All panelists were required to sign conflict of interest declarations and confidentiality deeds in relation to all aspects of the selection process.

The appointed probity adviser reported that:

- the selection panel members appropriately declared conflicts of interest
- all conflicts were appropriately managed.

QUESTION 14

Given that Mr. Dumesny failed to declare his interest regarding the Racing NSW CEO, will he be considered for future selection panel lists?

ANSWER

The establishment of selection panels is conducted in accordance with the requirements of the Thoroughbred Racing Act 1997.

QUESTION 15

Could you please:

- (a) Explain how APAC Probity were selected to oversee the probity checks on the process for selecting directors for Racing NSW?
- (b) List what other selection processes APAC Probity have been involved in with the Office of Racing?

ANSWER

APAC Probity Advisory and Auditing Consultants is pre-qualified under the Government's Service Provider Prequalification Scheme. As a pre-qualified probity advisor, APAC has been engaged for a number of Hospitality &Racing portfolio selection processes.

QUESTION 16

Other than the paucity of RICG consultation and the absence of Strategic Planning, what other issues did you raise with the Chair of Racing NSW in your letter of 9 August 2024?

ANSWER

On 9 August 2024, I wrote to the Chair of Racing NSW about its obligations under the *Thoroughbred Racing Act 1997* relating to strategic planning and meetings with the Racing Industry Consultation Group.

QUESTION 17

Are you satisfied with the new draft 2024 Strategic Plan, which looks similar to every other Racing NSW Strategic Plan, such as the perpetual, unfulfilled promise of lower costs to owners and the construction of a Newmarket-style training facility?

ANSWER

This is a matter for Racing NSW

QUESTION 18

Are you satisfied with the accountability of Racing NSW, given that its Strategic Plans and Annual Reports fail to record the goals of its previous Strategic Plans that have been implemented and those that remain unfulfilled?

ANSWER

This is a matter for Racing NSW

QUESTION 19

Other than the need to improve regional racecourse infrastructure, what other issues have you raised in discussions with Racing NSW where it needs to improve its performance?

ANSWER

I have routinely discussed matters including the status of Group 1 races, training and education, and female jockey facilities.

QUESTION 20

Given that it supports the sale of Rosehill racecourse (the most valuable industry-owned asset in the State) for housing, Racing NSW does not have a policy of "keeping racecourses for racing". Accordingly, will the Minister now support the independence and autonomy of country race clubs by ensuring Racing NSW infrastructure funding is unconditional, that is, without the extortion system by which the clubs need to transfer freehold land title and Racing NSW gets to appoint club directors?

ANSWER

This is a matter for Racing NSW

QUESTION 21

Has the Minister received legal advice as to whether or not ICAC can investigate Racing NSW and if so, what does the advice say?

ANSWER

It is a matter for the Independent Commission Against Corruption to determine whether matters and/or persons are within its jurisdiction, in accordance with the requirements of the *Independent Commission Against Corruption Act 1988*

QUESTION 22

Since becoming Minister, how many complaints about Racing NSW have you and your office referred to:

- (a) ICAC
- (b) the police, and
- (c) the Ombudsman?

ANSWER

This information is confidential.

QUESTION 23

Given the extraordinary censorship and intimidation of NSW racing participants who disagree publicly with Racing NSW will you now support the introduction of Free Speech and Customer Service Protocols at Racing NSW?

ANSWER

This is a matter for Racing NSW

QUESTION 24

Are you aware of the circumstance of the highly respected breeders Vin Cox and Anthony Thompson late last year when, after being accused of disagreeing with Racing NSW, they were pursued and harassed by A Current Affair and the Ben Fordham Program (2GB) respectively for "campaigning against the best interests of racing in NSW". Will you investigate how this occurred, especially the role played by free hospitality and gifts provided by Racing NSW to the media outlets concerned?

ANSWER

This is a matter for Racing NSW

QUESTION 25

After Vin Cox wrote to you asking that the term of Russell Balding at Racing NSW not be extended, did you or your office pass this letter onto anyone else, if so, whom? What are the details?

ANSWER

Mr Cox's letter was responded to directly and was not shared outside of Government.

QUESTION 26

Given the extraordinary media and political influence Racing NSW believes it is garnering through free hospitality in the Directors' Room at Royal Randwick (as per the CEO's letter of 6 October 2023) and gifts like Ben English's trip to the Kentucky Derby, will you insist on Racing NSW declaring in its annual reports the recipients of its free hospitality and gifts?

ANSWER

This is a matter for Racing NSW

QUESTION 27

After 20 years as the Racing NSW CEO Mr. Peter V'Landys has done some positive things for the industry but has now become a lightning rod for division, disputes and widespread discontent, such that the negative now outweighs the positive. Given that anyone who attends the races or speaks to owners, trainers and breeders knows of this problem, will you as Minister now ask Peter V'Landys to move on for the good of the industry, as you did recently with the Greyhounds CEO?

ANSWER

The employment of staff, including CEOs, of both Racing NSW and Greyhound Racing NSW, are matters for the respective boards of those organisations.

QUESTION 28

What type of funding model would you like to see for NSW's race clubs in support of their autonomy and facilities? Will you write to Racing NSW to end the constant centralising of power through financial control and financial starving of the clubs?

ANSWER

Racing NSW has legislative functions and powers, including in relation to race clubs and financial management. The Thoroughbred Racing Act 1997 provides that Racing NSW is not subject to direction or control by or on behalf of the Government.

QUESTION 29

Do you support the policy of the Minns Government to curb 'fat cat' salaries in the NSW public sector? How then can you justify the annual payment (base salary and bonuses) of more than \$1.5 million to the CEO of Racing NSW, especially given he's performing a part- time job with his extensive commitments in running rugby league?

ANSWER

The Thoroughbred Racing Act 1997 provides that Racing NSW may fix the salary, wages and conditions of employment of the CEO and its other staff. It also provides that the Government Sector Employment Act 2013 does not apply to the CEO or other members of Racing NSW staff.

QUESTION 30

Are you aware of the CEO of Racing NSW writing letters to trainers threatening to no longer accept nominations from their horses (that is, to put them out of business) without a stewards' inquiry, charges being laid or even an allegation of the Rules of Racing having been broken? When will this racing dictatorship end and due process resume?

ANSWER

Specific concerns about the exercise of legislative functions and powers by Racing NSW are matters for the Board of Racing NSW.

QUESTION 31

Are you concerned that the General Manager of Investigations in the Racing NSW Integrity Unit was previously run out of the NSW Police for cocaine abuse? Doesn't this make him an obvious target for organised crime? How can such a person be in charge of NSW racing integrity?

ANSWER

The employment of staff at Racing NSW is a matter for that organisation.

QUESTION 32

Are you aware of the extent of cronyism and nepotism in the employment practices of Racing NSW, whereby few people are recruited on merit and the bigger criteria for employment and promotion are a) to be related to a prominent media figure, b) to be related or connected to Racing NSW senior staff and c) to be young, female and attractive? Will you write to Racing NSW asking for the reinstatement of strictly merit-based employment?

ANSWER

The employment of staff at Racing NSW is a matter for that organisation.

QUESTION 33

Are you aware of the extent of cronyism and nepotism in the employment practices of Racing NSW, whereby few people are recruited on merit and the bigger criteria for employment and promotion are a) to be related to a prominent media figure, b) to be related or connected to Racing NSW senior staff and c) to be young, female and attractive? Will you write to Racing NSW asking for the reinstatement of strictly merit-based employment?

ANSWER

The employment of staff at Racing NSW is a matter for that organisation. Specific concerns about the exercise of legislative functions and powers by Racing NSW are matters for the Board of Racing NSW.

QUESTION 34

At the Estimates hearing Mr. Barakat said there was no departmental policy across the three racing codes for the best way of managing integrity structures and procedures. Given the critical importance of integrity to racing, why doesn't such a policy exist to guide the three controlling bodies in NSW Racing?

ANSWER

The legislative framework for the three codes of racing is set out in the Thoroughbred Racing Act 1997, Harness Racing Act 2009 and Greyhound Racing Act 2017 (GRA). Each of the controlling bodies exercises its functions independently and none are subject to direction or control by or on behalf of the NSW Government, except to the extent expressly provided for in the GRA in the case of the Greyhound Welfare & Integrity Commission.

QUESTION 35

NSW greyhound racing has a different integrity structure to harness and thoroughbred, having had its commercial/infrastructure arm (GRNSW) separated from its integrity operations (GWIC). Why isn't this a good model for the other two codes?

ANSWER

The Greyhound Racing Act 2017 established the foundations and governance arrangements for the greyhound racing industry, including a separated governance structure, as a result of significant concerns found in relation to integrity and animal welfare in the sport.

QUESTION 36

Are you aware of the work of the Victorian Racing Integrity Board which has insisted on the three Victorian codes ensuring that their commercial/infrastructure arms in no way interfere with the work of their integrity units and stewards? Isn't this a best practice model for NSW to adopt?

ANSWER

Racing integrity arrangements in Victoria are a matter for that jurisdiction.

QUESTION 37

The CEO of a racing controlling body inevitably forms hundreds of work and social relationships with licensed persons - it's part of their job; whereas the protocol for stewards is to never fraternise with licensed persons, to ensure they are always independent in determining integrity matters. As the Victorians have found, doesn't a separation of commercial/infrastructure and integrity functions offer the best structure for a controlling body, given that a CEO involved in stewards' matters will inevitably be compromised with conflicts of interest in the relationships he/she has formed with licensed persons?

ANSWER

This is a matter for Racing NSW

QUESTION 38

Are you aware of the Racing NSW Stewards Inquiry at Mudgee Racecourse on 27 May 2021 into the conduct of Colleen Walker, the Chairperson of the Mudgee Race Club? Ms. Walker had got into a disagreement with Julia Camilleri (a marketing staffer employed by Racing NSW, also the daughter of John Camilleri, the owner of Steggles and a well-known horse breeder friend of Peter V'Landys) about the conduct of a race-day VIP function at Mudgee on 28 February 2021. Julia Camilleri did not make a complaint about her interaction with Ms. Walker (nor did she claim Ms. Walker had sworn at her or called her names) but the dispute about the running of the function came to the attention of Mr. V'Landys. As per the official transcript of the hearing, in the words of the Chief Steward, Marc Van Gestel, "Mr. V'Landys has appointed a Committee of Stewards to hear the matter and the appointment has been myself and Mr. Railton (the Deputy Chairman of Stewards) ... In relation to the process, Mr. Railton and I have been requested by Mr. V'Landys to conduct this inquiry and then, subsequent to

considering all the evidence, make any recommendations to Mr.V'Landys". In establishing the inquiry and receiving recommendations, didn't Mr. V'Landys have a conflict of interest in that he was Julia Camilleri's employer and a personal friend of her father?

ANSWER

The conduct of stewards inquiries is a matter for Racing NSW, in accordance with its legislative responsibilities and as the Principal Racing Authority under the Rules of Racing. The Thoroughbred Racing Act 1996 provides that Racing NSW does not represent the Crown and is not subject to direction or control by or on behalf of the NSW Government.

QUESTION 39

Do you agree it was an unusual practice for the Racing NSW CEO to select the Chief Steward and his Deputy and send them to Mudgee to inquire into a raceday disagreement (along with two minor historic matters concerning Ms. Walker), instead of relying on the regional stewards who would normally handle such an inquiry?

ANSWER

The conduct of stewards inquiries is a matter for Racing NSW, in accordance with its legislative responsibilities and as the Principal Racing Authority under the Rules of Racing.

QUESTION 40

Further into the inquiry transcript, Marc Van Gestel explained the process to Ms. Walker and her lawyer as follows: it "may include things such as whether Mr. V'Landys believes it's appropriate for charges to be issued; whether he accepts our recommendations; he may not accept our recommendations ... We'll consider the evidence, make any recommendations that we think are appropriate and then Mr. V'Landys considers as to whether or not he agrees with those recommendations and whether the matter progresses any further". Wasn't it a denial of natural justice and procedural fairness for Mr. V'Landys to be the final decision maker in this matter when he hadn't been present for any of the evidence?

ANSWER

The conduct of stewards inquiries is a matter for Racing NSW, in accordance with its legislative responsibilities and as the Principal Racing Authority under the Rules of Racing.

QUESTION 41

Are you aware of Mr. V'Landys' evidence to the Rosehill Inquiry on 9 August when he said, "Let me say again under oath, Mr. Latham, I have never, ever interfered in a stewards' inquiry, ever"? Are you also aware of his statement to the racing media after I raised the Mudgee/Walker inquiry transcript at Premier's Estimates on 28 August that, in fact, Mr. V'Landys runs the entire NSW stewards' system, holding, "the delegation of the Board in respect of all integrity, licensing and disciplinary matters"? This was a more honest and frank explanation of the

CEO's involvement in stewards' inquiries. He's involved in them all, with the power to set them up, appoint certain stewards and to accept or reject steward's recommendations. Do you believe this is an acceptable integrity standard for the independent conduct of stewards' inquiries in NSW, free of conflicts of interest and the possibility of the CEO favouring licensed persons he is associated with, while punishing others known to disagree with him and to be critical of his role?

ANSWER

The conduct of stewards inquiries is a matter for Racing NSW, in accordance with its legislative responsibilities and as the Principal Racing Authority under the Rules of Racing.

QUESTION 42

Do you believe the structure and conduct of stewards' inquiries at Racing NSW places unreasonable pressure on stewards to comply with the wishes of their employer, the CEO? For instance, industry participants commonly say that the former Chief Steward, Marc Van Gestel (2016-22), saw no point in making recommendations that Mr. V'Landys would disagree with, so he would ask him early in the process what he wanted the outcome to be.

Isn't this a major integrity risk and flaw in the stewards system at Racing NSW, especially with a dominant, controlling CEO in place?

ANSWER

The conduct of stewards inquiries is a matter for Racing NSW, in accordance with its legislative responsibilities and as the Principal Racing Authority under the Rules of Racing.

QUESTION 43

Will you now write to Racing NSW urging them to adopt the Victorian system for handling integrity matters?

ANSWER

Racing integrity arrangements in Victoria are a matter for that jurisdiction.

OUESTION 44

Minister, can you tell parliament what the function of the Integrity Assurance Committee of Racing NSW is?

- (a) Can the minister say how many times has the IAC has met in each of the past three years?
- (b) Can the minister say who is on the board of the IAC and how they were selected?
- (c) Can the minister say how many meetings of the IAC have involved the CEO of Racing NSW or other senior executives in the past three years?

ANSWER

The function of the Integrity Assurance Committee (IAC) is set out at section 23 of the *Thoroughbred Racing Act 1997*, which also provides for Racing NSW to determine the qualifications and disqualifications for its membership. The frequency of meetings, and attendance at meetings of the IAC are matters for

the IAC and Racing NSW.

QUESTION 45

Minister, can you tell the parliament what the function of the Animal Care and Ethics Committee (ACEC) of Racing NSW is?

- (a) Can you who has served on the board of ACEC in each of the past three years?
- (b) Can you provide attendance notes of those directors at each meeting in each of the past three years?

ANSWER

Information on the Racing NSW Animal Care and Ethics Committee, including its membership, is available in Racing NSW annual reports. Attendance at meetings of the committee is a matter for Racing NSW.

QUESTION 46:

ABORIGINAL AFFAIRS

(46) What is the NSW Government doing to prioritise Aboriginal Community Controlled Organisations in procurement?

ANSWER: As this is a procurement question, it would be best directed to the Minister for Finance for a response.

QUESTION 47:

ABORIGINAL AFFAIRS

(47) What is the NSW Government doing to ensure that Aboriginal and Torres Strait Islander women and children who are experiencing domestic and family violence can access specialist and culturally safe services and support?

ANSWER: This question would be best directed to the Minister for the Prevention of Domestic Violence and Sexual Assault for a response.

QUESTION 48:

Considering the impact of domestic and family violence in First Nations communities, does the NSW Government intend to fund primary violence prevention initiatives in NSW which align with Changing the picture: A national resource to support the prevention of violence against Aboriginal and Torres Strait Islander women and their children (Our Watch, 2018)?

(a) If not, why not?

ANSWER: This question should be directed to the Minister for the Prevention of Domestic Violence and Sexual Assault for a response.

QUESTION 49:

Given the Aboriginal Women's Advisory Network is an integral initiative to support Closing the Gap Target 13, why has the NSW Government not provided ongoing recurrent funding for the Network?

ANSWER: This question should be directed to the Minister for Women for a response.

QUESTION 50

Given New Zealand is a member of Greyhounds Australasia and is not considered an overseas jurisdiction, and no 'greyhound passport' is required, how does GWIC monitor these dogs?

- (a) Does the Minister have any oversight of these greyhounds?
- (b) How many greyhounds have been exported to New Zealand, for each financial year since its commencement?

ANSWER

I am advised by the Greyhound Welfare & Integrity Commission (GWIC):

Transfer of a greyhound from a NSW participant to a New Zealand participant is dealt with under the Greyhound Racing Rules in accordance with the normal transfer processes between Greyhounds Australasia (GA) jurisdictions. Once an application is made to transfer a greyhound from a NSW participant to NZ under the rules, Greyhound Racing NZ (GRNZ) will confirm/approve the incoming transfer. A greyhound can only be transferred to a participant registered in NZ. Once the greyhound is transferred it is under the jurisdiction of GRNZ.

- (a) GRNZ and the Racing Integrity Board of NZ have oversight of greyhounds transferred to NZ.
- (b) Since GWIC commenced use of its system 'eTrac' in November 2022 there have been no applications for transfers to NZ as a receiving racing authority.

QUESTION 51

In 2023-24, how many NSW-registered greyhounds were issued with a greyhound passport by Greyhounds Australasia?

- (a) Of these, how many were sent to:
 - i. The US?
 - ii. Canada?
 - iii. Elsewhere?

ANSWER

- (a) I am advised by the Greyhound Welfare & Integrity Commission (GWIC): In 2023-2024, 493 NSW-registered greyhounds were issued with a greyhound passport by Greyhounds Australasia.
 - (i) 428 NSW-registered greyhounds were exported to the US for rehoming as companion animals.

- (ii) 64 NSW-registered greyhounds were exported to Canada for rehoming as companion animals.
- (iii) One greyhound registered in NSW was exported to Ireland.

QUESTION 52

How many OTVs are at each racing track per race?

ANSWER

I am advised by the Greyhound Welfare & Integrity Commission (GWIC): One On-Track Veterinarian (OTV) is present at every race meeting. Two OTVs are normally scheduled for attendance at premier events such as the Million Dollar Chase and Golden Easter Egg. Two OTVs also attend the annual Coonamble Cup, due to the expanded race program.

QUESTION 53

What are the experience and qualification requirements for OTVs?

ANSWER

I am advised by the Greyhound Welfare & Integrity Commission (GWIC):

On-Track Veterinarians (OTVs) must be fully registered with the NSW Veterinary Practitioners Board. Specific greyhound experience is not mandatory. OTVs are required to have a thorough understanding of GWIC guidelines and policies, particularly those related to serious injury management.

QUESTION 54

What is GWIC's procurement process for employing OTVs?

ANSWER

I am advised by the Greyhound Welfare & Integrity Commission (GWIC): GWIC employs two categories of On-Track Veterinarians (OTVs) through

GWIC employs two categories of On-Track Veterinarians (OTVs) through distinct employment or procurement processes. For full-time OTVs, of which GWIC currently employs five, the recruitment involves a rigorous selection and interview process. This includes a behavioural assessment and evaluation based on the Role Description Development Guide, in alignment with the NSW Public Sector Capability Framework. In contrast, the procurement of contract OTVs, numbering approximately 12, follows a different approach. It includes an informal interview conducted by the Chief Veterinary Officer (CVO) and an assessment during the mandatory shadow training process. All OTVs, regardless of their employment or contract status, must meet GWIC's standard qualifications and undergo the required training before commencing solo work. In addition, GWIC 'Code of Ethics and Conduct', and 'Conflict of Interest Statutory Declaration' forms must be completed.

QUESTION 55

Has GWIC conducted an audit of GRNSW's OTV rooms, in relation to ensuring they meet the required standards?

ANSWER

I am advised by the Greyhound Welfare & Integrity Commission (GWIC): GWIC has conducted multiple comprehensive audits of the On-Track Veterinary (OTV) rooms operated by Greyhound Racing NSW (GRNSW), undertaken internally by GWIC's

OUESTION 56

own OTVs.

Given the Australian Veterinary Association has recommended all jurisdictions ban the cruel and inhumane breeding method known as surgical artificial insemination, which is used for over 80% of greyhound breeding, will the NSW Racing Minister take action to ban it?

- (a) If not, why not?
- (b) Why has GWIC not advised all NSW industry participants to cease using this inhumane procedure?

ANSWER

I am advised by the Greyhound Welfare & Integrity Commission (GWIC):

- (a) Greyhounds Australasia has signaled its intention to amend the Greyhounds Australasia Rules of Racing to prohibit surgical artificial insemination of greyhounds commencing 1 January 2026. GWIC supports this change and will adopt the relevant rule change in NSW.
- (b) See answer to (b).

QUESTION 57

The Brittan report referenced financial hardship as being used as an excuse for euthanasia. How many people are receiving subsidies to ensure no euthanasia?

- (a) At what point does this become a welfare issue, considered a 'failure to provide care' offence under POCTAA?
- (b) How many welfare cases have been seized by GWIC?
 - i. What happened to those greyhounds?
 - ii. How many were returned to the owner?

ANSWER

I am advised by the Greyhound Welfare & Integrity Commission (GWIC):

A greyhound cannot be euthanised on the grounds of financial hardship of the participant. The four criteria set out in GWIC's rehoming policy for euthanasia are:

- Medical euthanasia
- Declared dangerous dog
- Known risk to people
- Failed temperament assessment
 - (a) To establish an offence under the Prevention of Cruelty to Animals Act 1979 (POCTA Act), it must be proven beyond a reasonable doubt that the owner or person in charge of the greyhound has committed an act of cruelty.
 - **(b)** GWIC does not have a power to seize greyhounds except under the POCTA Act. In the 2023/2024 financial year, GWIC has seized one greyhound under the POCTA Act. The Commission prefers to work closely with the participant and GaP to have the greyhounds assessed for the GaP rehoming program whilst being supported as mentioned

above.

- (i) If a greyhound is seized by GWIC, it will be fostered whilst being placed in the GaP rehoming program
- (ii) None

OUESTION 58

What happened to Cruise, the unregistered puppy at Broken Hill mentioned in the Brittan report?

ANSWER

I am advised by the Greyhound Welfare & Integrity Commission (GWIC):

A search of records maintained by GWIC cannot identify a dog with the racing name Cruise.

QUESTION 59

The Brittan report noted that the industry is hostile to many animal welfare groups. Given that GWIC is intended to be independent of the commercial arm of the industry and seeks to work with stakeholders in relation to improving regulatory activities, why does GWIC not meet with more animal welfare organisations on a regular basis?

ANSWER

I am advised by the Greyhound Welfare & Integrity Commission (GWIC):

GWIC meets on a bi-monthly basis with Dr Harry Rothenfluh from the Coalition for the Protection of Greyhounds.

GWIC has offered to have regular meetings to Animal Liberation NSW, however this offer has not been accepted to date. Nevertheless, the GWIC CEO is in regular contact with Animal Liberation NSW to provide information and respond to their queries.

QUESTION 60

The Minister in an ABC TV interview recently stated that the \$60 per dog per race allowance for GRNSW participants would be stopped. Can you confirm it has been stopped?

- (a) If yes, what date was it stopped?
- (b) If no, does the Minister intend to stop it?

ANSWER

Matters raised in the Brittan 'handover' Report are currently the subject of the Drake Inquiry into Greyhound Racing NSW. This is a matter from Greyhound Racing NSW.

QUESTION 61

Following allegations in the Brittan report, has GWIC taken immediate action to ensure Broken Hill greyhounds are not desexed without appropriate pain relief?

(a) If not, will GWIC be taking action to do so in the future?

ANSWER

I am advised by the Greyhound Welfare & Integrity Commission (GWIC):

The Veterinary Practitioners Board (VPB) is the appropriate authority to address concerns related to veterinary practices, including the administration of pain relief during surgical procedures such as desexing.

QUESTION 62

Has GWIC taken action against the two vets who are well known for euthanising dogs (a practice which contravenes GWIC's greyhound welfare code), alleged in the Brittan report?

ANSWER

I am advised by the Greyhound Welfare & Integrity Commission (GWIC):

The Veterinary Practitioners Board is the appropriate authority to address concerns related to veterinary practices. Where the Commission detects evidence that the euthanasia of a greyhound may contravene GWIC's Greyhound Rehoming Policy, the matter is referred to GWIC's compliance team for investigation.

QUESTION 63

Following allegations in the Brittan report, has GWIC provided clear communication to NSW vets articulating that requests for euthanasia of a greyhound for behavioural or financial hardship reasons are in breach of GWIC's greyhound welfare code?

ANSWER

I am advised by the Greyhound Welfare & Integrity Commission (GWIC):

The Veterinary Practitioners Board is the appropriate authority to address concerns related to veterinary practices. Where the Commission detects evidence that the euthanasia of a greyhound may contravene GWIC's Greyhound Rehoming Policy, the matter is referred to GWIC's compliance team for investigation.

QUESTION 64

How many greyhound industry participants have had disciplinary action against them by GWIC for failure to socialise, for each of the financial years since GWIC's commencement?

ANSWER

I am advised by the Greyhound Welfare & Integrity Commission (GWIC): One.

QUESTION 65

What action has GWIC taken to investigate the 50 dogs alleged in the Brittan report as killed for behavioural reasons?

ANSWER

I am advised by the Greyhound Welfare & Integrity Commission (GWIC): Greyhounds can only be euthanased in accordance with GWIC's Greyhound Rehoming Policy. For the 2023/2024 financial year, 34 greyhounds were euthanased for the following reasons:

- Declared dangerous/menacing dog: 8
- Failed a temperament assessment to determine suitability to be rehomed:
 11
- Known risk to people: 15

The deaths of all greyhounds are reviewed by GWIC to ensure that the euthanasia is in accordance with the Rehoming Policy. In each of the deaths listed above a third party has made an assessment of the greyhound and determined that it should be euthanased.

QUESTION 66

GWIC launched an updated rehoming policy in May 2023 which no longer allows greyhounds to be sent to facilities (within NSW or interstate) where they would be used for experiments or for terminal blood donation, nor can greyhounds be rehomed to council pounds without prior approval of the Commission. Since May 2023:

- (a) How many greyhounds has GWIC detected as having been sent to facilities (within NSW or interstate) where they'd be used for experiments or for terminal blood donation?
- (b) How many participants have been penalised for sending greyhounds to such facilities?
- (c) How many greyhounds have been sent to council pounds with the prior approval of the Commission?
- (d) How many greyhounds have been sent to council pounds without prior approval?
- (e) How many participants have been penalised for sending greyhounds to such facilities?
 - Please list the types of penalties allocated by GWIC for this infraction.
 - ii. Is this data publicly available? If not, why not?
- (f) Given the NSW Government has not empowered GWIC to track greyhounds interstate, how will GWIC's updated rehoming policy be enforced regarding interstate facilities?
 - i. How will the outcomes of enforcement be reported upon (i.e. quarterly, annually, or otherwise)?
 - ii. Will this data be made publicly available? If not, why not?
 - iii. Does GWIC have memorandums of understanding in place to facilitate information exchange with all known facilities (within NSW and outside NSW) currently in receipt of NSW greyhounds for experimentation and terminal blood donation?

ANSWER

I am advised by the Greyhound Welfare & Integrity Commission (GWIC):

- (a) 0
- (b) 0
- (c) 17 greyhounds were sent to Council pounds, 16 of which were approved by the Commission.
 - (d) 0
 - (e) 0
 - (i) Section 59 (1) of the Greyhound Racing Act 2017 specifies the forms of disciplinary action that GWIC may take.
 - (ii) If a NSW-registered participant transfers a greyhound in breach of the GWIC Rehoming Policy, they may be subject to disciplinary action. All disciplinary action decisions made by GWIC are published on its website. Summary data is also published in GWIC's Annual Report. Transfers by participants registered in other jurisdictions are matters for the registering jurisdiction.
 - (f) (i) All disciplinary action decisions made by GWIC are published on its website. Summary data is also published in GWIC's Annual Report.
 - (ii) See answer to question 66e ii
 - (iii) GWIC's Greyhound Rehoming Policy prohibits transfer of a greyhound to a Council pound or to a veterinary research facility without the prior approval of GWIC. GWIC does not have information sharing agreements with such facilities.

QUESTION 67

If not, how does GWIC intend to monitor what is happening at these facilities?

ANSWER

I am advised by the Greyhound Welfare & Integrity Commission (GWIC):

Where GWIC receives reports of greyhounds being transferred to a Council pound or veterinary research facility in contravention of its Greyhound Rehoming Policy, the report is referred to GWIC's Compliance unit for investigation. A NSW-registered participant who is found to be in breach of the Policy may be subject to disciplinary action by GWIC.

QUESTION 68

The NSW Government's Greyhound Welfare Code of Practice specifies participants must have a documented plan with exercise, socialisation and enrichment standards for greyhounds. For FY2023–24:

- (a) how many of these plans were checked by GWIC?
- (b) what percentage of these plans met GWIC requirements?
- (c) what percentage of these plans failed GWIC requirements?
- (d) regarding plans that failed GWIC requirements, what percentage received a penalty from GWIC (and where is this data publicly available)?
- (e) if this data is not publicly available, please explain why.

ANSWER

I am advised by the Greyhound Welfare & Integrity Commission (GWIC):

(a) GWIC Inspectors review a participant's Exercise, Socialisation and

Enrichment plan at every kennel inspection. In 2023-2024 the Commission conducted 432 kennel inspections.

- (b) In 2023-2024, the Commission did not take disciplinary action against any participants in respect of a breach of Standard 7.12 of the Code of Practice. The Commission compiles data in relation to disciplinary action taken in response to breaches of the Code of Practice. Where a participant does not have a current or adequate Exercise, Socialisation and Enrichment plan a direction is issued requiring the participant to take corrective action.
- (c) See answer to 68b.
- (d) To date, no penalties have been issued in relation to Exercise, Socialisation & Enrichment plans.
- (e) Any disciplinary action taken by GWIC is published on its website.

QUESTION 69

In relation to fines for any disqualified participants, please advise for FY2023-24:

- (a) whether any fines have been levied
- (b) to whom fines have been levied and why
- (c) what percentage of fines levied have been paid?

ANSWER

I am advised by the Greyhound Welfare & Integrity Commission (GWIC):

- (a) The Commission issued fines to participants who were disqualified in six cases.
- (b) Fines were issued against the following:
 - Chantel Galwey
 - Charlie Azzopardi
 - Desmond Cecil
 - Paul Bonner
 - Richard Polidano
 - Trevor Rice

All disciplinary action decisions made by GWIC are published on its website. Summary data is also published in GWIC's Annual Report.

(c) \$300/\$12,950 or 2.3%, noting that a participant who owes a fine cannot re-register before the fine is paid in full.

QUESTION 70

In relation to the recently announced closure of Coonamble and Tamworth tracks, will the Minister require GRNSW to pay back these public funds?

(a) If the Minister won't be requiring GRNSW to pay back these funds, will the Minister consider using the Greyhound Industry Future Fund to recoup these funds? If not, why not?

ANSWER

I am advised, projects at Coonamble and Tamworth funded through the Capital Grants Program were completed in accordance with the funding agreement in place for each project.

QUESTION 71

Does the Minister or GWIC have any knowledge or oversight of the greyhound industry injury rebate schemes operating in NSW?

(a) Does the Minister or GWIC have any knowledge or oversight of what happens to greyhounds under these schemes, including how many greyhounds with injuries are treated, how many are returned to racing and how many die or are euthanised?

ANSWER

I am advised by the Greyhound Welfare & Integrity Commission (GWIC):

(a) The management of the injury rebate scheme is an internal operational matter for Greyhound Racing NSW, which publishes information regarding the injury rebate scheme in its Annual Reports.

QUESTION 72

Has any Minister for Racing ever inquired into whether GRNSW has collected venue assessments and yearly audits in relation to track compliance, in accordance with the Operating Licence's framework for compliance with the minimum standards?

ANSWER

The terms of reference for the inquiry into Greyhound Racing NSW (GRNSW), led by the Hon Lea Drake, includes to inquire into, report on and make findings and recommendations in relation to:

 the performance and effectiveness of GRNSW's functions under the Greyhound Racing Act 2017 and the GRNSW Operating Licence in relation to racecourse safety, management and compliance with minimum track standards.

QUESTION 73

Has the Minister conducted an audit, or requested GRNSW conduct an audit, to measure how many tracks are compliant with the minimum standards, or to estimate when all tracks will be fully compliant by?

ANSWER

The terms of reference for the inquiry into Greyhound Racing NSW (GRNSW), led by the Hon Lea Drake, includes to inquire into, report on and make findings and recommendations in relation to:

• the performance and effectiveness of GRNSW's functions under the Greyhound Racing Act 2017 and the GRNSW Operating Licence in relation to racecourse safety, management and compliance with minimum track standards.

QUESTION 74

GWIC's current rehoming policy does not detail what happens to greyhounds that are not accepted by Greyhounds as Pets due to capacity issues. What is GWIC's policy in relation to this?

ANSWER

I am advised by the Greyhound Welfare & Integrity Commission (GWIC):

The purpose of GWIC's Greyhound Rehoming Policy is to maximise the rehoming of retired greyhounds and minimize unnecessary euthanasia. Industry participants are required to rehome any greyhounds that they do not wish to retain. GWIC has in 2023 initiated, in partnership with GRNSW and other industry stakeholders, a Rehoming Action Plan to seek to enhance pathways for rehoming of greyhounds.

QUESTION 75

Please list the cause of death for each greyhound that has died in NSW's jurisdiction in 2023- 24.

ANSWER

List enclosed at Attachment A.

QUESTION 76

Under reforms through the 24-Hour Economy Legislation Amendment (Vibrancy Reforms) Act 2023, hotels that schedule live music or arts and cultural events can apply to extend trading hours. Please clarify whether poker machine operating hours are also allowed to be extended for the same amount of time when an application is approved for extended trading hours for live music or arts and culture events.

ANSWER

Under reforms through the 24-Hour Economy Legislation Amendment (Vibrancy Reforms) Act 2023 there are a number of scenarios where venues can seek additional trading hours. Whether additional gaming machine trading hours are allowed will depend on which of these scenarios applies. They are as follows:

- 1. S13 Special Event Extended Trading
 - Gaming machines cannot be operated if they are not otherwise able to be operated by the venue at that time.
- 2. S12A Live music extended trading incentive for live music and performance venues
 - No prohibition on gaming machine operation during extended trading.
 Gaming machines can be operated so long as the Hotel or Club is authorised to sell liquor.
- 3. S49(3) New Extended Trading Authorisation
 - Hotels can apply for a special Extended Trading Authorisation, which will allow ILGA to give 'due weight' to the strong positive social impact associated with offering live music. Hotels can only apply for this pathway if they put on regular performances, and agree to have a condition on their

licence that prevents them from operating gaming machines during the ETA period.

QUESTION 77

Under the current legislation, venues with live music and trading with the additional hours must keep a log of their programming to ensure compliance with the intent of the incentives including discounts on their licence fees. For venues without the extended trading:

- (a) How do we know that they are genuinely programming music in line with the guidelines?
- (b) What measures are in place to ensure that their programming can be evaluated?

ANSWER

Live music venues are required to hold an average of at least 2 live music performances per week. Live music venues are subject to inspections and audits by Liquor & Gaming NSW inspectors to ensure they are genuinely programming live music in line with the requirements in the *Liquor Act 2007* and the Liquor Regulation 2018.

QUESTION 78

How many of the current venues identified on the Liquor and Gaming website are live music venues, or if other types of venues such as theatres, are genuinely programming live music in accordance with the guidelines?

ANSWER

As at 17 September 2024, there were 355 live music venues and 68 live performance venues published on the Liquor & Gaming NSW website. Live performance venues include theatres.

Live performance venues are not required to schedule live music to qualify for the incentives. They can schedule other arts and cultural events that may include focus on other creative and artistic disciplines that relate to a cultural theme. Other types of performance arts include but are not limited to, theatre shows, visual arts (e.g. an art exhibition) or literary arts events.

QUESTION 79

The now repealed section 163 of the Liquor Act 2007 required the Minister for Gaming and Racing to provide a report to Parliament on the progress of the Parliamentary priorities to streamline liquor licensing and planning approvals and the development of live entertainment incentives. With this reporting process being removed by the NSW Government as part of the Vibrancy reforms for NSW, what actions can the Minister demonstrate on Government decision-making processes under the licensing and planning regulatory framework that have made the licensing and planning process more supportive, transparent and consistent?

ANSWER

The NSW Government made an election commitment to harmonise liquor and planning approvals to make it easier to open new venues.

The NSW Government has taken significant steps to make the licensing and planning process more supportive. Regulation around noise, planning and liquor licensing was streamlined, updated and simplified through the passage of the 24-Hour Economy Legislation Amendment (Vibrancy Reforms) Act 2023.

The Vibrancy Reforms are a cross-government initiative developed in consultation with key agencies, industry, councils and stakeholders to bring sector regulation in line with contemporary going out behaviours, improve government processes and encourage more people to go out, closer to home.

The NSW Government has committed to developing a second tranche of Vibrancy Reforms in 2024 to further support live music and performance and remove administrative and regulatory burden, including the further harmonisation of licensing and planning processes.

QUESTION 80

In Budget Estimates in February this year, I asked the Minister where he was up to implementing facial recognition technology (FRT) in pubs and clubs, considering the commitment from Labor was that FRT installation would be mandated by 30 June.

(a) How many clubs and pubs have installed FRT? Please provide a list.

ANSWER

Clubs and hotels are subject to privacy laws under the Commonwealth's *Privacy Act 1988*. The NSW Government is currently developing a code of practice to provide minimum standards for the voluntary use of facial recognition in NSW clubs and hotels.

QUESTION 81

What guidelines or governance arrangements are in place for the use of FRT in venues? Please provide links to these documents.

ANSWER

Clubs and hotels are subject to privacy laws under the Commonwealth's *Privacy Act 1988*. The NSW Government is currently developing a code of practice to provide minimum standards for the voluntary use of facial recognition in NSW clubs and hotels.

QUESTION 82

What protocols exist around the use and storage of data collected by the use of FRT? Please provide the protocol.

ANSWER

Clubs and hotels are subject to privacy laws under the Commonwealth's *Privacy Act 1988*. The NSW Government is currently developing a code of practice to provide minimum standards for the voluntary use of facial recognition in NSW clubs and hotels.

QUESTION 83

What reporting requirements are there for the use of FRT and for interventions with patrons, such as exclusions, by venues as a result of the use of FRT?

ANSWER

General requirements for intervening with patrons suspected of experiencing gambling harm are detailed in the Responsible Conduct of Gambling training framework under the *Gaming Machines Act 2001* and Gaming Machines Regulations 2015. Under this Framework, venue staff must report incidents of gambling harm in their Gambling Incident Register, including a breach or attempted breach of an exclusion order. The requirement to keep a Gambling Incident Register for all pubs and clubs with gaming machines was introduced by the Government from 1 July 2024. In addition, the NSW Government is developing a code of practice to provide minimum standards for the voluntary use of facial recognition in NSW clubs and hotels.

QUESTION 84

What requirements are there for signage indicating FRT is being used for the purposes of identifying individuals on a self-exclusion register, or who are otherwise experiencing gambling addiction?

ANSWER

Obtaining an individual's consent to collect their personal information is a requirement under the Commonwealth's *Privacy Act 1988*. The NSW Government expects clubs and hotels to comply with Commonwealth privacy requirements.

QUESTION 85

Regarding a statewide self-exclusion register:

- (a) Has it been rolled out?
 - i. If not, when will it be launched?
- (b) Who will be administering it?
- (c) How will it be used in conjunction with FRT?
- (d) Has consideration been given to connecting the self-exclusion register with the ID scanning requirements that already exist in clubs and many pubs? Why isn't this being considered as an alternative to FRT?

ANSWER

All NSW clubs and hotels are required to offer patrons access to a self-exclusion scheme. The NSW Government committed to developing a statewide exclusion register. Input has been sought from the Independent Panel for Gaming Reform on some of the key issues relating to the self-exclusion register. A technical consultative committee and external reference group has also been established to assist with developing the technical and operational requirements for the statewide register to inform the procurement and future operation of the register.

QUESTION 86

How many poker machines are currently operational with cashless gaming technology in NSW?

- (a) In those machines currently operating with cashless technology, what percentage of transactions remain as cash transactions?
- (b) How many users have opted to exclusively use the cashless technology?
- (c) Have any participating clubs reported a decline in gambling revenue since the trial was implemented?
- (d) Is there any evidence of changing behaviour due to the implementation of cashless technology?
- (e) What reasons are participants giving for declining participation in the trial?

ANSWER

The cashless gaming technologies have been installed on 2,388 electronic gaming machines in NSW clubs and hotels for the cashless gaming trial overseen by the Independent Panel on Gaming Reform.

The trial operates under a voluntary hybrid model, where the cashless gaming technologies are being installed in addition to the current cash-based technology. Participants are able to use cash if they wish to.

The Independent Panel on Gaming Reform will consider the trial findings, including any trends identified through data via the Centralised Monitoring System for gaming machines, to inform its recommendations to the Government.

Independent research company, 3arc Social, has been commissioned to evaluate the trial and is finalising its report. The Independent Panel on Gaming Reform will consider the research report to inform its recommendations to the Government. The Panel will report to Government in November 2024.

QUESTION 87

Evidence in Bell inquiry indicated that Mr Crawford had lost confidence in Star chief executive Robbie Cooke and had expressed this position to the Star board not later than December 7. How was this position reached?

(a) Was this position reached as a result of any internal NICC process, benchmarking or a board meeting at the NICC?

ANSWER

The NICC has the sole responsibility of considering The Star's suitability to hold a casino licence. This includes consideration of the conduct of The Star's executives in leading The Star's remediation efforts. The Government is not in a position to comment on the NICC's decision making process.

QUESTION 88

Evidence presented during the Bell inquiry said the Star board wrote a comprehensive response to an assessment into Star by manager Nick Weeks. The response signed by Star chair David Foster and Robbie Cooke dated 23 January 2024, claimed Mr Weeks' report contained a number of factual errors and significant omissions and conclusions were made without full information. Were there any attempt to verify these claims or other issues raised by the Star board in their response to the Weeks' report?

ANSWER

It would not be appropriate for the Government to comment on the NICC's current consideration of The Star's suitability to hold a casino licence.

QUESTION 89

Have you or your department reviewed the concerns raised by the Star board in the 23 January report?

ANSWER

It would not be appropriate for the Government to comment on the NICC's current consideration of The Star's suitability to hold a casino licence.

QUESTION 90

Was there any relationship between NICC chief commissioner Philip Crawford and Adam Bell SC that needed to be disclosed?

ANSWER

The Government is not aware of any relationship between Mr Crawford and Mr Bell that requires disclosure, or raises concerns in relation to the NICC's engagement of Mr Bell to conduct inquiries.

QUESTION 91

Are you aware if Mr Crawford has accepted any hospitality from any companies or entities associated with Mr Bell?

ANSWER

The Government is not aware of any such matter.

QUESTION 92

Were you aware of Mr Crawford's role as chair and head of credit committee at high-interest lender Jewel Solutions?

ANSWER

No

QUESTION 93

Does this external appointment present any reputational issues or the potential for conflicts for the NICC?

ANSWER

The NSW Government expects the NICC to manage conflicts as appropriate.

QUESTION 94

Are you aware Mr Crawford wrote a letter to Mr Foster dated 1 February 2023 saying "further meetings with you were not required?" The letter also misstates the nature of the 23 January report, saying "it was in response to the concerns of the NICC". Do you agree with the contents of the letter?

ANSWER

It would not be appropriate for the Government to comment on the NICC's current consideration of The Star's suitability to hold a casino licence.

QUESTION 95

When were you informed that Bell inquiry was being reconstituted?

(a) Did you provide advice to Mr Crawford on the decision to do this?

ANSWER

The NICC announced the second Bell Inquiry into The Star on 19 February 2024. .

(a) The decision is within the NICC's powers under sections 143 and 143A of the Casino Control Act 1992, and does not require the Government's approval or advice

QUESTION 96

Are you aware if Mr Crawford has discussed the status of Star's license with executives or directors from Crown, Crown Sydney or Blackstone?

ANSWER

It would not be appropriate for the Government to comment on the NICC's current consideration of The Star's suitability to hold a casino licence.

QUESTION 97

Does Mr Crawford or any other NICC commissioners have any prior relationship with Wexsted Advisors?

ANSWER

The Government is not aware of any relationship between Commissioners of the NICC and Wexsted Advisors that requires disclosure, or raises concerns in relation to the NICC's engagement with Wexsted Advisors. The Government expects the NICC to manage conflicts as appropriate

QUESTION 98

Why did the NICC choose the morning of Friday August 30 to release the Bell Inquiry?

(a) Was it deliberately scheduled to coincide with the release of Star's full year accounts?

ANSWER

It is not appropriate for the Government to comment on the NICC's decision in relation to the release of the report of the second Bell Inquiry, which is within the NICC's powers under the *Casino Control Act 1992*.

QUESTION 99

Was there a process to determine the extension of Star manager Nick Weeks until March 2026?

(a) Were other candidates or organisations, other than Wexted Advisors, considered for the role?

ANSWER

Mr Nicholas Weeks was appointed by the NICC under section 28 of the *Casino Control Act 1992* as manager of the casino operated by The Star Pty Limited. The section also provides that the appointment may be extended by the regulations. On 24 July 2024 the NICC wrote to the Government to request the amendment of Casino Control Regulation 2019 to extend the term of Mr Weeks to 31 March 2025. The extension is intended to allow sufficient time for the NICC to consider the report of the second Bell Inquiry, and for The Star and all relevant stakeholders to respond to the NICC's decision once it has been made, including to implement any transitional staffing, business and governance arrangements if required.

Having regard to the above, the Government facilitated the extension through amending clause 48A of the Casino Control Regulation 2019. It is not the Government's role to comment on the NICC's independent decision making in respect of the selection of the manager.

Minister Harris – Budget Estimates QoNs and SQs – September 2024 Supplementary Questions – Veterans

QUESTION 100

The Royal Commission into Defence and Veteran Suicides highlights multiple factors affecting veteran's return to civilian life. How will your government address the factors specific to veterans of NSW?

- (a) The Royal Commission Final Report includes the suggestion of new agency to focus on veterans' wellbeing. Is this something your government intends to implement for the state to collaborate with the anticipated Commonwealth agency?
- (b) In a previous response you mentioned that the NSW Office for Veterans Affairs has 13 staff members, mainly involved in coordinating roles. Is there intention to move restructure this workplace to better address the pressing issues faced by veterans?

ANSWER

The NSW Government is considering the Royal Commission into Defence and Veteran Suicide's Final Report and looks forward to working with the Australian Government to respond to the recommendations effectively across jurisdictional responsibilities. The next whole-of-government NSW Veterans Strategy 2025-2030 is currently being developed and this provides an opportunity to include a range of initiatives that respond to the Final Report recommendations through assisting veterans' wellbeing and the transition to civilian life.

- a) The NSW Government is committed to collaborating with potential Commonwealth agencies tasked with focusing on veterans' wellbeing. Collaboration is key to securing good outcomes for veterans, and to this end, the NSW Government engages in a range of cross departmental and cross jurisdictional forums. This includes regular meetings with the Australian Government's Department of Veterans Affairs as well as other states and territories. The NSW Government also regularly consults with the veteran community, holding annual regional forums, as well as regular meetings with the key ex-service organisations.
- b) The Australian Government's Department of Veterans Affairs is the primary government agency with responsibility for providing support and services to the veteran community including programs to maintain and enhance physical wellbeing and quality of life. In NSW multiple government agencies are responsible for service delivery, including health, transport, education, justice and community support. The NSW Office for Veterans Affairs plays a critical role in advocation and coordinating state responses to ensure that service delivery, for veterans and their families, as far as possible, is coordinated across government and that government agencies are aware of the potential vulnerabilities of this cohort. It also manages a small portfolio of programs and events that honour the services and sacrifice of this cohort as well as an employment program that helps veterans secure sustainable and meaningful employment. There is currently no plan to restructure or move the Office for Veterans Affairs. Resourcing to respond to the Royal Commission recommendations will be considered as part of the next phase of work.

QUESTION 101

Will stakeholders in the upcoming NSW Veterans Action Plan be offered opportunity to reflect on findings from the Royal Commission into Defence and Veteran Suicide and implement strategies to address factors pertinent to those veterans residing in NSW?

ANSWER

The NSW Government has a regular program of stakeholder consultations. It is committed to collaborating with the veteran community to ensure better wellbeing outcomes for veterans and that lived experience is reflected in the NSW Veterans Strategy and action plans.

QUESTION 102

Currently, the role of Minister for Veterans for NSW covers memorials and commemorations and includes the Veterans Employment Program. Does your government intend to expand the NSW role further to accommodate the Commonwealth, particularly as it aims to address the multitude of recommendations from the Royal Commission?

ANSWER

The Australian Government's Department of Veterans Affairs is the primary government agency with responsibility for providing support and services to the veteran community including programs to maintain and enhance the physical wellbeing and quality of life. The NSW Government's new Veterans Strategy 2025-2030 will include responses to recommendations, and these will be across the whole of government.

Minister Harris – Budget Estimates QoNs and SQs – September 2024 Supplementary Questions – Medical Research

QUESTION 103

Will the government commit to an extension of this funding initiative upon completion of the 10 year program in 2028?

- (a) What support will the government provide in sharing the progress and findings of this research with stakeholders outside of the research program?
- (b) Are there active plans to implement similar program initiatives

ANSWER

The Office for Health and Medical Research is currently undertaking a mid-term evaluation of the Cardiovascular Capacity Development Program. Evaluation of NSW's investment in the Program and key Program learnings will be utilised to inform future decision-making and investment.

QUESTION 104

What incentives is your government offering to retain research entities and personnel throughout NSW?

ANSWER

In 2024-25, the NSW Government will invest more than \$104 million through the Office for Health and Medical Research to support excellence in health and medical research in NSW and build research capability and infrastructure. Information on the wide range of programs and initiatives supported is available at www.medicalresearch.nsw.gov.au.

There are also opportunities related to cancer research, available through the Cancer Institute NSW. These include fellowship schemes for early and mid-career cancer researchers, translational research grants, infrastructure support and funding for clinical trials.

QUESTION 105

What efforts are being made to facilitate collaboration between research organisations not involved in government-funded operations to ensure a transparent and holistic approach to medical research?

ANSWER

NSW Health facilitates collaboration between Medical Research Institutes and Research Foundations through their inclusion in supported activities and programs within dedicated NSW Health Precincts. Collaboration is also facilitated at a state level through research networks in priority technology and research areas.

In addition, the Cancer Institute NSW supports the NHMRC-accredited NSW Research Translation Centres through 5-year Translational Cancer Research Capacity Building Grants of \$4 million annually to collaborate and build statewide cancer research capacity.

QUESTION 106

Premier Chris Minns stated in a NSW Government video late in 2023 that "for every dollar we invest in (medical) research, we see a return of nearly \$3.90 to the economy." Will you ensure a funding commitment to medical research in the next budget?

ANSWER

Since March 2023, the NSW Government has demonstrated its long-term commitment to investing in medical research through a range of programs, such as the Medical Research Support Program that will provide \$40 million per annum over the next four years (to FY28) to support the day-to-day costs of running independent medical research institutes in NSW.

Through the Cancer Institute NSW, the Government has invested over \$5 million annually in clinical trials, \$11 million in translational research grants, over \$2 million in infrastructure and equipment grants and \$6 million in early and mid-career fellowships.
