## Clarification of evidence/transcript for Budget Estimates hearing

I write to clarify evidence I provided in relation to the number of adults and young people in custody at the Budget Estimates hearing for Legislative Council Portfolio Committee No. 5 – Justice and Communities, on Wednesday 4 September 2024.

## Number of adults and young people in custody

1. Page 17 of the transcript currently reads as:

MICHAEL TIDBALL: As of this morning there are 13,009 adult prisoners in the NSW Correction system and 56% are sentenced prisoners and 43% are held on remand.

This should be amended to:

MICHAEL TIDBALL: As of this morning there are **13,088** adult prisoners in the NSW Correction system and 56% are sentenced prisoners and 43% are held on remand.

2. Page 22 of the transcript currently reads as:

MICHAEL TIDBALL: Clearly, if you have 231,000 as compared with an adult population of 13,000, this figure is highly sensitive to movements in percentage terms.

This should be amended to:

MICHAEL TIDBALL: Clearly, if you have **231** as compared with an adult population of **13,088**, this figure is highly sensitive to movements in percentage terms.

3. Page 61 of the transcript currently reads as:

Ms SUE HIGGINSON: With the remand, you provided evidence earlier that there were 13,009 people on remand.

MICHAEL TIDBALL: Correct, yes.

This should be amended to:

Ms SUE HIGGINSON: With the remand, you provided evidence earlier that there were 13,009 people on remand.

MICHAEL TIDBALL: I would like to clarify that 13,088 is the adult prisoner population in the NSW Correctional system (sentenced and remand) as at 1 September 2024.
