Good Afternoon

Thank you for the opportunity to review the draft transcript from the Liverpool City Council ("Council") attendance at the recent Parliamentary Inquiry into Western Sydney Science Park and Aerotropolis Developments. Please find attached minor tweaks to the draft transcript for consideration.

Regarding the two items taken on notice – Master Plans currently under consideration for the Aerotropolis and funding secured for Council under the Liveability Program of the Western Sydney City Deal – please find below the relevant information.

1. Master Plans under consideration for the Aerotropolis Precinct

As of 1 October 2024, three (3) Master Plans have been submitted for land parcels located within the Aerotropolis Precinct and within the Liverpool Local Government Area (LGA). One of the three submitted Master Plans, the Bradfield City Centre Master Plan, was approved by the Minister for Planning and Public Spaces, the Hon. Paul Scully MP, in September 2024. The remaining two Master Plans are still under consideration.

2. Funding secured by Liverpool City Council under the Western Sydney City Deal

Under the Liveability Program, Liverpool City Council secured more than \$12 million in funding to complete the construction of a recreation hub at Phillips Park, Lurnea, and more than \$2 million towards the upgrade of Light Horse Park, Liverpool.
